31 ABSTRACT

- 32 **Purpose:** To assess the association between physical activity, sleep duration, sitting
- time, and alterations of posterior segment structures with swept-source optical
- 34 coherence tomography (SS-OCT).
- 35 Methods: Patients with diabetic retinopathy (DR) were recruited, and diabetic
- 36 patients without retinopathy (non-DR) who matched for age and duration of diabetes
- 37 were used as control. The physical activity, siting time, and sleep duration were
- 38 obtained by using standardized questionnaire. OCT parameters included: retinal nerve
- fibre layer (RNFL) thickness, ganglion cell inner plexiform layer (GC-IPL) thickness,
- 40 retinal thickness, and choroidal thickness (CT). Linear regression was conducted to
- 41 analyse the association.
- 42 **Results:** Each group included 116 diabetic patients. Average macular CT was
- 43 positively correlated with metabolic equivalents (MET) only in the DR group,
- independent of age, gender, and other potential confounding factors ($\beta = 1.163$, P =
- 45 0.006). Average macular CT was also positively correlated with sleep duration only in
- the non-DR group, independent of age, gender, and other potential confounding
- 47 factors ($\beta = 10.54$, P = 0.031). No correlation was found between MET, sleep duration,
- and other OCT parameters. Sitting time was not significantly correlated with OCTparameters either.
- 50 **Conclusions:** Physical activity and sleep duration are both positively correlated with
- 51 macular choroidal thickness; this suggests that more time in physical activity and
- sleep benefit the retina, while there was no association between sedentary time and
- 53 OCT parameters. Further studies are warranted to clarify the underlying mechanisms
- 54 and the role of physical activity and sleep in CT alterations and DR.

59 **INTRODUCTION**

Diabetes mellitus (DM) and diabetic retinopathy (DR) have become major public 60 61 health issues globally. There were 415 million adults with DM across the world in 62 2015, and the figure will reach 642 million by 2040.[1] Among DM patients, 35% 63 will develop DR, which is the leading cause of blindness in the working-age 64 population.[2] Many risk factors have been identified as being associated with DR, 65 including the glycemia level, duration of DM, smoking, obesity, and hypertension.[2] Physical activity, sedentary time, and sleep duration have also been implicated in the 66 development and progression of DR.[3,4] Optical coherence tomography (OCT) has 67 been widely used for DR patients in clinical practice. The advance of OCT technology 68 69 gives us an opportunity to obtain more detailed anatomical information of the 70 posterior segment, including each layer of the retina and the choroid.[5] 71 72 Identifying related factors for OCT parameters is informative for clinical evaluation of 73 normal variations and understanding the pathogenesis of DR. Previous studies mainly 74 focus on the relationship between OCT parameters and traditional risk factors of 75 diabetes, such as insulin resistance, poor glycaemic control, and renal function.[6-8] 76 Population-based studies have shown that physical activity is related to retinal 77 microcirculation, which has long been established as an independent risk factor of 78 diabetes.[9-11] Emerging evidence suggests that sleep duration and sleep quality may possibly affect the incidence of diabetes and DR, as well as being associated with 79 80 insulin resistance and poor glycaemic control.[12-14] However, little is known about 81 the relationship of physical activity, sleep, and posterior segment structure, including 82 the choroid and retina, in diabetic patients. 83 84 Considering the alterations in each layer of the retina and choroid in DM patients, it is 85 reasonable to hypothesise that physical activity and sleep may also strongly impact 86 OCT parameters. Therefore, the objective of this study was to investigate the 87 association between physical activity, sleep, and retinal and choroidal parameters 88 assessed with the latest swept-source optical coherence tomography (SS-OCT).

90 METHODS

91 **Participants**

92 This cross-sectional study was performed at Zhongshan Ophthalmic Centre (ZOC), 93 Sun Yat-sen University, China. The protocol of the study was approved by the Institute Ethics Committee of ZOC. The study was performed according to the 94 guidelines of the Helsinki Declaration. All participants signed written informed 95 consent before entering. Subjects aged 35 or more who had type 2 diabetes with 96 97 treatment-naïve eyes were recruited. The patients of DR were considered as case group (DR group), and the patients without DR were set as control group (NDR 98 99 group). The diabetic patients with and without DR were matched for age and duration 100 of DM. Exclusion criteria were as follows: (1) history of serious systemic diseases 101 other than diabetes, such as serious cardiovascular and cerebrovascular diseases, 102 malignant tumour, renal diseases, and chronic obstructive pulmonary disease; (2) 103 history of surgery, such as thrombolysis therapy or kidney transplantation; (3) 104 presence of cognitive impairment, mental illness, or inability to complete the 105 questionnaire and examination; (4) history of glaucoma, age-related macular 106 degeneration, vitreous-macular diseases other than DR, or amblyopia; (5) history of 107 ocular surgical interventions, such as retina laser or intraocular injection, glaucoma 108 surgery, cataract surgery, or laser myopia surgery; and (6) abnormal refractive media 109 (moderate to severe cataract, corneal ulcer, pterygium, or corneal turbidity), poor 110 fixation, and other causes resulting in poor quality of fundus or OCT images. 111

112 Systemic and laboratory parameters

113 General information, including age, sex, duration of diabetes, other systemic chronic

diseases, and risk factors, was collected via questionnaires. Height, weight, systolic

- 115 blood pressure (SBP), and diastolic blood pressure (DBP) were measured by an
- experienced nurse. Mean blood pressure (mean BP) = 1/3 SBP + 2/3 DBP. The serum
- 117 creatinine (Scr), haemoglobin A1c (HbA1c), total cholesterol (TC), triglycerides (TG),
- serum uric acid, and C-reactive protein were determined in standardized lab.

120 Physical activity and sleep duration

121 The International Physical Activity Questionnaire (IPAQ) was used to assess the 122 physical activity status of the participants. Metabolic equivalents (MET) were then 123 calculated according to the principles of the IPAQ to quantify physical activity.[15] 124 Sitting time, a proxy for sedentary time, was also included in the analysis. We used 125 the Pittsburgh Sleep Quality Index (PSQI) to assess sleep quality over a 1-month time 126 interval. The PSQI, a self-reporting questionnaire, is widely used in clinical research 127 due to its well-established reliability and validity. We used the sleep duration item 128 mainly for statistical analysis.[16] 129 130 **Ocular examination** 131 Comprehensive ocular examinations were conducted for all participants. The anterior 132 and posterior segments were evaluated by slit-lamp biomicroscopy and 133 ophthalmoscopy. The evaluations of best corrected visual acuity (BCVA) and 134 intraocular pressure (IOP) were regularly performed. Ocular biometric parameters 135 were obtained using optical low-coherence reflectometry (Lenstar LS900; Haag-Streit

136 AG, Koeniz, Switzerland). Auto refraction was measured by an autorefractor

137 (KR8800; Topcon, Tokyo, Japan) after pupil dilation.

139 SS-OCT imaging

140 The SS-OCT (DRI OCT-2 Triton; Topcon, Tokyo, Japan) instrument was used to

obtain high-definition retina and choroid images. The macular region was scanned
using a 6*6 mm volume scan protocol, which presents the thicknesses of each layer of

143 retina and choroid in 9-ETDRS sectors. Segmentation of different layers on the OCT

- 144 images and construction of topographic maps were automatically rendered by the
- software program. Segmentation was carefully inspected and confirmed by one OCT
- technician who was masked as to the refractive status of the participants, and manual
- 147 correction was performed when the software misjudged the borderline of each layer.
- 148 The peripapillary region was scanned using a 360 degree, 3.4-mm-diameter circle that

149 was centred on the optic disc. Scans were centred using internal fixation. The macular

- region was scanned using a 3.14 circle. Parameters assessed by SS-OCT include
- average thickness of the macular retinal nerve fibre layer (mRNFL), GC-IPL
- thickness, retinal thickness, macular choroidal thickness (MCT), thickness of the
- 153 peripapillary retinal nerve fibre layer (pRNFL), and peripapillary choroidal thickness

We incorporated data of the right eye only into analyses. The Kolmogorov-Smirnov

156 Statistical analyses

158 test was carried out to verify normal distribution. When normality was confirmed, a 159 t-test was conducted to evaluate inter-group differences of demographic, systemic, 160 and ocular parameters. The Fisher's exact test was used for categorical variables. 161 Bivariate scatter plots were made to display the potential factors affecting OCT 162 parameters. Variables with a P value < 0.10 in univariate analyses were included in 163 the multivariate analysis. Univariate and multivariate linear regression analyses were 164 used to assess the associations of MET, sitting time, sleep duration, and OCT 165 parameters. We conducted crude linear regression in model 1. Potential confounding 166 factors were then adjusted in multivariate regression analysis, with model 2 adjusting 167 for age and sex, and model 3 for age, sex, gender, axial length, duration of diabetes, 168 haemoglobin A1c (HbA1c), mean blood pressure, cholesterol, body mass index (BMI), 169 intraocular pressure (IOP), best corrected visual acuity (BCVA, logMAR unit), and 170 OCT imaging time. We also assessed the average MCT stratified by MET tertile in

- 171 patients without retinopathy and stratified by different status of sleep duration in
- patients with retinopathy, using ANOVA. A P value of < 0.05 was considered
- statistically significant. All analyses were performed using Stata Version 14.0 (Stata
- 174 Corporation, College Station, TX, USA).

176 **RESULTS**

177 Demographic and clinical characteristics

178 A total of 232 participants (116 in each group) who met inclusion/exclusion criteria

179 were included in the final statistical analyses. The demographic and clinical features

of the participants are shown in Table 1. The mean age was 64.2 ± 7.2 years, and

- almost half of them were male. The patients with and without DR did not differ in
- 182 most demographic and clinical parameters, except for higher systolic blood pressure

in DR patients (136.6 \pm 19.5 mmHg versus 130.4 \pm 16.0 mmHg, P = 0.009).

185 Physical activity, sitting time, and OCT parameters

186 Figure 1 shows that higher MET was associated with increased choroidal thickness,

with average MCT 167.9 \pm 9.9 μ m for the first tertile, 198.3 \pm 10.9 μ m for the second

tertile, and $214.5 \pm 12.4 \,\mu\text{m}$ for the third tertile (P < 0.001). The results of the linear

regression of MET with OCT parameters are summarized in Table 2. There was a

positive correlation of average MCT and MET in the DR group ($\beta = 1.561, 95\%$

- 191 confidence interval (CI): 0. 653 to 2.469, P = 0.001). In further adjusting of other
- factors, MET remains significantly associated with average MCT (P = 0.005 in model
- 193 2, P = 0.006 in model 3). None of the other OCT parameters—mRNFL thickness,

194 GC-IPL thickness, retinal thickness, pRNFL thickness, and pCT—were significantly

related to MET. The MET was not related to any OCT parameters in NDR patients.

196 Moreover, when we considered sitting time as another parameter to reflect physical

197 activity, no significant correlations were found between it and all OCT parameters in

198 both groups (Table 3).

200 Sleep duration and OCT parameters

201 For patients with NDR, average MCT was positively correlated with sleep duration (β 202 = 16.02, 95% CI: 4.76 to 27.28, P = 0.006), as shown in Figure 2A. The average MCT 203 was significantly different among the three subgroups ($167.2 \pm 20.0 \mu m$ versus 209.7 204 \pm 9.6 µm versus 247.0 \pm 21.3 µm, P < 0.001). The results of linear regression of sleep 205 duration and OCT parameters are summarized in Table 4. After adjusting other factors, 206 sleep duration remains independently correlated with average MCT in NDR patients, 207 with $\beta = 11.11$ (95% CI: 0.03 to 22.19, P = 0.049) in model 2 and $\beta = 10.54$ (95% CI: 208 0.96 to 20.12, P = 0.031) in model 3. For OCT parameters in patients with DR, no

significant association with sleep duration was noted (All P>0.05).

211 **DISCUSSION**

212 The present study used SS-OCT to explore the association of physical activity and 213 sleep duration with posterior segment structure in diabetic patients. The results 214 suggested a thickened macular choroid in DR patients with more physical activity, but 215 no association between sitting time and OCT parameters. We also found a positive 216 correlation between sleep duration and the MCT in individuals without DR. To the 217 best of our knowledge, this is the first study to correlate the OCT parameters centring 218 on macula and optic nerve head with physical activity and sleep duration. 219 220 The choroid provides 85% of the blood supply to the eyeball and plays a very 221 important role in normal retinal and choroidal functions. There are limited data on the 222 relationship between physical activity and retino-choroidal microcirculation.[17-20] 223 Our finding of an increased CT being associated with higher physical activity 224 indirectly affirms the previous finding that a higher level of physical activity lowers 225 the likelihood of DR due to altering the retinal microvascular function. Keel et al.[21] 226 reported an inverse correlation between physical activity and retinal venular calibre in 227 adolescents with type 1 diabetes, while Gopinath et al.[9] reported that higher levels 228 of physical activity are associated with narrower retinal arterioles. Sayin et al.[22] 229 reported that short-term dynamic exercise causes a significant increase in CT for at 230 least 5 min following exercise. However, Hong et al. [23] did not find any changes of 231 MCT in healthy subjects after 15 min on a treadmill. Alnawaiseh et al.[18] 232 demonstrated that increased physical activity induced significant changes in optic

nerve and macular perfusion. Nussbaumer et al.[24] reported that the effects of
endurance exercise on retinal vessel diameters was age- and intensity-dependent. The

findings of our study and previous studies, that physical activity may cause long-term

effects on the choroid, may be dependent on varying disease status.

As to sedentary behaviour, we found it is not related to CT and other OCT parameters.

239	Anuradha et al. reported that sedentary behaviour quantified by TV viewing time was
240	significantly associated with the retinal microcirculation in an Australian
241	population.[25] The Multi-Ethnic Study of Atherosclerosis (MESA) demonstrated
242	that television viewing time is related to retinal vascular calibre only in non-Hispanic
243	whites, but not in other ethnic groups.[10] The discrepancy of results in the
244	aforementioned studies may be related to different definitions of sedentary behaviour
245	and different ethnicities. The form of sedentary behaviour measured in the two studies
246	mentioned above was TV viewing and playing computer/video games. This may
247	cause confounding bias as time spent on electronic screens may affect retinal
248	microcirculation independently. Consistent with the MESA study, we found no
249	association of sedentary time with OCT parameters in this Chinese population.
250	
251	Sleep deprivation may play a role in the pathogenesis of DR but remains unclear.
252	Recent studies confirm that obstructive sleep apnoea syndrome (OSAS), characterized
253	as sleep disturbance, is an independent risk factor for the presence and progression of
254	DR.[12,14,26,27] Sleep duration has recently been reported to be related to DR risk,
255	and it has been well documented that CT is changed in DR patients.[28,29] This study
256	first assessed the relationship between posterior segment structures and sleep duration
257	in diabetic patients, and found a positive correlation between MCT and sleep duration
258	in diabetic patients without DR, but no significant association in DR patients. The
259	relationship between sleep and CT needs further study.
260	
261	This study suggests that more physical activity and more sleep are good for the retina
262	and may reduce the risk of the onset of DR, but the underlying pathogenic
263	mechanisms to explain these associations remain inconclusive. Hypoxemia,
264	inflammation, oxidative stress, hormonal changes, insulin resistance, and disturbance
265	of autoregulation in retinal microcirculation may possibly take part in the
266	pathogenesis of choroid alteration leading to DR.[5,28,29]
267	
268	The major strengths of the present study are: (1) the use of standardized

269	questionnaires, such as the IPAQ and PSQI, to quantify the status of physical activity
270	and sleep affords well-established reliability and validity of our data; (2) the use of
271	SS-OCT enabled us to obtain non-invasive 'optical slices' of the posterior segment,
272	including the retina and the choroid; and (3) the comprehensive consideration of
273	potential confounding factors (age, gender, axial length, duration of diabetes, HbA1c,
274	BP, cholesterol, BMI, IOP, BCVA, and OCT imaging time). This study also has
275	certain limitations. First, we only analysed the most representative parameters of
276	physical activity and sleep in the form of questionnaires, which may have recall bias.
277	More objective assessment of more complex factors obtained from wearable devices
278	may be a better method to reduce recall bias in the future.[30] Second, as this study
279	utilized a cross-sectional design, we cannot infer causality from the observed
280	associations. Further cohort studies are warranted to verify the findings of the present
281	study.
282	
283	In conclusion, the present study documented a significant relationship between
284	physical activity, sleep duration, and retino-choroidal structures assessed by SS-OCT
285	in Chinese patients with type 2 diabetes mellitus. Greater physical activity and longer
286	sleep duration were correlated with thicker macular choroidal thickness in DR and
287	NDR patients. Further studies are warranted to clarify the underlying mechanisms and
288	the role of physical activity and sleep in CT alterations and DR progression.
