

## **Diligent medical activities of a publicly designated medical institution for infectious diseases pave the way for overcoming COVID-19: A positive message to people working at the cutting edge**

Severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), which causes coronavirus disease 2019 (COVID-19), is highly infectious and has spread worldwide. An important factor compounding spread is the infection of medical staff with SARS-CoV-2, which threatens the collapse of the very institutions required to treat COVID-19. The possibility of virus transmission from patients with COVID-19 to medical staff is thus of primary concern. Asymptomatic COVID-19 carriage among hospital staff could also conceivably act as a potent source of ongoing transmission<sup>1</sup>. Here we show that, surprisingly, none of the medical staff working at a hospital with COVID-19 patients had IgG antibodies for SARS-CoV-2, indicating that transmission from patients to medical staff did not occur in these medical workers. These results show that standard preventive measures against infectious diseases can prevent SARS-CoV-2 exposure in medical staff, and should greatly encourage medical practitioners at the front line of this pandemic.

## **Methods**

On May 1, 7 and 8, 2020, sera were collected from medical staff at the Hyogo Prefectural Kakogawa Medical Center, which has 353 beds and is one of 55 publicly designated medical institutions for infectious diseases—including Ebola, smallpox, plague, tuberculosis, severe acute respiratory syndrome (SARS) and Middle East respiratory syndrome (MERS)—in Japan. The institutional review boards of Kobe University Hospital and Hyogo Prefectural Kakogawa Medical Center approved the study, and written informed consent was obtained from all participants. IgG antibodies for SARS-CoV-2 in each serum sample were analyzed by immunochromatographic test (INNOVITA, Hebei, China).

## Results

Hyogo Prefectural Kakogawa Medical Center began accepting patients with COVID-19 on March 11, 2020 (Fig.1). On May 1, 7 and 8, 2020, 39 (7 in ICU), 21 (8 in ICU) and 19 (7 in ICU) patients with COVID-19 were hospitalized, respectively. A total of 509 medical staff were assigned to work on these cases. The 509 medical staff consisted of 88 men and 421 women with a median age of 39 (18 to 66) years. They were 77 doctors, 310 nurses, 1 pharmacist, 20 radiology technicians, 19 laboratory medical technologists and 82 medical assistants. 115, 18, and 72 worked in the ICU, the ambulatory unit for patients with fever and the ward for patients with COVID-19, respectively. The median time from contact with patients with COVID-19 to sera collection was 23 days. All medical staff wore masks in the hospital and performed hand disinfection with alcohol after each procedure. When they collected samples for PCR or came into contact with PCR-positive patients, they wore full personal protective equipment. All sera from the medical staff were negative for IgG antibodies, indicating that none of the staff had been infected with SARS-CoV-2 despite their close contact with the patients. Sera from patients 14 days or more after onset of COVID-19 were used as a positive control and showed a 100% (10/10) positive rate for IgG.

## **Discussion**

Despite the hard work of brave medical workers around the world, many patients continue to die of COVID-19<sup>2</sup>. Unfortunately, not a few medical staff members themselves have died from nosocomial infections of SARS-CoV-2. The medical staff at the Kakogawa Medical Center have been in contact with COVID-19 patients for up to 53 days, but so far there have been no incidents suspicious for nosocomial infection. Our surprising results suggest that standard preventive measures, if strictly followed, can prevent SARS-CoV-2 exposure in medical practitioners. For the first time, this study provides supporting evidence suggesting the usefulness of standard precautions against SARS-CoV-2. Although all medical workers naturally fear SARS-CoV-2 exposure, we believe the current results could help alleviate their anxiety, and could provide courage and inspiration for their fight against COVID-19.
