# 1 Changes in the stool and oropharyngeal microbiome in obsessive-compulsive

### 1 ABSTRACT

2 Although the etiology of obsessive-compulsive disorder (OCD) is largely unknown, it is accepted that 3 OCD is a complex disorder. There is a known bi-directional interaction between the gut microbiome and 4 brain activity. Several authors have reported associations between changes in gut microbiota and 5 neuropsychiatric disorders, including depression or autism. Furthermore, a pediatric-onset 6 neuropsychiatric OCD-related syndrome occurs after streptococcal infection, which might indicate that 7 exposure to certain microbes could be involved in OCD susceptibility. However, only one study has 8 investigated the microbiome of OCD patients to date. We performed 16S ribosomal RNA gene-based 9 metagenomic sequencing to analyze the stool and oropharyngeal microbiome composition of 32 OCD 10 cases and 32 age and gender matched controls. We estimated different  $\alpha$ - and  $\beta$ -diversity measures and 11 performed LEfSe and Wilcoxon tests to assess differences in bacterial distribution. OCD stool samples 12 showed a trend towards lower bacterial  $\alpha$ -diversity, as well as an increase of the relative abundance of 13 *Rikenellaceae*, particularly of the genus *Alistipes*, and lower relative abundance of *Prevotellaceae*, and 14 two genera within the Lachnospiraceae: Agathobacer and Coprococcus. However, we did not observe a 15 different Bacteroidetes to Firmicutes ratio between OCD cases and controls. Analysis of the 16 oropharyngeal microbiome composition showed a lower Fusobacteria to Actinobacteria ratio in OCD 17 cases. In conclusion, we observed an imbalance in the gut and oropharyngeal microbiomes of OCD 18 cases, including, in stool, an increase of bacteria from the Rikenellaceae family, associated with gut 19 inflammation, and a decrease of bacteria from the *Coprococcus* genus, associated with DOPAC synthesis. 20 21

## 2 INTRODUCTION

3	Obsessive-compulsive disorder (OCD) is a neuropsychiatric disorder characterized by intrusive and
4	unwanted thoughts (termed obsessions) and repetitive behaviors or mental acts (called compulsions)
5	that are performed to partially relieve the anxiety or distress caused by the obsessions. The etiology of
6	OCD is largely unknown, although it likely involves a combination of genetic, neurobiological and
7	environmental factors or events. Genetic association studies, including genome-wide association
8	analysis and a multispecies approach integrating evolutionary and regulatory information, have
9	highlighted genes involved in dopamine, serotonin and glutamate signaling, synaptic connectivity and
10	the cortico-striato-thalamo-cortical circuit (CSTC) (Gasso et al., 2015; Mattheisen et al., 2015; Noh et al.,
11	2017; Servaes et al., 2017; Stewart et al., 2013).
12	Several researchers have speculated that the microbiome might also play a role in the development of
13	OCD (Rees, 2014; Turna et al., 2016). In fact, a recent pilot study of the gut microbiome in OCD has
14	observed some dysbiosis in OCD cases compared to controls (Turna et al., 2020), and a previous work
15	observed a difference in gut microbial composition in deer mice presenting an obsessive behavior
16	compared to the normal individuals (Scheepers et al., 2019), while microbial treatments such as germ-
17	free environment and probiotic treatments can modify OCD-like behavior in rodents (Bastiaanssen et al.,
18	2019), and some OCD risk factors, such as stress, pregnancy or antibiotic use, are known to disrupt the
19	gut microbiome (Rees, 2014). Moreover, it is recognized that some children, after suffering a
20	streptococcal infection, present with a sudden onset of tics, OCD and other behavioral symptoms, a
21	condition known as pediatric autoimmune neuropsychiatric disorders associated with streptococcal
22	infections syndrome (PANS/PANDAS) (Snider and Swedo, 2004).
23	There is a well-known bi-directional interaction between the gut microbiota and brain activity (Cryan
24

and Dinan, 2012; Mayer et al., 2014). Brain function can be affected by endocrine-, neurocrine- and

1	inflammation-related signals from the gut microbiota, while psychological and physical stressors can
2	affect the composition of the gut microbiome (Bailey et al., 2011; Partrick et al., 2018). Differences in
3	the composition of the gut microbiome have been associated to depression (Valles-Colomer et al.,
4	2019), autistic disorder (Liu et al., 2019a; Tomova et al., 2015; Vuong and Hsiao, 2017), or schizophrenia
5	(Schwarz et al., 2018), among other psychiatric disorders. Moreover, two studies have found differences
6	in gut bacterial distribution when OCD cases or PANS/PANDAS patients are compared to healthy age-
7	matched individuals (Quagliariello et al., 2018; Turna et al., 2020). On the other hand, some studies have
8	also shown an alteration of the oropharyngeal microbiome in patients with autism (Hicks et al., 2018;
9	Qiao et al., 2018) or schizophrenia (Castro-Nallar et al., 2015). However, so far, only one study has
10	explored a potential link between gut microbiota and OCD, and the OCD oral microbiota has not been
11	explored yet. Here, we explore the composition of fecal and oropharyngeal microbiota of OCD-patients
12	before and after treatment and compare it to healthy matched controls.
13	

#### 14 MATERIAL AND METHODS

#### 15 Sample collection

16 Thirty-eight patients (20 females; mean age=40.16±14.12, see Table 1) with a diagnosis of OCD with at 17 least one year of development were recruited from the OCD clinic at Bellvitge Hospital (Barcelona, 18 Spain) from January 2016 to September 2017. Diagnoses were assigned by two psychiatrists with 19 extensive clinical experience in OCD, following the DSM-IV criteria for OCD diagnosis (Association, 1994) 20 and using the Structured Clinical Interview for DSM-IV Axis I Disorders-Clinician Version (SCID-I) (First et 21 al., 1996). A summary of the patients' clinical data is provided in supplementary Table S1. Patients 22 presenting psychoactive substance abuse/dependence (current or in the past six months), psychotic 23 disorders, intellectual disability, severe organic or neurological pathology (excepting tic disorder), or

1 autism spectrum disorder were excluded from the study. Other affective and anxiety disorders were not

- 2 criteria for exclusion in cases where OCD was the main diagnosis.
- 3 Thirty-three healthy controls (18 females; mean age=36±9.87) were recruited from the same 4 sociodemographic environment and constituted a comparable sample in terms of age and gender (see 5 Table 1 and supplementary Table S2 for a summary of clinical information on controls). Prior to 6 inclusion, each control participant underwent the Structured Clinical Interview for DSM-IV non-patient 7 version (SCID-NP) (First et al., 2002) to exclude presence or history of any psychiatric disorder. 8 Written informed consent was obtained from all participants after a complete description of the study, 9 which was performed in accordance with the Declaration of Helsinki (2013) and approved by Bellvitge 10 Hospital's ethical committee. 11 Stool samples from 28 OCD cases at two time-points (before (OCD T0) and after (OCD T3) three months 12 of pharmacological treatment and cognitive behavioral therapy), 7 OCD cases at a single time-point (4 13 OCD T0 and 3 OCD T3), and 33 healthy subjects were collected in Stool Collection Tubes (Stratec 14 Molecular). Samples were stored at -20°C until processed. DNA was extracted using the PSP Spin Stool 15 DNA Basic Kit (Stratec Molecular). 16 Oropharyngeal swab samples, corresponding to the tonsils and the back of the throat, from 28 OCD 17 cases at two time-points, 8 single timepoint OCD cases (4 OCD T0 and 4 OCD T3) and 32 healthy 18 individuals were collected with the Catch-All sample collection swabs (Epicentre), conserved in 19 PowerBead tubes (MO BIO Laboratories), frozen at -20°C and processed for DNA extraction with the 20 PowerSoil DNA Isolation kit (MO BIO Laboratories). Details for the overlap between stool T0, stool T3, 21 oropharyngeal T0 and oropharyngeal T3 samples are provided in Figure S1. 22 Sample sizes were deemed appropriate for this exploratory approach considering previous similar 23 studies of microbiota involvement in other psychiatric disorders (Castro-Nallar et al., 2015; Qiao et al.,

2018; Quagliariello et al., 2018; Schwarz et al., 2018; Tomova et al., 2015; Turna et al., 2020), performed
 with similar sample sizes.

3 All participants were asked to provide dietary information through a questionnaire (supplementary

- 4 tables S3 and S4). Severity of the obsessive and compulsive symptoms before and after treatment
- 5 among the OCD patients was assessed through the clinician-administered version of the Yale-Brown
- 6 Obsessive Compulsive Scale (Y-BOCS) (Goodman et al., 1989). A global measure as well as independent
- 7 ones for both obsessions and compulsions were taken. Table 1 and supplementary Tables S1 and S2
- 8 summarize the main characteristics of the OCD and control cohorts.

### 9 Sequencing and data analysis

10 16S ribosomal RNA (rRNA) sequencing was performed by the UPF Genomics Core Facility following

11 Illumina's protocol with slight modifications. Briefly, in each sample, the variable V3-V4 region of the 16S

12 rRNA gene was amplified for 35 cycles using the primers described in Klindworth et al. (Klindworth et al.,

13 2013) and Platinum High Fidelity Taq (Thermofisher) and purified, followed by 8 cycles of indexing PCR,

14 and quantification. The indexed products were then pooled in an equimolar way in two final amplicon

15 libraries (one for stool and one for tonsils), each containing 96 samples. Each library was sequenced in

16 one 2 x 300 bp paired-end sequencing run on a MiSeq System.

17 The DADA2 R package (version 1.6.0) (Callahan et al., 2016) was employed to obtain counts of amplicon

18 sequence variants (ASV), and sequence taxonomy was assigned using the SILVA database (Yilmaz et al.,

19 2014). Resulting ASV counts, along with clinical data and diet information collected for each individual,

20 were stored and analyzed using the Phyloseq package (version 1.22.3). 16S counts were normalized per

21 sample, obtaining the relative abundance of each taxon within a sample, with all values ranging

22 between 0 and 100.

23 We estimated different  $\alpha$ - (within samples) and  $\beta$ -diversity (between samples) measures using the

24 Phyloseq, picante and vegan R packages (see supplementary material for details). α-diversity indices

included the Shannon and Simpson Diversity Index, Faith's phylogenetic diversity, the observed species
index, the Chao1 index and the ACE (Abundance-based Coverage Estimator) index. β-diversity measures
included Unifrac distances, the Bray-Curtis dissimilarity, Jensen-Shannon diversity and Canberra indices.
We performed a PERMANOVA test on β-diversity with 999 permutations considering even dependence
of samples (paired OCD samples after and before treatment). Finally, we applied a Principal Coordinate
Analysis (PCoA) to visualize the clustering of the samples.

# 7 Statistical analysis

8 Correlation between categorical variables (i.e. sample type, type of obsessions, etc.) and taxa 9 abundances or other continuous variables was tested using the Kruskal-Wallis rank sum test, and 10 correlation between two categorical variables was tested using Chi-squared tests. Statistical significance 11 of  $\alpha$ -diversity differences between groups was evaluated with Mann–Whitney U test when samples 12 were independent, and with Wilcoxon rank-sum test when samples were paired. In all cases, we applied 13 the Bonferroni correction to adjust the p-values by the number of comparisons and provide only 14 corrected p-values. Correlation plots and boxplots were generated using *qqplot2* (version 2.2.1) and 15 association plots were generated using the assoc function from the R package vcd (version 1.4.4). 16 Linear discriminant analysis Effect Size (LEfSe) was performed using the Huttenhower lab's tool 17 implemented in Galaxy web (Segata et al., 2011). For the statistical test we used an  $\alpha$  value of 0.05 and a logarithmic LDA score threshold of 2.0. 18 19 20 21 22 23

### 1 **RESULTS**

2	High-throughput sequencing analysis of bacterial 16S rRNA V3–V4 regions was conducted on fecal and
3	oropharyngeal samples of the 32 OCD (two timepoints) and 33 control individuals (see Figure S1). In
4	total, 8,653,960 high-quality reads (90,145.42 ± 15,356.44 reads/sample) were obtained from all 96 fecal
5	samples, representing 196 operational taxonomic units (OTUs) when considering all samples, while each
6	sample had, on average, 91.77 ± 17.51 OTUs. For the 96 oropharyngeal samples, 6,051,021 high-quality
7	reads (63,031.47 ± 16555 reads/sample) were obtained, representing 81 operational taxonomic units for
8	all samples, with an average of $32.22 \pm 9.29$ OTUs/sample.
9	While statistical analyses revealed some differences between cases (at T0 and/or at T3) and controls, no
10	statistically significant differences were identified when comparing OCD cases before and after
11	treatment (T0 vs T3). On the other hand, we observed some association between some of the diet
12	variables and taxa abundances, but there were no significant associations between the variables
13	collected in the diet questionnaires and whether the individual belonged to the OCD or control group,
14	which suggests that the taxa differences between OCD cases and controls may be influenced by the OCD
15	phenotype, rather than by other variables.
16	OCD samples show a trend towards lower bacterial $\alpha$ - diversity in the gut

Analysis of the microbial composition of the gut showed that OCD T0 samples presented an overall lower level of all  $\alpha$ -diversity indices compared to the control group, although no test reached statistical significance after adjusting for multiple testing (Bonferroni adjusted p-value = 0.057) (Figure 1A). These differences were reduced in the OCD T3 group. On the other hand, we did not observe a strong separation of sample groups based on the  $\beta$ -diversity measures (Figure S2), and there were no statistical differences between the Bacteroidetes to Firmicutes ratio when comparing OCD samples to controls (Wilcoxon rank-sum test Bonferroni adjusted p-value = 0.0653; Figure 2A). In all three groups, the 20

most abundant genera belonged to either the Bacteroidetes or Firmicutes Phyla, while at the family
level there was also representation of *Proteobacteria*, *Verrucomicrobia* and *Actinobacteria*, albeit at very

3 low abundances (Figure S3).

4 LEfSe results reveal an enrichment for *Rikenellaceae* and depletion of *Prevotellaceae*, and a shift from

5 *Coprococcus* to *Flavonifractor* within the Clostridiales in the gut

6 LEfSe analysis revealed a significant increase of the relative abundance of *Rikenellaceae*, particularly of 7 the Alistipes genus, and a decrease in the levels of Prevotellaceae, in OCD TO stool samples compared to 8 controls (Figure 3). We also observed a different distribution of bacteria from the order Clostridiales, 9 where OCD TO samples presented a higher abundance of the genera Oscillibacter, Anaerostipes and 10 Flavonifractor, and a depletion of Agathobacter, Coprococcus, Lachnospira, Howardella, Romboutsia, 11 Butyricicoccus and Clostridium compared to controls. In addition, within these, depletion of Lachnospira pectinoschiza correlated with OCD severity on the obsessions subscale (YBOCS OBS 0 vs Species 12 13 Lachnospira pectinoschiza r = -0.420). Relative abundances in stool samples from cases and controls for 14 these taxa are presented in Table S5. Most of these differences are also present when comparing OCD

15 post-treatment samples versus controls (Figure S4).

#### 16 In the oropharyngeal microbiome, OCD samples show a lower Fusobacteria to Actinobacteria ratio

Again, in the analysis of the oropharyngeal microbiome,  $\alpha$ -diversity indices did not show significant differences between the OCD and control groups (Figure 1B). Similarly, we did not see any separation of sample groups based on most  $\beta$ -diversity measures (Figure S5). However, there was a significant difference in the ratio of Fusobacteria to Actinobacteria when comparing OCD samples (T0 and T3) to controls (Wilcoxon rank-sum test p-value = 0.004; c, Figure 2B), where OCD samples had lower ratios. Bacterial diversity in the oropharyngeal samples was lower than in the stool samples (Shannon diversity: Stool=  $3.17 \pm 0.46$ , oropharyngeal=  $2.46 \pm 0.45$ ; Faiths PD: Stool=  $23.18 \pm 4.00$ , oropharyngeal=  $15.25 \pm$ 

4.53). Among the 20 most abundant genera, the largest contribution belonged to the Actinobacteria and
 Fusobacteria phyla, although Epsilonbacteraeota (e.g. *Campylobacter)*, Bacteroidetes, Firmicutes and
 Proteobacteria were also represented (Figure S6).

- 5 LEfSe analysis of the oropharyngeal microbiome data revealed an increase of species within the
- 6 Actinobacteria and Coriobacteriia classes in the OCD samples: particularly, the genera Actinomyces and
- 7 *Atopobium* represented a higher percentage of total bacteria in OCD T0 compared to control samples;
- 8 there was also an increase of *Lachnospiraceae* and other Firmicutes. In contrast, control samples had a
- 9 higher percentage of bacteria from the Fusobacteriia class (Figure 4). Analysis of OCD T3 vs controls
- 10 highlighted again the increase of the Actinobacteria and Coriobacteriia (Figure S7). Relative abundances
- 11 in oropharyngeal samples from cases and controls for these taxa are presented in Table S6.
- 12 We also performed a directed analysis of enrichment of *Streptococcus* in OCD samples versus controls,
- as this genus has been shown to be associated to the onset of PANDAS (Quagliariello et al., 2018).
- 14 However, the top 15 most abundant species did not include bacteria form this genus in either OCD TO,
- 15 OCD T3, or controls.

### 17 DISCUSSION

- 18 We have performed an explorative comparative analysis of the gut (fecal) and oropharyngeal
- 19 microbiome between OCD cases (before and after treatment) and age- and gender-matched healthy
- 20 controls, via 16S rRNA amplicon sequencing.
- 21 While our analysis shows only a trend towards lower bacterial diversity in the gut of OCD patients which
- 22 is not significant after correction for multiple testing, this result is consistent with the lower gut  $\alpha$ -
- diversity in PANS/PANDAS patients reported by Quagliariello et al. (2018), and in OCD by Turna et al.
- 24 (2020). Lower α-diversity has also been reported in subjects with attention deficit hyperactivity disorder

1 (Prehn-Kristensen et al., 2018), and in some studies of ASD individuals (Kang et al., 2018; Kang et al., 2 2013; Liu et al., 2019b), although it is not consistently observed, and may be dependent on the cohort 3 characteristics, including sample size. Nevertheless, most of these studies, as ours, are exploratory 4 analyses with small sample sizes, which may explain differences in the specific indexes reported 5 significant. In addition, in the analysis of Quagliariello et al. (2018) they also observed, in the younger 6 subset of PANS/PANDAS patients (aged 4-8 years), a higher percentage of Bacteroidetes and lower level 7 of Firmicutes, while we did not observe significant shifts in the Bacteroidetes to Firmicutes ratio. This 8 discrepancy between our results and those of Quagliariello et al. (2018) could be related to the age of 9 our subjects, as all our patients are adults, while their study was performed on pediatric cases. However, 10 we did not observe a correlation between age and any of the taxa ratios tested. Additional analyses on 11 larger cohorts should clarify the observed trends. 12 The Wilcoxon and LEfSe tests performed here highlighted differences in OTU abundances in the gut: 13 interestingly, we observed an increase of bacteria from the *Rikenellaceae* family, which had been 14 reported as a biomarker of PANDAS (Quagliariello et al., 2018). In addition, an increase in abundance of 15 Rikenellaceae has also been reported in ADHD (Aarts et al., 2017) and major depressive disorder (MDD) 16 (Jiang et al., 2015). This bacterial family and, specifically, the *Alistipes* genus, is also positively associated 17 with gut inflammation in human and mice studies (Bassett et al., 2015; Saulnier et al., 2011). Recently, a 18 study linked neuroinflammation throughout the CSTC circuit to OCD (Attwells et al., 2017). Considering 19 these observations, it is tempting to speculate a possible link between the neuroinflammation observed 20 in OCD patients and the higher abundance of Alistipes and Rikenellaceae in these patients. Finally, OCD 21 TO samples showed lower levels of bacteria of the Prevotellaceae family, similarly to reports on ASD (Liu 22 et al., 2019b).

LEfSe analysis also found specific members of the Firmicutes phylum with higher abundance in OCD TO
 samples: Oscillibacter, Anaerostipes, and Flavonifractor, and a lower abundance of Coprococcus and

1 Lachnospira; futhermore, abundance of Lachnospira pectinoschiza was also negatively correlated with 2 severity, in line with the depletion in cases compared to controls. While several of these differences are 3 maintained when comparing OCD post-treatment samples to the control group, the decrease in the 4 genus Lachnospira is not. Furthermore, Valles-Colomer et al. (2019) report a correlation of four mental 5 well-being scores (measured by the RAND-36 health-related quality of life survey) with higher 6 abundance of Coprococcus, and two of these (social functioning and emotional well-being) also correlate 7 with a lower abundance of *Flavonifractor* genus in the gut microbiota. We observe precisely the 8 opposite trend in our cohort of OCD patients, where OCD patients have lower abundance of 9 Coprococcus and higher abundance of Flavonifractor. The relative abundance of Coprococcus in the 10 aforementioned study was strongly associated with the microbial pathway for DOPAC (a dopamine 11 metabolite) synthesis. Relevantly, dopaminergic transmission has been implicated in the neurobiology of 12 OCD, as dopamine receptor agonists are effective as an augmentation therapy to selective serotonin 13 reuptake inhibitors in reducing OC symptoms (Vulink et al., 2009), and OCD patients under deep brain 14 stimulation show improvements associated with release of striatal dopamine (Figee et al., 2014). 15 However, our results are not replicating the findings by Turna et al. (2020). In their study, they observed 16 a lower relative abundance of Oscillospira, Odoribacter and Anaerostipes. We do not see a significant 17 difference for Oscillospira and Odoribacter, although a detailed look at the data show that, for 18 *Oscillospira*, a similar trend is present, with lower abundance in OCD TO samples compared to controls. 19 and an increase in abundance in OCD T3 samples (supplementary table s5, figure S8). On the other hand, 20 in the case of *Anaerostipes* we observe an increase of these bacteria as opposed to what was previously 21 reported. These differences might be explained by chance, as both studies have a small, exploratory, 22 sample size, or it could be related to dietary differences or to methodological differences in the analysis 23 between both studies.

24 We also analyzed the oropharyngeal microbiome of OCD cases and controls. While the composition of

1 the oral microbiome has received little attention in relation with psychiatric diseases, there are some 2 studies that indicate possible changes in the oral microbiota of Parkinson's disease or autistic disorder 3 (Clarke et al., 1998; Hicks et al., 2018; Mihaila et al., 2019). In addition, the bacterial composition of the 4 oral cavity might be used to represent the composition of the upper gastrointestinal tract (Tsuda et al., 5 2015). Furthermore, in this case we were particularly interested in the evaluation of the presence of 6 Streptococcus pyogenes, as a potential biomarker of OCD, as it had been associated with PANDAS 7 (Orefici et al., 2016), but we did not detect this species in our dataset. We then analyzed bacterial 8 diversity measures between cases and controls without observing an overall difference in  $\alpha$ -diversity. 9 We did observe a significantly higher Actinobacteria to Fusobacteria ratio in OCD T0 compared to 10 controls, which is still present, but reduced, after treatment. This difference correlated with an increase 11 in Actinomycetales and a decrease of Fusobacteriales observed in the LEfSe analysis. We then analyzed 12 whether the Fusobacteria to Actinobacteria ratio could be used as a proxy for the increased abundance 13 of Alistipes and Rikenellaceae in the gut microbiome, but we did not detect a significant correlation with 14 either Alistipes or Rikenellaceae. The Fusobacteria/Actinobacteria ratio was, however, correlated with 15 the presence of the *Coprococcus* genus or the *Eggerthellaceae* family (Figure S9). 16 17 While our results support an imbalance in OCD cases, both in the gut and the oropharyngeal 18 microbiome, it is not possible to establish a causal relationship, as the observed changes in the 19 microbiome can be both a cause or a consequence of the disorder. It has been shown that the brain can 20 modulate the gut microbiome by a top-down function of the gut-brain axis. For instance, the lower  $\alpha$ -21 diversity observed in OCD cases could be a consequence of the anxiety provoked by obsessions. Since 22 our study included only patients already diagnosed with OCD, it is not possible to discern between cause 23 and effect. Further studies involving animal models, larger sample sizes, longitudinal cohorts and 24 eventually, interventional experiments, should help understand the contribution of intestinal and oral

1	microbiota to obsessive-compulsive disorder. In this regard, a recent animal study points toward the
2	existence of an underlying aetiological association between alterations in gut microbiota and
3	development of obsessive-compulsive behavior (Scheepers et al., 2019). Our analysis has some
4	limitations: the study sample size is relatively small, although in line with other exploratory studies in
5	autism or depression; on the other hand, gut microbiome composition has been analyzed through the
6	bacterial composition of stool samples, which represents mostly the composition of the colon, while
7	underestimating that of other regions of the gut such as the small intestine. Nevertheless, most
8	studies on the gut microbiome use this same sample source, as it is more accessible and less
9	invasive.
10	In summary, our results and those of others indicate that the gut microbiome might be playing a role in
11	the pathogenesis of OCD, which might involve an increase in inflammation levels related to
12	overabundance of bacteria in the Alistipes genus, or be related to a decrease in abundance of Prevotella
13	and Coprococcus genera, the latter associated with the microbial DOPAC synthesis pathway. While
14	awaiting confirmation on additional cohorts, these results open the door to further explorations into
15	possible interventions directed to the modulation of both the microbiota in OCD patients or the
16	mechanisms through which they exert their effect.




each area: a. Firmicutes to Bacteroidetes ratio in gut samples from Control, OCD T0 and OCD T3


subjects. b. Fusobacteria to Actinobacteria ratio in Oropharyngeal samples from Control, OCD TO and




phylogenetic relationship of biomarkers associated with OCD and control groups through the Linear
