

**Cost effective reusable gowns for routine use in hospital and laboratory: a necessity
arising of COVID-19 Pandemic**

Reusable Gowns for routine use in hospital and laboratory: a necessity arising of COVID-19 Pandemic

Abstract:

COVID-19 pandemic caused by SARS-CoV-2 has started a paradigm shift in working in a hospital or laboratory and airborne precautions have become equally significant as universal blood and body fluid precautions. Use of PPE including surgical masks or N95FFR is becoming a norm and this has led to scarcity of PPE for healthcare workers. We have prepared gowns for healthcare and laboratory workers made from a reusable material and tested with various disinfectants and heat. The cloth could tolerate repeated exposures to heat, alcohol, hypochlorite and hydrogen peroxide, but was damaged by phenol. Since this impermeable material did not allow the air to pass, we used a cool vest made up of indigenous “Khadi” cloth with pockets containing phase change material. The cost of whole reusable assembly of gown and cap was Indian Rupees 250 (1USD=76INR). This can be used in healthcare workers in hospital and community as well as people in diagnostic and research laboratories as a cost effective PPE.

Introduction: SARS Coronavirus-2 (SARS-CoV-2) the agent that causes COVID-19 is a positive sense single stranded RNA virus belonging to subgenus Sarbecovirus of genus Betacoronavirus.¹ The disease started in China in December 2019 and has now become a pandemic. According to recent figures a total of 7.46 million people across globe have suffered from COVID-19 with 419,000 deaths.² This disease has fast emerged in India and other developing countries primarily in major metropolitan cities, but slowly spreading to smaller towns and villages as the population started migrating to their homes from cities. It is a well known fact that patients presenting with any other clinical illness may carry SARS-CoV-2 in pre clinical or asymptomatic stage³ and the routinely received respiratory and intestinal samples of such subjects may carry the virus along with other pathogen^{4,5}. This may be universally applicable to all the patients in a hospital as we do not know the COVID-19 status of a subject unless she is tested for the same. Even, the most sensitive test, RT PCR detects only 29-93% of those carrying SARS-CoV-2 in various samples.⁶ As the virus is highly infectious and may not induce the immune-protective response⁷, the chances of the virus to

be there in population will be high as endemic strain in the future. But till this happens, a lot of precautions are warranted for community as well as healthcare workers.

The route of transmission of SARS-CoV-2 is not ascertained and an April 2, 2020, expert consultation from the National Academies of Sciences, Engineering, and Medicine to the White House Office of Science and Technology Policy concluded that available studies are consistent with the potential aerosol spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), not only through coughing and sneezing, but by normal breathing.⁸ Diagnosis of COVID-19 has led to revamping of various laboratories and a number laboratories have been repurposed for COVID-19 testing. In India, Board of Governors of the erstwhile Medical Council of India have released an order recently that all the medical colleges should have a biosafety level-2 (BSL-2) laboratory for infectious pathogens in the department of Microbiology. Another report from Nature has indicated that as scientists around the world return to work, they're encountering new safety rules and awkward restrictions — and sometimes writing the protocols themselves⁹.

This paradigm shift warrants that the healthcare workers and researchers become more inclined to airborne safety in addition to universal safety precautions.

Similar to COVID-19, cough is a common feature of tuberculosis (TB) and several other diseases and precautions are most needed for laboratory diagnosis of TB. It has been recommended that Biosafety Level-1 without a biosafety cabinet may be sufficient to handle sputum samples for TB smear microscopy and cartridge based nucleic acid amplification test (CB NAAT). For COVID-19 testing the laboratories should have at least Class 2 A2 or B biosafety cabinets in BSL-2 laboratory. This has to become a norm for all the samples as the patients excrete SARS-CoV-2 in various samples⁵.

As the pandemic progresses there has been shortage of PPE including N95FFR. Recently, we conducted a study to analyse effect of various disinfecting techniques for respirators and prepared SOP for the same.¹⁰ Since disposable laboratory gowns are becoming scarce, we are proposing use of reusable in-house gowns for the laboratory as well as healthcare workers.

Material and methods: To prepare and test an in-house reusable gown we contacted Defense Research and Development Organization (DRDO) as they had been working on

selection of such material for their own PPE. (Personal Communication) After discussion, we contacted a company (AjiTech, Surat India <https://www.ajitechindia.com/>) and they agreed to provide us cloth for testing and preparation of at least 2 gowns. Before, this cloth could be used we tested its efficacy, integrity, durability, resistance to various decontamination procedures and acceptability by the end users. The vendor had claimed that this cloth, made up of polyester coated with polyurethane could be reused at least 20 times after washing.

For various tests, we made 15x15cm square pieces of the cloth.

Testing for impermeability: This was tested by making a pocket of the cloth and holding 5ml of water for 5 minutes. (photo 1)

Testing for various decontamination procedures: Various pieces of this cloth were subjected to repeated exposure to 70% ethanol, 5% phenol, 1% hypochlorite, 1% H₂O₂, boiling at 100deg C and autoclaving at 121 deg C for 15min each.

For checking its integrity and durability- After every treatment, we repeated the water holding experiment. Gross examination of the cloth was conducted every time any experiment was performed.

Acceptability by end users: The cloth was shared with the laboratory people and based on their choice we got it stitched by our hospital linen section in line with how they stitch surgical gowns for operation theater.

Results:

The cloth passed the water holding technique after treatment with all the disinfectants and heat including autoclaving, except Phenol treatment where the material was damaged. (Photo 2) Physically, there was no change in the cloth except for some insignificant creases after repeated 70% alcohol treatment. The laboratory staff liked the cloth as it was lighter than other disposable PPE they were using. However, they had an apprehension that since water could not pass through it air will also not pass. For this purpose, after brain storming session we decided to make it in the form of gown to allow air to pass from below and use it wherever air-conditioning was available in the laboratory.

Also, at the request of laboratory staff, we improvised a “Khadi” (homespun cotton) vest with four large pockets to accommodate pouches of phase change material¹¹ that was kept in refrigerator before use. “Khadi” cloth by virtue of its make absorbs sweat in warm humid climate and is well accepted in our area with such conditions.

The hospital tailor was able to stitch it into a gown by using 2.5 m of cloth. The cost for one gown was just Rs 250 at the rate of Rs 100 per meter. (1USD=76 INR)

Discussion:

The COVID-19 pandemic has started affecting the developing countries and the hospitals and laboratories have started struggling for procurement of PPE.

Hospitals have started reusing the single use PPE by using various techniques, e.g. Hypochlorite, H₂O₂, Ethylene Oxide or a combination of these. The material used for reusable PPE is not sturdy and after few uses starts to disintegrate. The material tested in the present study has been shown to sustain repeated use of disinfectants, except phenol, and heat for at least 20 times. Any of the methods can be used for disinfection of the gown. One precaution is for the use of hypochlorite as disinfectant; where after treatment the gown has to be properly washed with water otherwise it becomes stained and sticky. (Photo 3)

We also looked for the comfort of end user by stitching it in the form of a gown and using PCM inside to keep the body temperature low. JAMA had published an editorial sometime back wherein editors had asked for suggestions for the extended use or reuse of PPE¹¹. One of the authors of the present study had suggested use of vests of phase change material inside the gown to protect the wearer from heat and sweat in warm and humid climate as a comment to the editorial¹¹. Since the commercially available jacket with phase change material was not available with us, we used indigenous cloth “Khadi” that solved the issue of sweating as well. The packets of phase change material were reused after keeping them in refrigerators (not freezer) and the “Khadi” clothe was washed with soap and water.

Another item for PPE include head cap that has also been made reusable using same material. In another publication, we have also suggested reuse of N95FFR using UV-C in an

indigenously made cabinet made from materials available in the microbiology department.¹⁰

We are using reusable eye protection (Rs 300) along with other items. (Photo 4)

Conclusion: We conclude this cost effective reusable gown along with masks/respirators can be used in any area where protection from droplets/aerosols is required, including hospitals and laboratories not only during COVID-19 pandemic but beyond that as well.
