Distress among Brazilian university students due to the Covid-19 pandemic: survey results and reflections

SECTION 1

Researchers at the Shanghai Mental Health Center have created the Covid-19 Peritraumatic Distress Index (CPDI), to measure the amount of psychological suffering of the population, due to the pandemic of Coronavirus. Before our research, the survey had been applicated in China and Iran. The main objective of the study was to identify with the survey, the health and well-being of Brazilian students from different undergraduate courses at the Pontifical Catholic University of São Paulo (PUC/SP) during the Covid-19 pandemic and to test the hypothesis that medical students suffer more than students from other courses.

SECTION 2

The study provides the first empirical evidence on the level of psychological distress in Brazilian university students during the Covid-19 pandemic, practically 90% (87.92%) of the students experienced some suffering.

Abstract

The first case of infection with the new coronavirus was identified in December 2019 in Wuhan, China. In March, the World Health Organization (WHO) defined the disease epidemic as a pandemic. Thus, a quarantine was imposed by many governments. As a consequence, and given that epidemiological outbreaks of infectious diseases, such as Covid-19, are associated with psychological disorders and symptoms of mental illness, researchers at the Shanghai Mental Health Center have created the Covid-19 Peritraumatic Distress Index (CPDI), in which the results are obtained: normal, mild/moderate distress and severe distress. The main objective of the study was based on the application of CPDI, in order to identify the health and well-being of Brazilian students from different undergraduate courses at the Pontifical Catholic University of São Paulo (PUC/SP) during the Covid-19 pandemic and to test the hypothesis that medical students suffer more than students from other courses. The research is based on a cross-sectional observational study, in which we applied, using Google Forms^R, the questions contained in CPDI, among with demographic data: age, sex, educational institution, undergraduate course and school year. The Index was applied online for seven days in which a total of 654 valid responses were obtained: 501 (76.6%) female and 149 (22.8%) male. Regarding age, 333 students (50.91%) were 17-20 years old, 279 (42.66%) between 21-25, 30 (4.59%) between 26-30 and 12 (1.84%) between 31-50. The results indicate that the participants reported significant psychological distress, according to the CPDI score. Practically 90% (87.92%) of the students experienced suffering, while only 12.08% did not suffer. The study provides the first empirical evidence on the level of psychological distress in Brazilian university students during the Covid-19 pandemic. Also, it suggests support and monitoring of university students during and after the pandemic, with effective and efficient intervention in their mental health.

INTRODUTION

The first case of infection by the new coronavirus was identified in December 2019, in Wuhan, China¹. Since then, cases have spread rapidly across the world. In February, Brazil's first case was identified in São Paulo. At April 24, 2020, in the country, there were 52,995 confirmed cases and 3670 deaths, while in the world the number of cases totals 2.79 million and a total of 196 thousand deaths². In March, the World Health Organization (WHO) defined the disease epidemic as a progressive pandemic.³

Covid-19, the name given to the disease caused by the new coronavirus, SARS-CoV2⁴, despite not having its pathophysiology completely elucidated, presents with a clinical picture of pneumonia, fever, difficulty breathing and pulmonary infection^{5,6}, associated with a disseminated intravascular coagulation (DIC) ^{7,8}. As it is a disease whose transmissibility occurs through one sick person to another or through close contact⁹, the best form of prevention is social isolation¹⁰. Therefore, quarantine was established by many governments. As a consequence, and given that epidemiological outbreaks of infectious diseases, such as Covid-19, are associated with psychological distress and symptoms of mental illness^{11–13}, many people have their lives impacted and this should have an important impact on their health, since in 1947 the WHO developed the concept of health as "a state of complete physical, mental and social well-being and not just the absence of disease or infirmity" ¹⁴. For instance, it is worth mentioning that medical students in China, during the pandemic, experienced more stress and anxiety.¹⁵

Researchers at the Shanghai Mental Health Center, during the epidemic, developed a questionnaire to research and assess the level of peritraumatic distress specific to Covid-19. The word distress represents an act or effect of suffering, physical pain, anguish, affliction, bitterness, patience and resignation 16 . The questionnaire, called the Covid-19 Peritraumatic Distress Index (CPDI), has a ranking from 0 to 100. A score between 28 and 51 indicates mild to moderate psychological distress. A score \geq 52 indicates severe psychological distress. CPDI inquires about the frequency of anxiety, depression, specific phobias, cognitive change, avoidance and compulsive behavior, obsessive thoughts, physical symptoms and loss of social functioning. The questionnaire's reliability criterion, verified by the researchers, is based on Cronbach's alpha coefficient, which, in this case, is 0.95 (p <0.001) $^{.17}$

The main objective of the study was based on the application of the Covid-19 Peritraumatic Distress Index, in order to identify the health and well-being of Brazilian students from different undergraduate courses at the Pontifical Catholic University of São Paulo (PUC/SP) during the Covid-19 pandemic and to test the hypothesis that medical students suffer more than students from other courses. Besides that, quantify the prevalence and severity of psychological distress in the sample studied, and therefore provide data to adapt and implement relevant mental health intervention policies to deal with this challenge in an efficient and effective manner, prioritizing assistance to psychologically affected people.

METHODS

The survey was approved by the ethic committee of Pontifical Catholic University of São Paulo, was voluntary, and we assured the participants confidentiality and anonymity of their responses, evidenced by the free and informed consent term (can be seen in the appendix), in which the participants had to read and accept it in order to answer it.

The inclusion criteria used were undergraduate students, specifically from the Pontifical Catholic University of São Paulo, using the electronic form. Those who were not undergraduate students enrolled at the Pontifical Catholic University of São Paulo were excluded, as well as those who, perhaps, were not actively enrolled.

The study uses a cross-sectional observational analytical primary study design, evaluating medical students and other undergraduate courses at PUC/SP. To them it was sent a semi-structured and self-administered questionnaire, answered electronically, using Google Forms^R, with the questions contained in CPDI along with demographic data: age, gender, educational institution, undergraduate course and the respective academic year.

The Questionnaire contains 24 questions, each of which has 5 answers, whose score is 0 to 4 points for each question. At the end of the questionnaire, the result is obtained from the sum of the answers in addition to the sum of 4 more points. Finally, the points of the responses of each participant, individually, will be added to reach a score. Thus, the compiled data will be analyzed according to the following statistics:

1. Description of the distribution of absolute and relative frequencies of the variable degrees of suffering, age, gender, course and grade;

- 2. Description of the mean and standard deviation of the suffering score variable.
- 3. Analysis of differences in suffering scores according to age, gender, course and grade, with special attention to the medical school and its boarding school, using linear regression.

For all tests, a significance level of 0.05, bilateral, were adopted.

The English and Portuguese versions of CPDI, as well as its scoring key can be found in the appendix.

RESULTS

The COVID-19 Peritraumatic Distress Index (CPDI) was applied online for seven days, from 12 May 2020 to 18 May 2020, in which a total of 764 responses were obtained. Of these, 110 were excluded, as these participants did not belong to the group of students at the Pontifical Catholic University of São Paulo (PUC/SP), a mandatory inclusion criterion. Thus, the total of valid responses analyzed was 654, among them: 501 (76.6%) female, 149 (22.8%) male and 4 (0.6%) preferred not to say the gender. Regarding age, 333 students (50.91%) were between 17 and 20 years old, 279 (42.66%) between 21 and 25 years old, 30 (4.59%) between 26 and 30 years old and 12 (1.84%) between 31 and 50 years old. Concerning the scores, 87.92% of the entire sample presented some level of psychological distress (52.90% mild/moderate and 35.02% severe). Regarding graduation, responses were obtained from 27 different courses (Table 1).

DISCUSSION

The results indicate that the participants reported significant psychological distress, according to the CPDI score. Practically 90% (87.92%) of the students experienced suffering (52.90% of the participants with scores between 28 and 51, and 35.02% with scores ≥52), while only 12.08% did not suffer, obtaining a mean of 45.70, with a standard deviation (SD) of 14.88, in a total sample of 654. The results are alarming, especially when compared to those of the Chinese and Iranian studies, whose means were 23.65 (SD: 5.45) and 34.54 (SD: 14.92), respectively.

It is important to point out that when the research was started the state of São Paulo, where the University is located, in Brazil, was already in its 50th day of

quarantine, and according to the Ministry of Health, it already had 47.719 cases infected by Covid-19 in the state, in addition to 177.589 confirmed cases and 12.400 deaths in the country. Based on these data, it is possible to speculate a correlation between the increase in psychological distress and these stressors.

Through statistical analysis of multiple linear regression, a high rate of peri traumatic distress was associated with the female gender, with undergraduate courses that not Medicine and with non-medical interns. The women who responded showed higher psychological distress when compared to men (mean (SD) = 47.14 (14.42) vs 40.83 (15.41), p = 0.001, 95% CI 1,26 to 2,50), which enhances the results from previous research which concluded that women are much more vulnerable to stress and more likely to develop post-traumatic stress.¹⁹

Medical interns reported a lower score of suffering compared to non-intern students (mean (SD) = 50.12 (13.11) vs 38.04 (14.02), p = 0.001, 95% CI 3,16 to 4,14) and to students from other courses (mean (SD) = 42.20 (14.82) vs 46.48 (14.79), p = 0.004, 95% CI 1,26 to 2,69). This suggests that the level of health knowledge, specifically the medical one, is a protective factor.

Age did not appear to be a significant predictor of psychological distress (p=0.738), as occurred in a Chinese study sample.²⁰

The study has certain limitations. First, the research is based on a cross-sectional observational study. Therefore, there was no follow-up of individuals. Second, our sample does not reflect the national college students, since the objective was to evaluate the students from PUC/SP. Third, although there were responses from several undergraduate courses at the University, some of them presented a very small sample number, such as Communication and Multimedia (0.153%), Data Science and Artificial Intelligence (0.153%), Theology (0.306%), Philosophy (0.306%), when compared to other courses, such as Medicine (18.196%).

The study provides the first empirical evidence on the level of psychological distress in Brazilian university students during the Covid-19 pandemic. The results demonstrate a significant psychological disorder in the participants. Therefore, the study suggests support and monitoring of university students during and after the pandemic, with effective and efficient intervention in their mental health, such as (1) greater attention to vulnerable groups, such as women, non-medical interns and students of others courses that not Medicine; (2) University strategy, with planning

and coordination for psychological and medical care and assistance for psychologically affected students, in an accessible and free way; (3) future monitoring, in order to ensure longitudinal monitoring of those with psychological distress, as well as an active search for new cases; (4) joint efforts with other universities, expanding the screening of students with some level of mental distress or mental anguish.
