2 **Gender as a Social Determinant of Menstrual Health: A Mixed Methods**
3 **Study Among Indian Adolescent Girls and Boys**

10 **Abstract:** Gender bias in the patriarchal Indian society becomes evident in the form of worse
11 sexual and reproductive health outcomes for girls than boys. While girls face menstrual
12 taboos that affect their health, boys' understanding of, and participation in, the menstruation
13 discourse remains limited. We investigate how gender through its micro-interactional and
14 macro-structural ways makes menstruation a gendered experience for adolescents; how
15 various social determinants influence girls' gendered menstruation experience across social
16 domains; and whether the lived gendered experience of menstruation harms girls' health.
17 Using a sequential mixed-methods design semi-structured interviews of 21 boys and girls
18 each; 12 adult key-respondent interviews; and a cross-sectional survey of 1421 adolescents
19 from urban, rural and tribal settings of Nashik district, India, were conducted. Applying
20 social constructivist theory and gender analysis framework, we thematically analysed the
21 qualitative data. Multivariable regression analysis of survey data yielded risk ratios.
22 Adolescents' experience of menstruation was gendered. Fewer boys (versus girls) reported
23 receiving information in schools [Incidence Rate Ratio (IRR) at 95% CI: 0.34 (0.24, 0.49)].
24 Girls' gendered menstrual experiences varied across social domains and various

25 socioeconomic backgrounds. Girls' menstrual health was poorer among those with a lived
26 experience of gendered menstruation [IRR: 0.22 (0.05, 0.90)]. Key respondents shared the
27 need to engage boys in the menstruation discourse though apprehensive regarding its
28 consequences. Gender bias along with other social factors negatively influence social
29 construction regarding menstruation. Further, the discrimination is embodied by girls as poor
30 health, thus perpetuating health inequalities across socioeconomic settings.

34 **Background:**

35 Indian girls and boys face several sexual and reproductive vulnerabilities that can
36 harm their health during the transformative yet turbulent period of adolescence when their
37 gender identities are still being shaped. While Indian girls showed a greater prevalence of
38 genital infections and lower awareness regarding HIV/AIDS as compared to boys/young men
39 (International Institute for Population Sciences (IIPS) and Macro international, 2007); a
40 smaller proportion of boys than girls knew that a woman can get pregnant at first sex
41 (International Institute for Population Sciences (IIPS) and Population Council, 2010).
42 Additionally, our finding corroborates the NFHS-4 finding that girls' constrained mobility
43 and decision-making affects their healthcare seeking ability (International Institute for
44 Population Sciences (IIPS) and Macro international, 2007; National Family Health Survey-4,
45 2017).


46 The resulting inequalities highlighted, frequently by sex-disaggregated datasets, are
47 informative to policy-makers, yet incomplete unless gender itself is recognised as a social

48 factor contributing to these inequalities. For instance, the observed differences could be
49 wrongly interpreted as solely rooted in sex-linked biology (Dube, 1988; Gender and Health
50 Group, 1999; Krieger, 2003; Morgan et al., 2016; Nowatzki & Grant, 2011). Moreover, to dig
51 deeper into why certain social experiences, and opportunities, differ systematically for girls
52 and boys, it is essential to understand the intersection of the processes driving gender
53 inequalities with other socioeconomic inequalities (Hankivsky, 2012; Lorber & Moore,
54 2002). In the patriarchal Indian society, such interlinks create structural inequalities where
55 girls and boys have unequal access to resources, and unequal norms hamper girls' ability to
56 question the gendered nature of their body and self (Dube, 1988; Thapan, 2001). Studies from
57 Odisha show that girls face sanitation insecurity because physiological processes such as their
58 menstruation and urination are governed by these intersecting inequalities (Caruso et al.,
59 2017; Sahoo et al., 2015). For instance, socioeconomic inequalities were found to intersect
60 with gender inequalities as women from lower socioeconomic strata could not find a private
61 space to change their menstrual cloth or felt apprehensive as they faced drunken men while
62 they walked to remote places to relieve themselves. Additionally, many Indian girls face
63 menstrual taboos and strict norms within households and in the community; remain deprived
64 of hygienic facilities at home and in public; and therefore, menstruation becomes a burden for
65 girls (a Dasgupta & Sarkar, 2008; Kotecha et al., 2009; Narayan et al., 2001; P. Sharma et
66 al., 2008; Singh, 2006). For instance, a study found that about 85% of school-going girls from
67 West Bengal (n=160) faced menstruation-related restrictions (A. Dasgupta & Sarkar, 2008);
68 about 75% of girls from Haryana (n=582) could not afford sanitary napkins ((V. Sharma et
69 al., 2013); about one in four Indian girls miss at least a day in school during menstruation
70 (van Eijk et al., 2016) and 43.46% older adolescent girls from Sikkim (n=1031) reported
71 menstrual illness (Mishra & Mukhopadhyay, 2012).

72 On the other hand, to our knowledge, except for a few qualitative studies, Indian boys
73 are largely excluded from menstrual health research, furthering the understanding that
74 menstruation is a “women’s topic” and missing avenues for including boys who not just play
75 a role in health but in several facets of girls’ and women’s lives throughout the life-course (S.
76 E. Mahon et al., 2015; Mason et al., 2013). A concern is that not recognizing menstruation as
77 a gendered social experience that is potentially embodied by girls in the form of menstrual
78 illnesses risks perpetuating gender inequalities in health.

79 Therefore, we investigate (Figure 1.1): (i) In what ways does gender determine
80 adolescents’ menstruation-related knowledge, experiences and beliefs; (ii) whether girls’
81 social experience of menstruation is gendered and varies across social domains; (iii) whether
82 a gendered experience of menstruation impacts girls’ menstruation-related beliefs and health.

83 **Figure 1.1.: Conceptual Model for this chapter**





86 **Theoretical Frameworks**

87 In addition to applying a broader lens of social construction of gender and the social
88 determinants of health framework, we attempt at unravelling the minute ways in which
89 adolescents learn and make sense of menstruation. To understand how menstruation is a
90 gendered experience and how it impacts health, we used a gender analysis framework (Figure
91 1.2) that was put together by referring to: (i) the gender analysis toolkit for health systems
92 (Jhpiego, 2016) and, (ii) the guidelines for analysing gender and health (Gender and Health
93 Group, 1999).

96 The theory of social construction of gender helped to understand the minute ways in
97 which adolescent girls and boys, make sense of menstruation and its gendered nature
98 (Fingerson, 2006; Tolman et al., 2003). To further study how it becomes a subject of
99 concealment, we treated gender as a process by its ability to be produced and reproduced
100 through everyday social engagements with its ability to order social life by creating subtle
101 hierarchies (Fingerson, 2006; Lorber, 1994; Lorber & Moore, 2002; West & Zimmerman,
102 1987). This helped us theorize how gender through its micro-interactional and macro-

103 institutional ways makes menstruation a discriminatory experience for girls and an
104 exclusionary experience for boys (Ridgeway, 2009).

105 By using a gender analysis framework, we attempt to study how a gendered
106 construction of menstruation operates and affects adolescent health (Nowatzki & Grant,
107 2011; Tolman et al., 2003). This framework helps examine gender power relations and its
108 impact on menstruation-related health outcomes by questioning how gender-specific social
109 roles, and society's preferential inclusion and exclusion of a particular gender in the
110 allocation of menstruation-related information and resources, influence adolescents' social
111 construction of menstruation in a step-by-step manner in the research process. We use
112 gender-differences in menstruation-related outcomes as a trigger and question their
113 unjustness (Gender and Health Group, 1999; Tolman et al., 2003).

114 **Methods**

115 **Study site**

116 Our research was carried out in the north-west part of Maharashtra state in India in Nashik
117 district, with a contrasting characteristic of having a high Human Development Index (0.746)
118 and some of the poorest inlands in the state (Jayachandran, 2014). The district has one of the
119 largest tribal populations in the state with substantial socioeconomic heterogeneity
120 (International Institute for Population Sciences (IIPS), 2014; International Institute for
121 Population Sciences (IIPS) & ICF, 2017; Nashik District Collectorate, 2017).

122 **Study design**

123 In this sequential mixed-methods study, we used a combination of an exploratory as well as
124 explanatory approaches (Byrne, 2009). In the first phase, we conducted semi-structured
125 interviews (adolescents aged 13-19 years and key-respondents) and focus group discussions
126 (henceforth, FGDs) (separately for girls and boys). The emerged themes and observations

127 from the qualitative data guided the survey questionnaire. A school-based cross-sectional
128 survey using a sequential mixed methods design (Qual→ Quant→ qual), as described by
129 Creswell et al. (2013), was carried out to capture the gender differences in menstruation-
130 related outcomes, gendered experience and its impact on health among girls. A short post-
131 survey qualitative phase was carried out to receive feedback on our survey findings. We
132 integrated the quantitative and qualitative results to mix at the interpretation stage. This helped to
133 bring forth the intricacies and patterns in the data as the complementary attributes of both the
134 quantitative and qualitative (singular) methods were used (Onwuegbuzie & Johnson, 2006).

135 Qualitative phase 1

136 Sampling of the 13-19 years old adolescent girls and boys was done using a mix of snowball
137 and purposive sampling from three sub-district administrative divisions. Total 21 boys, 21
138 girls and 12 key-respondents (4 parents/ guardians, 3 teachers, 5 healthcare providers
139 including a gynaecologist, an Ayurveda doctor, a homeopath, a nurse and a psychologist)
140 were interviewed for about 25-45 minutes, nine FGDs lasting for 50-80 minutes were
141 conducted in a familiar yet private place in schools, homes, or at workplaces (with the
142 exception of one FGD that was conducted at a local non-governmental organization working
143 on sanitation). Except for three boys' interviews and one girls' FGD who seemed nervous to
144 record their responses, all other interviews were audio-taped.

145 In each interview and FGD, after a general introduction, participants were slowly directed
146 towards the topic. Data were collected until data saturation was achieved. For this sensitive
147 topic, we took care of the participants' comfort by recruiting a male interviewer with a past
148 experience with health-based grass-root level work in Maharashtra to talk to male
149 participants. However, a female interviewer was present in addition to a male moderator for
150 three interviews and three FGDs of boys. Through thick description for verbal as well as non-

151 verbal responses we noted the perceived differences in boys' responses for the
152 presence/absence of the female researcher.

153 **Survey questionnaire formation**

154 A field-test for the survey question-bank was carried out among 35 boys and girls. The
155 questionnaire was modified according to the feedback received and was translated into
156 Marathi; back-translated into English and was checked for content validity by experts.

157 **Survey**

158 **Sampling and population**

159 Initially, a list of schools stratified by setting (urban/rural/tribal) and type (government/
160 private aided/ private unaided) was prepared for participants' selection from various
161 socioeconomic settings (Goyal & Pandey, 2012). The sample size for the survey was
162 calculated based on a maximum and the minimum expected prevalence for possible outcomes
163 which was compared for adolescents' subgroups using a two-sided test with 80% power. We
164 required 1500 participants with 10% non-response, of which we could collect the data from
165 1491 participants. The analytical sample for the study was 1421 as the data of 70
166 premenarchal girls was excluded.

167 We could collect the survey data from 27 out of 35 approached schools through snowball
168 sampling that covered about 2.5% of secondary schools in the district [28]. Students from
169 different educational divisions with alternate roll numbers /alternate seats were chosen as
170 participants. A research assistant (RA) and a school staff-member ensured smooth
171 administration of the survey. In few cases, RA had to read out the questions in-person for
172 participants with reading difficulty. More details regarding methodology could be found in
173 another paper by (Gundi & Subramanyam, 2019).

174 *Variables of Interest*

175 The choice of the variables was guided by the findings from the pre-survey qualitative phase
176 and the overall conceptual model for this study.

177 The outcome variables used were- knowledge (possesses/does not possess), and beliefs
178 (favorable/unfavorable) regarding menstruation. Menstrual health status, a composite
179 variable, was used as a binary outcome variable (no complaints regarding menstrual
180 health/any complaint). The predictors used were (i) gender (boys/girls), (ii) received
181 information in schools (yes/no) and (iii) comfort asking questions on menstruation to teachers
182 (lack of complete comfort/ complete comfort) and (iv) the lived experience of gendered
183 menstruation among girls, a composite variable operationalized as a binary variable
184 (gendered experience/not) was used as a predictor. The gendered experience of menstruation
185 (among girls) was captured using five separate variables depicting girls' menstruation-related
186 social experiences within households, schools, and communities.

187 *Covariates*

188 Age (early/late adolescents), caste [general (socially privileged caste-group)/other],
189 and religion (Hindu/non-Hindu) and mother's occupation (farmer, daily wage worker,
190 employed, self-employed), and father's occupation (farmer, daily wage worker,
191 employed/self-employed, other) were used as covariates. The details regarding variables are
192 found in Appendix 1.

193 Five girls (of which, 2 were married) and three key respondents (a female tribal-village head,
194 a sex education expert and a social worker) were interviewed for post-survey qualitative
195 phase, to seek their feedback on our study findings. Despite efforts, we were unable to recruit
196 school dropout boys due to lack of parental consent.

197 **Ethical considerations**

198 Ethical approval was obtained from the IIT Gandhinagar Institutional Ethics Committee prior
199 to the study. School authorities were approached in advance to discuss survey objectives and
200 detailed procedure. Prior verbal consent was obtained from parents/guardians by the school
201 representatives, as suggested by the school authorities. After obtaining the consent, we were
202 invited by the school authorities to collect the data. Participants were told the aim and the
203 voluntary nature of participation. Verbal consent from students' parents/guardians was
204 requested to be acquired by the school representatives. Adolescents' verbal consent/ assent
205 (depending upon their age) was sought prior to their participation in the qualitative
206 interviews/FGDs or survey. They could choose either English or Marathi survey form.

207 They were informed that they could ask any queries at any point and that they can ask us to
208 stop the audio taping if they wished to speak off-the-record. They were also told that they
209 could withdraw from the study at any point without any consequences. The anonymity of the
210 survey and the confidentiality of the data was maintained throughout the study. More details
211 are found in other paper (Gundi & Subramanyam, 2019).

212 **Analysis**

213 **Qualitative data analysis**

214 After we transcribed and translated the recorded data into English, we got the translation
215 verified by an expert to ensure that the translation did not lose nuanced meanings. The data
216 was then analyzed using thematic analysis (Braun et al., 2019). After a thorough reading of
217 the transcripts, through open coding we identified meaningful statements or words with
218 similar findings to create labels. Then through axial coding, any association between labels
219 was identified (Terry et al., 2017). Later, we converted the selected codes into shorter codes
220 and created the categories with shared meanings. We also ensured data triangulation by

221 including member (participant) rechecking and peer checking. Additionally, a deep
222 engagement with the participants and key participants' interviews further strengthened data
223 triangulation (Terry et al., 2017; Willig & Rogers, 2017).

224 **Quantitative data analysis**

225 The data were cleaned, labelled and the descriptive statistics of the main variables were
226 calculated. A generalized linear model with a logarithmic link function and binomial
227 distribution for the residual were fit as a form of log binomial regression models that
228 produced prevalence ratios for the binary dependent variables at an alpha value of 0.05. We
229 accounted for school-level clustering by using robust standard errors in the regression
230 analysis. In case the models did not converge, Poisson regression models with survey
231 commands were used to model the incidence rate ratios (equivalent to prevalence ratios in
232 this study). The unadjusted model (model 1) was adjusted for age, setting, gender (wherever
233 they were significant) in model 2. Model 3, following our conceptual model, included
234 parental socioeconomic status and school type. The findings were tested for the exclusion of
235 non-significant predictors as a part of sensitivity analysis. STATA version 12 was used for
236 data analysis (StataCorp, 2012).

237 **Results**

238 **Qualitative phase 1**

239 *Gendered Experience of Menstruation in Different Domains of Life*

240 Girls' gendered social experience of menstruation cut across different social domains
241 such as households, schools, and neighborhoods. Most girls faced severe restrictions within
242 households than in schools/ communities as they were expected to hide their menstrual status
243 and absorbent from men in the family.

244 Several menstruating girls across different settings and socioeconomic backgrounds
245 were either prohibited from or felt awkward while interacting with men. Although restrictions

246 were reportedly becoming less rigid as compared to earlier generations, a few girls expressed
247 an inability to overrule or question these gendered norms.

248 “I am not allowed to offer any food to men in the family and I am required to sit
249 away during meal-time”

250 “Why do you think you are required to follow this?”

251 “...umm.. (pause)... because of having periods...”

252 “I understand, but why do you have to follow this when you have your periods?”

253 “..I am not really sure...”

254 “Do you think you can ask this question to your mother?”

255 “No...I don’t think I can... (smiles)”

256 - Komal (14 years, urban setting)

257 However, this largely pervasive gendered experience was not found to be analogous
258 in all domains. For instance, although embarrassment while buying sanitary pads from a male
259 shopkeeper was narrated by a few girls from wealthy urban households, they did not report
260 hiding their menstruation from men in the family. Conversely, a girl from an urban area who
261 dried her absorbent cloth at home by hiding it under a bigger cloth was comfortable attending
262 a sex-education workshop at her mixed-gender school.

263 ***Patterns in Girls’ Gendered Experiences of Menstruation***

264 Girls’ gendered experience of menstruation was influenced by their socioeconomic
265 setting and school-type. It was common for girls from non-urban areas to experience teasing
266 from boys for menstruation. Girls from both urban and non-urban settings without private
267 toilet facility seemed to accept that menstruation was not a private matter. Several girls from
268 rural setting were not allowed to visit or touch anyone outside to respect commonly followed
269 social norms. A few educated mothers too gave gender-specific instructions to their

270 daughters. However, most girls from private unaided schools and wealthy families felt
271 comfortable discussing menstruation in mixed-gender classrooms and in front of their fathers.
272 Except two fathers from wealthy urban families, no father played an active role in
273 menstruation.

274 “..My dad told me about menstruation before my periods started, when I was in 6th
275 or 7th standard I guess. He gave me a book to read and said, “Let’s discuss if you
276 have any questions.” I read the book and then discussed many things that I did not
277 understand.. He also took us for dinner when I got my first periods.. (Smiles)”

278 - 15 years-old girl, urban setting

279 Our key respondent interviews showed that parents across varied socioeconomic
280 backgrounds (except for two highly educated mothers) communicated gender-specific
281 expectations to their menstruating daughters.

282 ***Boys’ Role in Menstruation***

283 An apprehension at the possibility of being teased by boys was palpable among most of
284 the girls who opposed the idea of boys being informed about menstruation.

285 “Do you think boys should be given detailed information about menstruation?”

286 “No... not at all..”

287 “No” (loud and a firm response)

288 “No... I mean it is both good and bad at the same time..”

289 “Why do you say that?”

290 “Good thing is that they will know about it as it is important for future.. as they grow
291 as adults.. but they will also laugh at us, tease us if they know more details”.

292 “I think if they are told what menstruation is, they should also be told that it is not
293 good to tease about it”.

294 - Focus group discussion (Girls, Urban setting)

295 However, a few girls (mostly urban) stressed that boys should receive the information
296 from appropriate sources as exploring wrong sources could misguide them. Questions about
297 boys' perceived role in menstruation yielded a mixed response from boys. Many boys
298 expressed their role as altruistic "to help and behave when girls are in pain", while only a
299 couple of boys from an urban setting, who attended sex-education workshops in schools,
300 argued that learning about menstruation should be natural so that boys engage in healthy
301 sexual relationships. One of the boys (14 years old) said, "Right now we are in a protected
302 environment. When we will enter college, there is a possibility that if we don't know about
303 these things, we may engage in risky behaviors that can harm girls."
304 Although the adolescent psychologist supported this, most parents opposed including boys in
305 menstrual discussion until they turned sixteen. Parents from disadvantaged backgrounds were
306 unsure of any meaningful roles that boys and men could play even if they knew about
307 menstruation.

308 **Quantitative phase**

309 Below is a gender distribution of adolescents with adequate knowledge, favorable
310 beliefs, receiving information in school, and opining favourably to 'whether boys should
311 know' (Table 1.1).




320 Below are gender differences - for possessing adequate and accurate knowledge (n=677 girls
321 and 703 boys), favorable beliefs (n=574 girls and 684 boys), receiving information on
322 menstruation in school (n=673 girls and 732 boys) and opining favourably to 'whether boys
323 should know about menstruation' (n=660 girls and 727 boys) (Figure 1.3)

326 Notably, about 95% of the girls (n=443) reported at least one gendered social experience of
327 menstruation. (Figure 1.4)

335 In fully adjusted models, fewer boys than girls possessed knowledge [IRR at 95% CI:
 336 0.34 (0.24, 0.47)]. Although fewer boys than girls had received information in school [IRR at
 337 95% CI: 0.34 (0.24, 0.49)], more boys (than girls) opined that boys should know about
 338 menstruation [IRR at 95% CI: 1.25 (1.00, 1.58)].

339 **Influence of gendered experience of menstruation on health-related outcomes (Table 1.3):**

341 A gendered experience of menstruation versus a lack of it was negatively associated with
 342 positive beliefs [IRR: 0.39 (0.16, 0.93)] and with good menstrual health status [IRR: 0.22
 343 (0.05, 0.90)], in fully adjusted models.

344 **Qualitative Phase 2**

345 Key respondents agreed with our study findings and suggested looking deeper into the
 346 social patterning of gender inequalities and its influences on menstruation-related

347 experiences. Our interviews underscored the scope of capturing more shades of girls’
348 gendered experience of menstruation to understand how it impacts their lives. For instance, a
349 17-year-old unmarried girl from the tribal setting shared that

350 “... Our male teacher locks the toilet of the school and keeps the key with him.. he denies us
351 access to toilet saying that we make it dirty...”. A similar experience was shared by another
352 19-year-old girl from tribal setting who said that menstruating girls were not allowed to use
353 the hostel toilets for changing their absorbents. She added,

354 “Sometimes we used to climb up a hillock just to relieve ourselves or to change the
355 absorbents...”

356 All the married (for not more than three months) girls from tribal area whom we
357 interviewed were unsure regarding whether their husbands knew about menstruation. None of
358 them had tried to bring this topic up and had only shared their date for periods with their
359 mother-in-law. The already gendered experience of menstruation that girls face within
360 households seemed to become more stressful as girls got married and moved to their in-laws’
361 households. A 19-year-old married girl from tribal setting shared,

362 “Here everything is new... I will have to tell my mother-in-law when I get my periods
363 as she will tell me what to do... here the house is new for me. I don’t know, where to
364 wash my menstrual cloth, where to dry it so that no one sees it. One day I will have to
365 talk to my husband about it because you know.... Married men should know about it....
366 if the man wants to do something (sexual intercourse), he will still do it even if his wife
367 is menstruating”

368 Marital status of the adolescent girls also seemed to contribute to the gendered
369 perception of the self and the body among the tribal poor. Although in the pre-survey
370 qualitative phase, we did not come across any girl (all unmarried) mentioning pubic hair

371 removal as the essential step in menstrual hygiene, married girls from the post-survey phase
372 did mention it as a necessary step. At least one married tribal girl confirmed buying a hair
373 removal crème every month for ‘cleaning’ the area, though it was economically taxing. She
374 said she “had to somehow manage money to buy one.”

375 We shared that the teasing experience narrated by several menstruating girls was
376 mostly denied by boys, as reflected in our results based on both the qualitative and the
377 quantitative pieces. Girl participants in the post-qualitative phase reiterated that the teasing
378 experience was indeed common and affected several girls emotionally. A girl participant
379 from tribal area narrated incident when they witnessed their friend crying as she was teased
380 (laughter upon seeing a stain). A married tribal girl shared a teasing incident faced by her
381 school-friend and wondered whether boys tease because they don’t know that menstrual
382 blood flow is not a bodily fluid that can be controlled by the body (such as urinary control).
383 She wondered whether they laugh because they think that it is girls’ immaturity to have a
384 stain as she “suddenly loses control over her body (sphincters).”

385 The social worker supported our findings regarding gender being a social determinant
386 of menstruation-related experience. He explained,

387 “It [being a boy] makes society adamant about what he can participate in. Being a
388 woman is at least beneficial in the sense that women come together and discuss about
389 menstruation. I find it extremely challenging to gather boys from disadvantaged
390 backgrounds for sex education as their coming together is always politicized. Family
391 resists if we try to get them out of the rigid cage of masculinity.. In this community we
392 also see a close link between menstruation and domestic violence.”

393 Key informants also pointed out that one needs to examine the complexity in the
394 relationship amongst caste, class, and menstrual experience. The sex-education expert

395 cautioned that while tribal societies are considered egalitarian, one needs to find out if
396 menstruation-related negative beliefs are due to infrequent water supply, a lack of privacy, or
397 other such constraints, rather than social reasons. The social worker explained that class and
398 wealth may not show an incremental relationship with menstruation-related outcomes
399 because stereotypes regarding gender, caste, class, and honour intersect in complex ways.
400 Parents' lack of consent for inclusion of their school-dropout sons in our interviews also
401 hinted at greater barriers to healthy SRH faced by school-dropout boys.

402 **Discussion**

403 We found that gender influences adolescents' menstruation-related experiences,
404 understanding, and beliefs. It unpacks the various layers explaining how menstruation
405 becomes a gendered experience in different social domains for girls and influences their
406 health. The quantitative findings highlight the gender differences in knowledge, beliefs,
407 receipt of information in schools and also in opinion on 'whether boys should know about
408 menstruation'. Further, the quantitative strand unearthed how gendered experience of
409 menstruation influenced menstrual health-related outcomes.

410 Thus, our analysis added textured explanations to support the previous findings
411 suggesting that gender is an important determinant of sexual and reproductive health among
412 adolescents; operating through unjust roles, norms, and expectations.

413 The gender analysis framework guided us in disentangling the complex ways in which
414 being a boy/girl influences menstrual health-related experiences: by (i) governing
415 adolescents' access to information, ability to possess knowledge, and ability to possess
416 beliefs, (ii) creating gender roles, expectations, and by sustaining stigma, (iii) by negatively
417 impacting' girls' menstrual beliefs and health outcomes.

418 Our finding that being a boy (than a girl) likely meant not receiving information in
419 schools and not possessing adequate and accurate knowledge, corroborates the findings of
420 previous studies on Indian adolescents' sexual and reproductive health (SRH). Additionally,
421 the finding that boys were curious to learn about reproductive health (a greater proportion of
422 boys versus girls opined that boys should know about menstruation) was similar to previous
423 studies on Indian boys (S. E. Mahon et al., 2015; Mason et al., 2013). Notably, girls
424 expressed a fear of getting teased by boys if boys got to know about menstruation. Our pre-
425 survey as well as the post-survey qualitative phase reflected that teasing faced by girls could
426 have several layers to it as it could emerge from boys' awkwardness, their increased sense of
427 differences between a male and a female body, as well as their unawareness regarding the
428 nuanced aspects of menstruation (for instance, that menstrual blood flow cannot be
429 'controlled' by a woman's body). Our study brings forth that gender inequality was produced
430 and sustained as menstruation was viewed as a biosocial marker to differentiate what girls
431 and boys can/ not do, an important finding corroborating previous research on adolescents (T.
432 Mahon & Fernandes, 2010; Pradhan & Ram, 2010; Santhya & Jejeebhoy, 2014). This
433 analysis also shows that girls felt awkward to interact with-and hid their menstrual status and
434 absorbents from-men, which also echoes the finding by scholars who argue that by
435 concealing their menstrual status, girls learn to un-gender their sexual maturity, while also
436 subscribing to the societal expectations of the gendered power relations that generate stigma
437 for their bodily processes and subordination to men (Caruso et al., 2017; Dube, 1988;
438 Fingerson, 2006; Luke, 1997). Our post-survey qualitative phase unpacked how marital status
439 added more burden to girls' already gendered menstrual experience as they struggled to fit in
440 with the normative ideas of cleanliness and menstrual hygiene management (for instance, by
441 using hair removal cream for removing their pubic hair), while remaining clueless about how
442 to discuss menstruation with their husbands. The influence of the political economy of the

443 hygiene industry on the ideas of cleanliness was reflected in our data as girls' perceptions
444 regarding their own body and bodily processes seemed to get affected by the created notions
445 of hygiene (Lahiri-Dutt, 2014).

446 Our qualitative data also corroborated the multi-dimensional nature of the gendered experience,
447 influenced by different axes of determinants fluidly intersecting in a given situation (Sen &
448 Iyer, 2012). Girls' ability to push the boundaries in avoiding a gendered experience of
449 menstruation within their communities could be limited due to several social and familial
450 inequalities intersecting with gender inequality. For instance, residing or passing through a
451 neighbourhood perceived as unsafe may limit a menstruating girl's ability to freely talk to
452 boys. Research on sanitation insecurity in India has revealed that girls from the tribal setting
453 often feel insecure using sanitation facilities outside of homes or to defecate in the open as
454 that increases their risk of interactions with intoxicated men (Caruso et al., 2017; Sahoo et al.,
455 2015). Although tribal societies are largely viewed as egalitarian in nature, it has been found
456 that girls and women find it difficult to transfer any egalitarian views on SRH from one social
457 institution to the other due to the difference in the nature of the gender-related power
458 dynamic across social institutions that lessens their scope to bargain with patriarchal
459 discriminatory practices (Caruso et al., 2017; Maharatna, 2000; Richards et al., 2013). Also,
460 girls and women not speaking to men in the open is often normalized and an attempt to break
461 this norm is found to be challenging by most girls and women, especially from the
462 disadvantaged backgrounds (Scott et al., 2017). A study from North India which tested the
463 participatory approach of Village Health, Sanitation, and Nutrition Committees (VHSNCs) to
464 challenge the gendered social experience faced by women members of the committees, found
465 it to be effective only among the few women who could push the strict gender boundaries
466 (Scott et al., 2017). This was primarily associated with women's realization of their limited
467 ability to bargain with the patriarchy as they had to return to their homes where gender power

468 relations were likely less negotiable. Such dynamics may have influenced even adolescent
469 girls' experiences due to- or post- menarche.

470 Moreover, the process by which gender might intersect with caste and class is not
471 one-dimensional. Scholarship on intersectionality indicates that lower class, caste, and gender
472 might intersect to give rise to higher morbidities among women belonging to poor SES (Scott
473 et al., 2017). On the other hand, literature also suggests that an intersection of higher class
474 and patriarchy might limit a woman's ability to seek autonomy and agency; as such a
475 woman's seclusion is largely associated with the honour of the family. These dimensions are
476 perhaps reflected as girls from an urban setting going to private schools whose mothers are
477 moderately educated facing gendered experience of menstruation, and also those belonging to
478 a reserved caste category or the fact that girls in urban private schools whose mothers are
479 moderately educated and belong to open category reported feeling ashamed to buy sanitary
480 napkins from a male shopkeeper.

481 This suggests that at both the higher and the lower levels of class and caste, women
482 seem to be less valued. While the minute processes through which this complex dynamic
483 becomes a social experience may differ in different social environments, we could find a
484 glimpse of this complexity in our data.

485 An essential part of the intersectional nature of social identities was showcased by our
486 qualitative data shedding light on the several ways through which being a boy also invited
487 gendered experiences: boys remained deprived of information regarding menstruation and
488 their curiosity remained unaddressed. Thus, a gendered experience is not restricted to girls
489 but boys, too, were adversely affected in several ways by the gendered nature of
490 menstruation-communication. Intersectionality scholars highlight that *gender and health* is
491 not necessarily about *women* and *women's health* (Hankivsky, 2012).

492 Underscoring the gendered nature of menstruation, this article shows that the
493 discrimination that girls face affects their menstrual beliefs and health. Our findings shed
494 light on a few mechanisms explaining how gender inequality affects women’s health, links
495 also discussed by several scholars in the past (Chandra-Mouli et al., 2013; Krieger, 2003;
496 Moss, 2002; Sanneving et al., 2013; Tolman et al., 2003). A study from Pondicherry (n=800)
497 showcased how a ‘traditionality index,’ indicating gendered beliefs regarding menstruation,
498 was higher among rural and poor girls and a greater proportion (36%) of ‘very traditional’
499 girls reported white discharge during menstruation as compared to ‘very modern’ (18.1%)
500 (Narayan et al., 2001). This closely reflects our findings that the experience of gendered
501 menstruation reduces the chance of possessing good menstrual health. However, in this
502 chapter we add further layers as we look at (i) the heterogeneity in gender-based
503 discrimination in different social environments and across socioeconomic settings; (ii) the
504 influence of school-level social determinants in addition to parental socioeconomic
505 characteristics; (iii) the impact of gendered menstruation on possessing positive beliefs; and,
506 (iv) menstrual health status as a measure reflecting many aspects of menstrual health than
507 only white discharge.

508 Our ability to generalize the findings to a wider population is limited because we used
509 a non-probabilistic sampling design and could not include school drop-outs and adolescents
510 less than 12 years old. However, our sample was adequate to detect socioeconomic patterns
511 in the gendered experience of menstruation, a unique contribution in the Indian context. The
512 cross-sectional nature of this study limits our ability to study the causal pathways. However,
513 as a first attempt at unpacking how gender is a social determinant of menstrual health, this
514 study still adds value. Our integrated theoretical approach does not capture the psychological
515 and developmental aspects of adolescents’ experiences regarding menstruation; however, it
516 does justice to the application of a social epidemiological lens. Knowledge, beliefs, and

517 gendered menstruation index variables were calculated by an additive method, which might
518 not represent the complexities of these constructs. Additionally, variables for parental
519 socioeconomic characteristics were reported by adolescents who might have failed to give
520 adequate and accurate information (10% of wealth data were missing). Our inability to cross-
521 check this information by referring to school-records remains a limitation. Furthermore, when
522 compared with a data representative of Nashik district, our sample lack a representation of
523 the poorest two categories of household wealth because we used a school-based survey which
524 excluded poor adolescents who are most likely school drop-outs. This potentially is a reason
525 for the inconsistent and weak findings pertaining to parents' socioeconomic characteristics
526 and wealth. Our sample size also prevented us from performing subgroup analyses examining
527 how gender and social inequalities interact. Additionally, due to limited resources, we were
528 unable to gather data on objectively assessed menstrual health. Despite these limitations, we
529 could highlight how gender is a social determinant of menstrual health, how various social
530 factors (mother's education, setting, wealth) create patterns in the menstrual experience of
531 girls in different social environments (family, school, community) and how this gendered
532 experience affects girls' health outcomes (beliefs and menstrual health status).

533 To our knowledge, this is the first mixed-methods study using a gender-sensitive
534 methodology and an integrated theoretical approach that draws attention to how gender and
535 social inequalities intersect to impact girls' and boys' understanding, beliefs and experiences
536 regarding menstruation, a unique social epidemiological approach that questions treating
537 menstruation as a 'women's only' topic. By using a mixed-methods design, we could unearth
538 context-specific nuances of the gendered social experience of menstruation while quantifying
539 the social patterning in this gendered experience and its influence on girls' menstrual health.
540 The mixing enabled a coherent interpretation of these nuances and patterns. Our finding that
541 the gendered experience of menstruation differs in different social domains highlights how

542 gender permeates structural spaces and environments and acts as an “organizing principle of
543 social life” (Gita et al., 2002; Sims & Butter, 2002).

544 **Conclusion**

545 Our study showcases how menstrual health, which is largely considered a ‘women’s’
546 topic, reflects unjust gender and socioeconomic differences in the accessibility of information
547 for both boys and girls at a stage in their lives when they learn to conform to expectations.
548 These unjust differences rooted in the gender inequalities perpetuated in patriarchal societies
549 such as India govern girls’ menstruation by treating it as a shameful experience.

550 Thus, by recognizing the role of boys and men in creating and sustaining taboos
551 around menstruation, this study underscores the need to engage them in creating
552 menstruation-friendly societies. Although programs exist which target narrowing gender-
553 based discrimination and gender gaps in health, several programs focus on developing
554 skillsets among women, improving their access to financial resources but fewer programs
555 aiming to reduce gender disparities reach marginalized adolescent girls and boys who have
556 specific needs. Although India’s national-level program for adolescents, the *Rashtriya*
557 *Kishor Swasthya Karyakram*, recommends involving boys in the discussion on menstruation,
558 it is not based on evidence regarding the similarities and differences in girls’ and boys’
559 menstruation-related understanding (Ministry of Health and Family Welfare, 2017). It is only
560 by recognizing adolescents’ needs specific to their gender and socio-demographic
561 characteristics that patriarchal societies such as India can aim to develop gender-sensitive
562 menstrual health strategies for Indian adolescents.
