Bronchoscopy on Intubated COVID-19 Patients is Associated with Low Infectious Risk to Operators

ABSTRACT

Background: The coronavirus disease 2019 (COVID-19) pandemic raised concern for exposure to healthcare providers through aerosol generating procedures, such as bronchoalveolar lavage (BAL). Current society guidelines recommended limiting use of BAL to reduce operators' risk for infection, yet data on the infection rate for providers after BAL is sparse. Since March 2020, our institution used a modified protocol to perform over 450 BALs on intubated COVID-19 patients. We therefore sought to describe the infectious risks to providers associated with BAL.

Methods: Fifty-two pulmonary and critical care faculty and fellows at our tertiary-care, urban medical center were surveyed. Survey participants were asked to provide the number of BALs on COVID-19 patients they performed, the number of weeks they worked on intensive care unit (ICU) services with COVID-19 patients, and the results of any SARS-CoV-2 testing that they received. Participants were asked to assess the difficulty of BAL on intubated COVID-19 patients as compared to routine ICU BAL using a numeric perceived difficulty score ranging from 1 (easier) to 10 (harder).

Results: We received 47 responses from 52 surveyed (90% response rate), with 2 declining to complete the survey. Many respondents (19/45, 42%) spent >5 weeks on an ICU service with COVID-19 patients.

The number of COVID-19 BALs performed by providers ranged from 0 to >60. Sixteen of the 35 providers (46%) who performed COVID-19 BALs underwent at least one nasopharyngeal (NP) swab to test for SARS-CoV-2, but none were positive. Twenty-seven of the 35 providers (77%) who performed COVID-19 BALs underwent SARS-CoV-2 serology testing, and only one (3.7%) was positive. Respondents indicated occasionally not being able to follow aerosol-minimizing steps but overall felt BALs in COVID-19 patients was only slightly more difficult than routine ICU BAL.

Discussion: At a high-volume center having performed >450 BALs on intubated COVID-19 patients with aerosol-limiting precautions, our survey of bronchoscopists found no positive NP SARS-CoV-2 tests and only one positive antibody test result. While the optimal role for COVID-19 BAL remains to be determined, these data suggest that BAL can be safely performed in intubated COVID-19 patients if experienced providers take precautions to limit aerosol generation and wear personal protective equipment.

INTRODUCTION

The coronavirus disease 2019 (COVID-19) pandemic has caused tremendous amounts of morbidity and mortality. Bacterial co-infections in viral pneumonia have been well described, especially in the setting of influenza pandemics, and have been associated with significant mortality (1). Preliminary studies from COVID-19 have also shown found bacterial co-infection, with especially high rates in those with fatal outcomes (2), suggesting that identification and appropriate treatment of ba(2)cterial co-infection may improve outcomes (3). Preliminary data on a subset of our population found high coinfection rates (4). Given the long average duration of ventilation in COVID-19 patients (5), they are also at high risk for secondary infection with nosocomial bacterial organisms (6).

Therefore, an accurate diagnosis of bacterial superinfection of ventilated COVID-19 patients is important for management, especially to guide appropriate antibiotic stewardship (7, 8). Bronchoalveolar lavage (BAL) with quantitative cultures can be a helpful diagnostic test in the management of severe

pneumonia (9). We have a longstanding practice of examining lower respiratory tract samples with rapid diagnostic platforms to inform the diagnosis and treatment of severe pneumonia, as well as research the alveolar microenvironment in severe pneumonia (4, 10).

The standard in our intensive care unit (ICU) had been nonbronchoscopic BAL performed by respiratory therapists, with occasional bronchoscopic BAL for more challenging cases. Since the primary method of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) transmission is aerosolization of respiratory droplets (11), nonbronchoscopic BAL was felt to be contraindicated. Endotracheal aspirates have been shown to be inferior to BAL (12, 13). When done correctly for diagnostic purposes, this maneuver also involves a long break in the closed ventilator circuit (14, 15), and thus is not preferred. Bronchoscopic BAL was therefore felt to be the safest procedure for determining the presence and etiology of bacterial infections in intubated COVID-19 patients.

There is concern that bronchoscopy exposes healthcare workers by generating aerosols (16). Society and panel guidelines discourage routine use of bronchoscopy in patients with COVID-19, though this is only based on expert opinion (17, 18). A paucity of data informs the infectious risk to providers performing BAL in COVID-19 patients. In a single-center report of 101 COVID-19 BALs, one of two bronchoscopists became sick with COVID-19 and had to be replaced by a third, who remained uninfected for the duration of the study (19). Some studies where COVID-19 BAL was performed mentioned low provider infection rates, though details are not provided (20).

We therefore designed a safety protocol for BALs in patients intubated with respiratory failure from known or suspected COVID-19. To date in our tertiary-care, urban academic medical ICU, we have performed over 450 bronchoscopies on such patients. Given our high volume of COVID-19 BALs, we designed the following study to assess the incidence of SARS-CoV-2 infection and seropositivity among bronchoscopists.

METHODS

We surveyed all clinical faculty and fellows in the Pulmonary and Critical Care Division at Northwestern Memorial Hospital (NMH) in Chicago, IL (Survey available as Supplementary 1.) Survey participants were asked to provide the number of COVID-19 BALs that they personally performed or

directly participated in, the number of weeks they cared for ICU patients with COVID-19, and the results of any SARS-CoV-2 testing that they had received. Participants were asked to assess the difficulty of BALs on intubated COVID-19 patients compared to routine ICU BALs using a numeric perceived difficulty score ranging from 1 (easier) to 10 (harder). They were also queried regarding COVID-19 exposures outside of work. No identifiers were collected, and all respondents were offered the choice to decline to participate. We received permission from the Vice Dean of Education and our Program Director to survey trainees. This study was reviewed and deemed exempt by our institution's Institutional Review Board.

SARS-CoV-2 testing

Nasopharyngeal (NP) testing for SARS-CoV-2 by polymerase chain reaction (PCR) (Becton and Dickinson, Becton, Dickinson and Company, Franklin Lakes, NJ; Cepheid, Sunnyvale, CA; and an institutionally-developed platform) was offered to providers *ad hoc* at the discretion of our hospital's infection control team, either in response to providers' symptoms, after a known exposure without PPE, or routine pre-procedure screening for the provider's own medical care. Serology (Abbott Architect SARS-CoV IgG, Abbott Park, IL) testing was offered to all medical staff by NMH starting in June 2020.

COVID-19 bronchoscopy protocol (full protocol available in Supplementary 2)

Bronchoscopies were performed in the ICU on intubated patients with respiratory failure from either known or suspected COVID-19. The decision to perform bronchoscopy was at the discretion of the ICU team, in some cases to establish a diagnosis or in others to exclude bacterial coinfection. Bronchoscopies were performed by a pulmonary ICU attending, interventional pulmonology (IP) attending, and/or Pulmonary/IP fellows. Nurses and respiratory therapists were not in the rooms during the actual bronchoscopy. PPE included an N95 mask, eye protection, gloves, gown, and hair protection. Bronchoscopy was performed with a disposable Ambu® aScope™ (Ambu Inc., Columbia, MD) bronchoscope. Patients were sedated per ICU protocols or at the proceduralist's discretion. Administration of cisatracurium (0.1-0.2 mg/kg) in order to minimize coughing during bronchoscopy was recommended. The endotracheal tube was clamped while the ventilatory circuit was manipulated to

accommodate scope placement, and the inspiratory limb of the ventilator was transiently disconnected during the brief break in circuit.

Statistical Analyses

Survey results were exported from Qualtrics (Qualtrics XM, Provo, UT) and compiled in Microsoft Excel (Version 15.39 for Mac, Microsoft, Redmond, WA). Graphs were generated in GraphPad Prism 8 (version 8.4.3, GraphPad Software LLC), Adobe Illustrator (Version CC for Mac, Adobe Inc, San Jose, CA), and Python using Seaborn v0.10.1. Not all continuous data were normally distributed, and so median values with interquartile ranges (IQR) were reported. Non-parametric analyses included Mann-Whitney-Wilcoxon and Spearman's rank correlation for continuous variables. Kruskal-Wallis rank testing was used to compare values across multiple categories.

RESULTS

We surveyed 52 clinical Pulmonary and Critical Care faculty and fellows. Forty-five respondents (90% response rate) agreed to participate: 18 fellows and 27 attendings (Table 1, Figure 1). The majority (35/45, 78%) had performed at least one bronchoscopy. The most common range of bronchoscopies performed by a respondent was 10-30 bronchoscopies, which 14/45 (31%) respondents selected. Two respondents reported performing bronchoscopy without full PPE under emergent situations, and 12 reported performing bronchoscopies without being able to follow the full protocol.

Many respondents (42%) spent >5 weeks on an ICU service with COVID-19 patients. The number of weeks on ICU service correlated to bronchoscopy volume (Spearman r=0.66, p<0.05). The overall median perceived difficulty score was 6 (IQR 6-7), with fellows (6.5, 5.75-7 IQR) and attendings (6, IQR 6-7) not differing significantly (p=0.66) (Figure 3). The perceived difficulty score did not correlate with either bronchoscopy volume (p=0.5) or time spent on ICU service with COVID-19 patients (p=0.18). Comments included that respondents felt these bronchoscopies were quite safe given numerous precautions instituted and adequate availability of PPE.

Sixteen of the 35 providers (46%) who performed bronchoscopies underwent at least one nasopharyngeal swab for SARS-CoV-2. No respondents reported a positive test. Five respondents

indicated having a respiratory illness that prompted their testing. Eight respondents indicated their SARS-CoV-2 testing was for screening purposes only.

Twenty-seven of the 35 providers (77%) who performed bronchoscopies underwent SARS-CoV-2 serology testing. One individual (3.7%) had two sets of serology testing, with one result being positive and another result being negative. This individual spent >5 weeks on an ICU service with COVID-19 patients, performed 10-30 bronchoscopies, but did not have any febrile respiratory symptoms.

DISCUSSION

Bronchoalveolar lavage plays an important role in the evaluation of acute respiratory failure in the ICU. Current society guidelines recommend a limited role for bronchoscopy in the care of COVID-19 patients to minimize the potential infectious risk to beside providers of aerosol-generating procedures (17, 18). These guidelines are based on expert opinion and appropriately emphasize provider safety, but data regarding the infectious risk of BAL to providers have been lacking. Our survey is small and limited to a single center, but our data suggest that the risk of transmitting COVID-19 to providers performing BAL may be low. No provider developed COVID-19, and only one had positive serology.

This survey was not a formal study of our specific bronchoscopy protocol. However, we hypothesized that careful technique during bronchoscopy can limit infectious risk. Principles of our protocol included: 1) limiting the number of providers in the room, 2) minimizing aerosol generation by with clamping the endotracheal tube and disconnecting the inspiratory limb of the ventilator during manipulations, 3) minimizing cough by neuromuscular blockade or heavy sedation and instillation of lidocaine into the tracheobronchial tree, and 4) use of a disposable bronchoscope. We also had a small number of highly skilled providers (our IP team) performing a high number of the BALs, ensuring adherence to protocol. Fortunately, most providers felt that the bronchoscopies following the protocol were only slightly more difficult than routine ICU bronchoscopy. We suspect that other centers may have similar protocols, and a more scientific exploration of techniques would be needed to comment on protocol efficacy.

Our group has supported adhering to evidence-based critical care during the COVID-19 pandemic rather than making practice changes solely in response to uncertainties associated with the

COVID pandemic (21). Medical provider safety is of paramount importance and precluded relying on our standard of care nonbronchoscopic BAL performed by respiratory therapists. However, our providers already utilize BAL during their routine critical care practice, and were likely to be able to safely continue that practice while using appropriate PPE and minimizing aerosolization. Our results demonstrate that assumption was accurate.

Our study has several limitations. First, this is a retrospective survey of providers and their recollection of practices. We did not directly pull exact bronchoscopy numbers and test results from the electronic medical records so as to respect our colleagues' privacy, and instead looked for voluntary responses. However, collateral data suggests overestimation of bronchoscopy numbers is very unlikely. Adherence to the modified bronchoscopy protocol was not monitored. We were not able to capture a 100% response rate for the survey but obtained results higher than most physician survey response rates (22).

While serology testing was offered to all providers per hospital protocol, only a subset of providers actually got tested. NP testing was performed *ad hoc* based upon symptoms or exposure. Since neither form of testing was mandated across the survey cohort, both may in fact under-represent the true infectious risk. It is also possible that asymptomatic infections were missed if providers did not seek testing in a short time period after performing said procedures.

In summary, this is the first detailed report of infectious risks from BAL from a large-volume center that routinely incorporates bronchoscopy as part of critical care for patients with COVID-19 respiratory failure. While additional research is needed to inform the optimal use of invasive sampling of the lower respiratory tract to improve outcomes for patients with COVID-19, our data suggest that BAL can be routinely incorporated into the ICU care of these patients with minimal infectious risk to providers.




Figure 2: Weeks of COVID-19 ICU Service and Bronchoscopy Volume. The amount of time providers

spent on service, and the number of COVID-19 BALs they performed.





Figure 3. Difficulty as rated by fellows and attendings. Scale of 1 (easier) to 5 (same) to 10 (harder), as compared with non-COVID ICU BAL.

The main benefit of participation is publicizing the risks/safety of bronchoscopy on COVID patients. Why am I being asked to take part in this research study?

We are asking you to take part in this research study because you have potentially bronched a COVID-19 patient.

- You can agree to take part and later change your mind.
- · Your decision will not be held against you.

If you say that "Yes, you want to be in this research," here is what you will do:You will be asked to complete a survey on the number of bronchoscopies you have performed on COVID patients, the number

of COVID tests you have received, and the results of your COVID testing. Will being in this study help me in any way?

We cannot promise any benefits to you from your taking part in this research. However, possible benefits include publicizing the risks/safety of bronchoscopy on COVID patients

Is there any way being in this study could be bad for me?

The primary risk of participation is potentially being identified based on how many bronchoscopies you have performed and the small cohort of participants.

What happens if I do not want to be in this research or if I say "Yes", but I change my mind later?

Participation in research is voluntary. You can decide to participate or not to participate.

Supplementary 2: NMH COVID-19 ICU Bronchoscopy protocol

Bronchoscopy in the COVID ICU will be performed for diagnostic and therapeutic purposes, including, but not limited to:

- Diagnostic evaluation of newly intubated patient, including COVID rule-out testing
- Evaluation of possible VAP or superimposed bacterial CAP
- Airway clearance

Bronchoscopy can be performed at the discretion of the ICU attending, but the general policy will be that off-hour bronchoscopy performed by a fellow without an attending should be limited to emergent situations such as mucous plugging. The following protocol will be used for bronchoscopy and will be performed by 1-2 member(s) of the IP service or the ICU attending. The ICU fellow will participate if willing and available (per fellow's preference).

Given the longer circuit break with NBBAL, these will not be performed on COVID-19 patients.

The nurse will help with printing order labels, pre-procedural sedation including administration of neuromuscular blockade but then will leave the room.

RT may help with gathering equipment but does not need to be present in the room.

Role 1: primary bronchoscopist (fellow, attending, IP attending) – this person is responsible for assessing the clinical situation, consenting the family, ensuring all necessary equipment are ready, ordering lab tests, ensuring adequate sedation, performing the bronchoscopy, cleaning the equipment afterwards, and ensuring samples delivered to the lab.

Role 2: secondary bronchoscopist (supervising IP attending or ICU attending or fellow) – this person will assist the primary bronchoscopist, silence ventilator alarms, assist in circuit manipulation, instill saline for lavage, withdraw BAL, and connect lukens trap.

Order checklist:

- Adequate sedation goal of RASS -4 if neuromuscular blockade to be used
- Cisatricurium 0.2mg/kg (Pharmacist may often have, otherwise call 9th floor pharmacy)
- Labwork
 - BAL cell count and differential
 - BAL amylase
 - BAL respiratory culture (normal, +/- fungal, AFB per clinician determination)
 - o Lower Respiratory Tract Panel (BioFire Pneumonia Panel)
 - SARS-CoV-2 test (repeat even if status already known, to monitor for clearance/reinfection)
 - o Cytology, Galactomannan, PJP DFA per clinician determination
 - 0
 - Extra patient label for research specimen

PPE checklist:

- N95 mask (ensure adequate fit) + covering surgical mask
- Gown, gloves (discard after procedure)
- Faceshield or goggles (wipe down after procedure)

Equipment checklist:

- Ambu scope (large/orange if concern for mucus plugging, but check ETT size; regular/green otherwise)
- Ambu tower (ensure adequately charged)
- Drape or chuck to lay down supplies on
- Scope adaptor for ETT
- Clamp for ETT
- Scope lubricant

- Extra suction tubing, if far from the bed
- 4x 30cc syringes (slip tip preferred if luer lock, ensure slip tip adaptors available; often in the scope bag)
- Normal saline (500cc bottles)
- Lukens trap
- Orange specimen cup + labels
- Research Eppendorf tube + patient sticker
- Extra specimen bags outside room for double-bagging specimens

Procedure steps:

 Outside the room, Primary Bronchoscopist times out with nursing and ensures consent has been signed, orders placed and labels printed. Sedation adjusted to goal RASS-4 with cisatraciurium 0.2mg/kg administered at provider's discretion (this is suggested when patient in early/acute phase with likely high viral load and tenuous status but may not be necessary for convalescing patients late in disease stage). FiO2 increased to 100%.

- 2. As able, Primary Bronchoscopist preps the bronch equipment outside the room
 - a. Drawing up 30cc normal saline x4
 - b. Connecting AmbuScope to Monitor
 - c. Lubricating AmbuScope
 - d. Pre-loading AmbuScope onto scope adaptor
 - e. Applying labels to specimen cups and research tube
- Primary Bronchoscopist and Secondary Bronchoscopist enter room; Nursing and RT available but are outside the room.
 - a. Primary Bronchoscopist responsible for narrating steps out loud, stands at the side of the patient; Secondary Bronchoscopist stands next to first, closer to the ventilator
 - b. Primary Bronchoscopist ensures equipment set up, suction connected and functioning, sedation is adequate and vitals are stable to tolerate the procedure
 - c. Primary Bronchoscopist clamps ETT

- d. Secondary Bronchoscopist disconnects inspiratory limb from the vent distal to the filter
- e. Primary Bronchoscopist places the adaptor (pre-loaded with the scope) onto the ETT
- f. Secondary Bronchoscopist reconnects the inspiratory limb
- g. Primary Bronchoscopist unclamps the ETT
- Primary Bronchoscopist performs inspection, toileting secretions as needed, wedges into target lobe
- Secondary Bronchoscopist instills saline in 30cc aliquots, 120cc recommended, draws back and discards first 5 cc, draws back more sample if able, then connects the lukens trap (goal >40cc return)
- j. Primary Bronchoscopist suctions sample into lukens trap
- k. Secondary Bronchoscopist disconnect lukens trap, hooks back up to wall suction
- Primary Bronchoscopist cleans up any remaining secretions, pulls scope back to edge of adaptor, then clamps ETT
- m. Secondary Bronchoscopist disconnects inspiratory limb from the vent distal to the filter
- n. Primary Bronchoscopist removes adaptor and scope in one motion
- o. Secondary Bronchoscopist reconnects the inspiratory limb
- p. Primary Bronchoscopist unclamps the ETT
- q. Sample placed into orange specimen cup from lukens trap (have had several break), with
 10-15cc placed in Eppendorf tube for research team
 - i. Samples bagged first in room, then placed in another bag held by someone outside the room
 - ii. Orange specimen cup + labels delivered to 7th floor lab
 - iii. Research specimen The MICU research team can be contacted by phone at 62752 or by pager at 59285. If they are not readily available to pick up the specimen, it can be left in the specimen fridge in the dirty utility room in the 9th floor MICU.
- r. Disposable equipment placed in red biohazard bag for disposal
- s. Monitor and pole wiped down before leaving room, returned to RT room

- t. Primary Bronchoscopist returns FiO2 to pre-procedure level (assuming tolerated) and ensures hemodynamics acceptable
- u. Both proceduralists doff PPE and wash hands; surgical mask over N95 should be discarded but N95 can be reused; goggles/faceshields wiped down and reused
- v. Primary Bronchoscopist documents procedure note

Special Circumstances:

- Prone positioning: continue with standard procedure
- iNO: continue with standard procedure
- Brushings: sometimes requested by research team, who will provide brushes, brush cutter (wire cutter can also be found in bronch suite), research tube/medium for brush to be cut into
