# Efficacy of face-masks used in Uganda:

## a laboratory-based inquiry during the COVID-19 pandemic

### 27 **Abstract**

#### 28 **Background**

29 With shortages of face-masks continuing to be reported worldwide, critical questions like  
30 whether or not there is an adequate alternative to commercially manufactured face-masks  
31 continue to linger especially in low- and middle- income settings. This study aimed at  
32 addressing this through testing and comparing various materials and forms of face-  
33 masks for filtration efficiency, breathability, microbial cleanliness, distance-dependent  
34 fitness, and re-usability of different face-masks procured from face-mask vendors in  
35 Kampala, Uganda.

#### 36 **Methods**

37 This was a laboratory-based descriptive study that applied new protocols and already  
38 existing protocols with substantive modifications to ten different types of face-mask  
39 types each in quadruplicate to achieve each specified aim.

#### 40 **Results**

41 Surgical face-masks had better filtration efficiency, distance-dependent fitness and  
42 breathability compared to other face-masks tested. Decontamination of these face-masks  
43 with 70% ethanol negatively affected their efficacy. Locally-made double layered face-  
44 masks had better: filtration efficiency, distance-dependent fitness and breathability  
45 compared to other locally-made cloth face-masks, and re-usability compared to all the  
46 face-mask types that had been tested.

### 47 Discussion/conclusions

48 Locally-made double layered cloth face-masks could serve as alternative face-masks  
49 especially for populations in low- and middle- income settings like Uganda while  
50 allowing restricted use of surgical face-masks and other respirators like the KN95 to high-  
51 risk groups only.

### 55 Introduction

56

57 Several countries continue to encourage and/or enforce the wearing of face-masks in  
58 public settings as a preventive measure to curb the acquisition and spread of the  
59 coronavirus disease 2019 (COVID-19) that is caused by the Severe Acute Respiratory  
60 Syndrome Coronavirus 2 (SARS-CoV-2) (1–5). The use of face-masks in public settings  
61 has been reported as a crucial preventive measure in limiting the acquisition and spread  
62 of COVID-19 by the World Health Organization (WHO) and the United States Centers  
63 for Disease Control (CDC) (6,7).

64 Several published studies have shown that the use of face-masks in public settings can  
65 limit the acquisition and spread of COVID-19, and has several advantages for example:  
66 (i) strong sustainability, (ii) good health- and economic- benefits, and (iii) simple

67 operation (8–15). Other published studies have described face-masks as discernable  
68 indications of the widely prevalent SARS-CoV-2, and as apparatuses that might be  
69 exploited to remind the public of the importance of the other infection-control measures  
70 for example maintaining social distancing and performing hand hygiene, and have also  
71 recommended their use to limit the acquisition and spread of COVID-19 (16). In the same  
72 study (16), face-masks have been described as symbols, beyond them being apparatuses,  
73 face-masks have been described as talismans that can boost health-care workers’  
74 perceived sense of safety, well-being, and trust in their health-care settings.

75 Although testing and contact tracing remain crucial in limiting the acquisition and spread  
76 of COVID-19, designing, manufacturing and getting the public to wear face-masks seems  
77 more achievable (17–20). Hence, the use of face-masks in public settings could be the  
78 single most important- low hanging opportunity for limiting the acquisition and spread  
79 of COVID-19 and could give the public the guarantee they yearn for to return our  
80 societies back to life (17–20). Face-masks meant for use in public settings should have  
81 good qualities for example a high filtration efficiency similar to those of the highly  
82 effective respirators i.e. the N95 and KN95 respirators; face-masks equivalent to these  
83 respirators may perhaps allow the public control over their own safety, a greater  
84 incentive to use them, as well as the confidence to resume their day-to-day activities  
85 (14,17).

86 The design of the face-masks for use in public settings should allow for: (i) protection that  
87 could result from filtration and/or deflection i.e. how well potentially infectious aerosols  
88 are blocked from passing through the face-masks as well as “fit” and leakage i.e. how  
89 well the face-masks seal around the wearer’s face and prevent potentially infectious  
90 aerosols from coming around them, while permitting breathed out air to vent efficiently  
91 (17,21,22), (ii) scalability that is permitted by the design’s potential to utilize commonly  
92 available materials that both commercial and non-commercial manufacturers can procure  
93 in huge quantities (17), (iii) comfort that allows the wearers to use the face-masks for  
94 extended durations of time without having to touch them or take them off too frequently  
95 (17,23), (iv) re-usability to prevent the continuous need for new face-masks; face-masks  
96 should be easy to clean, this would enable their repeated use (17,19,23), (v) style since the  
97 wide-spread adoption of face-mask use could necessitate a significant cultural shift so  
98 that they could become a seamless part of a “new normal”, could be enhanced by the use  
99 of various logos and/or colors of individuals’ favorite sports teams and/or brands (17,23).

100 However, it is critical to note that designing and manufacturing such face-masks and  
101 influencing the public to use them as one of the preventive measures to curb the  
102 acquisition and spread of COVID-19 is not straight forward as it poses not only  
103 engineering and manufacturing challenges but also marketing challenges that could  
104 necessitate quite a lot of tradeoffs (17).

105 Also critical to note is that, not only did the outbreak of COVID-19 spark a major debate  
106 about the efficacy of face-masks in general but it also exposed the inadequacy of existing  
107 guidelines on the use of cloth face-masks, despite the wide spread use of these face-masks  
108 in majority of the low- and middle- income countries especially in Africa as reported in  
109 several studies (20,24–27). At the same time, the outbreak fashioned critical questions like  
110 whether or not there was an adequate alternative to commercially manufactured face-  
111 masks for example the N95, KN95 and surgical face-masks that could be made easily  
112 available for populations in low- and middle- income settings especially in Africa (28).  
113 At the time of writing, similar to a few other low- and middle- income countries in Africa,  
114 Uganda was continuing to implement a phased-approach of lifting the countrywide  
115 lockdown while considering the use of face-masks in public settings mandatory for all  
116 (29). In light of this, many untested brands of cloth face-masks, potentially inadequate to  
117 provide protection against COVID-19 could have flooded the Ugandan market hence  
118 making it necessary to assess the safety and fitness-for-use of the different brands of cloth  
119 face-masks that were commonly circulating on the Ugandan market during the COVID-  
120 19 pandemic.

121 Hence this study aimed at testing and comparing various materials and forms of cloth  
122 face-masks procured from face-mask vendors in Kampala, Uganda during the COVID-  
123 19 pandemic; the testing was done to assess the: filtration efficiency, breathability,  
124 microbial cleanliness, distance-dependent fitness, and re-usability of the cloth face-  
125 masks. We hoped that the findings obtained from this study would assist health  
126 organizations in Uganda and similar low- and middle- income settings in Africa to  
127 develop policy on the use of cloth face-masks to prevent the transmission of COVID-19.

## 129 Results

130  
131 **Filtration efficiency of the face-masks tested.** All the face-masks that had been tested  
132 had a filtration efficiency of  $\geq 99.9\%$ , regardless of the face-mask decontamination method  
133 used (Table 1).



136 **In-house breathability testing of the face-masks.** Glass beakers that had been sealed  
137 with surgical face-masks that had been obtained from both the community pharmacy and  
138 street vendors, as well as the locally-made double-layered cloth face-masks with non-  
139 elastic straps purposely for tying around the head showed a significant increase in weight  
140 after the 24-hour duration of the testing. However, glass beakers that had been sealed  
141 with surgical face-masks that had been obtained from the street vendors had a  
142 significantly higher weight gain compared to those that had been obtained from the  
143 community pharmacy and the locally-made double-layered cloth face-masks with non-  
144 elastic straps purposely for tying around the head, while the locally-made double-layered  
145 cloth face-masks with non-elastic straps purposely for tying around the head had a  
146 significantly higher weight gain compared to the other face-masks that had been tested,  
147 regardless of the face-mask decontamination method used (Figure 1b). Face-mask

150 **and (b) a locally-made double-layered cloth face-mask with non-elastic straps**



154 Furthermore, there was a significant association between the type of face-mask and the  
155 average increase in weight of each of the face-masks used in the testing, regardless of the  
156 method of face-mask decontamination used ( $F=4.42$ ,  $p<0.05$ ). However, there was no

157 significant association between the type of face-mask and the humidity content in the  
158 testing environment, regardless of the method of face-mask decontamination used  
159 ( $F=1.16, p>0.05$ ). Surgical face-masks that had been obtained from street vendors had a  
160 significantly higher weight gain compared to the other types of face-masks that had been  
161 tested (Table 2).



164 **Microbial cleanliness of the face-masks.** There was no significant difference between  
165 the counts in terms of CFUs and type of microorganisms that had been isolated from the  
166 inner- and outer- surfaces of the face-masks that had been tested, regardless of the  
167 method of face-mask decontamination used (Figure 2). The gram- positive bacteria that  
168 had been isolated from both the inner- and outer- surfaces of the face-masks surfaces  
169 were predominantly coagulase negative staphylococcus (>95%), while no gram- negative  
170 bacteria had been isolated.

174 **Distance dependent fitness testing of the face-masks.** Figures 3, 4, 5, and 6 show the  
 175 relationship between the number of sprays that were applied to each face-mask with  
 176 distance, as the measure for distance dependent fitness testing of the face-masks. The  
 177 distance dependent fitness testing experiment was done for face-masks that had not been  
 178 subjected to any decontamination, those that had been: treated with 70% ethanol, washed  
 179 and dried under the sun and washed, dried under the sun and ironed.

180 **With no decontamination.** Largely, the number of sprays applied to each of the face-  
 181 masks for the volunteers to taste the reagent that had been used in the testing increased  
 182 with increase in the distance. At 1 meter, the study volunteers tasted the reagent that had



183 been used in the testing after just a few sprays (<100 sprays). As the distance increased,  
184 the number of sprays applied to each of the face-masks also increased. Noteworthy, the  
185 number of sprays applied in the case of the surgical face-masks that had been obtained  
186 from the street vendors for the volunteers to taste the reagent used in the testing increased  
187 exponentially to  $\geq 500$  sprays at 2 meters. The number of sprays applied to the locally-  
188 made double-layered cloth face-masks with non-elastic straps purposely for tying around  
189 the head for the volunteers to taste the reagent used in the testing also increased steadily  
190 till 2 meters at which point they increased exponentially passing the 500-spray mark at 3  
191 meters. The number of sprays applied to the face-mask that had been made from thick  
192 material with an elastic strap for attaching around the head for the volunteers to taste the  
193 reagent used in the testing also increased steadily till 5 meters at which point they passed  
194 the 500-spray mark. The number of sprays applied to all the single layered face-masks for  
195 the volunteers to taste the reagent used in the testing increased steadily till 6 meters but  
196 did not pass the 500-spray mark.

197 The surgical face-masks that had been bought from the street vendors passed the distance  
198 dependent test at 2 meters, while the locally-made double-layered cloth face-masks  
199 passed the same test at 3 meters, and the face-masks that were made from the thick  
200 material with an elastic strap for attaching around the head passed the same test at 6  
201 meters. All single-layered face-masks did not pass for distance dependent fitness test.

205 **Decontamination with 70% ethanol.** Largely, the number of sprays applied to each of

206 the face-masks for the volunteers to taste the reagent that had been used in the testing

207 increased with increase in the distance upon decontamination with 70% ethanol. At 1

208 meter, all the face-masks required a few sprays (< 100 sprays) to be applied for the

209 volunteers to taste the reagent that had been used in the testing. As the distance increased,

210 the number of sprays applied to the locally-made double-layered cloth face-masks with

211 non-elastic straps purposely for tying around the head for the volunteers to taste the

212 reagent used in the testing increased steadily till 2 meters at which point they increased



213 exponentially passing the 500-spray mark at 3 meters. The number of sprays applied to  
214 face-masks that had been made of face scrub cloth with elastic straps that allowed for  
215 attachment on the ears for the volunteers to taste the reagent that had been used in the  
216 testing increased steadily till 5 meters at which point they then increased exponentially  
217 passing the 500 spray-mark at 6 meters.

218 On decontamination with 70% ethanol, the locally-made double-layered cloth face-masks  
219 with non-elastic straps purposely for tying around the head, and face-masks that had  
220 been made of face scrub cloth with elastic straps that allowed for attachment on the ears  
221 passed the distance dependent fitness test. Noteworthy, both surgical face-masks that  
222 had been obtained from the community pharmacy and street vendors failed the distance  
223 dependent fitness test.

227 **Washing of face-masks with non-bacterial soap and drying them under the sun.** Upon

228 this face-masks decontamination, the number of sprays applied to each of the face-masks

229 for the volunteers to taste the reagent that had been used in the testing largely increased

230 with increase in the distance. At 1 meter, all the face-masks required a few sprays (<100

231 sprays) to be applied for the volunteers to taste the reagent that had been used in the

232 testing. However, as the distance increased, the number of sprays applied to the locally-

233 made double-layered cloth face-masks with non-elastic straps purposely for tying around


234 the head for the volunteers to taste the reagent used in the testing increased steadily till  
235 3 meters at which point they increased exponentially till they passed the 500 spray-mark  
236 at 4 meters. The number of sprays applied to the face-masks that had been made of face  
237 scrub cloth with elastic straps that allowed for attachment on the ears, steadily increased  
238 till 5 meters where they then increased exponentially passing the 500 spray-mark at 6  
239 meters.

240 Upon washing of the face-masks with non-bacterial soap and drying them under the sun:  
241 the locally-made double-layered cloth face-masks with non-elastic straps purposely for  
242 tying around the head and face-masks made of face scrub cloth with elastic straps for  
243 attaching onto the ears passed the distance dependence fitness test.

248 **Washing of face-masks with non-bacterial soap, drying them under the sun and**  
249 **ironing them.** Generally, the number of sprays applied to each of the face-masks for the  
250 volunteers to taste the reagent that had been used in the testing increased with increase  
251 in the distance. At 1 meter, all the face-masks required a few sprays (<100 sprays) to be  
252 applied for the volunteers to taste the reagent that had been used in the testing. As the  
253 distance increased, the number of sprays applied to the locally-made double-layered  
254 cloth face-masks with non-elastic straps purposely for tying around the head for the  
255 volunteers to taste the reagent used in the testing increased steadily till 2 meters at which

256 point they increased exponentially passing the 500 spray-mark at 3 meters. The number  
257 of sprays applied to the face-masks made of face scrub cloth with elastic straps for  
258 attaching onto the ears increased steadily till 5 meters at which point they increased  
259 exponentially passing the 500 spray-mark at 6 meters.

260 On washing of face-masks with non-bacterial soap, drying them under the sun and  
261 ironing the, locally-made double-layered cloth face-masks with non-elastic straps  
262 purposely for tying around the head and the face-masks made of face scrub cloth with  
263 elastic straps for attaching onto the ears passed the distance dependent fitness test.

## 268 Discussion

270 To the best of our knowledge this is the first study assessing the efficacy of face-masks in  
271 Uganda. In this study, we analyzed the: filtration efficiency, breathability, microbial  
272 cleanliness, distance-dependent fitness, and re-usability of different face-masks procured  
273 from face-mask vendors in Kampala, Uganda during the COVID-19 pandemic.

274 This study answered questions like whether or not there was an adequate alternative to  
275 imported commercially manufactured face-masks for example the KN95 and surgical  
276 face-masks, through testing and comparing various materials and forms of face-masks.

277 The findings of this study could be beneficial for improving the uptake of face-masks by  
278 the public in Uganda and similar low- and middle- income countries in Africa, as a key  
279 intervention in preventing the transmission of COVID-19. In addition, the findings of this  
280 study unmasked the potential of a locally-made face-mask to offer an alternative to  
281 imported commercially manufactured face-masks in providing protection against  
282 COVID-19, and hence inspires efforts geared towards local production of face-masks not  
283 only in Uganda but also in other low- and middle- income countries in Africa.

284 The increased local-production of face-masks could translate into increased supply and  
285 availability or accessibility which could address future shortages, as well as ensure  
286 reasonable prices of the face-masks. Increased local-production could also enable  
287 prioritizing and limiting the use of KN95 and surgical face-masks to frontline clinicians  
288 and essential health-care workers.

289 This study's finding where surgical face-masks purchased from either the community  
290 pharmacy or street vendors had better filtration efficiency and breathability than any  
291 other type of face-masks that had been tested are consistent with the findings of related  
292 studies. These studies (30–32), alluded to the effectiveness of surgical face-masks in  
293 offering protection against infectious aerosols for example SARS-CoV-2 while attributing  
294 this to their good qualities of filtration and breathability. However, this finding is  
295 inconsistent with those of other studies (33–35), that reported filtration limitations of  
296 surgical face-masks which could negatively affect the ability of these face-masks to offer  
297 protection to the wearers against infectious aerosols for example SARS-CoV-2 especially  
298 during coughs by infected patients.

299 Above and beyond the apparent imperfect filtration efficiency and breathability of  
300 surgical face-masks, several observational studies have found no significant benefits of  
301 other respirators (i.e. the N95 and KN95) over these face-masks and have indicated the  
302 ability of these face-masks to not only offer protection against infectious aerosols for  
303 example SARS-CoV-2 but to also offer a cheaper alternative to the other respirators (i.e.  
304 the N95 and KN95), which have been reported to offer better protection than the surgical  
305 face-masks (30,36–39). Therefore, despite the limitations of surgical face-masks there  
306 remains reason for optimism regarding their real-world effectiveness.

307 The differences in performance of the surgical face-masks that had been obtained from  
308 the community pharmacy and the street vendors reported in this study could be due to

309 the differences in the manufacturing enterprises of these face-masks. Different  
310 manufacturing enterprises use different materials in production and this could lead to  
311 differences in the performance of the face-masks they produce. A similar line of thinking  
312 has been documented by related studies (40). In these studies, surgical face-masks were  
313 reported to provide different levels of protection against infectious aerosols particularly  
314 when they were produced from different enterprises.

315 The rapid growth in consumer demand for sustainable face-masks represents an  
316 enormous opportunity for small-scale enterprises in low- and middle- income countries.  
317 We believe that providing assistance to these small-scale enterprises could enable them  
318 to seize the opportunity and significantly improve the quality of the face-masks they  
319 produce. This could also consequently result in the reduction of the differences in the  
320 face-masks thereby creating more homogeneity in performance of the face-masks.

321 Global and local shortages of respirators and surgical face-masks have been reported by  
322 several studies (37,41). These shortages have caused the extended use or re-use of  
323 respirators as well as surgical face-masks designed for single-use (37,41–43). To ease the  
324 shortage of respirators and surgical face-masks, many individuals continue to explore  
325 non-standard methods to maintaining an adequate supply including among others face-  
326 mask decontamination, which could extend the wearable life of the face-masks beyond  
327 the expiration date, and procuring of the more costly respirators i.e. KN95 and N95 (37).  
328 However, the findings of this study indicate that the decontamination of surgical face-

329 masks obtained from both the community pharmacy and street vendors using 70%  
330 ethanol negatively affected the general efficacy of these face-masks. These negative  
331 effects could have been due to the 70% ethanol destroying the structural integrity of the  
332 surgical face-masks, a thinking that has also been shared in related studies (43–45). These  
333 studies have also reported the potential of using other decontamination methods for  
334 example using vaporized hydrogen peroxide and ultraviolet germicidal irradiation  
335 (41,46–48). However, basing on the evidence generated in this study about the negative  
336 effects on the efficacy when decontamination of surgical face-masks is done with 70%  
337 ethanol, as well as the alternative potential decontamination approaches provided by  
338 related studies, but which have been also documented to be labor intensive and  
339 expensive (47), hence likely to be unaffordable by majority of the population and health-  
340 care systems in low- and middle- income countries, health-care organizations for  
341 example ministries of health in these countries could ensure that policies as well as  
342 systems are put in place to ensure that decontamination practices are carried out safely  
343 and in line with existing evidence. Also, these organizations could ensure that the  
344 available surgical face-masks are restricted for use to only the frontline clinicians and  
345 essential health-care workers to reduce the requirements for re- use and extended use of  
346 the surgical face-masks.

347 The findings in which locally made, double layered cloth face-masks were found to  
348 provide the best alternatives to surgical face-masks could be related to those of related

349 studies (14,28). In these studies, testing of face-masks that had been made from two layers  
350 of quilt fabric with household paper towels as filters was done, the face-masks tested in  
351 these studies were reported to be viable alternatives to surgical face-masks and other  
352 respirators like the KN95 and N95 in providing protection to the users against infectious  
353 aerosols. Despite the fact that these studies acknowledged the superiority of surgical face-  
354 masks over cloth face-masks, they highlighted that the use of these face-masks was  
355 severalfold more effective than not wearing a face-mask at all.

356 As the world with particularly low- and middle- income settings standing to benefit the  
357 most, seek cheaper approaches of achieving mask decontamination as reported in related  
358 studies (47), this study's findings that demonstrated the potential of decontaminating  
359 locally made, double layered cloth face-masks utilizing cheaper local methods and the  
360 ability of the locally made, double layered cloth face-masks to maintain their structural  
361 integrity and hence efficacy despite the different methods of decontamination the face-  
362 masks had been subjected to are of great importance. These findings imply, that once  
363 procured, these face-masks can be used and re- usable or used for extended durations of  
364 time while decontaminating the face-masks with the documented approaches unlike in  
365 the case of surgical face-masks. The findings could also imply that locally made, double  
366 layered cloth face-masks when availed and used could improve the uptake of face-masks  
367 by the public in Uganda and similar low- and middle- income countries in Africa, as a  
368 key intervention in preventing the transmission of COVID-19. Also, similar to other the

369 findings of related studies (49,50), these findings reinforce the potential for local mass  
370 production of protective face-masks by likely non- experts utilizing the available  
371 resources through policy information as well as call for the updating of national  
372 guidelines to provide clear and consistent criteria to ensure the widest availability and  
373 appropriate use of face-masks, while bearing in mind populations in social  
374 disadvantaged or low- and middle- settings.

375 Our results demonstrated that locally made, double layered cloth face-masks can be  
376 effectively decontaminated using various approaches while maintaining their structural  
377 integrity which means maintaining their ability of provide protection to the wearer  
378 against infectious aerosols. Given the Ugandan government recommendation that cloth  
379 face-masks should be worn in public settings, decontamination using ordinary soap and  
380 drying under the sun with or without ironing could provide cheaper, safe and effective  
381 decontamination of cloth face-masks.

382 Regarding microbial cleanliness of the face-masks, of note we found no significant  
383 difference between the counts as well as the types of microorganisms that had been  
384 isolated from the inner- and outer surfaces of the face-masks that had been tested in this  
385 study. These finding are inconsistent with those of related studies, that reported having  
386 found a greater contamination of on the outer- surfaces of the face-masks with  
387 microorganisms as compared to the inner- surfaces of the same face-masks (35).

388 Coagulase negative staphylococcus remain known members of the normal flora of the  
389 human skin, nasal and oral cavity (51–53). The isolation of coagulase negative  
390 staphylococcus from the inner- and outer- surfaces of face-masks in this study could be  
391 attributed to several factors that could include among others: face-masks aerodynamic  
392 features that could result in a turbulent jet due to leakage of air around the edge of the  
393 face-mask that could consequently contaminate the outer- surfaces of the face-mask, a  
394 thought shared by related studies (35) , as well as the possibility that the bacteria could  
395 have: been picked or originated from the skin, oral, nasal cavities of the wearers or even  
396 their hands during contact with the face-masks (53,54). These findings hence support the  
397 importance of hand hygiene after touching the surfaces of face-masks to ensure  
398 microbiological cleanliness of the face-masks.

399 Our study had strength and limitations; (i) the strength of the study is that, in absence of  
400 documented protocols, the study was able to develop, test and optimize protocols to  
401 successfully perform the testing of the face-masks, protocols which could also be adapted  
402 as templates for the development of more comprehensive protocols, (ii) despite the fact  
403 that the size and concentrations of the SARS-CoV-2 in aerosols generated during coughs  
404 by infected patients are unknown, the sizes of aerosols generated by our hand-held sprayer  
405 especially at different distances were not determined, this leaves a gap in the information  
406 regarding whether or not the face-masks tested would offer adequate protection against  
407 SARS-CoV-2, (iii) most experiments done especially in the high income settings use

408 automated aerosol generation to continuously produce aerosols in the testing, however,  
409 in this study, we used hand-held sprayers whose aerosol generation depends on the  
410 number of squeezes made by the operator, (iv) despite measuring environmental  
411 temperature and humidity since they have been documented to affect the evaporation of  
412 the generated aerosols during ordinary exhalation, talking and singing, the wind speed  
413 was not catered for during this study and is likely to have affected the aerosol  
414 transmission and speed.

## 415 Conclusions

416  
417 This study described workable protocols to evaluate the efficacy of face-masks. This  
418 study also demonstrated limitations of surgical face-masks in the context of re-usability,  
419 although they are to a higher extent protective. In addition, this study also demonstrated  
420 the potential of locally-made double layered cloth face-masks to serve as cheaper face-  
421 mask alternatives especially for populations in Uganda. Unmasking the potential of the  
422 locally-made double layered cloth face-masks allows for the limited use of surgical face-  
423 masks to high-risk groups. Lastly, the study demonstrated the need to boost local  
424 production of face-masks by small-scale enterprises with support of relevant government  
425 ministries.

## 426 Methods

427

## Research article

428 **Study design.** This was a laboratory-based descriptive study, and was part of a larger  
429 study titled: Assessing knowledge, attitudes, perceptions and skills towards the use of  
430 face-masks: a community-level perspective (MASKUG-2020), that aimed to assess: (1)  
431 knowledge, attitudes, perceptions, practices, and skills towards the use of face-masks by  
432 high-risk groups in Kampala, Uganda, (2) skills towards the use of face-masks by the  
433 same groups, and (3) to evaluate the face-masks for safety and fitness-for-use, (4) to  
434 provide a classification for those commonly circulating on the Ugandan market, as well  
435 as (5) to educate and skill the same groups on the rational use and disposal of face-masks.

436

437 **Study sites.** The study was carried out in the Department of Medical Microbiology at the  
438 School of Biomedical Sciences, College of Health Sciences, Makerere University- Uganda.

439

440 **Description and source of the face-masks.** Ten different types of face-masks each in  
441 quadruplicate, were purposively selected and procured from face-mask vendors in  
442 Kampala, the capital city of Uganda (Table 1).

443

444 **Laboratory testing.** This was achieved using new protocols as well as already existing  
445 protocols with substantive modifications or rather innovative applications of existing  
446 protocols to new models or scientific questions and involved;

447 **Semi-quantitative mask fitness testing.** This was performed using saccharin solution.  
448 Saccharin is a non-nutritive sweetener of 1,2-benzisothiazol-3-(2H)-one and is about  
449 300- 400 times sweeter than sucrose (55,56). It is less soluble in water in its natural form  
450 and hence it is conjugated with either sodium or calcium salt to improve on the solubility  
451 (55,56). Even though saccharin has not been reported to be tasted differently, research on  
452 various artificial sweeteners has reported that they may elicit different responses upon  
453 interaction with the sweet taste receptor, and as such, there is therefore a possibility of  
454 people having different tasting thresholds for saccharin (57).

455 The sensitivity testing protocol was adopted from 3M Center for Respiratory Protection,  
456 United States (58). While preparing for the testing, efforts were made to ensure that the  
457 study volunteers did not eat or drink anything, 30 minutes before the testing except for  
458 drinking water. The testing hood was assembled by fitting it onto the collar of the study  
459 volunteers, making a 10 cm 'gap' between the study volunteers' faces and the inside  
460 surface of the hood. The nebulizers were prepared and about 10 mls of saccharin  
461 sensitivity and test solutions were added to their respective nebulizers. Sensitivity testing  
462 and test experiments were then performed. The sensitivity testing was performed to  
463 ensure that the study volunteers could taste the saccharin solution before carrying out  
464 the test experiments. Before nebulizing, the study volunteers were instructed to breathe  
465 through the mouth with the tongue slightly out, so that they could be able to taste the  
466 saccharin. During the fit testing, the study volunteers were instructed to breathe: (i)

467 normally, (ii) deeply, (iii) while moving head side-to-side, (iv) while moving head up and  
468 down, (v) while bending over or bending at the waist, (vi) while talking, and (vii) to  
469 breathe normally again. When saccharin was not tasted by the study volunteers; the test  
470 was considered as 'passed' or 'successful' while the test was considered as 'failed' or  
471 'unsuccessful' when the saccharin was tasted by the study volunteers. Despite, the 'failed'  
472 test, the number of squeezes applied for the study volunteers to taste the saccharin were  
473 recorded. The test was recorded as completely 'failed' or 'unsuccessful' after repeat  
474 testing had been done and the saccharin was tasted while the same face-mask was being  
475 worn.

476 **In-house filtration efficiency.** In the testing, a 0.5 McFarland bacterial suspension of  
477 *Mycobacterium smegmatis* was prepared and later transferred into a multi-purpose hand-  
478 held sprayer that was used to generate a steady stream of aerosols. A vacuum filtration  
479 unit was constructed in-house and set up in a biosafety cabinet. All items in the biosafety  
480 cabinet were thoroughly disinfected using 5% Lysol and 70% ethanol. The in-built filter  
481 of the vacuum filtration unit was aseptically removed and replaced with the test filters  
482 (sections of the face-masks). The negative control protocol was performed by running the  
483 vacuum pump for 30 minutes without aerosol generation and the filtered air was  
484 inoculated on 7H11 agar media. The different face-masks were tested by maintaining a  
485 steady stream of aerosols of *Mycobacterium smegmatis* for 30 minutes directed towards the  
486 vacuum filtration unit having the face-mask sections and the filtered air was inoculated

487 on 7H11 agar media. The positive control protocol was performed by maintaining a  
488 steady stream of aerosols of *Mycobacterium smegmatis* for 30 minutes without any  
489 filtration and inoculating the air/aerosols on 7H11 agar media. The inoculated agar plates  
490 were sealed with micropore tape and incubated at 37°C for 3 days. The filtration  
491 efficiency was assessed by comparing the growth on the plates for the positive control  
492 with those of the test face-masks.

493 **In-house breathability testing.** In the testing, the ASTM E96 water vapor testing protocol  
494 specifically the desiccant method was adapted (59). In the testing, a glass beaker was  
495 almost filled with a solid desiccant (anhydrous calcium chloride granules) and then  
496 covered with the sections of the test face-masks leaving a very small air space between  
497 the desiccant and the sections of the test face-masks. The sections of the test face-masks  
498 were properly sealed to the edge of the glass beaker to prevent side diffusion. The initial  
499 weight of the glass beaker containing the calcium chloride granules was then taken. The  
500 glass beaker was then placed in an environment where the environmental -humidity and  
501 -temperature were constantly monitored and recorded. The glass beaker containing the  
502 calcium chloride granules was then weighed after 2 hours and the gain in weight of the  
503 set-up was extrapolated to provide data on the moisture passing through the fabric in a  
504 day (i.e. 24 hours). A positive control glass beaker containing calcium chloride was  
505 included. This was left uncovered for the entire duration of the experiment. The  
506 permeability of the face-masks was categorized as 'low', 'moderate' or 'high'.

507 **In-house microbial cleanliness testing.** This testing was performed after the study  
508 volunteers had used each of the face-mask for the fitness testing. After the fitness testing,  
509 each of the face-masks was aseptically removed from the study volunteers faces and the  
510 outer and inner surfaces of each of the used face-masks were swabbed in that order with  
511 sterile cotton swabs made slightly wet with physiological saline while focusing on the  
512 sites where the nose and mouth would typically be positioned. The contents of the swabs  
513 were then inoculated onto Blood agar and MacConkey agar. Both culture media were  
514 then incubated aerobically, at  $35^{\circ}\text{C} \pm 2^{\circ}\text{C}$  for 24 hours. All growth was enumerated and  
515 identified per the face-mask tested and the results recorded. The identification of target  
516 gram-positive bacteria (i.e. *Staphylococcus spp*) was done using recommended biochemical  
517 tests: DNase, mannitol salt fermentation after performing gram-stain microscopy,  
518 catalase, slide and tube coagulase tests.

519 **In-house distance dependent fit testing.** In this testing: (i) care was taken to ensure that  
520 the study volunteers had no facial hair and that they did not eat or drink anything except  
521 drinking water in the 30 minutes before the start of the testing, (ii) the nebulizers (hand-  
522 held sprayers) were prepared and saccharin sensitivity and test solutions were added to  
523 their respective nebulizers, (iii) sensitivity testing was performed with the study  
524 volunteers not wearing face-masks, while standing stationery at 2, 3, 4, 5 and 6 meters, to  
525 ensure that the study volunteers could taste the saccharin sensitivity solution at the  
526 different distances. At distances and beyond which the saccharin sensitivity solution was

527 not tasted by the study volunteers, testing with the saccharin test solution was not  
528 performed. The saccharin test solution was tested after the study volunteers wore the test  
529 face-masks at stood stationery at the distances where the saccharin sensitivity solution  
530 had been tasted by the same individuals. During the testing, particularly before  
531 nebulizing, the study volunteers were instructed to breathe through the mouth with the  
532 tongue slightly out, so that they could ably taste the saccharin. During the testing, the  
533 volunteers were instructed to breathe: (i) normally, (ii) deeply, (iii) while moving their  
534 head side-to-side, (iv) while moving their head up and down, (v) while bending over or  
535 bending at the waist, (vi) while talking, (vii) and to breathe normally again. When  
536 saccharin was not tasted at the respective distances; the test was considered as 'passed'  
537 or 'successful' while the test was considered as 'failed' or 'unsuccessful' when the  
538 saccharin was tasted at the respective distances. Despite, the 'failed' test, the number of  
539 squeezes to tasting the saccharin were recorded. The test was recorded as completely  
540 'failed' or 'unsuccessful' after repeat testing was done and the saccharin was tasted while  
541 the same face-mask were being worn.

542 **In-house face-mask re-usability testing.** In the testing, each of the face-masks was  
543 subjected to 3 decontamination methods that included: (i) spraying the face-masks with  
544 70% ethanol and drying under the sun particularly for the non-reusable face-masks, (ii)  
545 washing the face-masks with non-bacterial soap and drying them under the sun, (iii) and,  
546 washing the face-masks with non-bacterial soap, drying them under the sun and ironing

547 them, after which semi-quantitative mask fitness testing, in-house: face-mask filtration  
548 efficiency testing, breathability testing, and distance dependent fit testing were repeated.

549 **Positive controls.** United States Food and Drug Administration (FDA) KN95 paper based  
550 European Union (EU) certified EN 149:2001+A1:2009 FFP2 NR D face-masks were used  
551 as positive controls in the series of experiments performed.

552 **Data management and analysis.** Data from the collection forms previously validated by  
553 the study principal investigators and the laboratory team was entered and cleaned using  
554 MS Excel 2016 and analyzed using Stata 14.0, a statistical software. Descriptive analyses  
555 such as proportions, and means (where appropriate) were performed. In-house face-  
556 mask filtration efficiency was determined by counting the number of colony forming  
557 units (CFUs) on the test culture plates similar to those on the positive control culture  
558 plates. Analysis of variance was used to assess the association between the face-mask  
559 types and average increase in weight and humidity to determine which face-mask had  
560 the best breathability. The statistical significance levels were two-sided at  $p < 0.05$  (95%  
561 CI). Graphs were plotted using excel and Stata 14.0 where appropriate to describe the  
562 data.
