

1 Recommendations from long-term 2 care reports, commissions, and 3 inquiries in Canada

34 Abstract

35 Background

36 Multiple long-term care (LTC) reports over the last 30 years issued similar recommendations for
37 improvement across Canadian LTC homes. Our primary objective was to identify the most
38 common recommendations made over the past 10 years. Our secondary objective was to estimate
39 the total cost of studying LTC issues repeatedly over the past 30 years.

40 Methods

41 The qualitative and cost analyses were conducted in Canada from July to October 2020. Using a
42 list of reports, inquiries and commission from The Royal Society of Canada Working Group on
43 Long-Term Care, we coded recurrent recommendations in LTC reports. We contacted the
44 sponsoring organizations for a cost estimate, including direct and indirect costs. All costs were
45 adjusted to 2020 Canadian dollar values.

46 Results

47 Of the 80 Canadian LTC reports spanning the years of 1998 to 2020, twenty-four (30%) were
48 based on a national level and 56 (70%) were focused on provinces or municipalities. Report
49 length ranged from 4 to 1491 pages and the median number of contributors was 14 (interquartile
50 range, IQR, 5–26) per report. The most common recommendation was to increase funding to
51 LTC to improve staffing, direct care and capacity (67% of reports). A median of 8 (IQR 3.25–
52 18) recommendations were made per report. The total cost for all 80 reports was estimated to be
53 \$23,626,442.78.

54 **Interpretation**

55 Problems in Canadian LTC homes and their solutions have been known for decades. Despite
56 this, governments and non-governmental agencies continue to produce more reports at a
57 monetary and societal cost to Canadians.

61 Introduction

62 The COVID-19 pandemic led to a high proportion of deaths in Canadian long-term care
63 homes (LTCH) compared with those of other developed countries. The proportion of deaths from
64 COVID-19 in LTCH in Canada was 81% compared with a mean of 42% in other Organisation
65 for Economic Cooperation and Development (OECD) countries [1]. This statistic is surprising
66 since Canada is considered to have a relatively low number of COVID-19 deaths overall [2].
67 There were also significant differences between provinces that were attributed to pandemic
68 preparedness, integration of services (LTCH, public health and hospitals), funding and resources,
69 daily care hours for residents, comprehensiveness of inspections and differences in ownership
70 model (profit versus non-profit) [3].

71 Residential LTCHs provide living accommodations for people who require full-time
72 supervised care [4]. The founding of long-term care (LTC) in Canada was based in the
73 Elizabethan Poor Law of 1601 that grouped older adults with other disadvantaged populations in
74 housing that was run by various organizations and not centrally regulated [5]. LTC is not situated
75 within the Canada Health Act [4], which resulted in different care models and resource allocation
76 across organizations and homes. This variation has been associated with significantly different
77 outcomes during the current pandemic [6].

78 During the early months of COVID-19, the media reported a shortage of direct care
79 providers and personal protective equipment (PPE) in Canadian LTCHs, which led to residents
80 suffering from a lack of basic personal care and delays in identifying medical problems [7].
81 Reduced staffing levels and wage compression in Canada's LTC sector compelled individuals to
82 work at more than one facility to make a living wage. An Ontario study comparing for-profit and
83 non-profit facilities found lower staffing levels in for-profit LTCHs, which was associated with

84 worse COVID-19 outcomes [8], although this may not be the case elsewhere in the country [9].
85 Working at multiple nursing homes contributed to the spread of COVID-19 infection [6], and
86 although restricting employment to one facility reduced the number of outbreaks, it also
87 exacerbated pre-existing work force shortages [10]. Furthermore, lower staffing levels and direct
88 care hours are associated with increased rates of infection and hospital admission among
89 residents [11], with this same trend observed in LTCHs with COVID-19 outbreaks [3,6,12].

90 In April, the Royal Society of Canada Working Group on Long-Term Care was tasked
91 with reviewing the current state of LTC in the face of COVID-19 [5]. Their report found 103
92 LTC reports, commissions, and inquiries, 80 of which were unique reports based in Canada. The
93 review found recurrent themes of longstanding deficiencies in the LTC sector that contributed to
94 the magnitude of the COVID-19 crisis in LTCHs. Despite the wealth of evidence, little change
95 has been implemented and in COVID's wave 2, LTCHs are again being devastated by outbreaks
96 [16]. LTCHs continue to account for the majority of outbreaks and deaths in Canada; as of Nov 7
97 there were 2,026 COVID-19 outbreaks in LTCHs [13]. The Canadian Red Cross has been called
98 in to support care in 7 Ottawa LTCHs [14]. Since June, LTCHs across Canada have seen a 19%
99 increase in the number of deaths [2]. The opportunity to support residents and care providers
100 between wave 1 and wave 2 has passed. Sadly, the consequences of the lack of action will be
101 disproportionately carried by the most vulnerable residents and the lowest paid, most
102 marginalized members of the LTC workforce, personal support workers (PSW), who provide
103 90% of the direct care [15].

104 The primary **objective** of this study was to examine the recurring recommendations over
105 the past 10 years. Our secondary objective was to calculate the total costs of generating all of the

106 LTC reports, commissions, and inquiries in Canada over the last 30 years. We aimed to put the
107 cost of repeatedly studying the same problems into context of the current pandemic.

108 **Methods**

109 Qualitative and quantitative analyses were based on Canadian LTC reports and
110 commissions identified from The Royal Society of Canada Working Group on Long-Term Care
111 [5], which was done using a literature search and environmental scan over the last 30 years. Our
112 analysis took place from July to October 2020. Content analysis was used to determine the
113 presence of certain words, themes, or concepts within reports published in the past 10 years. Two
114 reviewers independently reviewed 5 reports, and a consensus coding scheme was created. For the
115 cost analysis, we excluded follow-up reports and included cost estimates in the original larger
116 report.

117 **Estimation of report cost**

118 We contacted the author or sponsoring organizations of the 80 Canadian LTC reports to
119 inquire about the estimated cost of producing each report. We requested both direct and indirect
120 costs. Direct costs included consultancy fees, salaries, compensation for expert witnesses,
121 graphics, layout, printing, and dissemination. Indirect costs included time donated from authors
122 who volunteered their time to produce the report. When an estimated budget was not available,
123 we searched online for global budget reports from the sponsoring organization. Total annual
124 expenses for research, advocacy, or reports were divided by the number of reports published that
125 year by the organization to generate an estimated cost. We also searched for media reports about
126 costs of commissions or coroner's inquests. If no costs were available, the estimate was based on
127 length, depth of research, inclusion of external experts/witnesses, and the sponsoring

128 organization of similar LTC reports. Costs were in Canadian dollars and adjusted to 2020 values
129 according to the Bank of Canada Inflation Calculator [16].

130 Data abstraction and analysis

131 Report characteristics were extracted, including title, sponsoring organization,
132 publication year, geographic region, scope of report, number of contributors, number of pages,
133 and duration of the project. The primary outcome was recurrent recommendations. Secondary
134 outcomes included contributors, total costs of producing the reports and median page count.

135 Ethics approval

136 No ethics approval was required for this analysis.

137 Results

138 The list of Canadian LTC reports from the Royal Society commission spans the years
139 1998 to 2020 (n=80). There was an increase in the number of reports over time, with 10 reports
140 in the first half of 2020 (Figure 1). Most of the reports were focused at a provincial level (n=55,
141 68.8%), 24 reports were based on a national level (30.0%). We found one municipal report and
142 no reports from the territories. Ontario (n=31, 55.0%) produced the majority of the provincial
143 reports, followed by British Columbia (n=11, 19.6%) (Table 1). More reports were funded by
144 provincial governments (n=26) compared with the federal government (n=9). Non-profit
145 organizations (e.g. Canadian Association for Long Term Care, Canadian Institute of Health
146 Information) and professional unions (e.g. Canadian Federation of Nurses Unions, Canadian
147 Union of Public Employees) or associations (e.g. Registered Nurses' Association of Ontario,
148 Canadian Medical Association) authored the remaining 45 reports. No reports were funded by
149 the private sector. Most of the reports focused solely on LTC (68.8%), but some reports focused

150 on continuing care, older adults, or the health care system as well. The median report length was
151 40 pages (interquartile range, IQR, 21–84), with 16 reports (20.0%) over 100 pages. The median
152 number of contributors, including authors, witnesses, and consultants, was 14 (IQR 5–26).

153 Common recommendations in reports

154 Reviewing the reports from the last 10 years (n=48), we identified a median of 8 (IQR
155 3.25–18) recommendations per report. Numerous recommendations were repeated in these
156 reports (Table 2). Overall, the most frequent recommendations were: (i) to increase or
157 redistribute funding to improve staffing, direct care, and capacity (66.7%), (ii) to standardize,
158 regulate and audit LTC quality of care (58.3%), and (iii) to standardize, regulate or reform
159 education and training for LTC staff (52%). Improving staff education and training, increasing
160 behavioural supports, and modernizing infection control measures were universally
161 recommended in reports by governments, non-profits, professional association and unions.

162 Government-authored reports (n=35) focused on using improving data collection (n=8,
163 22.9%), improving education and training of staff (n=8, 22.9%) and standardizing LTC quality
164 of care (n=8, 22.9%). Professional union reports (n=11) focused on regulating for-profit LTCHs
165 (n=4, 36.4%) and standardizing LTC quality of care (n=4, 36.4%). The most common
166 recommendation made by non-profits (n=19) was to improve training and education for staff
167 (n=9, 47.4%). Professional associations reports (n=20) most commonly recommended
168 standardizing staffing mix (n=10, 50.0%) and increasing funding for direct care (n=10, 50.0%).
169 The least common recommendation made by professional associations was for improved
170 transparency, reporting and tracking of critical incidents (n=1, 5.0%).

171 Critical incidents received the most attention from governments (n=6, 17.1%), followed
172 by non-profits (n=2, 10.5%) and a professional association (n=1, 5.0%). Recommendations

173 regarding quality of care or data utilization were more likely to be made by government (n=18,
174 51.4%) or professional associations or unions (n=20, 64.5%) than by non-profits (n=3, 15.8%).
175 Staff wellness support was most recommended by non-profits (n=7, 36.8%), followed by
176 professional associations or unions (n=6, 19.4%), then government (n=3, 8.6%). The
177 appointment of commissions or inquiries was mostly recommended by professional associations
178 or unions (n=7, 22.6%) then by government (n=2, 5.7%) and no commissions were
179 recommended by non-profits.

180 Although recommendations to improve resident quality of life were mentioned in 12
181 reports, they mostly overlapped with other recommendations such as increasing direct care,
182 optimizing staff mix, increasing quality of life data collection, and improving quality of care.
183 Only one report discussed specific recommendations to improve quality of life, such as
184 increasing decision-making capacity (e.g. choice over when to bath), improving privacy with
185 single rooms, and prioritizing relational care over medical tasks and interventions [17].

187 Cost of reports

188 Nearly half of the reports (45%) had cost estimates by the sponsoring organization or by
189 publicly available budget or media reports. The total cost for all 80 reports was estimated to be
190 \$23,626,442.78 (Table 1). The median cost per report was \$15,203.48 (IQR \$10,000–
191 \$53,147.81). Details of each report's cost estimate are shown in Supplementary table 2. The
192 lowest cost was estimated at \$500 for each of the Canadian Army Joint Task Force reports,
193 which accounts for the administrative costs of writing the reports even if the services were
194 provided on military order, but the cost of military deployment was not included [7]. The highest
195 cost was \$9,046,255.51 for the Public Inquiry into the Safety and Security of Residents in the

196 Long-Term Care Homes System (The Wettlaufer Report) in 2019, which involved 79
197 contributors, witnesses, and experts [18].

198 Discussion

199 This analysis highlights the efforts of multiple organizations, both governmental and non-
200 governmental, to address the longstanding challenges and quality issues in Canada’s LTCHs.
201 The Royal Society Briefing Report concluded that the unresolved issues in Canada’s nursing
202 homes have been known for decades. According to our analysis, there are numerous sound
203 recommendations backed by evidence, yet little action has followed. This inaction has
204 contributed to the devastating loss of life during the COVID-19 pandemic and to lower quality of
205 life in LTCHs. Our analysis further shows the substantial cost of studying the problem repeatedly
206 over the years.

207 Duplicate investigation of known findings reduces value and increases waste [19]. From
208 the LTC reports, issues regarding understaffing, undertraining, and the negative impact of for-
209 profit LTC homes were repeatedly mentioned [5]. Policy change often requires persistence [20],
210 but the cost of advocating for change should be viewed from a societal context (financial and
211 moral). Commissions and inquiries into LTC issues, like those happening or slated to begin
212 around the country [21–23], can solidify our determination for policy change, but do not replace
213 the need for policy implementation – action.

214 Several provinces have increased wages and provided full-time employment with more
215 appropriate compensation and benefits to stabilize the LTC workforce [24]. The Ontario
216 government went further to commit 4.00 hours per day of direct care for each LTC resident by
217 2024 [25], bringing the total care hours above the national average (3.30 hours) [26]. However,
218 increasing direct care hours, while essential, is only one of the many recommendations from

219 existing reports. Identifying the right staff mix and care team composition, providing proper
220 education and training, and supporting staff wellness are also critical to developing a long-term
221 workforce that has sufficient resilience to confront future crises [27]. Furthermore, we should
222 focus more attention on resident quality of life, which should be the ultimate goal of our efforts.

223 Although the total cost of \$23 million in generating LTC reports may seem insignificant
224 compared to a government budget, it represents a lost opportunity to continually improve
225 Canadian LTCHs. Studying the same problems repeatedly means Canadian experts are confined
226 to fixing critical deficiencies in LTC instead of innovating new care models.

227 There are several strengths of this study. Two reviewers extracted key recommendations
228 from each LTC report in the last 10 years and created a consensus coding scheme. We
229 systematically tracked down the cost of each report by contacting the sponsoring organization or
230 consulting their global budgets. The total costs, including time donated of experts authoring
231 these reports, were accounted for. For reports that did not have available cost data, we estimated
232 the total cost by using reports with known costs with similar length and depth.

233 The main limitation of this study was the lack of true cost estimates for half of the LTC
234 reports. Some organizations lacked transparency about costing, and others lacked detailed
235 accounting of spending. Staff turnover and record keeping practices were barriers to accessing
236 data, particularly for the reports produced over 10 years ago. For government agencies, we often
237 had to call multiple departments and speak with numerous representatives and noted
238 considerable variation in the level of disclosure. For the two military reports during COVID-19,
239 we likely underestimated the cost since they were generated as part of military duty. However,
240 there were still considerable costs incurred by the public by having the military deployed to those
241 LTCHs [28]. We also grouped reports on health system improvement and care of older adults in

242 general in this analysis because LTC is intricately tied to the health system at large. Leaders in
243 senior care such as Denmark also design LTC policy as in integral part of their health system
244 [29].

245 Conclusion

246 Over the last two decades, Canadian governments and non-government organizations
247 have repeatedly investigated longstanding LTC issues and have largely drawn the same
248 conclusions. Had the recurring recommendations been implemented, we would not only have
249 improved working conditions, quality of care and quality of life, but would also have prevented
250 unnecessary deaths due to COVID-19. Instead of continuing to investigate LTC issues, we
251 should focus our resources on implementing the recommendations in the identified reports.

Figure 1: The number of Canadian reports with LTC recommendations over the span of 1998-2020. LTC = long-term care.

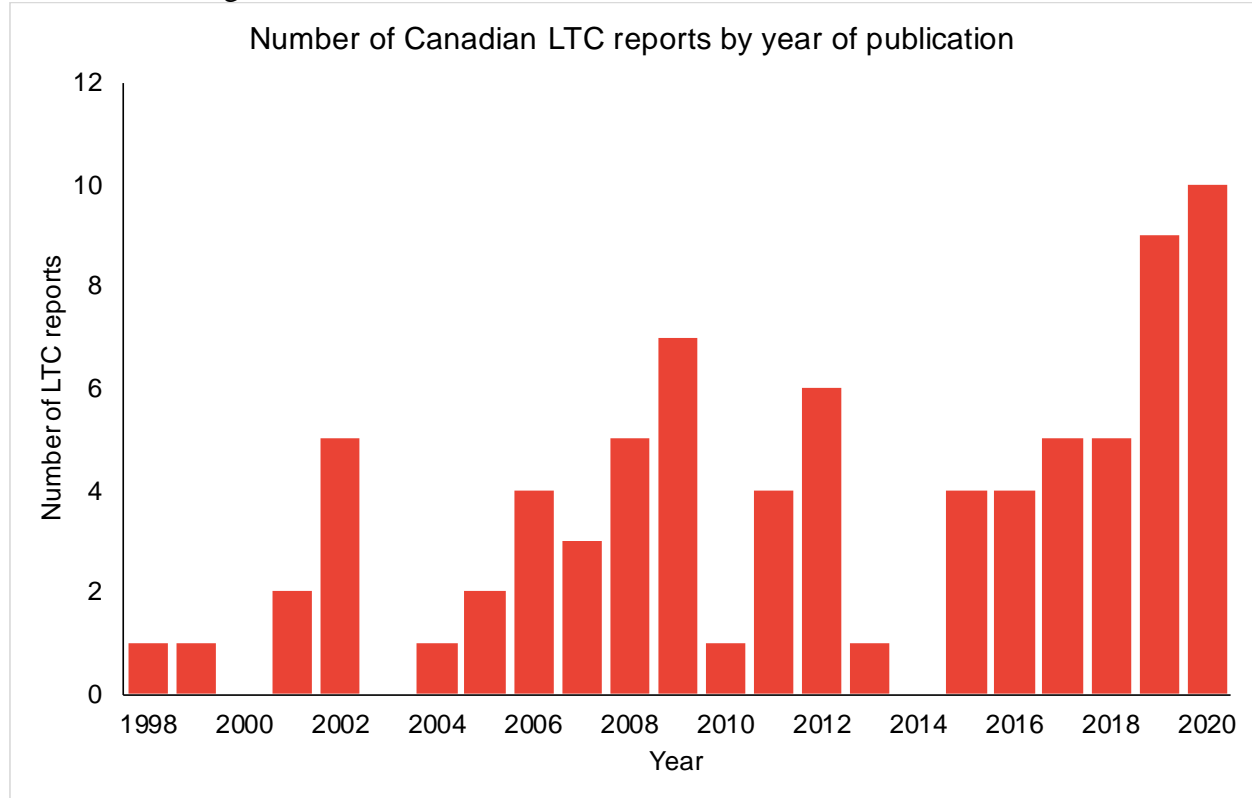
