

Impact of mass testing during an epidemic rebound of SARS-CoV-2: A modelling study

Abstract

We used a mathematical model to evaluate the impact of mass testing in the control of SARS-CoV-2. Conditions required to control a quickly growing epidemic with mass testing appear impossible to achieve. Mass testing should therefore not be seen as a silver bullet that will ensure other control measures can be removed. Even under a set of optimistic assumptions, this strategy is most relevant when epidemic growth remains limited, thanks to a combination of interventions.

Introduction

Several European countries facing a large increase in COVID-19 cases have moved back into lockdown. While Test-Trace-Isolate remains for now the most efficient way to control an epidemic rebound at the end of these lockdowns, there is debate about optimal ways to use testing (1, 2). So far, testing has mostly targeted symptomatic individuals and contacts of

cases. The increasing availability of diagnostic tests now makes it possible to consider a strategy of mass testing, that consists in testing a large proportion of the population in a single campaign to identify and isolate as many infected individuals as possible. The development of rapid antigenic tests facilitates the implementation of such an approach since these tests can provide results in less than 30 minutes compared to 1-2 days for the standard PCR. Although these antigenic tests have a reduced sensitivity as compared to the PCR test for the diagnostic of SARS-Cov-2, the most sensitive rapid antigenic tests have a sensitivity threshold that is sufficient to identify a large proportion of infectious individuals (with high viral shedding)(3).

However, even with antigenic tests, the implementation of mass testing will be extremely challenging with an impact that is still to be determined. Here, using a mathematical model, we assess the possible impact of mass testing campaigns in a scenario of epidemic rebound at the end of the ongoing lockdown in Metropolitan France.

Modelling the spread of SARS-CoV-2 and consecutive campaigns of mass testing

We use a compartmental SEEIR model to describe the spread of SARS-CoV-2 in Metropolitan France (4, 5). After infection, individuals move between the following compartments: compartment E1 where they have been exposed but are not infectious yet (average duration: 4 days), compartment E2 where they are infectious (i.e. can transmit) but have no symptoms (average duration: 1 day), compartment I where they are infectious and may be symptomatic (average duration 3 days), compartment R where they recovered. This description leads to a generation time of about 7 days consistent with existing data on chains of transmission and viral excretion (6, 7).

In our baseline scenario, we deliberately consider very optimistic assumptions to derive an upper bound of the impact of mass testing. We assume that an infectious individual (i.e. in compartments E2 or I) has a probability of testing positive with an antigenic test equal to $Se=90\%$ and that a person testing positive will reduce onward transmissions by $\rho=70\%$ on average thanks to isolation (1, 2). In sensitivity analyses, we also consider $Se=60\%$, 75% and $\rho=50\%$, 90% .

Assuming a basic reproduction number $R_0=0.9$ from 30th November 2020, the start of the ongoing lockdown, to January 4th 2021, we expect about 8000 daily infections (with about half of them being detected) and 13% of the population of Metropolitan France being infected by January 4th 2021. From January 4th 2021, we consider rebound scenarios where the number of daily infections doubles every 10 (effective reproduction number $Re=1.6$), 14 ($Re=1.4$), 17 ($Re=1.3$) and 21 ($Re=1.22$) days. As a reference, Re was estimated at 1.4 from hospitalisation data in mid-October.

We assume that the first testing campaign starts on January 4th, is repeated every 1-30 days with 0-90% of the population being tested during each campaign.

Impact of mass testing on epidemic dynamics

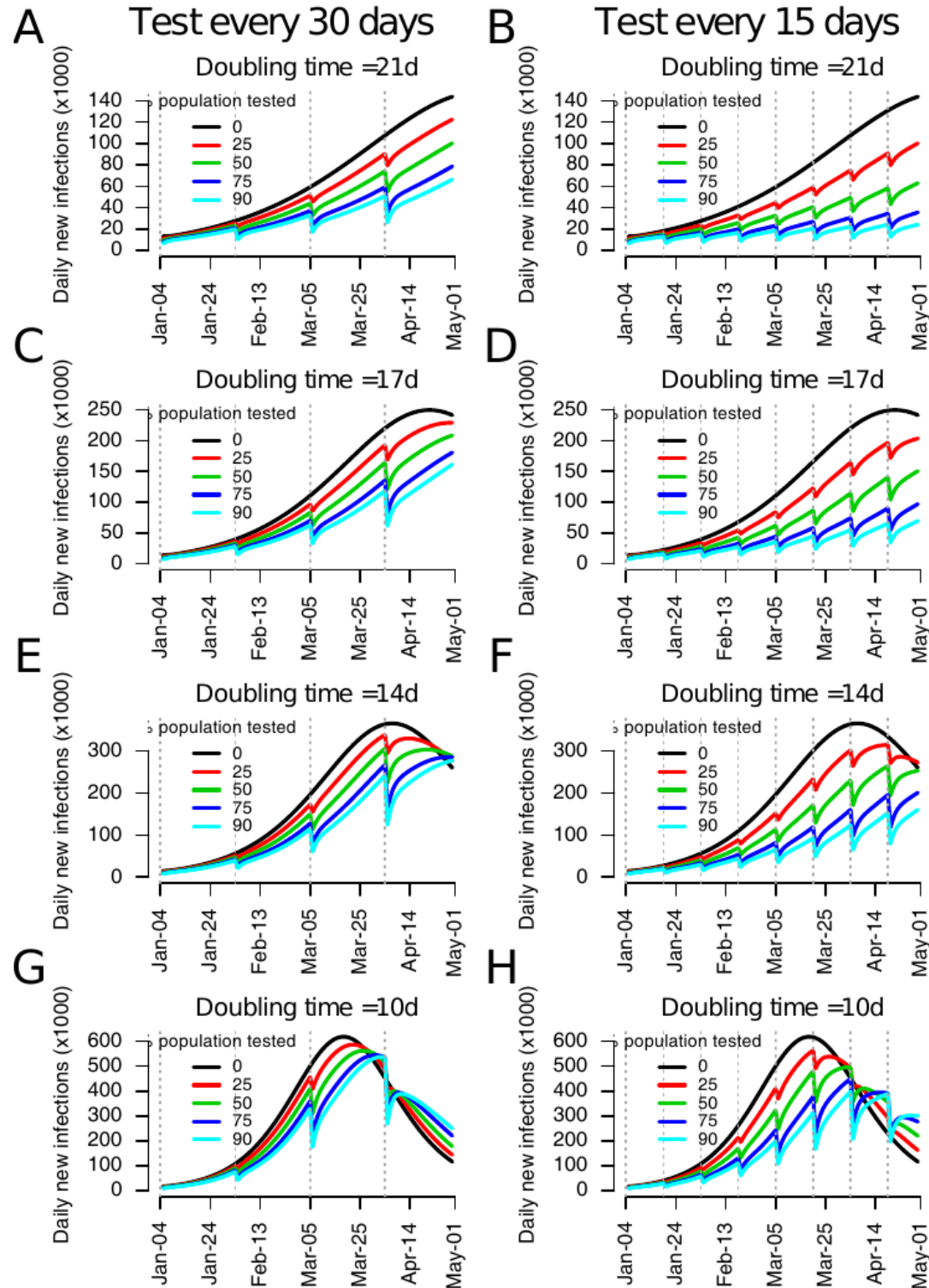


Figure 1. Expected numbers of daily infections when monthly (A, C, E, G) and bi-weekly (B, D, F, H) testing campaigns are performed targeting different proportions of the population. We explore epidemiological scenarios where the number of infections double every 21 (A, B), 17 (C, D), 14 (E, F) and 10 (G, H) days. We assume that the probability to detect an infectious individual with an antigenic test is $Se=90\%$ and the reduction in onward transmission following a positive test is $\beta=70\%$.

Figure 1 shows epidemic dynamics for monthly and bi-weekly campaigns of mass testing starting on January 4th 2021. For an epidemic rebound with a doubling time of 21 days, we would expect 140,000 daily infections by May 1st in the absence of mass testing. A monthly campaign of mass testing in which 75% of the population is being tested would reduce that

number to 80,000 daily infections, and a bi-weekly campaign to 35000. For a doubling time of 14 days, a monthly campaign testing 75% of the population would reduce daily infections at the peak from 360,000 to 285,000 and bi-weekly campaigns to 200,000 daily infections.

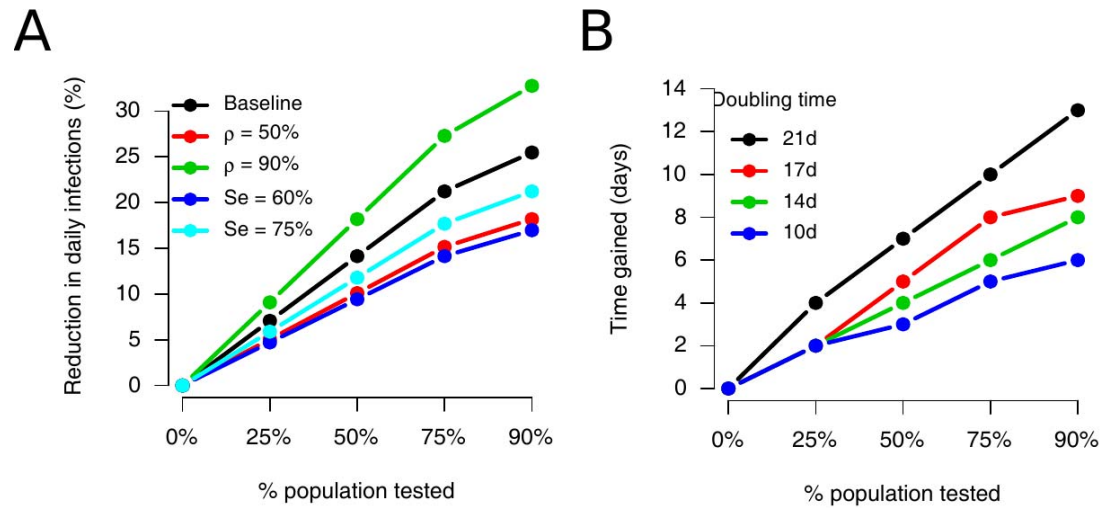


Figure 2. Impact of a single campaign of mass testing. A. Reduction in the number of infections occurring 10 days after the campaign, for different scenarios. In our baseline scenario (black line), the probability to detect an infectious individual with an antigenic test is $Se=90\%$ and the reduction in onward transmission following a positive test is $\rho=70\%$. We consider alternative scenarios with $\rho=50\%$ (red line), $\rho=90\%$ (green line), $Se=60\%$ (blue line) and $Se=75\%$ (light blue line). B. Time it takes for the number of daily infections to go back to levels observed prior to mass testing, as a function of the doubling time in the baseline scenario.

In our baseline scenario, we find that a single campaign targeting 75% of the population reduces the number of infections that occur 10 days after the campaign by about 21% (Figure 2A). We obtain 14% and 18% reductions for a sensitivity Se of 60% and 75%, respectively, and 15% and 27% reductions for an effectiveness of isolation ρ of 50% and 90%, respectively. Results are insensitive to the value of the effective reproduction number (results not shown). These reductions may have limited impact on overall dynamics in a context of quick epidemic rebound. For example, in our baseline scenario, if the number of infections doubles every 21 days and 75% of the population is being tested, we expect that it will take 10 days to get back to the epidemiological situation observed prior to testing (Figure 2B). For a doubling time of 14 days, we only gain 6 days.

Figure 3 shows the maximum daily number of infections observed by May 1st as a function of the number of days between consecutive campaigns and the proportion of the population being tested in each campaign. In our baseline scenario, for a doubling time of 21 days, to ensure that the number of infections remains below 80,000, 60,000 and 40,000 up to May 1st, a campaign testing 75% of the population would need to occur every 30, 22, and 16 days, respectively. For a doubling time of 14 days, testing of 75% of the population should occur every 6 days to have <40,000 daily infections.

We explore the sensitivity of our results to model assumptions (Figure 4). To observe <40,000 daily infections by May 1st with a doubling time of 21 days, testing 75% of the population needs to be repeated every 21 days and 11 days when the effectiveness of isolation following a positive test is $\rho=90\%$ and $\rho=50\%$, respectively. Such campaigns need to be repeated every 12 and 10 days for a sensitivity Se of the test of 75% and 60%.

Discussion

We used a simple mathematical model to highlight the potential and limits of mass testing for the control of SARS-CoV-2 epidemics. Our analysis suggests that, to positively impact epidemic dynamics, mass testing needs to target a large proportion of the population, be repeated, and rely on a test with good sensitivity to identify infectious individuals. The strategy only makes sense if a large proportion of those testing positive are effectively isolated. The conditions required to control a quickly growing epidemic with mass testing appear impossible to achieve. Mass testing should therefore not be seen as a silver bullet that will ensure other control measures can be removed. Even under a set of very optimistic assumptions, this strategy is most relevant when the epidemic growth remains limited, thanks to a combination of interventions. These results are consistent with another modelling study (8).

An important limitation of mass testing is that, when the campaign begins, approximately half of the individuals who are infected are still in the latent phase E1 so that they do not shed sufficient virus to test positive. These individuals will not be detected and will become infectious after the campaign, fueling once again the epidemic. This problem can be partly mitigated by isolating household contacts and performing robust contact tracing of cases(9).

With interventions able to slow down the epidemic growth, high frequency of screening remains the key element to provide an additional contribution to epidemic control (7). However, the logistics, efficiency of isolation, and voluntary participation of the population to repeated mass screening need to be carefully assessed. Few pilot studies have been conducted so far in small regions and with one-shot approaches requiring several days of implementation (10). Weekly screening 75% of the population in France would correspond to about 50M antigen tests to be administered every week, with substantial challenges in supplying, distribution, and administration. Limited adhesion to isolation if positive would largely compromise such effort. Here we considered a very optimistic scenario with 70% reduction of onward transmission in isolation (with 50%-90% for sensitivity), but survey data from the UK point to smaller adhesion rates, of about 10%(11).

Our study has a number of limitations. First it relies on a deterministic model that may imperfectly capture epidemic dynamics when the daily number of infection becomes very low. In such situations, the epidemic may take longer to rebound than anticipated by the model. Second, we assumed that the probability to test positive only depends on whether the individual is infectious (7). However, sensitivity may change during the infectious phase. Also, we do not address the logistical challenges involved in regular mass screening and assume that individuals are tested in a single day.

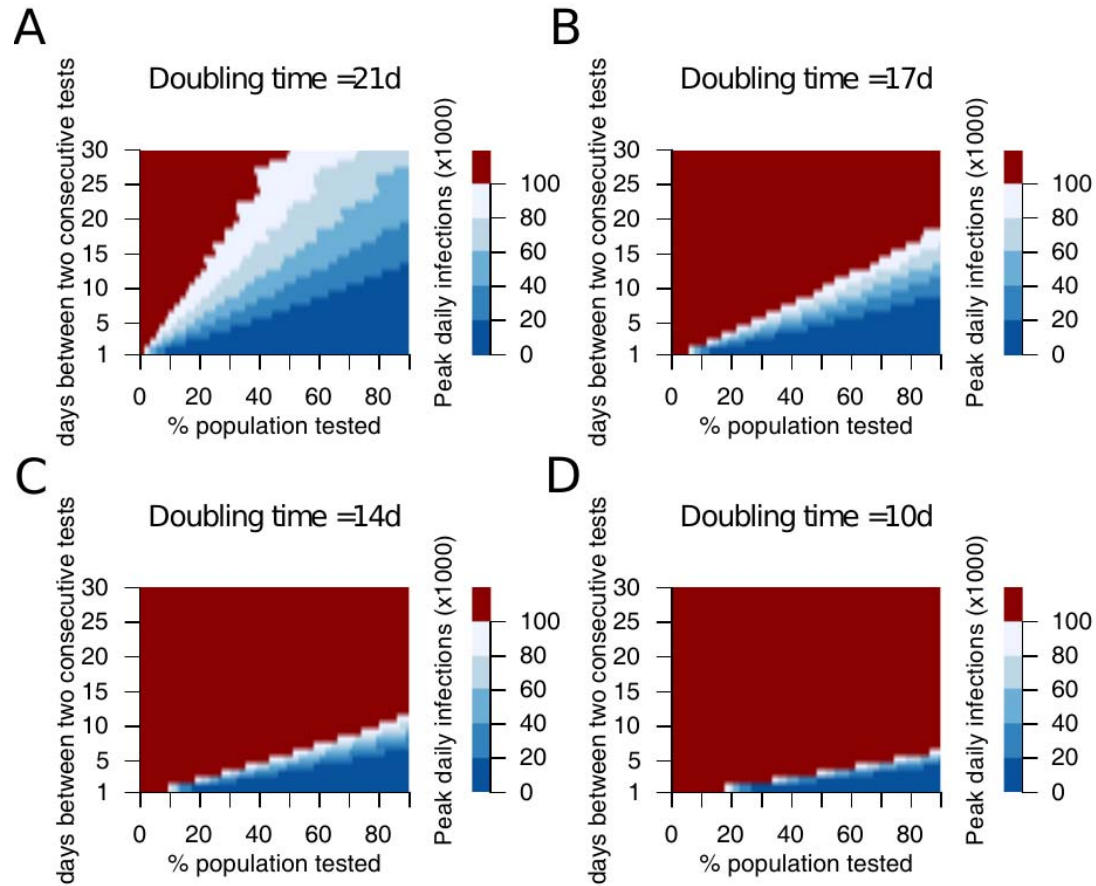


Figure 3. Expected maximum number of daily infections observed by May 1st as a function of the number of days between consecutive campaigns and the proportion of the population being tested in each campaign, for doubling times of 21 (A), 17 (B), 14 (C) and 10 (D) days. We assume that the probability to detect an infectious individual with an antigenic test is $Se=90\%$ and the reduction in onward transmission following a positive test is $\alpha=70\%$.

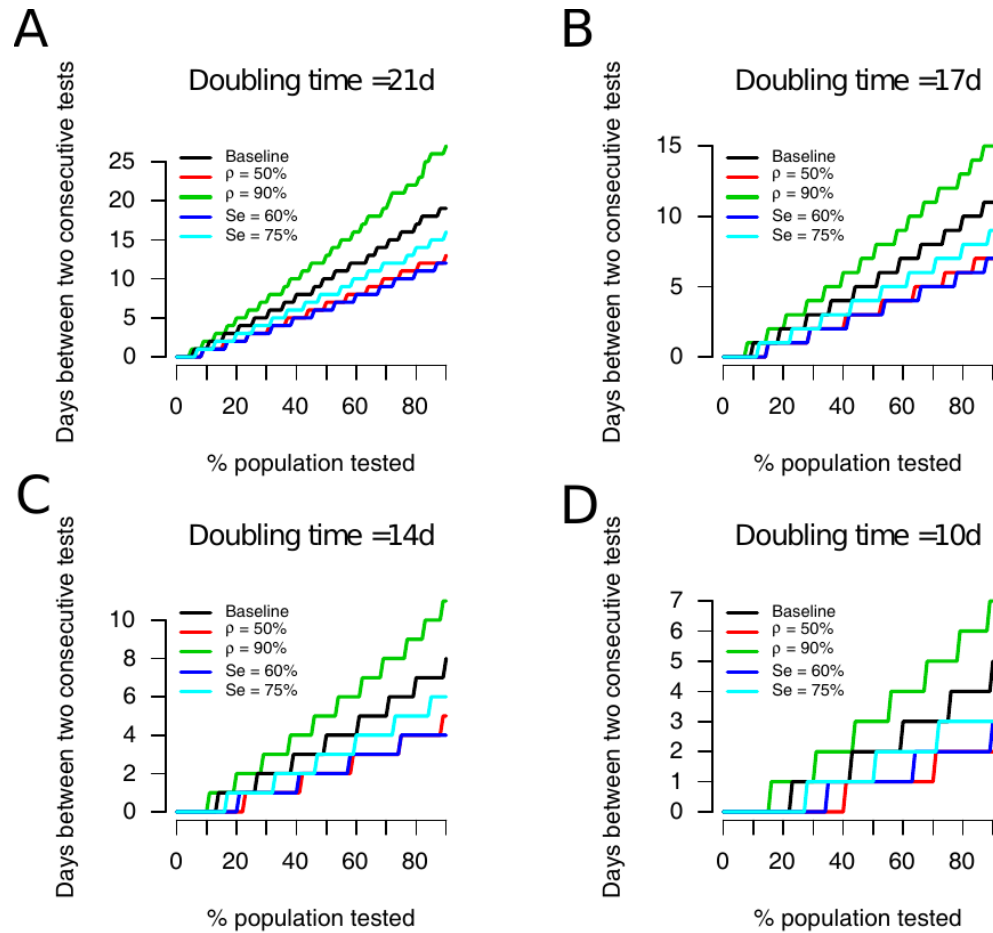


Figure 4. Frequency of mass testing campaigns necessary to keep the number of daily infections below 40,000 until May 1st as a function of the proportion of the population being tested in each campaign, for different modeling assumptions. In our baseline scenario (black line), we assume that the probability to detect an infectious individual with an antigenic test is $Se=90\%$ and the reduction in onward transmission following a positive test is $\rho=70\%$. We consider alternative scenarios where the reduction in transmission is $\rho=50\%$ (red line) and 90% (green line) and where the probability to detect an infectious individual is $Se = 60\%$ (blue line) and $Se = 75\%$ (light blue line).
