

**Title:** Significant and sustained decrease in non-SARS-CoV-2 respiratory viral infections during COVID-19 public health interventions.

**ABSTRACT**

Public health interventions to decrease the spread of SARS-CoV-2 were largely implemented in the United States during spring 2020. This study evaluates the additional effects of these interventions on non-SARS-CoV-2 respiratory viral infections from a single healthcare system in the San Francisco Bay Area. The results of a respiratory pathogen multiplex polymerase chain reaction panel intended for inpatient admissions were analyzed by month between 2019 and 2020. We found major decreases in the proportion and diversity of non-SARS-CoV-2 respiratory viral illnesses in all months following masking and shelter-in-place ordinances. These findings suggest real-world effectiveness of nonpharmaceutical interventions on droplet-transmitted respiratory infections.

## **INTRODUCTION**

Public health interventions to decrease the spread of SARS-CoV-2 have been in place in the San Francisco Bay Area since spring 2020. A shelter-in-place order went into effect in Bay Area counties on March 16, 2020 with dynamic restrictions over the summer, fall and winter of 2020 (1). An order requiring face coverings went into effect April 17, 2020 (2). While these types of nonpharmaceutical interventions have been linked to dramatic reductions in the rates of influenza (3, 4), there has been a paucity of data examining rates of circulation of other common respiratory viruses.

## **METHODS**

Results of a multiplex polymerase chain reaction respiratory pathogen panel (RPP) assay (FilmArray RP2, Biofire Diagnostics) were extracted from the Zuckerberg San Francisco General Hospital (ZSFG) clinical laboratory information system from January 2019 to December 2020; a period spanning approximately one year before and during the COVID-19 pandemic. The RPP panel tests for 17 viral pathogens and 4 bacterial organisms. At our center, this test is utilized for evaluation of infectious respiratory diseases in patients admitted to the hospital. To assess trends in incidence of respiratory pathogens during the COVID-19 pandemic, we compared the number and percentage of positive results (total and by pathogen) by month. We tested for significance using Chi-square or Fisher exact tests. All statistical analyses were performed in Prism 9.0.0 (GraphPad Software). This project was approved by UCSF Human Research Protections Program (IRB# 20-32769) and ZSFG protocol approval board.

## RESULTS

A total of 1,484 and 2,037 RPP tests were analyzed during 2019 and 2020, respectively. Percent positivity of tests by month ranged from 13.6%-39.1% during 2019 and 2020 pre-COVID-19 interventions (January, 2019-March, 2020) and 0.0%-11.1% during 2020 post-interventions period (April-December, 2020) (Figure 1). The proportion of total positive tests was not significantly different for January, February, and March of 2019 versus the same months in 2020. However, the proportion of positive tests was lower for every month April-December 2020 during COVID-19 restrictions compared to 2019. Human rhinoviruses/enteroviruses (HRE) were the respiratory pathogens most frequently detected across all years (Table 1). During the April-December 2020 post-interventions period, 89.6% (43/48) of positive results were HRE versus 55.0% (177/322) over the same period in 2019. Zero influenza cases were detected during the 2020-2021 influenza season for this time period.

## DISCUSSION

The COVID-19 pandemic began affecting the United States in March 2020 (5). To mitigate disease transmission in the San Francisco Bay Area, public health orders to shelter-in-place and wear face coverings were imposed and have largely been followed. The effectiveness of these interventions has primarily been measured in relation to SARS-CoV-2 incident infections, for which testing availability and indications and public health mitigation strategies have varied widely. The effect of mitigation measures on non-COVID-19 respiratory infections has mainly been seen in the profound reduction of influenza (3, 4). However, the seasonal nature of influenza has prevented generalization of this trend to other respiratory viruses, particularly those that circulate year-round. We observed a striking decrease in the number and percentage of all respiratory viruses after public health interventions began in March 2020 and observed a

sustained low rate of respiratory virus detection throughout the summer, fall and early winter of 2020.

Our study contains certain limitations. We employed a cross-sectional design comparing two years of data from a single healthcare system. As such, we cannot control for year-to-year variations in viral respiratory illnesses or demographic confounders in our study population. Our data may also be affected by reduction of health services or avoidance of medical care directly from COVID-19 and evolving local policies regarding allowable indoor businesses and personal gathering (6, 7). Despite this, our focus on inpatients tested for respiratory infections, rather than the larger population of outpatients, should decrease variation in testing practices that may occur from workup of mild and undifferentiated illness.

While our findings add to the evidence regarding effective disease mitigation strategies (8-10), it is also notable that the low rate of respiratory virus detection remained low during intermittent months of increased public interaction and movement in the Bay Area, including periods when businesses were allowed to partially reopen, times at which civil protests occurred, and periods of increased summer outdoor recreational activities. This suggests a central role for masking and reduction of enclosed space gathering for the disruption of respiratory viral transmission.

Since our study population focuses on prospective inpatient admissions, these results primarily represent moderate and severe infections requiring high-level care. As such, these findings also suggest that community-based strategies have downstream effects on inpatients with respiratory illness. While we cannot conclude which sequence or combination of nonpharmaceutical

interventions is most effective, the sustained decrease in respiratory viral illnesses we observed argues for further investigation of the impact of these strategies, particularly those aiming to reduce droplet transmission, in personal, healthcare and workplace settings.

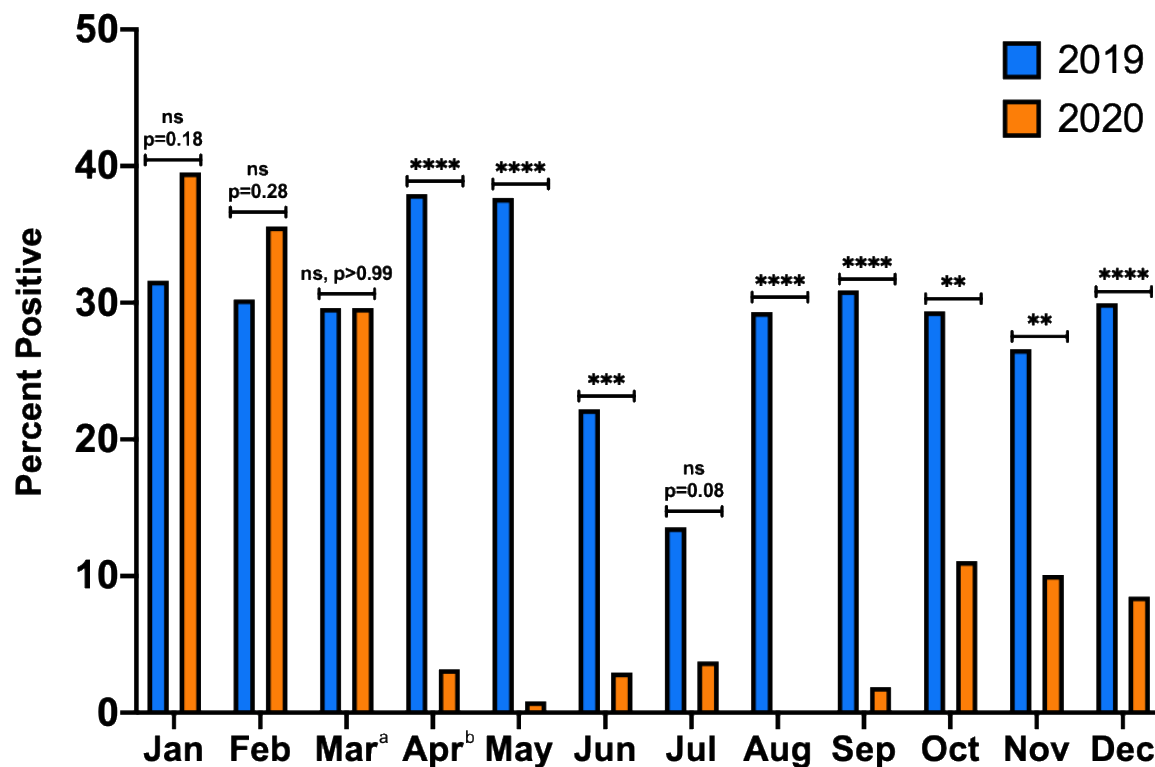
