

1 **Surveillance of COVID-19 vaccination in US nursing homes, December 2020-April 2021**

20 Unstructured Abstract: *Word count = 150; Limit 150*

21 Monitoring COVID-19 vaccination coverage among nursing home (NH) residents and staff is
22 important to ensure high coverage and guide patient-safety policies. With the termination of the
23 federal Pharmacy Partnership for Long-Term Care Program, another source of facility-based
24 vaccination data is needed. We compared numbers of COVID-19 vaccinations administered to NH
25 residents and staff reported by pharmacies participating in the temporary federal Pharmacy
26 Partnership for Long-Term Care Program with those reported by NHs participating in new
27 COVID-19 vaccination modules of CDC's National Healthcare Safety Network (NHSN). Pearson
28 correlation coefficients comparing the number vaccinated between the two approaches were 0.89,
29 0.96, and 0.97 for residents and 0.74, 0.90, and 0.90 for staff, in the weeks ending January 3, 10,
30 and 17, respectively. Based on subsequent NHSN reporting, vaccination coverage with ≥ 1 vaccine
31 dose reached 77% for residents and 50% for staff the week ending January 31 and plateaued
32 through April 2021.

37 1) *What is the current understanding of the subject?*

38 Because of high risk of disease, nursing home residents and staff were prioritized for COVID-19
39 vaccination when doses were limited.

41 2) *What does this report add to the literature?*

42 National monitoring of nursing home residents and staff vaccination coverage through the CDC
43 National Healthcare Safety Network (NHSN) correlated with vaccination administration reports
44 from the federal Pharmacy Partnership for Long-Term Care Program in January 2021. NHSN-
45 reported vaccination coverage rates plateaued from February through April 2021.

47 3) *What are the implications for public health practice?*

48 NHSN can track COVID-19 vaccination in nursing homes and help guide efforts to increase
49 vaccine uptake in residents and staff.

50 **Introduction**

51 Residents and staff of nursing homes (NHs) are at increased risk for SARS-CoV-2 infection,¹⁻³ and NH
52 residents are at risk for severe complications of COVID-19.^{1,4-7} To help protect this disproportionately
53 affected population, in December 2020, the Centers for Disease Control and Prevention (CDC) launched
54 the Pharmacy Partnership for Long-Term Care Program, facilitating on-site COVID-19 vaccination of
55 NH residents as well as NH staff.⁸ Among the approximately 11,000 NHs that had at least one on-site
56 vaccination clinic in the first month of the program, an estimated three-quarters of residents (77.8%) and
57 one-third of staff (37.5%) were vaccinated with ≥ 1 dose of a COVID-19 vaccine.⁹

58 CDC's National Healthcare Safety Network (NHSN) is the nation's web-based surveillance program for
59 monitoring healthcare-associated adverse events, annual healthcare staff influenza vaccinations, and
60 other patient-safety practices. In December 2020, NHSN released COVID-19 reporting modules for
61 tracking vaccination coverage among residents and staff of long-term care facilities.¹⁰ These modules
62 allow for voluntary weekly reporting by facilities and are designed to collect data on the number of
63 current residents and staff eligible for vaccination and who have been vaccinated.¹⁰

64 The Pharmacy Partnership for Long-Term Care Program was designed as a time-limited initiative to
65 facilitate a limited number of vaccination clinics at each participating facility. With the conclusion of the
66 program, reporting of facility-level resident and staff COVID-19 vaccine administration data to CDC
67 has ceased, but the need for a national data source for ongoing monitoring of COVID-19 vaccination in
68 NHs remains, so the Centers for Medicare and Medicaid Services has begun to require NH reporting
69 through NHSN as of June 2021.¹¹

70 The objectives of this analysis were to: 1) compare numbers of COVID-19 vaccinations administered to
71 NH residents and staff in January 2021 as reported by pharmacies participating in the Pharmacy
72 Partnership for Long-Term Care Program, and the NHSN COVID-19 vaccination reporting modules,
73 among CMS-certified NHs that participated in both; and 2) report weekly COVID-19 vaccination
74 coverage for residents and staff among CMS-certified NHs voluntarily reporting through NHSN from
75 December 2020 through April 2021.

76 **Methods**

77 Correlation of COVID-19 Vaccination Administration Reporting

78 We used facility NHSN Organization ID and CMS Certification Numbers to identify NHs that had their
79 first Pharmacy Partnership for Long-Term Care Program vaccination clinic in the weeks ending January

80 3, 10, and 17, and also reported vaccination coverage data through NHSN. Data were accessed on
81 February 22, 2021. We identified a minority number of facilities in which the total number of doses
82 administered to residents or staff according to Pharmacy Partnership for Long-Term Care Program
83 reporting exceeded the total number of current residents or staff eligible to be vaccinated as reported to
84 NHSN, and set the total vaccinated to the total number of residents or staff reported to NHSN. We
85 calculated Pearson correlation coefficients to compare vaccine administration data reported by the
86 Pharmacy Partnership for Long-Term Care Program and NHSN.

87 COVID-19 Vaccination Coverage in Facilities Reporting to NHSN

88 Among all CMS-certified NHs reporting vaccination data through NHSN, we calculated the numbers
89 and proportions of residents and staff who received doses of COVID-19 vaccine among facilities
90 reporting each week from the week ending December 20, 2020 through the week ending May 9, 2021.

91 This activity was reviewed by CDC and was conducted consistent with applicable federal law and CDC
92 policy.[§]

93 **Results**

94 Correlation of COVID-19 Vaccination Administration Reporting

95 During the three consecutive one-week periods, 1028 CMS-certified NHs reported vaccination data on
96 residents to both the Pharmacy Partnership for Long-Term Care Program as well as to NHSN; 818
97 CMS-certified NHs participated in the Pharmacy Partnership for Long-Term Care Program and reported
98 COVID-19 vaccination coverage to NHSN for staff. Among these NHs, the number of vaccine doses
99 administered in the weeks ending January 3, 10, and 17, 2021 exceeded the total number of current
100 residents eligible to receive COVID-19 vaccination as reported to NHSN for 62 (17.7%), 53 (12.5%),
101 and 33 (12.9%) facilities, respectively, and the number of vaccine doses administered exceeded the total
102 number of eligible staff reported to NHSN for 13 (4.5%), 9 (2.7%), and 5 (2.6%) facilities, respectively.

103 Pearson correlation coefficients for numbers of COVID-19 vaccinations administered to NH residents
104 and staff as reported by the Pharmacy Partnership for Long-Term Care Program and the NHSN COVID-
105 19 vaccination coverage modules were 0.89, 0.96, and 0.97 for NH residents and 0.74, 0.90, and 0.90 for
106 NH staff, in the weeks ending January 3, 10, and 17, 2021.

107 COVID-19 Vaccination Coverage in Facilities Reporting to NHSN

108 A total of 5065 NHs reported resident COVID-19 vaccination coverage for at least 1 week from the
109 week ending December 20, 2020 through the week ending May 9, 2021; a total of 3554 NHs reported
110 staff COVID-19 vaccination coverage for at least 1 week during the same period. Among NHs reporting
111 to NHSN, coverage with at least one dose of COVID-19 vaccine rose rapidly and reached 77.0% for
112 residents (**Figure 1**) and 49.6% for staff (**Figure 2**) during the week ending January 31, 2021. Coverage
113 with at least one dose of COVID-19 vaccine then plateaued for both NH residents and NH staff through
114 April 2021. By the week ending January 31, 2021, 50.5% of residents and 30.5% of staff had received a
115 complete series of COVID-19 vaccine, and the proportion of residents and staff who had received a
116 complete series continued to increase through April 2021.

117 In the most recent 4-week period analyzed, from April 12, 2021–May 9, 2021, 2,276 NHs reported
118 resident vaccination data, representing 13.8% of all CMS-certified NHs enrolled in NHSN, and 1,997
119 NHs reported staff vaccination data, representing 12.1% of NHs. These NHs reported 77.1% of residents
120 (n=130,427) and 55.5% of staff (n=131,317) received at least partial vaccination; 72.8% (n=123,131)
121 and 51.8% (n=122,545) received a completed vaccination series.

122 **Discussion**

123 High correlation between vaccine administration reported by the Pharmacy Partnership for Long-Term
124 Care Program and NHSN COVID-19 vaccination reporting modules suggests NHSN can be used to
125 track COVID-19 vaccination in NHs. With the completion of the Pharmacy Partnership for Long-Term
126 Care Program, there remains a public health need to track COVID-19 vaccination coverage in NHs,
127 where residents remain at elevated risk for morbidity and mortality and both residents as well as staff are
128 at high risk for SARS-CoV-2 acquisition and transmission.

129 Continued tracking of COVID-19 vaccination coverage in NHs is important for several reasons. First,
130 vaccination coverage of staff members has plateaued, suggesting further efforts are needed to increase
131 coverage in these important healthcare personnel. Historically, high staff turnover rates at NHs—
132 approximating 100 percent annually¹²—warrant ongoing COVID-19 vaccination efforts. Additionally,
133 addressing vaccine hesitancy of NH staff¹³⁻¹⁵ and improving vaccine acceptance is needed. Ongoing
134 weekly surveillance from NHSN can track the impact of such efforts. Second, although currently
135 plateaued at a rate higher than in staff members, NH resident vaccination coverage should continue to be
136 monitored to track national vaccination efforts, as new residents are admitted to facilities on a daily
137 basis. Third, jurisdictions can use weekly coverage rates to target intervention resources to facilities with

138 greatest need of vaccination uptake.¹⁶ Fourth, NHs may use facility vaccination rates to guide infection
139 control policies, such as those pertaining to indoor visitation with NH residents.¹⁷

140 This report is subject to a few limitations. First, correlation between Pharmacy Partnership for Long-
141 Term Care Program and NHSN data is not expected to be exact. Pharmacy Partnership for Long-Term
142 Care Program data include only individuals vaccinated on-site, whereas NHSN counts persons
143 vaccinated at the facility or elsewhere. Second, there were instances in which the total number of doses
144 administered to residents or staff according to Pharmacy Partnership for Long-Term Care Program
145 reporting exceeded the total number of current residents or staff reported to NHSN. One explanation is
146 that the number of vaccine doses brought to a facility exceeded the number of residents and staff who
147 decided to be vaccinated, and to avoid wastage other persons (e.g., healthcare workers from other
148 facilities) were vaccinated and recorded as facility residents or staff. Another possible explanation is that
149 the number of residents or staff were underreported to NHSN. Nonetheless, the number of facilities
150 reporting excess doses administered was small and declined each week. Third, facilities reporting NHSN
151 COVID-19 vaccination coverage may not be representative of all nursing homes. Reporting to NHSN
152 was voluntary, and approximately one-tenth of eligible facilities reported vaccination coverage data in
153 the last 4 weeks of the study period. Nonetheless, the January vaccination coverage rates reported by
154 NHSN the Pharmacy Partnership for Long-Term Care Program were similar for residents (77.3% versus
155 77.8%) and staff (50.0% vs. 37.5%)⁹.

156 As the Pharmacy Partnership for Long-Term Care Program has been replaced with direct federal
157 allocations of COVID-19 vaccine to the long-term care pharmacies, which have traditionally provided
158 vaccines to nursing homes,⁸ NHSN is now the single national source of facility-level resident and staff
159 COVID-19 vaccination data to monitor vaccination progress, target vaccination support programs, and
160 help inform infection control policies.

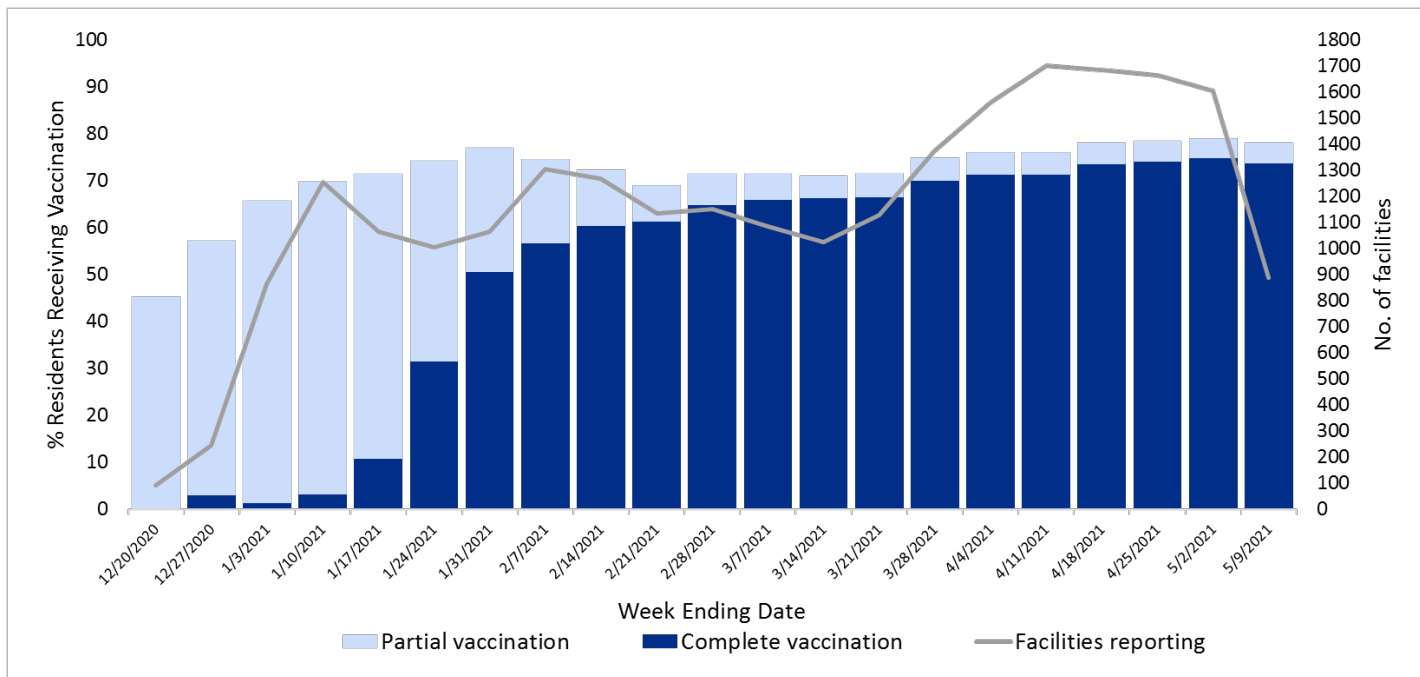

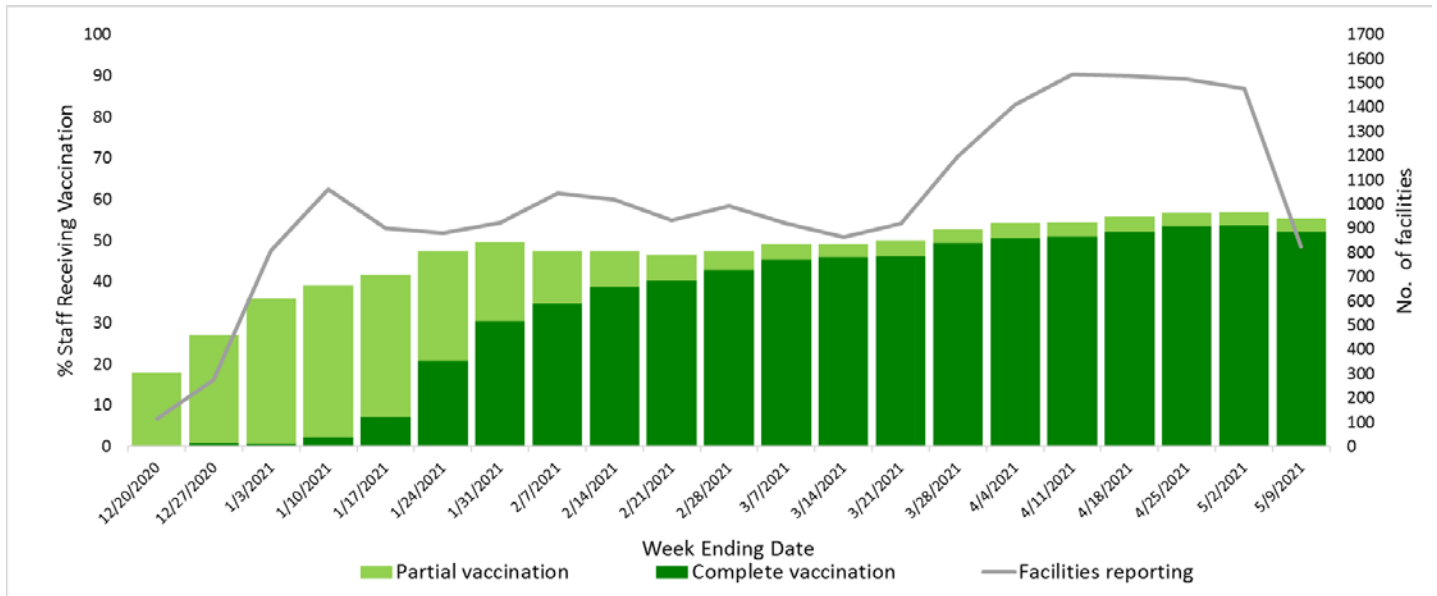
