1 Abstract:

2	Wastewater based surveillance employing qPCR has already shown its utility for monitoring
3	SARS-CoV-2 at community level, and consequently the European Commission has
4	recommended the implementation of an EU Sewage Sentinel System. However, using
5	sequencing for the determination of genomic variants in wastewater is not fully established
6	yet. Therefore, we focused on the sequencing analysis of SARS-CoV-2 RNA in wastewater
7	samples collected across 20 European countries including 54 municipalities. Our results
8	provide unprecedented insight into the abundance and the profile of the mutations associated
9	with the variants of concerns: B.1.1.7, P.1, B.1.351 and B.1.617.2, which were present in
10	various wastewater samples. This study shows that integrating genomic and wastewater-
11	based epidemiology (WBE) can support the identification of variants circulating in a city at
12	community level.

1 Introduction

Undeniably, the sudden emergence of SARS-CoV-2, which has caused a global pandemic, is 2 a significant and in many regards unprecedented threat to public health. SARS-CoV-2 rapidly 3 resulted in a high number of people requiring hospitalization, casualties and major socio-4 economic disruptions, with consequences which we still do not fully oversee. Consequently, 5 most countries have been forced to implement severe lockdown measures to ensure the 6 7 physical distance between people and interrupt virus transmission (1). Overall, the high transmission rate and the rapidly evolving nature of the virus, leading to the emergence of 8 new variants that may transmit more readily and evade the immune response, raise broad 9 concerns about SARS-CoV-2 (2-4). 10

11 The current phase of the COVD-19 pandemic is shaping into an era of genomic surveillance

12 to track the genomic changes in the SARS-CoV-2 virus, which belongs to the family

13 *Coronaviridae*, genus *Betacoronavirus*. According to PANGO lineages as of now, 1503

14 SARS-CoV-2 variants are known since the initial detection of SARS-CoV-2 by sequencing

15 (5). In the last few months, genomic epidemiology, the analysis of genome sequences, has

revealed some fast-spreading and highly virulent SARS-CoV-2 variants (3, 6, 7), making
them variants of concern (VOC) (8, 9). This development underlines the importance of
sequencing analyses. Although the European Commission recommended to sequence 5-10%
of the SARS-CoV-2 positive patient samples, as of 22 January 2021 (10), most Member

20 States are below this recommended sequencing target (11).

21 Wastewater-based epidemiology (WBE) is an emerging paradigm for monitoring the

circulation of SARS-CoV-2 in a community. Several research groups across the globe have

23 shown that WBE provides additional information about the dynamics of SARS-CoV-2 at

community level (12–17). WBE efforts have primarily focused on quantitative polymerase

chain reaction (qPCR), determining the titers of SARS-CoV-2 in the sewage and its
 correlation to the reported number of SARS-CoV-2 positive cases. At present, very few

correlation to the reported number of SARS-CoV-2 positive cases. At present, very few
 studies are available that looked for the combined potential of genomic epidemiology and

28 WBE to determine the SARS-CoV-2 genomic variants circulating in a specific region (18–

29 21). This pan-European study, which has been conducted under the umbrella of the EU

30 Sewage Sentinel System for SARS-CoV-2 (22), a direct result of what is called "The HERA

Incubator" (23), assesses whether next-generation sequencing (NGS) of wastewater samples

32 can provide information about the diversity of the SARS-CoV-2 variants and associated

33 mutations at community level.

1 SARS-CoV-2 Variants and Mutations of Concern in Europe

During March 2021, most countries in Europe reported an increase in the COVID-19 positive 2 cases. To get an overview of the clinical situation, we determined the count of sequences 3 associated with current VOCs (i.e., B.1.1.7, B.1.351, P.1, and B.1.617.2) (8, 9) in the 20 4 European countries that had provided wastewater samples (Fig. 1). The increased COVID-19 5 incidence rate corresponded with the increase in sequences of B.1.1.7 among the clinical 6 samples sequenced in these countries. For P.1 and B.1.351, no general pattern appeared and 7 they were only present to a small fraction. During this time, also very few B.1.617.2 8 sequences were reported (Fig. 1). While looking at the emergence of the mutations during 9 March 2021, we found that among the most abundant mutations across all countries, the 10 D614G (spike protein) and P323L (non-structural protein, Nsp12) mutations were detected in 11 12 all the countries (S.fig.2).

Co-occurrences of D614G and P323L have often been reported (24), however, some samples

from Germany and China lacked P323L (25). The spike protein N501Y and H69del 2 mutations were also highly abundant in most of the countries, earlier associated with B.1.1.7 3 and later with all VOCs except B.1.617.2 (S.fig.1, S.fig.2). In some countries the S106del, 4 G107del, F108del mutations, which are ORF1b signature mutations of the VOCs P.1, B.1.1.7 5 and B.1.351 (26), were also among the abundant mutations (S.fig.2). Across the twenty 6 7 European countries twenty-six ORF1ab mutations, fourteen spike protein, eight nucleocapsid (N) protein, six ORF8, and three ORF3 mutations were among the dominant mutations, 8 exhibiting spatial and temporal variation (S.fig.2). 9 10 Mutations associated with Variants of Concern in Wastewater Samples 11 12 For this study, wastewater influent 24h composite samples from 54 wastewater treatment plants (WWTPs) across 20 European countries were collected between weeks 10 - 13 of 13 2021 (i.e. 10th to 30th March 2021). We identified the mutations, which vary in their 14 association with the VOCs, in each wastewater sample, by mapping the reads generated to the 15 SARS-CoV-2 reference genome (Wuhan-Hu-1 [GenBank accession numbers NC_045512 16 and MN908947.3]). In total, 711 different mutations were identified across all the samples, 17 out of which 633 mutations were associated with the VOCs. These 633 VOC associated 18 mutations include mutations that are also associated with other SARS-CoV-2 lineages. Out of 19 these mutations, 619 mutations were observed at >2.5%, 311 mutations at >5% and 23 20 mutations at >50% allele frequency (Fig.2). Most of the 23 mutations were present in all but 21 a few samples. For example, the W131C mutation was only detected in wastewater samples 22 from Denmark (Fig.2). W131C is one of the important mutations in ORF3a, which is found 23 to assist the ion channel formation and thereby supports the virus in its infectivity (27). The 24

- A220V mutation was only identified in samples from Lithuania (Fig.2), which corresponds to
- the high count of A220V reported in clinical patient samples (S.fig.2).

Although many low-frequency mutations were observed, the read abundance of low-

10 frequency mutations was mostly similar to the abundance of the high-frequency mutations

11 (S.fig.4). The highest count (ranging between 16-60) was observed for mutations associated

1	with B.1.1.7 in all the samples (Fig.3), followed by B.1.351. P.1 and B.1.617.2, which had a
2	low count of associated mutations but included signature mutations. For example, signature
3	spike protein mutations (i.e. L452R, T478K, P681R, D950N) (9, 28) of B.1.617.2 were
4	identified in some of the wastewater samples.

6 Abundance of Spike protein AA mutations

As the spike protein AA mutations have been associated with changes to characteristics of
SARS-CoV-2, leading to an increase in transmissibility and reduced efficacy of treatments, a
particular list of spike protein AA mutations is used by the European Centre for Disease
Prevention and Control (ECDC) for characterizing the VOCs (9, 29). Therefore, we also
assessed the read abundance of these spike protein AA mutations in our wastewater samples
(Fig. 3).

Overall, D614G was most abundant, followed by: P681H, T716I, A570D, S982A, H69del, 13 Y144del, D1118H, N501Y, K417N, E484K and others, in decreasing order. Only six out of 14 the 27 AA mutations (i.e. D1118H, D614G, H69del, N501Y, P681H, S982A, and T716I) 15 were present in all the samples (Fig.3). A570D and Y144del were identified in 53 samples. 16 D1118H, S982A, T716I, H69del, P681H and A570D have been mainly found in the B.1.1.7 17 variant, whereas N501Y has been associated with B.1.1.7, B.1.351, and P.1 (30). For 31 18 samples, the total read abundance of these AA mutations was above 1e+05 reads, the lowest 19 values in all three sample were detected in the samples from Denmark ranging between 20 1e+04 to 3e+04 reads (Fig.3). 21

23 Abundance and prevalence of dominant AA mutations

Most of the attention is given to spike protein AA mutations, especially since the emergence 24 of B.1.1.7, because the spike protein mediates virus to host cell-surface attachment, and it is 25 also the principal target of neutralizing antibodies (4). However, mutations in other regions of 26 the SARS-CoV-2 genome are also relevant (30, 31). Therefore, we analysed the most 27 abundant AA mutations found across all the samples for a comprehensive insight into the 28 mutations detected in the wastewater samples (Fig.4). Three mutations (Q27stop, R52I, and 29 Y73C) in ORF8; D3L and S235F in the N protein; P681H, D614G, H69del, S982A, T716I, 30 31 D1118H, and N501Y in the spike protein; P4804P, T5304T, F3677del, A1708D, S216S, F924F, I2230T, T1001I, F1907F, and H5005H in ORF1ab appeared to be most dominant and 32 prevalent in the samples (Fig.4). The presence of Q27stop and R52I mutations, along with the 33 spike protein mutations, is reported to likely increase the transmissibility of SARS-CoV-2 34

(32). Another two ORF8 protein mutations, Y73C and K68stop, were present in most of the
samples. The Y73C mutation is known to be unique in B.1.1.7 (33). Although no clear
relevance of K68stop is known, it is reported to be present in SARS-CoV-2 genomes with the
highest number of spike protein mutations (32). The P681H spike protein mutation was the
third most abundant across the samples. In total, 13 spike protein mutations were amongst the
dominant mutations (Fig. 4).

All spike protein mutations, along with the earlier mentioned ORF8 mutations, have been 12 found in the B.1.1.7 variant in clinical samples (32). E484K was observed in all wastewater 13 samples from France and Sweden. This E484K mutation has been found in B.1.1.7, B.1.351, 14 and P.1(34). Eight mutations of the nucleocapsid protein were also dominant in the samples, 15 especially D3L and S235F. Both of these mutations are known to likely alter the stability and 16 immunogenic properties of the N protein (35) and are signature mutations of B.1.1.7 (36). In 17 the ORF1ab region, 21 mutations were abundant in the samples. The F924F and P4715L 18 ORF1ab mutations have been reported to have a strong allelic association with D614G in 19 20 variants dominant in Europe (37, 38).

Wastewater based Epidemiology reveals Genomic Variants

The pattern of genomic variants and the abundance of VOCs were consistent between the 7 clinical and the wastewater sequencing data, especially for dominant mutations (S.fig.2, 8 Fig.4). For example, both data-sets show a high read abundance of the D614G mutation. 9 Similarly, P681H was also dominant in clinical and wastewater samples (S.fig.2, Fig.4). On 10 the other hand, wastewater sequencing data can also reveal genomic variants which are not 11 reported as dominant in clinical data. For example, Q27stop was one of the dominant 12 mutations in wastewater samples but not in the clinical samples of all countries (S.fig.2, 13 Fig.4). The ORF8 mutations (such as Q27stop, R52I, K68stop) have been emphasized to be 14 relevant and require closure attention (32, 39), especially because they occur recurrently (30, 15 32). However, at present the count of the ORF 16

1	8 mutations in genomes deposited in GISAID (https://www.gisaid.org) is low, which
2	according to a previous study is due to bias in samples sequenced (32). Across most of the
3	wastewater samples, we detected a high occurrence of ORF8 mutations (i.e. Q27stop, R52I)
4	(Fig. 4), which provides evidence for the circulation of SARS-COV-2 variants containing
5	these mutations in the sampled regions. Also, wastewater sequencing data can reveal spatial
6	prevalence of mutations. For example, the Q57H mutation was dominant in all three samples
7	from Finland, which is consistent with clinical genomic data of Finland (40). This
8	emphasizes that sequencing for SARS-CoV-2 in wastewater can provide additional
9	information about the prevalence of mutations (such as Q27stop), which might not currently
10	appear abundant based on clinical data. Also relative abundance data grouping the mutations
11	that are associated with a particular variant revealed a clear dominance of B.1.1.7 among the
12	samples, followed by mutations associated with B.1.351, P.1, and B.1.617 (S.fig.5), which is
13	similar to the clinical sequencing data.
14	The results obtained in this study clearly show that surveillance of SARS-CoV-2 mutation
15	profiles associated with VOCs in wastewater samples is possible using NGS. The data
16	generated also presents the possibility to attain a sufficient coverage of the SARS-CoV-2
17	genome from the wastewater samples. In wastewater samples, a mixture of genomic material
18	of multiple SARS-CoV-2 variants may be present. Nevertheless, it is still possible to obtain
19	information about variants based on the prevalence of key mutations of the respective variant.
20	However, it is essential to note that sequencing surveillance of wastewater samples should be
21	considered complementary information to whole-genome sequencing of clinical samples.

Material and Methods

Sequencing

For this study, 24 h composite wastewater samples were collected between weeks 10 - 13 of 2021 (i.e. 10th to 30th March 2021) and shipped TU Darmstadt (Darmstadt, Germany), packed with icepacks (approximately at 6°C), for sequencing analysis. In Darmstadt, one litre of the untreated wastewater was filtered through a 0.45 µm electronegative membrane filter to concentrate the SARS-CoV-2 RNA, followed by extraction using the Fast RNA Blue Kit (MP Biomedicals) according to the manufacturer's protocol. Another 500 ml of the untreated wastewater was concentrated by ultrafiltration in 100 kDa Centricon® Plus-70 centrifugal ultrafilters (Merck) and RNA was extracted using the Ultra Microbiome kit (Thermofisher Scientific) according to the manufacturer's protocol. Both RNA extracts were pooled together for downstream analysis. From the pooled RNA, cDNA was synthesized using SuperScript[™] VILOTM Master Mix (Thermofisher Scientific), followed by library preparation using the Ion AmpliSeq SARS-CoV-2 Research Panel (Thermofisher Scientific) according manufacturer's instructions. This panel consists of 237 primer pairs, resulting in an amplicon length range of 125–275 bp, which cover the near-full genome of SARS-CoV-2. We performed multiple sequencing runs to achieve a high number of reads per sample. For each sequencing run, eight libraries were multiplexed and sequenced using an Ion Torrent 530 chip on an Ion S5 sequencer (Thermofisher Scientific) according to manufacturer's instructions.

We used the SARS-CoV-2 Research Plug-in Package, which we installed in our Ion Torrent Suite software (v5.12.2) of Ion S5 sequence. We used the SARS_CoV_2_coverageAnalysis (v5.16) plugin, which maps the generated reads to a SARS-CoV-2 reference genome (Wuhan-Hu-1-NC_045512/MN908947.3), using TMAP software included in the Torrent Suite. The summary of mapping of each sample is provided in S.Table 1. For mutation calls, additional Ion Torrent plugins were used, similar to our previous study (1). First, all single nucleotide variants (SNVs) were called using Variant Caller (v5.12.0.4) with "Generic - S5/S5XL (510/520/530) - Somatic - Low Stringency" default parameters. Then, for annotation and determination of the base substitution effect, COVID19AnnotateSnpEff (v1.3.0.2), a plugin developed explicitly for SARS-CoV-2, was used. The raw metagenomic sequence data were uploaded to the National Center for Biotechnology Information (NCBI) Sequence Read Archive (SRA) under Submission ID SUB9829162, BioProject number PRJNA736964.

qPCR Methods

Samples were received at the KWR laboratory and processed as previously described (2). The N2 assay targeting a fragment of the nucleocapsid gene, as published by US CDC (US-CDC 2020), was used to quantify SARS-CoV-2 RNA in the sewage samples. All RT-PCR's were run as technical duplicates on $5 \,\mu$ l extracted nucleic acid. RT-qPCR reactions on serial dilutions containing RT-ddPCR calibrated EURM-019 single stranded RNA (provided by the Joint Research Centre) were used to construct calibration curves that subsequently were used to quantify N2 in RNA extracted from the sewage samples. Reactions were considered positive if the cycle threshold was below 40 cycles.

CrAssphage CPQ_064 specific PCR (3) was used to quantify this DNA-virus that is ubiquitously present exclusively occurs in human intestinal tracts in high concentrations. Assays were performed in duplicate on 5 μ l 1:10 diluted extracted nucleic acid. Quantification was performed using PCR assays on dilution series of a synthetic quantified gBlock (obtained from IDT, Leuven, Belgium) containing the CPQ_064 gene fragment.

Data Analysis

We downloaded the variant surveillance data package from GISAID on 31th May 2021. This data package consists of information about the identified variants, the corresponding amino acid (AA) mutations and sample location. We filtered the dataset, limiting it to human samples with complete coverage. This dataset was used to determine associations between the amino acid (AA) mutations detected in wastewater samples and AA mutations, with their corresponding pangolin lineage, reported from clinical samples. From the GISAID data package, we also determined the fraction of clinical samples reporting the current variants of concern (VOC): (1) B.1.1.7, (2) P.1, (3) B.1.351, (4) and B.1.617.2 (4, 5). Data analysis was performed in R(v3.6.2) using the ggplot (v3.3.3) package for data visualization, and pheatmap (v1.0.12) for hierarchy clustering and heatmap construction.

Mutations in clinical samples

We determined the abundance spike protein mutations, which are suggested by the European Centre for Disease Prevention and Control (ECDC) for the characterization of the current VOCs (5), reported for clinical human samples. We found that the abundance of the mutations varied for the respective country, though associated with the same VOC (S.fig.1). For example, four out of eight spike protein mutations for P.1 for sequences from Slovakia were not reported.

SARS-CoV-2 RNA in wastewater samples

qPCR results

SARS-CoV-2 N2-gene RNA was detected in all 54 samples in concentrations ranging from 0.4 - 735 gene copies/ml (S. fig 3). The concentration protocol for NGS provided sufficient read depth (S. Table 1), even with the low SARS-CoV-2 concentration samples. The crassphage concentration (S. fig 3) is an index of the dilution of human fecal input in wastewater. This varied between the cities; in INF_21002_B and INF_21003_BA the Crassphage concentrations were markedly low, indicating high dilution of human fecal input in these wastewaters. Normalizing the SARS-CoV-2 N2 concentration for this dilution would markedly change the ranking of the wastewaters, which implies that normalization of 'raw' SARS-CoV-2 concentrations in wastewater for the level of dilution of human fecal input is necessary when linking these data to COVID-19 prevalence data.

Fraction of variants of concern in wastewater samples

We determined the relative abundance of the VOCs based on the abundance of reads associated with certain AA mutations. As there is quite an overlap between the AA mutations of different SARS-COV-2 variants, for better determination of the relative abundance of the VOCs, we specifically looked for the abundance of unique and shared AA mutations corresponding to each VOC (S.fig.5). Categorization of mutations as unique or shared was based on the percentage of sequences for associated mutations submitted in GISAID. We looked for percentage of sequences for each mutation for every lineage. Then for each VOC, mutations reported in more than 0.5% of total number of sequences for each VOC were selected. Among these selected mutations, mutations that are associated with more than one lineage were categorized as shared mutation otherwise they were associated with the respective VOC.

The abundance of mutations associated with B.1.1.7 was highest among the samples ranging from 15 to 40%, followed by abundance of mutations associated with B.1.351, P.1, and B.1.617 (S.fig.5), which is similar to the clinical sequencing data. The mutations associated with B.1.351 were detected in 33 samples, whereas for B.1.617 were detected in 21 samples and for P.1 in 15 samples. B.1.351 mutations were detected in all samples from Finland, Germany, and Sweden; however, the total relative abundance of these mutations varied from 2 to 8%. The relative abundance of the shared AA mutations accounted for 55 to 70% across all samples (S.fig.5).
