- 2 Long-distance migration was associated with increased prevalence of post-traumatic stress disorder in
- 3 Syrian refugees

19 Abstract

20 Background: Refugees are forced migrants but there is a large variation in the distance that refugees cover 21 and there is a paucity in the evidence of how this may affect refugees' health and health care needs. We 22 investigated the association between long-distance migration and post-traumatic stress disorder (PTSD), a 23 serious psychiatric disorder associated with deteriorating mental and somatic health. Methods: Included 24 from 2016-2019 were 712 adult Syrian refugees and asylum seekers in Lebanon and Denmark arrived up 25 to 12 months prior. PTSD was assessed using the Harvard Trauma Questionnaire and the estimate of 26 association was obtained by multiply imputing missing data and adjusting for confounding by propensity 27 score-weighting with covariates age, sex, socioeconomic status, trauma experience and WHO-5-score, 28 reporting the bootstrap 95-percentile confidence interval (95% CI). Additionally, a number of sensitivity 29 analyses were performed. Results: After multiply imputing missing data and propensity score-weighted 30 adjustment for confounding, migration to Denmark instead of Lebanon was associated with an increase in 31 PTSD prevalence of 9 percentage point (95% CI [-1; 19] percentage point). Discussion: We found that 32 long-distance migration was associated with an increase in the prevalence of PTSD suggesting that long-33 distance migration may be a factor to consider when assessing refugees' and asylum seekers' health. 34 Practitioners should consider "long-distance migration" in refugee health screenings and in particular 35 when assessing the risk of post-traumatic stress disorder. Future research should be designed to ultimately 36 lead to studies of relevant interventions to lower the risk of post-traumatic stress disorder in refugees.

40 Introduction

41 Refugees suffer from high risk of post-traumatic stress disorder (PTSD) [1] and are exposed to many risk-42 factors for PTSD before, during and after migration [2–4]. Risk factors for PTSD in the country of origin 43 and in the host country has been examined in detail; however, the contribution of the migration itself has 44 not received much attention in refugee health research. PTSD is a disorder that may develop after a

45 traumatic event and is associated with significant loss of functioning and increased morbidity and 46 mortality [5,6]. Symptoms of PTSD include intrusion (e.g. "flash-backs" and nightmares), avoidance and 47 arousal, characterized by persistent perception of threat which may result in sleep deprivation, irritability 48 and inability to concentrate [7,8]. Risk factors for developing PTSD comprise multiple trauma, female 49 sex, being spouseless, ethnicity, lower educational status, comorbid mental disorders and type of trauma 50 (for example intentional trauma, sexual assault etc.) [7]. Additionally, gene-environment interactions may 51 play a key role [9]. Dysfunction of the amygdala (emotional learning and memory modulation) and 52 medial prefrontal cortex (executive function) are key elements in PTSD and the disease is associated with epigenetic changes, increased blood levels of norepinephrine and decreased blood levels of 53 54 glucocorticoids [7]. The life-time prevalence of PTSD in the general population is estimated to be around 55 5% for males and 10% for females with considerable variation according to the study population and 56 diagnostic tools utilized [7,10]. In comparison, a recent meta-analysis produced a summary prevalence 57 estimate for PTSD of 31% across all refugees [1] with little difference between males (29%) and females 58 (34%) though with considerable variation between the country of origin, host countries and diagnostic 59 tools; however, not taking migration history into account. The impact of migration and the role and 60 measurement of "distance" (geographical, cultural, linguistic etc.) has been discussed at length for a 61 number of outcomes [11,12] and long-distance migration has been associated with poorer self-rated health in the general population [13], hypothesizing a link with increasing difficulty in acculturation [14,15]. In 62 63 the present study, we aimed at taking an initial step in assessing the effect of migration on refugees' and 64 asylum seekers' health by comparing the prevalence of PTSD in newly arrived Syrian refugees and 65 asylum seekers in Lebanon and Denmark.

66 Methods

In a cross-sectional design with one-stage cluster randomized sampling between 2016 and 2019, newly arrived adult Syrian refugees were included in Lebanon and newly arrived Syrian asylum seekers were included in Denmark and assessed for PTSD using the Harvard Trauma Questionnaire (HTQ)-scale with cut-off score at 2.5. The implemented inclusion criteria were: (a) adult (≥18 years of age), (b) Syrian-born, (c) had left Syria after the onset of the ongoing civil-war (after February 2011), (d) arrived in

Lebanon or Denmark less than 12 months prior to inclusion and (e) resident in the Lebanese settlements or Danish asylum seeker centres at the time of inclusion. Exclusion criteria were physical or mental illness that prevented participation. Variables to be collected to address confounding were decided upon *a priori* after discussions among the authors guided by graphical representations of our assumptions. See the Supplement 1-9 for a detailed description of the data collection instruments and the directed acyclic graph illustrating our assumptions about the relation of the variables. Also the study protocol is published and freely available [16].

79 Lebanon is a country of about 6 million people living in an area of nearly 10.000 km²—comparable in 80 size to the two major Danish island (Zealand and Funen). Since 2015 Lebanon has stopped accepting 81 asylum applications from Syrians seeking refuge in Lebanon. Nevertheless, being a close neighbour, in 82 both geographical, linguistic and cultural distance, the influx of refugees from the Syrian war has 83 endured. The majority live in structures ranging from regular (though dilapidated) structures to 84 improvised tents clustered in informal gatherings scattered across Lebanon [17]. We stratified Lebanon 85 into five regions based on geography, infrastructure and insights about local concerns (political, religious 86 etc.). In each region, we collaborated with the local health service operators to draw up the sampling 87 frame of gatherings and randomly decided on the inclusion sites, where all individuals eligible for 88 inclusion were invited to participate (i.e. stratified cluster sampling [18,19]). See the Supplement 2 for 89 details on the sampling frame. We obtained permission to include participants in all regions of Lebanon, 90 that is, we had access to include participants from areas that are usually outside the reach of researchers 91 due to "security considerations". Should a chosen site be deemed unsafe at the scheduled time of 92 inclusion we relocated to the closest setting deemed appropriate within the same region. 93 Denmark is a country of about 6 million people living in an area of about 50.000 km². In Denmark, all

eligible residents at a random sample of asylum centres were invited. The Danish asylum seeker centres
are run by the Danish Immigration Services but outsourced to different operators. Several types of asylum
seeker centres exist with the most common being the accommodation centre, to which the asylum seeker
is allocated by random shortly after arrival and applying for asylum in Denmark. Of five available
operators, three responded to the invitation, all accepting to participate in the study, representing a total of

99 11 accommodation asylum centres. Data-collection teams of two to four healthcare professionals were 100 instructed during several pre-collection sessions in the practicalities and ethical considerations involved in 101 the task: this encompassed obtaining written and informed consent, appropriate handling of confidential 102 information, collection of the questionnaire data, the mental health self-rating scales, clinical 103 measurements and the biological samples. At consent, the participant was instructed to independently 104 complete a background questionnaire and mental health scales. The data collectors assisted those who 105 could not read or write or had further questions regarding the study. Afterwards, the participant was 106 invited to a semi-structured clinical interview and a short clinical exam of basic parameters (blood 107 pressure, height, weight). Participants could at any time opt out of the data collection; if choosing to do 108 so the participant was asked if she would care to provide a reason. Also, individuals who were invited but 109 refused to participate were asked for a short non-structured interview including basic demographics and 110 reason for refusal. The procedure was piloted in its entirety in Denmark including 10 participants in an 111 asylum seeker centre, resulting in minor adjustments to the workflow. All relevant permissions were 112 obtained prior to inclusion of any participant in both Lebanon and Denmark. 113 In the following we give a brief summary of the applied statistical methodology. Further details are given 114 in the Supplement 3-9 and a thorough discussion of the statistical methodological considerations 115 necessary to combine multiple imputation and propensity score-weighted analysis is provided in Eiset and 116 Frydenberg [20]. Missing data was multiply imputed and confounding was address by propensity scoreweighting including age, sex, socioeconomic status, experienced trauma and WHO-5-score in the model. 117 118 The "standardised mortality ratio"-weights [21] was computed to estimate the weighted prevalence 119 difference of PTSD in the population that fled to Denmark instead of Lebanon and presented with a 95-120 percentile confidence interval found by bootstrapping. A number of sensitivity analyses were carried out 121 to assess the robustness of the estimated association between long-distance migration and PTSD. All data 122 management, analysis and plots were done in R [22]. Further details are given in the Supplement 5 as

123 well as directly in the R code available together with the *a priori* described analysis plan and a number of

124 the exploratory plots from <u>https://github.com/eiset/ARCH</u>.

125 **Results**

- 126 A total of 599 individuals were included in Lebanon and 113 were included in Denmark. Table 1 gives a
- 127 statistical summary of the inclusion process and non-participation. The study populations differed on key
- 128 variables such as sex (female: 73% in Lebanon, 47% in Denmark) and experience of violence (24% in
- 129 Lebanon, 39% in Denmark) and there were missing values for all variables except long-distance
- 130 migration. Figure 1 illustrates the missing proportion of key variables stratified on exposure status and
- 131 Table 2 gives a detailed summary of the study population characteristics for both the observed realization
- 132 and the imputed data set including missing for each covariates in the observed data.
- 133 The unadjusted prevalence of PTSD was higher in Denmark (60.2%) compared with Lebanon (55.1%).
- 134 The prevalence difference of PTSD increased from 5.1 percentage point (95-percentile CI [-4.6; 15.0]) to
- 135 8.8 percentage point (95-percentile CI [-1.4; 18.6 percentage point]) after multiply imputing missing data
- 136 and adjusting for confounding by propensity score-weighting. All sensitivity analyses produced estimates
- 137 in the same direction and of the same magnitude, except when forcing all missing in the "Violence"
- 138 variable to "Yes" in the study population included in Denmark, thus, grossly violating the missing-at-
- 139 random assumption of multiple imputation. Table 3 presents the point estimate for the propensity score-
- 140 weighted analysis and each of the sensitivity analysis accompanied by Figure 2 which includes different
- 141 types of bootstrap confidence intervals.

142 **Discussion**

- 143 This study aimed at estimating the association between long-distance migration and prevalence of PTSD.
- 144 The estimate of association corresponded to 87 additional cases of PTSD for every 1000 Syrian refugees
- 145 that migrated to Denmark instead of Lebanon. The 95% confidence interval indicate that, under the
- 146 model, the estimate may be as high as 190 additional cases or as low as 4 cases less per 1000 refugees,
- 147 thus, the estimate did not reach statistical significance, which may be ascribed to the relatively low
- 148 number of participants. The targeted sample size was not reached neither in Lebanon nor in Denmark due
- 149 to structural and political obstacles during the data collection.

150 To the best of the authors' knowledge this is the first investigation of the association of long-distance 151 migration and PTSD in a refugee population. A recent study [23] of Syrian refugees in Lebanon and 152 Norway found a prevalence of PTSD (assessed as HTQ-score ≥ 2.5) of 4% in Lebanon and 7% in 153 Norway. The study conflated heterogeneous groups for example asylum-seekers and refugees and 154 participants with short and long stay in the host country prior to inclusion in the study. The study found 155 that "Host country, Norway" was associated with an average increase in HTQ-score of 3% (95% CI [-5%; 156 12%]) when adjusting for age and sex; however, did not provide estimates of how this translated into absolute number of participants with PTSD. With a mean HTQ-score of 1.49 in the study population in 157 Lebanon the number of additional cases in Norway due to "host country" would be marginal. The 158 159 underlying cause for the observed increase in PTSD prevalence in Syrian refugees and asylum seekers 160 after long-distance migration has never been investigated. In our study, we approach this by minimized 161 the effect of living in the host country, thus, "long-distance migration" represented the migration process 162 itself (travelling through Europe). We found a high prevalence of PTSD and an increased prevalence 163 difference compared with the aforementioned study. Some studies hypothesise that great distance between 164 populations is associated with difficulty acculturating which in turn is associated with worse health 165 outcomes, including mental health [13,15,24]. The presented study is a first step in examining this in a 166 refugee population.

167 The prevalence estimates of PTSD was high in both Lebanon and Denmark compared with previous 168 studies of Syrian refugees and across different study designs and utilized instruments for assessing PTSD 169 [1,25–27]. In the present study, we utilized the widely used HTQ-score [28] which is considered valid 170 across multiple settings and diagnostic classification systems [29] although the specific cut-off has been 171 debated [30]. The sensitivity analysis showed little change in the estimate of association including when 172 changing the HTQ-score cut-off. An effort was made to make the data collection in Lebanon and 173 Denmark as comparable as possible; however, differences may exist introducing information bias. For 174 example, differential misclassification cannot be ruled out, if, during data collection in Denmark, doubt remained among the participants whether specific answers would affect their asylum application. This 175 176 may explain (some of) the difference in prevalence of PTSD in Lebanon and Denmark; however, judged from extensive exploratory plotting of the covariates, there was no difference between the exposure 177

178 groups in the association of the reported HTQ-score and WHO-5 (general mental well-being) or 179 depression- or anxiety-scores, thus, the participants would have had to be very consistent in their 180 misclassification of own mental health. The proportion that refused to answer, or did not know what to 181 answer, in the question on socioeconomic status was high and differed between the study population in 182 Denmark (22%) and in Lebanon (7%). After discussing this variable with Syrian natives, we speculate 183 that "socioeconomic status" was not defined in sufficient detail for all participants to be able to reflect on 184 the question; however, we do not have an explanation for the difference in proportion of missing between 185 Lebanon and Denmark. We consider the risk of selection bias low given the randomized sampling design 186 and very high participation rates. It was, however, not possible to retrieve or create a precise sampling 187 frame in Lebanon and thus, it was based on best information available at the time, knowing that refugees 188 frequently relocate and there is little registration of individuals outside the formalized refugee camps. 189 In the present study, the interpretation of the association between long-distance migration and PTSD is of 190 course limited by the cross-sectional study design. Most importantly, the time-order may be reversed so 191 that instead of long-distance migration leading to higher risk of PTSD it may be that PTSD affect the 192 "risk" of undertaking long-distance migration. A positive association between long-distance migration 193 and PTSD was found, thus, a reversal of the time order would mean that individuals with PTSD are more 194 likely to undertake long-distance migration. Although this cannot be entirely rejected, taking into account 195 the classical symptoms of PTSD such as difficulties in concentrating and planning, this interpretation of 196 the result seems far less likely than our stated hypothesis: that undertaking an, at times, hazardous travel 197 and living with uncertainty about the near future, increases the risk of PTSD.

We addressed confounding by propensity score-weighting and obtained balance on all covariates judged from our pre-specified criteria. To account for confounding we included covariates in the propensity score model according to what the authors believe is the current best evidence [7]; however, this does not alleviate us of speculations of entirely other covariates that may change the estimate. Furthermore, the collapsing of two levels of the socioeconomic status covariate diminishes the information this variable contains and thus may be a source for residual confounding in both the multiple imputation and in the propensity score weighted analysis. The missing mechanism was "everywhere missing-at-random"

allowing for frequentist inference from the multiply imputed data. In the Supplement 4 we provide
examples of the discussion necessary for each partly observed variable to deem the missingness

207 mechanism "everywhere missing-at-random".

208 Future research should be designed to determine if the association is transportable to other groups of

- 209 refugees and to investigate the underlying factors contributing to the association, for example examine the
- 210 different measures of "distance" (cultural, geographical etc.), the different types of trauma refugees may

211 experience during migration (poor shelters, starvation, interpersonal violence etc.), means of

transportation during the migration and the (health) reception in the host country. We note that the

213 direction of the association was consistent across different thresholds for PTSD (effectively lowering and

214 raising the estimated prevalence for PTSD in the study population), different propensity score models and

215 when imposing violation of underlying assumptions of multiple imputation; the strength was also

216 relatively consistent. We hypothesize that the association will be reproducible at least in comparable

217 populations and settings—for example newly arrived adult refugees from a Middle Eastern country to a

218 Western European country. Also, the association between long-distance migration and other health

219 outcomes, for example other mental health issues, is of great interest. The presented study is an initial

analysis of the association between long-distance migration and PTSD and provides the foundation upon

221 which future studies could build.


