

# **Understanding malnutrition management through a socioecological lens: Evaluation of a community-based child malnutrition program in rural Uganda**

## **ABSTRACT**

In Uganda, almost half of children under 5 years old suffer from undernutrition. Undernutrition, a common form of malnutrition in children, encompasses stunting, wasting and underweight. Causes of child undernutrition are complex, suggesting that interventions to tackle malnutrition must be multifaceted. In addition, limited access to healthcare for vulnerable populations restricts the potential of hospital-based strategies. Community-based management of acute malnutrition (CMAM), which includes nutritional counselling, ready-to-use therapeutic foods and the outpatient management of malnutrition by caregivers, is recognised as an effective approach for children's recovery. However, evaluations of CMAM programs are largely based on biomedical and behavioural health models, failing to incorporate structural factors that influence malnutrition management. The objective of this evaluation was to understand the factors influencing malnutrition management in a CMAM program in rural Uganda, using the socioecological model to assess the multilevel determinants of outpatient malnutrition management. This evaluation used qualitative methods to identify determinants related to caregivers, healthcare and societal structures influencing children's outpatient care. Data were collected at a community health clinic in 2019 through observations and interviews with caregivers of malnourished children. We observed 14 caregiver-provider encounters and interviewed 15 caregivers to examine factors hindering outpatient malnutrition management. Data were thematically analysed informed by the socioecological model. Findings showed that caregivers had a limited understanding of malnutrition. Counselling offered to caregivers was inconsistent and insufficient. Gender inequality and poverty limited caregivers' access to healthcare and their ability to care for their children. Factors at the caregiver- and healthcare-levels interacted with structural factors to shape malnutrition management. Results suggest that CMAM programs would benefit from providing holistic interventions to tackle the structural barriers to children's care. Using a socioecological approach to program evaluation could help move beyond individual determinants to address the social dynamics shaping malnutrition management in low- and middle-income countries.

## **WHAT IS KNOWN?**

- CMAM is recognised as a promising strategy to address moderate and severe acute malnutrition in children under five years old in resource-poor settings.
- Evaluations of CMAM programs largely focus on factors related to caregivers' choices, behaviours, and practices to explain why CMAM has inconsistent results.
- Limited attention has been given to the multilevel determinants that influence the outpatient management of malnutrition in CMAM programs.

## **WHAT THIS PAPER ADDS?**

- Caregivers had limited understandings of malnutrition and its underlying mechanisms.
- Counselling provided to caregivers by program personnel was inconsistent and insufficient, often including contradicting information about treatments prescribed to children.
- Structural factors limited caregivers' access to healthcare and their ability to comply with CMAM outpatient protocols.

## **1. INTRODUCTION**

The United Nations Sustainable Development Goals call to 'end hunger, achieve food security and improved nutrition, and promote sustainable agriculture' by 2030 (United Nations, 2021). Yet, we are not on track to achieve this goal in less than a decade (United Nations, 2021). Nearly half of all deaths of children under 5 years of age are attributable to undernutrition globally, with low- and middle-income countries bearing most of the burden (World Health Organization, 2020). Undernutrition, a common form of malnutrition in children, includes chronic malnutrition or stunting (low height for age), acute malnutrition or wasting (low weight for height), as well as underweight (low weight for age) (Brown et al., 2009). In Uganda, child undernutrition is recognised as a public health priority and is a central pillar in various national policies (Franklin, 2020; National Planning Authority, 2013, 2020). Although some progress has been made in the country in recent years, it is estimated that 29% of children under five years old are stunted, 4% are wasted, and 11% are underweight (Uganda Bureau of Statistics & ICF, 2018). Causes of malnutrition in Uganda, including undernutrition, are complex. The Ugandan population is largely rural (84%) and nearly two thirds work in agriculture, making rural

households vulnerable to environmental fluctuations like droughts and flooding, increasing food insecurity (USAID, 2021). With 35% of the population living in extreme poverty, access to sanitation and healthcare is limited (Mejia-Mantilla, 2020; USAID, 2021). High fertility rates and women's limited access to employment also worsen food insecurity and malnutrition. Other drivers of child malnutrition include high disease burdens and poor feeding practices (USAID, 2021). This suggests that interventions tackling malnutrition must be multifaceted, and that limited access to healthcare for vulnerable populations restricts the potential of hospital-based strategies.

The World Health Organization (WHO) recognises community-based management of acute malnutrition (CMAM) as a promising strategy to address moderate and severe acute malnutrition in children under five years old in resource-poor settings, prompting its implementation in more than 60 countries (Reed & Kouam, 2013). CMAM includes community outreach, outpatient management of moderate acute malnutrition (MAM) and severe acute malnutrition (SAM) without complications, provision of ready-to-use therapeutic food (RUTF), and nutritional counselling (Shah More et al., 2018). The goal is to decentralise malnutrition management so most cases are treated at home by caregivers (Reed & Kouam, 2013).

Evaluations of CMAM programs are inconsistent, assessing a wide array of factors to explain why children's outpatient care is suboptimal (Akparibo et al., 2017; Majamanda et al., 2014). These evaluations largely adopt behavioural or biomedical approaches to study malnutrition management, emphasising individual factors such as caregivers' choices, behaviours, and practices. Factors examined notably include sharing or selling RUTF (Ashworth, 2006; Cohuet et al., 2012; Tadesse et al., 2015), giving complementary feedings in addition to RUTF (Ashworth, 2006; Kajjura et al., 2019), and treatment compliance (Atnafe et al., 2019; Yebyo et al., 2013). While these factors do influence malnutrition management, it would also be

beneficial to assess determinants beyond the individual in CMAM program evaluations (Birn et al., 2017). Examining the multilevel determinants of children's care in CMAM programs would highlight how caregivers' behaviours are influenced by determinants at the healthcare- and structural- levels, limiting their ability to meet the long-term nutritional needs of their children.

The socioecological model is a useful framework for assessing malnutrition management holistically. Recognising that individuals are embedded in various interdependent environments (*i.e.*, individual, interpersonal, community, organisational, policy), the socioecological model can be adapted and changed to suit research on various topics, including malnutrition (Lanfer & Reifegerste, 2021; Mahmudiono et al., 2019). It has proven useful for examining the complex interactions of individual and contextual factors in impacting health behaviours and outcomes (Tesfay et al., 2021).

In 2019, we conducted a qualitative evaluation of a CMAM program delivered by a community health clinic in rural Uganda to understand the various factors hindering the outpatient management of acute child malnutrition. We used the socioecological model to discuss three levels of determinants that could explain malnutrition management in this program, namely determinants linked to caregivers, healthcare, and societal structures. This article presents the results of this evaluation.

## **1.1 Program description**

Located in the Eastern region of Uganda, Soft Power Health (SPH) is a not-for-profit organisation providing health education and affordable primary healthcare to rural, underserved communities through a community health clinic and community outreach programs (Soft Power Health, 2020). SPH's community health clinic runs a program to treat children with MAM and SAM, which integrates all the key elements of CMAM programs as defined by the WHO (Reed

& Kouam, 2013). SPH organises weekly community outreach activities in villages around the clinic. These activities involve malnutrition education and allow to screen for malnutrition in children of the participants present. There is also an on-site program offering nutritional counselling to caregivers of malnourished children at the clinic and provides high energy milk (HEM), a homemade mix of powdered milk, sugar, and oil, as treatment for malnutrition. High in calories and protein, HEM is cheaper to make than commercial RUTF and can be easily reproduced by caregivers at home if needed (Namayengo, 2001).

When coming to the clinic, children go through three program stages. First, children's anthropometric measurements are taken at the triage station. Second, children and their caregivers are sent for a consultation with a doctor for confirmation of diagnosis or follow-up. The doctor also prescribes HEM according to children's age and weight. Third, the kitchen personnel distribute HEM and explain to caregivers how to prepare the treatment. Program personnel include triage officers, doctors, and support staff. Nutritional counselling should be provided at each stage by corresponding personnel. Children are expected to return to the clinic every two weeks for re-evaluation of their nutritional status. They are followed until their anthropometric measurements indicate recovery. In 2019, it was estimated that more than 6,200 paediatric patients were screened for malnutrition at the clinic and that 500 received HEM as treatment for malnutrition (Soft Power Health, 2019).

## **2. MATERIALS & METHODS**

### **2.1 Evaluation design**

We conducted a qualitative process evaluation of SPH's on-site malnutrition program from September to December 2019. The evaluation responded to the need of program managers to better understand factors that could hinder children's nutritional recovery, with the prospect of

improving program services. This evaluation focused on the encounters between caregivers of malnourished children enrolled in the program and program personnel to examine caregivers' knowledge of malnutrition and perceptions of the program, program delivery, as well as contextual factors influencing the outpatient management of malnutrition (Moore et al., 2015). Data were collected through non-participant observations of patient-provider encounters during program delivery at the clinic, and subsequent semi-structured interviews with caregivers.

## **2.2 Sampling strategy**

We used purposive sampling to recruit caregivers of children between 12 and 59 months old diagnosed with MAM or SAM, enrolled in SPH's malnutrition program, and receiving HEM as treatment. The WHO criteria for diagnosis of child MAM and SAM, also used by the clinic, were adopted as inclusion criteria (World Health Organization, 2006). Exclusion criteria were as follows: 1) children under 1 year old, as they receive different treatments for malnutrition; 2) children over five years old, as diagnosis criteria for malnutrition differ; and 3) children with cerebral palsy, as they are prescribed HEM as long-term dietary supplement. During the 18 days of data collection in October and November 2019, all caregivers of eligible children were approached at the triage station, and all accepted to participate (N=15). All gave their oral consent for observation of their encounters with program personnel and participation in an interview. Before the interviews, caregivers gave their written informed consent in a form written in Lusoga (local language), which was read for them if needed. Program personnel involved in the consultations also provided their oral consent for the observations.

## **2.3 Data collection and translation**

We observed a total of 14 encounters between caregivers and program personnel and interviewed 15 caregivers (two caregivers sharing custody of the same child were observed together but interviewed separately). Observations were conducted directly after recruitment to ensure that all three stages of the program could be observed. Observations allowed to examine the encounters between caregivers and program personnel to evaluate factors associated with program delivery and counselling that could influence children's care (Liu & Maitlis, 2010).

Immediately after observation of patient-provider encounters and counselling, semi-structured interviews were conducted in Lusoga and English with the same caregivers. Interviews assessed factors linked to caregivers' practices, knowledge, and living conditions that could influence outpatient malnutrition management. We also examined their perceptions of the program, including nutritional counselling and HEM preparation. At the end of each interview, caregivers received a pictogram tailored to their children's HEM treatment (*i.e.*, quantity and intervals between feeds) explaining how to prepare it. If unable to describe how to prepare HEM, caregivers were referred to program personnel for further counselling. Interviews, lasting between 12 and 29 minutes, were conducted in a quiet room away from the main clinic.

Lusoga was the mother tongue of all participants. Therefore, observations and in-depth interviews were conducted in collaboration with a local interpreter, previously trained by the first author. The interpreter provided whisper translation of the exchanges between program personnel and caregivers during observations and translated all interviews in real time. The interpreter validated her initial translations by adjusting interview transcripts while listening to the recorded interviews, increasing translation precision and validity (Shimpuku & Norr, 2012; Squires, 2009).

## **2.4 Data analysis**



This study used interpretive description to analyse interview and observation data, allowing for a contextually situated analysis of children's care which could be useful for improving program practices (Thorne et al., 1997, 2004). Data were transcribed in English, imported in NVivo, and submitted to thematic analysis (Braun & Clarke, 2006). Analysis was done in a deductive and inductive manner to examine determinants of care from a socioecological perspective, while allowing for developing codes directly from the data (Lanfer & Reifegerste, 2021; Saldaña, 2013). Notes from observations were used to validate analysis of interview data. Themes were confronted to literature on the evaluation of CMAM programs in a logic of data triangulation between observations, interviews and existing literature (Nowell et al., 2017).

## **2.5 Ethical considerations**

Ethics approval was granted by Mbarara University of Science and Technology's Research Ethics Committee in Uganda. An exemption was granted after evaluation of the project by the University of Montréal's Ethics Committee for Science and Health Research following Article 2.5 of the Panel on Research Ethics of the Government of Canada. This project was conducted in an ethical manner. Informed consent was obtained from participants. Data were anonymised to protect participants' confidentiality.

## **3. RESULTS**

We observed 14 caregiver-provider encounters and interviewed 15 caregivers of malnourished children. Sociodemographic characteristics of participants are presented in Table 1. Three themes were developed from the analysis of the 15 interviews. The first theme presents determinants related to caregivers' knowledge and practices that may influence the outpatient management of malnutrition. The second theme identifies healthcare determinants that can

impact how caregivers comply to treatment protocols at home. The third theme describes the structural determinants that may affect children's care. Notes from program observations were used to enrich and validate findings from interview data. Summarised observations are represented in Table 2.

### **3.1 Lacking the knowledge to support their children: Determinants of malnutrition management at the caregiver-level**

#### *3.1.1 Having a limited understanding of malnutrition*

When asked about their understanding of malnutrition, caregivers explained what it meant to them and discussed signs of child malnutrition. The primary sign identified was weight loss, as many caregivers said that losing weight led to seeing the children's bones under their skin. Most described malnutrition as "thinning out" or "growing small." Accordingly, a woman in her 50s (P05) explained how she understood that her child was malnourished: "The signs that showed me that she had gotten malnourished were that I saw her thinning out, with no flesh onto the bones." A woman in her 20s (P07) defined malnutrition similarly: "There are some kids in this case of malnutrition, you can find that they have gone small, and they have no flesh. You just see bones." Although caregivers interviewed could generally identify weight loss as a sign of malnutrition, many of their children had symptoms other than weight loss. Only a few participants named other signs of malnutrition, such as "swelling of the cheeks," "enlarging of the abdomen," "yellowing of the face" or "a change of colour of the hair." Caregivers often asked for more information on malnutrition, suggesting that their health literacy was limited and that they would have benefitted from better understanding this condition.

#### *3.1.2 Not grasping the mechanisms that bring malnutrition*

Caregivers discussed causes of malnutrition and factors that contribute to improving children's nutritional status. Caregivers named many perceived causes of malnutrition that were not necessarily linked with nutrition such as "sleeping well," "giving leftover food," "the body being hot," "coldness," and "delaying seeking medical care." Nevertheless, all but one participant identified inappropriate feeding habits as the primary cause of malnutrition. A woman in her 50s (P08) explained that not eating nutritious food could cause malnutrition: "What brings malnutrition: this child not feeding well or not eating food which can help build the body." A woman in her 20s (P02) described how she could help her children recover from malnutrition: "According to me, the way I think, it means giving enough food to this child and having different meals, like having a balanced diet." Although all participants stressed their role as caregivers in supporting their children to recover from malnutrition, the majority mentioned mostly feeding their children on a carbohydrate diet. Posho (cornmeal porridge), matooke (boiled green banana), rice and potatoes were the foods most named by caregivers: all participants named at least one of these food items and almost half only discussed carbohydrates. For instance, a woman in her 50s (P09) detailed her child's daily diet: "There are many foods, like posho, potatoes, matooke. Sometimes, the father also brings in rice." Data suggests that while caregivers could identify perceived causes of malnutrition, they did not fully grasp the mechanisms of malnutrition or know concrete ways to support their children.

### **3.2 Being unequipped to make informed decisions: Healthcare determinants of malnutrition management**

#### *3.2.1 Difficult knowledge transfer and inconsistent counselling*

The counselling provided to caregivers by program personnel varied greatly. This was assessed during observations of patient-provider encounters and confirmed during interviews

with caregivers. The frequency, content, and intensity of counselling were inconsistent across program stages and personnel. Counselling sessions most often addressed how to have a balanced diet, when to feed children, and examples of local foods to give them. A woman in her 20s (P12) confirmed this emphasis put on diet when remembering counselling: “I was told to cook food [...] Taking care, giving the treatment that they have given me, and also giving food all the time.” However, others mentioned receiving very little or no counselling. Another woman in her 20s (P01) explained that in her previous appointment, when her children were first admitted into the program, she did not receive much counselling: “Last time when I came, I didn’t get enough education. It’s today that I have got more health education.” Similarly, another woman in her 20s (P07) who had previously dropped out of the program and returned after months of absence said that she was not counselled: “There is nobody who educated me [...] They taught me how to cook only [...] I also had the first teaching on the other side about hygiene.” Therefore, in line with our observations, counselling offered to caregivers was inconsistent. Knowledge transfer also seemed inefficient, as caregivers did not all realise that they had received counselling, nor did they fully understand the information that was shared with them. Many participants expressed their uncertainty during the interviews and asked for recommendations to better care for their children.

### *3.2.2 Confusion caused by conflicting information on the HEM treatment*

All participants had positive perceptions of HEM. Many mentioned that HEM was “better than cow’s milk,” “built the body” and “helped children gain energy.” However, most were hesitant when asked to describe the treatment. A woman in her 20s (P06) explained that she did not know what HEM was made of: “Ah! For me I don’t know, but they say they put that building food in the milk.” Likewise, a woman in her 40s (P04) expressed not understanding what was

HEM: “This milk you are giving me? I don’t know it.” In addition to not knowing what HEM was made of, many participants were confused when asked to explain how to prepare HEM. As confirmed from program observations, this could be explained by the fact that caregivers were often given different information about the prescribed amount of HEM and feeding times by doctors and other personnel. For example, in several instances, instructions given by support staff upon distribution of HEM contradicted the treatment plan previously described by doctors. Considering that the treatment plan changed at every visit (*i.e.*, according to children’s weight, height, and nutritional status), this might influence treatment compliance.

While some were given conflicting information about the HEM treatment, others received no information about how to prepare it, such as this woman in her 20s (P07) who expressed not being taught about how to cook HEM: “I wasn’t told [...] How long does that milk take to boil? I forgot asking.” Similarly, a woman in her 50s (P08) was unsure about how to measure the right quantity of HEM for her child:

This measuring part, like measuring milk... I was told to measure with the baby cups, the ones having measurements. What if I just give the estimated amount? Now, this one is a big child, what if I use a regular cup? [...] What if I don’t use the real measurements?

At the end of their visit in the program, participants were therefore still confused about how to prepare HEM. Yet, few participants were asked about their understanding of the treatment plan by program personnel. Importantly, given their limited access to stable incomes and education, many participants did not own baby bottles with measurements, and did not know how to read, making it impossible for them to comply with the treatment prescribed. This was not addressed by program personnel, while most participants would have needed more information. Having asked participants about their understanding of the prescribed HEM treatment and its preparation could potentially have improved compliance.

### **3.3 Trying to overcome inequalities: Structural determinants of malnutrition management**

#### *3.3.1 Poverty hindering access to healthcare and compliance with CMAM protocols*

Many caregivers named poverty as an obstacle to managing their children's condition. One way in which economic insecurity impacted malnutrition was by restricting access to healthcare. Most caregivers, like this woman in her 50s (P05), recognised access to medical care as crucial for nutritional recovery: "What will help her is taking the child to see the medical personnel [...] and giving treatment so that the child will get fine." However, many participants lived far from the clinic and had to pay up to 8.50 USD for a round trip using public transport, even if they had no income. For instance, a woman in her 20s (P01) explained delaying to seek medical attention for her child, not having enough money to pay for transport: "When he feels sick, you may lack money for transport to bring the child to the clinic. Like last time, I was supposed to come back on [a specific day] but money was a problem." Another woman in her 20s (P02) who had been receiving free healthcare and HEM from the program expressed being scared because program personnel told her she would soon have to start paying for treatment:

Right now, since I'm not working, I don't have money. And now, they are saying that they are going to stop [my children] from getting milk [...] I don't have any money, and I don't have anywhere to start from to get money, and I've been relying on this milk.

Another caregiver (P05) mentioned that poverty hindered her ability to comply with the recommendations of the program, lacking the money to buy a variety of food to feed her child with a balanced diet: "Maybe I can [help my child get better], but right now I don't have enough money. Still, I can buy what I can afford." Consequently, poverty limited access to healthcare and hindered treatment compliance for participants, as they often could not afford to pay for transport, treatment, or diverse foods to support their children.

### *3.3.2 Gender inequality limiting caregivers' ability to care for malnourished children*

Out of 15 participants interviewed, 13 were women. Most of them did not access education beyond primary school and were not employed. In contrast, the two male respondents had secondary education and were expected to support their family financially. Women participants were primary caregivers, responsible for much of child rearing duties, often having many children to care for. They mentioned that difficult family situations impacted their ability to manage their children's malnutrition. For instance, a woman in her 30s (P15) with many children explained that people in her village provided food for them because she did not have an income. She said that her husband, who had abandoned her and their children, occasionally came back to force her to have other children, while not supporting his family:

The man is not at home. He has taken a long time without coming home. He ran away from home, and he has spent years [without coming back] [...]. He just forced me to have sex. Then, I gave birth to this one.

She also expressed that while many of her children were malnourished, she did not have money to bring them all to the clinic.

Other women similarly discussed being left to provide for their children alone. One woman (P01) said that she moved out of her husband's home because he "did not give [her] care" and that her financial situation was "very bad." Another woman (P12) mentioned that her husband was rarely present: "I stay with him, but still... I stay with him for a short time. [...] He's having two wives so he's not ever at home." Similarly, a woman in her 20s (P02) discussed seeking help from the clinic's domestic violence counsellor to ensure she could provide treatment for her children: "I went to the [domestic violence] counsellor who came and spoke to [the program personnel], and they made for me a receipt indicating that I will be taking milk for free, and also the transport included." Therefore, difficult family situations and women's financial

dependency upon their male partners seemed to hinder their ability to respond to their children's nutritional needs and access services required to overcome malnutrition.

#### **4. DISCUSSION**

This article offers novel insight on the outpatient management of child malnutrition in the context of CMAM, following the evaluation of a malnutrition program in rural Uganda. It provides more information on the multifaceted determinants of malnourished children's care. Three themes were developed, indicating that caregiver/household, healthcare, and structural determinants can shape how children fare in programs where acute malnutrition is to be treated by caregivers at home. To the best of our knowledge, this is the first CMAM program evaluation that has used the socioecological model as conceptual framework to guide its findings. Results should be used to inform the implementation and evaluation of these programs in low- and middle-income countries to ensure that children can thrive.

In our evaluation, we found that a majority of caregivers experienced multiple causes of marginalisation – including chronic poverty, gender inequalities, limited access to education and employment, and lack of social protections – which clustered to hinder children's care (Nisbett & Harris, 2018). These structural barriers increased the vulnerabilities of caregivers and their families, limiting their agency to become food secure, access healthcare, and care for malnourished children (Clement et al., 2019). Yet, many evaluations of CMAM programs adopt biomedical or behavioural health approaches, neglecting to explore factors beyond the individual that can influence malnutrition management (Abubakar, 2013). It has been argued that the multilevel determinants of children's health should be studied concurrently when assessing health interventions, to grasp how individual factors interact with structural factors to shape patterns of health vulnerability and inequity (Nisbett & Harris, 2018; Uddin et al., 2021). CMAM programs



should therefore consider these barriers and examine how structural determinants can hinder caregivers' capacity to uphold CMAM protocols (Kim et al., 2013).

The first theme demonstrated that caregivers' characteristics and practices could influence malnutrition management. Our results are consistent with evaluations of other CMAM programs showing that caregivers in low-resource settings may have limited understandings of malnutrition (Isanaka et al., 2020; Mbogo et al., 2020; Peter et al., 2019; Ware, 2018). Our findings showed that most caregivers associated nutrition with weight loss, having more difficulty identifying other signs of malnutrition. Interestingly, a study investigating community perceptions of child undernutrition and CMAM in India found that caregivers were less likely to consult health professionals if their children were 'only skinny' (Burtscher & Burza, 2015). This result is worth considering in the Ugandan context, as it suggests that low health literacy regarding malnutrition could impede caregivers' ability to detect the condition early, recognise its severity, and seek medical care. Caregivers' perceptions of malnutrition could also influence treatment compliance and children's care.

Our second theme identified determinants associated with program implementation that could shape the outpatient management of malnutrition. Observations and interviews showed that caregivers received inconsistent counselling, as well as insufficient (and sometimes contradicting) information about their children's treatment plans. This resonates with findings from other CMAM evaluations highlighting that healthcare providers do not always adhere to program protocols, and that training and supervision of personnel are critical to programmatic success (Shah More et al., 2018; Tadesse et al., 2016). Studies also found that nutritional counselling was often weak in these programs (Ashworth, 2006; Somassè et al., 2016). These results are significant for our evaluation, potentially explaining why caregivers struggled to describe and comply with the treatment prescribed. Strengthening knowledge transfer in CMAM

programs to ensure that caregivers better understand treatment plans could improve children's care.

Our third theme outlined structural barriers impacting outpatient malnutrition management. Structural violence, referring to the social structures embedded in everyday practices and institutions that exacerbate health inequalities and exposure to risk for certain individuals, can limit the agency of caregivers in taking care of their malnourished children (Farmer et al., 2006; Nisbett & Harris, 2018; Chung & Hunt, 2012; Chung, 2021). In our evaluation, caregivers, who were mostly women, stressed that poverty was an obstacle to follow CMAM protocols, limiting their ability to pay for transport, seek medical care, and buy a diverse diet for children. Their lack of access to education and employment also increased their financial dependency upon their husbands and left them in precarious situations when unmarried.

While many studies on nutrition highlight that maternal education, poverty and gender inequality can influence children's nutritional status (Kajjura et al., 2019; Kumeh et al., 2020; Nankinga et al., 2019; Uddin et al., 2021), few evaluations of CMAM programs consider these factors in their analysis. These studies recommend assessing economic and food needs of entire households, family dynamics, domestic violence, and women's empowerment (Shah More et al., 2018; Sharma & Subramanyam, 2021; Tette et al., 2016). Assessing these structural determinants of care in program evaluations could help deconstruct the 'gendered and classed discourses of blame' often present in food-related research, in which women and their behaviours are blamed for family feeding practices (Mackay, 2019). Our results, supported by the existing literature, therefore suggest that CMAM programs should adopt integrated responses, tackling the acute needs of malnourished children while also intervening to improve the social conditions at the roots of children's nutritional trajectories.

#### **4.1 Limitations**

First, it is possible that program personnel and caregivers adapted their behaviours as they were being observed and interviewed. This could have altered how counselling was provided by program personnel (*i.e.*, leading to more thorough counselling). It could also have changed the ways in which caregivers responded to interview questions (*i.e.*, saying they were satisfied with the CMAM program), despite being encouraged to openly share the positive and negative aspects of their experience. Second, working with an interpreter in cross-cultural research can impact the reliability and validity of findings, because subtle differences in meaning across languages and cultures are not always captured (Kapborg & Berterö, 2002). It is therefore possible that some sociocultural references were not grasped during data collection and analysis. However, training of the interpreter before conducting the interviews helped minimise these issues. This contributed to ensuring that interview transcripts conveyed conceptual equivalence, meaning that the interpreter translated not only the literal meanings of words, but also conveyed how words relate conceptually in their context (Squires, 2009). In addition, the fact that the first author was immersed in the evaluation context for a prolonged period is an important strength of this evaluation. Close collaboration with local healthcare personnel throughout the process also ensured that the content of the evaluation was ethical, transparent, and culturally appropriate.

#### **5. CONCLUSION**

CMAM programs could be improved by extending their scope beyond caregivers' feeding practices and care behaviours. Programs should strengthen their counselling curricula to ensure that caregivers receive sufficient information on children's nutritional care. Counselling should also be used to screen for structural vulnerabilities affecting households, to tackle the multilevel barriers to malnutrition management. CMAM programs being often delivered by non-

governmental organisations providing primary healthcare, caregivers could be referred to partner services targeting chronic food insecurity, poverty, domestic violence, family planning, and women's empowerment. We hope that the results from this evaluation contribute to encouraging CMAM programs to develop tailored responses to the needs of households, incorporating complex interventions to address structural determinants of care (Birn et al., 2017; Kim et al., 2013; Nisbett et al., 2014). As we step into the last decade of the Sustainable Development Goals, it is critical that CMAM programs involve multidisciplinary teams to support families in accessing the resources needed to tackle the fundamental causes of undernutrition.
