Synergetic measures to contain highly transmissible variants of SARS-CoV-2

Summary

- 14 **Background** The public and scientific discourse on how to mitigate the COVID-19 pandemic is
- often focused on the impact of individual protective measures, in particular on vaccination. In
- view of changing virus variants and conditions, however, it seems not clear if vaccination or any
- other protective measure alone may suffice to contain the transmission of SARS-CoV-2.
- 18 **Methods** Here, we investigate the effectiveness and synergies of vaccination and non-
- 19 pharmaceutical interventions like masking, distancing & ventilation, testing & isolation, and
- 20 contact reduction as a function of compliance in the population. Our new analysis accounts for
- 21 the practical compliance in the population and for both droplet transmission and aerosol
- 22 transmission.
- Findings For realistic conditions, we find that it would be difficult to contain highly contagious
- 24 SARS-CoV-2 variants by any individual measure. Instead, we show how multiple synergetic
- 25 measures have to be combined to reduce the effective reproduction number (R_e) below unity for
- 26 different basic reproduction numbers ranging from the SARS-CoV-2 ancestral strain up to
- 27 measles-like values ($R_0 = 3$ to 18). For $R_0 = 5$ as reported for the Delta variant and ~70%
- vaccination rate, the synergies of masking and distancing & ventilation with compliances around
- 29 30% appear sufficient to keep $R_e < 1$. In combination with 2-3 tests per week, this would work
- also at lower vaccination rates, e.g., in schools.
- Interpretation If the Omicron variant were to reach $R_0 = 8$, it could still be contained with the
- 32 synergetic measures outlined above. In case of measles-like transmissibilities ($R_0 = 12$ to 18),
- 33 higher compliances and testing rates or additional measures like general contact reductions
- would be required. The presented findings and approach can be used to design and communicate
- 35 efficient strategies for mitigating the COVID-19 pandemic.

Research in context

Evidence before this study

- 40 Studies on how to mitigate the COVID-19 pandemic are often focused on the impact of
- 41 individual protective measures, in particular on vaccination. The effectiveness of non-
- 42 pharmaceutical interventions (NPIs) like masking or distancing & ventilation are often under
- debate due to a lack of understanding of different transmission pathways (droplet versus aerosol
- 44 transmission) and protective measures, in particular for the efficacy of masking and contrasting
- randomized trial results under different conditions (virus-limited vs. virus-rich) and at different
- levels of practical compliance. Thus, in view of more contagious variants such as Delta or
- 47 Omicron, it is not clear if vaccination or any other protective measure alone may suffice to
- 48 contain the transmission of SARS-CoV-2.

Added value of this study

- Our analysis explicitly accounts for both droplet and aerosol transmission as well as for practical
- 51 compliance in the population, which is the main reason for divergent results on the effectiveness
- of the same NPIs in different regions. This was not fully considered before and may have led to
- 53 misunderstandings and misinformation about the actual effects of preventive measures. For
- 54 realistic conditions, we find that it would be difficult to contain highly contagious SARS-CoV-2
- variants by any individual measure. Instead, we show that combining multiple synergetic
- measures with realistic compliances can reduce R_e below unity without lockdown.

57 Implications of all the available evidence

- Our findings and the presented scientific approach can be used to design and communicate
- 59 efficient strategies for mitigating the COVID-19 pandemic for specific environments like schools
- as well as on a population level.

Introduction

The COVID-19 pandemic has severe health, economic, and societal effects. Immunization by vaccination is one of the most important and prominent measures to control and mitigate the transmission of SARS-CoV-2, which has the benefit of not just reducing the transmission but also reducing the average severity of disease 1 . Recent developments, however, suggest that the progress and effectiveness of vaccination may not suffice for suppressing or breaking waves of infection and swiftly mitigating the spread of COVID-19 2 . Besides vaccination, common further measures to control and contain the transmission of SARS-CoV-2 are universal masking, distancing & ventilation, contact reduction, and testing & isolation $^{3-10}$. Here, we investigate and quantify the effectiveness and synergies of these measures in reducing the effective reproduction number, R_e . In the main text and figures we focus on a basic reproduction number of $R_0 = 5$ that approximates the transmissibility of the Delta variant of SARS-CoV-2 11 . In the supplementary Figs, we also show results for $R_0 = 3$ referring to the ancestral strain of SARS-CoV-2 and for $R_0 = 8$ to 18 representing extremely contagious variants with transmissibilities similar to measles (Supplementary text S1). These high R_0 scenarios may become relevant for designing measures and strategies against the newly emerging Omicron or further variants (Supplementary text S1).

A detailed account of the scientific approach and methods applied in our study is given in the Methods. Based on recent observations, we assume that the probability of SARS-CoV-2 transmission is on average reduced by approx. 70% for vaccinated persons ^{12,13} (Supplementary text S2). As illustrated in Fig. 1, universal masking reduces both the exhalation and the inhalation of respiratory viruses like SARS-CoV-2 (source control and wearer protection) and can thus reduce the probability of transmission by approx. 80% in case of surgical masks and approx. 99% in case of N95/FFP2 masks (Methods; Cheng et al., 2021). Physical distancing by at least 1-2 meters and proper ventilation of indoor environments can decrease the risk of transmission by respiratory droplets (> 0.1 mm) and aerosols (< 0.1 mm) by approx. 90% (Methods), whereby distancing primarily reduces droplet transmission and ventilation primarily reduces aerosol transmission ³⁻⁶. Reducing the number of contacts leads to a directly proportional decrease of R_e , and the effects of testing & isolation of infected persons on R_e can be described as detailed in the Methods ¹⁴. Our investigations are focused on airborne transmission (including aerosols and droplets) rather than fomite transmission. Most of the investigated protective measures, however, would also reduce fomite transmission (vaccination, contact reductions, testing & isolation, masking via source control).

Methods

In this study, we are building and extending the scientific approach developed in Cheng et al. (2021) ⁵. By definition, the basic reproduction number, R_0 , can be linked to the basic population average infection probability, P_0 , by

where *d* represents the average duration of infectiousness, and *c* represents the average daily number of human contacts (Supplementary text S1 and references therein). Vaccination, non-pharmaceutical interventions such as universal masking (surgical, N95/FFP2), distancing &

ventilation, contact reduction, and testing & isolation can lead to reduced effective reproduction number, R_e , by decreasing the infection probability (P), duration of infectiousness, or number of daily contacts.

The effectiveness of an individual measure, E_i , can be defined as

where $R_{e,i}$ represents the effective reproduction number after implementing the measure *i*. The combined effectiveness of multiple independent measures, E_{tot} , can be calculated by

In the following, we described how the effects of different protective measures on R_e were calculated in this study.

The influence of vaccination on R_e is described E_{vac} , which depends on the rate of vaccination, V_r , and on the vaccine effectiveness against transmission, E_v , i.e., the average degree by which the probability of SARS-CoV-2 transmission is reduced in the vaccinated population:

Universal masking is an effective measure against airborne transmission of SARS-CoV-2 5,10,15,16 (Supplementary text S3). The influence of masking on R_e is described by E_{mask} , which is calculated for both aerosol transmission (via respiratory particles with diameters < 0.1 mm) and droplet transmission (via respiratory droplets with diameters > 0.1 mm). The effects of masking on aerosol transmission of SARS-CoV-2 depends on R_0 (reflecting population average infection probability) and have been calculated the same way as in Cheng et al. (2021) 5 . Because the effectiveness of masking depends on the variability of infection probability (Eq. 1 & 2), we adopted a standard deviation of $\sigma = 2$ to describe the virus load distribution 5 . The effect of compliance with masking, m, on the infection probability via aerosol transmission, $P_{\text{mask,a}}$, can be described by Eq. 6 5 :

Here $P_{0,a}$ represents the population average infection probability via aerosol transmission when no one wears masks; $P_{sc,a}$ represents the average infection probability in the case of source control (mask wearing by infected persons); $P_{wp,a}$ represented the average infection probability in the case of wearer protection (mask wearing by susceptible persons); and $P_{um,a}$ represent the average infection probability in the case of universal masking as determined by Cheng et al. (2021) ⁵. Similarly, we can calculate the effects of universal masking on droplet transmission by

With regard to wearer protection against droplet transmission, the additional terms in Eq. 7 take into account that droplet transmission may also occur through the eyes of the mask wearer ¹⁷. The fractional contribution of droplet transmission through the eyes (eye infection) is described by the parameter x, and the fractional contribution of droplet transmission through mouth and nose is given by (1-x). By inserting $P_{\text{mask,a}}$ or $P_{\text{mask,d}}$ in Eq. 2 and 3, we calculated a mask effectiveness for aerosol transmission, $E_{\text{mask,a}}$, and a mask effectiveness for droplet transmission, $E_{\text{mask,d}}$. Because the relative contributions of aerosol and droplet transmission have not yet been determined, we took the smaller value for E_{mask} to obtain a conservative estimate for the overall effectiveness of masking. For x = 0.3 and as illustrated in Fig. S2, this implies $E_{\text{mask}} = E_{\text{mask,a}}$ for surgical masks and $E_{\text{mask}} \approx E_{\text{mask,d}}$ for N95/FFP2 masks.

For proper physical distancing by at least 1-2 m, we assume an effectiveness of approximately ~90% against direct transmission by droplets and aerosols, corresponding to the respiratory particle volume fraction typically lost through gravitational settling over such distances (Supplemental text S4, Fig. S3) 7,19 . In contrast to physical distancing, regular ventilation has little effect on direct transmission by semi-ballistic respiratory droplets (> 0.1 mm) but reduces indirect transmission by equilibrated respiratory aerosols (< 0.1 mm) in indoor environments both in the near-field and the far-field 5,6,18 . Changing from passive ventilation to high rates of active ventilation can reduce the airborne virus concentration and probability of indirect transmission by aerosols with an effectiveness up to ~90% 5 (Supplemental text S4). Thus, we assume an effectiveness of $E_{\rm d\&v} \approx 90\%$ for the combined influence of distancing & ventilation on $R_{\rm e}$.

The influence of testing & isolation on R_e can be described by an effectiveness of

$$E_{t\&i} = 1 - 0.7/(n*d) \tag{8}$$

where n is the number of tests per week and d is the duration of infectiousness. The basis for this equation and how to consider relevant parameters like the average duration of infectiousness or false negative rates of testing are detailed in the supplement (Supplementary text S5).

Results

Individual measures and synergetic effects

For each of the investigated protective measures, Figure 2 shows how R_e decreases with increasing compliance in the population. Vaccination alone (black line) can reduce the reproduction number from $R_0 = 5$ to $R_e = 2.5$ at 70% compliance, which corresponds approximately to the current rate of vaccination in Germany (https://impfdashboard.de/). Even at 100% compliance, however, vaccination alone would not reduce R_e below 1 as required to contain the transmission. Without other protective measures, R_e would remain as high as 1.5, leading to continued exponential growth. In other words, the currently available vaccines are highly protective against the disease and severe outcomes of COVID-19 ^{12,13}, but they are not sufficient to contain and end the transmission of SARS-CoV-2 without synergetic measures. For $R_0 = 5$ or higher basic reproduction rates, even a vaccine that reduces the probability of infection

and transmission by 95% 1 would require vaccination rates higher than 85% to decrease $R_{\rm e}$ below 1 (Fig. S1). In theory, distancing & ventilation alone (yellow line) could decrease $R_{\rm e}$ to 0.5 at 100% compliance, but at more realistic compliance rates around 50% as discussed below, $R_{\rm e}$ would also remain above 1. Similarly, universal masking (red line) with 100% compliance could bring $R_{\rm e}$ close to 1 in case of surgical masks (Fig. 2A) and well below 1 in case of N95/FFP2 masks (Fig. 2B), but at more realistic compliance rates around 50%, $R_{\rm e}$ would again remain above 1.

When all these measures are combined (solid blue line), compliance rates around 50% are sufficient to bring R_e close to 1 in case of surgical masks (Fig. 2A) and well below 1 in case of N95/FFP2 masks (Fig. 2B). The steep non-linear decay of the "all measures" curve and the very low R_e values obtained at high compliance highlight the strong synergetic effect that results from combining multiple protective measures and multiplying their individual effects. Even if only universal masking were combined with distancing & ventilation ("physical measures", dashed blue line), R_e would fall below 1 at 50% compliance with N95/FFP2 masking (Fig. 2B). Note, however, that 50% compliance with masking are not easy to achieve as discussed below and in Cheng et al. (2021). We are not suggesting to promote these physical measures without vaccination, which would also be missing the benefit of reducing both the transmission of the virus and the severity of the disease by immunization 1,12,13 . Nevertheless, the "physical measures" curve shows, that the synergetic effects of combining and properly applying these simple measures are strong enough to reduce the reproduction number substantially, e.g., for breaking or suppressing waves of infection.

The actual rates of vaccination vary widely due to different supplies, age limits, and willingness. For example, the percentages of fully vaccinated people are around 39.4% in India, 61.4% in the U.S.A., 70.2% in Germany, 87.8% in Portugal, and 46.6% worldwide at this time (21 December 2021) 23 . In our study, we are not explicitly accounting for persons immunized by recovery from the disease. Depending on the level of immunization, they can be implicitly included in the vaccination rate (compliance). Given an approximate efficacy of 70% and an approximate upper limit of 90% for compliance, vaccination can only reduce R_e from 5 to approx. 1.9. Recent observations suggest that the efficacy of currently available vaccines against the transmission of the new Omicron variant is lower and may thus contribute less to reducing the effective reproduction number of SARS-CoV-2 (Supplemental text S2).

For universal masking, 100% compliance would be difficult to achieve because masking is not always possible and practical, for example at home, during eating or drinking in restaurants and bars, in schools and kindergartens, etc. ⁵. The potential importance of such situations is demonstrated by a recent modeling study attributing around 10% to 40% of daily infections to restaurants and cafés/bars ²⁴. Moreover, a lack of willingness to follow recommendations or mandates for mask use may also lead to low compliance with mask wearing. For example, inpatient respiratory protection studies show that adherence rates vary from 10% to 84% for health care personnel ²⁵. Similar effects can be expected when wearing masks with low efficiency or poor fit and high penetration or leakage rates ^{5,26}. Combining these effects, we may estimate ~50% as an effective upper bound for the compliance with universal masking (Supplementary text S3). For physical distancing, we may expect a similar effective upper limit of compliance because distancing may be difficult under the same or similar conditions that are

unfavorable for masking. With regard to ventilation, earlier investigations indicate that the ventilation of indoor environments is often much lower than recommended, and the values recommended for common indoor environments are also lower than the ventilation rates used for effective infection control in health care units ^{6,27}. We found no data specifically suited for estimating population-average ventilation effects ⁶, but based on the available literature we assume that the effective upper limit of compliance with distancing & ventilation is similar to the value estimated for distancing (approx. 50%).

Thus, it would be difficult to contain SARS-CoV-2 transmission and end the pandemic by any individual measure as currently available under realistic conditions. On the other hand, Fig. 2 shows that the synergetic effects of combining the investigated protective measures at realistic levels of compliance can decrease the effective reproduction number from $R_0 = 5$ as reported for the Delta variant of SARS-CoV-2 to well below 1. In case of new virus variants such as Omicron, the efficacy of vaccines may be reduced, but the effectiveness of simple physical measures should not change much. In case of higher basic reproduction numbers up to measles-like transmissibilities, higher compliances or additional measures would be required as illustrated in Fig. S4 for $R_0 = 8$, 12 and 18, respectively, and further discussed below. In the following, we explore the synergies of combining vaccination with universal masking, distancing & ventilation, contact reduction, and testing & isolation.

Combining vaccination with non-pharmaceutical interventions

Figures 3A and 3B show how R_e decreases as a function of compliance with universal masking for different vaccination rates in the population, assuming that vaccine efficacy against virus transmission is 70% and that no other protective measures are applied. The basic reproduction number R_0 is 5, and the reduced starting values of R_e at zero compliance with masking correspond to different vaccination rates. At a vaccination rate around 70% (black line), decreasing R_e below 1 would require compliances higher than 70% for surgical masking (Fig. 3A) and higher than 50% for N95/FFP2 masking (Fig. 3B). In practice, such compliance values appear unrealistically high as discussed above, indicating that controlling the transmission of SARS-CoV-2 in a population with moderate vaccination rate (e.g., in Germany) requires additional measures beyond vaccination and masking. At a vaccination rate around 90% (yellow line), decreasing R_e below 1 would require compliances around 50% for surgical masking (Fig. 3A) and 30% for N95/FFP2 masking (Fig. 3B). Thus, high compliance with universal masking may suffice to prevent or suppress potential waves of infection in populations with high vaccination rates (e.g., in Portugal).

In Figs. 3C and 3D, we include the effect of distancing & ventilation. They show how R_e decreases as a function of compliance with distancing & ventilation for different compliances with universal masking at a fixed vaccination rate of 70%. Different starting values of R_e at zero compliance reflect the effects of vaccination and different levels of masking. Without masking (black line), decreasing R_e below 1 would require compliances higher than 70%, which appear unrealistically high as discussed above. With universal masking at a level of 30% (red line), decreasing R_e below 1 would require distancing & ventilation compliances around 50% in case of surgical masks (Fig. 3C) and around 30% for N95/FFP2 masks (Fig. 3D). As discussed above, compliance levels around 30% are not unrealistic. Thus, high compliance with universal masking

in combination with distancing & ventilation may suffice to prevent or suppress waves of infection in populations with moderate vaccination rates (e.g., in Germany).

In Fig. S5, we include the effect of contact reduction. It shows how R_e decreases as a function of contact reduction for different compliances with universal masking at a fixed vaccination rate of 70%. With universal masking at 30% compliance (Figs. S5A and S5B, red line), decreasing $R_{\rm e}$ below 1 would require contact reductions by approx. 50% in case of surgical masks and approx. 30% for N95/FFP2 masks. According to recent studies 8,28-30, 30% contact reduction would correspond to partial confinement and 50% would correspond to a lockdown. When universal masking is combined with distancing & ventilation at 30% compliance (Figs. S5C and S5D, red line), contact reductions by approx. 30% would decrease R_e slightly below 1 for surgical masks and as low as 0.7 for N95/FFP2 masks. Thus, moderate contact reductions (around 30%, partial confinement) combined with distancing & ventilation and N95/FFP2 masking at moderate levels of compliance (around 30%) may suffice to prevent infection waves. The synergetic effects of contact reduction combined with other protective measures are further illustrated in Figs. S6, S7 and S8, including higher basic reproduction numbers ($R_0 = 8$, 12 and 18, respectively). In case of measles-like transmissibilities ($R_0 = 12$ to 18), even high levels of compliance ($\sim 50\%$) with masking and distancing & ventilation plus vaccination (~70%) would not suffice, and additional measures like general contact reductions (\sim 50%) would be required to bring R_e below 1 (Figs. S11 and S12).

Testing & isolation of infected persons is a protective measure particularly common and relevant for mitigating the transmission of SARS-CoV-2 in schools ¹⁴. Figure 4 shows a pronounced nonlinear dependence of R_e on the frequency of testing (number of tests per week) for different vaccination rates and compliances with universal masking and distancing & ventilation. The latter are key measures and essential tools to contain the transmission in schools and keep them operational during the pandemic. Even for largely unvaccinated groups such as primary school children, R_e can be kept as low as 0.5-0.9 by 2-3 tests per week combined with distancing & ventilation and surgical or N95/FFP2 masking at moderate compliance levels around 30% (red lines, Figs. 4A and 4B). At a vaccination rate of 70%, similar results can be achieved just by testing and masking (red lines, Figs. 4C and 4D). At 70% vaccination rate, 30% masking, and 30% distancing & ventilation, even one test per week may suffice to keep R_e below 1 and contain the spread of SARS-CoV-2 (red lines, Figs. 4E and 4F). Figure S9 shows the results obtained for various further combinations of protective measures at different levels of compliance. In practice, the frequency of testing has to be adjusted according to the rates of false negative results ²² (Methods), and the effects of incomplete isolation have to be considered, which may reduce the effectiveness of this measure. Nevertheless, testing & isolation may be highly effective not only in educational but also in workplace and private environments, especially with increasing vaccination rates (see Figs. S9E and S9F). Testing & isolation combined with all other available measures and high compliances may become essential for containing SARS-CoV-2 transmission in educational and workplace environments if more contagious variants emerge (see Figs. S10, S11 and S12 for $R_0 = 8$, 12 and 18, respectively). In case of measles-like transmissibilities ($R_0 = 12$ to 18) and low efficacy of vaccination against transmission, high practical compliance with all NPIs including general contact reductions (~50%) plus 3-4 tests per week could still bring R_e well below unity (< 0.7) and contain, if not terminate, the spread of SARS-CoV-2 in a population (Figs. S11E and S12E).

We suggest to further extend and validate the above results by target-oriented collection and analysis of observational data. The modeling tools developed and applied in this study will be made freely available on the internet. In this context, it will be important and challenging to clarify and resolve the actual contributions of viruses in respiratory particles of different sizes, e.g., the contribution of aerosol versus droplet transmission. This will be worthwhile for both the traditional medical cut-off at 5 µm, distinguishing between fine and coarse particles, as well as for the physical upper limit at 0.1 mm, distinguishing between suspended aerosols and larger semi-ballistic particles, including droplets and dry particles (Supplementary text S6 and references therein). Among the simple physical protective measures, distancing works primarily against droplet transmission and ventilation against aerosol transmission (Methods)^{3,5,6}. Surgical masks are effective and N95/FFP2 masks are highly effective against aerosol transmission, and both are even more effective against droplet transmission because of the higher filtering efficiency and low penetration rates for large droplets ⁵.

Discussion

We suggest that the presented scientific approach, results, and tools can be used to design and communicate efficient strategies to contain the transmission of SARS-CoV-2 in different environments and to mitigate the COVID-19 pandemic. Our quantitative results are consistent with earlier recommendations ^{2,31}, and the modeling tools can be used to explore and refine the synergetic effects of combining multiple protective measures as a function of R_0 , compliance, and efficacy of each measure (Supplementary text S6). For example, universal masking should be promoted and the efficacy and suitability of different masks against aerosol and droplet transmission under different conditions should be further clarified and communicated – in particular, why any decent mask is better than none, why tightly fitting FFP2 masks are particularly effective, and why masks are also useful in outdoor gatherings ^{5,26}. Efficient ventilation of classrooms and other indoor environments could be fostered, optimized and assessed by readily available techniques like exhaust fans, air ducts for displacement ventilation, and CO₂ sensors etc. For schools, we find that the transmission of SARS-CoV-2 can be contained by 2-3 tests per week combined with masking, distancing & ventilation, even at moderate compliances and low vaccination rates for $R_0 = 5$. Thus, testing appears worthwhile in schools and other densely occupied environments ¹⁴. The frequency of testing may be adjusted according to the non-linear relation to R_e as well as the rates of false negative results 22 , the effects of incomplete isolation, and potential changes of R_0 in case of more contagious variants (see Fig. S10 for $R_0 = 8$ to 18).

The strong dependence of R_e on practical compliance with preventive measures highlights the importance of situations where masking, distancing & ventilation or isolation are not possible, impractical, or ineffective – in particular during eating/drinking in restaurants/bars, schools/kindergartens, trains/planes, and at home. In such situations, it may, for example, help to wear masks alternatingly. Obviously, infectious fluids can also be transferred via surface contacts, and standard hygiene procedures against fomite transmission should also be followed (https://www.cdc.gov/coronavirus/2019-ncov/more/science-and-research/surface-transmission.html).

The simple and robust methods and the easy-to-understand plots of R_e vs. compliance provided in this study may help to communicate these strategies and to demonstrate the importance of cooperation to the wider public. Moreover, they may help to convince both the public and decision makers that each of the currently available measures by itself is insufficient to contain the transmissions of SARS-CoV-2 and that the synergetic effects of multiple protective measures can and have to exploited for efficient mitigation of the pandemic. Even with high and increasing rates of vaccination, other protective measures and synergetic effects should be maintained to prevent, suppress, or break potential and ongoing waves of infection. These aspects and their quantitative description might become even more important, if more transmissible variants and escape mutations of SARS-CoV-2 were to emerge. The challenge we are facing now is not just how to end the pandemic, but also how fast we can do it to save more lives and reduce the probability of further dangerous mutations of SARS-CoV-2.




Fig. 1 Schematic illustration of different transmission pathways and protective measures.




Fig. 2 Effectiveness of individual and combined measures. Reduction of effective reproduction number, R_e , as a function of compliance with different protective measures for a basic reproduction number $R_0 = 5$ approximately reflecting the transmissibility of the Delta variant of SARS-CoV-2. Panels **A** and **B** refer to universal masking with surgical masks and N95/FFP2 masks, respectively. The curve labeled "physical measures" refers to the combination and synergy of universal masking plus distancing and ventilation; the curve labeled "all measures" refers to the combination and synergy of the physical measures with vaccination.




Fig. 3 Effectiveness of masking and distancing & ventilation for different vaccination rates and compliances. Reduction of effective reproduction number, R_e , as a function of compliance with universal masking for different vaccination rates (**A**, **B**) and as a function of compliance with distancing & ventilation for different levels of masking at a fixed vaccination rate of 70% (**C**, **D**). Basic reproduction number $R_0 = 5$; reduced starting values of R_e at zero compliance with masking correspond to different vaccination rates. Left column corresponds to universal masking with surgical masks, right column corresponds to N95/FFP2 masks.




Fig. 4 Effectiveness of testing & isolation for different compliances with masking, vaccination, and distancing & ventilation. Reduction of effective reproduction number, R_e , as a function of testing frequency (number tests per week per person) for different compliances with universal masking and distancing & ventilation, as well as different vaccination rates. Basic reproduction number $R_0 = 5$; reduced starting values of R_e reflect different vaccination rates and compliances with masking and with distancing & ventilation, respectively. Left column corresponds to universal masking with surgical masks, right column corresponds to N95/FFP2 masks.

Supplementary text:

S1. Basic reproduction number and population average infection probability

The COVID-19 pandemic has severe health, economic, and societal effects ¹. The basic reproduction numbers, R_0 , for the ancestral strain of SARS-CoV-2 and Delta variant have been estimated to be ~ 2.9 (2.4–3.4) (Billah et al., 2020)² and ~5.1 (Liu and Rocklöv, 2021)³, respectively. In this study, we used $R_0 = 3$ and 5 to approximate the transmissibility of them, respectively. As the Omicron variant is suspicious to have a higher transmissibility than Delta ⁴⁻⁷, we investigated the scenarios with $R_0 = 8$, 12 and 18. Here, $R_0 = 12$ and 18 approximates highly contagious variants with transmissibilities similar to measles ⁸.

By definition⁹, R_0 , can be linked to the basic population average infection probability, P_0 , by $R_0 = P_0 \cdot c \cdot d$. Here, d represents the average duration of infectiousness, and c represents the average daily number of human contacts. As in Cheng et al. S2. Efficacy of vaccination against SARS-CoV-2 transmission

Based on recent observations, we assume that the probability of SARS-CoV-2 transmission is on average reduced by approx. 70% for vaccinated persons ¹⁹⁻²². In other words, the currently available vaccines are highly protective against the disease and severe outcomes of COVID-19 for both the ancestral strain of SARS-CoV-2, Delta and previous variants ¹⁹⁻²². Their efficacy against the Omicron variant is still under investigation²³. The impact of different vaccination efficacies is illustrated in Fig. S1. Although our results show that vaccinations are currently not sufficient to contain and end the transmission of SARS-CoV-2 without synergetic measures, we are not suggesting to promote the non-pharmaceutical measures without vaccination, which would also be missing the benefit of reducing both the transmission of the virus and the severity of the disease by immunization ^{19-22,24}.

S3. Universal masking: source control, wearer protection, and practical compliance

Masks can prevent infections in two ways: (i) source control, reducing the emission and spread of respiratory viruses through airborne droplets and aerosols, and (ii) wearer protection, reducing the inhalation of airborne respiratory viruses. Surgical and N95/FFP2 masks are highly effective against aerosol transmissions ²⁵, and are even more effective against droplet transmissions because of the higher filtering efficiency of masks against large droplets ^{26,27}.

As explained in the main text, the fractional contribution of droplet transmission through the eyes (eye infection) is described by the parameter x. In Fig. S2, we show how different values of x would affect the results. For our calculations, we assumed an estimate of x = 0.3. Higher values would reduce the differences between surgical and N95/FFP2 masking.

For universal masking, 100% compliance would be difficult to achieve because masking is not always possible and practical, for example at home, during eating or drinking in restaurants and bars, in schools and kindergartens, etc. ^{12,28}. The potential importance of such situations is demonstrated by a recent modeling study attributing around 10% to 40% of daily infections to restaurants and cafés/bars ²⁹. Moreover, a lack of willingness to follow recommendations or mandates for mask use may also lead to low compliance with mask wearing. For example, inpatient respiratory protection studies show that adherence rates vary from 10% to 84% for health care personnel ^{30,31}. Similar effects can be expected when wearing masks with low efficiency or poor fit and high penetration or leakage rates ^{28,32}. Combining these effects, we may estimate ~50% as an effective upper limit for the compliance with universal masking.

S4. Distancing & ventilation

Physical distancing strongly reduces the transmission by droplets (> 0.1 mm), but has much smaller impact on reducing exposure to equilibrated aerosols in indoor environment ^{28,33-35}. By assuming characteristic distances around ~ 0.25 m for close contact, our calculation shows that the mass of large respiratory droplets would decrease by ~88% at a distance of 1 m and by ~95% at a distance of 2 m (Fig. S2). These estimates are consistent with the ~ 60% to 90% effectiveness of physical distancing as reported in the review of Chu et al. ³⁶ based on observations and data for SARS-CoV-1 and MERS ³⁷. Thus, we assume approximately ~90% (upper bound) for the effectiveness of proper physical distancing (> 1-2 m) against droplet transmission.

In contrast to physical distancing, regular ventilation has little effect on direct transmission by ballistic droplets (> 0.1 mm) but reduces indirect transmission by aerosols (< 0.1 mm) in indoor environments both in the near-field and far-field $^{28,33-35,38}$. Changing from passive ventilation to a high ventilation rate (e.g., $12 \, h^{-1}$, as applied in airborne infection isolation rooms) can reduce the airborne virus concentration and probability transmission with an effectiveness up to ~90% 28 , which can be regarded as an approximate upper bound for the effectiveness of ventilation against aerosol transmission 38,39 . Efficient ventilation of classrooms and other indoor environments could be fostered, optimized, and assessed by readily available techniques like exhaust fans, air ducts for displacement ventilation, and CO_2 sensors etc. $^{38-40}$.

The influence of distancing & ventilation on R_e is described by $E_{\text{d\&v}}$. The reason for combining these measures is that each of them influences only one branch of airborne transmission, either droplet transmission (distancing) or aerosol transmission (ventilation). Moreover, the relative contributions of aerosol and droplet transmission in SARS-CoV-2 transmission have not yet been determined conclusively, but they exhibit similar upper limits of effectiveness (~90%). Thus, we assume $E_{\text{d\&v}} \approx 90\%$. In summary, physical distancing by at least 1-2 meters and proper ventilation of indoor environments can decrease the risk of droplet (> 0.1 mm) and aerosol

transmission (< 0.1 mm) in indoor environments by approx. 90%, whereby distancing primarily reduces droplet transmission and ventilation primarily reduces aerosol transmission 28,38,39,41,42 . In our calculations, we assume that the population-average transmission occurs in a virus-limited regime as discussed in Cheng et al. (2021) 28 , which would hold for the range of R_0 and R_e values investigated in this study. Compared to $E_{\rm vacc}$ and $E_{\rm mask}$, the estimated value of $E_{\rm d\&v}$ is subject to larger uncertainties. It should be further tested and validated, e.g., by large-scale randomized control trials, in the future.

S5. Testing & isolation

The influence of testing & isolation on R_e is described by $E_{t\&i}$. The effects of testing & isolation are equivalent to reducing the average duration of infectiousness, d. According to U.S. CDC, "patients with mild-to-moderate COVID-19 remain infectious no longer than 10 days after symptom onset. Most patients with more severe-to-critical illness or those who are severely immunocompromised likely remain infectious no longer than 20 days after symptom onset; however, there have been several reports of severely immune compromised people shedding replication-competent virus beyond 20 days" ¹⁷. For this study, we assumed that d is approximately 10 days ¹⁰ (Supplementary text S1). When applying tests on n days per week, the duration of infectiousness can be effectively reduced to 7/n days, assuming 100% precision of tests and immediate isolation preventing further transmission. Under these conditions, we obtain $E_{t\&i} = (1 - 0.7/n)$. In practice, the frequency of testing has to be adjusted according to the rates of false negative results ⁴³, and the effects of incomplete isolation have to be considered, which may reduce the effectiveness of this measure. The influence of a false negative testing rate f on $E_{t\&i}$ can be described by:

$$E_{t\&i} = 1 - f - 0.7 (1 - f) / n \tag{7}$$

For example, a 20% false negative rate (f = 20%) will reduce the effectiveness of two tests per week (n = 2) from 65% to 52%.

S6. Droplet versus aerosol transmission

To distinguish between aerosol transmission and droplet transmission, medical studies have frequently referred to a diameter of 5 μ m as a boundary between aerosol particles and droplets, whereas in aerosol science, 100 μ m or 0.1 mm are considered as an upper limit to the aerosol size range ^{28,33-35,42,44-46}. Around 0.1 mm, the gravitational settling velocity of particles approaches 1 m s⁻¹ in still air. Droplets larger than 0.1 mm are also called semi-ballistic or ballistic droplets, corresponding to Reynolds numbers larger than 1 or 1000, respectively⁴⁴. They are not floating in the air but falling to the ground in seconds within a 1-2 m radius around the emitting person, approximately following a ballistic trajectory ⁴⁴.

In the physical sciences, particles in the size range of approximately 5 to 100 μ m are still considered aerosols because they remain suspended up to tens of minutes and can float many meters away from the emitter. Aerosol particles with diameters less than 5 μ m can remain

suspended and accumulate over hours before being removed by slow sedimentation or diffusion to the ground and walls of indoor environments.

In aerosol research and air quality monitoring, the boundary between fine and coarse aerosol particles is usually set around 2.5 μ m. Fine particulate matter with diameters up to 2.5 μ m (PM2.5) is known to penetrate deeper into human lungs and cause more severe health effects than coarse particulate matter ⁴⁴⁻⁴⁸. Actually, the air quality boundary of 2.5 μ m approximately coincides with the traditional medical boundary of 5 μ m, because the diameter of respiratory droplets emitted at 100% relative humidity decreases by about one half upon drying in ambient air at typical relative humidities in the range of 30-60%, e.g., from 5 μ m to approx. 2.5 μ m ²⁵. In analogy to atmospheric PM2.5, fine respiratory aerosol particles may also penetrate deeper into the human lungs, and we hypothesize that this might cause more severe infections, which remains to be elucidated.

With regard to the relevance and occurrence of aerosol vs. droplet transmission, the following relations are relevant regardless of the boundary used to distinguish between aerosols and larger droplets (5 μm or 0.1 mm). If the viral load (concentration) in epithelial lining fluids and in respiratory aerosol particles or droplets is small, or if the median infectious dose of the virus is large, then the total volume of respiratory aerosol particles (<5 μm or <0.1 mm) and the virus dose contained in aerosols may be too small to cause substantial infection risks by aerosol transmission. Under such circumstances, only droplets in the larger size ranges (>5 μm or > 0.1 mm) with a large total volume are expected to contribute substantially to the infection probability and virus transmission ("droplet transmission").

Even if the viral load (concentration) in large respiratory droplets may be lower than in small respiratory aerosols due to different origins and enrichment processes in the respiratory tract ²⁵, the size dependence of the particle volume is so strong (diameter to the power of three) that it seems unlikely that virus transmission would proceed only through aerosols and not through larger droplets as well. On the contrary, it seems that aerosol and droplet transmission are likely to go hand in hand. For direct infections in the near-field, droplet transmission is likely to be even more important than aerosol transmission, unless there is an enormous size dependence of viral load (more than three orders of magnitude). Therefore, masking and distancing are important precautions during contacts also outdoors, not just in indoor environments. In practice, the relative importance of aerosol and droplet transmission has not yet been measured and resolved for SARS-CoV-2, regardless of the definition and boundary applied (5 μm or 0.1 mm).

By consistent use of masks, distancing & ventilation as well as testing & isolation, it was possible to contain early variants of SARS-CoV-2 even without vaccination as demonstrated in several Asia-Pacific countries during the years 2020-2021⁴⁹⁻⁵². It will depend on the basic reproduction number of Omicron and further variants whether these measures may suffice or more strict measures like sustained or recurring general contact reductions may be required to mitigate the pandemic and prevent or control future waves of infection.

We suggest that the presented scientific approach, results, and tools can be used to design and communicate efficient strategies to contain the transmission of SARS-CoV-2 in different environments and to mitigate the COVID-19 pandemic. Our quantitative results are consistent

with earlier recommendations $^{53-55}$, and the modeling tools can be used to explore and refine the synergetic effects of combining multiple protective measures as a function of R_0 , compliance, and efficacy of each measure.








Fig. S3 Fraction of remaining respiratory particle volume (aerosols and droplets with diameter up to 1 mm). Assumption: after ejection from the mouth, all respiratory particles move forward at a horizontal speed of 5 m s⁻¹ with the airflow and the horizontal velocity remains constant; the deposition velocity is caused by the gravitational settling and is size dependent. When the vertical settling distance of the particles is < 1.2 m, we considered them as the remaining particles that may infect others.



Reduction of effective reproduction number, R_e , as a function of compliance with different protective measures for a basic reproduction number $R_0 = 8$ (C and D) approximating a variant with higher transmissibility than the delta variant of SARS-CoV-2 and for $R_0 = 3$ (A and B) approximately reflecting the transmissibility of the ancestral strain of SARS-CoV-2, and for $R_0 = 12$ (E and F) and $R_0 = 18$ (G and F) approximating a variant with similar transmissibility of measles. The curve labeled "physical measures" refers to the combination and synergy of universal masking plus distancing and ventilation; the curve labeled "all measures" refers to the combination and synergy of the physical measures with vaccination. 

Reduction of effective reproduction number, R_e , as a function of contact reduction for different compliances with universal masking at a fixed vaccination rate of 70%. Basic reproduction number $R_0 = 5$; reduced starting values of R_e at zero contact reduction reflect the vaccination rate and different levels of masking and distancing & ventilation (30% compliance, panels C and D). Left column corresponds to universal masking with surgical masks, right column corresponds to N95/FFP2 masks.



Similar to Fig. S5, for $R_0 = 8$: reduction of effective reproduction number, R_e , as a function of contact reduction for different compliances with universal masking at a fixed vaccination rate of 70% and 30% compliance of distancing and ventilation (**A** and **B**). In the lower four panels (**C**, **D**, **E** and **F**), we consider the worst scenario when vaccination does not work for a new highly contagious variant (0% vaccination rate). Basic reproduction number $R_0 = 8$; reduced starting values of R_e at zero contact reduction reflect the vaccination rate and different levels of masking and distancing & ventilation. 

Reduction of effective reproduction number, R_e , as a function of compliance with different protective measures and contact reduction for a basic reproduction number $R_0 = 5$ (A and B) approximately reflecting the transmissibility of the delta variant of SARS-CoV-2, for $R_0 = 8$ (C and D) approximating a variant with higher transmissibility than the delta variant, and for $R_0 = 12$ (E and F) and $R_0 = 18$ (G and F) approximating a variant with similar transmissibility of measles. The curve labeled "non-pharmaceutical" refers to the combination and synergy of universal masking, distancing and ventilation and contact reduction; the curve labeled "all measures" refers to the combination and synergy of the non-pharmaceutical measures with vaccination. Left column corresponds to universal masking with surgical masks, right column corresponds to N95/FFP2 masks.



Basic reproduction number $R_0 = 5$ (**A** and **B**) and $R_0 = 8$ (**C** and **D**); reduced starting values of R_e at zero compliance with non-pharmaceutical measures correspond to different vaccination rates. Left column corresponds to universal masking with surgical masks, right column corresponds to N95/FFP2 masks.



Left column corresponds to universal masking with surgical masks, right column corresponds to N95/FFP2 masks.






