Maternal Disrespect and Abuse by Health Care Providers among postpartum women attending Mizan-Tepi University Teaching Hospital, South West Ethiopia

**Abstract** 

**Background**: In Ethiopia, only 48% of all births occur at health facilities. Maternal disrespect and

abuse by health care providers during child birth is one of the main reasons that affect health care

seeking behaviors from health facilities. Thus, this study aims to assess magnitude of maternal

disrespect and abuse during institutional delivery among postpartum women at Mizan -Tepi

University Teaching Hospital (MTUTH), Bench Sheko Zone, South west Ethiopia

**Methods:** Institution-based cross-sectional study design was employed. A total of 409 postpartum

women were enrolled using systematic random sampling technique between Augusts to

September, in 2021. Pré-tested and structured questionnaire used for face-to-face interview. Data

were coded, edited, and analyzed using SPSS version 25. Bivariate and multivariable logistic

regression analyses were done. The presence and strength of association were determined using

AOR with its 95% CI. Variables with P value of less than 0.05 were considered as statistically

significant

Results: About half (52.1%) of the postpartum women experienced at least one category of

maternal disrespect and abuse during institutional delivery. No formal education status during

labor [AOR=2.216; 95% CI:1.266, 3.879], delivery during night shifts [(AOR=2.2; 95% CI: 1.306,

3.772], living in rural area [AOR=3.014;95% CI:1.630,5.572], number of health provider 2-

3[AOR=4.101; 95%CI:2.70,6.23] and number of health provider above three[AOR=8.13;

95%CI:2.12,5.62] were found to be strongly associated with reporting maternal disrespect and

abuse.

Conclusions: The study highlights that large proportion of mothers are experiencing maternal

disrespect and abuse during institutional delivery in this study setting. Thus, appropriate

interventions should be designed, focusing on supervision during night shifts, empowering

childbearing women about their rights at health facilities and providing training for health care

providers about respectful maternity care need to be emphatise.

Background

Disrespectful care is a barrier to pregnant women who get public health care services. Disrespect and abuse in facility-based childbirth include physical abuse, non-dignified care, non-consented care, non-confidential care, discrimination, abandonment of care, and detention in facilities.<sup>1</sup> One of the global agendas in Sustainable Development Goals (SDGs) is reducing maternal mortality to less than 70 per 100,000 live births and ending preventable deaths of newborns and children under 5 years of age at least as low as 12 per 100 live births <sup>2</sup> . An estimated 303,000 maternal and 2.7 million neonatal mortality were occurred globally in 2015(3). Globally, one of the silent contributing factors for maternal morbidity and mortality is disrespect and abuse (D and A). For better maternal care service utilization, it is important to assess the existing prevalence of disrespect and abuse during child birth (4)(5). D & A during childbirth is a strong factor for choice of facility for the next childbirth(1)

Evenghough every region has advanced in maternal care service, the maternal mortality ratio is increasing in sub-Saharan Africa compared (6). By 2030, it is aimed to reduce the global maternal mortality ratio (MMR) to less than 70 and focused on increasing antenatal care (ANC) coverage and facility-based childbirth as a key mechanism to reduce maternal mortality (3).

Ethiopia is one of the countries with the highest maternal mortality ratio in the world. According to the latest (2016) Ethiopian demographic and health survey report, maternal mortality ratio of the country was 353 per 100, 000 live births(5).

The magnitude of Disrespectful and abusive is more seen in many child birth facility settings

particularly for underprivileged populations which violates their human rights and results in

significant hindrance in accessing maternal care services(7). As a result, disrespect and abuse

increases maternal and infant mortality by discouraging women from using facility-based

childbirth (8). The burden of perinatal deaths is increasing now days particularly in developing

country. So, developing the quality of care during childbirth, has been recognized as the most

useful approach for decreasing perinatal death (9). According to Ethiopia Mini Demographic and

Health Survey (EMDHS) 2019, the prevalence of institutional delivery was low (48%)(10).

Disrespect and abuse maternal care affects women's rights to compassionate and respectful

maternity care service utilization and impair their freedom which even leads to death as recognized

by World Health Organization (11). In Ethiopia only 50% of births were attended by health

professional (10). Deny of appropriate labor pain management, respectful care, fear of showing

the body to health professionals, perceived cost of using a health facility during birth are all known

as predisposing factor to low utilization of facility based birth (5)

In Ethiopia, only 48% of all births occur at health facilities. Even though few facilities based

studies were conducted in Ethiopia (12) One of the main factor that affect health care seeking

behaviors during child birth is maternal disrespect and abuse which resulted from health

professional that seen in health facilities. Facilitating and ensuring compassionate and respectful

maternity care services during labor and delivery is one of the most important interventions to

maintain good maternal and newborn outcome.

However, compassionate and respectful maternity care has received much less attention both in

practice and research. The reasons for failing to use skilled services during delivery have been

studied a lot. But there is inadequate research on impact of disrespect and abuse of women during

facility based deliveries that decreasing utilization of maternity services. Currently compassionate

and respectful maternity care during labor and delivery considered as an important component of

health care provider. No study were conducted on prevalence of disrespect and abuse during child

birth and its contributing factor in this setting. Therefore, the main aim of this study was to assess

the magnitude of maternal disrespect and abuse and its associated factors among postpartum

women who gave a birth at health facility.

**Methods and Materials** 

Study design, setting, and participants

This study was conducted in MTUTH which is located in Bench-Sheko Zone of South West

Ethiopia 574km from Addis Ababa, Ethiopia. MTUTH is the only teaching hospital in the zone

which is populated by more than 800,000 people. It also give the service to adjacent zone including

Kaffa, West Omo, Sheka and south part of Gambela region and refuges of South Sudan. The

hospital has four patient wards: medical, surgical, pediatrics and obstetrics and gynecological

wards. The obstetrics and gynecological ward consists of six waiting and fourteen postnatal beds

with three delivery coaches, and two operation rooms' tables. In addition, the ward has a total of

50 staffs (2 Obstetric and gynecologists, 8 general practitioners, 37 midwives, and 105 nurse). The

average number of deliver per year for the hospital reaches around 2490.

Source and study population

All mothers who delivered at MTUTU were source population. All postnatal mothers who were

admitted to postnatal care (PNC) services during the study period considered study population

**Eligibility Criteria** 

All postnatal mothers who received delivery services for their last child birth at the study hospital

and come to postnatal unit for their first postnatal services during the study period were included

for this study. Postnatal mothers who were critically ill, unable to communicate at the time of data

collection, refused to participate in the study, and they come to postnatal unit and those delivered

by caesarian section were excluded.

Sample size determination

The sample size required for this study was determined using a single population proportion

formula considering the assumptions: Proportion of physical abuse (0.16), the woman's right to

information, informed consent, and choice/preferences was not protected (0.58), the woman's

confidentiality and privacy was not protected (0.45), non-dignified care (0.01), Stigma and

discrimination(0.73), the woman was left without care/attention(0.39) and the woman was

detained or confined against her will(0.02) during facility based child birth. These figures were

taken from a previous study conducted in Five health centers of Addis Ababa(13) Level of

confidence 95% and margin of error to be 5% (d = 0.05). The sample size for each form of

disrespect and abuse was calculated as follows:

So, the large sample size 409 was taken in order to include all forms of disrespect and abuse.

### Sampling procedure

In MTUTH the average number of deliveries per month in this hospital was 331 then during the two months of data collection period the number of deliveries was estimated to be a total of 662 deliveries. Systematic sampling technique was used for enrollment of 409 postnatal mothers who will be accessed for their first postnatal care services; by the assumption of: N (the estimated deliveries in two months period in the selected hospital which was s, and n (required minimum sample size = 409 which gives sampling fraction (k) of 2):  $k = N/n = >662/409 = 1.66 \approx 2$  To start data collection, the first two women who was admitted to PNC clinic for their first postnatal services were given numbers 1 or 2 and one of them from postnatal clinic was selected by lottery method to select the first participant (the first sampling unit). Then after every 2nd unit included until the required sample reached

Study variables

**Independent variables** 

Socio-demographic characteristics: Age, residence, income level, occupation, educational status

Obstetric characteristics: Parity, history of antenatal care follow-up, history of previous

institutional delivery, place of birth, type of delivery

Dependent variable

Non respectful and abusive care: Physical abuse, non-consented care, non-confidential care, non-

dignified care discrimination based on specific clients' attributes, abandonment of care and

detention in health facilitie

Data collection tool and procedures and quality

Data on participants' demographic, individual related, obstetric history and provider related was

collected using structured interviewer administrated questionnaire. For the sample participants, the

purpose of the study and importance of participation was informed and verbal consent was ensured.

Based on their willingness to participate in the study, a standardized structured interviewed

questionnaire which is modified contextually was distributed to collect the data by trained four

year regular nursing students.

The quality of data was assured by training of data collectors, further adjustment to the data

collection tool was made after pre-testing with 5% of the sample size or 20 mothers at MTUTH

which was not include in the study to improve clarity, understandability and simplicity of the

message.

All of the questionnaires were checked for completeness and accuracy before, during and after

the period of data collection. The collected data was again reviewed and checked for completeness

before data entry. Data entry format template was prepared and programmed by principal

investigator. Disrespect and abuse during childbirth was measured using 9 performance standards

(categories of disrespect and abuse) and 35 verification criteria according to the new WHO

framework of mistreatment of women during child birth (1)

Data processing, analysis, and interpretation

All the questionnaires were checked for completeness, coded and entered in to Epi Info version

7.1.2.0 and then transported to SPSS version 24 software package further analysis. Descriptive

statistics such as mean, percentage and standard deviation were computed and presented, using

frequencies and proportions for categorical variables, and summarized by mean and standard

deviation for continuous variables. Frequencies of D&A components and subcomponents were

also computed and reported in a table. Bi-variable logistic regression was done to determine the

association between each independent variable and the outcome variables. Variables with a p-

value of less 0.25 were considered candidates for the multivariable analysis to adjust the effect of

confounders on the outcome variables. The degree of association between dependent and

independent variables was determined using the odds ratio with confidence interval of 95% and p

value of 0.05. The second analytical step used a stepwise backward model. The Homer and

Lemeshow goodness-of-fit was applied to test for model fitness.

Ethics approval and consent to participate

This study was conducted in accordance with the Declaration of Helsinki. Ethical clearance

obtained from Mizan-Tepi University research and community support officers. Before this

survey, a formal letter was submitted to administrative office of Hospital .The study's objective,

benefit, and risks were explained to the participants before data collection and obtained written

informed consent from all respondents. The study participants were assured of the attainment of

confidentiality, and the information they give us will not be used for any purpose other than the

study

**Results** 

Background Characteristics of postpartum women attending Mizan-Tepi University

Teaching Hospital, Benchi-Sheko Zone, South West Ethiopia

A total of 409 postpartum women were participated in this study with

response rate of 100%. The average age of the participants was 31.3 years with a minimum and

maximum age of 18 and 40 respectively. Majority of the respondents were 25 to 34 years old.

About 44% of the study participants were from the Bench ethnic group. Approximately 45.7% of

women were followers of Orthodox Christian religion (Table 1).

Obstetric history of the postpartum women attending Mizan-Tepi University Teaching Hospital, Bench-Sheko Zone, South West Ethiopia, 2021

Out Of 409 respondents, 389(95%) had a history of ANC follow-up for their most recent delivery. Majority of the respondents had at least four visits for ANC service. The large proportion of women reported had previous history of institutional delivery for at least one child. Of the total sample, 279(68.2%) of mothers gave birth through spontaneous vaginal delivery. The vast majority, 336(82.2%) of women reported they had given birth preparedness education during ANC follow-up (**Table 2**).

## Magnitude of maternal disrespect and abuse among postpartum during institutional delivery at MTUTH in Bench-Sheko Zone, South West Ethiopia

Of the total sample, half (52.1%) of the postpartum women reported that they have experienced at least one form of Disrespect and Abuse during facility based Childbirth. Based on verification criteria for categories of D and A, we counted mothers who faced at least one condition among the possibilities. Accordingly, the most commonly experienced form of D and A was ineffective communication between maternity care providers and women during labor and delivery213 (52%). (Table 3)

# Factors associated with experiencing maternal Disrespect and Abuse among postpartum women attending Mizan-Tepi University teaching hospital, Benchi-Sheko Zone, South West Ethiopia.

In bivariate analysis, Religion, Occupation, Monthly income, Number of delivery in health facility, Stay in hospital after delivery, Number of health provider attending the delivery, Time of delivery, Sex of main provider conducting the delivery and Involvement in birth plan with provider were found to be significantly associated with maternal disrespect and abuse. After controlling for other factors, religion, educational status and gender of the heath care provider attending delivery were significantly associated with disrespect and abuse. The odds of maternal disrespect and abuse among mothers who gave birth at night shifts were 2.2 times higher than those who delivered at day shifts [AOR=2.21; 95% CI:1.306, 3.772]. The likelihood of reporting disrespect and abuse among mothers who have no formal educational status during labor and delivery were 2.20 times higher than those who can read and write [AOR=2.216; 95% CI:1.266, 3.879]. Similarly, the odds ratio of disrespect and abuse among respondent who lives in rural area were 3.014 times higher than those who were live in urban [AOR=3.014, 95% CI:1.630,5.572] (Table 4).

#### **Discussion**

This study investigated magnitude of maternal disrespect and abuse among postpartum women during facility based child birth in MTUTH. In the present study, overall magnitude of disrespect

and abuse during labor and delivery was found to be high. The manifestation of disrespect and

abuse measured using different entities: Ineffective communication, non-consented care, non-

confidential care, verbal abuse, abandonment/neglected care and physical abuse. The current

finding revealed that magnitude of disrespect and abuse is lower than findings from a study

conducted in Arba Minch town (98.9%) in Ethiopia and Nigeria (98%), Bahir Dar (67.1%) and

Addis Ababa (75.3%) (5,14),

This discrepancy might be due to the difference of study settings. The previous studies include a

hospital and health centers in Ethiopia and Nigerian study at teaching hospital. The current study

also use nine categories of disrespect and abuse to measure its extent. In line with this, ineffective

communication and unacceptable companionship were included which are crucial to respectful

maternity care during labor and delivery. The previous studies used the same definitions for the

categories of disrespect and abuse as the present study, but used fewer items: whereas 35 items

were used in the present study, the studies in Bahir Dar and Addis Ababa used 25, 23 items

respectively (5,14).

According to this study, ineffective communication is the most commonly experienced component

of disrespect and abuse and its prevalence was 52%. This showed that above half of the women

faced poor communication that reflects women's social and cultural needs, where relevant to labor

and childbirth, despite communication being referred to as a core component of respectful

maternity care. This might be due to maternity care providers give less attention to effective communication than other categories of D and A. The most commonly experienced form of ineffective communication was provider did not introduce himself/herself to mother and her companion and greet in respectful manner. This might be due to health care providers that consider respectful greeting is not as such important.

The second commonly reported types of D and A was non confidential care and verbal abuse (51%). This figure was lower than study conducted in Malawi (15). This discrepancy might be due to data collection method. The previous study was from direct observations of labor and delivery. Asking women for agreement is an important measure of showing respect for the laboring mother. In this study, 24% of laboring mother received non-consented care. This might be due to women didn't know they had rights to be asked their consent before any procedures. However, this finding was lower than the same study conducted in Tanzania (16). This inconsistency might be due to difference in health police and implementation program. The statement of the universal rights of childbearing women states that healthcare providers must protect the patient's privacy and confidentiality during any procedure and when handling a woman's information (11). In contrast, this study revealed that 51% of women had been provided care in a non-confidential manner. This could be due to the lack of appropriate physical barriers like curtains at health facilities and/or poor understanding of the importance of confidentiality during childbirth among healthcare providers. This finding is high from the study which was conducted in urban Tanzania and Kenya(17,18). This difference might be due to data collection methods. The previous studies found data from direct observation of mothers during labor and delivery.

According to these findings, the other category of disrespect and abuse experienced by women

was verbal abuse which is similar with non-confidential care (51%). This discrepancy might be

due to fact that there is socio cultural and socio economical difference that affect mothers' behavior

and their reactions during labor and delivery. But, this finding was higher than the study conducted

in Peru (19). This difference might be due to data collection method and study setting.

Similarly the other category of disrespect and abuse reported in this study was

abandonment/neglected care during labor which accounts for24.2 %. This figure is lower than the

study conducted in Kenya to measure disrespect and abuse during facility based child birth using

direct observation(20). The difference may be due to hawthorn effect, in which behavior under

study changes because the actors know they are being observed. This could be due to lack of

empathy by health care providers for continuous caring laboring mothers.

The other category of disrespect and abuse reported in this study was physical abuse which

accounts the prevalence of 12.5 %. This figure is lower than the studies conducted in Nigeria,

Addis Ababa and Bahir Dar, Ethiopia (5,14,21). The discrepancy might be due to good

commitment of health care professionals against physical abuse. This finding is similar with

studies conducted in Pakistan and India on women's experiences of mistreatment during facility

based childbirth (22,23)

The odds of maternal disrespect and abuse among mothers who gave birth at night shifts were

2.2 times higher than those who delivered at day shifts [AOR=2.21; 95% CI:1.306, 3.772 ]. This

finding in line with study conducted in Kenya (17). In line with this, qualitative study conducted

in Ethiopia revealed disrespectful and abusive care were more common during night shifts(4). The

possible justification might be due to workload and dissatisfaction by health care providers.

The likelihood of reporting disrespect and abuse among mothers who have no formal educational

status during labor and delivery were 2.20 times higher than those who can read and write

[AOR=2.216; 95% CI:1.266, 3.879. This finding is higher than the studies conducted in Addis

Ababa and Bahir Dar, Ethiopia (13,21)The discrepancy might be due to women with no formal

The odds ratio of disrespect and abuse among respondent who lives in rural area were 3.014 times

higher than those who were live in urban [AOR=3.014, 95% CI:1.630,5.572] This figure is higher

than the studies conducted in Nigeria, Addis Ababa and Bahir Dar, Ethiopia (5,14,21). The

discrepancy might be due to women who lives in rural area may not get access to health police

and implementation program that support and stand for right of women who delivery at facility

based child birth as well as do not Know the statement of the universal rights of childbearing

women that states healthcare providers must protect the patient's privacy and confidentiality

during any procedure and the right of handling a woman's information confidentially

Low maternal family income status was also a factor for reporting disrespectful care and abuse.

The finding is consistent with study set in Addis Ababa which indicates poor women were more

disrespected and abused than the rich (14). evidence from Kenya reveals the rich women received

care earlier compared to the poor, despite the seriousness of the medical condition(20).

The gender of health care providers was associated with experiencing maternal disrespect and

abuse. The women who gave birth and assisted by female health care provider were more likely to

have had disrespectful care and abuse during labor and delivery.

In the current study, maternal religion was associated with reporting of disrespectful care and

abuse. A mother whose religion was orthodox were more likely disrespected and abused than

those mothers whose religion was protestant. This result agrees with the study conducted in

Tanzania (16). The interpretation of this finding remains very complex and needs further

interpretations. In the present study, duration of Stay in hospital after delivery attended by health

care providers was found to be indictors of experiencing with disrespectful care and abuse[AOR=

11.739 95%.CI (4.284-32.171]. This study agree with that of study conducted in Kenya (17).

The Strengths and Limitations

The study tried to measure nine categories of D and A based on the new WHO framework using

35 verification criteria. So, it reduces underestimate of disrespectful and abusive practices during

childbirth. The study also collected data from first postnatal mother visitors. This it may tackle

information and recall biases. Since study relied on self-report, it does not provide an objective

measure of the frequency of poor and abusive care in facility. The study also not supported by

qualitative study to get information about D and A from community leader prospective and

maternity care user prospective

**Conclusions and recommandations** 

In this study, women receiving labor and delivery care at Mizan Tepi University Teaching Hospital

are experiencing maternal disrespect and abuse to a higher extent suggesting intervention.

Ineffective communication was found as one of the commonest types of disrespectful care at this

Teaching Hospital. Abusive and disrespectful care at this hospital is critical concern, which urges

attention to promote women-friendly care for all women. This maternal disrespect and abuse could

result in low use of health care service which needs immediate measures by health care managers.

This study in general indicates the need for a more integrated intervention including empowering

all women of childbearing age about their rights at this hospital, the economic empowerment of

women, the type of care they deserved and providing training for all health care providers both on

job and during their basic trainings Should be prioritized in order to improve access to medical

services and combat disrespect and abusive care The problame is particularly high among

uneducated women and women who are from rural areas. Women's right to information and

informed consent was the most frequently violated while Stigma and discrimination in hôpital

facilities was reported by none of the respondents. Some of the misconducts might be related dis

satisfaction of staffs and also needs serious attention by the Heath managers of the institutions.

Further research to disclose barriers and facilitators of respectful and dignified maternal care in

accordance to providers and the health system is needed to design and implement effective

interventions to maintain respectful maternity care in area of limited resources
