# A Systematic Review of Datasets to Research the Effect of Policy and Place on Immigrants' Health

# **Abstract**

State and local immigrant policies—which regulate immigrants' rights and access to services and material resources—shape self-rated health and health care access for Hispanic/Latino immigrants. However, due to data limitations, we know little about their impacts on non-Hispanic immigrants or on objective measures of health. To help researchers address these gaps, this systematic review creates a comprehensive resource indexing nationallyrepresentative US datasets that can be used to measure the effects of policy and place on immigrant health. Following PRISMA guidelines, I searched ICPSR and federal data repositories for nationally-representative, population-based, longitudinal or repeated cross-sectional datasets that included health/health care access, race/ethnicity, and state or county of residence. I extracted information about race, ethnicity, migration, language, and geocodes in each dataset for each year, 2005-2021. Data searches (final search December 2021) identified 54 datasets, many of which have never been used to study the effects of policies on immigrant health. These data sources have unexploited potential to advance this literature. For example, longitudinal data sources will allow researchers to examine the effects of policies on the same individuals over time, while datasets with detailed measures of race/ethnicity and migration can be used to distinguish which immigrants are most impacted.

These policies, collectively referred to as immigrant policies, may affect immigrants from all countries of origin, as well as their US-born co-ethnics. They may also shape multiple domains of health and mortality across the lifecourse (3, 16). However, current research is limited in scope with respect to the *health outcomes* and *immigrant populations* studied.

Most population-level research focuses on health care access (7, 8, 17) and single-item measures of self-rated health (11, 12). Because few studies include objective measures of morbidity and mortality (for exceptions, see 4, 5, 13), we do not yet know to what extent immigrant policies have measurable impacts on physical or mental health.

These gaps in our understanding of policy effects are due in part to data limitations. Most research relies on three datasets: the American Community Survey (ACS) (10,17), US birth records (5, 14), and the National Health Interview Survey (NHIS) (6, 12). These datasets are commonly used because they are among the most reliable and accurate sources of data about health and health insurance coverage (23, 24); they provide annual, repeated cross-sectional

Other nationally-representative datasets, such as the Survey of Income and Program

Participation (SIPP), the Early Childhood Longitudinal Study program (ECLS), and the National

Immunization Surveys (NIS) have been underutilized. These sources have unexploited potential

to advance this literature. For example, SIPP measures immigrants' legal status. ECLS and SIPP

provide longitudinal data. Longitudinal datasets are important because repeated cross-sectional

datasets such as ACS and NHIS, which recruit new samples each year, can produce biased

estimates of policy effects if the composition of the sample changes after a policy is

implemented. NIS provides detailed data on vaccination uptake, which is particularly relevant

as COVID-19 has raised concerns about how anti-immigrant policies may reduce vaccine uptake

among marginalized immigrant populations (26).

To understand how immigrant policies impact different immigrant groups, researchers need detailed information about race/ethnicity; country of birth, citizenship, and legal status;

geographic location; and outcomes of interest. However, identifying useful datasets is challenging and time-consuming. Researchers must review documentation spanning years or decades to ensure that sample sizes are adequate, necessary geocodes are available, and key variables are measured consistently over time.

Purpose of this review

The current study creates a comprehensive resource indexing US datasets that can be used to measure the health effects of state and local policies and other contextual factors. In this systematic review, I identify longitudinal and repeated cross-sectional, nationally-representative, individual-level datasets that include geocodes, race/ethnicity, and at least one health-related outcome. This review describes 54 such datasets, many of which have never been used to study the effects of policies on immigrant health.

To help researchers identify datasets in which key variables are measured consistently over time, I describe measures of race, ethnicity, nativity, country of birth, citizenship, language, and geocodes for each year (2005–2021) of each dataset. I also report language(s) of interview for each survey to aid researchers in identifying which immigrant groups may be excluded due to language barriers. Immigrants who are not proficient in English are often socioeconomically disadvantaged and are more likely to have tenuous legal statuses (27). Thus, surveys conducted only in English will exclude the most vulnerable immigrants (28).

This review is a tool for any researcher who seeks to use large, nationally-representative datasets to study the effects of policy and place on immigrant health. By identifying underutilized datasets that measure health, health behaviors, and health care access, this review should greatly increase the speed and scope of questions that can be answered about the effects of place on immigrant health.

## Methods

This systematic review was conducted and reported following PRISMA guidelines (29). I reviewed all datasets listed at healthdata.gov (30), and datasets related to health compiled by the Department of Health and Human Services (31), the Substance Abuse and Mental Health Services Administration (32), and the National Institute on Alcohol Abuse and Alcoholism (33). To identify relevant datasets indexed by Inter-University Consortium for Political and Social Research (ICPSR), I searched the ICPSR website using the keyword "health." I also reviewed all datasets included in ICPSR thematic collections related to children and families, health, disability, aging, and demography (34–43). The initial search was run between January 24 – February 9, 2020, and updated December 29 – January 13, 2021. This systematic review was not registered, and no protocol was published.

In reviewing datasets, I applied the following inclusion criteria: nationally-representative sample of the general population (not a specific disease or public benefits sample); released as person-level data; at least 1,000 respondents per year; at least one measure of health, disability, or health care access; geocodes at the state level or below; and data available (with

health-related outcomes) for at least two years since 2005. I did include datasets without immigration variables because these datasets are useful to researchers who seek to understand how immigrant policies affect broader populations, including racial/ethnic groups with high proportions of immigrants.

First, I reviewed dataset titles and abstracts/project summaries. If a dataset met the inclusion criteria, or if any of the criteria could not be ascertained based on the title and abstract, the dataset was included in the next stage of screening. For these datasets, I reviewed all available documentation, including project websites, codebooks, public-release datasets, and technical documentation, to determine whether each dataset met the inclusion criteria and to extract information from datasets that met the inclusion criteria. If any information could not be ascertained from documentation, I contacted dataset administrators to inquire directly.

The data extraction sheet in Appendix A was used to extract information from data documentation. The primary variables of interest were race, Hispanic ethnicity, nativity (foreign-born vs. US-born), country of birth, citizenship, legal status, language, health-related measures, and geocodes. I compared measures of race/ethnicity in each dataset to guidelines from the Office of Management and Budget (OMB) and US Department of Health and Human Services (HHS) (Table 1), which set standards for data collection in federal data sources (44, 45). I also extracted technical details about the design and administration of each dataset, including information about which racial/ethnic groups were oversampled in each year.

# **Results**

The searches returned 25,511 records (see flow diagram in Figure 1). After removing duplicates and removing studies that did not meet the criteria, 183 unique datasets were identified for further review. Of these, 54 datasets met the inclusion criteria, including 49 interviews (24, 46–93) and five administrative datasets (89, 94–97). Datasets are described in Tables 3–7 and Appendix B. Five datasets did not include all 50 states in every year, but included most states and were representative of included states (48, 50, 74, 75, 81). The remaining datasets included all 50 states and the District of Columbia. Eight included Puerto Rico (49, 50, 52, 59, 94–97), and six included additional US territories (49, 52, 94–97).

Twenty-seven datasets were designed specifically to collect health data, including vital statistics, health, health care, and/or health behaviors (25, 46–58, 74, 75, 81–84, 89, 93–98). The remaining datasets focused on demographics (59), life course trajectories (66–68), housing (61), economics and labor force (60, 62, 64, 85, 90, 91), education (65, 69–72, 92), violence exposure (73, 78, 88), time use (63), public opinion (76, 77, 79, 80), the arts (87), or experiences during the COVID-19 pandemic (86).

Tables 3–7 show the types of health-related outcomes measured in each dataset. Health insurance coverage was the most common health-related measure (25, 46, 47, 49, 50, 52–57, 59, 60, 62, 64–73, 75–77, 79, 81–86, 89–93, 98). Other common measures included: self-rated or parent-rated health (25, 46–51, 53–58, 60, 62, 63, 65–71, 75–77, 80, 81, 83–85, 88–90, 93, 98); physical health (25, 47–50, 52–58, 63, 65–72, 74, 75, 81–86, 88, 89, 93–98); mental health

(25, 47–50, 53–57, 63, 65–72, 74, 75, 77, 78, 81, 83–86, 88, 93); disability (25, 47–50, 53, 54, 57, 59–62, 65–75, 77, 81, 84–90, 92, 93); health behaviors (25, 46–51, 53–58, 63, 65–71, 74, 75, 78, 83, 84, 86, 93, 98); and health care access/utilization (25, 46–50, 52–57, 62, 65–71, 73–76, 79, 81–86, 90, 91, 93–96, 98).

Twenty-seven datasets were repeated cross-sectional (25, 46–52, 54–56, 58, 59, 63, 65, 80, 81, 83, 84, 86–88, 92, 94, 96–98). Twenty-two were longitudinal (53, 57, 60–62, 64, 66–73, 75, 76, 78, 82, 85, 89, 91, 95), with follow-up ranging from a few weeks (76) to over 50 years (85). Five datasets included both longitudinal and cross-sectional components (74, 77, 79, 90, 93). For 24 datasets, data were released annually (25, 49, 50, 52–55, 59, 62–64, 73, 74, 84, 90, 91, 94–97) or more frequently (60, 82, 86, 98). The remaining surveys released data less frequently. Nine surveys have concluded data collection (69–71, 78, 80–82, 89, 91).

Sample sizes in the most recent year of each dataset ranged from 1,646 (78) to 3,747,540 (94). In the most recent year of data collection, fourteen surveys oversampled Black respondents (46–48, 56–58, 63, 65–68, 75, 83, 91), sixteen oversampled Hispanic respondents (46–48, 56, 58, 60, 63, 65–68, 75, 83, 87, 89, 91), and six oversampled Asian respondents (47, 69–72, 80). Most datasets had relatively large samples of White, Black, and Hispanic respondents, but small samples of Asian, Pacific Islander, American Indian, and Alaska Native respondents. Most datasets also had relatively small samples of non-Mexican Hispanic respondents. The exceptions were birth records, death records, and the American Community Survey (ACS), which had very large sample sizes (2,500,000–4,000,000 respondents in the most recent year).

# Race and ethnicity

Tables 3–7 give information about race, ethnicity, nativity, migration, language, and geocodes for the most recent year of each survey. Appendix B provides detailed information about each survey for each year from 2005–2021. In the most recent year, 42 datasets met or exceeded OMB standards for race and ethnicity (25, 46, 49–53, 55–73, 75, 76, 83–92, 94–97). Twenty met or exceeded HHS standards for race (25, 51–53, 55, 57, 59–62, 64, 69, 70, 85, 86, 91, 94–97), and 33 met or exceeded HHS standards for ethnicity (25, 46, 52, 53, 55–57, 59, 60, 62–64, 66, 69, 71, 72, 75–79, 83–87, 89–91, 94–97).

Smaller datasets released limited detail about race and ethnicity to protect participant confidentiality. In many cases, broad racial and ethnic groups were available in public-use data, while more detailed categories were available in restricted-use data. In general, measures of race and ethnicity have become more detailed over time.

### Migration

Two-thirds of datasets included immigration variables. Thirty-five included nativity (25, 46, 47, 52–57, 59–62, 65, 66, 68, 70–73, 75–77, 79, 80, 82–85, 87–89, 91, 92, 97). Twenty-one indicated country of birth (52, 55, 59–62, 66, 68, 70–72, 75, 76, 80, 83, 85, 87–89, 92, 97). Twenty-five provided information about how long the respondent had lived in the US (25, 46, 47, 53, 55–57, 59–62, 65, 66, 68, 70–72, 75, 76, 80, 81, 83, 84, 87, 88). Twenty-three identified

whether the respondent was a US citizen (25, 57, 59–62, 66, 68, 70–73, 75–77, 79–81, 84, 85, 87, 89, 91). Only four indicated legal status for noncitizens (62, 68, 80, 84).

Half of studies included migration variable(s) for one or both parents, typically residential parents of minor children. Twenty-seven released parent nativity (25, 47, 53, 54, 59–62, 65–72, 76, 77, 79, 80, 84, 85, 87, 92, 94–96), 16 released country of birth (59–62, 66, 67, 69–72, 85, 87, 92, 94–96), 12 released how long the parent had lived in the US (25, 47, 53, 54, 59–62, 68, 72, 87, 92), nine released citizenship (25, 57, 59–62, 69, 70, 87), and two released legal status (62, 67).

# Language

Of the 49 surveys, four were conducted only in English (48, 74, 79, 93). Twenty-five collected data in English and Spanish (46, 47, 49–51, 55–58, 63, 65, 72, 75–78, 82–84, 86, 88, 90–92, 98). The remaining surveys used one or more of the following methods to collect data in additional languages: translated written interview/survey documents (70, 80), used professional interpreters by phone or in-person (25, 52, 54, 62, 69, 71, 73), utilized bilingual interviewers (25, 59, 60, 62, 64, 66–68, 70, 80, 81, 85, 87), and/or asked family members or neighbors to interpret (25, 53, 59–62, 64, 73, 87). In accordance with HHS guidelines, 15 datasets included information about English proficiency (46, 48, 53–57, 59, 62, 65, 69–71, 80, 84), and 17 indicated the primary language(s) that respondents spoke at home (46, 47, 53, 54, 57, 59, 62, 65,69–72, 75, 78, 84, 90, 92).

All datasets identified respondents' state of residence. Eighteen identified core-based statistical area (CBSA), metropolitan statistical area (MSA), or city (25, 47, 52, 55, 59, 60, 62, 64–68, 70, 73, 83–85, 87). Thirty-seven identified county (25, 46, 47, 52–56, 59–62, 64–71, 73–77, 79, 81, 85–89, 92, 94–97), and twenty identified zip code (52, 54–56, 58–60, 64, 69–75, 79, 83–85, 88). Over one-third of datasets identified sub-county geocode(s), including census tract (25, 46, 47, 53, 55, 59–62, 64, 65, 70, 71, 73, 75–77, 85, 89), block group (25, 46, 47, 53, 55, 59, 64, 65, 85), block (25, 47, 55, 59, 64, 85), census place (25, 47, 59–62), and latitude / longitude (25, 47).

In most datasets, sub-state geocodes, country of birth, and legal status were available only in restricted-use datasets. Appendix B describes data access and associated fees for restricted-use data.

Impacts of COVID-19 on data collection

In April 2020, the US Census Bureau began the Household Pulse Survey to monitor the social and economic effects of the COVID-19 pandemic. Data about health, education, economic well-being, and COVID-19 diagnoses and vaccines are available for most weeks since April 2020 (86).

The COVID-19 pandemic disrupted data collection for many other surveys. Early in the pandemic, workplaces closed and employees worked remotely from home. Call centers closed, delaying data collection for telephone surveys. The switch to remote work also delayed mailing of surveys and other materials to participants (99).

The pandemic led to higher-than-usual levels of nonresponse bias in the American Community Survey (ACS) and the Current Population Survey (CPS). The Census Bureau cautions researchers that in 2020 ACS data, weighting cannot adequately adjust for nonresponse bias (100).

Nonresponse bias also affects 2020 CPS (101) and Consumer Expenditure Surveys (102) data, to a lesser extent than ACS. In 2020, nonresponse bias led to underrepresentation of low-socioeconomic status, Hispanic, foreign-born, and noncitizen individuals (101). Researchers should expect similar nonresponse bias in other 2020 surveys.

#### Discussion

State and local immigrant policies are associated with self-rated health and health care access for Hispanic families (3). Much remains unknown about how these policies affect non-Hispanic immigrants, or to what extent the policies are associated with objective measures of health. To fill these gaps, researchers need nationally-representative data sources that include a broad range of racial/ethnic and immigrant groups and are collected over a period of years or decades. This systematic review identified 54 such datasets.

over time, in response to OMB and HHS guidelines; (2) nativity was available in two-thirds of

datasets, while country of birth, citizenship, and parent nativity were each available in about

half; (3) most surveys were translated into Spanish, with interviews conducted by Spanish-

speaking interviewers; (4) over two-thirds of the datasets included county and sub-county

geocodes, which will facilitate research on the effects of county/municipal policies; and (5)

almost 75% of datasets included specific measures of physical and/or mental health. Over

recent years, many researchers have gained access to restricted federal data due to the

expansion of Federal Statistical Research Data Centers (FSRDCs) to thirty-one locations

nationwide (103).

The datasets also had some limitations in common. (1) While over one-quarter of data sources

included oversamples of Hispanic and Black respondents, few included Asian oversamples, and

none oversampled foreign-born respondents. As a result, data sources had relatively small

sample-sizes of non-Hispanic immigrants. (2) Only five datasets measured legal status, which

limits researchers' ability to study policy effects on undocumented immigrants. (3) Fewer than

half of surveys were administered in languages other than Spanish, leading to

underrepresentation of immigrants from countries outside the Americas.

Dataset and survey administrators could make several changes to improve the quality of data

available for immigrant populations. First, oversampling of Asian, non-Mexican Hispanic, and/or

foreign-born respondents would provide larger sample sizes for understudied immigrant groups. Second, although professional translation and trained interpreters are costly, these resources should be utilized to improve data collection for immigrants who speak neither English nor Spanish (104). Third, surveys should collect data on country of birth, citizenship, and legal status when possible. Measurement of legal status is important in order to improve our understanding of how policy impacts differ by legal status. However, survey administrators should consider both the risks and benefits of collecting data about immigration status (21, 105).

Some of the datasets can be linked to each other or to additional sources to provide additional individual-level data about participants. For example, NHIS can be linked to MEPS, mortality, Housing and Urban Development, and Medicare and Medicaid data (106). NLSY79 and NLSY Children and Young Adults can be linked so that researchers have detailed longitudinal data about mothers and their children (66, 67). The Census Bureau links individuals over time across different years of Census and administrative data, creating a longitudinal dataset (107). These linked data sources will provide researchers with more detailed and longitudinal data.

Data about immigrants in 2020–2021 surveys may be of lower quality than previous years due to challenges related to the 2020 Census and the COVID-19 pandemic. The Trump administration planned to add a citizenship question to the 2020 Census. Researchers estimated that this would lead to an 8% drop in the response rate for households with noncitizen residents (105). Ultimately, the citizenship question was not included in the Census,

but the Trump administration planned to use other government data sources to identify noncitizens in the Census. This effort was halted by the Biden administration in January, 2021 (108). The COVID-19 pandemic also introduced major challenges for data collection. Many surveys likely had lower-than-usual response rates for low-income, Hispanic, and immigrant individuals. Nonresponse bias may lead to significant challenges for immigration research in 2020–2021.

This review has several limitations. First, I included all data sources in the largest and most commonly-used data repositories; there may be additional datasets not included in these repositories. Second, data sources that do *not* fit the inclusion criteria (e.g., state-specific databases and data aggregated to the state or county level) may be useful for specific research questions. Third, while this review provides a full description of demographic and migration measures over time, I do not provide an exhaustive review of how *health* is measured. Such information is outside the scope of this paper; many of the datasets have dozens or hundreds of health-related measures each year. Finally, some data sources described here are not available for every year; researchers studying short-term effects of policies need annual data.

ACS, NHIS, and birth records remain the largest, longest-running, and most versatile secondary datasets available for researchers to examine the effects of policy and place on health care access, public benefits uptake, and overall health status. However, many other data sources have unique benefits for specific research questions. For example, MEPS-HC includes detailed, longitudinal (2.5-year) data about health care expenditures and can be linked to NHIS (53). ECLS

surveys include directly-measured data on child development (69–71), while NHANES includes biomarkers (47). ECLS (69–71) and NLSY (66–68) are longitudinal surveys with medium- to long-term follow-up of the same individuals. Use of these data sources can help researchers uncover the ways that policy and place affect many physical and mental health outcomes for immigrants from all over the world.


