2	SARSCoV-2 Epidemic Outbreak in Shanghai by Mathematical Modeling

#### 19 Abstract

The COVID-19 Omicron outbreak in Shanghai has been going on for >1 month and 25 20 21 million population is subjected to strict lock-down quarantine. Until now, it is not clear how long this epidemic might end. Here, we present a time-delayed differentiation 22 equation model to evaluate and forecast the spreading trend. Our model provides 23 important parameters such as the average quarantine ratio, the detection interval from 24 being infected to being tested positive, and the spreading coefficient to better 25 understand the omicron progression. After data fitting, we concluded on 11 April that 26 27 the maximum overall number infected in Shanghai would exceed 300,000 on 14 April and the turning point would be in the coming days around 13-15 April, 2022, which is 28 29 perfectly in line with the real-life infection number. Furthermore, the quarantine ratio 30 in Shanghai was found to be greater than 1, supportive of the effectiveness of the strict lockdown policy. Altogether, our mathematical model helps to define how COVID-19 31 epidemic progresses under the Shanghai lock-down unprecedented in human history 32 33 and the Chinese zero tolerance policy.

#### 35 Introduction

The SARS-CoV-2 Omicron variant, reported as a new variant of COVID-19 in November, 2021<sup>1</sup>, has broken out in Shanghai recently. This variant carries mutations to help the virus to resist or escape immunity provided by COVID-19 vaccines <sup>1-3</sup>.To prevent the spread of infection, the local government of Shanghai municipal decided to enforce a practical lockdown on 28 March. However, in the past one and a half weeks,

41	there were still over 20,000 Omicron cases confirmed per day, including both diagnosed
42	and asymptomatic. The situation was quite severe when compared to other places across
43	mainland China during the same period or that in Shanghai several months ago. Here,
44	we propose a new mathematical model to evaluate the epidemic trend of Omicron
45	spreading in Shanghai and make forecasts for the near future.

#### 47 **Results**

The Omicron epidemic in Shanghai has begun since early March, 2022. Until 12
March, the number of confirmed cases per day did not exceed 100 (Extended Data Fig.
1). Due to the surge in COVID-19 positives since mid-March, the Shanghai municipal
government made the practical lockdown decision on March 28 to control the spread.
We obtained a time-delayed differential equation to describe the spreading of

53 COVID-19 Omicron (Fig. 1):

$$\frac{dp(t)}{dt} = k \cdot [p(t) - u \cdot p(t - \tau)]$$

In the above equation, p(t) is the total number of patients infected at timet. The average spreading coefficient k represents the average number of people one unquarantined patient can infect in a unit interval. The average quarantine ratio u is defined as the number of quarantined patients divided by the number of people showing nucleic acid positive at time t. The average detection interval  $\tau$  is the average time interval from being infected to being tested positive.

61 We fitted the data of total number of reported cases before and after 28 March to 62 our equation above, in order to figure out to what extent the more stringent policy could

affect. We found that the fitting between the reported data and the curve calculated from our equation was quite close (**Fig. 2**). We found that, in order to fit the data better, it was needed to alter the parameter  $\tau$  in the two scenarios: i)  $\tau = 2$  (days) before the city lockdown and ii)  $\tau = 1$  (day) after the city lockdown. This can be construed as that the more stringent quarantine policy after the city lockdown, with nucleic acid tests for all citizens once or twice per day, reduced the detection interval  $\tau$ .

In addition, we found that the spreading coefficient k decreased after the city 69 70 lockdown, from 1.63 to 1.49, approximately (Fig. 2). Furthermore, in the early stage of 71 the epidemic, the quarantine ratio u was 1.32 > 1, which means that almost all the patients tested positive as well as their close contacts were quarantined. In the later 72 stage of the epidemic, the quarantine ratio u became smaller, ~1.04. The reduced u73 74 may serve as a sign of the arrival of the turning point. Since p(t), the cumulative number of confirmed cases, is a non-decreasing function, its derivative,  $\frac{dp(t)}{dt}$ , has to be 75 greater than or equal to 0. Therefore, from our equation, u must be smaller than or 76 equal to  $\frac{p(t)}{p(t-\tau)}$ . At the beginning of the epidemic, Omicron was spreading quickly, 77 p(t) was much larger than  $p(t-\tau)$ , so u was relatively bigger. When the turning 78 point was getting close, Omicron spreading was slowed down, thus p(t) was not much 79 different from  $p(t-\tau)$ ,  $\frac{p(t)}{p(t-\tau)}$  was close to 1, which made the quarantine ratio u 80 smaller than that in the early stage of the epidemic. 81

With the three parameters estimated, the trend of Omicron spreading in the near future was predicted. We concluded that there will be more than 300,000 people infected in Shanghai during this Omicron outbreak (**Fig. 3a**). Most importantly, we

predicted that the number of confirmed cases per day would start to decrease around
April 13 (Fig. 3b), which was the so-called turning point.

- We found that the average detection interval  $\tau$  was 1 or 2 days when fitting the 87 known data, which means that, there would be 1 to 2 days of delay from infection to 88 showing positive in the nucleic acid test, during which time the unnoticed patients were 89 still infectious<sup>4-6</sup>. We believe that this is one of the major reasons why Omicron spread 90 rapidly. Furthermore, the average quarantine ratio u was found to be greater than 1, 91 which means that most of the infected patients and their close contacts had been 92 93 quarantined, indicating that the lockdown and other stringent policies were effective, making appearance of the turning point and quelling the epidemic possible. 94
- Moreover, the apparent R0 value, which is the number of people a patient could infect, could be obtained by multiplying the spreading coefficient k and the detection interval  $\tau$ . After the lockdown, the value of R0 dropped from 3.27 to 1.49, providing further supporting evidence for the effectiveness of the lockdown.
- We finished the forecast on April 10. Before our manuscript is submitted, the numbers of daily infected patients before April 17 were collected to check our prediction (**Supplementary Table 2**). Strikingly, it turned out that the real turning point indeed appeared on 13 April, showing exact concordance with our prediction.

### 104 **Discussion**

105 The sudden Omicron epidemic outbreak in Shanghai has brought panic to the 106 public, and great loss to business. In order to evaluate and forecast the spreading trend

based on available confirmed data, we proposed a novel mathematical model, which 107 took the Chinese government policy (such as frequent nucleic acid tests and isolating 108 109 those showing nucleic acid positive as well as their close contacts) into account, which could provide us important parameters describing the Omicron epidemic such as the 110 spreading coefficient k, the quarantine ratio u, and the detection interval  $\tau$ . The 111 predicted number of overall cases and the expected time of turning point may help the 112 government to make judgment on the spreading and to revise the policies accordingly. 113 Although our mathematical model is forged based on China's anti-epidemic 114 115 strategies which rely heavily on quarantine, it is also applicable to other countries (including western countries) in the world. Compared to western countries relying on 116 the formation of herd immunity and mRNA vaccines which reduce the average 117 118 spreading coefficient k, China attempts to boost the average quarantine ratio u to get the epidemic under control. 119 Our model is easy to be applied to describe the spreading of other epidemic diseases, 120 121 and can help the society to avoid panic and build up confidence to fight against COVID-

122 19. For example, the Guangzhou city was the latest metropolitan city in China that 123 declared city-wise lockdown on Apr 11. We believe that our mathematical model 124 presented in this report would help the public to have a better grasp of the current 125 pandemic spread, and would undoubtedly instill confidence and calm that are urgently 126 needed in the caught-up fight of COVID-19 in China.

#### 128 Materials and methods

#### 129 Data used in modeling

130 The case numbers were collected manually from officially released reports131 (Supplementary Table 1).

#### 133 Mathematical modeling

First, a differential equation was deducted to describe the spreading of COVID-19 as following. Let us denote s(t) as the number of people whose nucleic acid tests are positive, then

137 
$$s(t) = p(t - \tau)$$

in which p(t) is the total number of patients infected at time t, and  $\tau$  is the time interval from being infected to being tested positive. Since the patients infected during the time  $\tau$  will not be recorded as nucleic acid positive, the diagnosed or recorded patients (s(t) above) at time t is equal to the number of infected population at time  $t - \tau$ .

143 During the time dt, the number of newly infected patients dp(t) is

144 
$$dp(t) = k \cdot f(t) \cdot dt$$

Where k is the spreading coefficient representing the average number of people one unquarantined patient can infect in a unit interval, and f(t) is the number of unquarantined patients at time t. f(t) is equal to p(t) subtracted by the number of quarantined patients q(t):

$$f(t) = p(t) - q(t)$$

150 We further assume that q(t) (including both nucleic acid positive patients and their

151 close contacts) is proportional to s(t), and let u be the average quarantine ratio:

152 
$$q(t) = u \cdot s(t) = u \cdot p(t - \tau)$$

153 Therefore, we get the final differential equation:

154 
$$\frac{dp(t)}{dt} = k \cdot f(t) = k \cdot [p(t) - q(t)] = k \cdot [p(t) - u \cdot p(t - \tau)]$$

In this equation, there are three unknown parameters: the average spreading coefficient k, the average quarantine ratio u, and the average detection interval  $\tau$ . These parameters may vary during different periods, *e.g.*, before or after the city lockdown. Using the number of reported cases during a particular time in Shanghai, these three parameters can be estimated by data fitting. As a next step, we could forecast the trend of Omicron spreading in Shanghai with these estimated parameters.

#### 162 Additional information

This manuscript/model submitted on-line 163 was to preprint server (https://www.medrxiv.org) on 12 Apr (using infection data available up to 11 Apr). Now, 164 165 on the eve of our latest submission to Nature on 19 Apr, we can check the real-life infection against our prediction. As shown in Supplementary Table 2 and Fig. 4, the 166 actual turning point is on 13 Apr and the date when the total infection number exceeded 167 300,000 is on 14 Apr, perfect matches to our mathematical description/prediction. 168

222	The actual and predicted turning point were represented by the vertical dashed line
223	and the rectangle above the curves.




Fig. 1 Jiding wet not compared by preprint doi: https://doi.org/10.1101/2022.04.13.22273788; this version posted April 27, 2022. The copyright holder for this preprint for this preprint for this preprint in perpetuity. It is made available under a CC-BY-ND 4.0 International license .


# Fig. 2 Jiang et al. 2022




The number of COVID-19 cases detected in Shanghai before lockdown

The number of COVID-19 cases detected in Shanghai after lockdown













Fig. 3 Jiang et al. 2022
