

1 Enterprise healthcare physician services in Canada: an environmental

Abstract

Background: Employers in Canada are increasingly offering physician services to their employees, often through third party workplace “enterprise healthcare” platforms. To date however, little work has been done to understand this method of organizing and delivering care.

Objective: To understand the nature, extent and implications of enterprise healthcare physician services in Canada.

Methods: We conducted structured internet and database searches to identify enterprise healthcare platforms that provided physician services and their public websites. To answer our research question, We extracted data from company websites and linked company documents as well as information from Mergent Intellect, a web-based application with business data on Canadian companies.

Results: We identified nine companies offering enterprise physician services to employees in Canada via 11 enterprise software platforms. According to company claims, over four million Canadian employees and their family members have access to enterprise physician services. All platforms offer virtual physician services and five also facilitate in person visits. Ten of the platforms provide primary care services and one offers only addiction medicine services. Four of the platforms offer to communicate and share information with an employee’s regular primary care provider. Five state they share aggregate or de-identified health data with employers.

Conclusions: Enterprise healthcare companies provide millions of Canadian employees and their families with rapid access to virtual physician services and, in some cases, in person care. These services may disrupt continuity of care (care by the same provider over time) and pose risks to employee privacy. As other Canadians do not have access to these services, enterprise healthcare is also introducing two-tiered healthcare across Canada potentially affecting the sustainability of the public healthcare system.

61 Introduction

62 Employers in Canada are increasingly offering physician services to their employees, typically
63 through a third party company (1–5). The third party companies enable virtual physician
64 services through a workplace “enterprise healthcare” platform (Box 1). Some also facilitate in
65 person physician care through the platforms (6). The companies claim the enterprise platforms
66 improve access to care, leading to lower rates of employee absenteeism (7,8) and a good return
67 on investment for employers (7–9). Some enterprise healthcare companies may share de-
68 identified employee health data with employers (10–12). The companies state that data sharing
69 allows employers to evaluate the health services they provide and identify ways to reduce
70 employee absenteeism. Data sharing, however, also has implications for employee privacy and
71 autonomy.

72
73 Enterprise healthcare differs from the traditional model of healthcare in Canada where most
74 people receive care from self-employed physicians working independently or in small groups in
75 community clinics (13). These physicians either bill the provincial/territorial single-payer public
76 health system – known as “Medicare” – or, much less commonly, bill patients directly (14–16).
77 Until recently, these physicians, working in the traditional model of care, rarely provided virtual
78 care; only three percent of Canadians reported a virtual care physician visit in 2018 (17). With
79 the onset of the Covid-19 pandemic, and the introduction of public funding for virtual care,
80 more physicians started offering these services (18). In the province of Ontario, for example,
81 virtual care visits increased 56-fold to comprise over 70% of all visits between March 2020 and
82 July 2020 (19).

83
84 Despite the apparent widespread access to enterprise healthcare in Canada, little work has
85 been done to understand the extent and nature of this method of organizing and delivering
86 physician services, nor the implications for employees and for the health system. Our research
87 objective, therefore, was to gain an understanding of the nature, extent and implications of
88 enterprise healthcare in Canada through a national environmental scan.

89 Box 1. Terms used in the article

Virtual care (Telemedicine)	Any interaction between patients and/or members of their circle of care (e.g. physicians, nurses), occurring remotely, using any forms of communication or information technologies with the aim of facilitating or maximizing the quality and effectiveness of patient care (20)
Enterprise healthcare	A method of delivering healthcare to employees, on behalf of the employer, using a third party’s proprietary software platform
Enterprise healthcare companies	The third-party companies contracted to provide enterprise healthcare services to employees, on behalf of employers

93 Methods

94 We conducted structured internet searches between December 3rd, 2021 and April 1st, 2022 to
95 identify enterprise platforms that provide physician services to company employees in Canada.
96 The search terms used consisted of terms pertaining to the topic areas of virtual care, Canada,

97 and enterprise. We ran each of the searches individually and examined the first 50 results
98 looking for relevant findings. We compared our findings to a list we compiled when conducting
99 a previous research study examining direct-to-patient virtual care in Canada to ensure our
100 search terms were identifying all relevant platforms. We then identified the company that
101 owned the platform.

102

103 [Inclusion/exclusion criteria](#)

104 We included platforms if the company could be contracted by an employer to provide physician
105 healthcare services through a proprietary software platform to employees living in Canada. We
106 only included companies that provided physician services as these historically are part of
107 Canadian Medicare, whereas many other clinical services (e.g., counseling) are not. We
108 included companies with platforms that provided physician visits through both synchronous
109 (e.g., phone calls, video chat, in person) and asynchronous communication (e.g., text
110 communication). We excluded companies if they provided services solely to employees living
111 outside of Canada or if they offered only non-physician services. We only included companies
112 with platforms using the English language.

113

114 [Identification of documents](#)

115 For each enterprise healthcare platform we included, we identified the platform's public
116 website and any linked websites or documents. We also searched Mergent Intellect, a publicly
117 accessible, web-based application offering business data for a collection of US and Canadian
118 private and public corporations (21). This database contains basic company information, as well
119 as financial, industry, and executive details for over 1.6 million Canadian businesses. It offers
120 information on corporate structures, including a list of key executives and a complete company
121 family tree.

123 [Data extraction and analysis](#)

124 We extracted information on the company's corporate structure, company headquarters,
125 countries of operation, ownership (publicly-traded or privately held), communication mode(s)
126 (e.g., in person, text, phone, or video), primary care physician services, specialist services,
127 payment for physician services (private or public), in person services, system navigator services,
128 family coverage for services, sharing of data with employers and information on
129 communication with an employee's regular primary care provider. Where available, we also
130 collected information on company claims about number of Canadian enterprise clients
131 (employers) and number of enterprise members (employees and their family members) in
132 Canada.

134 [Ethics](#)

135 As we only used publicly available documents, we received a research ethics board exemption
136 from Women's College Hospital.

138 [Results](#)

139

140 We identified 11 enterprise healthcare platforms offering physician services to employees in
 141 Canada. These enterprise care companies claim to provide services to more than 44,000
 142 companies and 4.5 million employees and their family members (Table 1). Seven of the 11
 143 companies are publicly-traded. Ten companies are based in Canada and one in the U.S. (Table
 144 2). All companies offer virtual care physician services and five also arrange in person visits
 145 through their platform. Ten companies offer primary care and one company offers only
 146 addiction physician services. Seven provide coordinated access to specialist appointments and
 147 six provide a system navigator to help employees navigate the health system. Four platforms
 148 offer to provide information to an employee’s regular primary care provider and five state they
 149 provide employers with aggregate or de-identified employee health information.

160 Discussion

161 Our environmental scan provides insight into enterprise physician services in Canada.

162 Enterprise healthcare companies provide millions of Canadian employees and their families
163 with rapid access to virtual physician services and, in some cases, in person care. These services
164 may disrupt continuity of care (care by the same provider over time) and pose risks to
165 employee privacy. Further, as many people living in Canada do not have access to these
166 services, the model is also introducing two-tiered healthcare broadly across Canada. This is
167 likely to increase disparities in care and costs to the public health system.

168

169 Our analysis indicates that some employees may experience disruptions to continuity of care.

170 Less than half of the platforms enable in-person physician visits, implying patients are expected
171 to seek care from their regular care provider or the emergency department for complicated
172 issues. As a result, employees are likely to experience a disruption to continuity of care (care by
173 the same provider over time), a challenge for effective management of chronic and complex
174 health conditions (6).

175

176 As some of these enterprise care companies state they share de-identified or aggregate patient
177 data with employers and/or third parties, this method of delivering healthcare may present
178 additional risks to employees. Although the risk of re-identification, is likely to be low if the
179 data are de-identified or aggregated (1,22), sharing data with employers can enable other
180 privacy-related harms such as surveillance and discrimination. For example, the data can be
181 used to identify the characteristics of employees who are likely to have complex health
182 conditions or who may have a high-risk pregnancy (10–12,23). Companies may use this
183 information to improve services for these types of employees. They may also, however, use this
184 information in job recruitment algorithms to ensure these individuals are not offered
185 employment in the first place (24–26).

186

187 Enterprise healthcare is also introducing a two-tiered system, where millions of employees and
188 family members have access to physician services not available to other Canadians. This may
189 worsen health disparities. Employees of larger companies are often from a higher socio-
190 economic stratum than other people living in Canada, and part of a group that already has
191 better access to care (13), and better health outcomes (21–24). Further, studies show that a
192 two-tiered system is likely to increase wait-times for those in the public system by luring
193 physicians and other healthcare providers to the enterprise system (27–29).

194

195 Finally, enterprise healthcare may lead to “cream-skimming” (30,31). As mentioned above,
196 many enterprise platforms do not offer in person assessments meaning that physicians working
197 for these platforms can only treat simple medical problems. Patients who have complicated

198 health issues are shunted to the emergency department or back to their regular primary care
199 provider (28,32,33). This may increase the burden on the public health system (30,31). Recent
200 research supports this concern. A Canadian study found that patients who had a virtual care
201 visit with a commercial virtual care platform were more likely to have an emergency
202 department visit than those who had a virtual care visit with their regular primary care provider
203 (18).

205 [Limitations](#)

206 Our study is limited by the fact that we relied on company documents to answer our research
207 questions. Additionally, we were not able to find information on whether physician services
208 were billed to the public system, or if companies paid for these services privately.

210 [Conclusion](#)

211 Enterprise healthcare seeks to provide employees with rapid access to physician services. This
212 method of organizing and delivering care, however, may also expose employees to harms, as
213 well as pose threats to the sustainability of the public healthcare systems in Canada. More
214 research is needed to further explore this method of delivering and funding physician services
215 in Canada including how the system functions economically, who the system benefits and the
216 implications for employees, other people in Canada and the publicly-funded health systems.
