Title: Pulmonary function among rural residents in high air pollution area in northern Thailand

Abstract

Background: Air pollution has become a serious environmental and health issue in several countries. This condition leads to respiratory diseases, particularly asthma and chronic obstructive pulmonary disease (COPD). This study aimed to determine pulmonary functions and prevalence of respiratory diseases among rural residents in an area in northern Thailand with a high concentration of air pollution.

Methods: A cross-sectional study was conducted in people aged 18 years or older, living in Lamphun, Thailand in December 2021. Demographics, pre-existing diseases, respiratory symptoms, and pulmonary functions by spirometry including forced vital capacity (FVC), forced expiratory volume in one second (FEV_1), peak expiration flow (PEF), forced expiration flow rate at 25-75% of FVC (FEF_{25-75}), and bronchodilator responsiveness (BDR; FEV_1 improvement after BDR test $>12\%$ and 200 mL) were collected.

Results: A total of 127 people (78.7% male) were included. Mean age was 43.76 ± 11.32 years. Smoking was 52.0% and 4.44 ± 5.45 pack-years. Self-reported respiratory diseases were allergic rhinitis (7.1%), asthma (0.8%), and COPD (0.8%). Respiratory symptoms were presented in 33.1% (14.2% runny nose, 10.2% nasal obstruction, 9.4% cough, 7.9% sputum production, and 6.3% breathlessness). Lung functions showed FVC in $96.74 \pm 12.91\%$, FEV_1 in $97.52 \pm 12.99\%$, PEF in $102.46 \pm 19.18\%$, and FEF_{25-75} in $96.77 \pm 29.88\%$. Abnormal lung functions were found in 15.7%. Small airway disease ($FEF_{25-75} < 65\%$) was 7.1%. Restrictive defect ($FVC < 80\%$) was 6.3%. Airway obstruction ($FEV_1/FVC < 70\%$) was 2.4%. There was no BDR. Compared to people with normal lung functions, the abnormal lung function group was older (48.00 ± 8.68 years vs 42.96 ± 11.61 years, $P=0.036$), and had a higher proportion of breathlessness (20.0% vs 3.7%, $P=0.021$).

Conclusions: Abnormal pulmonary functions, especially small airway disease, were relatively common in rural residents in a polluted air area in northern Thailand. These abnormal pulmonary functions were associated with more respiratory symptoms.

Introduction

The problem of air pollution has become a serious environmental and health issue in many countries, including Thailand [1-3]. There are several small particles of air pollution, including sulfur dioxide (SO₂), nitrogen dioxide (NO₂), carbon monoxide (CO), ozone (O₃), and particulate matter (PM), particularly fine particulate matter (PM_{2.5}) and coarse particulate matter (PM₁₀) [4, 5]. These are related to health problems such as increased mortality rate from lung cancer and cardiopulmonary disease [6, 7], and increased risk of respiratory diseases, especially chronic obstructive pulmonary disease (COPD) [4, 8], some interstitial lung diseases [9], asthma [10-13], and asthma exacerbation [14, 15]. Moreover, air pollution leads to decreased pulmonary functions [16-18], restricted activities [19], and increased respiratory symptoms, e.g., cough, sputum production, wheeze, breathlessness, and chest tightness [19].

Lamphun is a small province in northern Thailand that has been affected by air pollution because it is surrounded by mountains [20]. Especially in the summer season, air pollution is the main issue because low airflow causes accumulation of air pollutants. For the past 10 years, this problem in Lamphun has been monitored and found to be over the limit. Air pollution concentration exceeded the standard concentration level every dry season which affected human health [1]. However, pulmonary function data of people living in this area has been limited. Therefore, the objective of this study was to determine pulmonary functions and prevalence of respiratory diseases among rural residents in an area in northern Thailand with highly polluted air.

Methods

Study design and participants

A cross-sectional study was conducted at Li district, Lamphun in Thailand in December 2021. People aged 18 years or older and able to communicate in Thai were included in this study. Exclusion criteria were recent unstable angina or myocardial infarction, pulmonary embolus, resting heart rate more than 120 beats per minute, systolic blood pressure more than 180 mmHg or/and diastolic blood pressure more than 100 mmHg, inability to perform spirometry, and positive results of rapid antigen testing for SARS-CoV-2.

Ethic approval was obtained from the Human Research Ethics Committee of Thammasat University (Faculty of Medicine), Thailand (IRB No. MTU-EC-IM-6-295/64, COA No. 302/2021), in compliance with Declaration of Helsinki, The Belmont Report, CIOMS Guidelines and The International Practice (ICH-GCP). All methods were performed in accordance with these guidelines and regulations. All participants provided written informed consent.

Procedures and outcomes

Demographic data, pre-existing diseases, respiratory symptoms, and pulmonary functions by spirometry including forced vital capacity (FVC), forced expiratory volume in one second (FEV_1), peak expiration flow (PEF), forced expiration flow rate at 25-75% of FVC (FEF_{25-75}), and bronchodilator responsiveness (BDR) were collected. Spirometry was performed according to the American Thoracic Society and European Respiratory Society guidelines [21-23] using PC spirometer (Vyntus SPIRO, Vyaire Medical, Inc., Mettawa, IL, USA). Briefly, participants were asked to blow into the tube hard and fast and then to continue exhaling for 15 seconds or more. FVC, FEV_1 , FEV_1/FVC , PEF and FEF_{25-75} were recorded and reported in liters (L), %predicted, %, or liters per second (L/s). BDR testing was done using salbutamol inhalation (total dose of 400 μ g) and repeating spirometry 15 minutes later according to the American Thoracic Society and European Respiratory Society guidelines [21-23].

Abnormal lung functions were defined as airway obstruction ($FEV_1/FVC < 70\%$), restrictive lung disease ($FVC < 80\%$), small airway disease ($FEF_{25-75} < 65\%$), or BDR (FEV_1 improvement after BDR test $> 12\%$ and 200 mL).

Statistical analysis

In a previous study [24], the prevalence of airway obstruction in subjects living in an outdoor air pollution area in India was 24.9%. Our sample size was calculated using 80% power, 5% type I error, and 8% precision margin. Thus, the sample size would be 113.

Categorical data was shown as number (%). Continuous data was shown as mean \pm standard deviation. Chi-squared test was used to compare categorical variables between two groups. Student's t-test was used to compare continuous variables between two groups. A two-sided p-value < 0.05 was considered statistically significant. Statistical analyses were performed using SPSS version 26.0 software.

Results

A total of 140 subjects were screened. Of these, 127 were included in the study and 23 were excluded (Figure 1). 78.7% was male. Mean age was 43.76 ± 11.32 years. Current or former smokers comprised 52.0% and 4.44 ± 5.45 pack-years. The most common occupation was government officer (45.7%). Biomass fuel was used for 51.2% of cooking. Allergic rhinitis (7.1%) was the most common self-reported respiratory disease. Runny nose (14.2%) was the most common presenting respiratory symptom (Table 1).

Abnormal lung functions were found in 15.7% of subjects. Airway obstruction was 2.4%. Restrictive defect was 6.3%. Small airway disease was 7.1%. There was no BDR (Table 2). Compared to people with normal lung functions, the abnormal lung function group was significantly older, and had a higher proportion of breathlessness (Table 3). The dataset of study participants is shown in S1 File.

Discussion

This study is the first study of pulmonary function and prevalence of respiratory diseases in a high air pollution area in northern Thailand. Abnormal lung function was found in 15.7% of subjects. The most common abnormality was small airway disease (7.1%). Airway

obstruction was found in only 2.4% of the subjects in our study, which is 10-fold less than the prevalence in people living in an outdoor air pollution area in northern India (24.9%), according to a study by Kumar R and colleagues [24]. Those findings might be because air pollution levels, particularly PM_{2.5}, are significantly higher in northern India than in northern Thailand. High PM_{2.5} concentration in northern India is a major problem, which is associated with social disadvantages [25]. The main source of PM_{2.5} in India is the post-harvest agricultural fire activity [26].

The north of Thailand is faced with high air pollution because the natural geographical features of this area are mountains and basin pan areas [27]. Forest fires and the burning of agricultural waste are common causes of air pollution in this area [2, 28, 29]. Additionally, pollution might blow in from neighboring countries as transboundary pollution [29]. These sources all contribute to the accumulation of pollutants [1, 29, 30]. It usually from late winter to early spring because the weather is calm and dry [1, 4, 29]. Small air pollutants cannot float to the atmosphere, so they accumulate in this condition.

The Pollution Control Department, Thailand, reported that in 2021, the year of our study, the mean PM_{2.5} level across the country was 35.11 µg/m³ (range in 2 to 128 µg/m³) while the mean PM₁₀ level was 47.28 µg/m³ (range in 10 to 152 µg/m³) [31]. These levels are higher than the World Health Organization's recommended annual average PM_{2.5} and PM₁₀ concentrations of 5.0 and 15 µg/m³, respectively [5]. The results of our study indicate that air pollution affects the health of residents in northern Thailand.

Numerous pollutants, especially PM_{2.5} and PM₁₀, are associated with health problems. Several previous studies found that PM_{2.5} led to decreased pulmonary functions (FVC, FEV₁ and maximal mid-expiratory flow) [32, 33], increased risk of respiratory diseases and symptoms [34], airway inflammation, and lung fibrosis [35-37]. Decreased maximal mid-expiratory flow,

or $FEF_{25-75} < 65\%$, a small airway disease, was a common abnormal pulmonary function in our study (7.1%).

A large study from results of the population-based UK Biobank study by Doiron D and colleagues showed that ambient air pollution was associated with lower lung functions (FVC and FEV_1) and increased COPD prevalence especially high concentrations of $PM_{2.5}$, PM_{10} and NO_2 [38]. Furthermore, the study of air pollution from forest fire in northern California, the United States, by Reid CE and workers revealed that every $5 \mu\text{g}/\text{m}^3$ increase in $PM_{2.5}$ increased the risk of asthma exacerbation requiring hospitalization (relative risk of 1.07) or emergency department (ED) visits (relative risk of 1.06), or COPD exacerbation with ED visits (relative risk of 1.02) [39].

A systematic review of acute outdoor air pollution on PEF in patients with asthma by Edginton S and coworkers showed that each $10 \mu\text{g}/\text{m}^3$ increase in acute exposure to PM_{10} and $PM_{2.5}$ was associated with a decrease in PEF of 0.25 L/min in adults with asthma, particularly among non-smokers [40]. In addition, every $10 \mu\text{g}/\text{m}^3$ increase in $PM_{2.5}$ increased the risk of COPD exacerbation requiring ED visits or hospitalizations by 2.5% [41].

A systematic review of short-term exposure to air pollution by Achilleos S and colleagues showed that every $10 \mu\text{g}/\text{m}^3$ increase in $PM_{2.5}$ increased mortality rates from all causes by 0.89%, cardiovascular diseases by 0.80%, and respiratory diseases by 1.10% [42]. Moreover, several studies of long-term exposure to ambient air pollution showed every $10 \mu\text{g}/\text{m}^3$ increase in $PM_{2.5}$ increased mortality rates from all causes by 4-6% [43, 44], cardiac diseases by 11-14% [44, 45], and lung cancer by 8-21% [43, 45], and it decreased pulmonary function (decline of FEV_1 in 3.38 mL per increase $10 \mu\text{g}/\text{m}^3$ of PM_{10}) [46].

Our study found that the prevalence of abnormal lung function was not very high, probably because the mean age of participants was only 43 years and the associated risk factor smoking only 4.4 pack-years. These findings are similar to a study of lung functions among

university athletes by Saiphoklang N and coworkers, which showed that young athletes who smoked very lightly had good lung functions [47].

Our study showed that subjects with abnormal lung functions were significantly older than those with normal lung functions. This finding indicates that older age and long-term exposure to air pollutants might be risk factors for lung diseases, particularly COPD, which is similar to findings of some other studies [48, 49]. Moreover, our study also showed that abnormal lung functions were associated with breathlessness.

Interestingly, a study of children (median age of 7.7 years) with long-term exposure to air pollution by Rice MB and colleagues showed that this situation, particularly living less than 100 m from a major roadway, was associated with lower lung function in terms of FVC particularly living less than 100 m from a major roadway [50]. However, the mechanism of pollution-induced lung damage is unclear. Some studies suggested that PM_{2.5} and PM₁₀ might produce adverse effects on the respiratory system via the generation of reactive oxygen species [35, 36] lead to airway inflammation and changes in pulmonary function [36].

There are the limitations of this study. Firstly, because of the small population size, some results might not be obviously different between the abnormal and normal lung function groups. Secondly, our study is a cross-sectional study. Subjects were not followed up in long-term to monitor lung functions and respiratory symptoms. Therefore, we cannot predict the changes of symptoms and lung function in the future. However, our study showed a negative trend of obstructive defect. Large prospective studies are required to evaluate lung functions and long-term clinical outcomes in respiratory diseases in northern Thailand.

Conclusions

Abnormal pulmonary functions, especially small airway disease, were relatively common in rural residents in an air pollution area in northern Thailand. These abnormal

pulmonary functions were associated with more respiratory symptoms, particularly breathlessness. Large prospective studies are needed to investigate lung functions and long-term clinical outcomes in respiratory diseases in this area.

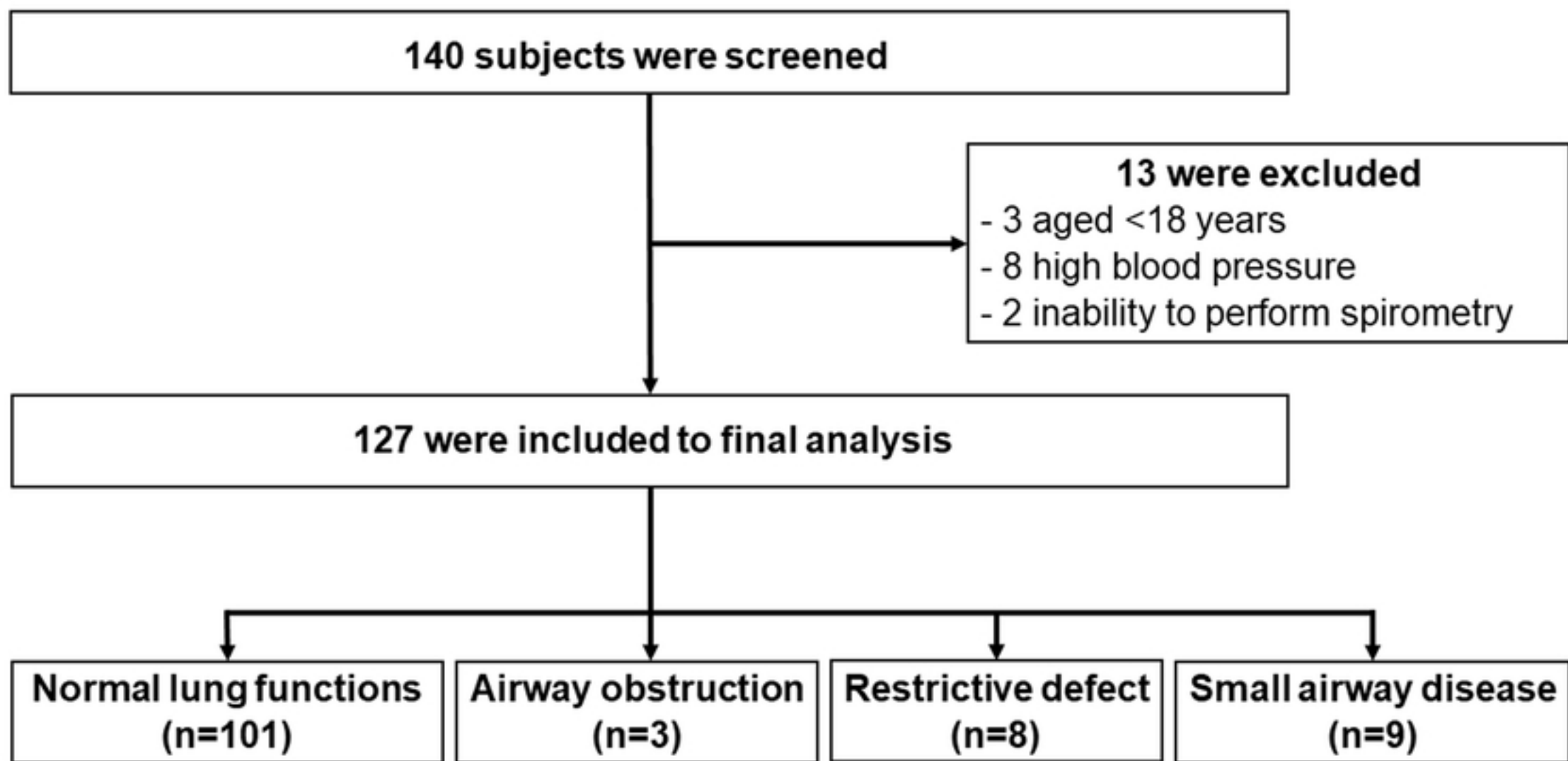
