Dementia and Alzheimer's disease in former contact sports participants: population-based cohort study, systematic review, and meta-analysis

1 Summary

2	Background: There is uncertainty and contention around whether former participants in sports
3	characterised by repetitive head impact subsequently experience an elevated risk of dementia and
4	Alzheimer's disease, and if the occurrence of these neurodegenerative disorders differs between amateur
5	and professional athletes who have different levels of exposure. In a meta-analysis, we aggregated new
6	results from individual-participant analyses of a cohort study of former amateur athletes with those from a
7	systematic review of existing studies.
8	Methods: The cohort study comprised 2005 male retired amateur athletes who had competed
9	internationally for Finland (1920-1965), and a general population comparison group of 1386 age-equivalent
10	men. Dementia occurrence was ascertained from linked health registries. For the PROSPERO-registered
11	(CRD42022352780) systematic review, we searched PubMed and Embase from their inception to August 23
12	2022, including cohort studies published in English that reported standard estimates of association and
13	variance. Study-specific estimates were aggregated using random-effect meta-analysis. An adapted
14	Cochrane Risk of Bias Tool was used to assess study quality.
15	Findings: In the cohort study, up to 46 years of health surveillance of 3391 men gave rise to 406 dementia
16	cases (265 Alzheimer's disease). After adjustment for confounding factors, former boxers experienced
17	elevated rates of dementia (hazard ratio 3.60 [95% Cl 2.46, 5.28]) and Alzheimer's disease (4.10 [2.55,
18	6.61]) relative to general population controls. Associations were of somewhat lower magnitude in retired
19	wrestlers (dementia: 1.51 [0.98, 2.34]; Alzheimer's disease: 2.11 [1.28, 3.48]) and soccer players (dementia:
20	1.55 [1.00, 2.41]; Alzheimer's disease: 2.07 [1.23, 3.46]), with some estimates including unity. The
21	systematic review identified 827 potentially eligible published articles, of which 7 met inclusion criteria. All
22	studies sampled men and the majority were of moderate quality. After aggregating results from these
23	retrieved studies with those from the new cohort study, results for all contact sports combined revealed a
24	raised risk of dementia (summary risk ratio 1.91 [95% CI 1.30, 2.82], I ² =87%) and Alzheimer's disease (2.30
25	[1.32, 4.00], I ² =83%) relative to the general population. Former boxers had higher rates of dementia (2
26	studies: summary risk ratio 3.14 [95% CI 1.72, 5.74], I ² =34%) and Alzheimer's disease (2 studies: 3.07 [1.01,
27	9.38], I ² =55%), as did retired soccer players (3 studies of dementia: 2.78 [1.69, 4.59], I ² =86%; 2 studies of

- Alzheimer's disease: 3.22 [1.34, 7.75], l^2 =81%). While the pooled estimate for dementia in retired
- American football players was less convincing (4 studies: 1.63 [0.76, 3.49], I² =75%), disease occurrence in
- 30 onetime professionals was markedly higher (2.96 [1.66, 5.30]) than amateurs where there was no
- 31 suggestion of an association (0.90 [0.52, 1.56]). There was also a risk differential for retired professional
- 32 (3.61 [2.92, 4.45]) and amateur (1.60 [1.11, 2.30]) soccer players.
- 33 Interpretation: Based on a modest collection of studies exclusively comprising men, former participants in
- 34 contact sports subsequently experienced poorer brain health, and there was a suggestion that retired
- 35 professionals had the greatest risk. Whether these findings are generalisable to the contact sports not
- 36 featured, and to women, warrants examination.

38 **Research in context**

39 Evidence before this study

40 The observation that brain injury traumatic enough to warrant hospitalisation is associated with the 41 development of dementia raises the possibility that former participants in sports characterised by low 42 intensity repetitive head impact may also experience an increased burden of the disease, and that 43 dementia rates might differ between former amateur and professional athletes who have different levels of 44 exposure to training and competition. Searching PubMed and Embase using terms for specific contact 45 sports (e.g., 'boxing', 'martial', 'wrestling', 'football', 'soccer', 'hockey', 'rugby') and neurodegenerative 46 outcomes (e.g., 'dementia', 'Alzheimer') revealed studies of dementia risk in retired athletes from American 47 football, soccer, and boxing but no evidence for wrestling or other contact sports. There was a suggestion 48 of mixed results across studies. While we also retrieved several relevant systematic reviews, these were all 49 narrative reports and there was no meta-analysis offering a quantitative synthesis of the available 50 evidence, including analysis by professional/amateur status.

52 Added value of this study

53 In the first individual cohort study to simultaneously examine effects across multiple contact sports, after 54 adjustment for confounding factors, relative to the general population, there was a markedly raised risk of 55 dementia in former boxers which was weaker but still elevated for soccer players and wrestlers. The 56 strength of these associations was more pronounced for Alzheimer's disease whereby there was a 57 quadrupling of risk in retired boxers and a doubling in onetime wrestlers and soccer players. After 58 incorporating these new results into the first meta-analysis in this field, in aggregate, there was a greater 59 risk of dementia and Alzheimer's disease in all former contact sports participants combined, and in retired 60 soccer players and boxers, relative to the general population. While former American football players did 61 not collectively have clearly elevated rates of dementia, there was evidence that those from professional 62 backgrounds experienced a raised risk which was not apparent in retired amateurs. This professional-63 amateur risk differential was also seen in erstwhile soccer players.

- 65 Implications of all the available evidence
- 66 With soccer being the most common participation sport worldwide, and wrestling and American football
- 67 long-established in the educational systems of selected countries, quantifying the burden of dementia for
- 68 these activities has potential for public health impact, particularly if the risk is also raised in the more
- 69 populous amateur groups. The existing evidence base is, however, hampered by an absence of studies of
- 70 women, and is modest in scale and narrow in scope, currently not including several popular contact sports
- 71 such as rugby or basketball.

72 Introduction

73	Estimates of the present and future burden of dementia for individuals, societies, and health care systems
74	are clear: there are currently around 60 million cases globally and, owing to demographic growth of the
75	ageing population, predictions are that this is likely to triple by 2050. 1 Unsuccessful trials of drug treatment
76	to alter the course of the disease brings into sharp focus the need to identify modifiable risk factors for the
77	primary prevention of dementia, ² and head injury has recently been advanced in this context. ³
78	
79	Head impact occurs on a spectrum of severity. In people who experience head trauma serious enough to
80	warrant hospitalisation, typically resulting from motor vehicle accidents or falls, there is evidence from
81	large scale cohort studies of the general population of an approximate doubling in the rate of later
82	dementia relative to the unexposed, ⁴⁻⁷ although these are not universal findings. ⁸ There is also an
83	indication of a dose-response association, whereby less severe head injury has intermediate level risk. ⁹
84	These observations raise concerns that lower intensity repetitive head impact, characteristic of
85	participation in contact sports, may have implications for the occurrence of dementia. ¹⁰
86	
87	Although autopsy investigations reveal evidence of chronic traumatic encephalopathy, a
88	neurodegenerative disease, among select samples of former athletes from American football, ¹¹ soccer, ¹²
89	and boxing, ¹³ whether participation in these sports is associated with a later risk of dementia is uncertain.
90	In former American football players, for instance, there is a suggestion of elevated rates of dementia
91	relative to the general population, ¹⁴ while other studies report no difference in the occurrence of this
92	neurodegenerative disorder across these groups. ¹⁵ Elsewhere, dementia risk was raised amongst retired
93	professional soccer players, ^{16,17} yet a small cohort of onetime amateur boxers had the same rates as
94	unexposed controls. ¹⁸

To address this paucity of evidence, we first utilise new data from a well-characterised cohort study of men
drawn from an array of elite amateur athletic backgrounds which include the contact sports of soccer,
wrestling, and boxing, who had long-term follow-up for incident dementia. We then aggregate these

- 99 results within a meta-analysis based on a systematic review of results from all published cohort studies.
- 100 Although there are several recent systematic reviews of dementia in former contact sports participants,¹⁹⁻²¹
- 101 we are not aware of any quantitative synthesis of these findings, including a comparison of disease
- 102 occurrence in retired amateur and professional athletes who have different levels of historical exposure to
- 103 head impact.

- 105 Methods
- 106 Cohort of Finnish former elite athletes
- 107 This cohort study was initiated in 1978 to examine the relationship between participation in different elite-
- 108 level sports and longevity.^{22,23} The sample was generated from 2613 Finnish male former elite amateur
- athletes (640 Olympians) who competed internationally between 1920 and 1965 (supplemental figure 1).
- 110 Identified using a combination of sports yearbooks, association records, and periodicals, these individuals
- 111 represented a diverse array of sporting backgrounds. Data collection was approved by the ethics
- 112 committee of the Hospital Districts of Helsinki and Uusimaa, and all participants consented. The reporting
- of this cohort study conforms to the Strengthening the Reporting of Observational Studies in Epidemiology
- 114 (STROBE) Statement of guidelines for reporting observational studies.²⁴

116 Derivation of exposed and unexposed groups

117 Based on the occurrence of head injury,²⁵⁻²⁷ the included sports were denoted as contact (soccer, boxing,

118 wrestling, ice hockey, and basketball) or non-contact (track and field, cross-country skiing, and weight-

lifting). Individual contact sports were then disaggregated as the numbers of dementia cases at follow-up

allowed. Thus, separate analyses were possible for former soccer players, boxers, and wrestlers (non-

121 professional or freestyle/Greco-Roman), while retired athletes from the sports of ice hockey and basketball

- 122 players were combined into a 'other' contact sports category. A general population-based (unexposed)
- 123 comparison group comprising age-equivalent healthy men was generated using records from a population-
- 124 wide medical examination routinely administered to all Finnish males at around 20 years of age as part of

128 Assessment of covariates

- 129 Data on covariates were extracted from two sources. The presence of diabetes, hypertension, and
- 130 coronary heart disease was derived from linkage of study members to a national drug treatment register.
- Additionally, in 1985, surviving study members and population controls (N=2851; 66% of the original
- 132 cohort) were mailed a self-completion questionnaire (N=1917; response 67%) (supplemental figure 1) with
- enquiries regarding health behaviours (e.g., smoking, alcohol intake), physical stature, and weight.
- 134 Questionnaire data in combination with those extracted from the Finnish Central Population Registry were
- used to generate a variable for longest held job, our indicator of socioeconomic status.²⁸

- 137 Ascertainment of dementia
- 138 Health surveillance began upon initiation of nationwide health registries in 1970 when the average age of
- 139 the athlete group was 45.4 years (controls 44.3 years). Study members were linked to: death records,
- 140 including cause; hospitalisation records, including cause; and the Finnish Drug Prescription Register for
- 141 medications specifically used to treat Alzheimer's disease (see supplemental table 1 for International
- 142 Classification of Disease and medication codes). Using these data, we derived three dementia outcomes
- 143 for use in the present analyses: dementia, Alzheimer's disease, and non-Alzheimer's dementia.

145 Systematic review and meta-analysis

146 Search strategy and study selection

This PROSPERO-registered (CRD42022352780) systematic review and meta-analysis was reported in
 accordance with Preferred Reporting Items for Systematic reviews and Meta-Analyses (PRISMA)²⁹ and
 Meta-analysis Of Observational Studies in Epidemiology (MOOSE)³⁰ guidelines. We identified relevant
 literature by searching PubMed (Medline) and Embase databases between their inception and August 23

151 2022. We used combinations of free text and controlled terms in 2 categories (supplemental box 1): the

exposure (i.e., specific sports such as boxing, soccer, martial arts, and rugby), and the outcome (i.e.,

dementia and its subtypes such as Alzheimer's disease and vascular dementia). We also scrutinised the

154 reference sections of retrieved articles for additional publications.

156 We included a published paper if it fulfilled the following criteria: utilised a cohort study; the diagnosis of

dementia outcomes was made by a healthcare professional as part of a medical examination in either a

research or clinical setting (self-reports of physician diagnosis and cognitive tests did not qualify); reported

159 standard estimates of association (e.g., relative risk, odds ratios, hazard ratios) and variance (e.g.,

160 confidence interval, standard error); appeared in a peer-reviewed journal; and was published in English.

161 Two authors (GDB and PF) independently screened the identified records first by title, then abstract, and, if

162 necessary, the full paper. Any discrepancies were resolved on discussion.

164 Extraction of results and assessment of study quality

165 Where available, a range of characteristics were extracted from each publication, including the name of the

166 lead author, publication year, country of sample population, number of participants exposed/unexposed,

167 number of events and type, and effects estimates for both minimally- and multivariable-adjusted results.

168 Study authors were contacted when clarification was required.

169

170 We used an adapted version of the Cochrane Risk of Bias Tool to assess study quality.³¹ This comprised

seven domains of appraisal, including the comprehensiveness of the exposure, confounding variables,

outcome ascertainment, and adequacy of the follow-up (supplemental table 2). With a maximum of 4

points for each domain (total 28), we regarded the quality of the study as high if the total score was at least

174 21, moderate if the score ranged between 14 and 20, and low if it was <14.

176 Statistical analyses

177 In individual-participant analyses of the Finnish cohort study, after exclusion of study members owing to

178 record-linkage failure and death prior to the beginning of follow-up, the analytical sample comprised 3,391

179	men (2005 former athletes, 1386 population controls). Event surveillance was from 1 st January 1970 until
180	the occurrence of a dementia event or the end of surveillance (December 31, 2015) – whichever came first.
181	Having ascertained that the proportional hazards assumption had not been violated, we used Cox
182	regression to compute hazard ratios with accompanying 95% confidence intervals to summarise the
183	relationship of a background in contact sports with the risk of dementia. ³² Age was used as the time
184	covariate.
185	
186	For the meta-analysis, we pooled the results from the analyses of raw data in the Finnish cohort alongside
187	published study-specific estimates using a random effects meta-analysis, ³³ an approach which incorporates
188	the heterogeneity of effects in the computation of their aggregation. An I ² statistic was computed to
189	summarise the heterogeneity in estimates across studies. All analyses were computed using Stata 15
190	(StataCorp, College Station, TX).
191	
192	Role of the funding source
193	This report had no direct funding. All authors had final responsibility for the decision to submit for
194	publication.

196	Results
197	Finnish cohort study
198	In analyses of the Finnish cohort, a mean of 30.6 years of disease surveillance (range 1-46 years) in the
199	analytical sample of 3391 men, gave rise to 406 cases of dementia (265 cases of Alzheimer's disease).
200	There was little difference in the magnitude of the hazard ratios in the univariate and multivariate models
201	(table 1), so we present the results for the latter here. Former boxers experienced a more than three-fold
202	risk of dementia (hazard ratio 3.60 [95% CI 2.46, 5.28]) relative to the general population comparison
203	group. While risk was also elevated in retired wrestlers (1.51 [0.98, 2.34]) and soccer players (1.55 [1.00,
204	2.41]), statistical significance was not apparent. The risk of dementia in erstwhile athletes from 'other'
205	contact sports (ice bockey and basketball) and those from non-contact sports such as track and field was

not significantly different to the general population controls. Alzheimer's disease was most strongly related
to a history of contact sports, whereby boxing was associated with a quadrupling in risk (4.10 [2.55, 6.61]),
and the rate in wrestlers (2.11 [1.28, 3,48]) and soccer players (2.07 [1.23, 3.46]) was around double that of
general population controls. The risk of non-Alzheimer's dementia was also raised in retired boxers (2.62;
1.68, 4.11) but not convincingly so in former soccer players (1.23 [0.74, 2.06]) nor wrestlers (1.22 [0.73,
2.03]) (supplemental table 3).
We conducted some sensitivity analyses. First, given the maturity of this cohort, competing risk bias may

214 arise because the occurrence of a non-dementia event precludes occurrence of our primary outcome of 215 interest. We therefore subjected Alzheimer's disease to a competing risks analysis based on the most 216 common cause of ill-health herein, cardiovascular disease, and our findings were unchanged (supplemental 217 table 4). Second, given the amateur era in which study members competed internationally, it is plausible 218 that, if sufficiently skilled, they could have participated at elite level in more than one of the sports linked 219 to dementia in our analyses. Mutual control for each of the three sports related to dementia in earlier 220 analyses did not, however, change the overall pattern of association (supplemental table 5). Lastly, owing 221 to missing data, the more complex statistical models comprise fewer study members. We therefore 222 recomputed the main effects in a non-missing dataset and results were essentially the same (supplemental 223 table 6).

225 Systematic review and meta-analysis

The systematic review identified 827 potentially eligible published articles of which 7 met our inclusion criteria (figure 1). Of these, four cohort studies captured dementia cases in retired American football players^{14,15,34,35} (none featured Alzheimer's disease); there were two such studies of former soccer players^{16,17} (one with Alzheimer's disease,¹⁶ one with non-Alzheimer's dementia¹⁶); and one of retired boxers¹⁸ (one with Alzheimer's disease¹⁸) (table 2). One study was field-based¹⁸ and the remainder were generated from linkage of administrative records. All retrieved studies exclusively comprised men, and were a mix of former amateurs^{15,18,34} and professionals.^{14,16,17,35} Comparison groups were typically the

233	general population, with two utilising a non-collision sports group. ^{15,35} The studies of erstwhile American
234	football players were unsurprisingly based on samples from the USA, ^{14,15,34,35} whereas former boxers were
235	drawn from Wales, ¹⁸ and the soccer players from Scotland ¹⁶ and France. ¹⁷ When reported, the number of
236	events in the retired athletes ranged from 5 ¹⁸ to 180 ¹⁶ for dementia; 2 ¹⁸ to 64 ¹⁶ for Alzheimer's disease; and
237	for the single study reporting non-Alzheimer's dementia the count was 64. ¹⁶ Of the seven retrieved studies,
238	only one ¹⁶ was evaluated as being of high quality, with the remainder classified as moderate (supplemental
239	table 2).
240	
241	In the meta-analysis, we pooled results from these published studies alongside the new findings from the
242	Finnish cohort. On combining effects estimates for all contact sports, there was around a doubling of the
243	risk of dementia (summary risk ratio 1.91 [95% Cl 1.30, 2.82], I ² =87%) and Alzheimer's disease (2.30 [1.32 to
244	4.00], I ² =83%) relative to general population comparison groups.
245	
246	In analyses of specific sports, former soccer players (figure 2) had elevated rates of dementia (2.78 [1.69,
247	4.59]), Alzheimer's disease (3.22 [1.34, 7.75]), and non-Alzheimer's dementia (2.32 [1.04, 5.16]).
248	Confidence intervals around these estimates were wide, however, indicating low precision, and there was a
249	high degree of cross-study heterogeneity in both analyses (I ² >81%). In the studies of former professional
250	soccer athletes, there was a suggestion of a higher risk of dementia (3.61 [2.92, 4.45]) relative to the single
251	cohort of retired amateur players (1.60 [1.11, 2.30]).
252	
253	The overall results for the American football studies (figure 3) revealed an unconvincingly raised risk of
254	dementia in former participants, the confidence interval for which included unity (1.63 [0.76, 3.49],
255	I ² =75%). Again, however, a differential in dementia risk according to past playing level was also evident,
256	whereby an association was evident for retired professionals (2.96 [1.66, 5.30]) but not in onetime
257	amateurs whose only exposure was in high school (0.90 [0.52, 1.56]). In one of the American football
258	studies, ¹⁵ the 'unexposed' group of non-football players in fact comprised some wrestlers who, in analyses
259	of the Finnish cohort study herein, had a modestly elevated post-retirement risk of dementia. This could

260 have had the impact of narrowing the risk differential; however, dropping the study from the meta-analysis

did not alter our conclusions.

262

Lastly, in the analyses of boxers (figure 4), all of whom competed on an amateur basis, in aggregate, former

athletes experienced a greater risk of both dementia (3.14 [1.72, 5.74]) and Alzheimer's disease (3.07 [1.01,

265 9.38]). There was a moderate level of heterogeneity across these two studies ($l^2 \le 55\%$).

267 Discussion

In the present study, we quantitatively aggregated results from new analyses of a Finnish cohort study with

those from the extant literature. With the caveats that the evidence base is modest in scale and confined

to men, relative to general population comparison groups, we found elevated rates of dementia in former

271 participants from the contact sports of soccer and boxing. While studies of retired American football

272 players did not collectively reveal a convincing association with dementia, those from professional

backgrounds experienced markedly higher risk than amateurs who were only exposed in high school. This

differential in disease risk between former professionals and amateurs was also seen for former soccer

athletes. In partial support of the finding of lower dementia rates in former high school football athletes, at

autopsy, former professionals and college players had a markedly higher prevalence of chronic traumatic

277 encephalopathy, a neurodegenerative disorder.¹¹

278

279 Another salient finding of the present meta-analysis was the general pattern of dementia risk despite the 280 contrasting head impact profiles of the included sports. That is, concussions are most common in wrestling 281 and boxing,^{26 27} and result largely from person-on-person contact – in boxing, for instance, the primary 282 objective is to render the opponent unconscious. In soccer, however, the insult is more likely to be sub-283 concussive and attributable to contact with the ball when attempting to redirect it using the head. In 284 within cohort analyses of former soccer players featured in the present meta-analysis,¹⁶ those who 285 occupied outfield positions in their careers and were therefore more likely to 'head' the ball, had higher 286 rates of dementia at follow-up, including Alzheimer's, relative to goalkeepers who rarely head the ball.³⁶

288 Plausible mechanisms

289 Most of the studies included in the present meta-analysis had a modest collection of confounding factors, 290 however, in the analyses of the well-characterised Finnish cohort, controlling for an array of risk factors had 291 little impact on the magnitude of the effects. This apparent independent influence of contact sports 292 participation therefore raises the question of potential mechanisms. It is plausible that athleticism and 293 neurodegenerative disorders share selected gene variants although empirical data are currently lacking. 294 For those sports played in outdoor environments, it has been speculated that exposure to pesticides might raise dementia risk,^{37,38} though this would not apply to the indoor sports of boxing and wrestling where 295 296 dementia risk was highest. Sport-specific explanations include, for soccer, the suggestion that heading 297 produces an acute if temporary lowering of cognitive function³⁹ while potentially more permanent structural changes to the brain are evident upon imaging.⁴⁰ Specific mechanisms of risk in boxing and 298 299 American football are less clear. That global participation in soccer – estimated at more than a quarter of a 300 million by its governing $body^{41}$ – is seemingly the highest of any sport, and programmes of wrestling and 301 American football are long-established in many colleges,⁴² means that, if indeed causal, a link between a 302 background in these activities and dementia may have public health significance.

304 Study strengths and limitations

305 The present study has its strengths, including being the first quantitative synthesis of dementia risk in 306 former participants from a range of contact sports, and one that incorporates new cohort study data. It is 307 not, however, without its limitations. First, all retrieved studies, plus the Finnish cohort, exclusively sample 308 men. While we can think of no reason for the present results not applying to women given that other risk 309 factors predict dementia equally well in sex-specific analyses, ^{43,44} clearly, empirical studies are required. 310 Second, the findings of a meta-analysis are only as strong as the methodological quality of the studies it 311 includes, and all data herein were observational with the large majority of moderate quality. With 312 conventional trials in this field being unviable ethically and perhaps logistically, an advance on current 313 evidence may be the use of natural experiments. These could include the impact on dementia risk pre- and

314	post-introduction of compulsory protective equipment such as change in the composition of the soccer ball
315	from leather to plastic which resulted in lower weight (1986-present), or the introduction of head gear in
316	amateur boxing (1984-2016). This quasi-experimental approach has been used elsewhere in dementia
317	research by examining the role of mandated increases in school leaving age as a proxy for improved
318	education. ⁴⁵ Lastly, none of the studies have data on actual head impacts; instead, sporting background
319	was used as a proxy. There is empirical evidence, however, of a higher occurrence of head trauma in
320	contact sports groups versus control populations. ¹⁵
321	
322	In conclusion, based on a modest collection of studies of moderate quality, former participants in contact
323	sports experienced poorer brain health at follow-up, and this was particularly evident for retired
324	professionals with the highest accumulative exposure to head impacts. Whether these findings are
325	generalisable to women is unclear given the dearth of data.


