Factors Associated with Receipt and Parental Intent for COVID-19 Vaccination of Children Ages 5–11 years

13 ABSTRACT

14 Background and Objectives

- 15 COVID-19 vaccine was first recommended for children ages 5–11 years on November 2, 2021.
- 16 This report describes COVID-19 vaccination coverage and parental intent to vaccinate their child
- ages 5–11 years, overall, by sociodemographic characteristics, and by social and behavioral
- 18 drivers of vaccination, the fourth month after recommendation.
- 19

20 Methods

- 21 We analyzed data from 5,438 interviews conducted in February 2022 from the National
- 22 Immunization Survey-Child COVID Module (NIS-CCM), a national random-digit-dial cellular
- 23 telephone survey of households with children.

25 **Results**

- 26 30.9% of children ages 5–11 were vaccinated with ≥ 1 dose of COVID-19 vaccine, 35.2% were
- 27 unvaccinated and the parent reported they probably or definitely would get the child vaccinated
- or were unsure, and 33.9% were unvaccinated and the parent probably or definitely would not
- 29 get the child vaccinated. Vaccination coverage and parental intent differed by sociodemographic
- 30 variables, including income, health insurance status, and rurality. Parental intent to vaccinate
- children also differed by ethnicity and race. Concern about the child getting COVID-19 and
 confidence in vaccine importance and safety were positively associated with vaccination receipt
- and intent to get the child vaccinated.

35 Conclusions

- By the fourth month of the COVID-19 vaccination program for children ages 5–11 years, less
- than one-third were vaccinated, and coverage was lower for some sociodemographic subgroups.
- An additional one-third of children had a parent who was open to vaccinating the child. Efforts
- 39 to address parental concerns regarding vaccine safety and to convey the importance of the
- 40 vaccine might improve vaccination coverage.

1 INTRODUCTION

2 COVID-19 is usually milder in children than adults; however, children can become severely ill and require hospitalization and intensive care, and some children have prolonged 3 illness duration.^{1,2} Some children have also contracted multisystem inflammatory syndrome after 4 infection with COVID-19.³ Children might play an important role in the transmission of 5 6 COVID-19, highlighting the importance of child vaccinations in the effort to reduce COVID-19 community transmission and hospitalization rates.⁴ The U.S. Food and Drug Administration 7 8 authorized the emergency use of the Pfizer-BioNTech COVID-19 vaccine for children ages 5-11 9 years in the United States on October 29, 2021, which was endorsed on November 2, 2021, by 10 the Centers for Disease Control and Prevention (CDC) based on recommendations from the Advisory Committee on Immunization Practices.⁵ Administrative data reported to CDC showed 11 12 that coverage among children 5–11 years was 24% during the first two months of vaccine 13 rollout, which was lower than coverage among those ages 12–15 years (33%) during the first two months of eligibility for that age group.⁶ A report on the safety of the Pfizer-BioNTech COVID-14 15 19 vaccine, the only COVID-19 vaccine authorized for 5-17 year olds, after administration of approximately 8 million doses to children ages 5–11 years found the vaccine to be safe, with 16 mild to moderate local and systemic reactions to be expected after vaccination.⁷ In two studies 17 completed within 3-4 months of vaccine authorization, COVID-19 vaccine effectiveness after 18 two doses among children ages 5–11 years was 31% against asymptomatic and symptomatic 19 20 Omicron infection and 46% against COVID-19 associated emergency department and urgent care encounters.^{8,9} 21

The evaluation of disparities in receipt of routine childhood vaccinations is an important
 component of the national immunization program in the United States.¹⁰ Understanding

sociodemographic differences in COVID-19 vaccination and parental intent to vaccinate children
ages 5–11 years during the first few months after the COVID-19 vaccine recommendation is
essential in efforts to achieve higher vaccination coverage in this age group and addressing
inequities in coverage early in the vaccination program. Better understanding of the associations
between behavioral and social drivers of vaccine uptake and the willingness of parents to
vaccinate their children might help to identify specific issues and demographic subgroups where
tailored efforts might be helpful to improve vaccination coverage.

8 This report describes COVID-19 vaccination coverage among children ages 5–11 years 9 during the first four months of eligibility and parents' intent to vaccinate their children, overall 10 and by sociodemographic characteristics using data from the National Immunization Survey-11 Child COVID Module (NIS-CCM). The study also examines variation in several behavioral and 12 social drivers of COVID-19 vaccination by parents' intent to vaccinate their children.

14 METHODS

The NIS-CCM is a random-digit-dial cellular telephone survey of households with 15 children ages 5–17 years. The NIS-CCM began on July 22, 2021, including households with 16 children ages 13-17 years and asking the respondent about the child's COVID-19 vaccination 17 status and their intention to vaccinate the child. On October 1st, NIS-CCM was expanded to add 18 children ages 12 and 5–11 years (intent questions only), and on November 2nd vaccination status 19 questions were added for children ages 5–11. The NIS-CCM utilizes the same sampling frame 20 used for the NIS-Child.^{11,12} The respondent to a NIS survey is the parent or guardian of the child 21 who self-reports as being knowledgeable about the child's vaccination history (hereafter referred 22 23 to as parent).

1 COVID-19 vaccination coverage was based on the parent's response to the question "Has 2 [child] received at least one dose of a COVID-19 vaccine?" Parental intent among parents who reported the child did not receive a vaccine was measured by asking: "How likely are you to get 3 4 [child] a COVID-19 vaccine? Would you say you would: definitely get a vaccine for [child]; probably get a vaccine; probably not get a vaccine; definitely not get a vaccine; or are not sure?" 5 6 We grouped children as follows: 1) child vaccinated with ≥ 1 dose, 2) "child unvaccinated and 7 parent open to vaccination", defined as unvaccinated children whose parent reported they definitely or probably will get the child vaccinated or were unsure, and 3) "child unvaccinated 8 9 and parent reluctant to vaccinate", defined as unvaccinated children whose parent reported they 10 definitely or probably will not get the child vaccinated.

Further, in order to control for the effect that any increasing vaccination coverage in a 11 group has in depleting the proportion with high intent in the pool of those still unvaccinated 12 (because of them getting vaccinated over time), we created an additional variable called 13 "willingness" to get the child vaccinated with COVID-19 vaccine. "Willingness" included 14 15 parents who already had the child vaccinated (they are willing to get the child vaccinated, as evidenced by them doing so) and parents open to vaccination (i.e. parents with unvaccinated 16 children who definitely or probably will get the child vaccinated or were unsure). Parents who 17 reported that the child had received COVID-19 vaccination were asked the kind of place where 18 the child received the vaccination. All information about the parent, child, and household was 19 20 self-reported by the parent respondent.

The variables describing potential drivers of COVID-19 vaccine uptake are derived from the Behavioral and Social Drivers of Vaccination (BeSD) Framework.¹³ The domains and associated survey questions were:

1 • Thinking and Feeling:

2	• "How concerned are you about [child's name] getting COVID-19?" "Not at all
3	concerned, a little concerned, moderately concerned, or very concerned."
4	• "How important do you think getting a COVID-19 vaccine is to protect [child's name]
5	against COVID-19?" "Not at all important, a little important, somewhat important, or
6	very important"
7	• "How safe do you think a COVID-19 vaccine is for [child's name]?" "Not at all safe,
8	somewhat safe, very safe, or completely safe".
9	 Social Processes:
10	• "If you had to guess, about how many of your family and friends have gotten a COVID-
11	19 vaccine for their children ages 5–11 years?" "None, some, many, or almost all."
12	• "Has a doctor, nurse, or another health professional ever recommended that you get a
13	COVID-19 vaccine for [child's name]" "Yes or no."
14	• "Does [child's name]'s school require a COVID-19 vaccine to attend in-person
15	classes?" "Yes or no."
16	 Practical Issues:
17	• "How difficult would it be/was it for you to get [child's name] a COVID-19 vaccine?"
18	"Not at all difficult, a little difficult, somewhat difficult, or very difficult."

20	Data from interviews conducted from January 30 through February 26, 2022, were
21	analyzed. There were 5,496 completed parent interviews for children ages 5–11 years. Of these,
22	35 were missing vaccination status, and 23 of the unvaccinated children did not have vaccination
23	intent reported for the child, for a resulting analytic sample of n=5,438. The cumulative NIS-

1 CCM response rate was 15.1%. Weighted proportions with 95% confidence intervals (CIs) were 2 estimated considering the complex survey design and weights by using SAS-callable SUDAAN (version 11.0.3, RTI) and SAS version 9.4 (SAS Institute, Inc.). The NIS-CCM survey weights 3 4 adjust for non-response and households without cellular telephones and were calibrated to match counts of children with one or more doses of COVID-19 vaccine by sex within each U.S. 5 Department of Health and Human Services (HHS) region for children ages 5-11 years as of mid-6 month, using data reported to CDC by jurisdictions.⁶ T-tests for proportions were used to test for 7 statistically significant differences with p < 0.05. The NCHS reliability criteria for proportions 8 was implemented and proportions not meeting the criteria were suppressed from the tables.¹⁴ 9 10 RESULTS 11 Figure 1 shows the distribution of children across six levels of vaccination and intent, 12 including vaccinated with at least one dose, and each of the five levels of intent for unvaccinated 13 children included in the survey question. COVID-19 vaccination coverage among children ages 14 15 5-11 years increased from 8.0% in November 2021 to 20.7% in December 2021, 27.6% in January 2022, and 30.9% in February 2022 (Figure 1). In February, 35.2% were unvaccinated 16 and the parent reported they probably or definitely would get the child vaccinated or were 17 unsure, and 33.9% were unvaccinated and the parent probably or definitely would not get the 18 child vaccinated. The places that children ages 5-11 years received their vaccinations were: 19 medical place (46.4% [specifically: 23.3% doctor's office, 12.4% clinic/health center, 6.5% 20 21 hospital, 3.4% health department, 0.9% other medical place]), pharmacy/drug store (38.3%), school (7.5%), mass vaccination site (5.3%), or another non-medical place (2.6%; data not 22 23 shown).

1	Child's receipt of ≥ 1 dose of COVID-19 vaccine and parents' willingness to get their
2	child vaccinated with COVID-19 vaccine varied by sociodemographic characteristics (Table 1).
3	A higher percentage of children ages 7–8 years (29.5%) and 9–11 years (34.4%) were vaccinated
4	compared to children ages 5–6 years (26.0%), yet there were no age differences in parents'
5	willingness to get their child vaccinated (Table 1). There were no differences in the percentage of
6	Hispanic or Black non-Hispanic children receiving ≥ 1 dose compared with White non-Hispanic
7	children; however, there was a higher willingness to vaccinate among parents of Black non-
8	Hispanic children (72.7%) and Hispanic children (71.4%) compared with White non-Hispanic
9	children (57.9%, Table 1). The highest vaccination coverage (68.7%) and parental willingness to
10	vaccinate (92.9%) was among parents of Asian non-Hispanic children.
11	A lower percentage of children received COVID-19 vaccination in households above
12	poverty with income <= \$75,000 (23.1%) and below the poverty level (22.1%) compared with
13	children in households above poverty with income >\$75,000 (36.9%); however, there was no
14	difference in willingness to vaccinate by income (range 63-68% across income levels). A higher
15	proportion of children with non-Medicaid health insurance received COVID-19 vaccination
16	(35.0%) compared with Medicaid-insured children (24.3%), while uninsured children had similar
17	coverage to Medicaid-insured children (25.9%); there were no differences in willingness to
18	vaccinate by insurance status. Among children who did not receive an influenza vaccination
19	since July 2021, 16.4% received a COVID-19 vaccine compared with 51.0% of children who
20	had received an influenza vaccination. A lower proportion of children living in rural areas were
21	vaccinated (16.6%) than children living in urban areas (34.3%), and there was a lower
22	willingness to vaccinate in rural (46.5%) and suburban (65.8%) areas compared with urban areas
23	(73.2%). There were also differences in vaccination coverage and willingness to vaccinate by

county-level characteristics and by HHS region (see Table 1). The study also found variation by
 sociodemographic characteristics in parents' openness and reluctance to vaccinate children who
 were unvaccinated, as shown in Table 1.

4 There were strong associations between social and behavioral drivers and the child's 5 receipt of ≥ 1 dose of COVID-19 vaccine and parental intent to vaccinate the child (Figure 2). 6 Parents who were reluctant (reported that they definitely or probably would *not* get their child 7 vaccinated) were less likely to report they were very/moderately concerned about the child getting COVID-19 when compared to parents of vaccinated children (23.6% vs 56.8%), were 8 9 less likely to report that getting a COVID-19 vaccine was somewhat/very important (16.0% vs 10 95.9%), less likely to report that COVID-19 vaccine is completely/very safe (7.1% vs 80.0%), less likely to report that almost all/many friends/family have their child vaccinated (6.0% vs 11 63.6%), and less likely to report a provider recommendation for COVID-19 vaccine (18.4% vs 12 56.6%). Parents who were open to vaccinating their child, but had not yet vaccinated them 13 (reported that they were definitely/probably/unsure), were less likely to report that getting a 14 15 COVID-19 vaccine was somewhat/very important when compared to parents of vaccinated children (77.6% vs 95.9%), less likely to report that COVID-19 vaccine is completely/very safe 16 (38.3% vs 80.0%), perception of fewer friends/family having their child vaccinated (16.0% vs 17 63.6%), and less likely to report a provider recommendation for COVID-19 vaccine (24.0% vs 18 56.6%). 19

Table 2 describes the behavioral and social drivers for COVID-19 vaccination among the subset of unvaccinated children whose parents were open to vaccination. Hispanic children in this group had a higher percentage of parent-reported concern about the child getting COVID-19 (58.4%), but a lower percentage of confidence in the safety of the vaccine (29.7%) than among

1	White non-Hispanic children (44.1% and 45.2%, respectively). Among unvaccinated Black non-
2	Hispanic children whose parent was open to vaccination, there was a higher percentage of
3	parent-reported concern about the child getting COVID-19 (67.8%) and perceived importance of
4	the vaccine (88.2%) than among White non-Hispanic unvaccinated children (44.1% and 71.3%,
5	respectively). For children who had a mother with a college degree, the respondents were more
6	confident in the vaccine's safety than those with \leq high school education (50.4% vs 30.3%) and
7	had higher reported provider recommendations for COVID-19 vaccination (30.7% vs 18.3%).
8	Other sociodemographic differences are reported in Table 2.

reluctant to get their child vaccinated are not likely to get vaccinated without a larger shift in the
parents' beliefs.¹⁸

19 This study found no differences in COVID-19 vaccination coverage between Hispanic or 20 Black non-Hispanic children compared with White non-Hispanic children. This absence of 21 racial/ethnic disparity is encouraging and might be a result of the efforts at outreach to 22 communities to promote and increase access to vaccination.^{15,17} Estimates available earlier in the 23 vaccination program showed there might have been some racial/ethnic differences, but they had narrowed by February 2022 when the data for this study were collected.^{6,19} It is less encouraging
that COVID-19 vaccination coverage was low (< 40%) for all racial/ethnic groups, except for
Asian non-Hispanic children. The higher COVID-19 vaccination coverage among Asian nonHispanic children is consistent with other studies and with what has been found for influenza
vaccination.^{6,20}

We did find disparities by household income and by health insurance status. Children in 6 7 lower-income families had COVID-19 vaccination coverage that was approximately 15 percentage points lower than those in a higher-income household, yet the parents in these lower-8 income households were as willing to have their children vaccinated as were those in the higher-9 income households. This indicates possible structural access barriers to COVID-19 vaccination 10 among lower-income children. Likewise, we found that children who were Medicaid-insured or 11 12 uninsured had COVID-19 vaccination coverage that was approximately 10 percentage points lower than children with private or other non-Medicaid health insurance, with no differences in 13 parental willingness to get the child vaccinated by insurance coverage. This disparity could be 14 15 associated with the difficulty of enrolling Vaccines for Children (VFC) providers, who serve children that are uninsured or Medicaid-insured, to stock and administer COVID-19 vaccines. 16 Given changes in coverage of administration fees for vaccination of uninsured people that took 17 effect on April 5, 2022, these disparities might become wider in the future, perhaps more so for 18 children without a medical home; however, only a small proportion of children are uninsured.²¹ 19 Any interventions to reduce access barriers to COVID-19 vaccination for young children, such as 20 vaccinations offered in school settings or increasing the availability of vaccinators during 21 convenient hours for working parents, should be encouraged.¹⁷ 22

1 The behavioral and social driver variables that were most different between children already 2 vaccinated compared to unvaccinated children whose parent was open to getting them vaccinated 3 were concerns about vaccine safety, perceptions of how many friends and family were getting 4 their children vaccinated, and provider recommendations for COVID-19 vaccination. The lower 5 confidence in vaccine safety was even more prevalent among Hispanic parents. Discussions with trusted messengers, such as the child's pediatrician or community and faith-based leaders, might 6 help allay parents' concerns.²² This might also increase parental perception that the social norm 7 is to have children vaccinated with all CDC-recommended childhood vaccines, even if this is not 8 9 true within their immediate circle of friends and families. The finding of a lower percentage of 10 provider recommendations among unvaccinated children compared to vaccinated children suggests that outreach to pediatricians and other medical providers for young children might be 11 12 needed to encourage them to use every opportunity to strongly recommended COVID-19 vaccination for their patients, as is recommended for other childhood vaccinations. This is 13 especially important for VFC providers who are serving Medicaid and uninsured children. 14 15 Children without a medical home are likely missing out on the opportunity to receive a provider recommendation, emphasizing the importance of all children having a medical home. 16 Furthermore, providers that not only recommend vaccines for their patients but also offer 17 vaccines during the visit have been shown to result in higher vaccination coverage levels.²³ 18 Improving the availability of COVID-19 vaccines at provider offices would help increase 19 coverage. Other evidence-based approaches for providers include integrating vaccination into 20 standard medical practice and sending reminders to parents; given less than 10% of children in 21 this study were reported to be vaccinated at school, expanded school-located vaccination 22 programs could be considered.¹⁷ 23

1 This study is subject to at least four limitations. First, the response rates were low (15%) and 2 bias in estimates might remain after weighting. Survey weights were therefore calibrated to the 3 COVID-19 vaccine administration data by region, age group, and sex to mitigate possible bias 4 from incomplete sample frame and nonresponse. Second, vaccination status was parent-reported 5 and subject to recall bias and social desirability bias. However, recall bias of the child's vaccination status might be reduced given the recency of the event (<4 months). While 6 7 calibration to the COVID-19 vaccine administration data does not correct for misclassification of vaccination status on an individual level, it does mitigate impact of this misclassification on 8 estimates of vaccination coverage. Third, we defined the shorthand term "willingness" to 9 10 vaccinate the child to include parents who already had the child vaccinated plus those whose child was unvaccinated but they said they definitely or probably or were unsure they would get 11 the child vaccinated, however these reported intentions might not translate to actual willingness 12 to have the child vaccinated. Semantic arguments might also be presented for including the 13 already vaccinated as willing, however other shorthand words/phrases had their own limitations. 14 15 Finally, the survey is cross-sectional, so cause and effect relationships cannot be determined. 16

17 CONCLUSION

By the fourth month of the COVID-19 vaccination program for children ages 5–11 years, slightly less than one-third were vaccinated and coverage was even lower for some sociodemographic subgroups. An additional one-third of children had a parent who was open to vaccination for the child. There were variations in vaccination coverage and parental intent by several sociodemographic characteristics and in the potential drivers of vaccination. Efforts to address parental concerns regarding vaccine safety and to convey the importance of the vaccine

1	might improve vaccination coverage. This study also suggests health-care provider
2	recommendation of COVID-19 vaccines and discussions with trusted messengers might also
3	improve coverage among children ages 5-11 years. ¹⁷


