# Loss of regulation of complement C5 activation

# in HIV associated Preeclampsia

## 1 Abstract

**Objective:** Maternal mortality remains a global health concern in developing countries that are also affected by HIV infection. Complement components are anaphylatoxin that mediate several growth factors necessary during pregnancy. An extensive stimulation of the complement system contributes to the pathogenesis of preeclampsia; hence its inhibition facilitates a successful pregnancy. The study evaluated the expression of complement components C2 and C5a in HIV and the association with preeclampsia.

9 38 were preeclamptic and 38 normotensive pregnant. The participants were further stratified according
10 to HIV infection status. Bio-Plex multiplex immunoassay method was used to quantify serum

**Materials and Methods:** Serum samples were collected from 76 pregnant women of which

11 concentration of C5a and C2 complement components.

**Results:** The C2 complement concentration was not significantly different between preeclamptic and normotensive pregnant women, irrespective of HIV status as well as pregnancy type. However, based on preeclamptic *vs* normotensive pregnancy type, the expression of C5a was significantly different (p = 0.05). The C5a levels were downregulated in preeclampsia compared to normotensive women, irrespective of HIV status. Both C2 and C5a concentrations did not differ across all study groups.

18 Conclusion: This novel study reports a loss of regulation of complement activation shown by the 19 downregulation of C5a in preeclamptic compared to normotensive pregnant women, regardless of HIV 20 status. Complement dysregulation affects the host innate defence, and as a consequence, intensifies 21 placental and fetal injury. Moreover, HIV status did not influence the expression of both C5a and C2, 22 irrespective of pregnancy type, this may be attributed to Highly Active Antiretroviral Therapy.

## 24 Introduction

25 Maternal mortality remains a global health concern particularly in low- and middle-income countries [1]. While Human Immunodeficiency Virus (HIV) infection, haemorrhage, and hypertensive disorders 26 in pregnancy (HDP) are the main factors contributing to maternal mortality in South Africa [2]. 27 Preeclampsia (PE) is a common and potentially fatal HDP, affecting 3-8% of all pregnancies worldwide 28 [3]. It is diagnosed by a new onset high blood pressure of  $\geq$ 140/90 mmHg with/without proteinuria (> 29 30 300 mg/d) and/or evidence of maternal organ dysfunction at or after 20 weeks of gestation [4]. PE is a 31 two-stage disorder in which stage 1 involves abnormal placentation shown by inadequate trophoblast invasion with resultant deficient myometrial spiral artery remodelling that leads to an ischemia/ hypoxic 32 micro-environment [5]. The maternal syndrome of PE is a consequence of ischaemia which leads to 33 widespread endothelial damage, multi-organ involvement, and the clinical signs and symptoms of PE 34 35 or stage 2 of this pregnancy disorder [6].

During normal pregnancy, the adaptations of the innate and adaptive immune system ensure the survival 36 37 of the fetus [7]. However, during PE, immune hyper-reactivity results in maternal intolerance of the fetus [8]. In contrast, in HIV infected individuals, the immune response is suppressed, thus in HIV 38 associated PE a neutralisation of immune response is expected [9, 10]. However, the use of 39 40 Antiretroviral Therapy (ART) causes reconstitution of the immune system [11], thereby predisposing HIV infected women to the development of PE [12]. The complement cascade, a fundamental part of 41 42 the innate immune system is enhanced in the pathogenesis of PE [13-15], hence its inhibition facilitates a successful pregnancy [16]. Notably, the complement system is activated via one of three pathways 43 viz., classical, lectin, or alternative [17] that merge at a central point of C3 convertase production [18]. 44 Thereafter cleavage of C3 convertase leads to a central terminal path that mediates host defence via the 45 opsonization of pathogens, eliciting inflammation, lysis of pathogen cells, and/or clearing of immune 46 complexes [15, 17, 19-21]. However, the role of the complement system in HIV infection is complex, 47 48 as it may protect the host from HIV infection whilst also augmenting the infectivity of HIV [22].

49 Anaphylatoxins are potent inflammatory mediators targeting a vast spectrum of immune and nonimmune cells [23]. Complement component 5a (C5a) is a powerful anaphylatoxin [15, 24, 25]. C5a 50 mediates the release of potent anti-angiogenic factors, soluble vascular endothelial growth factor 51 receptor 1 (sFlt-1) and soluble endoglin (sEng) [26] with a concomitant decline in pro-angiogenic 52 53 growth factors including placental growth factor (PIGF) and vascular endothelial growth factor (VEGF) [26, 27]. Additionally, increased C5a elevates pro-inflammatory cytokines such as Tumour Necrosis 54 55 Factor-alpha (TNF- $\alpha$ ) and Interleukin 6 (IL-6) both known to promote HIV infection [25, 28].

56 Complement component 2 (C2) is a precursor protein and is a critical factor in both the classical 57 pathway (CP) and lectin pathway (LP) [29, 30]. C2 is cleaved to form C3 convertase, C4bC2a [6, 24]. 58 The exact role of C2 in pregnancy and during HIV infection remains unknown. Nonetheless, existing 59 research shows that C2 concentrations are high in pregnancy [16]. Moreover, complement components 60 C1q - C4 are increased in asymptomatic HIV-infected patients compared to healthy controls [31]. In 61 light of the paucity of information available on the regulation of complement components in HIV 62 associated PE, this study aimed to evaluate the concentration of serum C5a and C2 during pregnancy.

# **Materials and Methods**

#### Ethical Approval 64

This prospective study utilized stored serum samples for which institutional ethics class approval (BCA 65 66 338/17) was obtained. Written informed patient consent, hospital manager's approval and the regulatory 67 authority consent were obtained in the primary study. Participants confidentiality was respected, and participant details remained anonymous when processing the samples. 68

#### Study population 69

70 Post consultation with an institutional biostatistician, sample size was calculated using G\*Power 71 statistical software (80% power and 95% probability). To detect a moderate effect size of 0.66 between 72 two groups normotensive vs preeclamptic women or HIV positive vs HIV negative assuming equal 73 groups (n=38 per group), a sample size of 76 pregnant women was required. To compare four groups,

74 normotensive (HIV+ and HIV-) and preeclamptic (HIV+ and HIV-), a sample size of 19 in each group was needed to detect a large effect size of 0.95. A study population of 76 was recruited from a large 75 76 regional hospital, consisting of 38 normotensive and 38 preeclamptic women. Both groups were further stratified by HIV status into 19 HIV positive preeclamptic and 19 HIV non infected preeclamptic, also 77 78 19 HIV positive normotensive pregnancy and 19 HIV non-infected normotensive pregnant women. Inclusion Criteria: the study group consisted of primigravid and multigravida participants, 79 diagnosed with PE ( $\geq$  140/90 mmHg and/or the presence of a single incidence of proteinuria) 80 [4], and participants with a normotensive pregnancy serving as the control group. All HIV 81 82 positive women received antiretroviral therapy (ART). Exclusion Criteria: women with polycystic ovarian syndrome, intrauterine death, cardiac disease, 83

chorioamnionitis, unknown HIV status, eclampsia, sickle cell disease, active asthma that requires
medication during the gestational period, abruption placentae, chronic renal disease, patients who have
been declined from participation, systematic lupus erythematosus, pre-existing seizure disorders, and
thyroid disease were not included in the study group.

## 88 Multiplex Immunoassay

89 Maternal blood samples were collected and centrifuged at 3000 g for 10 minutes at 20°C. Serum was aliquoted and stored at -80°C until required. A cytometric mechanism with a bead-based flow 90 constructed the assay, where multiplex analyses are permitted. Using the manufacturer's instructions, 91 92 Human Complement Magnetic Bead Panel (Millipore by Sigma Aldrich, catalogue number: HCMP1MAG-19K), Bio-Plex<sup>®</sup>MAGPIX<sup>™</sup> (Bio Rad Laboratories, Inc., USA) was utilized, using the 93 94 serum samples. Blank captured antibody with magnetic beads, C5a and C2 samples, antigen samples 95 (1:4 dilution), and standards (serial dilution) were incubated overnight. Post incubation a triple wash eliminated any unbound substances. 50 µL of biotinylated detection antibody was added to each well. 96 97 The assay plate was then incubated for 1 hour and washed to eliminate unbound biotinylated detection antibodies. Thereafter, 50 µL of 1X streptavidin-phycoerythrin (SA-PE) was added into each well. The 98 99 plate was thereafter incubated for 10 minutes at  $850 \pm 50$  rpm in a dark room. The assay plate was

washed 3 times and re-suspended in assay buffer for 30 seconds at 850 ± 50rmp. Lastly, a Bio Plex<sup>®</sup>MAGPIX<sup>TM</sup> Multiplex Reader (Bio Rad Laboratories, Inc., USA) was used to read the assay plate.

#### 102 **Statistical Analysis**

103 Data were analysed utilizing GraphPad Prism 5.00 for Windows (GraphPad Software, San Diego 104 California USA). The Kolmogorov Smirnov normality test was used to check for parametric or non-105 parametric distribution. Non-parametric data are represented as median and interquartile range. 106 Statistical significance according to pregnancy type (preeclamptic vs normotensive) and HIV status 107 (negative vs positive) was determined using a Mann-Whitney's U test. The Dunn's Multiple 108 Comparison post hoc test and the Kruskal-Wallis test determined statistical significance across all groups. A *p*-value of <0.05 was considered to be statistically significant. Spearman's Rank Correlation 109 Coefficient (r) was calculated to determine the relation between clinical/demographic data versus C2 110 and C5a concentrations across the study population (-1 and 1). The outcome results were elucidated 111 112 based on the degree of association as strong (0.7-1), moderate (0.5-0.7), or low (< 0.5) after taking 113 significant correlation values into consideration.

## 114 **Results**

## 115 Patient Demographics and Clinical Characteristics

Patient demographics and clinical characteristics data are represented as median and interquartile range (IQR) in Table 1. Maternal age (p = 0.03), parity (p = 0.01), gravidity (p = 0.04), gestational age (p = 0.001), systolic (p < 0.0001) and diastolic blood pressures (p < 0.0001) were different across the study groups. However, maternal weight (p = 0.11) did not differ across all study groups.

# 126 Serum concentrations of complement component C2

127 *Pregnancy type* - C2 concentration was similar between the normotensive pregnant (median = 24285

pg/ml, IQR = 21319 pg/ml) vs the preeclamptic (median = 22287 pg/ml, IQR = 21701 pg/ml) groups,

regardless of HIV status (Mann-Whitney U = 654; p = 0.4837; Fig 1A).

*HIV status* – The concentration of C2 level between the HIV positive (median = 23180 pg/ml, IQR = 29300 pg/ml) *vs* HIV negative (median = 23118 pg/ml, IQR = 20373 pg/ml) groups showed no
statistical significance, irrespective of pregnancy type, (Mann-Whitney U = 690.5; *p* = 0.7469; Fig 1B). *Across all groups* – The concentration of C2 was similar across all groups (Kruskal-Wallis H =1.098;

134 p = 0.7776; Fig 2.3C; Table 2).

#### 137 Serum concentrations of complement component C5a

- 138 *Pregnancy type* The serum concentration of C5a was significantly higher in the normotensive pregnant
- 139 (median = 6562 pg/ml, IQR = 5302 pg/ml) than the preeclamptic (median = 4745 pg/ml, IQR = 3279
- 140 pg/ml) group, regardless of HIV status (Mann-Whitney U = 532; p = 0.0486; Fig 2A).
- 141 *HIV status* Serum C5a level was similar between the HIV positive (median = 5383 pg/ml, IQR = 4202
- 142 pg/ml) vs HIV negative (median = 5548 pg/ml, IQR = 4726 pg/ml) groups, irrespective of pregnancy

143 type, (Mann-Whitney U = 697; 
$$p = 0.8002$$
; Fig 2B).

- 144 *Across all groups* The concentration of C5a did not differ across all groups (Kruskal-Wallis H = 4.352; 145 p = 0.2259; Fig 2C; Table 2).
- 146 Normotensive HIV status No statistical significance was shown between the normotensive HIV
- 147 negative group (median = 5965 pg/ml, IQR = 6010 pg/ml) vs normotensive HIV positive group (median
- 148 = 7160 pg/ml, IQR = 4958 pg/ml). (Mann-Whitney U = 162; p = 0.6032; Fig 2D).
- 149 *Preeclamptic HIV status* C5a expression was non-significantly different between the preeclamptic
- 150 HIV negative group (median = 5044 pg/ml, IQR = 3093 pg/ml) vs preeclamptic HIV positive group
- 151 (median = 4447 pg/ml, IQR = 3642 pg/ml); (Mann-Whitney U = 159; p = 0.5441; Fig 2E).

## 163 Correlation between maternal demographics and serum C2

### 164 *concentration*

165 Diastolic blood pressure correlates with C2 concentration in normotensive HIV negative participants

166 [r = -0.463 (p < 0.05)] and in preeclamptic HIV negative participants [r = -0.483 (p < 0.05)]. A negative 167 correlation co-efficient demonstrated a relationship between maternal age and C2 [r = -0.482 (p < 0.05)] in preeclamptic HIV positive patients. Table 4 displays the Spearman Rank Correlation Co-169 efficient for all other statistical non-significant maternal clinical/demographic data and C2 170 concentrations.

## 171 Correlation between maternal demographics and serum C5a

#### 172 concentration:

There was a significant correlation between gestational age and C5a concentration [r = -0.523 (p < 0.05)] in normotensive HIV positive patients. Additionally, a positive correlation co-efficient r= 0.615(p < 0.001) was noted between diastolic BP and C5a concentration preeclamptic HIV positive group, likewise a positive correlation was observed between systolic blood pressure and C5a concentration r= 0.483 (p < 0.05) in preeclamptic HIV negative patients (Table 5).

## 186 *Relationship of C2 and C5a*

187 There was no statistically significant correlation of C2 on C5a concentration and vice versa (Table 4).

# 188 **Discussion**

Our study demonstrates a down-regulation of serum C5a concentration in PE compared to normotensive 189 pregnancies, irrespective of HIV status at term. This unexpected finding may be attributed to C5a being 190 191 consumed faster than production, resulting in its rapid removal from circulation [32]. Alternatively, 192 there may be a dysregulation of its receptor (C5aR) or ligand-receptor mediated affinity thereby 193 inhibiting signal transduction. Off note, a knockdown of C5aR with small interfering RNA (siRNA) 194 salvages endothelial cell migration and vessel formation [33]. Endothelial injury and angiogenic inhibition characterises PE development. In normal pregnancy, there is a mild systemic inflammation 195 in response to the semi-allogenic fetus whilst in PE there is excessive maternal inflammation [34]. 196 197 Notably, the anaphylatoxin C5a represents fragments of activated complement proteins that are the main mediators of an inflammatory response. A study conducted by Burwick et al. (2013) demonstrated 198 that plasma concentrations of C5a and C5b-9 are exaggerated in PE, this leads to the urinary excretion 199 of excess C3a, C5a, and C5b-9 [32]. Richani et al. (2005) showed that plasma C5a concentration is 200 elevated in normotensive pregnancies compared to non-pregnant women respectively [16, 35]. These 201 results may be due to inadequate renal clearance/filtration of these circulating complement proteins via 202 [36]. This suggests that complement dysregulation in ongoing disease arises mainly at the level of C5 203 204 [32] and may be a possible explanation for the downregulation of C5a during gestation as observed in PE in our study. 205

Notably, C5a exerts its damaging effect by inducing the release of the potent anti-angiogenic factor,
soluble vascular endothelial growth factor receptor-1 (sVEGFR-1), also known as sFlt-1 [26] (Fig 3).
It is widely accepted that PE is associated with a rise of this scavenger receptor, sFlt-1. This elevation
with a concurrent decline in VEGF and PIGF inhibits endothelial cell migration and tube formation
[26]. Moreover, Govender *et al.* (2013) also reported elevated sEng in PE, regardless of HIV infection

211 supporting an offset of the immune hyperactivity [9]. sEng weakens TGF- $\beta$ 1 receptor transduction and prevents activation of the endothelial nitric oxide synthase 3 (eNOS) action, thereby promoting the 212 development of hypertension. The C5a downregulation in our study, is confounding and may be 213 attributed to our small sample size and ART. In a study by Burwick and Feinberg (2013), Eculizumab 214 215 a monoclonal antibody inhibitor of C5 decreases the production of complement components C5a and C5b-9 and their downstream effects [37,38]. Worldwide, C5 deficiency is correlated with genetic 216 defects. It is possible that a polymorphism of the C5 gene may be involved in C5a dysregulation, in 217 218 fact, a complement C5 gene, c.754G>A:p.A252T mutation has been demonstrated in the Western Cape, South Africa in Black African patients infected with meningococcal disease [39-41]. A single 219 220 nucleotide polymorphism in maternal C5, C5a and fetal CD55 and CD59 may constitute independent 221 risk factors for PE development. It would be interesting to examine the C5a gene in Black African 222 women of isiZulu origin in South Africa.

Our study also reports similar C5a levels between HIV negative compared to HIV positive women, 230 231 regardless of pregnancy type. It is widely accepted that this pattern recognition component is activated 232 during HIV infection because C5a serves to attract dendritic cells and macrophages to sites of HIV entry 233 [42]. Of note, C5aR1 is critical for viral entry [43]. In fact, the targeted reduction of C5aR1 expression 234 reduces HIV infection by 50% because C5aR1 acts as an enhancer of CCR5-mediated HIV entry into 235 macrophages (Fig 3). It is therefore plausible that the similar C5a levels may be attributed to a dysregulation of C5, C5aR1 expression, or ART usage. Nonetheless, C5a has a small amphipathic 236 237 configuration with an antiviral action [44, 45] that blocks herpes simplex virus 1 (HSV-1), HSV-2,

238 hepatitis C, and HIV-1 entry by disrupting the integrity of viral membranes [46-48]. Also, HIV induces the cleavage of C5 to generate the anaphylatoxin C5a, which attracts immature dendritic cells (DC) to 239 promote viral amplification and dissemination [42]. A plausible explanation for the similarity between 240 HIV negative and HIV positive groups in our study may be the inadequate binding of C5a to C5aR, 241 242 mediated by the effect of ART [42]. More specifically, the removal of C-terminal arginyl residues from C5a by the enzyme carboxypeptidase N converts it into a proinflammatory form called 243 Desarginated C5a (C5a<sup>desArg</sup>) [49]; a potent stimulatory factor that primes monocyte-derived 244 245 macrophages for HIV entry. Furthermore, kinetic analyses of HIV replication have shown that exposure 246 to C5a leads to the acceleration of HIV infection in macrophages [25]. Moreover, C5a independently 247 induces release of pro-inflammatory Tumour Necrosis Factor-alpha (TNF- $\alpha$ ), IL-1, and Interleukin 6 (IL-6) by monocytes and macrophages [50, 51]. This increase of pro-inflammatory cytokines TNF- $\alpha$ 248 249 and IL-6 occur in the presence of C5a, and both are known promoters of HIV-1 infection and regulation 250 [25,28]. Maharaj et al. (2017) reported a decrease of IL-2 and TNF- $\alpha$  concentrations in PE and a lower 251 IFN-γ and IL-6 concentrations in HIV-infected preeclamptics receiving HAART relative to uninfected 252 preeclamptic women. HIV infection together with HAART lowers the production of inflammatory cytokines during pregnancy in both successful and preeclamptic pregnancies [52]. It is plausible to 253 254 hypothesize that C5a production has a directly proportional effect on the release of cytokine TNF- $\alpha$  and IL-6. Since these cytokines are reduced in HIV-infected patients, one may deduce that decline emanates 255 from the lower C5a expression. 256

In addition, we report similar C2 expression between PE and normotensive pregnancies, irrespective of 257 258 HIV status albeit a down regulatory trend. This observation in PE is consistent with previous reports where C2 polymorphisms and its deficiency is linked to chronic inflammatory conditions such as 259 systemic lupus erymatosus (SLE) [53, 54]. The clinical manifestations of PE mimics the exacerbated 260 immune microenvironment of SLE, where a 10% penetrance of C2 deficiency occurs [30]. Moreover, 261 262 in pregnant women with SLE, there is complement-mediated injury, predisposing them to a greater risk 263 of PE development, placental insufficiency, miscarriage, and fetal growth restriction [55]. It is widely 264 accepted that the complement cascade is activated in PE via the LP and/or the CP [56]. Activation of

these pathways are impaired in C2 deficient patients where during periods of active disease, serum complement activity is reduced emanating from a low expression of CP components notably C1q, C2, C4 (Fig 3) [57]. Also, C2 deficiency predominates in females [58]. Hepatocytes synthesize 90% of plasma complement components [59]. Since liver enzyme abnormalities occur in approximately 10% of PE [60], it is plausible that the C2 and C5a downregulation in our study may be attributed to liver dysfunction in the PE cohort. In fact, in C5 deficient mice, the administration of murine C5 or C5a restores hepatocyte regeneration while obstruction of C5aR prevents hepatocyte proliferation [61].

272 We also demonstrate that HIV status did not affect serum C2 expression at term, albeit with an 273 upregulated trend. These results are similar to that of Mahajan et al. (2017) who reported in vitro studies 274 of HIV-1 infected astrocytic cell lines and primary astrocytes a significant enhancement of C2 and C3 275 expression [62]. Huson et al. (2015) reported increased C3 and C1q-C4 levels in asymptomatic patients 276 with HIV infection compared to healthy controls [31]. The similar C2 expression in our study may be 277 attributed to HAART the standard treatment for all HIV positive patients in South Africa (SA). It is 278 plausible that HAART lowers C2 levels to re-instate immune response [63]. In an astrocytic U373 cell 279 line, HIV-1 increases mRNA level of C2 [64]. Moreover, the regulation of C2 production may be attributed to HIV viral proteins Nef, Rev, and Tat on the complement promoter protein synthesis in the 280 host cell. Furthermore, structural proteins such as gp120 and gp41 may also regulate HIV expression 281 [65]. Furthermore, the modulation of C2 production may be secondary emanating from HIV-induced 282 transcription factor NFkB, the main controlling factor in viral transcription. 283

284 In our study, we report a moderate correlation between gestational age (r=-0.523), diastolic (r=0.615) and systolic blood pressure (r=0.483) with C5a concentration in normotensive HIV positive, 285 preeclamptic HIV positive and preeclamptic HIV negative respectively. High blood pressure has been 286 287 previously correlated with elevated C5a in humans [66]. Notably, the development of hypertension is also associated with the development of vascular damage [67, 68]. In our study, gestational age was 288 negatively correlated with C5a concentration [r = -0.523 (p < 0.05)] in normotensive HIV positive 289 group. Whilst normal pregnancy is associated with complement activation, gestational age does not 290 291 correlate with the anaphylatoxin C5a [16]. We also report a moderate negative correlation between

292 diastolic blood pressure and C2 concentration in the normotensive HIV negative [r = -0.463 (p < 0.05)]and preeclamptic HIV negative [r = -0.483 (p < 0.05)] participants. In hypertension, C3, C4 and C5 293 levels, all by-products of C2 correlate with development of hypertension [67]. C2 downregulation has 294 been previously linked with age-related macular degeneration and genetic polymorphisms in people of 295 296 Indian ethnicity [69]. Maternal age is a predisposing factor to PE development [70]. This study also reports no significant correlation between C2 concentration on C5a and vice versa. Limitations of our 297 study that may have influenced analyte expression include the small sample size, all HIV infected 298 299 women received ART and the unknown duration of ART/HAART management.

# 300 Conclusion

301 This novel study reports a significant downregulation of C5a in PE. This observation suggests a loss of 302 regulation of complement activation, dysregulation of signal transduction and/ or polymorphisms of C5a in women of African descent. We also demonstrate a similar C5a and C2 expression by HIV status, 303 304 which may be attributed to ART/HAART therapy. Notably, the dysregulation of complement activation will impact the host innate defence, enhancing placental and fetal injury. Further studies should include 305 306 a large cohort that investigates C2, C5a, C5a-desArg, C5aR1 and C5aR2 together with proinflammatory polypeptides in the development of PE. Single nucleotide polymorphisms investigations 307 of these components are required to better understand the complement cascade in complicated 308 pregnancies thereby preventing premature delivery and enabling better clinical management in the 309 310 synergy of HIV and preeclampsia.






