# Post-Traumatic Stress Disorder symptom sub-cluster severity predicts gray matter volume changes better than overall symptom severity

# ABSTRACT

Meta-analysis shows that sub-clusters defined by affected domains of psychosocial functioning capture PTSD subtypes better than symptom clusters defined in the DSM-IV. This pilot study investigated the association between symptom sub-clusters and brain volume in twelve persons with PTSD (females, mean age 40.9 years). Structural magnetic resonance imaging (MRI) images were acquired, and voxel-based morphometry (VBM) was used to estimate local gray matter volume throughout the brain. Participants' gray matter volume was correlated with both overall PTSD severity and sub-cluster severities. In this preliminary study examining sub-clusters and brain morphometry, we found that neuronal changes associated with sub-clusters may provide a more complete understanding of the neuroanatomical changes that occur in PTSD beyond what can be ascertained using overall disorder severity or comparisons with control subjects. The results of our study suggest that the neurobiological changes resulting from severe trauma depend on the specific sub-clusters of symptoms experienced by individuals with PTSD.

# **INTRODUCTION**

The neural plasticity resulting from traumatic stress is well characterized (Karatsoreos & McEwen, 2011; McEwen et al., 1999; Weiss, 2007). Lower volume of the hippocampus, medial prefrontal cortex, and insula is characteristic of individuals with Post-Traumatic Stress Disorder (Rauch et al., 2006; Liberzon, 2008). While studies comparing PTSD and non-PTSD individuals have provided essential information about the neurobiological changes induced by severe trauma, the results of these studies tend to be inconsistent (Krause et al., 2007; Landré, 2010; Pacella et al., 2011; Frewen et al., 2011; Hopper et al., 2007).

Individual differences in PTSD symptoms may contribute to the heterogeneity observed in PTSD group difference studies of brain structure (Kroes et al., 2011). Even in the absence of significant correlation between gray matter volume (GMV) and overall PTSD severity, Kroes et al. (2011) found a correspondence between lower GMV and PTSD symptom clusters as defined in the DSM-IV (American Psychiatric Association, 2000). A limitation of Kroes' study is that the DSM-IV symptom clusters serve to provide physicians with information useful for obtaining a differential diagnosis, rather than providing detail on how specific types of symptoms may be related (e.g. in terms of psychosocial functioning) (Evenden, 1999). Indeed, meta-analysis shows that a four-factor model is preferable to competing models in describing PTSD symptom structure (Yufik and Sims 2010).

The four-factor model, comprised of Hyperarousal, Avoidance, Intrusions, and Dysphoria sub-clusters, demonstrated superior validity and temporal stability in a sample of 396 female survivors of interpersonal violence, 68% of whom were diagnosed with PTSD (Krause et al, 2007).

In the present study, we sought to examine the association between symptom sub-cluster severity, based on the four-factor model, and GMV in patients with PTSD. Understanding the link between sub-clusters and brain volume may illuminate symptom-related biomarkers of PTSD, with implications for treatment.

## METHODS

## **Participants**

Twelve individuals diagnosed with PTSD related to interpersonal violence (IPV-PTSD) participated in the study. Participants were right-handed females, with mean age of 40.9 years (SD = 11.9). All participants experienced a traumatic event since age 18. PTSD diagnosis was assessed using the Clinician-Administered PTSD

Scale (CAPS; Blake et al., 1995). All participants completed at least 12 years of education; 9 participants had completed additional college (5 participants, 42%) or graduate/trade school education (4 participants, 33%). Participants were excluded if they endorsed current substance abuse or dependence, lifetime or current psychosis or bipolar disorder, or current suicidal ideation. Individuals taking antipsychotic medications, benzodiazepines, mood stabilizers, clonidine, propanolol, and certain antidepressants such as selective serotonin reuptake inhibitors (SSRIs) or serotonin norepinephrine reuptake inhibitors (SNRIs) were excluded.

Participants completed the PTSD Checklist (PCL; Weathers et al., 1983), a validated self-report measure (Krause et al., 2007), to assess PTSD severity. Participants' mean score on the PTSD Checklist was 45.5 (*SD* = 9.7), above the recommended cutoff for a diagnosis of PTSD among civilians (Blanchard et al., 1996). Mean subcluster scores for participants are shown in Table 1.

Participants also completed the Center for Epidemiological Studies Depression Scale (CES-D), a self-report screening questionnaire that measures severity of depressive symptoms (Radloff, 1977). Comorbid depression is present in at least 20% of civilian IPV-PTSD patients (O'Campo et al., 2006). The mean CES-D score in 11 of 12 participants was 42.4 (SD = 6.7; one patient had missing data), indicative of a high level of depressive symptoms (Radloff, 1997).

#### Procedure

Patients were recruited for the study via ads in several venues. They were screened by telephone for eligibility, then brought to the Clinical Research Center for study procedures. Prior to participating in the experiment, subjects were screened according to MRI safety procedures at Georgetown University. In adhering to Georgetown University Medical Center Institutional Review Board-approved protocols, written consent was obtained following explanation of experimental procedures and each participant was paid \$50 for their time.

### **Data Acquisition**

Magnetic resonance imaging was performed at the Center for Functional and Molecular Imaging at Georgetown University. Structural MRI data was acquired with a 3-Tesla Siemens Trio whole body scanner (Siemens Medical Systems; Erlangen, Germany) with an 8-channel head coil. Brain volumes were acquired using the T1-weighted structural MPRAGE sequence (TR = 1900 ms, TE = 2.52 ms, TI = 900 ms, FOV = 250 x 250 mm<sup>2</sup>, slice thickness = 1 mm, 176 sagittal slices, 246 × 256 matrix).

#### Data analysis

Voxel-based morphometry was performed in SPM5 (Ashburner et al., 2000) to estimate local GMV throughout the brain. Preprocessing of the structural MPRAGE volume included spatial normalization to the standard MNI152 template using 12-parameter affine and non-linear cosine basis function transformations, and brain segmentation into gray matter, white matter, and cerebrospinal fluid. Gray matter was then modulated using the Jacobian of the spatial normalization transformation to examine GMV. Spatial smoothing was applied to the modulated GMV with a Gaussian kernel, full-width half-max of 12 mm to reduce noise and to allow for individual variability in the transformation into the MNI atlas space.

To examine the association between PTSD symptoms and GMV, we used SPM5 to investigate correlations between GMV and overall PTSD severity, as well as between GMV and symptom sub-clusters of Intrusions, Dysphoria, Hyperarousal, and Avoidance. Overall PTSD severity was determined by the participant's score on the PTSD Checklist (PCL; Weathers et al. 1983). Each item on the PCL is included in a unique sub-cluster (Avoidance, Dysphoria, Hyperarousal, or Intrusions). PTSD subcluster scores were calculated for each participant by summing scores for items within a sub-cluster (Krause et al., 2007). We performed multivariate regression analyses with GMV, PCL overall or subcluster score, and age as variables of interest. Effects of participant age on brain structure were controlled for by modelling age as a nuisance regressor. Whole-brain comparisons were performed for each contrast. Statistical maps were thresholded at a whole-brain level *p-value* < 0.005 (t=3.25) and an extent threshold of 10 to form clusters from which final significance was assessed using a cluster-level corrected threshold of *p* < 0.05. In addition, to account for multiple statistical tests conducted for each subcluster, Bonferroni correction was applied to the activation maps of Intrusions, Dysphoria, Hyperarousal, and Avoidance. MNI coordinates of peak activations were transformed to Talairach coordinates using mni2tal (http://imaging.mrc-

cbu.cam.ac.uk/downloads/MNI2tal/mni2tal.m).

#### RESULTS

Regions of GMV were associated with overall PTSD severity, as reported in Table 1. A positive correlation was observed in left medial frontal gyrus (p = 0.042) and a negative correlation was observed in right parahippocampal gyrus (p = 0.049). All coordinates are reported in Talairach ("tal") space.

Several regions of GMV were associated with individual PTSD sub-clusters. Avoidance symptom severity was negatively correlated with GMV in the right insula (BA13; p < 0.001), bilateral mid-cingulate gyrus (p < 0.001), left inferior temporal gyrus (p = 0.009), right superior temporal gyrus (p < 0.001), and right middle temporal gyrus (BA 21; p < 0.001), and was not positively correlated with GMV in any region of the brain. Hyperarousal symptom severity was positively correlated with GMV in the right anterior cingulate gyrus (BA 32; p < 0.001), and was not negatively correlated with GMV in the right anterior cingulate gyrus (BA 32; p < 0.001), and was not negatively correlated with GMV in the right anterior cingulate gyrus (BA 32; p < 0.001), and was not positively correlated with GMV in the right anterior cingulate gyrus (BA 32; p < 0.001), and was not negatively correlated with GMV in any brain region. There was no significant correlation between severity of Dysphoria symptoms and GMV. Intrusion symptom severity was positively correlated with GMV in the bilateral globus pallidus and putamen (p < 0.001). Intrusion symptom severity was negatively correlated with GMV in the bilateral symptom severity was negatively correlated with GMV in the bilateral posterior cingulate gyrus (BA 31) and left fusiform gyrus (p < 0.001). Table 3 illustrates the brain regions associated with PTSD subcluster severity. All coordinates are reported in Talairach ("tal") space.

### DISCUSSION

Previous studies have found that overall PTSD severity is associated with decreased GMV in the hippocampus and anterior cingulate cortex, particularly in combat populations. However, studies of non-combat populations (e.g. IPV-PTSD) have reported discrepant results, such as no change in GMV (Landré et al., 2010; Jatzko et al., 2006; Fennema-Notestine et al., 2002; Pederson et al., 2004) or increased GMV in the temporal lobe (Golier et al. 2005). The present study suggests that different symptom sub-cluster profiles may account for the divergent GMV findings observed in patients experiencing various precipitating traumas. Our results reveal a large number of brain areas where GMV is correlated with specific symptom clusters but with overall PTSD severity.

Consistent with a previous study examining DSM-IV-defined symptom clusters (Kroes et al., 2011), we found that severity of sub-clusters were differentially associated with brain alterations. We found that severity of the Avoidance subcluster was associated with decreased GMV in the bilateral middle cingulate gyrus, right insula, and bilateral regions of the temporal lobe. Cingulate dysfunction is a genetically-determined risk factor for PTSD

(Pine et al., 2011; Shin et al., 2009) and is associated with the inability to extinguish salient fear associations (Kasai et al., 2008; Quirk et al., 2010). Hopper et al. (2007) reported a negative correlation between activation of the right anterior cingulate and Avoidance symptoms in a script-driven imagery task.

Decreased volume of the temporal cortex has previously been observed in combat-related PTSD. We found that decreased GMV in the superior temporal lobe was associated with heightened Avoidance symptom severity in the present study. In sum, decreased GMV in the cingulate gyrus, insula, and regions of the temporal lobe may be associated with avoidant thoughts and behaviors due to the involvement of these regions in fear extinction, monitoring aversive internal states (Nagai et al., 2007; Strigo et al., 2010), and misattribution of context (Woodward, 2009).

Hyperactive cognitive-appraisal networks in IPV-PTSD may promote hypervigilance symptoms through an exaggerated sensitivity to context cues related to past trauma (Fonzo et al., 2010). Hyperarousal symptoms are mediated by functional interactions between the anterior cingulate cortex and amygdala (Weiss, 2007; Rauch, 2006). We found that hyperarousal symptom severity was positively correlated with GMV in the right anterior cingulate cortex and right inferior parietal lobule. While overall PTSD severity is associated with neuronal loss in the anterior cingulate (Karl et al. 2006; Kasai et al. 2008), such findings may be more pronounced in combat-exposed populations (Landré et al., 2010).

The Intrusions symptom subcluster includes flashbacks, dreams, and reliving of traumatic events. We found that decreased volume in the bilateral posterior cingulate gyrus and left fusiform gyrus, and increased volume in the bilateral globus pallidus and putamen, were associated with Intrusions symptom severity. Consistent with our findings, Lanius et al. (2005) found that PTSD patients with high flashback/reliving symptoms recruited the posterior cingulate cortex over the course of a script-driven imagery fMRI paradigm, whereas control subjects did not. The posterior cingulate plays a role in "assessing the environment and memory" (Vogt et al., 1992); altered function of this region may result in altered self-referential cognition in PTSD (Bluhm, 2012).

Dysphoria symptoms include loss of interest in activities, emotional numbing, and general cognitive disturbance. Despite participants' high level of severe depressive symptoms, we found no correlation between Dysphoria symptoms and GMV. This is likely due to the restriction of range on the CES-D, where scores were well above the cutoff used to screen for depressive disorders.

To our knowledge, this is the first study investigating the relationship between factor-derived symptom sub-clusters and brain structure in IPV-PTSD. Four-factor sub-clusters, particularly Avoidance, may reflect specific domains of psychosocial functioning (Yufik and Sims 2010; Pietrzak et al., 2010). Patients with IPV-PTSD who are highly dependent on avoidant coping strategies benefit less from therapeutic interventions (Leiner et al., 2012; Pacella et al., 2011) and are at higher risk of escalating symptom severity within the first few months of trauma (Pineles et al., 2011).

Our results extend the findings of Kroes et al. (2011). Despite our smaller sample size and the use of a Bonferroni correction for multiple comparisons, we identified a greater number of brain regions correlating with symptom severity than previously observed by Kroes and colleagues, suggesting that the four-factor sub-cluster model accounts for more neurobiological differences found in PTSD.

In conclusion, our preliminary findings indicate that (1) subcluster-based approaches of investigating gray GMV may reveal neurobiological changes overlooked by traditional between-group studies of PTSD; and (2) neuroimaging studies of symptom sub-clusters may potentially reveal associations between brain structure and psychosocial functioning. Limitations of this pilot study include a small sample size and the large age range of our participants. Future investigations exploring the link between PTSD symptom sub-clusters and trauma type, disease progression, and treatment efficacy may supplement group comparisons of patients and healthy controls in the study of this disorder. In particular, studies that strictly focus on between-group differences may overlook key differences among PTSD subtypes, which this analysis suggests could be an important factor in understanding the neurobiological changes induced by PTSD.
