Abstract:	13
Background: Hepatitis B and C virus infections are serious blood borne diseases with global	14

14 health concern particularly in developing countries. The association between survey 15 participant's knowledge, attitude, and practices (KAP) about HBV and HCV infection is rarely 16 studied, particularly among migrants seeking resettlement. Libya is a main transient station for 17 migrants northward toward Europe and the flow is increasing into Al Kufra from neighboring 18 countries that have endemic intermediate and high HBV and HCV prevalence. The purpose of 19 this exploratory descriptive study in Al Kufra was to assess the level of participating migrant's 20 KAP, regarding cause, transmission, prevention, and treatment of viral hepatitis due to HBV 21 and HCV. Method: A cross-sectional study was conducted among 674 sub-Saharan African 22 migrants in Al Kufra, Libya from January to October 2021. Migrant's KAP about HBV and 23 HCV infection was assessed by interview questionnaire. Statistical and data analysis used SPSS 24 version of 25. Results: Out of 700 questionnaires distributed, 674 were returned with a 25 response rate of 96.3%. The study population included 580 (86.1%) males, mean age of 29.6 26 \pm 7.2 SD years. A majority, 508 (75.4%) were illiterate and elementary level, 8 2.483+.232, 27 respectively. Positive significant linear correlations were found between knowledge-attitude (r 28 = 0.524, p < 0.01) knowledge-practice (r = 0.123, p < 0.01) and attitude-practice (r = 0.278, p ≤ 0.01) 29 < 0.01). Ethnicity and education variables were significantly associated with mean KAP. 30 Gender identity and marital status were both significantly associated with mean knowledge and 31 attitude. Conclusion: The migrant population from the neighboring and sub-Saharan African 32 countries have inadequate KAP about HBV and HCV to limit infection. 33

Introduction:

Viral hepatitis B and C are blood borne viruses that infect millions of people worldwide.

Infections with hepatitis B virus (HBV) and C (HCV) virus are leading causes of chronic liver

disease, cirrhosis, liver cancer and associated morbidity and mortality worldwide and are a

primary indication for liver transplantation [19]. Chronic HBV and HCV infections are

responsible for nearly 57% of liver cirrhosis cases (HBV 30%, HCV 27%) and 78% of
42
hepatocellular carcinomas (HBV 53%, HCV 25%), the third most common cause of cancer
43
deaths worldwide [12, 24, 25].

The endemicity of HBV is high in developing areas, including Africa, the Middle East and 45 Southeast Asia, where at least 8% of the population are HBV chronic carriers [39, 24]. The 46 largest burden of morbidity and mortality from chronic liver disease continues to be in nations 47 of the developing world. For example, 5-10% of the adult population in East Asia and sub-48 Saharan Africa are estimated to have chronic HBV infection [28]. The highest reported 49 prevalence of chronic HCV is in Africa. Egypt has the highest prevalence of HCV, with some 50 studies reporting HCV antibody positive rates of up to 15%, with an estimated 10% with 51 chronic viremia [14, 11]. Viral hepatitis disproportionately affects sub- Saharan Africans 52 populations [10, 13, 31, 34, 41, 42] with high rates of migration from countries where 53 childhood HBV vaccination has only recently been implemented [15]. 54

The hepatitis B vaccine is the mainstay of HBV prevention [38]. No vaccine is available for 55 HCV, dictating the importance of education and precautions [38]. These viruses are blood- and 56 bodily fluid-borne, transmitted most commonly through sharing of injection equipment, reuse 57 or poorly sterilized of medical equipment, especially syringes and needles and sharp objects, 58 sexual contact, and mother to child transmission [4, 16, 21]. 59

Countries of high HBV & HCV prevalence are often economically disadvantaged and areas of 60 conflict that are a source of migrants seeking stable high-income regions including Europe and 61

North America. This poses challenges to the public health and immigration systems in the host 62 nations [28] and countries along migration routes [26]. In 2020 the total of international 63 migrants was 280.6 million, making this group the 5th most populous nation [38; 22]. Many 64 migrants move into and remain part of ethnic minority groups maintaining traditional social 65 and cultural behaviors that are reinforced and persist and may have adverse implications for 66 exposure to HBV and HCV [30]. 67

Countries such as Libya along migration routes from countries with high prevalence of viral 68 hepatitis, e.g., sub-Saharan African countries have special problems. Migrants typically suffer 69 from infectious diseases that are more prevalent in countries of origin [14, 26]. Migrants from 70 neighboring and sub-Saharan African countries have been cited as one of the major factors 71 spreading the chronic liver disease and hepatocellular carcinoma with risks of disease 72 transmission to the local population [8, 29]. Lack of access to health care services, lack of basic 73 knowledge, poor to nonexistent personal hygiene, and the inability to obtain information about 74 the transmission and prevention all contribute to the importance of defining issues leading to 75 improvement. 76

The knowledge, attitudes, and practices (KAP) about viral hepatitis transmission, prevention, 77 and liver disease progression among immigrant populations from the neighboring and sub-78 Saharan African countries is likely to have significant bearing on transmission. Studies show 79 that awareness of chronic HBV or HCV in most populations is low but that among migrant 80 populations it tends to be even lower [30; 36]. A combination of factors contributes to disease 81 propagation, including poor knowledge of the diseases, their risk factors and symptoms, lack 82 of access to healthcare and health information, stigma associated with disease, as well as the 83 lack of symptoms from the early stages of liver disease such as viral hepatitis [30; 33; 34]. 84 General knowledge in immigrant populations is not adequate to avoid blood borne diseases. 85 Social and cultural norms, unsafe sexual intercourse, exposure to the blood or body fluids of 86

an infected person, and intravenous drug use may increase the risk of HBV and HCV infection.
Furthermore, minimal education and resources, isolation, and stress contribute the refugees
tendency to engage in risky behavior, increasing the risk of these infections [28]. The purpose
of this study is to determine the state of knowledge, attitudes, and practices related to HBV and
HCV, transmission, consequences, treatment and prevention.

Methods:

The study was conducted from January 1 to October 31, 2021 at the Libyan Red Crescent, Al 93 Kufra branch laboratory in a high migrant area. The study area is located in the southeast of 94 Libya having borders with Egypt to the East and with Sudan and Chad to the South. It is 1700 95 km from Tripoli, the capital city of Libya and 900 km South of the nearest Mediterranean port. 96 The study population of migrants attending at the Libyan Red Crescent Al Kufra branch 97 laboratory included 674 apparently healthy males and females, aged 21–52 years. Knowledge, 98 attitudes, and practices related to HBV and HCV infection were assessed by questionnaire 99 specially designed to permit literacy-independent answers. Questions concerned awareness, 100 beliefs, and attitudes focusing on the causes, transmission, prevention, and treatment of viral 101 hepatitis (Appendix 1-3). Subject categories included behaviors contributing to infection risk 102 with both HBV and HCV; sociodemographic data; and practices of the study population 103 regarding viral hepatitis. A pre-designed, structured questionnaire sheet was completed inside 104 the laboratory by direct personal interview with each migrant individually. The questionnaire 105 was developed and adapted through extensive literature review in English language [1; 5; 20; 106 31; 40]. The questions in knowledge section were further divided into 3 main sections (see 107 Appendix A): the first 19 knowledge questions were general on viral hepatitis diseases; seven 108 significant viral hepatitis transmission risk factors were included in question 20. Question 21 109 includes eight common complications of HBV and HCV infections. The attitude and practice 110

section of questionnaire consist of 13 and 12 questions, respectively. The demographic items 111 included age, gender, education level, and ethnicity. 112

Statistical Analysis:

113

Data were analyzed using Statistical Package for Social Sciences (SPSS) v. 25.0. The relationship 114 between independent categorical variables and the main outcomes of the study (knowledge, attitude, 115 and practice related to transmission and prevention of HBV and HCV infection) were tested using Chi-116 square test. The p-value < 0.05 was considered to be significant. Descriptive statistics were used to 117 illustrate migrants' demographic characteristics. Categorical variables were measured as 118 percentages while continuous variables were expressed as mean \pm standard deviation. 119 Normality of data was tested using Kolmogorov-Smirnov test. Inferential statistics involving 120 Chi-square test, Mann-Whitney U test, Kruskal Wallis H test were used to assess the difference 121 while Spearman's rank correlation coefficient was used to evaluate the relationship between 122 the study variables. Cronbach's alpha was calculated as an indication of internal consistency. 123

Ethics Approval:

Written informed consent was obtained from the study participants after they have been clearly 125 briefed about the objective of the study. They were informed about their right to refuse to 126 participate in the study. 127

Results:

Descriptive statistics for each item in the questionnaire are given in Appendix Tables A1, A2, 130 and A3. A total of 674 African migrants from sub-Saharan Africa, 43.8% Eritrean, 26.6%, 131 Somalian, 21.7%, Ethiopian, and 8% Sudanese, participated in this study (Table 1). Among the 132 674 participants, 87.5% were married, 86.1% were male and 13.9% female. The age range was 133 21–52 years old with a mean age of 29.6 years. A majority of the participants, 75.4%, were 134

illiterate or had a basic education level, while 24.6% of participants had a high school level or 135

above (Table 1).

Of the 700 distributed questionnaires, 674 were returned with a response rate of 96.3%. The140Kolmogorov-Smirnov test revealed non normal distribution of the data. The Cronbach's alpha141of the questionnaire was 0.76 for individual domains, maximum Cronbach's alpha was for142attitude section followed by practices and knowledge section. The reason for low Cronbach's143alpha for knowledge domain might be due to the number of questions as compared to attitude144145

Overall, knowledge regarding HBV and HCV was poor, Table 1a. more than 40% of 146 participants answered Don't know to the 37 questions reflecting understanding. Most (34 of 147 37) questions had an answer either correct or not, of these, only 16% of migrants' answers were 148 correct. For questions of overall indicative knowledge, more than 8 out of 10 migrants, 83.0%, 149 had never heard of viral hepatitis. Less than 1 out of 10 migrants, 7.9%, could identify hepatitis 150 B and C as viral infections (Table 2a). More than 90% of participants had no knowledge about 151 the transmission of HBV and HCV and did not know that a simple test could identify HBV and 152 HCV infections. 153

A majority, 86.5% falsely believed that hepatitis B could be cured (or didn't know), while 157 nearly half, 47.3% believed that hepatitis C is not curable although a third (33.4%) 'did not 158 know'. The vast majority, 98.4% did not know that an HBV vaccine existed and only 1.6% of 159 the migrants had been vaccinated. Moreover, 82.9% had never been screened for HBV. 160

Knowledge of risk factors was also very poor. The overwhelming majority had no 161 understanding that HBV and HCV could be transmitted by mechanisms including: by un-162 sterilized syringes, 90.2%; by blood products and body fluids, 94.2%; and by sharing needles, 163 89.6%. Furthermore, similarly high majorities did not understand that both HBV & HCV could 164 be transmitted by tattooing, 93.5%, sharing personal care items 91.0%, and through sexual 165 contact, 87.7%, (Table 2). Among the 674 migrant participants, only ca. one in 10 understood 166 that complications of chronic hepatitis include liver cancer, liver cirrhosis, fulminant hepatitis, 167 and liver failure (Table 2a). 168

Results of attitude assessment indicated that nearly 90% of the migrants were not concerned169about being infected with HBV or HCV and did not consider the infections a public health170problem Table 2b. Only about 20% believed that they could get HBV or HCV infections and17115% were not worried about it. Only 15% agreed that migrants172

should be tested and less than 10% of participants agreed that the HBV vaccine is safe and 174 effective (Table 2b). Similar to the knowledge response (Table 1a), less than 10% of 175 participants believed or didn't know that HBV was not curable. Reflecting lack of concern, 176 more than 90% of participants we felt comfortable living with people with hepatitis B or C, 177 while 34.3% of the migrants believed that HBV and HCV infection could be transmitted by 178

food. More than two thirds of participants showed a negative attitude towards vaccination 179 (Table 2b). 180

Participating migrant responses to practice assessment questions indicate many unsafe 181 practices that may result in exposure to blood- and body fluid-borne diseases. Very few, 4.3%, 182 indicated that they would seek further diagnosis and treatment if they tested positive for HBV 183 or HCV, Table 2c. Very few indicated a ready source of information about hepatitis B or C, 184 social networks, 4.9%, or friends, 8.0%. Responses reflecting lack of knowledge or reliable 185 source of information, very high proportions of participants indicated high-risk practices for 186 transmission: 84% indicted shared use of injecting materials; 81% indicated shared intravenous 187 drug use; almost all, 98% indicated sharing shaving materials; and with a high rate of sexual 188 activity, ca. 90%, 189

the mean practice score of married migrants was significantly higher than among single 203 migrants. Finally, significantly higher differences were observed between mean knowledge and 204 attitude scores for migrants with high school education compared to those with illiterate/basic 205 education. However, those having high school education had significantly lower mean practice 206 scores. 207

A correlation between different domains of questionnaire was also assessed. The correlation 208 revealed significant positive linear correlations between knowledge-attitude (r = 0.524, p < 209 0.01) knowledge-practice (r = 0.123, p < 0.01) and attitude-practice (r = 0.278, p < 0.01), as 210 shown in Table 4. 211

Using chi-square test, for knowledge scores of the study participants were divided into two 214 categories: good, and poor. Attitude and practice scores of the study participants were divided 215

into three categories: good, fair and poor. On this basis, knowledge was 'Poor', >85%, across 216 all categories of gender, ethnicity, and marital status (Table 5). Attitudes could be considered 217 'Fair' for most categories. But practices were considered 'Poor' for > 2/3's of participants across 218 all categories. 219

Discussion:

Currently, the flow of immigrants into Libya from neighboring countries is increasing. 225 However, there are no post-arrival screening mechanisms for hepatitis B and C viruses to assess 226 migrant conditions or to support public health policy or actions. Accordingly, the purpose of 227 this study was to assess the level of participating migrant's knowledge, attitude, and practices, 228 regarding cause, transmission, prevention and treatment of viral hepatitis due to HBV and 229 HCV. Libya public health professionals are concerned as the country as a whole is classified 230 among geographical regions with low-intermediate endemicity for hepatitis B virus infection 231 and an area of low endemicity for hepatitis C. The prevalence of hepatitis B surface antigen 232

(HBsAg) and anti-HCV antibodies in sub-Saharan African migrants has been found to exceed
30-50% indicating significant cause for concern (27). A plausible reason for this high
prevalence appears related to the lack of knowledge about HBV and HCV, their health
significance, their means of transmission, of actions for preventing infection.

The present study assessed the participant's knowledge, attitude, and practices about HBV and 237 HCV infection. Results clearly show poor KAP towards HBV and HCV among migrants at Al 238 Kufra. An overwhelming lack of knowledge about HBV and HCV, their mode of transmission, 239 and the possibility of prevention by vaccination. was observed among participating migrants 240 Most of these sub-Saharan participants did not know typical ways of transmission, prevention, 241 and development of liver disease. In addition, participants were not aware of the different types 242 of viral hepatitis and did not have access to information about their consequences. Only just 243 over 15% the migrants in our study had basic knowledge about HBV and HCV as a disease of 244 liver, consistent with a previous report of an Ethiopia study in which just 11.0% of the refugees 245 know the relationship between liver cancer and hepatitis B and C. Ethiopia has a population-246 wide prevalence of 7.4 and 3.1% for HBV and HCV respectively [5]. 247

Most of the migrants in this study, 84.12%, did not consider HBV and HCV as a real risk for 248 themselves and for their family. Although this may explain their inadequate practices it almost 249 certainly contributes to high rates of HBV and HCV infection [27]. Migrants participating in 250 this study showed poorly supported attitudes and exceedingly poor practices towards HBV and 251 HCV reflecting their very low state of knowledge important to minimizing risk and infection. 252 A wide range of unsafe practices are evident in the survey responses, exposing the migrants to 253 infection by blood borne diseases. 254

Conclusions:

255

In this screening study, the level of knowledge and awareness of migrant African populations 256 transiting Libya was poor about the concepts of infectious risk associated HBV and HCV. Poor 257

knowledge and lack of awareness of the African immigrants about HBV and HCV must 258 contribute to the prevalence of these infections in developing countries compared with 259 developed ones. Survey results demonstrate that knowledge on transmission is lacking, and 260 awareness about HBV and HCV transmission to others is only fair. Lacking information about 261 transmission and prevention migrants are at risk of contracting HBV and HCV emphasizing 262 the need for education to limit the spread of the blood borne disease. Opportunities exist for 263 attention by Libyan health and immigration authorities to assist migrants seeking improved 264 conditions. Poor knowledge and lack of awareness about HBV and HCV among sub-Saharan 265 populations undoubtedly contributes to the spread of these infections in native countries. 266
