Associations between Traditional Chinese Medicine Body Constitution and Cardiovascular Disease Risk in a White population

Abstract

Introduction Traditional Chinese medicine (TCM) has guided generations of practice on disease treatment and health maintenance. The TCM principles include the framework of body constitution (BC). In essence, it represents one of the first attempts at applying the principle of personalized, precision medicine. Major limitations to broad implementation of the body constitution (BC) framework, and perhaps TCM as a whole, include not only a lack of empirical study about its relation to other models of health maintenance but also a poor understanding of its applicability outside of Chinese population.

Methods We conducted a study using baseline data from the Personalized Prevention of Colorectal Cancer Trial. 191 participants from an almost entirely White population were evaluated for BC type.

Results Fifty-seven (29.8%) were identified as neutral BC, while Blood-stasis (17.3%), Qideficient (13.6%), and Special diathesis (10.5%) were the pre-eminent pathologic subtypes. We also found there are substantial differences in proportions of TCM BC types in our study of white Americans conducted in US from previous studies conducted in Chinese populations. Additional analyses investigated the relationship between cardiovascular disease (CVD) risk and BC subtypes. Among them, Yang-deficiency, Yin-deficiency, and Blood stasis carried a lower risk of CVD.

Conclusions It is important to understand the underlying mechanisms contributing to these differences, which may not only help to understand the underlying mechanism for TCM, but also help to identify novel factors or mechanisms for CVD risk, prevention and treatment.

1 Introduction

In Traditional Chinese Medicine (TCM), a primary framework of health maintenance and 3 surveillance hinges upon the classification of individuals into nine categories of "body 4 5 constitutions" (BC): Gentleness type, Qi-deficiency type, Yang-deficiency type, Yin-deficiency type, Phlegm-dampness type, Dampness-heat type, Blood-stasis type, Qi-depression type, and 6 Special diathesis type ¹. These BCs help to draw a picture of an individual's health status and 7 have been used on a provider-specific basis to identify patients who may be at risk for future 8 disease, such as cardiovascular disease (CVD). However, TCM has a very limited role in 9 10 Western medical practice and part of the reason for this is a simple lack of data concerning its 11 application in Western populations. Additionally, while BCs are generally assigned based on different measures of an individual's health, there exists little in the way of standardization when 12 it comes to broadly applying this health framework in the clinical setting ²⁻⁵. What is more, there 13 have been few studies regarding the relationship between TCM principles and contemporary 14 models of health and disease. For example, the BC types of Yin and Yang-deficiency, which 15 describe individuals who are routinely hot/anxious or cold/sluggish, seem to hint at 16 manifestations of thyroid disease. Despite these parallels, little has been done to study what 17 possible relations may exist between the BC framework and our current understanding of health 18 19 and disease. Studies of this kind may not only help us understand more about the BC principle, 20 but may also establish a role for BCs in current medical practices, such as in diagnostic screens. 21 Su et al. developed the most commonly used questionnaire to stratify individuals into the 9 major 22

BC types 6,7 . With this more standard approach, a number of studies have attempted to then

explore utility of the TCM BC structure, specifically with the intent to identify a biological basis

for the different BC types. In one particular study, associations between TCM BC types and
HLA polymorphisms were identified ⁸. In a similar study, it was discovered that specific BC
types are more likely to carry genetic variations of metabolic genes ⁹. These efforts represent
attempts to ground the principles of the TCM BC framework in empiric data that explores
physiologic and genetic bases for the different TCM BCs. This will in turn help identify clinical
associations to chronic disease.

CVD is of particular interest in this study. It remains the leading cause of death worldwide, in 32 33 particular due to its subtypes of coronary artery disease (CAD), as well as its manifestations of acute coronary syndrome (ACS) and myocardial infarction (MI)^{10,11}. The landmark Framingham 34 Heart study provided data to establish what are now well-known risk factors of CVD, including 35 cigarette smoking, cholesterol, blood pressure, and others ¹². Understanding and identifying these 36 risk factors have led to major advances in health maintenance, including the advent of routine 37 blood pressure monitoring, regular exercise, and lipid control. Nonetheless, heart disease remains 38 39 the leading cause of death in the US. Thus, there is a need to identify other early markers of CVD or populations at greatest risk to further preventive cardiology. The relationship of TCM 40 BCs and markers of chronic disease, including dyslipidemia, hypertension, diabetes, etc., have 41 42 further been studied and helped foster increased interest in the TCM BC system, as they might serve as an early indicator of needed intervention for specific chronic illnesses ¹³⁻¹⁵. 43 44

45 However, all of these previous studies using TCM BC have been conducted in Chinese

46 populations except for one study of 400 White college students attending three Beijing

47 universities in China¹⁶. In addition, none of the previous studies have examined the associations

48	between TCM BCs and CVD risk. To that end, the aim of this study is to investigate the ability
49	for TCM BCs to identify participants at higher risk for CVD per general cardiovascular risk
50	score (GCRS), an updated version of the original Framingham risk score (FRS), in a US
51	population of white individuals; whether TCM BC is a better correlate of biomarkers of CVD
52	(C-reactive protein (CRP) and uric acid) ^{17,18} than the GCRS; and whether TCM BC is associated
53	with weight, body mass index and waist-to-hip ratio. In the same way that the Framingham
54	study gave physicians insight on which health parameters may predict later heart disease, we
55	seek to determine the potential value of utilizing TCM BCs in the clinical setting to predict CVD
56	development ^{19,20} .

58 Materials and Methods

We conducted a cross-sectional study using baseline data from the Personalized Prevention of Colorectal Cancer Trial (PPCCT; NCT01105169 at ClinicalTrials.gov). The primary aim of the PPCCT was to examine the effect of Mg supplementation on expression of carcinogenesis biomarkers in colorectal mucosa. Between 2010 and 2017, the PPCCT enrolled 250 participants, aged 40 to 85 years, with high risk of colorectal cancer from Vanderbilt University Medical Center. Detailed inclusion and exclusion criteria have been reported (Supplemental materials)
^{21,22}. The study was approved by the Vanderbilt Institutional Review Board.

67 Constitution in Traditional Chinese Medicine Questionnaire

- 68 A self-administered Traditional Chinese Medicine Questionnaire (TCMQ) was implemented for
- a subset of participants enrolled from May 31, 2012 to Jan 30, 2016 (n=191). The original

70 version of the standardized Constitution in TCMO was developed in China with sensitivity and specificity of predicting BC types ranging from 42.7% to 82.7%^{1,7}. The TCMQ was translated to 71 English by the research team and tested in cognitive debriefing interviews before it was applied 72 73 in the study. The TCMQ consists of 60 questions, which fall into nine subscales that correspond to one of nine TCM BC types: Gentleness (8 Items), Qi-deficiency (8 Items), Yang-deficiency 74 (7 Items), Yin-deficiency (8 Items), Phlegm-wetness (8 Items), Wetness-heat (6 Items), Blood-75 76 stasis (7 Items), Qi-depression (7 Items), and Special diathesis (7 Items). Six of the questions 77 exhibit overlap between different subscales.

The 60-item questionnaire is graded on a 5-point Likert scale, ranging from 1 (not at all) to 5
(very much). Each of the nine subscales within the TCMQ assess one type of the TCM BC
individually. A total score of each subscale is obtained by summing relevant item scores ²³.
Then, the transformed score was generated for each type by using the following equation.

83 Following the criteria, a higher score in a specific TCMQ BC subscale indicates a higher likelihood of the corresponding BC type, with a score of 30 being a "threshold" for case 84 85 definition. To ultimately classify a participant within a specific TCM BC, the following algorithm is applied: when 1) the score for the Gentleness subscale is greater than or equal to 60 86 87 and other BC type scores are less than 30, the study participant is diagnosed as "Gentleness" 88 which is considered the neutral BC; when 2) the score for an imbalanced BC type (all other BCs) 89 is greater than or equal to 40, then the participant is regarded as one or more of eight imbalanced 90 BC types; when 3) a BC type score is between 30-40, the diagnosis will be made by a wellmedRxiv preprint doi: https://doi.org/10.1101/2022.12.13.22283433; this version posted December 20, 2022. 91 trained Chinese Medicine Practitioner. Based on the TCM theory, coexistence of multiple
92 imbalanced BC types was possible.

93 General cardiovascular risk score

Participants completed a telephone interviewer-administered survey at baseline to solicit 94 95 information on medical history, tobacco and alcohol use, and other risk factors for colorectal 96 cancer. Persons who smoked cigarettes regularly, measured by packs per day, during the previous 12 months were classified as smokers. During each clinic visit, the participant's use of 97 medications and biosamples were collected. Weight, height, waist and hip circumference as well 98 as systolic and diastolic blood pressure, were measured. Body mass index (BMI) (kg/m^2) and 99 100 waist hip ratio (WHR) were calculated. Serum samples were assayed for a lipid profile (low-101 density lipoproteins cholesterol (LDL-C), high-density lipoproteins cholesterol (HDL-C), total cholesterol (TC), and triglycerides, c-reactive protein (CRP), and uric acid at the Vanderbilt 102 Lipid Laboratory which is standardized by the Centers for Disease Control and Prevention for 103 104 lipid analysis (Supplemental materials). Those used antihypertensive medication, blood pressure categorization was made accordingly. Participant characteristics were then assigned specific 105 106 point values, with total points being then converted to a general cardiovascular risk score, 107 representing a person's 10yr risk of CVD. This score is a derivative of the original Framingham risk score (FRS) produced by the same group. However, it was reported to be better in predicting 108 CVD risk, which may be explained by the modeling of risk factors continuous variables (as 109 opposed to categories in the model developed by Wilson et al)²⁴. A risk assessment calculator 110 based on the Cox regression model of proportional hazards was utilized to obtain participant 111 GCRS²⁵. 112

128 Statistical analyses

129 We performed generalized linear model for continuous variables or Pearson chi-squared tests for

- 130 categorial variable to evaluate the differences among the nine types of TCM BC. We further
- 131 evaluated the impact of significant differences among Gentleness group, Low CVD risk group
- and the remaining group. Mean \pm standard deviation for continuous demographic variables and
- 133 percentage for categorical demographic variables were presented in Table 2 and Table 3.
- 134 Additionally, we performed analyses stratified by sex. All P values are two sided and statistical

significance was determined using an alpha level of 0.05. The data analyses used software SAS

138 **Results**

- 139 For the reliability and validity of the self-administered Traditional Chinese Medicine
- 140 Questionnaire (English Version), the construct validity was confirmed with scaling success rates
- 141 that ranged from 75.0 to 100% (Supplemental Table 2), and confirmatory factor analysis indicate
- 142 an acceptable model fit. The results of reliability for test-retest reliability (intra-class correlation
- 143 coefficients) were 0.7-0.8 (Supplemental Table 3), the Cronbach's alphas ranged from 0.44 to
- 144 0.72 during three-month period.

As shown in Table 1, the distribution of BC types varied greatly between this study and previous
studies conducted in Chinese populations. Gentleness (29.8%) was the predominant BC type in
this study, while the three most common pathologic BC types were Blood-stasis (17.3%), Qideficient (13.6%), and Special diathesis (10.5%). In contrast, the most common pathologic BC
types found in Chinese populations, in no particular order, were Qi-deficient, Yang-deficient,
Yin-deficient, and Phlegm-Dampness.

The characteristics of the study participants are shown overall and by BC type in Table 2.Among the 191 participants, the median age was 60, a minority were active smokers, and a

majority were using anti-hypertensive and anti-lipid medications, both of which reflect a higher
risk of CVD. There were statistically significant differences in the distribution of several factors
across the various BC types. These included BMI, gender, CRP, and GCRS. Specifically, the
Gentleness BC had a generally lower average BMI (28.9), CRP (2.2), and GCRS (20.6), as well
as lower female predominance (26.3%) compared to other groups.

161 *Comparison of cardiovascular disease risk among TCM subtypes*

162 Among participants using hypertensive medication, the three most common BC types were

163 Gentleness (26.9%), Qi-deficient (21.8%), and Blood-stasis (15.4%) (results not shown in table).

164 On the other hand, the predominant types among participants using lipid control medications

were Gentleness (27.9%), Qi-deficient (19.1%), Blood stasis (17.7%), and Special diathesis

166 (11.8%) (results not shown in table). The GCRS averages, which represent a 10-year risk of

167 cardiovascular disease, were statistically significantly different across BC types (p=0.013).

168 Specifically, individuals in Yang-deficiency (6.4), Blood stasis (12.9), and Yin-deficiency (13.2),

had a substantially lower risk of cardiovascular disease than other groups (Table 2). These BC

170 types were also more common among women than among men.

171 To further investigate the characteristics of the three BC types with lower CVD risk, we

172 combined individuals of these BC types into one low-risk group, and compared this new group

against both the normal "Gentleness" type and the combination of the other 5 TCM groups

- 174 (Table 3). As previously noted, the low-risk group had a significantly higher proportion of
- women. Additionally, individuals in these groups were younger (57.8 y, p=0.047) than their
- 176 counterparts in the rest of the study (61.0 y and 60.8 y, respectively). They also tended to have a

177 higher average serum HDL-C (p=0.228), which is known to be protective against CVD,

178 compared to counterparts. This low-risk group also had the highest percentage of never-smokers

and never-drinkers compared to the other groups, although this difference was not statistically

180 significant. In stratified analysis by sex, there were no statistically significant differences for

181 BMI, CRP, uric acid, or the GCRS (Table 4) by BC type.

183 Stratified analyses by CRP and Uric acid levels

184 Based on previous studies which linked elevated CRP and uric acid to increased CVD risk, we classified our study population into "normal" and "elevated" groups. Specifically, individuals 185 with CRP levels >10 mg/dL and uric acid >5.5 mg/dL were sorted into elevated CRP and uric 186 187 acid groups, respectively. Average GCRS were 14.7 and 19.9 in the elevated and normal CRP 188 groups, respectively; on the other hand, average GCRS was 21.7 and 16.8 in the elevated and normal uric acid groups, respectively. Analyses were then conducted to identify if specific TCM 189 subtypes were associated with elevated biomarker levels. While there were no noticeable 190 191 differences in the distribution of individuals with elevated CRP levels, the low-risk CVD group 192 had a significantly lower level of elevated uric acid (Table 3). Further analysis of these findings 193 occurred by stratifying the population by gender. Results of these analyses were not significant 194 in terms of the distribution of individuals with elevated CRP/Uric acid levels (Table 4).

197 **Discussion**

All previous studies of BC type have been conducted in Chinese populations except for a study
of White college students in China ¹⁶. The present study, to the best of our knowledge, is the first

to be done in an American population ²⁶. The major types of TCM BC in our study of white
individuals in the US were different from the types among Chinese in China. Furthermore, in this
cross-sectional study, we newly examined the relationships between the nine BC types with
predictive models or markers of CVD, in particular the GCRS.

204 Our study of white individuals in the US had a large proportion of Blood-Stasis (17.3%) and Special Diathesis types (10.5%). No previous study has been conducted in US populations. In a 205 previous large study with 8,448 participants conducted within Chinese population, the most 206 common pathologic BC subtypes are Oi-deficient (13.4%), Dampness-Heat (9.1%) and Yang-207 deficient $(9.0\%)^{27}$. The difference between our study of white individuals in the US and this 208 large study conducted in Chinese population may be due to multiple factors. First, our study 209 participants may not represent the general US population. Thus, our finding needs to be 210 confirmed by future larger studies conducted in US population. Secondly, this difference could 211 212 be due to different genetic background. Thirdly, the difference could be caused by regional environmental factors as our study was conducted in one state in the US. There was one previous 213 study of Caucasian college students attending three Beijing Universities in China¹⁶. We found 214 215 the distribution of major types of TCM BC in this earlier study is also different from that in our study. However, the White college students recruited in this earlier study were mostly younger 216 than 50 years old and lived in Beijing, a Northern city in China while most of the participants in 217 218 our study were older than 50 years and lived in a single US state. Thus, the differences could be caused by age and regional environmental factors. 219

221 Another potential explanation for these discrepancies may lie in identifying how biomarkers of 222 common diseases contribute to an individual's TCM subtype. In our study, significant 223 differences were found among the nine different BC types by various different biomarkers and 224 vitals for cardiovascular disease. Some of these findings were expected, such as lower BMIs in the "healthy" Gentleness controls and the classically thinner Blood-stasis compositions²⁸. 225 However, the elevated BMIs in most other BC types, including the Phlegm-dampness and Yin-226 deficient types stand in contrast to findings in studies conducted in Chinese populations²⁹. 227 228 Again, the reason is unclear. For example, White, and in particular White Americans, peoples tend to have a higher overall BMI than Asian populations³⁰. If BMI contributes to a person's 229 TCM BC type, then it may help to explain the differences in proportion of TCM BC subtypes 230 between an American and Chinese populations. Taken a step further this could reflect differences 231 232 in disease prevalence, such as cardiovascular disease, from one population to another, as previous studies found the incidence rates of cardiovascular disease and cancers (i.e. breast 233 234 cancer, colorectal cancer and prostate cancer) are much higher in US populations than in Chinese populations ^{31,32}. Zhu et al. also identified which TCM subtypes were more represented among 235 major chronic diseases, including hypertension, hyperlipidemia, and hyperglycemia. Thus, 236 further understanding the underlying mechanism for the difference in TCM BC type between US 237 and Chinese population may help to identify the novel risk factors contributing to common 238 disease etiology. 239

Another primary research focus of this study was the GCRS, which represents an individual's percent risk of cardiovascular disease (CVD) in 10 years, with a higher score necessarily translating to a higher percent risk. Again, our analyses revealed significant differences in the overall GCRS across BC types. Constitutions with the lowest average GCRS included Yang

deficient (6.4), Blood-stasis (12.9), and Yin deficient (13.2), while Dampness-Heat (DH) (27.4)
and Qi-deficient (21.9) recorded the highest GCRS.

246 Further subgroup analysis of the three low-CVD risk groups (Yin/Yang-deficient and BS) 247 revealed a significantly lower average age and BMI, as well as a higher predominance of 248 women, compared to both the Gentleness group and the remaining 5 groups. This biologically makes sense in the context of the Framingham model, which typically associated men, 249 250 particularly older and more obese men, with increased CVD risk. Another finding was a 251 significantly lower uric acid level among the low-CVD risk group. While uric acid was not a 252 component of the initial Framingham study, more recent literature has reported on an association 253 between uric acid and CVD risk, specifically an association between elevated uric acid (>5.5) and increased CVD risk ³³. Stratified analyses by sex revealed a loss of significance in the 254 255 differences in BMI, GCRS, and Uric acid. Mediation analysis was also conducted, which 256 revealed no significant effect mediation by sex. Thus, the loss of statistical significance when 257 stratified by sex may be due to reduced sample size as we also found the patterns still remained in the stratified analysis. 258

259 The major limitation of the study was the sample size, specifically the sample sizes in each BC 260 group, which limits the power of the analysis in stratified analysis. Secondly, the limitation is 261 that not all parts of the survey were easily translatable to English from the original Chinese version due to the cultural differences, with some questions, such as those involving "sighing 262 without reason" or "thick saliva" perhaps being less readily answered by our exclusively 263 264 American population. However, this only appeared in limited survey questions which may not materially affect the directions of results. Also, this non-differential misclassification caused by 265 the translation in cultural difference usually biases the results to the null. In other words, the true 266

267	associations may be stronger than the ones we observed. Thirdly, the limitation is that we did not
268	collect family history of cardiovascular disease and cannot adjust for this covariate in the current
269	study. Further studies are warranted to examine whether family history of CVD contributes to
270	the TCM BC types related to CVD risk. Finally, although the intra-class correlation coefficients
271	ranging from 0.7 to 0.8 and the Cronbach's alphas ranging from 0.44 to 0.72 are reasonable for
272	reliability, these findings indicate that TCM BC types could vary during the three-month period
273	in a study of White individuals in the US. Further studies are warranted to identify the factors
274	contributing to the changes.

The majority of previous studies conducted in Mainland China which have investigated a similar 276 topic have noted significant associations between CAD and particular TCM BC types, in 277 particular Yin/Yang deficiency as well as Phlegm-dampness^{14,34}. These findings have helped 278 practitioners in China to better identify patients at risk for CVD and therefore initiate a 279 280 preventive health regimen. Additional studies have also postulated associations between BC types and chemokine receptor/ligan expression, which would hold implications for a whole host 281 of pathologies, including immunology and oncology. Translating these promising findings to an 282 283 American population could be beneficial, given the prevalence of CVD in the United States. However, our findings found although there are similarities, there are substantial differences 284 between these two populations. Future studies should aim to understand the underlying 285 286 mechanisms contributing to these differences, which may not only help to understand the underlying mechanism for TCM, but also help to identify novel factors or mechanisms for CVD 287 risk, prevention and treatment. 288
