49 Abstract

50 Background

The extent to which physical activity attenuates the detrimental effects of sugar (SSBs)- or artificiallysweetened beverages (ASBs) on the risk of cardiovascular disease is unknown.

53 Methods

We used Cox proportional-hazards models to calculate hazard ratios and 95% confidence interval [HR (CI)] between SSB or ASB intake and physical activity with cardiovascular disease risk among 65,730 women in the Nurses' Health Study (1980-2016) and 39,418 men in the Health Professional's Followup Study (1986-2016), who were free from chronic diseases at baseline. SSBs and ASBs were assessed every 4-years and physical activity biannually.

59 **Results**

- 60 A total of 13,269 cardiovascular events were ascertained during 3,001,213 person-years of follow-up.
- 61 Compared with those that never/rarely consumed SSBs or ASBs, HR and 95% CI for cardiovascular
- disease for participants consuming ≥ 2 servings/day were 1.21 (95% CI,1.12 to 1.32; *P*-trend<0.001)
- and 1.03 (95% CI, 0.97 to 1.09; *P*-trend=0.06), respectively. In the joint analyses, for participants
- 64 meeting and not meeting physical activity guidelines ($<7.5 \text{ vs} \ge 7.5 \text{ MET-h/week}$) as well as consuming
- $\geq 2 \text{ servings/day of SSBs or ASBs, the HRs for cardiovascular disease were 1.15 (95% CI, 1.08 to 1.23)}$

66 and 0.96 (95% CI, 0.91 to 1.02), and 1.47 (95% CI, 1.37 to 1.57) and 1.29 (95% CI, 1.22 to 1.37)

- respectively, compared with participants who met physical activity guidelines and never/rarely
- 68 consumed these beverages. Similar patterns were observed when coronary heart disease and stroke

69 were analyzed.

70 Conclusions

Our findings suggest that among physically active participants, higher SSB intake, but not ASBs, is associated with a higher cardiovascular risk. Our results support current recommendations to limit the intake of SSB and maintain adequate physical activity levels.

78 Clinical Perspective

79 What is new?

80	•	Consumption of sugar- or artificially-sweetened beverages and physical activity are
81		independently associated with cardiovascular disease; nevertheless, the role that physical
82		activity plays in the associations between sugar- and artificially-sweetened beverages
83		consumption and cardiovascular disease warrants further analysis since physical activity could
84		offset the health risk that would have been induced by their consumption.
85	•	In two US cohorts, not meeting physical activity guidelines jointly with a greater intake of
86		sugar- or artificially-sweetened beverages was associated with a higher risk of cardiovascular
87		disease; however, even when individuals were physically active, higher consumption of sugar-
88		sweetened beverages was associated with a higher cardiovascular risk.
89		
90	What	are the clinical implications?
91	•	Our results provide further evidence of the intake of sugar-sweetened beverages and low
92		physical activity as factors negatively impacting cardiovascular health.
93	•	Our results support public health recommendations and policies to limit the intake of sugar-
94		sweetened beverages and meet and maintain adequate physical activity levels.

98 Introduction

Sugar-sweetened beverages (SSBs) have a detrimental impact on health^{1–5} and are associated 99 with a higher risk of cardiovascular disease (CVD),^{1,6–11} the leading cause of mortality worldwide.¹² 100 Although there has been a nationwide decline in SSB consumption since 2000,¹³ they remain the single 101 largest source of calories and added sugar in the diet.¹⁴ In contrast, the intake of artificially-sweetened 102 beverages (ASBs) has increased in the United States (US).¹⁵ They are used as 'healthier' alternatives to 103 SSBs and may be an effective strategy to help control caloric intake and support weight loss.¹⁶ 104 However, evidence on the long-term health impact of ASBs on incident CVD is still inconclusive.¹⁷⁻¹⁹ 105 Furthermore, the role that physical activity plays in the association between SSB or ASB consumption 106 and the risk of CVD warrants further analysis. Independently, physical activity is cardioprotective,^{20,21} 107 and the majority of SSB or ASB intake studies adjust for physical activity. A counterargument is the 108 probable role that physical activity could play to offset the potential health risk that would have been 109 induced by SSB or ASB intake. Thus, the implication is that given the same level of exposure to SSB 110 or ASB intake, those who meet physical activity recommendations would have a relatively lower risk 111 of CVD than those who are not physically active. Therefore, the aim of this study is to examine the 112 independent and joint associations between SSB or ASB consumption and physical activity in relation 113 to the risk of CVD in men and women from two large US prospective cohort studies. 114

115 Methods

116 Study Population and Design

117 The Nurses' Health Study (NHS), a prospective study initiated in 1976, enrolled 121,700 118 registered nurses aged 30-55 years. The Health Professionals Follow-up Study (HPFS), a prospective 119 study established in 1986, enrolled 51,529 US male health professionals aged 40-75 years. Baseline 120 and follow-up questionnaires were sent to participants every 2-years to update medical, lifestyle, and 121 health information. Follow-up rates exceed 90% for each 2-year cycle. Diet was assessed using a self-122 administered food frequency questionnaire every 4-years, first collected in 1980 in NHS and 1986 for

HPFS, used as this study's baseline cycles. A detailed description of the two cohorts has been
 previously reported.^{22,23}

We excluded individuals with a history of diabetes mellitus, CVD, or cancer at or before
baseline; missing information regarding SSB and physical activity; or implausible caloric intake (<500
or >3500 kcal/day in women, and <800 kcal or >4200 kcal/day in men). The final analysis included
65,730 women and 39,418 men. The protocol was approved by the institutional review board of
Brigham and Women's Hospital and Harvard T.H. Chan School of Public Health. All participants gave
informed consent.

131 Dietary Assessment and Sugar-Sweetened Beverage Intake

Intakes of SSBs and ASBs were assessed using a validated and reproducible food frequency 132 questionnaire designed to assess the usual diet over the previous year. The reproducibility and validity 133 of these instruments have been described previously.^{24,25} Participants were asked how often, on 134 average, they consumed a standard portion of foods and beverages (one standard glass, bottle, or can), 135 with possible responses ranging from 'never or less than once/month to '≥6 times/day'. SSBs were 136 defined as carbonated sugar-sweetened beverages (caffeinated colas, caffeine-free colas, or other), and 137 noncarbonated sugar-sweetened beverages (fruit punches, lemonades, or other fruit drinks). Fruit juices 138 were not considered SSBs since sugar is naturally present. ASBs were defined as caffeinated, caffeine-139 free, and noncarbonated low-calorie or diet beverages. 140

141 Physical Activity Assessment

Participants' physical activity was assessed every 4-years by reporting the average time per week spent in various moderate- or vigorous-intensity leisure-time activities in the preceding year, using a validated self-reported questionnaire.²⁶ Based on the intensity and duration of each activity, weekly expenditure in metabolic equivalent tasks (MET-hr/week) was calculated and summed over all

146 activities for total physical activity.

147 Ascertainment of Cardiovascular Disease Incidence

The primary outcome was incident total CVD, defined as a composite of fatal and nonfatal 148 coronary heart disease (CHD, including myocardial infarction) and fatal and nonfatal stroke. 149 150 Secondary outcomes were CHD, defined as fatal CHD or nonfatal myocardial infarction, and stroke. In 151 both the NHS and HPFS cohorts, when a participant (or family members) reported an incident event, permission was requested to examine their medical records by the study investigator-physicians who 152 153 were blinded to the participant's risk factor status. For each endpoint, the month and year of diagnosis 154 were recorded as the diagnosis date. Nonfatal events were confirmed through a review of medical records. Myocardial infarction was defined according to the World Health Organization criteria.²⁷ 155 Strokes were confirmed if data in the medical records fulfilled the National Survey of Stroke criteria.²⁸ 156 157 Strokes were classified as ischemic stroke (thrombotic or embolic occlusion of a cerebral artery), hemorrhagic stroke (subarachnoid and intraparenchymal hemorrhage), or stroke of probable and/or 158 159 unknown subtype (subtype data not available). Death ascertainment was performed by searching the National Death Index,²⁹ by family members' responses to follow-up questionnaires, or by reports from 160 participants' professional organizations. We requested access to medical records, autopsy reports, and 161 death certificates to confirm all suspected deaths due to myocardial infarction. Fatal myocardial 162 infarction was confirmed by medical records or autopsy reports. We included all confirmed and 163 probable cases in our report because results were similar after probable cases were excluded. Follow-164 up for deaths was >98% complete. 165

166 Assessment of Covariates

Information on lifestyle and CVD risk factors was assessed and updated every other year and included: age; weight; smoking status; use of aspirin, multivitamins, postmenopausal hormonereplacement therapy, and oral contraceptives; menopausal status; and hypertension or hypercholesterolemia that had been recently diagnosed by a physician; and family history of chronic diseases. Height was ascertained for women in 1976 and for men in 1986. Height and body weight were used to calculate body mass index (BMI; weight in kilograms divided by height in meters

squared). Alcohol intake was assessed, and updated, from the food frequency questionnaires every 4 173 years. Ancestry information was collected in1986 for men and in 1992 for women. The Alternate 174 175 Healthy Eating Index (AHEI, range 0-90; higher score indicating adherence to Dietary Guidelines for 176 Americans) was calculated from food frequency questionnaire data, without the exposure (SSBs) and 177 alcohol (we considered as a separate confounder) components, to indicate participant's overall diet quality.³⁰ 178 179 Statistical Analysis 180 Person-years of follow-up were calculated from the return of the baseline questionnaire to the date of 181 diagnosis of CVD, death, or end of follow-up whichever came first. We used Cox proportional-hazards models to estimate hazard ratios and 95% confidence intervals (HRs [CIs]) of developing CVD 182 according to the independent and joint associations of SSB or ASB intakes and physical activity. 183 For the independent association analysis between SSB or ASB intakes and risk of CVD, we 184 calculated the cumulative averages of SSBs and ASBs, and subtypes, at each updated food-frequency 185 questionnaire to approximate long-term habitual intakes. Beverage intake was categorized by 186 frequency: <1/month (reference), 1–4/month, 2–6/week, 1-<2/day, and $\geq 2/day$, and linear trends were 187 evaluated using the Wald test on a continuous variable representing median intakes of each category. 188 The same categorization was applied to SSB and ASB sub-types. We also evaluated the association for 189 1 serving increase of SSB and ASB intakes per day in the multivariable models. In Model 1 we 190 adjusted for age; race; ancestry; alcohol intake; smoking status; physical activity (for independent SSB 191 192 and ASB models, in quintiles); family history of myocardial infarction; baseline hypertension or antihypertensive medication; baseline hypercholesterolemia or cholesterol-lowering medication; 193 multivitamin and aspirin use; menopausal status and use of hormone-replacement therapy (in women); 194 195 total energy intake (continuous); and BMI (in quintiles). In Model 2 we additionally adjusted for the Alternate Healthy Eating Index (in guintiles, without SSBs and alcohol; not applicable in the 196 independent physical activity models). 197

We conducted a series of stratified analyses for continuous servings/day of SSBs or ASBs with incidence CVD by pre-specified subgroups and calculated p-values for heterogeneity with Wald tests for the multiplication interaction of SSB or ASB exposures (continuous variable) with the effect modifier variables.

For the joint analyses, SSB or ASB intakes were combined into three categories: (1) never or 202 203 less than 1 serving/month, (2) 1-4 servings/month, (3) \geq 2 servings/week, with physical activity 204 dichotomized according to the current aerobic physical activity guidelines for adults (<7.5 METhr/week is equivalent to 150 minutes/week of moderate-intensity physical activity)³¹: <7.5 MET-205 206 hr/week vs. \geq 7.5 MET-hr/week. We set participants who reported never/rarely consuming SSBs or 207 ASBs and meeting physical activity guidelines as the reference category. We tested the multiplicative interaction with the cross-product interaction term between continuous servings/day of SSB or ASB 208 209 intakes*total physical activity added to the main effects models. To assess the additive interaction, we derived the probability value of the relative excess risk due to interaction as an index of additive 210 interaction, also with SSB and ASB intakes and physical activity as continuous variables.^{32–34} 211 Because participants may alter dietary patterns after the diagnosis of major illness, we stopped 212

updating dietary variables when participants reported a diagnosis of coronary artery bypass, angina, or cancer, although follow-up continued until CVD endpoint occurrence, death, or the end of the study period.³⁵ If food-frequency questionnaire exposure data were missing at a given updated time point, we carried forward the exposure level from the previous cumulative cycles.

217 Sensitivity Analyses

We also ran a series of sensitivity analyses to assess the robustness of results in independent and joint associations. First, the diet was continuously updated until the end of follow-up. Second, we excluded BMI from the models. Third, models were adjusted for median household income and education. Fourth, instead of adjusting for AHEI, we adjusted for a set of dietary variables. Lastly, we further examined two sub-groups: 1) 'heavy SSB or ASB consumers' (top 25% SSB or ASB

223	consumers vs not) and the dichotomized physical activity variable, and 2) 'heavy SSB or ASB	

consumers' and 'high physical activity level' (top 25% physical activity vs not).

All analyses were performed separately for each cohort and then pooled using inverse varianceweighted fixed-effect meta-analysis, and variance-weighted meta-analysis. Statistical tests were twosided, and *P*-values of < 0.05 were considered to indicate statistical significance. Data were analyzed with the SAS package, version 9.4 (SAS Institute, Cary, NC).

229 **Results**

230 A total of 13,269 CVD cases (8,438 CHD; 4,997 strokes) were documented, 6,156 in men and 231 7,113 in women, during a maximum follow-up of 30 (median 13.4) and 36 (median 17.9) years, respectively. Men and women in the reference group, who jointly met physical activity guidelines and 232 consumed less than 1 SSB serving/month at baseline (21% women and 23% men), had on average 233 lower total energy intake and higher diet quality (Table 1). In contrast, men and women who did not 234 meet physical activity guidelines and consumed ≥ 2 servings/week of SSBs at baseline had a higher 235 total energy intake and lower Alternate Healthy Index diet quality score. Table S1 shows baseline 236 characteristics by categories of SSBs and ASBs intakes separately, and quintiles of physical activity. 237 Table S2 shows baseline characteristics jointly by categories of ASB and physical activity. 238

Table 2 shows the pooled associations for intakes of SSBs, ASBs, and physical activity with 239 CVD, CHD, and stroke. In multivariable model 2, compared to participants who never/rarely 240 consumed SSBs, those consuming ≥ 2 SSB servings/day had a 21% higher risk of CVD (pooled HR 241 242 1.21, 95% CI, 1.12 to 1.32; p-trend<0.001). Per serving increment of SSB intake per day, the pooled HR for CVD was 1.15 (95% CI, 1.09 to 1.20; p- trend<0.0001), for CHD 1.17 (95% CI, 1.10 to 1.24; 243 p-trend<0.0001), and for stroke 1.11 (95% CI, 1.02 to 1.20; p- trend=0.02). No evidence of significant 244 245 differences in ASB intake and risk of CVD or CHD was observed, with the exception of stroke where per serving increment of ASB intake per day was 1.05 (95% CI, 1.01 to 1.10; p-trend=0.03). 246 Comparing the highest to the lowest quintile of physical activity, the pooled hazard ratios were 0.66 247

(95% CI, 0.63 to 0.70) for CVD, 0.67 (95% CI, 0.63 to 0.72) for CHD, and 0.64 (95% CI, 0.59 to 0.71) 248 for stroke. Table S3 shows the results for stroke subtypes for SSB, ASB, and physical activity. Table 249 250 S4 shows the results for the association between SSB or ASB subtypes and CVD. In the SSB subtype 251 pooled analysis, per serving increment of cola and non-cola carbonated drink intake per day was 252 associated with a15% (pooled HR 1.15, 95% CI, 1.08 to 1.23; p-trend<0.0001) and a 12% (pooled HR 253 1.12, 95% CI, 1.04 to 1.21; p-trend=0.004) higher risk of CVD, respectively. The associations between 254 SSB, ASB, and physical activity with CVD risks were consistent across subgroups (Table 3). Cohortspecific results are shown in Table S5. 255 256 Compared to the reference group (met physical activity guidelines and consumed SSBs <1/month), participants who did not meet the physical activity guidelines and consumed ≥ 2 257 servings/week of SSBs, had a pooled HR of 1.47 (95% CI, 1.37 to 1.57) higher risk of CVD (Figure 1, 258 259 panel A). There was also a higher risk of CVD among those who met physical activity guidelines and consumed ≥2 SSB servings/day (pooled HR 1.15, 95% CI, 1.08 to 1.23), with similar patterns for CHD 260 (Figure 1 panel B) and stroke (Figure 1, panel C). Participants who did not meet physical activity 261 guidelines and consumed ASBs <1/month had a 29% (pooled HR 1.29, 95% CI, 1.22 to 1.37) higher 262 risk of CVD (Figure 1, panel A), which was consistent with those who did not meet the physical 263 activity guidelines and consumed ≥ 2 servings/week of ASBs (pooled HR 1.29, 95% CI, 1.22 to 1.37), 264 compared to the reference group. Cohort-specific results for joint associations are shown in Table S6, 265 and stroke subtypes are included in **Table S7**. **Table S8** shows the results for the joint associations 266 267 between SSB or ASB subtypes and physical activity and risk of CVD. Although there was no evidence of statistically significant multiplicative interactions between SSB or ASB and physical activity for any 268 outcome, we observed a significant additive interaction between SSB intake and physical activity and 269 270 risk of CVD (p<0.001) and CHD (p<0.001) (Table S9). In addition, we observed a significant additive interaction between the intake of ASBs and physical activity and the risk of CVD (p=0.03) and stroke 271 (p=0.04).272

The results of these analyses were consistent with those from primary analyses. When we 273 selectively stop updating diet, the independent associations between SSB or ASB consumption and risk 274 275 of CVD and CHD, were slightly attenuated, while the independent association between SSB intake and 276 risk of stroke remained consistent (Table S10). The results of the independent association between 277 physical activity and risk of CVD remained unchanged (Table S10). The SSB or ASB intakes and 278 physical activity joint associations and risk of CVD findings were consistent after we stopped updating 279 diet (Table S11). The independent and joint association results persisted after we excluded BMI from 280 the final model (Tables S12 and S13), except for the ASBs and physical activity joint association 281 results that were strengthened (Table S13). Results remained consistent when we additionally adjusted for socioeconomic status (Tables S14 and S15) and when we adjusted for dietary factors in lieu of 282 AHEI (Tables S16 and S17). The pooled hazard ratios for risk of CVD in 'heavy SSB consumers' 283 who met and did not meet the physical activity guidelines were 1.14 (95% CI, 1.08 to 1.21) and 1.44 284 (95% CI, 1.35 to 1.53), respectively (Table S18). The pooled hazard ratios for those 'heavy SSB or 285 ASB consumers' and that were in the top 25% of physical activity ('high physical activity level') were 286 slightly attenuated - vs using dichotomized physical activity - for all outcomes (Table S19). 287

288 Discussion

In two large prospective cohorts of US men and women followed for more than 30 years, we 289 found positive linear associations between SSB consumption and the risk of CVD and CHD, while 290 physical activity was inversely associated with CVD, CHD, and stroke risk, after adjusting for risk 291 292 factors and other dietary variables. Marginally significant associations were observed per serving increment/day of ASB intake and the risk of CVD. Most importantly, our joint analysis showed that 293 individuals who met physical activity guidelines and consumed >2 servings/day of SSBs had a higher 294 295 risk of CVD, compared to those who met physical activity guidelines and consumed SSBs <1/month. To our knowledge, the present study is the first large prospective study to examine the joint 296 associations of SSB or ASB consumption and physical activity and the incidence of CVD. Overall, our 297

study suggests that the protective effects of physical activity do not mitigate the detrimental impact ofSSB consumption on cardiovascular health.

300 Findings from several meta-analyses have consistently shown that SSB intake is associated with CVD risk in adults, after adjustment for physical activity.^{3,5,36} The most recent meta-analysis 301 (seven prospective cohorts with 16,937,316 person-years of follow-up and 16,915 incident CVD cases), 302 303 found that SSB consumption was associated with a 9% higher risk of CVD (95% CI, 1.01 to 1.18) when extreme categories of intake (none or less than one/month vs one or more/day) were compared.⁵ 304 305 In regard to ASBs, a meta-analysis including six prospective studies (16,281,005 person-years 306 of follow-up with 18,077 incident CVD events) showed that per serving increment of ASBs per day was associated with a 7% higher risk of incidence of CVD (95% CI, 1.05 to 1.10).⁵ Additionally, per 307 serving increase of ASBs per day was associated with a 6% higher risk of CHD and a 9% higher risk 308 309 of stroke. The dose-response results of our study were weaker because we observed a 3% higher risk of CVD, with marginal significance, and a 5% higher risk of stroke. 310

Concerning physical activity, we observed a 34% lower risk in the incidence of CVD in those 311 in the highest quintile of physical activity, when compared to the lowest quintile and after accounting 312 for demographic and lifestyle factors. A consistent and strong protective association has been reported 313 with leisure time (relative risk 0.76, 95% CI, 0.70 to 0.82 in men 0.73, 95% CI, 0.68 to 0.78 in women) 314 and occupational physical activity (relative risk 0.89, 95% CI, 0.82 to 0.97 in men and 0.83, 95% CI, 315 0.67 to 1.03 in women).³⁷ Furthermore, a recent systematic review and meta-analysis (33 studies with 316 1,683,693 participants and 89,493 events, follow-up=12.8 years) reported that an increase from being 317 inactive to attaining recommended physical activity levels was associated with a lower risk of CVD 318 incidence by 17% (95% CI, 0.77 to 0.89), after adjusting for body weight.³⁸ 319

The joint associations between SSB or ASB intakes and physical activity and risk of CVD findings are novel. Findings provide evidence against the argument that physical activity could counterbalance the potential health risk that would have been induced by SSB or ASB intake. Even

though participants who did not meet the physical activity recommendations had a higher risk of CVD 323 at all levels of SSB or ASB intakes, consuming >2 servings SSBs/week, compared to never/rarely 324 325 consumers of SSBs, while meeting physical activity guidelines was associated with a 15% higher risk 326 of CVD. Although we did not observe a multiplicative interaction between SSB or ASB and physical 327 activity and risk of CVD, we did detect significant additive interactions between SSB and physical 328 activity and risk of CVD and CHD; and ASB and physical activity and risk of CVD and stroke. Of 329 note, in a previous study in men, De Koning et al., reported no significant interaction between SSB and physical activity.⁸ Hence, meeting physical activity recommendations does not modify the CVD risk 330 331 associated with higher SSB intake. Interestingly, the impact of SSBs on CVD risk is still observed even in participants who met physical activity recommendations and were in the top 25% of physical 332 activity levels. 333

Strengths of this study include large sample size, prospective population-based design with 334 long and high rates of follow-up, well-defined outcomes, and the use of repeated and validated 335 measurements of diet and other lifestyle data. Limitations of this study include the difficulty in 336 inferring causality due to the observational design. Additionally, residual confounding remains a 337 possibility even though the analyses were extensively adjusted for potential confounders. As well, 338 reverse causation in the ASB analyses is a plausible limitation. Moreover, the dietary information was 339 self-reported and our assessment of SSBs and ASBs and physical activity inevitably had some degree 340 of measurement error. However, the use of repeated measurements lessens random measurement error 341 342 caused by within-person variation. Also, our study population consisted of primarily non-Hispanic white health professionals, thus the generalizability of our results to other populations may be limited. 343 Conclusion 344

Consumption of SSBs or ASBs and physical activity are independently associated with the risk of CVD. Not meeting physical activity guidelines jointly with a greater intake of SSBs or ASBs was associated with a higher risk of CVD. Additionally, findings from this study suggest that even when

348	individuals are physically active, higher consumption of SSBs is associated with a higher risk of CVD.
349	Our results underscore the adverse health effects of both SSBs consumption and being physically
350	inactive and support public health recommendations and policies to limit the intake of SSBs and
351	maintain adequate physical activity levels.


