Background: This study standardized the parameters of a novel visual midline gauge and
presents normative data, which can be used by optometrists in the assessment of visual
midline.

24 **Methods:** Ninety-three participants from three age groups (18 to 44, 45 to 64, and > 6525 years) without history of significant neurological or ocular problems were recruited in 26 Waterloo, Canada and Hong Kong. In experiment 1, the perceived horizontal and vertical 27 visual midline was measured using the gauge for 2 speeds and 2 repositioning methods. In 28 experiment 2, the perceived midline was measured for three different distances (25, 50 and 29 100 cm) using a target speed and repositioning method chosen from the first experiment 30 results. Since there was no significant difference between the two sites in any of the 31 measures, data were combined for analysis.

Results: For experiment 1, linear mixed models showed no effect of age, speed or repositioning method and no interaction (p>0.05) for the perceived midline position (p>0.05). In experiment 2, there was no significant effect of age or distance and no interaction effects on the perceived horizontal and vertical visual midline position using the chosen speed and method (2.3 degrees per second, adjustment method). Normative data (mean and 95% ranges of the perceived visual midline for control participants) was tabulated. The measurements were found to be repeatable. A few participants were found to have significant midline shifts.

39 Conclusion: This study shows that the measurement of midline is tolerant of differences of 40 target speed, testing method, test distance, and age group of the participants and that the 41 measurements using the visual midline gauge are repeatable. It is possible for even 42 individuals without a history of neurological or ocular disorders to have significant shifts in 43 their perceived visual midline.

# 54 INTRODUCTION

Cerebrovascular disease is the sixth most common global cause of chronic disability.<sup>1,2</sup> 55 56 According to the Canadian Heart and Stroke Foundation, the number of cerebrovascular accidents (CVAs or stroke) in Canada has increased<sup>3</sup> and this is also the case in the UK<sup>4</sup>, 57 US<sup>5,6</sup>, developing countries<sup>7</sup> and worldwide.<sup>1,2</sup> The incidence of stroke increased by 74% 58 between 1981 to 2004 in the UK for people older than 75 years old.<sup>4</sup> Between 550,000 to 59 795,000 people experience a stroke each year in the United States <sup>5,6</sup>, and around 400,000 60 Canadians are living with post-stroke disabilities.<sup>3</sup> There is also an increase in the number of 61 people surviving a stroke and therefore living with the consequences.<sup>8</sup> In the United States. 62 63 70% of stroke survivors receive rehabilitation services through either hospital-based inpatient, nursing, or home rehabilitation care outpatient facilities.<sup>5</sup> Approximately 10% of 64 65 individuals are admitted to a long term care facility after a stroke and only a few recover completely.<sup>3,9–11</sup> It is estimated that all stroke survivors have some degree of visual disorder, 66 60% having minor visual impairment and 40% surviving with moderate to severe 67 impairments.<sup>3,9,10</sup> 68

69 Within the optometric profession, there is an increased interest in rehabilitation to enhance 70 the independence, function, safety, and health of an individual and to optimise aging 71 following a neurological event. After a CVA, individuals may have a wide range of visual 72 sequelae, including impaired visual acuity, binocular vision disorders, visual field deficits, and visual perceptual difficulties.<sup>12,13</sup> Up to 70% of stroke patients report visual field 73 defects.<sup>10</sup> Reduced visual acuity post-stroke (less than 0.50 logMAR [6/18] corrected) was 74 documented in 13% of individuals for both near and distance vision.<sup>12</sup> Ocular motility 75 deficits are present in 68.4% of individuals with stroke.<sup>12</sup> Perceptual changes include visual 76 77 neglect (unilateral spatial inattention), and visual midline shift, in addition to others.

Visual neglect is a neurological disorder which occurs after a brain lesion and can result in
loss of visual attention of one side of visual space.<sup>14–17</sup> Neglect can impact different personal
spaces (personal space, intrapersonal-space, and external space) and is the most common
perceptual change post-stroke.<sup>12</sup>

82 Abnormal egocentric localization or visual midline shift (VMS) is a condition in which an 83 individual experiences a shift in their visual midline, defined as the point which the individual perceives as being straight ahead or "in front of their nose".<sup>9,10,18</sup> The midline can 84 85 be shifted laterally or vertically so that a target will be perceived as straight ahead when, for example, it is presented in front of the left eye rather than the true inter-ocular centre.<sup>18,19</sup> The 86 prevalence of the visual midline shift following CVA has not been determined. Visual 87 88 midline shift may result in postural changes and subsequent issues with balance and safety, the resultant condition being called visual midline shift syndrome.<sup>3,9,10,13,18</sup> 89

90 The pathophysiology of visual midline shift is uncertain and there is discrepancy in the 91 terminology used. It has been proposed that a CVA may affect a specific area of the feedforward dorsal visual pathway within the right inferior or posterior parietal lobe of the brain 92 resulting in visual neglect.<sup>20</sup> Neglect of one hemisphere may result in a change of visual 93 midline, often referred to as an altered subjective-straight ahead.<sup>18,20</sup> Padula et al.<sup>18</sup> proposed 94 95 that as a result of hemianopia following a CVA, VMS develops as a result of lack of 96 information to the retinotectal pathway. This visual pathway travels from the retina through 97 the superior colliculus to the pulvinar nucleus in the midbrain instead of through the lateral geniculate nucleus and onto the primary visual cortex.<sup>18</sup> Information that travels though this 98 99 pathway combines with information from different systems such as the vestibular, 100 proprioceptive, and kinesthetic which are responsible for the awareness of self-space by an individual.<sup>18</sup> Therefore, lack of information provided to that pathway causes the brain to 101

attempt to re-create a balance which results in a postural lean away from the affected visual
 space disturbing posture and balance.<sup>18</sup>

104 There has been little research regarding VMS, leaving many questions to be answered in 105 terms of the epidemiology, pathophysiology, and evidence-based treatment modalities. This 106 contrasts with the on-going and considerable research into visual neglect which may 107 accompany VMS. Prisms have been suggested as a rehabilitation intervention for patients 108 with VMS to correct posture and balance, improve quality of life following a stroke and possibly decrease the incidence of falls.<sup>13,21,22</sup> However, there are no clear guidelines 109 regarding duration of wear or amount of prism. <sup>22,23</sup> There is also insufficient evidence 110 regarding accurate assessment of VMS, which is necessary for any study protocol or clinical 111 management. 112

At present there is no validated clinical method of measuring the visual midline. Clinically, 113 114 the visual midline is currently measured manually. The patient is asked to visually track a 115 "wand" (a hand-held target) moved laterally or vertically in front of the individual to find the subjective visual midline point. Padula et al.<sup>18</sup> used a 30 cm long wand, the tip of which is 116 the target, presented against a blank wall at approximately 45 cm from the patient. The 117 118 recommended speed of the target was 4 cm per second. Various other methods have been described. For example, Houston<sup>20</sup> called the visual midline the visual eye-head egocentric 119 midline and created an apparatus to standardize measurements. Kapoor et al.<sup>13</sup> used a laser 120 pointer, viewed through a mirror while Kuhn et al.<sup>23</sup> described a method to measure the 121 122 midline (called the subjective straight ahead) with a small red spot presented in a perimeter.<sup>23</sup> 123 The purpose of this study is to standardize the parameters of a visual midline gauge using

124 participants with unimpaired vision and no history of stroke or other neurological disorders.<sup>18</sup>

125 The information gained in this study will be used to develop an accurate assessment tool for

use with post-stroke patients and to gather normative data against which the visual midline ofpost-CVA patients can be compared.

#### 128 METHODS

129 The Visual Midline (VM) gauge consists of a metal bar against a solid black background.

130 The bar and the background are both the same colour black. A white sphere of 13 mm size is

131 situated just behind the bar and can be moved at different speeds (1.15 or 2.3 degrees per

132 second). The target moves mechanically and can be manoeuvred using a control box and

133 push button. The bar has a millimetre scale for the examiner to measure the position of the

134 target, which is not visible to the participant (Figure 1).

This cross-sectional study received clearance through a University of Waterloo Research Ethics Board and a Hong Kong Polytechnic University (PolyU) Institutional Review Board and adhered to the principles of the Declaration of Helsinki. Participants were recruited from among the graduate students, staff, faculty, and their families as well as the School of Optometry Clinics at the University of Waterloo (UW) School of Optometry and Vision Sciences (UW) and the PolyU from January 2022 to September 2022. Snowball recruiting was also used.

A preliminary phone screening interview was conducted to ensure that potential participants
met the ocular and health history inclusion and exclusion criteria. Inclusion criteria were;

144 either gender, corrected visual acuity of 0.1 logMAR (6/7.5) or better in each eye.

145 Participants were excluded if they met any of the following criteria: more than one-line intra-

146 ocular difference in visual acuity (VA), strabismus, significant previous ocular or health

147 history, neurological disorders such as Parkinson's, multiple sclerosis, cerebellar dysfunction,

148 vestibular dysfunction, cerebral palsy, dizziness/vertigo, a diagnosis of dementia or cognitive

149 impairment, previous history of stroke or any medication that would affect balance. In

addition, the phone interview included questions on handedness (right, left or ambidextrous)and history of falls.

Fifty-four and 39 participants were recruited from UW and PolyU respectively, in three agegroups; 18 to 44, 45 to 64, and above 65 years (See Table 1).

Participants attended for two visits. During the first visit, participant's VA was measured at 4m using a different Early Treatment Diabetic Retinopathy Studies chart for each eye. A perletter scoring system was used for calculating the VA, which was recorded in logMAR units.<sup>24</sup> Ocular alignment was assessed with the unilateral cover test for distance and near using an accommodative target, and visual field loss (VF) was assessed using a hand-held arc perimeter with a 13 mm diameter white target and recorded manually on Goldmann VF recording sheets. After confirming the eligibility using these tests, the VM assessments were

161 conducted.

162 Visual midlines were assessed using the clinical method and the VM gauge. During the clinical method,<sup>18</sup> participants were asked to visually track a hand-held 13 mm diameter 163 164 sphere target on a 30 cm long wand that was moved laterally or vertically in front of their 165 face at a distance of 50 cm. The speed of the target was approximately 3-4 cm per second. 166 Participants were asked to indicate when the target was perceived to be in their midline. For 167 horizontal measurements they were asked to indicate when the target was in line with the tip 168 of their nose and for vertical measurements, they were asked to respond when it was level 169 with their eyes. The examiner subjectively estimated the VM from their intra-ocular midline 170 in centimeters based on the participants response. Two trials were undertaken from each 171 direction.

At the first visit (Experiment 1), horizontal and vertical VM was measured using the VM gauge at a 50 cm distance, with 2 speeds (1.15 or 2.3 degrees per second) and two methods of repositioning the target for accuracy (adjustment and repeated). Horizontal and vertical VM was also measured with the clinical method (see description above). At the second visit (Experiment 2), vertical and horizontal VM was measured for 25, 50 and 100 cm using the speed and method of repositioning chosen based on the data analysis of all the first visit data. VM with the clinical method was repeated.

During the measurement with the VM gauge, the participant was seated at the specified distance in front of the midline gauge. A headrest table was used to stabilize head position, adjusted for the target distance such that their inter-ocular midpoint was in line with the '0' midpoint on the device horizontally and level with the centre of the spherical target vertically. The room lights were fully on.

184 Before each measurement, the target was placed in a position remote from the anticipated 185 midline of the participant on alternating sides (left or right) and moved towards the expected 186 midline position. The '0' position on the VM gauge was not visible to the participant. The 187 participant was instructed to visually track the target with their eyes. The participant 188 responded with a push button when they perceived the target to be aligned with their visual 189 midline, which stopped the target movement. For horizontal measurements they were asked 190 to press the push button when the target was in line with the tip of their nose. For vertical 191 measurements, they were asked to respond when it was level with their eyes. Five trials were 192 undertaken from each direction. Participants were allowed to reposition the target position 193 after each trial if they did not believe it was in line with their midline. Two different methods 194 were used in visit 1 for this correction. In the adjustment method, participants were allowed 195 to ask the examiner to restart the trial and the participant was able to adjust the position of the 196 target from where it stopped initially using the push button. In the repeated method, the target

197 was moved back to the initial position (similar to when the trial started), and the trial was 198 repeated until the participant confirmed that the final target position was in alignment with 199 their perceived midline. This repeated method required 3 to 4 remeasurements for some of 200 the participants.

Experiment 1. The parameters for the VM gauge measurement in visit 1 (vertical/horizontal, two speeds, and two methods of adjustment) were varied in a counter-balanced order between participants to control for fatigue and practice effects. Two trials were performed in each direction to demonstrate the task, and the results of these trials were not recorded. Following this, the measurements were repeated five times from each direction resulting in a total of 80 trials for each participant during the first visit. Breaks were provided in between the conditions to reduce fatigue and to maintain attention.

Experiment 2. During visit 2, VM testing was conducted with the target speed (2.3 degrees per second) and the adjustment method of repositioning determined from the results of the first experiment. In experiment 2, the horizontal and vertical midlines were measured at 50 and 100 cm distances, corresponding to intrapersonal-space and external space), but only horizontal measurements were possible at 25 cm (personal space) due to mechanical constraints. Once again, the parameters were varied in a counter-balanced order and five measurements were taken from left, right, up and down starting points.

## 215 Analysis

Jamovi (version 2.3.18.0) software and Microsoft office Excel (version 16.55) were used to analyze the data. Descriptive statistics were examined to ensure that data met statistical test assumptions and Shapiro-Wilk test was used to assess normality. A Mann-Whitney U-test was conducted to compare the VM data from UW and PolyU since the examiners were

different at each location. There was no significant difference (p>0.05) in any of the

221 measures, therefore, data from both centres were combined for all further analysis.

222 Since the data were not normally distributed, Wilcoxon signed-rank tests were used to assess

the effect of test direction (right vs. left and up vs. down) at all distances for both visits.

Linear mixed models for repeated measures were used to analyze the impact of target speed,

225 method of repositioning, and age group of participants on the VM at first visit for the

226 horizontal and vertical directions. Linear mixed models were also used to analyze the effect

227 of testing distance and age group of participants on the VM at second visit for the horizontal

and vertical visual midline.

A Wilcoxon W test was used for each participant to check the study assumption that these

230 normal observers did not have a significant midline shift, i.e., whether their perceived midline

231 was significantly different from zero. Since many t-tests were undertaken (for each distance,

vertical and horizontal) a Bonferroni correction was used and the usual p value of <0.05 was

changed to <0.05/n = <0.00056 for significance. One sample t-tests were also performed for

each distance for both horizontal and vertical measures for each age group to determine if the

average position of the midline was centred on zero.

Clinically, it is usual to perform two measurements from each side.<sup>18</sup> So normal data for use
in clinical settings were calculated as the mean of the first two measurements from each
direction and 1.96 x SD (95% range). All other analysis was based on the full data set of 5
readings from each direction) parameters.

Repeatability between visit 1 and 2 was assessed using Bland Altman plots, bias, limits of
agreement for repeatability, and correlation coefficients.

242 **RESULTS** 

### 243 **Experiment 1**

## 244 Effect of direction

245 The results of Wilcoxon signed-rank tests showed significant differences between the visual 246 midlines measured with different starting directions (i.e., when the target moved from right 247 vs. left, and up vs. down). Specifically, the visual midlines were found to be shifted towards 248 the direction from where the target started (Figure 2). Hence, the 10 measurements for each 249 person (5 from each direction) were paired and analyzed as one measurement for all further 250 analysis. For example, the first measurement from the right was paired with the first 251 measurement from the left as one data point. This is similar to how the tests would be conducted clinically<sup>18</sup>. 252

#### 253 Effect of method and target speed

The linear mixed model included fixed effects for age group, target speed, repositioning method as well as the interactions and a random intercept per participant. There was no significant effect of repositioning method, target speed, or age group on the position of visual midline for either horizontal or vertical directions (p>0.05). There were no significant interaction effects. To conduct the VM test more efficiently, the faster repositioning method (i.e., adjustment) and speed (i.e.,2.3 degrees/second) were chosen for the second visit.

## 261 Experiment 2

The linear mixed model for the second visit included fixed effect for age group and distance as well as the interactions and a random intercept per subject. There was no significant effect of distance or age group for either horizontal or vertical direction (p < 0.05). There were no significant interaction effects.

## 266 Visual midline shifts in individuals

267	Wilcoxon W tests were conducted to assess for a significant VMS in each participant.
268	Each participant's average midline position was compared with zero, for the method of
269	adjustment, speed of 2.3 degrees/s, and distance of 50cm. This showed that some individuals
270	had significant horizontal and vertical visual midline shifts which remained significant after
271	Bonferroni correction (modified p value was $<0.05/91 = <0.00055$ ). In age group 1, there
272	were 2 and 3 participants who had horizontal and vertical VMSs, respectively. In age group
273	2, there were 4 and 7 participants who had horizontal and vertical VMSs, respectively. and in
274	age group 3, there were 12 and 9 participants who had horizontal and vertical VMSs,
275	respectively.

#### 276 Repeatability

The first two measurements from each starting direction were used to assess the repeatability. The results of the Bland Altman plots, and the Spearman correlation analysis are shown in Figures 3 & 4. The Bland Altman plots, limits of agreement for repeatability, and correlation coefficients all showed good repeatability.

The results were similar when test-retest repeatability analysis was conducted with all 10measurements (5 paired measurements).

## 283 Normative data

Because there was no effect of age or testing distance of 50 and 100 cm, normative data were calculated for all ages and 50 and 100 cm together. The data for 25cm were kept separate

since measurements at 25 cm were only possible for the horizontal direction. Means and the

287 95% range of normal (1.96 x SD) are shown in Table 2.

#### 288 **DISCUSSION**

The purpose of the study was to develop and test a new device to measure the perceived visual midline position. This study investigated the effect of parameters such as target speed, repositioning method, testing distance, and age of participants in individuals without a history of significant neurological or ocular disorders. The study is important, as, although other authors have described various methods for measuring the midline, there are currently no published studies on the effect of the various parameters on the VM or normative data. There are a wide variety of suggested ways to measure the perceived midline. Padula et al.<sup>18</sup>

296 described using one target size (30 cm length) and one speed (4 cm per second) at one 297 distance (45 cm), but no explanation was provided on the basis of choosing these parameters. The portable method mentioned by Kapoor et al.<sup>13</sup> used a laser pointer target moving slowly 298 299 in front of the participant while the participant looked through goggles and saw a reflected 300 mirror image in front of their eyes. A hand-held clicker was used to indicate when the image 301 of the laser pointer was aligned with their midline. Some of the participants were instructed 302 to look straight and not to follow the target and other participants received a demonstration of the true subjective straight-ahead position prior to the test.<sup>13</sup> The method by Kuhn et al.<sup>23</sup> for 303 304 measuring the visual midline shift involved a red spot presented in the perimeter in different 305 quadrants right, left, up and down and the participant was asked to verbally adjust the 306 position of the red spot until it aligned with their subjective straight-ahead position. Houston<sup>20</sup> measured the visual eve-head egocentric midline by asking the participant to 307 308 respond when a 1cm, manually moved white target (3 degrees/second) was perceived at the center.20 309

In the first session, we found no significant effect of target speed and repositioning method.So, the fastest speed and testing method (adjustment) were chosen based on clinical

312 considerations as it would make the testing more efficient in a clinical setting. This speed was

313	slower than the one used by Padula et al. <sup>18</sup> , which was 5 degrees per second, but much faster
314	than that by Kapoor et al. <sup>13</sup> , which was 0.5 degrees per second.
215	
315	The effect of starting direction was analysed from the first visit results, and there was a
316	significant effect of starting direction. Therefore, it is important in any clinical or
317	experimental setting that the final determination is based on the average of an equal number
318	of measurements from each direction, as is indeed clinical practice <sup>18</sup> .
319	In Experiment 2, the midline position was measured at three different distances to see
320	whether the perceived midline changes in personal space, intrapersonal-space, and external
321	space. This is important as one underlying pathophysiological theory is that an altered
322	midline occurs as a result of neglect <sup>25</sup> , which may occur differently in these spaces. Only the
323	horizontal direction assessment was possible at the personal space level due to physical
324	constraints. Experiment 2 showed no significant differences in the position of the perceived
325	midline, based on age and distance. Therefore, the normal data is presented together for all
326	age groups, separately for 25 cm, and combined for 50 and 100 cm. Overall, VM
327	measurements were not significantly different from zero.
328	In this study, we expected that people with normal vision and no history of neurological
329	impairments would have no significant midline shift. However, there were a few participants
330	who had significant VMS when the individual measurements were compared with zero. To
331	the authors' knowledge, this finding has not been reported before, but is important as not all
332	midline shifts may be due to stroke and may be present prior to stroke.
333	Prisms are one suggested method to control and treat midline shifts by two approaches. Some
334	have recommended the prescription of prisms in glasses for full-time wear <sup>18</sup> and others have
225	recommended mign adaptation while we denote the reary of a management <sup>19</sup> In either agas it

recommended prism adaptation while undergoing therapy as a management.<sup>19</sup> In either case it

336 would be expected that there should be some relationship between the degree of midline shift

- and the amount of prism used and so an accurate measure of the presence and degree ofmidline shift is desired, as can be provided by this gauge.
- 339 This is the first research study that has attempted to standardize the assessment of visual
- 340 midline. The study has shown that the measurement of the perceived midline is relatively
- 341 insensitive to the target speed and testing distances within the range that was tested. This is
- 342 also the first study to provide normative data, against which post-stroke patients can be
- 343 compared.
- 344 Futures studies are indicated to use the VM gauge to determine the range and potential causes
- 345 of midline shifts in individuals without stroke, but who might have other ocular disorders. It
- 346 is also important to determine the prevalence and natural history of midline shift in the post-
- 347 stroke population. Secondary analysis of this data will be conducted to determine the
- 348 associations of VMS with other vision and non-vision variables.





- 438 Experimenter's view from the back showing the numbered scale and target.


