The lasting effects of the pandemic: A time series analysis of first-time speech delays in kids under 5 years of age

Abstract:

Given the profound effects of the COVID-19 pandemic on the way individuals interact, we sought to understand if there was an increase in pediatric first-time speech and language delay diagnoses. We identified children under five years of age with a first-time speech delay diagnosis between January 1, 2018 and February 28, 2023, in Truveta Data. We calculated the monthly rate of first-time speech delay diagnoses per children with an encounter within the last year and no previous speech delay diagnosis. The Seasonal-Trend decomposition using LOESS (STL) method was used to adjust for seasonality. We also compared the difference in means between the 2018/2019 and 2021/2022 time periods. Significant increases in the mean of rates between 2018/2019 and 2021/2022 exist for the overall population and each age strata (p<0.001). Likely the causes of these trends are multifaceted and future research is needed to understand the specific drivers at play.

According to the CDC, nearly 8% of children have a communication or speech and language disorder¹. Although, timely intervention is linked to improved long-term outcomes, roughly half of children do not receive such services^{1,2}.

Given the profound effect of the COVID-19 pandemic on the way many live and communicate, as well as the shift from in-person to telehealth speech and language pathology services³, we are interested to see if there is a change in first-time speech and language delay diagnoses. To the best of our knowledge, no published data exists on first-time diagnoses of speech delays before and after the pandemic.

Methods: We identified children under five years of age with first-time speech delay diagnosis defined using diagnostic codes (**Appendix**) between January 1, 2018 and February 28, 2023, in Truveta Data. Truveta Data consists of electronic health records provided by member U.S. healthcare systems that were deidentified by expert determination in accordance with the HIPAA Privacy Rule ^{4,5}. Included patients were primarily located in 12 states.

We calculated the monthly rate of first-time speech delay diagnoses per children with an encounter within the last year and no previous speech delay diagnosis. Patients were excluded if they did not have an associated encounter in the same month as their first-time diagnosis. We looked at the under-five population overall and stratified by age (0-1, 1-2, 2-3, 3-4, and 4-5 years of age).

The Seasonal-Trend decomposition using LOESS (STL) method was used to adjust for seasonality (data here are comprised of the trend and residual components of the time series). We also compared the difference in means between the 2018/2019 and 2021/2022 time periods. 2020 was not included due to variation in care throughout the year.

Results: We identified 2,463,511 patients less than 5-years old who had an encounter between January 2018 and February 2023 and no previous speech delay diagnosis; of these, 3.6% had a first-time diagnosis within this period (**Table 1**). Throughout the study period the two-year-old patients had the highest rate of first-time diagnoses, followed by the one-year-old patients (**Figure 1**).

Significant increases in the mean of rates between 2018/2019 and 2021/2022 exist for the overall population and each age strata (p<0.001). Overall, we see a significant increase of 1.55 times the rate of first-time speech diagnosis between 2018/2019 and 2021/2022 (2018/2019 rate: 1.58 [95% confidence interval: 1.53, 1.63], 2021/2022 rate: 2.45 [2.40, 2.51], p<0.001). We saw the largest increase in the patients who were one-year-old, where the rate increased by 1.69 times (2018/2019 rate: 2.71[2.62, 2.80], 2021/2022 rate: 4.58[4.47, 4.69], p<0.001). The patients who were two-year-old also increased by 1.63 times (2018/2019 rate: 3.31[3.19, 3.43], 2021/2022 rate: 5.39[5.23, 5.56], p<0.001).

Discussion:

We found a significant increase in the rate of first-time speech delay diagnosis for all age groups studied, but most pronounced for the one- and two-year-old age groups. Interesting the one- and two-year-olds have the highest pre-pandemic rates. Likely the causes of these trends are

multifaceted and future research is needed to understand the specific drivers at play. Factors may include fewer social interactions and psychological distress, a reduction in speech propagation while wearing masks ⁶, decreased effectiveness in therapy practices due to the shift to telemedicine ³, or delays in care due to the pandemic ⁷.

This study did not analyze severity of speech delay or initiation of therapy. Only diagnoses made by health systems were available; school or private practice-based diagnoses were not included. Age during months without an encounter was estimated using the age at previous encounters. Despite these limitations, these data show an increase in speech delay diagnoses in the years following the pandemic.
