Abstract

Food insecurity and adequate nutrition is a major global challenge, especially in vulnerable groups 24 such as refugee communities. In West Africa, due to conflict and instability in their home country, 25 thousands of Burkina Faso refugees have crossed the border into northern Ghana. We conducted 26 27 a cross-sectional study aimed at assessing household food insecurity, living conditions, and sense of security among Burkina Faso refugees currently residing in the upper east region of Ghana. 28 Study data was collected from 19-29 October 2022 from 498 refugee households. Results revealed 29 30 that almost 100% of households experienced food insecurity, with 80.3% experiencing severe food insecurity. Refugees from rural areas were more food secure compared to urban refugees. Refugees 31 residing in host communities experienced lesser food insecurity than those in designated refugee 32 camps. Further, refugees who were dissatisfied with the size of their accommodation were more 33 likely to experience food insecurity. More than half of the refugees felt safe and welcomed by the 34 host communities. The study underscores the critical need for targeted intervention to avert hunger 35 and malnutrition among vulnerable groups such as children, pregnant women, and the aged in the 36 refugee population. The study also emphasizes the importance of community support systems and 37 social amenities for refugees' well-being. Long-term measures should include improving logistics 38 for food distribution, providing suitable accommodation, and strengthening healthcare services. 39 40 Follow-up research, such as repeated community surveys, can track this evolving situation to 41 continuously inform decision-making for refugee support.

48 Introduction

49 Food insecurity leads to malnutrition, which negatively impacts upon all individuals, but can have a devastating effect on more vulnerable groups such as young children and pregnant 50 women (1,2). The UN estimates that 735 million people, around 9% of the world's population, 51 are experiencing hunger and food insecurity, with increases in the prevalence of 52 undernourishment observed in sub-Saharan Africa(3). The Global Nutrition Report highlights 53 54 that no African country is on track to meet any diet-related non-communicable disease targets. This makes it challenging, if not impossible, to achieving the SDG target to eradicate hunger by 55 20230(4). 56

Globally, approximately 26 million people are currently refugees with close to 80% of this
population experiencing food insecurity regardless of location (1). Refugees often flee from
armed conflict. Violence can directly lead to food insecurity and malnutrition by obliterating
food systems, reducing farming labour, and destroying transport systems, thus leading to a
reduction in community resilience (5–7).

Burkina Faso is in West Africa, with an estimated population of 22.1m. It is a landlocked nation bordering several other countries, including Ghana to the south. Since 2015, Burkina Faso has witnessed several waves of armed conflicts emanating from non-state armed groups whose aims are to instrumentalize communal tensions and exploit the vulnerability of an already fragile population. This has resulted in a displacement surge among its citizens [1]. Reports from UNICEF indicate that Burkina Faso recorded 488 armed attacks with 144 people killed in the first quarter of 2022 (8). As a result of this conflict, the number of internally displaced persons

(IDP) has risen to over 1.8 million, with 61% of the group being children (9). The ongoing 70 instability and violence means that there are declining crop yields, with a continued rise in prices 71 of goods and services (8). As a result, around 13 million people are faced with food insecurity, 72 and one-third are malnourished children aged under 5 years old (10). 73 The insecurity situation in the country has resulted in 179 healthcare centres being closed 74 75 in the hardest hit regions, with 353 healthcare centres operating at suboptimal levels. These closures have denied over 2 million citizens access to health care (8). A significant proportion of 76 population now have little access to basic social amenities such as water, food, shelter, 77 78 education, and healthcare, with many people considering that their best option is to flee to neighboring countries. As of February 2023, Ghana hosted 13,500 refugees, of which 4000 of 79 these were Burkina Faso citizens seeking asylum (11). These numbers continued to increase 80 across 2022 and 2023, particularly within the Upper East region of Ghana, which directly 81 borders Burkina Faso (8). The care of these refugees is the sole responsibility of the Ghanaian 82 local and national authorities and is supported by international humanitarian agencies such as 83 United Nations High Commissioner for Refugees (UNHCR). Their arrival has not only resulted 84 in increased pressure on Ghanaian and international agencies to provide humanitarian needs for 85 86 these refugees, but also places excess pressure on social amenities in their host communities. This study was conducted to assess the health, social, and economic needs of these 87 refugees in the Upper East region of Ghana, with a specific focus on food insecurity and the 88 89 living conditions among this population. We aimed to explore and understand predictors of food insecurity, and to describe some of the key characteristics of this vulnerable group. 90 91

92 Methods

93	Study design and settings. A community-based cross-sectional study was implemented in
94	Ghana using in-person data collection from household heads of identified refugees (supplementary
95	S1). Data was collected in the rural districts of Binduri District, Bawku Municipal, and Bawku
96	West, situated within the Upper East region of Ghana (Figure 1), where the majority of displaced
97	people are located. The region contains 15 administrative districts with a population of 1,301226
98	(12), and a total landmass of 8,842sq/km constituting 2.7% of the country's land size (13). The
99	regional capital is Bolgatanga, approximately 60-100km west of the study sites. Upper East region
100	shares international borders in the north with Burkina Faso, and in the east with Togo (13). The
101	location of the region exposes it to a lot of cross-border activities with neighbouring migrants and
102	traders from Burkina Faso and Mali, Togo and Niger using it as transmit point into Ghana.

107	Study population and sample size determination
108	All consenting adult heads of refugee households in the host communities were eligible
109	participants. Start and end dates of data collection was 11-21 October 2022. Sample size was
110	calculated using a single population proportion formula with an assumption of 50% population
111	proportion ($p = 0.5$) due to the unknown population size. With a 95% confidence level, a 5%
112	margin of error, and a normal population distribution $Z = 1.96$, we adjusted for a 5% non-
113	response rate. This provided an estimated sample size of 400.

115	Sampling technique and sampling procedures

116	Using the list provided by the National Disaster Management Organization department of
117	all three administrative districts, the number of participants studied in each district was
118	proportional to the total number of registered refugees in the district. The number of registered
119	refugees for each district was 1072 in Binduri District (64%), 495 in Bawku Municipal (29%)
120	and 112 in Bawku West district (7%), which totalled 1679 individuals. Since the calculated
121	sample size for the study was 400, the number of participants for each district was 256 for
122	Binduri district, 116 for Bawku Municipal, and 28 for Bawku West district. A purposive
123	sampling technique was used to select only communities hosting Burkina Faso refugees. With
124	the help of the community refugee focal persons (persons appointed by the respective local
125	assemblies) who documented all refugees in the communities, we identified and contacted all
126	registered refugee households using the refugee register for each community. In each household,
127	the household head was our respondent. A household was revisited in the absence of the
128	household head. If that individual was still not available upon the second visit, the survey was
129	carried out with an individual nominated from the rest of the household members.
130	
131	Study variables
132	Household food insecurity assessment
133	We used the USAID household food insecurity assessment score (HFIAS) module (14),

we used the OSAID household food insecurity assessment score (HFIAS) module (14), which was used to assess household food insecurity over the previous 30 days. HFIAS consist of 9 questions grouped into 3 domains, including: (1) anxiety and uncertainty, (2) insufficient quality, and (3) insufficient food intake and physical consequences. Participants responded "yes" or "no" to each of the nine questions. Those who answered "yes" were further asked about the frequency of the occurrence of the condition and the responses were" rarely", "sometimes", or "often". We summed the responses to the nine questions to get the HFIAS index. The minimum
score was 0 if the participant responded "no" to all the nine conditions and the maximum of 27 if
all the nine conditions were selected "yes". A higher HFIAS score indicates greater food
household insecurity and a lower score indicates greater food security (14). Households were
finally categorized into secure, mildly food insecure, moderately food insecure, and severely
food insecure consistent with the HFIAS score (14).

Living condition variables. Participants were asked about their current accommodation, and living conditions including whether they knew locals prior to arriving in the community, the size of their accommodation facility, and presence of any social support for their household and sources of these social support systems.

149 Sense of security. To measure the safety and sense of security among the study 150 participants, 4 questions were asked using the 5-point Likert scale (e.g., "Generally, I feel 151 satisfied with my current living conditions"; $1 = strongly \, disagree$; $5 = strongly \, agree$). We 152 averaged the items to form a single index (M = 3.46, SD = 0.99, $\alpha = 0.68$).

Sociodemographic variables. These included: sex (male, female), age (continuous), marital status (not married, married, separated/divorced, widowed), religious affiliation of the household head (Christian, Muslim, Traditional, other), household size (number of people sharing a common shelter), number of children under five in the household, and number of household members pregnant.

Data collection procedure and quality control. Some of the questions were adapted from an existing questionnaire used in 2022 with Ukrainian refugees and internally-displaced persons by the same research team (15,16). The survey questions were uploaded to an Android smartphone App (ODK). The tool was pretested in Nabdam, a neighbouring district among 20

refugees. These test responses were not included in the final analysis. All the necessary 162 adjustments, including skip logic, and age groupings were made before the main data collection 163 begins. Ten community health workers participated in a two-day data collection training 164 workshop, covering issues such as data collection, good research practice and the need for 165 explaining the study and obtaining informed consent. As we anticipated low literacy rates, 166 167 survey questions were verbally read out and the data collectors recorded their responses directly onto the ODK app. The survey was written in English. A local dialect, Moshie, was used for 168 verbal translations and context. 169 170 Data analysis techniques 171 Stata version 15 was utilized in carrying out descriptive and inferential statistics for the 172 173 data. Descriptive statistics including frequencies, percentages, mean and standard deviation. A reliability test was conducted for the 9 HFIAS and the 4 sense of security variables and a 174 Cronbach alpha value of 0.84 and 0.68 respectively were obtained. To assess determinants of 175 household food insecurity, a logistic regression analysis was conducted, and p-values of < .05176 were considered statistically significant. 177

179 Ethical consideration

Ethical approval (UDS/RB/112/22) was obtained from the University for Development Sciences Research and Ethics Review (Supplementary, S2). Separately, approval and community entry was sought from the 3 district assemblies to carry out the study within their populations. Informed written consent was obtained from all individuals before they participated in the study.

185	Results
186	In total, 498 participants completed the survey (Table 1), with a majority being female
187	(65.3%). The average age was 37.2 years (<i>SD</i> = 16.2, <i>Range</i> 18-98). Nearly 86.0% had no formal
188	education, 93.0% were affiliated to Islamic religion, and 90.0% indicated that their home
189	community was a rural area (Table 1). The mean household size was 5.97 people, with a mean of
190	1.42 children aged under 5 years per household. Finally, 5.5% of the female group indicated that
191	they were pregnant.

221 Determinants of household food insecurity

From a simple linear logistic regression model, the sociodemographic variables were not 222 significant (Table 3). We therefore adjusted for only three significant variables, such as refugee 223 residents before migrating to their current location, refugees' current location in Ghana, and the 224 size of the accommodation facilities in the final multivariate logistic regression model. From the 225 model, rural refugee were negatively associated with food insecurity. That is, refugees from rural 226 areas were more food secure than those from cities or urban areas, B = -4.25 (CI: -5.79 - -2.71), 227 228 p < .001. Refugees currently staying with someone they knew, such as a relative or a friend in 229 the host community, reported lower food insecurity compared to those living in housing specifically set up to house refugees, B = -1.56 (CI: -2.74 - -0.39) p = .009. Finally, lower 230 231 satisfaction with accommodation space was marginally associated with increased food insecurity 232 compared to those happy with the size of their accommodation space, B = 2.96 (CI: -0.06 – 233 2.47), p = .060. Results are displaced in Table 3. 234

238 Living conditions of the refugees.

By accommodation status, 54.0% were living in housing specifically set up to house refugees, with 22.7% living with somebody they knew before migrating to Ghana, such as relatives or friends (Table 4). A further 19.5% were living in accommodation provided by a

242	member of the host community who was not previously known to the refugee participant. Most
243	females (69.1%) were living in housing specifically set up to house refugees (Error! Reference
244	source not found.). By living conditions, 84.1% of participants were least happy about their
245	current living conditions, with only 2.4% reporting being happy. In terms of support system, only
246	120 (24.1%) participants had received any welfare or housing payment to support their living
247	standards (Table 4). Of the 120 participants who received financial support, most had received
248	support from more than one source, with 94.2% receiving welfare payments from the Ghanaian
249	Government, and 85.0% from international agencies such as UNICEF and UNHCR as their
250	source of welfare payments (Figure 3). Overall, 76.0% of respondents indicated they did not
251	have enough financial and other resources to meet their household basic needs.

261	Regarding participants' sense of security, 71.9% of respondents agreed to some extent			
262	that they feel satisfied with their current living conditions. However, 28.5% of participants			
263	disagreed to some extent that they feel satisfied with their current living conditions. With regards			
264	to community safety, 72.5% agreed to some extent that they felt safe in their new location, with			
265	16.0% expressing some form of disagreement. By community response, 73.5% agreed to some			
266	extent that they felt welcome by the local community, whereas around 17.0% disagreed to some			
267	extent. Finally, participants 23.3% indicated that they had perceived some level of hostility or			
268	anger from others in their local community (Table 5).

Discussion

Displaced persons are often disadvantaged with access to adequate food and suitable living conditions. Among Burkina Faso refugees currently living in the Northern part of Ghana, our study found that close to 100% experienced household food insecurity, with 80.3% of households experiencing severe insecurity. Self-reported satisfaction of living conditions was variable across the study population, with most participants reporting how they felt safe and welcomed by their new local community.

The level of food insecurity was higher than the national prevalence of food insecurity in both Burkina Faso (41%) and the host country Ghana (11.7%) (17,18). Although, a recent study found some level of food insecurity reported by Ghanaian participants from a rural community in the Northern Region of Ghana(19). Among other refugee populations, food insecurity is typically very high. For example, several studies have reported greater than 80% insecurity for refugees in the USA, with 42% of children experiencing hunger (20). Similar results were found among Syrian refugees in Canada (21), and Afghan refugees in Iran (22). Lower insecurity was reported among Iraqi refugees in Lebanon (44.4%) and Scotland (56%) (23). Our findings add to the evidence base around risks of hunger and malnutrition among these vulnerable populations. There may be a need for targeted interventions to reduce the negative impact on the lives of under-5s, pregnant women, and older people, as these populations are disproportionately affected by food insecurity and conflict (21,24,25) For those who remained in Burkina Faso, there is a longer-term trend of difficulties with food security as a result of climate change, the impact of COVID-19, increases in food prices, and the continued rise in armed conflicts (24,26,27).

Around half of the participants in this study resided in refugee camps set up by UNHCR and the local authorities, and these people reported less satisfaction and greater insecurity with

the quality of their accommodation compared to participants who were staying with community members who they knew. This may highlight the increased vulnerability of forced migrants who have little knowledge of their new community, with issues such as familiarity and language being factors that may make it more difficult to access food, water, and healthcare.

Most participants (80%) reported some level of unhappiness around the size of their accommodation. A qualitative study conducted in Southern Australia among refugees and asylum seekers exploring the relationship between housing and health revealed that a significant number of participants were worried about the size of the accommodation which was reported to have a negative impact on their mental health (28). There are many factors that affect wellbeing of refugee groups, and this provides an opportunity for stakeholders to conduct site-specific needs assessments to determine optimum and realistic living conditions alongside the level of satisfaction among refugees.

Refugees are entitled to receive welfare support from local authorities, although this is often difficult due to individuals' lack of familiarity with bureaucratic and regulatory barriers. From our study, only 24.1% of refugees received welfare support with the major source of accessible support coming from Government of Ghana and the United Nations agency, such as UNICEF and UNHCR. This finding indicates the key role played by host-country in supporting the mandated UN systems to take care of displaced persons during emergencies.

Around half of the participants indicated that they felt safe and welcomed by the host communities. Refugees' sense of safety and security in the host community is a complex issue that varies across different contexts. Studies have shown that host communities' attitudes toward refugees can have a significant impact on their sense of safety and security (29). Acceptance and assistance from the host community are crucial in ensuring support for refugee populations

(30). However, the perception of safety among refugees is subjective and individual, with many refugees not considering themselves to have found complete safety and protection in their host countries (31).

Our analyses indicate that refugees who migrated from rural areas had higher levels of food security compared with those from urban areas. The majority of participants indicated they were originally from rural areas. Thus, it is possible that rural-dwellers can more easily assimilate themselves with community members for support compared to those from cities who may have a problem adjusting to rural life. This is consistent with an earlier study conducted in Australia, which revealed that refugees from rural communities found it easy assimilating with rural host communities compared to urban refugees (32). There can also be a negative impact upon food security within the host communities themselves, as an influx of refugees can lead to uneven distribution of limited food supplies (29). In this study, refugees who are presently residing with an acquaintance within the host community, such as a relative or a friend, encountered fewer complexities concerning food insecurity in comparison to individuals residing in housing exclusively designated for refugees or internally displaced persons. These findings are in line with an earlier study reporting the importance of social support and community networking in improving the well-being of refugees (33,34). The result equally confirms the trade and inter-personal relationships that exists between the Northern part of Ghana and southern Burkina Faso (35). These relationships are established by historical, cultural, and economic elements, with migration and familial connections present between the populations of both nations (36).

The number of the displacement of Burkina Faso populations are on a much smaller scale than the situation with Ukraine, and perhaps this is one of the reasons for the lower profile of this

crisis in West Africa. However, the needs and conditions of the populations described here appear to be worse than those experienced by Ukraine refugees who are typically wealthier and moving to higher-income settings. When comparing Burkina Faso refugees in Ghana with the population remaining within Afghanistan, the prevalence of food insecurity is similarly high. Malnutrition is one of the key concerns in Afghanistan, and this has to be a real concern for those addressing the refugee crisis in northern Ghana.

Strengths and limitations

The strength of this study lies in the fact that this was a community-based cross-sectional study, with high-level refugees' participation. This study fills a knowledge gap around assessment of food insecurity, safety, and wellbeing among refugees within the sub-region. However, the study contains limitations. The tool that was used to measure household food insecurity provides a direct measure of household ability to afford food within the last 30 days and does not take into account other factors, including seasonality of food production and availability, discrimination in food allocation, and food preference. These aspects must be explored further to understand how they influence household food insecurity. There is little data available around the demographics of this refugee population, and thus we cannot be sure how representative our study populations are. This is also a one-off survey at one point in time – the refugee situation evolves quickly, and repeated similar measurements would provide an up to date assessment of health and social needs.

Conclusion

The current study found a high prevalence of household food insecurity among the Burkina Faso refugee population residing in Ghana. Refugees staying with populations known to themselves reported higher food security. Participants who were unhappy with their

accommodation size were associated with a higher risk of household food insecurity. A majority of the participants felt safe and welcomed by the host communities. The short-term measures should include improved logistics for regular food distribution by governments, UNHCR, and UNICEF. Measures should be taken to improve the living conditions through the provision of acceptable accommodation facilities. Health services should be strengthened, with proactive review of potential emerging cases of malnutrition. Further research can include repeating this survey to ensure up-to-date findings are available for decision-makers.



Prevalence of food insecurity among households (%)




