

# THE IMPLEMENTATION AND OUTCOME OF DIABETES PREVENTION PROGRAM LIFESTYLE INTERVENTION IN HIGH RISK OR PREDIABETES: A REVIEW OF THE LITERATURE

## ABSTRACT

### Background

Effective lifestyle intervention can lower Type 2 diabetes mellitus in high-risk or prediabetic people through diabetes mellitus prevention programmes. The aim of this review of the research is to provide an explanation of how diabetes prevention programmes (DPP) are implemented in high-risk people or those with prediabetes using a variety of DPP methods and results.

### Method

The method used is a literature review by searching for relevant peer-reviewed articles published in English in three databases: Scopus, PubMed, and CINAHL. Studies assessing the use of diabetes mellitus preventive programmes in high-risk people or people with prediabetes were the inclusion criteria for this review. Individuals with prediabetes or high risk were among the subjects. The main result is the outcome of the DPP. Literature search is limited to publications in 2018–2023 and open access.

### Result

18 articles in all were reviewed. The main focus of DPP-based lifestyle interventions is dietary and physical activity. Health education and behaviour change strategies are also included in lifestyle interventions. The implementation of nutrition or dietary interventions can be provided face-to-face on a group-based basis for an average of 6–12 months and online through intensive interventions with weekly online modules through web-based platforms, text messaging, and digital therapy. The implementation of diet and physical activity interventions needs support from families or groups to be able to make healthy behaviour changes, one of which is peer support. The short-term effects of DPP are decreased waist circumference, plasma glucose levels, increased knowledge, diet, and physical activity. The long-term consequences of DPP include weight loss with a lowered risk of developing diabetes, modifications to lipid profiles, enhanced pancreatic cell function, increased insulin sensitivity, decreased body fat mass, and HbA1C.

### Conclusion

Diabetes mellitus prevention programme through effective lifestyle interventions to slow the onset of type 2 diabetes mellitus in prediabetic individuals

## BACKGROUND

Diabetes mellitus is a non-communicable disease that can cause death (WHO, 2023). The International Diabetes Federation (IDF) estimates that 573 million adult people (20-79 years old) worldwide already have diabetes, and that number will rise to 643 million by 2030 and 783 million by 2045 (IDF, 2021). Microvascular consequences of type 2 diabetes Mellitus might include retinopathy, nephropathy, and neuropathy (Thipsawat, 2023). Prediabetes is one factor that can accelerate the onset of diabetes mellitus (Venkataramani et al., 2019). According to Rooney et al. (2023), prediabetes is characterised by impaired glucose tolerance (IGT) (2-h glucose [140–199 mg/dL]) and impaired glucose tolerance (IFG) (fasting glucose [110–125 mg/dL]) or increased

blood glucose levels below the threshold for a diagnosis of diabetes. Approximately 96 million persons aged 18 and over were expected to have prediabetes in 2019 by the Centres for Disease Control and Prevention (CDC, 2022). According to Rooney et al. (2023), those with IGT and IFG have a high chance of getting diabetes within 5 years (up to 50%). Diabetes prevention through lifestyle interventions needs to be carried out in Prediabetic individuals to slow the onset of diabetes mellitus (Jiang et al., 2018).

According to several studies, lifestyle interventions can prevent 40–70% of prediabetic people from developing Type 2 diabetes mellitus (Kramer et al., 2018; Sampson et al., 2020; Thipsawat, 2023; Vargas et al., 2023). The main focus of DPP through lifestyle interventions is diet and physical activity (Ford et al., 2019; Kriska et al., 2021). Food composition is an integral part of diabetes mellitus management by considering three components, namely encouraging weight loss or maintenance, improving glycemic control, and preventing complications (Hall, Rosemary; Krebs & Parry Strong, 2016). Low-carbohydrate diets are effective in reducing weight and improving glycemic control (Brouns, 2018). Diabetes mellitus can be prevented by engaging in moderate-intensity physical activity for 150 minutes five days a week or longer, such as brisk walking, two to three sessions of muscle-strengthening exercises, and lowering total and saturated fat intake (Kramer et al., 2018; Sampson et al., 2020 ).

All participants in the DPP lifestyle intervention receive the same intervention to help them lose weight and get more exercise, but they are also free to choose how they want to go about accomplishing it (American Diabetes Association, 2021). Previous literature studies only provide a general description of the recommended components of diet and physical activity (MacPherson et al., 2020; Muilwijk et al., 2018), but the literature review describes the implementation of DPP through lifestyle interventions with various methods supported by limited evidence of its effectiveness. The aim of this literature review is to describe how the DPP lifestyle intervention is implemented the outcome in high-risk people or people with prediabetes.

## **METHOD**

The method used is literature-review by searching for relevant peer-reviewed articles published in English in three databases: Scopus, PubMed, and CINAHL. Studies assessing the application of diabetes mellitus preventive interventions in people at high risk of developing diabetes mellitus or prediabetes were the inclusion criteria for this evaluation. The types of research are observation, experiment, randomized controlled trial, non-randomized controlled trial. Individuals with prediabetes or diabetes mellitus were among the subjects. The main result is the outcome of the DPP. Open access and 2018-2023 publications alone are included in the literature search.

## **RESULT**

The author found 34,319 articles from three databases, including Scopus: 701 articles; Pubmed: 16,866 articles; CINAHL: 16,752 articles, after searching with specific keywords combined with Boolean "AND" and "OR" operators. The keywords of the PICO framework include Population (individuals at high risk of Diabetes mellitus or Prediabetes), Intervention (Diabetes Prevention), Comparison (usual care), and Results (Risk of diabetes mellitus or clinical condition).

18 papers were assessed after being duplicate-screened by Rayyan and manually by the research team while taking the inclusion criteria into consideration.

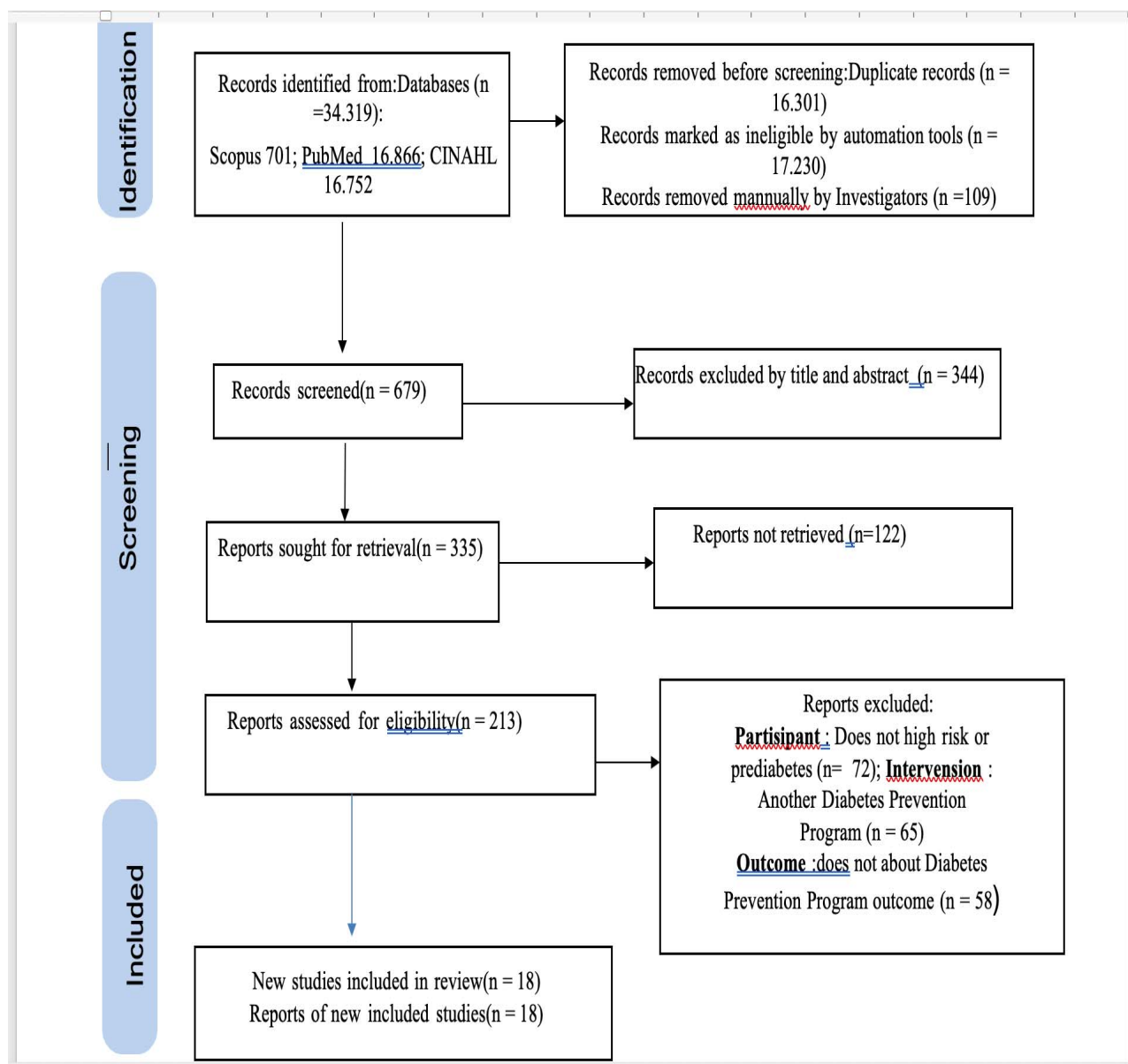


Figure 1. Flowchart for PRISMA

## DISCUSSION

### The Diabetes Prevention Program

The Diabetes Prevention Programme (DPP) aids those who are at high risk of developing diabetes mellitus or who have prediabetes (American Diabetes Association, 2021). One of the key goals of the DPP is to employ lifestyle interventions to stop high-risk people from developing prediabetes or diabetes mellitus (Jiang et al., 2018). Lifestyle interventions can lower the chance of developing diabetes mellitus, according to several randomised controlled trials, including diabetes mellitus prevention programmes (Gilbertson et al., 2019; Kramer et al., 2018; Sampson et al., 2020; Vargas-Ortiz et al., 2020). Weight loss of at least 7% and 150 minutes per week of moderate physical activity are the targets of lifestyle interventions (American Diabetes Association, 2021; Ford et al., 2019)

### Implementation of Diabetes Prevention Program in High-Risk or Prediabetic Individuals

The method used in the Diabetes prevention program is lifestyle intervention through dietary and physical activity (Ford et al., 2019; Kriska et al., 2021). Health education and behavior change strategies are also included in the lifestyle intervention in the Diabetes mellitus prevention program (Soltero et al., 2018). The Diabetes mellitus prevention program through lifestyle intervention is a goal-based intervention where all participants are given the same intervention to achieve the goal of losing weight and doing physical activity, but are allowed to use specific methods to achieve the goal (American Diabetes Association, 2021). The following is an overview of the implementation of the Diabetes mellitus prevention program based on a literature review:

## Dietary

Dietary interventions in diabetes mellitus prevention programmes include reducing total food fat and calories and increasing vegetable and fruit intake (Ford et al., 2019) to prevent type 2 diabetes mellitus for individuals at high risk with a body mass index showing excess body weight or obesity (American Diabetes Association, 2021). One of the goals of diabetes mellitus prevention programme is to reduce body weight by 7% in individuals who are overweight or obese (Kramer et al., 2018). Before implementing nutritional or diet interventions, it is necessary to assess food intake for 3 days to determine the total calorie intake and macronutrient composition, including carbohydrates, fats, and proteins, of a daily intake (Gilbertson et al., 2019).

Face-to-face implementation of dietary or nutritional treatments can be done over a period of 12 months and 22 group sessions (16 core sessions in the first 6 months, followed by 6 maintenance sessions) (Kramer et al., 2018). In addition, it can be carried out online through a 12-month intensive intervention with weekly online modules via a web platform (Lee, Pearl G; Damschroder, Laura J; Holleman, Robert; Moin, Tannaz; Richardson, 2018). It can also be carried out via text messages, which can include information on healthy eating and nutrition (Vargas et al., 2023). Online programmes to prevent diabetes mellitus attracted more participants. On the other hand, online or in-person programmes for preventing diabetes mellitus had a 5% effect on weight loss (Lee, Pearl G; Damschroder, Laura J.; Holleman, Robert; Moin, Tannaz; Richardson, 2018). Digital therapy is another method that can be used to deliver diabetes mellitus prevention programmes. Participants can access digital applications that include health education, health training, peer groups, and tools for tracking nutritional status, intake, physical activity, body weight, and HbA1c (Fauzi et al., 2023). Additionally, putting into practise diabetes mellitus preventive programmes can be done in clinical and communal contexts (Defosset et al., 2021).

To implement dietary or nutritional interventions and increase physical activity, it is necessary to have the support of the family or community. The assistance offered can take the form of evaluation, knowledge, practical assistance, and emotional support (Soltero et al., 2018). With people who are at high risk for diabetes or prediabetes, nutritional and food counselling is also given to family members. The topics are divided into 6 sections, each lasting around an hour. Processing meal planning, creating healthy plates, and analysing and contrasting food labels are all nutrition-related subjects. According to research (Vargas-Ortiz et al., 2020), family members who participate in diabetes mellitus preventive programmes effectively change their glucose and insulin sensitivity. A type of assistance offered by other patients who have adopted healthy lifestyle modifications and received training in preventing diabetes mellitus is known as peer support. In order to improve behaviour and prevent diabetes mellitus for six months, persons with prediabetes or high risk conditions can receive weekly telephone help from peers (Heisler et al., 2023). Patient-centered counselling strategies can be applied to nutritional or dietary therapies, as well as physical exercise, in the prevention of diabetes mellitus. stimulate decision-making regarding behaviour change, boost motivation for change, engage social support, support problem-solving and help with developing personally tailored goals, action plans, and self-monitoring. Participants established a behaviour modification goal of 7% weight loss if their BMI was higher than 30 (Sampson et al., 2020).



## **Physical activity**

People with prediabetes benefit from 150 minutes per week of moderate-intensity physical exercise, such as brisk walking (American Diabetes Association, 2021; Kramer et al., 2018; Sampson et al., 2020). A person's risk of developing diabetes mellitus can be decreased if they have a body mass index (BMI) of greater than 30, 150 minutes per week of moderate-intensity exercise, 2 to 3 sessions per week of muscle-strengthening exercise, and a lower intake of total and saturated fats (Sampson et al., 2020). Physical activity's primary objective is to lower body weight by about 7% (Kriska et al., 2021). Only 20% of people who engage in physical exercise with energy expenditure comparable to 20 minutes of brisk walking will develop Type 2 diabetes (Arsenault & Despr, 2023). Running sprint interval training (INT), which is performed four times for 30 seconds, can also be used as a form of exercise, as can moderate-intensity continuous training (MICT), which entails walking on a treadmill for 30 minutes while maintaining a heart rate reserve of 45–55%. Every four weeks, the training session is extended by 10 minutes, resulting in a 60-minute session for the MICT group members. According to Gilbertson et al. (2019), these two physical activities are successful at lowering body weight and body fat mass.

Age and socio-demographic characteristics are among those associated with participation and success in diabetes mellitus prevention programmes, according to a literature review (Devaraj et al., 2021; Venkataramani et al., 2019). According to Venkataramani et al. (2019), more than 25% of individuals have never taken part in a diabetic mellitus preventive programme and have no interest in doing

## **Outcomes from the Diabetes Mellitus Prevention Programme**

The Diabetes Mellitus Prevention Programme, which is a lifestyle intervention, has both short- and long-term effects on avoiding diabetes mellitus in those with prediabetes or high risk of developing the disease (Jiang et al., 2018a; Liu et al., 2022). After three months of the Diabetes mellitus prevention programme with lifestyle intervention, short-term effects were assessed, and long-term effects were assessed after six to twelve months (Jiang et al., 2018b; Liu et al., 2022). Short-term effects include reduced waist circumference and fasting plasma glucose levels, which were significantly higher in the intervention group compared to the control group (odds ratio 1.32,  $P = 0.02$ ) (Gilbertson et al., 2019; Lee, Pearl G; Damschroder, Laura J.; Holleman, Robert; Moin, Tannaz; Richardson, 2018). Increased awareness of food, exercise, and Diabetes Mellitus prevention are some other short-term effects (Yazel-Smith et al., 2020).

The Diabetes mellitus prevention programme with lifestyle intervention had the following long-term effects on participants: >5% weight reduction, 17% weight loss between 3 and 5%, and 47% weight loss of less than 3% (Lee, Pearl G; Damschroder, Laura J; Holleman, Robert; Moin, Tannaz; Richardson, 2018). Participants who lost more than 5% of their body weight had a 64% decreased chance of getting diabetes over the course of six years compared to those who lost between 3-5%. (Jiang et al., 2018) have diabetes. Changes in lipid profiles, insulin sensitivity, enhanced pancreatic cell activity, decreased body fat mass, and HbA1C are additional long-term impacts (Vargas-Ortiz et al., 2020; Kramer et al., 2018). A decrease in total energy intake and an increase in fruit and vegetable consumption were also seen (Ford et al., 2019).

## CONCLUSION

To stop the onset of diabetes mellitus in prediabetic people, lifestyle interventions for diabetes prevention must be implemented. Diet, physical activity, health education, and behaviour modification techniques are all examples of lifestyle interventions. The diet's major goals are to lower overall fat and food calories while increasing intake of fruits and vegetables. Diabetes mellitus can be halted or delayed with 150 minutes of moderate-intensity exercise five days a week or more, two to three sessions of muscle-strengthening exercise, and a reduction in total and saturated fat intake.
