# Moving together – Benefits of a 12-week online dance training intervention on static and dynamic postural stability and gait speed in older adults – a pre-post study

# 23 Abstract (297/300)

- Background Physical inactivity negatively affects gait performance and postural stability in older adults, which results in a higher risk of fall accidents. Previous research has shown that in-person dance training improves various aspects of balance and lower extremity function, however, the
- potential benefits of dance training delivered online on variables used for fall risk stratification in
   older adults have yet to be studied. We aimed to explore the benefits of a 12-week online dance
- training intervention on static and dynamic postural stability and gait speed in older adults.
- 30 **Methods** Forty-five older adults were included. The 12-week dance training intervention consisted
- 31 of two weekly 60-min classes in improvisation and salsa delivered online through Zoom video calls.
- 32 Static and dynamic postural stability was assessed using the center of pressure (CoP) area and
- 33 velocity (force platform), and the Mini Balance Evaluation Systems Test (Mini-BESTest),
- respectively. 10-m gait speed was measured using photo gates. Before and after comparisons were
- 35 performed using paired sample t-tests.
- 36 **Results** Thirty-two older adults completed the study. There were no significant changes for static
- 37 postural stability assessed by CoP area or velocity ( $P \ge 0.218$ ). The Mini-BESTest total score was
- 38 significantly improved at post-intervention (23.88  $\pm$  3.01) compared to baseline (22.56  $\pm$  1.41, P =
- 39 0.007). 10-m gait speed was significantly faster at post-intervention  $(1.68 \pm 0.25 \text{ m/s})$  compared to
- 40 baseline (1.57  $\pm$  0.22 m/s, P < 0.001).
- 41 **Discussion** These results indicate that online dance training has limited effect on static postural
- 42 stability but may be beneficial for gait speed and in particular dynamic postural control among older
- 43 adults. While the absolute increase in gait speed observed in the present study suggests limited
- 44 clinical relevance, the improvement in Mini-BESTest score was above the minimal clinically
- 45 important difference, which suggests a clinically relevant enhancement of dynamic postural control.

#### Introduction 49

50 Physical inactivity negatively affects gait performance and postural stability in older adults, which results in a higher risk of fall accidents. Medical costs related to falls in older adults were estimated 51 52 to be approximately \$50 billion per year in the USA alone (1). This is a concerning public health 53 problem, as around 30% of the older adult population is expected to experience an accidental fall 54 within a one-year time period (2). Common outcomes from fall accidents in older adults are: head 55 injuries (3), fear of falling (4), loss of physical independence (5), increased healthcare utilization 56 (6), and mortality (7), among others.

57 Physical training has been shown to improve risk factors and prevent fall accidents 58 among older adults by focusing on improving gait and balance stability deficits (8). In the current 59 world guidelines for fall prevention, dynamic gait evaluations are used for stratification of older 60 adults in relation to fall risk (9). The Mini Balance Evaluation Systems Test (Mini-BESTest) has been extensively used in clinical settings to evaluate anticipatory and reactive postural responses 61 62 and gait dynamics (10) due to its high construct validity and ability to discriminate between groups 63 with respect to fall risk in older adults (11). Furthermore, low gait speed has previously been 64 correlated with increased risk for accidental fall in community-dwelling older adults (12), a risk that is specifically amplified when gait speed is lower than 1 m/s (13). Jointly, these studies indicate the 65 66 importance of physically active aging in preventing fall accidents.

67 According to systematic reviews, dance training is a valuable health promotion 68 intervention for supporting healthy aging and addressing risk factors with declining health (14), and 69 for mitigating fall risk (15). Specifically, dancing is an enjoyable physical activity that can be 70 tailored to different cultural and aging backgrounds, and the physical needs of older adults; can 71 improve physical health outcomes; and has the potential to enhance emotional, psychological, and 72 social well-being. While Meron et al. (16) reported that folk or ballroom dancing did not prevent 73 falls or associated physical and cognitive fall-related risk factors, other studies using in-person 74 dance training have reported improved medial-lateral balance (17), reduced dependency of visual 75 input for balance maintenance (18), reduced attention demands during postural tasks (17), and 76 improved lower extremity function in older adults after as little as one weekly dance class for 12 77 weeks (19). In addition, a feasibility study (20) recently demonstrated beneficial impact of an 8-78 week contemporary dance training program on the modification of both physical and psychological 79 risk factors for falling in community-dwelling older adults. Taken together, although accumulating 80 evidence supports the benefits of in-person dance training on healthy aging, including the risk of 81 falls, virtually no studies have explored the potential benefits of dance training delivered digitally 82 (online) (21). Such online-based dance training may be particularly relevant in times of restricted access to physical activity, such as during the recent COVID-19 pandemic. Moreover, while home-83 84 based and digital training have previously proven to be effective for combating physical inactivity 85 among this population (22), less is known about whether this type of training may improve 86 variables used for fall risk stratification in older adults, such as gait speed and postural stability.

87 Therefore, the aim of the study was to explore the benefits of a 12-week online dance 88 training intervention the *Moving Together* (MT) program, on static and dynamic postural stability 89 and gait speed. Static postural stability is here defined as the ability to hold an upright position as 90 still as possible over a stable base of support, while dynamic postural stability is the ability to 91 maintain balance, i.e., keeping the body's center of mass vertical projection within the base of 92 support, when changes in the base of support occur (23). Throughout the evaluation of the 93 intervention's impact on these specific physical aspects, the study also seeks to contribute valuable 94 insights into the literature on the potential benefits of online dance training in the functional

95 performance of older adults. The hypothesis was that static postural stability, dynamic postural 96 stability, and gait speed would improve after 12 weeks of the online MT intervention.

#### **Materials and Methods** 97

#### 98 **Participants**

99 Forty-five older adults were included in this uncontrolled pre-post study (44 females;  $74 \pm 5.3$  years; 100  $69.7 \pm 13.0$  kg;  $1.62 \pm 0.58$  m). The participants were recruited through advertisements posted at activity centers for older adults in Municipality, through information meetings, by 101 advertisement in the press, and through flyers handled out in public spaces. To ensure inclusivity, 102 only two inclusion criteria were used: I) being 65 yrs or older, and II) being able to speak and 103 104 understand . Due to the wide inclusion criteria, there was a broad age range for participants 105 (65 to 87 yrs) as well as physical capacity of the participants. However, all were able to stand and 106 walk independently. The study was approved by the Committee on Health 107 Research Ethics (N-20220045) and conducted in accordance with the Declaration of Helsinki.

#### 108 **Dance training intervention**

The study builds upon a previous randomized controlled trial from our group (24) demonstrating that 109 110 regular fitness circuit training and a combination of in-person and online dance training significantly 111 reduced the number of fall accidents in older adults (25). In this separate study, we sought to extend this work by focusing on implementation of online dance training in practice (in the municipality). 112 113 Specifically, the MT consisted of two weekly dance classes lasting 60 min each, consisting of 114 improvisation (contemporary dance) (Day 1) and salsa (Day 2) performed for 12 weeks. The 115 movement language of Laban's choreological practice (26) was used to inspire and create variations 116 of movement during the contemporary dance classes, and the classes progressed in intensity. Each 117 class started and concluded with a focus on breathing exercises. The salsa classes were built upon 118 techniques from Cuban salsa; participants had a progressive introduction to the technique and the 119 expressive aesthetics of the dance style. Over time, the class included dancing with faster pace. The 120 classes were delivered by experienced professional dance instructors online through video calls using 121 the Zoom meeting application (Zoom Video Communications, Inc., San Jose, CA, USA). For 122 flexibility purposes, subjects could choose to attend the online classes either from home, or at one of four activity centers in the municipality. Each online class was recorded and uploaded to a designated 123 YouTube channel connected to the project after each class.<sup>1</sup> The YouTube channel resource was made 124 125 available for all participants and the public, where participants could review and replay the classes if 126 they were unable to attend on the day. Participants were instructed to dance at least once per week 127 but were encouraged to attend twice weekly. To promote engagement and social connection between the participants, a 60-min in-person salsa dance class was conducted once every month with physical 128 129 presence by both the instructor and the participants (up to three sessions in total per subject).

#### 130 Measurements

All measurements were performed immediately prior to (baseline) and following 12 weeks of dance 131 training and were carried out at local activity centers in Municipality. The same experienced 132 investigator was present at all tests and either performed the testing or provided supervised assistance 133 134 to two student helpers.

135 Static Postural Stability

136 Static postural stability during a quiet standing task was assessed for 30 seconds both with and without 137 a dual-task. A high-resolution three dimensional, four-channel, force platform (PLUX Wireless 138 Biosignals S.A., Lisboa, Portugal) sampled at 1000Hz was placed 1.5 m from a wall. A circle (d = 5139 cm) was placed on the wall at approximately eye height straight out of the participants. At baseline, 140 participants were instructed to stand on the force platform in a self-determined, comfortable position 141 with the distance between the feet measured with a non-elastic measuring tape. The distance between 142 the feet was then replicated at the post-test. Three single- and three dual-task recordings were 143 performed, and participants were instructed not to move during the 30-s recording period. 144 Measurements were calibrated prior to each participant, by recording a 10-s period with zero load on 145 the force platform. The center of pressure (CoP) data from the force platform was extracted from the horizontal forces and filtered digitally with a low-pass filter and a 20Hz cut-off frequency. The static 146 147 postural stability was then quantified from the CoP data via the 95% prediction ellipse CoP area and 148 resultant mean CoP velocity (27). A mathematic task was used as supra-postural task during the dual-149 task conditions, when participants were instructed to count backwards of 'minus 7', starting from a 150 random number between 0 and 500 (e.g., 40, 33, 26 etc.). The starting number for the three dual-tasks remained constant between visits. The mean of the three single-tasks and the three dual-tasks for both 151 152 variables were used for analyses.

## 153 *10-m gait speed*

154 Gait speed was determined using photo gates (Brower Timing Systems, Draper, UT, USA) placed in 155 a corridor 10 meters apart. Participants were instructed to walk as fast as possible without running ("Please walk as quickly as you can without running to the end of the corridor"). Participants started 156 walking two meters before the start line so that gait speed did not include the acceleration time, with 157 an additional 2-m walk-out after the participants crossed the finish line. A total of six walks were 158 159 performed (6 x 10 meters), with a self-determined break in between walks. For the last three 10-m walks, participants were instructed to perform the same mathematical dual-task as for the assessment 160 161 of postural control, yet with other starting numbers. For these dual-tasks, participants were instructed 162 to walk as fast as possible without running, while counting as correctly as possible. The mean of the three single-tasks and the three dual-tasks, respectively, were used for analyses. For comparison with 163 164 previous studies, the time to complete the 10-m walk was converted to speed (m/s).

- 165 *Dynamic postural stability (Mini-BESTest)*
- 166 Dynamic postural stability was determined using The Mini-BESTest (10). The Mini-BESTest
- 167 consists of 14 items related to domains of anticipatory transitions; reactive postural control; sensory
- 168 orientation; and dynamic balance during gait. The procedures for administration and scoring of the
- 169 Mini-BESTest were standardized as described in (28). For each item, a score from 0 (severe) to 2
- 170 (normal) was provided. Individual item scores were then summated and reported as the Mini-
- 171 BESTest total score (out of the maximum attainable 28 points) (28).

## 172 Statistics

- 173 Statistical analyses were performed using SPSS software (version 27; IBM, Armonk, New York)
- 174 with data reported as mean  $\pm$  SD. Statistical significance was set *a priori* at P < 0.05. Before and
- after comparisons on outcomes were performed using student paired t tests (two-tailed), with
- 176 Bonferonni adjustment for multiple comparisons (n = 2; gait speed with and without dual-task) by
- 177 dividing 0.05 with the number of comparisons such that significance was accepted at P < 0.025 for
- 178 these two outcomes. Pearson product-moment correlations (or Spearman's rank-order correlation
- 179 for non-normally distributed change scores) were calculated between age and change scores ( $\Delta =$
- 180 post-intervention baseline) for outcomes to explore potential associations between age and

- 181 responses to the intervention. We also calculated standardized effect sizes (Cohen d) to determine
- 182 the magnitude of change from baseline to post-intervention, with the following thresholds used for
- 183 interpretation: small (>0.2), moderate (>0.5), and large (>0.8).

#### Results 184

- 185 Of the 45 participants included at baseline, 13 dropped out, so that n = 32 in total were included for
- 186 analyses. All 32 participants were included in analyses irrespective of where and how they attended.
- Reasons for dropout included non-study related health issues (n = 5), lack of motivation (n = 4), 187
- 188 COVID-19 infection (n = 1), finding it too physically demanding to complete the dance sessions (n
- 189 = 2), and finding it uncomfortable being the only male (n = 1).
- 190 Static Postural Stability
- 191 Results for static postural stability are shown in Table 1. Due to corrupted data for three
- 192 participants, analyses are based on n = 29. There were no significant changes from baseline to post-
- 193 intervention for either single- or dual-task CoP area or velocity ( $P \ge 0.218$ ). Due to non-normality
- 194 of change scores, Spearman's rank order correlations were run to assess relationships between age
- and  $\Delta$  in single and dual-task CoP area and velocity. There were statistically significant correlations 195
- between age and  $\Delta$  in CoP area during single (r<sub>s</sub> = 0.386, P = 0.038) and dual-task (r<sub>s</sub> = 0.425, P = 196
- 197 0.022), suggesting that older age was associated with a greater increase in CoP area over the 12 198 weeks. Similarly, there was a statistically significant correlation between age and  $\Delta$  in dual-task
- 199 CoP velocity ( $r_s = 0.425$ , P = 0.021), with no correlation between age and  $\Delta$  in single-task CoP
- 200 velocity ( $r_s = 0.191$ , P = 0.321). The mathematical performance during the dual-task is presented in
- 201 Table 2. There were no significant changes in the mathematical performance during the dual-task,
- 202 either when expressed as the total number of counts, or as the relative or absolute number of correct
- 203 counting's ( $P \ge 0.28$ ).
- 204 10-m gait speed
- 205 One participant was unable to complete the walking test at post-intervention, so for 10-m gait speed
- 206 analyses is based on n = 31. 10-m gait speed was significantly faster after the 12 weeks of dance
- 207 training  $(1.68 \pm 0.25 \text{ m/s})$  compared to baseline  $(1.57 \pm 0.22 \text{ m/s}, P < 0.001, d = 0.737, Figure 1A)$ .
- 208 After Bonferroni adjustment, there was no significant change in 10-m gait speed with dual-task
- 209 from baseline  $(1.41 \pm 0.21 \text{ m/s})$  to post-intervention  $(1.48 \pm 0.25 \text{ m/s}, P = 0.045, d = 0.376, Figure$ 1B). There were no significant correlations between age and  $\Delta$  in 10-m gait speed (r = -0.072, P =
- 210 211
- 0.699) or age and  $\Delta$  in 10-m gait speed with dual-task (r = -0.99, P = 0.595). The mathematical
- 212 performance during the dual-task is presented in Table 3.
- 213 Dynamic Postural Stability
- Dynamic postural stability evaluated by the Mini-BESTest total score was significantly improved at 214
- 215 post-intervention (23.88  $\pm$  3.01) compared to baseline (22.56  $\pm$  1.41, P = 0.007, d = 0.52, Figure
- 216 1C). There was no significant correlation between age and  $\Delta$  in Mini-BESTest total score (r =
- 217 0.085, P = 0.642).

### Discussion 218

- 219 When comparing the results after 12 weeks of the MT with baseline values, our initial hypotheses
- 220 were only partially confirmed: I) it is not clear that static postural stability improved after the online
- 221 dancing intervention, as both the CoP area and velocity variables were not significantly different
- 222 between before and after intervention, II) gait speed was only faster during the conditions without

dual-task, however III) dynamic postural control, determined via the Mini-BESTest, was enhanced
 following the intervention.

225 Static Postural Stability

226 Assuming that static postural stability during a quiet standing task is achieved via controlling the 227 body posture as if it behaves as an inverted pendulum swinging around the ankle joints (29), the 228 optimal neuromuscular strategy to mitigate the effect of possible external perturbation is to increase 229 the stiffness around the ankles by co-contracting the antagonistic and agonistic muscles around this 230 joint (30). This strategy usually results in smaller and quicker displacements of the body after a 231 perturbation, which, in laboratory settings, are usually represented by smaller areas and increased 232 velocities of the CoP (31). Adding a supra-postural task, older adults would exhibit a decreased (I) 233 static postural stability (32), or (II) performance of the supra-postural task when the postural task is 234 highly demanding (33). In older adults, the capacity to carry out concurrent postural tasks is 235 paramount for maintaining balance in daily life activities, since its deficit may increase the risk for 236 accidental falls in this population (34). This capacity may also involve the prioritization of one of 237 the tasks over the other, which in postural control studies is often referred to as the "postural first" 238 principle, when the focus on maintaining the static posture stability overcomes the performance of 239 the supra-postural task (33). Regardless of the addition or not of a supra-postural task, the present 240 results did not show any clear change in CoP area or velocity nor in the performance of the dual-241 task intervention before/after. This could indicate: (I) a plateau effect, where the older adults that 242 participated in this study already presented good static postural stability prior to the intervention, 243 (II) a sensitivity problem, where the force platform measurement used here where not able to detect 244 the possible variations due to training, or (iii) ineffective intervention for static postural stability 245 since the dance training focused primarily on dynamic movements which relate to dynamic postural 246 stability. As exploratory analyses, we also computed correlations between age and changes in 247 postural control and gait speed to explore whether changes in these outcomes would be dependent 248 on age. For these analyses, we found significant correlations between age and  $\Delta$  in CoP velocity 249 (single-task only) and for age and  $\Delta$  in CoP area and velocity (both single and dual-task), thus 250 largely confirming previous research demonstrating greater CoP parameters at older age during 251 single- (35) and dual-task (36) platform assessments.

## 252 Dynamic Postural Stability

The ability to control the body position in space so its center of mass is within the base of support 253 254 when the body suffers perturbation (dynamic balance) relies upon the available sensory information 255 (usually vision, proprioceptive, and vestibular) to generate accurate motor responses to counter-256 react such perturbation and realign the vertical projection of the bodies' center of mass within the 257 new base of support. Such a scenario is often encountered when performing daily life activities such as walking, running, dancing, carrying objects, using transportation, doing house chores, etc. The 258 259 level of performance of such activities is usually associated with accidental falls in older adults, 260 where lower independence in performing these activities is associated with a higher risk of fall 261 accidents in older adults (37). After 12 weeks of the online dance training intervention, the Mini-262 BESTest score was significantly greater compared to baseline values, with a moderate effect size. 263 These results indicate that the MT intervention was beneficial for improving the older adults' 264 dynamic postural stability. It is noteworthy that the baseline values for Mini-BESTest (average of 265 22.5) were below the cutoff value of 23 points for the average age (74 years) reported in the 266 literature (38), which indicates that on average, participants were in a higher risk for fall accidents 267 when enrolled in the study compared to their peers. After the intervention, the average score for this 268 test increased to approximately 24 (with an average increase of 1.5 points), which is not only above

269 the cutoff values for fall risk in that age group, but also similar in size to the minimal clinically 270 important difference (1-2 points on the Mini-BESTest scale) when evaluating special groups such 271 as individuals after total knee replacement (39). However, it is important to highlight that the 272 number of fall accidents where not monitored in this study, so the real effect on fall accidents from

- 273 this intervention is yet to be investigated.
- 274 Gait Speed

275 Gait is also an effective way to quantify dynamic postural stability in older adults (40). In fact, 276 increasing gait speed after training has been correlated with lower fall risks in older adults. In 277 average, the gait speed increased 0.1 m/s after the present intervention, which even though 278 representing a moderate change (d = 0.737) might not be clinically relevant. The lack of relevance 279 of this result might be related to a ceiling effect. The maximum gait speed in older populations is 280 expected to range from 1.7 m/s (females) to 2.1 m/s (males) (41), while the average gait speed 281 during the baseline test was 1.5 m/s (all females). It is noteworthy that according to the latest 282 recommendations (9), gait speed should be used for fall risk stratification among older adults. 283 Indeed, gait speeds below 1 m/s are related to a higher risk of accidental falls in older adults (12), 284 indicating that for our participants, gait speed would not be an efficient measure for fall risk 285 stratification. Nevertheless, after the online dance intervention, our participants reached values close 286 to the maximum (1.6 m/s), indicating that the intervention may have provided enough stimuli for 287 motor improvement even though the participants already exhibited high performance values at 288 baseline. Further studies should investigate whether an online training approach is also effective for 289 less capable participants.

290 Methodological considerations

291 Despite the high degree of external validity in this study as the intervention was implemented in 292 practice, in a municipal setting, the study is limited, however, by not including a control group for 293 comparison. Thus, the results from the current study should be interpreted with some caution. 294 Another consideration is that our results might not be generalizable to older males, as only one man 295 was included in the study, and he dropped out due to not feeling comfortable with being 296 outnumbered. Such overwhelming female bias is consistent with the existing literature (14,42) and 297 should be addressed in future studies. Finally, this study is limited by the lack of control of 298 participant attendance. Due to our focus on inclusivity and implementation, participants were 299 allowed to play and replay the recorded dance classes from YouTube on their own, and hence we 300 were unable to accurately record attendance. This may have resulted in some participants attending 301 only once weekly, while others may have attended more than twice weekly. While we acknowledge 302 this limitation, it may approximate the more real-life context of our study.

#### 303 Conclusion

304 In summary, while the MT online dance training intervention had a limited impact on static postural 305 stability and gait speed, our data indicate important benefits of the intervention for dynamic postural control among older adults. Further research, including studies with stricter control of study 306 variables, is needed to investigate the efficacy of online dance training on the number of fall 307 308 accidents and to explore its effectiveness with different participant groups.
