Globally, 1.1 billion people have an untreated or preventable visual impairment (VI),

## 53 Introduction

55 including 43 million who are blind <sup>1, 2</sup>. The major cause of blindness are cataract and uncorrected refractive error (URE) is the leading cause of moderate and severe VI<sup>2</sup>. 56 57 The burden of eye conditions is disproportionately higher in low- and middle-income 58 countries with an estimated 39 million (91.8%) of the 43 million blind people living in 59 these countries  $^{2}$ . 60 Gender disparities in blindness and VI have been noted with women accounting for 61 55% of blindness <sup>2, 3</sup>. Studies across sub-Saharan Africa show that women, the elderly, 62 people in rural areas, and those in the poorest households are at highest risk of cataract-63 related blindness and VI<sup>4</sup>. Although factors like sex, economic status and disability 64 have been identified as driving inequities, more data on the relationships between these 65 variables is necessary 5-8.

66 Achieving universal eye health coverage is an integral step to achieving the Sustainable 67 Development Goals, and Universal Health Coverage, as reducing the burden of VI will 68 significantly improve individuals' achievements in education, work, social participation 69 and quality of life<sup>2</sup>. The World Report on Vision describes the need for integrated 70 person-centred eye care that adopts a health system perspective to address the 71 significant eye health challenges facing many countries, recommending monitoring 72 trends and evaluating progress as key actions for governments to meet their population 73 eye health needs <sup>1</sup>.

| 74 | Nigeria, has a population of over 200 million people in 2022, with people 50 years and             |

| 75 | over accounting for about 10% <sup>9</sup> . A national survey of VI in 2007 found the prevalence  |
| 76 | of blindness among adults aged over 40 years to be 4.2% (95%CI 3.8-4.6%) <sup>10</sup> .           |
| 77 | Kogi State, in northcentral Nigeria, is home to about 4 million people <sup>9</sup> . In 2007, the |
| 78 | prevalence of blindness in adults in this zone was 3.7% (95%CI 3.0-4.7%), prevalence               |
| 79 | of severe VI (SVI) was 1.7% (95%CI 1.2-2.5%) <sup>10</sup> . An unpublished situational analysis   |
| 80 | report in 2018 estimated the cataract surgical rate (CSR) in Kogi to be below 100 per              |
| 81 | million population. There were four ophthalmologists and one government hospital and               |
| 82 | numerous private hospitals providing routine small incision cataract surgery with                  |
| 83 | intraocular lens implantation.   |
| 84 | No data on eye health status, needs, or service coverage had been collected in Kogi                |
| 85 | since the 2007 national survey. In 2019, the Kogi State Ministry of Health, supported by           |
| 86 | non-governmental organisation, Sightsavers, embarked on a new eye health programme                 |
| 87 | with an aim to reach the most marginalised groups. A population-based blindness and                |
| 88 | VI survey was conducted at the outset to generate data to inform programme planning                |
| 89 | and baseline data to measure progress against. This paper reports the results of the               |
| 90 | survey.  |

## 92 Methods

### 93 Study design

- 94 A population-based cross-sectional survey, using a standardised rapid assessment of
- 95 avoidable blindness (RAAB) methodology (described elsewhere), was conducted
- 96 between September 2019 and March 2020<sup>11</sup>.

#### 97 Study population

- 98 This comprised adults aged 50 years and above resident in Kogi State for at least 6
- 99 months prior to the survey. Participants were recruited from 25<sup>th</sup> September 2019 to 31<sup>st</sup>
- 100 March 2020.

### 101 Sampling size and strategy

- 102 Sample size was calculated using the RAAB (version 5) software package. A minimum
- 103 sample size of 4,150 was determined based on an estimated blindness prevalence of
- 104 3.75% <sup>10</sup>, precision of 20% within a 95% confidence interval, non-compliance rate of
- 105 10% and design effect of 1.5.
- 106 A two-stage cluster sampling approach was adopted to select 4,150 eligible adults. First,
- 107 83 clusters were selected from a list of all villages (clusters) using probability
- 108 proportionate to size methodology. Secondly, 50 eligible participants were enrolled
- 109 from each village.

### 110 Study procedures

- 111 The data collection teams comprised an ophthalmologist (team leader), an ophthalmic
- 112 nurse and a cluster informer trained over five days by a certified RAAB trainer and
- 113 passed an inter observer variation test according to RAAB guidelines before proceeding
- 114 to the field.
- 115 Data were collected using an application on an android smartphone and uploaded to a
- 116 cloud-based server. Precise location of villages (not households) was recorded using
- 117 global positioning system (GPS) coordinates so that cluster level data could be visually
- 118 mapped and geospatially analysed.

#### 119 Study protocols and definitions

- 120 All consenting participants underwent an eye examination conducted by the
- 121 ophthalmologist following the standard RAAB protocol and answered additional
- 122 questions regarding disability and household wealth . Using the WHO definitions,
- 123 blindness was presenting VA (PVA) in the better eye less than 3/60, severe VI (SVI)
- 124 was VA better than 3/60 to less than 6/60, moderate VI (MVI) was VA 6/60 to less than
- 125 6/18<sup>12</sup>. Refractive error was PVA<6/18 improving to 6/18 with pinhole. Cataract
- 126 surgical coverage (CSC) is the number of operated persons with cataract as a proportion
- 127 of those needing plus who have had surgery, effective CSC is the number of operated
- 128 persons with cataract and have VA  $\geq 6/18$  as a proportion of those needing plus who
- have had surgery, and we used the new definitions presented in 2023  $^{13}$ .
- 130 The eye examination recorded the following data: (i) PVA measurement of each eye (all
- 131 participants). (ii) Pinhole VA of each eye if PVA<6/18. (iii) Lens examination of each
- 132 eye with a torch in a darkened room (all participants). (iv) Posterior-segment

133 examination with an ophthalmoscope of each eye PVA<6/18 where the principal cause 134 cannot be attributed to refractive error, cataract, or corneal scarring. (v) Assessment of 135 the major cause of VI of each eye PVA<6/18 and in persons where both eyes present 136 VA<6/18 and the causes are not the same. (vi) Questions regarding where cataract 137 surgery took place or why cataract surgery has not taken place where it is indicated. 138 Minor ocular conditions were treated by the team. Other conditions were referred to the 139 nearest hospital. 140 Disability (reported elsewhere <sup>14</sup>) was measured using the Washington Group Short Set 141 (WGSS) on Functioning a tool comprising six questions regarding self-reported 142 difficulties in six domains of functioning: seeing, hearing, climbing stairs or walking, 143 remembering or concentrating, self-care, and communication <sup>15</sup>. The severity of 144 disability was measured on a graded scale - 'no difficulty', 'some difficulty', 'a lot of 145 difficulty' and 'cannot do at all'. Individuals reporting 'a lot of difficulty' or worse in at 146 least one domain were considered to have a disability, creating a binary variable. Non-147 visual disability (a disability that excludes seeing difficulties) was defined as reporting 148 'a lot of difficulty' or worse in at least one domain excluding seeing. 149 The Nigeria Equity Tool (NET)<sup>16</sup>, an internationally recognised tool designed to 150 evaluate differences between social groups was used to categorise participants into one 151 of five quintiles according to ownership of a list of household assets, with the poorest in 152 the bottom quintile, and the wealthiest in the top quintile. The tool allows ascertaining

153 the relative wealth of study participants compared to the national population. For the

154 purposes of analysis, we created a binary variable by grouping the poorest three

155 quintiles, and the wealthiest two.

#### 156 Data management and analysis

| 157 | Data from the RAAB, Washington Group Short Set (WGSS) and Nigeria Equity Tool                     |

| 158 | (NET) were captured on CommCare software deployed on Android-based smartphones.                   |
| 159 | Each day, data were synced to the cloud, where it was downloaded and checked by a                 |
| 160 | study team member. Data was analysed in two main stages. First, a standardised                    |
| 161 | descriptive analysis was carried out using the RAAB software programme <sup>17</sup> . Age- and   |
| 162 | sex-adjusted prevalence was calculated for all variables of blindness and VI. Second,             |
| 163 | Stata v15 was used to conduct chi-squared tests and adjusted logistic regression models           |
| 164 | to estimate the associations between eye health outcomes, sex, relative wealth and                |
| 165 | disability <sup>18</sup> . Regression model standard errors were clustered to account for complex |
| 166 | sample design. The level of statistical significance was calculated between variables at          |
| 167 | p<0.05.   |

## 168 Ethics

169 The survey was approved by the Health Research Ethics Committee of Kogi State

170 Ministry of Health Nigeria and satisfied all legal and regulatory requirements pertaining

171 to research in Kogi State before commencement of the survey. Written consent was

172 obtained from all participants and thumb prints substituted in non-literate participants,

173 witnessed by an independent person – not a member of the study team – before

## 176 **Results**

### 177 **Participant characteristics**

- 178 The survey examined 3,926 adults (94.7% response rate) (Table 1); 2,283 (58.2%) were
- 179 female and the sample had a higher proportion of men aged 80+ years than women; the
- 180 oldest men were slightly older on average than the oldest women. From the sample,
- 181 212 (5.4%) had a non-visual disability (5.4% of men and 5.4% of women) and 1,078
- 182 (27.5%) adults lived in households belonging to the poorest quintile.

#### 185 **Prevalence of VI**

- 186 Adjusted for age and sex, the all-cause prevalence of bilateral blindness was 3.6% (95%
- 187 CI 3.0-4.2%), higher among men (4.1%, 95% CI 3.1-5.2%) than women (3.0%, 95% CI
- 188 2.4-3.9%), the difference not being statistically significant (Table 2). With best

189 correction, the adjusted prevalence was 3.3% (95% CI 2.7-4.1%). Prevalence of

- 190 presenting SVI was 2.0% (2.1% for men and 2.0% for women) and MVI 8.5% (8.8%
- 191 for men and 8.1% for women).
- 192 Adjusted for age and sex, the prevalence of all cause bilateral blindness among people
- 193 living with additional, non-visual disabilities was 38.3% (95% CI 29.0-48.6%)
- compared to 1.6% (95%CI 1.2-2.1%;  $\chi^2 = 771.9$ , p<0.001) among people without 194
- 195 additional disabilities. Prevalence of SVI and MVI was estimated at 5.5% and 13.5%,
- 196 respectively compared to 1.8 % and 8.2% among people without additional disabilities.
- 197 In general, bilateral blindness did not differ by household wealth quintile. However, the 198 prevalence of VI at all levels was slightly higher among participants in the poorest three 199 quintiles compared to the wealthiest two quintiles.

#### 205 **Causes of VI**

206 Cataract was the principal cause of bilateral blindness (73; 55.3% of all bilaterally blind

207 people), glaucoma the second most important (43; 32.6%), and non-trachoma corneal

208 opacities the third cause (7; 5.3%).

209 Cataract was the most important cause of SVI with 52 people (57.5% of all SVI cases),

210 followed by glaucoma and uncorrected refractive errors affecting eight people each

211 (10.4% each).

212 Uncorrected refractive error was the most important cause of MVI, affecting 174 people

213 (53.4% of all MVI cases), followed by cataract (118; 36.2%) and glaucoma (18; 5.5%).

#### 216 **Coverage of cataract services**

217 Age and sex adjusted cataract surgical coverage (CSC) at the 3/60 level was 48.0%,

218 higher among men than women (53.7% vs 40.3%). Among people with non-visual

219 disabilities, CSC was 12.0% compared with 66.9% among people without non-visual

220 disabilities. CSC was also higher among people living in households in the wealthiest

221 two quintiles (41.1%) compared to the lowest three (24.3%).

222 Effective CSC at the 6/60 level was 31.0% overall, and higher among males (34.9%)

223 than females (25.5%) and was extremely low among people with additional, non-visual

224 disabilities (1.9%) compared to people with no additional disabilities (46.2%). It was

225 also higher among people living in households belonging to the wealthiest two quintiles

226 (41.1%) compared to the poorest three (24.3%).

230 Using presenting visual acuity (PVA), of the 116 eyes operated on for cataract, 61

231 (52.6%) had good outcome (VA>6/18) increasing to 71 (61.2%) with best correction;

233 not shown). Surgical complications were identified as the most common cause of the 36

234 poor visual outcomes in operated eyes (n=21, 58.3%), followed by selection (n=7) and

- 235 sequelae (n=6). Both surgical complications (42.1%) and lack of spectacles (36.8%)
- 236 were important causes of borderline outcomes.

### **Barriers to cataract surgery**

- 238 More than 40% of people with untreated bilateral cataracts cited cost as the main barrier
- to surgery; 36.7% did not feel they needed the operation; and 8.5% were afraid to have
- surgery. People with cataracts in one eye mostly described not feeling the need as the
- reason for not being operated (56.7%), followed by cost (27.1%). There was little
- 242 difference between how men and women reported barriers to surgery.

#### Discussion 245

246 The prevalence of blindness among persons 50 years and over was found to be 3.6%,

247 almost unchanged from that reported in this part of Nigeria at 3.7% in 2007, suggesting

248 that the point prevalence of blindness has not changed over the past 13 years <sup>10</sup>. The

249 prevalence of blindness was lower among females (3.0%, 95% CI 2.4-3.9) than males

250 (4.1%, 95% CI 3.1-5.2) in this study, different from many other settings <sup>19, 20</sup>.

251 We had expected a higher blindness prevalence as we are not aware of any past or

252 current major blindness prevention initiatives in this state specifically targeting women.

253 With an average CSR of 317 per million population per year in Nigeria<sup>21</sup>, many people

cannot access the few surgical sites in the state capital. Furthermore, the Nigerian
population is aging and projected to reach 26 million in 2050 from 9 million reported in
2016<sup>22</sup>, the prevalence of blindness was expected to increase. Higher prevalence
estimates were found in other parts of Nigeria and other Sub-Saharan African countries
in more recent surveys: Plateau State 4.2%<sup>23</sup>, Katsina State 5.3%<sup>20</sup>, and lower levels in
Sokoto State 1.9%<sup>19</sup>.

260 As the major cause of blindness across Sub-Saharan Africa continues to be cataract <sup>2, 24</sup>, 261 our findings in Kogi State are consistent. Cataract surgical coverage for persons in our 262 study was relatively lower (48.0%) than in other parts of Nigeria like Sokoto where in 263 2016 the CSC for persons was reported at 67.3% and shows that only half of people 264 with an operable cataract had been operated on <sup>19, 25</sup>. The Sokoto study did in fact show 265 how in a ten-year period the CSC increased from 9% to 67% and prevalence of 266 blindness reduced from 11.6% to 6.8% largely because of improved availability of 267 human resources for cataract services. Availability of ophthalmologists as an indicator 268 of the capacity of services meeting eye health needs has been shown to not be a strong 269 predictor to the volume of cataract surgery and blindness prevalence elsewhere <sup>19, 26</sup>.

It is possible that people travel to the neighbouring Kwara State, known to have good eye services, to have their surgery. Given that eye camps are intermittent, some people may stay long periods of time with only one eye operated on particularly considering the significant direct and indirect costs of a second eye surgery. Also, a person bilaterally blind from cataracts might not feel compelled to operate the other eye if he/she sees well with the other earlier operated eye. Conversely, if the initial surgery had a poor outcome, the individual may have a risk adverse attitude to future surgery.

277 Similarly, to other studies in sub-Saharan Africa, we found that women were more

disadvantaged in accessing cataract services compared to men. The CSC for women in
our study was 12% lower (42.1%) compared to men (54.9%). Gender inequalities in
accessing cataract services are well known and have been documented in multiple
settings <sup>6</sup>, <sup>19</sup>, <sup>27</sup>, <sup>28</sup>. In Nigeria, gender differences were documented in the Nigeria
Blindness Survey, Plateau, and Sokoto states <sup>10</sup>, <sup>19</sup>, <sup>23</sup>.
Effective CSC provides additional quantitative information on the proportion of

operated individuals achieving good vision after surgery. In this study was found to be
31.0% overall, and significantly lower among women, poorer people, and those with
additional, non-visual disabilities. Closing the gap in surgical coverage for females
should be a deliberate attempt for all surgical service providers to ensure equity in
attaining UHC.

289 The cataract surgical outcome (CSO) in this study identified the proportion of eyes with 290 good VA following cataract surgery was 52.6% and increased to 61.2% with pinhole. 291 The best corrected CSO is higher than what was recorded for the northcentral zone in 292 the Nigeria Blindness Survey (54.9%) and slightly lower than in Sokoto State (69%)<sup>10</sup>, 293 <sup>19</sup>. The proportion of eyes with poor outcome following cataract surgery remains high in 294 comparison with the Nigeria Blindness survey and may be attributed to surgical 295 complications as recorded in this study. Quality surgical procedures such as biometry 296 and appropriate intraocular lens power determination may not be available and could 297 account for the leap in presenting versus best corrected visual outcome following 298 surgery. In planning for more cataract surgeries, it is important to ensure quality and 299 better outcomes.

This study identified cost as a major barrier to cataract surgery for those with bilateralcataracts. This is a significant challenge for patients as the average cost of cataract

surgery per eye is 45,000 Naira (\$64) whereas the minimum wage is 30,000 Naira (\$42)
<sup>29</sup>. Health insurance schemes have a low coverage with less than 5% of the working
population enrolled in these schemes from 2005-2021, necessitating a high proportion
of out-of-pocket payments for surgical services <sup>30</sup>. For those with unilateral cataracts, no
felt need was the biggest factor possibly because they still had unilateral functional
vision. This is not different from the findings of other surveys in similar settings <sup>20, 31</sup>.

#### 308 Strengths and Weaknesses

309 The survey response rate was high with 94.7%. Several reasons for this include the 310 survey being conducted in the dry season when most farming activities were inactive, 311 advance party information to the communities through the local cluster guides, and the survey team paying additional visits to absent enrolees. Women were more represented 312 313 in the sample than men particularly in the younger age group 50-69 years. This may be 314 related to the fact that there are marginally more women than men in the population 315 within that age group, and this evens out in older ages. As such age- and sex-adjusted 316 prevalence were reported. Also, this being partly a productive age group, it is possible 317 that many men were out searching for jobs in the daytime.

As the RAAB tool is designed to identify avoidable blindness and coverage of cataract surgical services, it may have underestimated the burden of blindness and visual impairment due to posterior segment diseases such as glaucoma, diabetic retinopathy and age-related macular degeneration due to limitations in the diagnostic accuracy of the tool. Therefore, results must be interpreted with caution.

# 323 Conclusions

| 324 | This study has provided baseline information needed to set up an inclusive eye health   |
