#### 44 Abstract

45 Background: Integrated approaches to mapping skin Neglected Tropical Diseases (NTDs) 46 may be cost-effective way to guide decisions on resource mobilization. Pilot studies have 47 been carried out, but large-scale data covering multiple countries endemic for skin-NTDs are 48 lacking. Within the LAMP4YAWS project, we collected integrated data on the burden of 49 multiple skin-NTDs.

50 Methods: From March 2021 to March 2023, integrated case searches for yaws alongside other 51 skin conditions were performed in endemic health districts of yaws in Cameroon, Côte 52 d'Ivoire, and Ghana. Initial screening involved a brief clinical examination of participants to 53 determine if any skin conditions were suspected. Cases of skin-NTDs were then referred to a 54 health facility for appropriate management.

55 Results: Overall 61,080 individuals screened, 11,387 (18.6%) had skin lesions. The majority 56 of individuals (>90%) examined were children aged 15 years old and under. The proportion 57 of serologically confirmed yaws cases was 8.6% (18/210) in Cameroon, 6.8% (84/1232) in 58 Côte d'Ivoire, and 26.8% (440/1643) in Ghana. Other skin conditions based on clinical 59 examination included: scabies, Buruli ulcer, leprosy, lymphatic filariasis (lymphoedema and 60 hydrocele), tungiasis, and fungal infections. The most common conditions were scabies and 61 superficial fungal infections (scabies versus fungal infections) in Cameroon with 5.1% 62 (214/4204) versus 88.7% (3730/4204), Côte d'Ivoire with 25.2% (1285/5095) versus 50.4% 63 (2567/5095) and Ghana 20% (419/2090) versus 1.3% (28/2090). Other skin-NTDs were less 64 common across all three countries.

65 Conclusion: This study confirms that integrated screening allows simultaneous detection of66 multiple skin-NTDs, maximising use of scarce resources.

# 70 Plain English Summary

Many Neglected Tropical Diseases (NTDs) predominantly affect the skin and are referred to as skin-NTDs. The World Health Organization (WHO) has developed a number of strategies for the control, eradication and elimination of skin-NTDs and recognizes the importance of integrated approaches to mapping skin-NTDs. We conducted a study adopting integrated screening for multiple skin-NTDs and other skin conditions in Cameroon, Côte d'Ivoire, and Ghana. This ran alongside a study focused on diagnostic tests for one specific skin-NTD – yaws.

78 The results showed that integrated screening is a feasible and cost-effective way to detect 79 multiple skin-NTDs in a single intervention. Of more than 60,000 individuals screened almost 80 one in five had a skin lesion. Cases of yaws confirmed by blood tests were detected more 81 frequently in Ghana compared to Côte d'Ivoire and Cameroon. The most common skin 82 conditions were scabies and superficial fungal infections. Other skin-NTDs such as Buruli 83 ulcer, leprosy, lymphatic filariasis and tungiasis were less common. Integrated screening 84 allowed detection of skin conditions and co-endemicity of skin-NTDs and the data can guide 85 decisions on resource mobilization to manage skin-NTDs.

#### 88 INTRODUCTION

Skin diseases affect over 900 million people worldwide annually and are the third most frequent reason for seeking care (1-3). A subset of these conditions are also classified by the World Health Organization (WHO) as Neglected Tropical Diseases (NTDs) (4). Of the twenty NTDs recognised by WHO, more than half can present as skin diseases and are referred to as skin-NTDs. If not diagnosed and treated promptly, these conditions can result in disfigurement, disability, stigmatisation, impacts on mental health, and socioeconomic difficulties (4-6).

In Cameroon, Côte d'Ivoire, and Ghana, several skin-NTDs are known to be endemic
including yaws (7-10), Buruli ulcer (11-13), leishmaniasis (14-16), leprosy (10, 17, 18),
lymphatic filariasis (19-21), mycetoma (22-24), onchocerciasis (25-27), and scabies (10, 2830). Alongside these conditions, a number of more common skin conditions including
superficial fungal and bacterial infections cause a considerable burden of disease (28, 31-33).

101 Most data on skin-NTDs rely on passive surveillance activities, which are likely to 102 underestimate the true burden of disease as they are dependent on patients who present to a 103 health centre, receive a diagnosis and are reported to the respective disease control 104 programme. The highest burden of skin-NTDs is believed to be in communities living in 105 difficult to reach areas with limited access to healthcare (34, 35). Consequently, routine data 106 are likely to underreport the true burden and epidemiology of these conditions.

107 To achieve the WHO goals for skin-NTDs, active case detection will be required. Therefore, 108 WHO has recently promoted integrated activities of skin-NTDs in order to accelerate progress 109 in their control, elimination and eradication (4, 36). Because NTDs often overlap in 110 geographic areas, integrated active case searching may offer a way to overcome some of the 111 challenges associated with stand-alone programmes and reduce the risk of late detection of 112 skin-NTDs. Integration can also result in a reduction of resources, thereby increasing cost-113 effectiveness and allow for an expanded coverage of interventions (2, 36-38).

The LAMP4YAWS project in Cameroon, Côte d'Ivoire, and Ghana aimed to implement and evaluate a loop-mediated isothermal amplification test for yaws. As part of the project, field activities included active case searching of yaws using an integrated approach (39). Here we report data on skin conditions from active case searches in yaws-endemic health districts from all three countries.

#### 120 METHODS

#### 121 Study design

122 From March 2021 to March 2023, we undertook integrated case searches in rural 123 communities within suspected yaws-endemic health districts in Cameroon, Côte d'Ivoire, and 124 Ghana. Integrated approach for skin-NTDs offers possibility to address several diseases 125 simultaneously in the same communities in order to maximize the utilization of limited 126 resources (40). This approach was implemented by assessing burden of yaws in health 127 districts from notifications of NTD national programs, training of health workers and village 128 volunteers, conducting active case detection of skin conditions, clinical diagnosis and rapid 129 tests for yaws, treating yaws cases and referring other skin conditions to healthcare centres 130 (2). In each community visited, initial screening involved an examination to determine if 131 participants had skin lesions as described in the study protocol (39).

#### 132 Study sites

The study was conducted in rural areas in 12 health districts in Cameroon, six in Côte d'Ivoire, and seven in Ghana (39). The characteristics of the study sites are summarised in Table 1. Study sites were selected based on clinical notifications of yaws by the national programmes on NTDs.

## 137 Recruitment of participants

Case searches were conducted in collaboration with national NTD programmes. District health staff were first trained to recognise skin-NTDs as well as other skin conditions. Training materials included the WHO manual on recognition of skin-NTDs (41), as well as other national NTD training materials.

Individuals presenting with yaws-like lesions underwent SD Bioline (Abbott, USA) test to detect anti-treponemal antibodies. Those reactive underwent a Chembio Dual Path Platform (DPP) test (Chembio Diagnostics, New York, USA) for simultaneous detection of both treponemal and non-treponemal antibodies, interpreted as serologically confirmed yaws case. Samples were then taken as part of the main study from participants as described elsewhere (39). Other skin diseases were recorded and referred to the health district for management following the national guidelines.

Several approaches were used for case finding, including community-based case detection, detection in healthcare centres, primary school-based screening programs, screening alongside mass drug administration (MDA) campaigns, church and house-to-house case searches (Table 1). The strategy was chosen based on other activities taking place in the selected district. The research team visited different study sites according to a pre-established schedule that was communicated to health workers, village chiefs, and school directors before the appointed day.

# 158 **Case definition of other skin conditions**

159 In order to be considered a case of leprosy (Hansen's Disease), an individual must have one or

160 more of skin lesions that were hypopigmented or red and had definite loss of sensation.

161 Buruli ulcer case was based on clinical presentation consistent with a painless, non-healing

162 ulcer with undermined edges and a necrotic base, typically located on the limbs; a painless

163 nodule or plaque, typically located on the limbs; and oedema of a limb or other body part,

164 with or without overlying ulceration.

Scabies were defined as people with rash consisting of papules, vesicles, and burrows,typically located on the hands, feet, and folds of the skin.

167 An individual suffering from lymphatic filariasis presented lymphedema characterised by the 168 enlargement of body parts in the limbs and breasts; or hydrocele marked by swelling in the 169 scrotal sack.

170 Case of tungiasis was defined as participant with a painful, pruritic nodule with a central171 black dot, mainly located on the feet, toes, or fingers.

172 Superficial fungal infections were defined as affection on the body commonly with a red,

173 ring-shaped rash with a raised border for *Tinea corporis* (ringworm); scaly patches on the

scalp sometime with hair loss for *Tinea capitis* (scalp ringworm); light or dark patches on the

skin, most commonly on the chest and back for *Tinea versicolor* (pityriasis versicolor).

## 176 Data analyses

177 Study data were recorded using standardized data collection forms. We used basic descriptive 178 statistics to summarise the characteristics of the individuals who were screened, the number 179 who were diagnosed with each skin-NTD, and other skin conditions. Results are shown 180 stratified by country. Analyses were performed in Microsoft Excel 2013.

# 181 **Ethics approval**

182 This study was approved in Cameroon by the National Ethics Committee on Research for 183 Human Health (CNERSH) under decision N°2020/12/1327/CE/CNERSH/SP and 184 of the of N°D30administrative authorization Ministry Public Health 185 308/L/MINSANTE/SG/DROS), in Côte d'Ivoire by the Comité National d'Ethique des 186 Sciences de la Vie et de la Santé (IQR) through decision IQRG0075\_16/09/2020, in Ghana by 187 the Ghana Health Service of Ethical Review Committee (GHS-ERC) and Noguchi Memorial 188 Institute for Medical Research-Institutional Review Board (NMIMR-IRB) under decisions 189 GHS-ERC 005/12/20 and NMIMR-IRB CPS 019/20-21), and in United Kingdom through 190 London School of Hygiene and Tropical Medicine (LSHTM) under decision N° 21633 (19 191 August 2021).

#### 195 **RESULTS**

## 196 **Demographic characteristics**

197 Case searches were conducted in 12 districts in Cameroon, six in Cote d'Ivoire, and seven in 198 Ghana. A total of 61,080 individuals were screened, including 20,414 in Cameroon, 16,530 in 199 Côte d'Ivoire, and 24,136 in Ghana. The male to female ratio was approximately 1:1 in the 200 three countries (10804/9610, 8430/8100, and 13241/10895 respectively for Cameroon, Côte 201 d'Ivoire and Ghana), with more than 90% of participants aged up to 15 years old 202 (56471/61080).

#### 203 Skin lesions detected

Table 2 summarizes the skin diseases detected in Cameroon, Côte d'Ivoire, and Ghana. Skin
lesion accounted for 18.6% (11389 /61080) and included 20.6% (4204/20414) in Cameroon,
30.8% (5095/16530) in Côte d'Ivoire and 8.7% (2090/24136) in Ghana.

207 The most frequent skin conditions encountered in Cameroon were *Tinea capitis*, scabies and 208 vaws-like lesions. T. capitis accounted for 82.7% (3478/4204) of the skin conditions and was 209 detected mainly in the health districts of Bankim (44.6%, 1552/3478)) and Sangmélima 210 (16.7%, 580/3478)). Scabies was the second most common skin condition detected in 5.1% 211 (214/4204) cases of skin conditions seen. The majority of scabies cases were again detected in 212 Bankim and Sangmélima with 37.9% (81/214) and 23.8% (51/214) of scabies among the 213 detected skin lesions, respectively. Yaws-like lesions were the third most common skin 214 condition (5%, 210/4204) and were identified in high numbers in Sangmélima (23.3%, 215 49/210), Djoum (22.4%, 47/210) and Mbang (15.7%, 33/210). However, only 18 individuals 216 were serologically confirmed as yaws cases almost all among Baka population.

*Pityriasis versicolor*, scabies, and yaws-like lesions accounted for 99.8% (5084/5095) of skin
conditions detected in Côte d'Ivoire. *P. versicolor* was the most common skin condition
(50.4% (2567/5095)) across the six health districts visited. Scabies represented 25.2%
(1285/5095) of the conditions and yaws-like lesions were reported among 24.2% of
individuals presenting with a skin condition (1232/5095) and were serologically confirmed in
84 people.

In Ghana, yaws-like lesions accounted for 78.6% (1643/2090) of them, with serologically confirmed yaws among 440 individuals. Upper West Akim District and Asene Manso Akroso

- 225 recorded the highest number of yaws cases. Scabies and T. capitis accounted for 20%
- 226 (419/2090) and 1.3% (28/2090) of skin conditions, respectively.

#### 231 DISCUSSION

In accordance with the NTD road map 2021-2030 (4), skin-NTDs are targeted for eradication (yaws), elimination (leprosy, onchocerciasis, lymphatic filariasis) and control (other skin-NTDs), and an integrated approach is the backbone to achieving these targets. The main study was focused on yaws while adopting an integrated approach in the screening of individuals in the selected health districts.

This project improved case detection of skin conditions such as yaws, scabies, lymphatic filariasis, Buruli ulcer, leprosy, tungiasis and superficial fungal infections in the three countries. Yaws and scabies were the predominant skin-NTDs.

240 The frequency of detection of serologically confirmed yaws among suspected cases in 241 Cameroon, Côte d'Ivoire and Ghana was 8.6%, 6.8% and 26.8% respectively. These data 242 show that yaws is more prevalent in endemic health districts in Ghana compared to Cameroon 243 and Côte d'Ivoire, which is consistent with routine reporting data in Ghana with frequencies 244 above 15% among suspected cases of yaws (34, 42, 43). Ghana has the second highest 245 population density in West Africa and this can make it more difficult to control the spread of 246 yaws. For instance, many MDA campaigns have been performed previously but the incidence 247 of yaws is still high in many parts of the country (42, 44, 45). The data obtained in Cameroon 248 overlap with previous findings, with less than 10% of yaws over suspected cases (46, 47) but 249 lower to what has been reported during an outbreak (8). The decrease of yaws cases in 250 Cameroon is linked to the surveillance impact by identifying and treating cases, and MDA 251 implementation in the Congo Basin in December 2020 before the current study was 252 conducted (48). The results of Côte d'Ivoire show that yaws remains prevalent in the study 253 sites (1.6%; 81/5095) compared to findings in the Divo health district between 2016 and 2017 254 that identified 8 cases of yaws out of 1,302 individuals with skin conditions (10). Côte 255 d'Ivoire is one of the countries in Africa that has been most affected by skin-NTDs, including 256 yaws (49, 50). The government of Côte d'Ivoire has implemented a number of programmes to 257 address these diseases. Areas of co-endemicity of skin-NTDs have undergone several 258 investigations with treatment which have certainly reduced the incidence of yaws (10). The 259 results of this study suggest that additional efforts are needed to control yaws in the three 260 countries where the disease is endemic, in particular the number of rounds of MDA which can 261 be reviewed to significantly reduce the incidence of the disease (51). More than 80% of yaws 262 like ulcers were not yaws (542/3085), suggesting that proper identification and management 263 of other cutaneous ulcers, such as *H. ducreyi*, is important to improve patient outcomes.

264 Scabies was the most common skin-NTD detected among participants with skin conditions. 265 The frequency was 25.2% in Côte d'Ivoire, 19.8% in Ghana and 5.1% in Cameroon. These 266 data are high compared to previous studies in the three countries where proportions of scabies 267 in people with skin lesions ranged almost from 3 to 9% during active case search. Difference 268 may be due to a number of factors, including the duration of the screening, the context of the 269 study and the methods used to detect scabies. The field activities of the current study were 270 carried out over almost three years unlike the previous ones whose duration was over a few 271 months. Earlier data from the three countries highlight the variability in the proportions of 272 scabies depending on the context and methods to detect in hospital, prison, boarding school or 273 even during active research in the community and in schools. Thus, data from several regions 274 in Côte d'Ivoire show the proportions of scabies during active case searches among people 275 suffering from skin diseases varied between 3.7% and 8.6% (10, 49, 52). In Ghana, recent 276 findings from 2019 show that the proportions of scabies are between 6 to 12% among patients 277 suffering from skin infections reported to urban and rural study health facilities (30, 53), and 278 prevalences of 11.2% to 71% during outbreaks (54, 55). In Cameroon, surveys in urban areas 279 in boarding schools show the prevalence of scabies of nearly 18% (56), 32% in prison (57), 280 and a proportion of 2.8% during active case search in rural areas among respondents with skin 281 disease (28). These data suggest that scabies is a major public health problem in all three 282 countries.

283 Other skin-NTDs such as leprosy, Buruli ulcer, lymphatic filariasis and tungiasis were less 284 common. Leprosy cases were not found in Ghana while in Cameroon and Côte d'Ivoire, 285 leprosy cases varied between 2 and 15 throughout the study period. Available data show that 286 some districts in Cameroon and Côte d'Ivoire are still of high endemicity (17, 31, 52). No 287 case from Ghana could be due to the significant progress in controlling leprosy or targeted 288 study sites. Buruli ulcer and lymphatic filariasis case numbers followed the same trend as 289 leprosy in Cameroon and Côte d'Ivoire, and tungiasis was only recorded in Cameroon. Buruli 290 ulcer and lymphatic filariasis are known to be endemic in Cameroon, Côte d'Ivoire and Ghana 291 (11-13, 19-21) suggesting that the diseases may have similar risk factors, and that tungiasis 292 may be more common in Cameroon due to specific environmental factors.

The study also found that superficial fungal infections were the most common form of skin disease in two of the three countries. In Cameroon, these conditions accounted for almost 90% with the majority due to *Tinea capitis* while *Pityriasis versicolor* constituted the bulk of these infections in Côte d'Ivoire (50.4%). The findings are concordant with field data in

297 Cameroon, Côte d'Ivoire and Togo highlighting fungal infections as the main skin conditions 298 (10, 28, 31, 58). In previous investigation, proportion of Pityriasis versicolor and Tinea 299 *capitis* among diagnosed skin diseases in Côte d'Ivoire was approximately 45% of each (31); 300 while in Cameroon proportion of *Pityriasis versicolor* in a rural setting was around 21% (28). 301 In Ghana, superficial fungal infections were likely to be less common. Previous data indicated 302 that fungal infections accounted for between 20 and 30% of patients with skin diseases (59, 303 60). In this study, superficial fungal infections were not automatically recorded in Ghana, 304 thus, only *Tinea capitis* was detected in 1.3% of individuals. In previous studies in Ghana, 305 *Tinea capitis* was one of the main fungal agents with proportions above 20% (59).

306 We found that the proportion of people with skin lesions was not the same from one country 307 to another and according to the diseases. This is likely due to a variety of factors, such as 308 ecological zones (climate, vegetation and culture), population density and standard of life. 309 However, early diagnosis and treatment are important to prevent the spread and to reduce the 310 risk of complications. Reducing the burden of skin conditions may require improved access to clean water and sanitation facilities, education of people about the diseases and their 311 312 prevention measures, availability and affordability of treatment, and reinforcement of public 313 health measures to control the spread of diseases such as mass drug administration 314 programmes.

315 All data were recorded at the health district level and subsequently transmitted to the 316 respective NTD programmes. Through these data, we can see the diversity that can exist in 317 terms of the burden of different diseases in the communities studied, hence the importance of 318 pooling efforts to overcome NTDs. The studies that have been conducted in Côte d'Ivoire 319 (10, 31), Benin (61) and Burkina Faso(62), are examples of integrated approaches to NTD 320 control, elimination and eradication. These studies have shown that integrated approaches can 321 be effective in reducing the prevalence of NTDs and improving the health of people in these 322 countries. Moreover, since many skin-NTDs are zoonotic or have a (possible) non-human 323 reservoir, a One Health guided approach should be used to handle integrated case search 324 activities (63). Synergies between skin-NTD programs and, for example, neglected zoonotic 325 disease programs (such as rabies elimination) could optimize the use of resources (logistics) 326 and stimulate cross-sectoral collaboration that is key for the sustainable control of NTDs.

This study has some limitations. The skin-NTDs reported apart from yaws were only suspected cases because the diagnoses were made based on clinical examinations. Unfortunately, the additional diagnostic tools required for confirmation of the clinical

diagnosis were not available for this investigation. However, the data collected are still useful for guiding where skin-NTD eradication, elimination or control work should be directed in the future, i.e., data collection, training, diagnostics and the needs for medical care in these remote areas. We also acknowledge that the field visits were focused on areas where suspected yaws cases were reported which constitutes a bias for the estimation of other skin-NTDs.

This study highlights how the use of existing disease-specific resources can be maximized to determine the burden of other NTDs. Integration, technical and scientific progress are all pillars of the road map to end the suffering caused by NTDs by 2030.

#### 339 CONCLUSION

340 We demonstrate improved data reporting of skin-NTDs when an integrated approach is used. 341 This study contributes to the strengthening of the yaws surveillance system into a guided 342 integrated system that is being put in place throughout each country. The detection of yaws 343 cases in areas that have undergone MDA is remarkable and highlights the importance of 344 rigorous active surveillance ideally with test confirmation of clinically suspected cases and 345 optimal coverage of MDA campaigns. The main challenges remain the difficulty of accessing 346 some communities where yaws is endemic, the follow-up of patients, and the inter-347 community movements which are sources of reinfection, and resources to manage the affected 348 populations.
