Associations between Social Contact, Sleep and Dietary Patterns Among Children: A Cross-Sectional Study

Abstract: Social isolation in adults can be associated with altered sleep and eating behavior. This 8 study aimed to investigate the interactions between the extent of social contact, eating behavior and 9 sleep in infants and preschool children. In an observational study, 439 caregivers of 562 children 10 aged 0-6 years provided information on sleep (i.e., duration, latency, bedtimes and nighttime 11 awakenings), eating behaviors (i.e., meal size, consumption of sweet snacks, salty snacks, fruits and 12 vegetables) and social contact (i.e., quarantine status, household size, social activities) during the 13 Covid-19 pandemic (April 2020). In infants (0-3 years), the change in meal size and consumption of 14 snacks, fruits, and vegetables did not significantly relate to the extent of social contact. For preschool 15 children (3-6 years), a trend was observed, suggesting that quarantine status was associated with 16 increased meal size. Changes in sleep duration, sleep latency, bedtimes and nighttime awakenings 17 from before to during the pandemic were not significantly linked to the 3 variables quantifying 18 social contact in both age groups. The study highlights that, contrary to expectations, the extent of 19 social contact has negligible associations with infants' and preschool children's sleep and eating 20 behaviors. These findings indicate that other factors beyond social isolation play a role in shaping 21 children's eating habits and sleep patterns. 22

1. Introduction

Social relationships are fundamental to well-being, mental and physiological health 28 in adults (Cacioppo et al. 2002; Holt-Lunstad et al. 2015) and adolescents (Qualter et al. 29 2013). Reported associations between social relationships and physical health mainly 30 focus on two constructs: social support and social integration. Social support represents 31 the psychological and material resources provided by the social network to help cope with 32 stress, while social integration represents the participation in social relationships (Cohen 33 2004). More generally, frequency and duration of social interactions have been linked with 34 physical and mental health through changes in health-related behaviors, such as diet, 35 exercise, or smoking (Berkman et al. 2000). 36

Social isolation in adults generates higher risk for depressive symptomology 38 (Cacioppo, Hawkley, and Thisted 2010), mortality (Holt-Lunstad et al. 2015) and reduced 39 sleep quality (Azizi-Zeinalhajlou et al. 2022; Cacioppo et al. 2002). One relevant factor 40 intertwined with these observations may lie in altered eating behavior, based on 41 indications that social isolation can be associated with eating disorders and binge eating 42 (Mason et al. 2016; Wright and Pritchard 2009). The effect of social isolation on sleep and 43

eating behavior has been experimentally examined in Drosophila, demonstrating that 44 separating adult flies from the group led to increased food consumption and shorter sleep 45 (Li et al. 2021). 46

The COVID-19 pandemic created a unique quasi-experimental framework to 48 investigate the effects of enforced confinement on a global scale, downsizing direct social 49 contact within populations. In this framework, social isolation significantly impacted 50 mental health of children and parents (Ehrler et al. 2022). In addition, children and 51 adolescents consumed more snacks and processed foods during the pandemic, leading to 52 weight gain (González-Monroy et al. 2021; Pujia et al. 2021). Children and adolescents also 53 experienced shortening of sleep (Markovic et al. 2021; Teixeira et al. 2021). Yet 54 controversial results remain, for example as part of the COVID-19 pandemic, an increase 55 in fruit and vegetable consumption was reported in Italian children ages 5 to 14 years 56 (Pujia et al. 2021). The pandemic-induced reduction of social contacts could explain the 57 changes in eating and sleeping behavior towards more "unhealthy" patterns, which aligns 58 with findings from observational studies on social isolation. Indeed, the contrasting 59 findings might be explained through differences in effective social isolation determined 60 by the household structure, family size, extent of isolation orders by country, or 61 geography (urban vs. rural regions). Thus, quantifying individual levels of social contact 62 might contribute to a more precise understanding of the interactions among social contact, 63 eating and sleep behaviors in children. Moreover, these interactions have not yet been 64 examined in preschool-age children, who might respond differently to changes in social 65 contacts due to their reliance on interactions with caregivers rather school-age children. 66

In this investigation, we thus tested the hypothesis that infants and preschool 67 children who experienced increased social isolation (i.e., being in quarantine, engaging in 68 activities alone rather than together with other family members and small household size) 69 have worsened sleep quality (shorter sleep duration, increased night awakenings, longer 70 sleep latency), and more "unhealthy" eating patterns (increased meal size, decreased 71 consumption of fruits and vegetables, and increased consumption of sweet and salty 72 snacks). 73

2. Materials and Methods

2.1 Study Design

During the start of the COVID-19 pandemic from April to July 2020, caregivers of 76 children below 6 years were invited to participate in a study about children's sleeping 77 behavior. Recruitment was realized through large-scale distribution of digital flyers and 78 a video invitation, distributed on social media platforms, childcare institutions, medical 79 practices, and personal channels. 439 primary caregivers (423 females, 96.35%, age 38.28 ± 80 4.74 years, mean ± SD) completed an online survey (SoSci Survey; Leiner, 2021) with 81 questions about their children's demographic variables, sleeping behavior, eating 82 behavior and social isolation. The survey was compiled in English, and then translated to 83 Italian, Spanish, French, and German by the authors, which was then checked by at least 84 two native speakers. For families with multiple children, questions were looped to assess 85 data for each child individually. We collected a total dataset of 309 (146 females, 47.25%) 86 infants and toddlers (between 0 and 35 months old), and 253 (127 females, 50.2%) 87 preschool children (age 36 to 72 months). The institutional ethics board of the University 88 of Fribourg, Switzerland, approved the study, and parents gave informed consent before 89 completing the survey. 90

2.1 Sleep Behavior change

According to age, children's sleep was either assessed with the Brief Infant Sleep 95 Questionnaire (BISQ; 0-35 mo) (Sadeh, 2004) or with the Children's Sleep Habits 96 Questionnaire (CSHQ; 36-72 mo) (Owens et al., 2000). Caregivers reported on the child's 97 sleep behavior before (retrospectively) and during the confinement. The change in four 98 aspects of sleep behavior was analyzed by means of a difference during-before the 99 lockdown: sleep duration, sleep latency, bedtimes and nighttime awakenings (as in 100 Markovic et al., 2021). For the infant group (0-36 months), parents reported infants' sleep 101 duration for nighttime and daytime sleep, which were summed for the total sleep time (in 102 minutes), number of nighttime awakenings, sleep latency (in minutes), and bedtimes (in 103 minutes). In the preschool group (36-72 months), sleep duration was quantified from the 104 item "My child sleeps about the same duration each 24-h-day (nighttime sleep and naps 105 *combined*)", sleep latency from the item "My child falls asleep within 20 min after going to bed", 106 nighttime awakenings from "How often does your child wake up during the night" and 107 bedtime from "My child goes to bed at the same time at night". Each item for preschool 108 children was captured with ratings from 1 to 5, such that 1 referred to never (being the 109 case, i.e., at 0 days/week), 2 to rarely (1 day/week), 3 to sometimes (2-4 days/week), 4 to 110 usually (5-6 days/week) and 5 to always (7 days/week) being the case. 111

2.2 Social contact

With three variables we captured the individual extent of social contact during the 114 confinement: First, quarantine status indicating whether the caregiver was in quarantine 115 at the time of survey completion. Second, household size indicating the number of people 116 living in the household. And third, social activities where parents reported the duration 117 their child engaged in several activities (e.g., watching television or playing), and whether 118 the child was doing these activities alone or with someone else (parents, siblings or 119 friends, for details see Appendix). The percentage of activity spent engaged with the 120 parents compared to alone was computed. For example, a child who spent half of the time 121 engaging in activities with someone else would be attributed a 50% participation rate in 122 social activities. 123

2.3 Eating behavior change

We assessed the change in meal size from before the confinement to during the 126 confinement with a 5-point Likert scale capturing whether the child's overall meal size 127 was "much smaller", "a bit smaller", "same as before", "a bit larger" or "much larger". 128 Moreover, parents rated the child's change in the consumption of salty and sweet snacks 129 (between main meals), and the consumption of fruits and vegetables by means of "much less", "a bit less", "the same amount", "a bit more" or "much more". 131

2.4 Statistical Analysis

Statistical analyses were performed in R version 4.0.5 with packages dplyr (Wickham 134 et al. 2021), and figures were created by using ggplot2 (Wickham 2016). Due to a small 135 number of responses for meal-sizes "much smaller" (n = 3 for the infant group, n = 4 for 136 preschool children) and "much larger" (n = 6 for infants, n = 4 for preschool children), the 137 scales were consolidated into three response groups "decreased", "no change", 138 "increased". Accordingly, the consumption of salty and sweet snacks, fruits and 139 vegetables were composed into a 3-point scale ("decreased", "no change", "increased"). 140 In each model employed, the number of participants was adjusted for the exclusion of 141 missing data. To examine the relationship between the extent of social contact and sleep 142 behavior, we separately computed generalized linear models for the two age groups, with 143

sleep duration, sleep latency, bedtimes and nighttime awakenings as the outcome and the 144 extent of social contact (quarantine status, household size, social activities) as the 145 predictor. For both age groups, the association between the extent of social contact and 146 eating was tested with change in meal size, snacks, fruits and vegetables as outcome and 147 social contact as predictor. Age and sex were included as control factors, and parental 148 stress was included as a covariate in alignment with previous work demonstrating an 149 association with children's sleep (Markovic et al. 2021). Change in parental stress was 150 captured with ratings from 1 to 5 with the question "Did your behavior change across the time 151 that passed since the lockdown, such that your level of stress: 1 decreased a lot, 2 decreased a little, 152 3 did not change, 4 increased a little, or 5 increased a lot." Alpha level was set to p < 0.05 and 153 p-values were corrected for multiple testing using the false discovery rate method 154 (Benjamini and Hochberg 1995). 155

3. Results

3.1 Study population

Demographic variables revealed that household size and percentage of quarantined families were similar in the age groups (Table 1). Percentage of shared activities was by 10.62% larger in the infant group compared to the preschool children. The control variable change in parental stress was comparable between groups.

3.2 Sleep behavior

Before the lockdown, sleep duration ranged from 570 to 1020 minutes for infants, 167 during the lockdown it ranged between 510 and 990. Sleep latency before the lockdown 168 was between 0 and 60 minutes, during the lockdown it was between 0 and 90 minutes. 169 Before lockdown, bedtime was between 6 and 11pm, it ranged from 6:30pm to 11:30pm 170 during the lockdown. Infants used to be awakened between 0 and 45 minutes during the 171 night before the lockdown, which was then comprised between 0 and 60 minutes during 172 the lockdown. Regular sleeping times on 5-6 days a week were reported for 59.11% of 173 preschool children before the lockdown and 51.82% of preschool children after the 174 lockdown. The number of times they fell asleep in less than 20 minutes 5-6 days a week 175 was 46.56% before lockdown and went down to 39.68%. Before the lockdown, for most 176 preschoolers, bedtimes were regular 5-6 days a week 66.40%, which decreased to 52.63% 177 during the lockdown. For 7.69% they woke up during the night once a week before the 178 lockdown and 9.31% during the lockdown. 179

Next, the change in sleep from before to during the pandemic was computed. This 180 revealed that more infants experienced a decrease in sleep duration (21.05% increase, 181 30.89% decrease), a prolongation of sleep latency (34.79% longer, 11.52% shorter), later 182 bedtimes (51.14% later, 13.01% earlier), and more night awakenings (19.86% increase, 183 13.47% decrease). For preschool children, the shift was in the same direction with less 184 regular sleep duration (6.73% more regular, 17.17% less regular), a more frequent long 185 sleep latency (27.95% more frequent, 8.08% less frequent), more irregular bedtimes 186 (33.67% less regular, 6.39% more regular), and more frequent night awakenings (16.16% 187 more frequent, 8.75% less frequent, Table 2). 188

The eating behavior overall remained similar for the majority, ranging from 56.97% 197 to 73.88% across all categories in infants and preschool children (Table 3). In the 198 remainder, meal size increased in 14.89-17% and decreased in 11.34-16.18% of infants and 199 preschool children. 200

The consumption of Salty snacks increased in 8.58-10.33% and decreased in 17.54-201 19.42% of children. 202

For Sweet snacks, an increase was observed in 5.74-5.97% and a decrease in 26.87-203 37.3% for both age groups. Children increased their consumption of Fruits in 14.08-15.38%204

of cases, while 19.43-25.27% decreased it. Vegetables eating increased in 14.08-14.17% of children and decreased in 12.27-12.96%. 206

3.4 Social isolation and eating behavior

We then examined whether the extent of social contact related to eating behavior in 209 both age groups. Overall, neither the change in meal size, nor snacks, fruits and vegetables 210

were related to the infants' extent of social contacts (Table 4, all p>0.05). In preschool 211 children, a trend was observed in the association between change in meal size and social 212 contact through quarantine status (p=0.07). In other words, this would indicate that 213 preschool children in quarantine were more likely to increase their meal size, compared 214 to non-quarantined preschool children (Figure 1). The other measures of social contact 215 were neither related to meal size nor to type of consumed food (Table 5, all p>0.05). 216

The control variables included in our model (age, sex and parental stress) were not 217 related to the children's eating behavior, with the exception that older children decreased 218 meal size to a larger extent from before to during the pandemic (b = -0.217, p < 0.001), and 219 ate more vegetables (b = 0.214, p < 0.001). 220

3.5 Social isolation and sleep behavior

We then examined whether the extent of social contact was related to children's sleep 237 behavior. Neither in infants nor in preschool children was the extent of social contact 238 associated with sleep variables (i.e., duration, sleep latency, bedtimes nor with the number 239 of nighttime awakenings; Table 6, all p>0.05). Change in sleep behavior was not related to 240 age, sex and parental stress, except for a link between parental stress and sleep latency in 241 preschool children, such that increased stress related to longer sleep latency (b = 0.130, p 242 = 0.043). 243

Overall, the results indicate only a negligible relationship between the extent of social contact with eating behavior in infant and preschool children during the COVID-19 250 pandemic. This was indicated by a trend suggesting that being in quarantine related to 251 increased meal size in preschoolers.

4. Discussion

Social isolation in adults can be related to poor sleep (Azizi-Zeinalhajlou et al. 2022; 255 Cacioppo et al. 2002), and altered eating behavior (Mason et al. 2016; Wright and Pritchard 2009). Yet, the interplay between those three factors remains to be elucidated in early 257 childhood, which was evaluated with this observational study during the COVID-19 258 confinement. Specifically, parents of 309 infants and 253 preschool children provided 259 information before and during the confinement, rating their children's social contacts, 260 eating behavior and sleep. Overall, our results indicate that children's social contact is not 261 strongly associated with sleeping behavior, nor with eating behavior, with the exception 262 for a trend such that quarantined preschool children tended to have increased meal size 263 compared to non-quarantined ones. The nuanced findings emphasize the need to better 264 understand which aspect of social isolation is impactful on children's health through 265 changes in their sleeping and eating behavior. 266

Contrary to our hypotheses, meal size, as well as the consumption of snacks, fruits 268 and vegetables, was not related to the extent of social contact, suggesting that factors 269 beyond social isolation play a role in dynamics of eating behavior in infants and 270 preschoolers. We observed that preschoolers being in quarantine had a heightened chance 271 of increasing meal size in relation to the confinement, yet this association remained as a 272

trend after adjusting for multiple comparisons. This relationship is concordant with 273 findings demonstrating increased subjective isolation in obese adolescents (Mason, 2020). 274 Interestingly, our observation prevailed only in preschool children, yet not in infants, 275 which could point to age-specific differences in need for social contact. Increased meal 276 size and more unhealthy eating behaviors during the pandemic have been reported in 277 children 6 years and older, suggesting that the effect of social isolation may be dependent 278 on age (González-Monroy et al. 2021; Pujia et al. 2021). Age effects could also be attributed 279 to the extent of contacts with people outside of the immediate household. For infants, the 280 main social contacts are their primary caregiver(s), while preschool children are more 281 likely to have extended contacts with other adults. Thus, as the change in social contact 282 with primary caregiver(s) during the pandemic did not change, infants' changes were 283 probably less extreme. Further, we lacked information on other aspects of eating behavior 284 such as the timing of meals which could also be affected by the pandemic and is related 285 to sleeping behavior (Mühlematter et al. 2023). Moreover, eating behavior is the primary 286 factor determining the composition of the gut microbiota, and interestingly animal 287 research observed associations between social isolation, the gut microbiota and the brain 288 (Dunphy-Doherty et al. 2018; Lopizzo et al. 2021). Thus, the gut microbiota could be an 289 interesting candidate in future research on the interplay between social isolation, sleeping 290 and eating behavior. Our results show that only quarantine could have an effect on eating 291 behavior, and only in children aged 3 to 6 years old. 292

In line with previous studies (Markovic et al., 2021), sleep behavior shifted towards 294 a decreased sleep quality (i.e., shorter sleep duration, longer sleep latency, more nighttime 295 awakenings). Similar to eating, children's changes in sleep variables were not strongly 296 linked to the degree of their social contacts. Interestingly, this contrast with findings in 297 adults. Effects of adults' social isolation on sleep quality are well-documented, showing, 298 for example that subjective loneliness often accompanies subjective poor sleep quality 299 (Bhatti and Haq 2017; Cacioppo et al. 2002; McLay et al. 2021). Thus, the difference to 300 children's sleep might be attributable to other factors, such as parents engagement in 301 mindfulness techniques or the presence of pets, as previously demonstrated (Markovic et 302 al. 2021). Another possibility is that children's interactions with their parents sufficiently 303 safeguarded them from potential negative effects of reduced social contact on their sleep. 304 Moreover, our study used objective ratings of social contact, whereas studies involving 305 adults relied on individual perceptions of isolation (Cacioppo et al. 2002; Cacioppo, 306 Hawkley, and Thisted 2010). Thus, the adverse outcomes of social isolation might be 307 subjectively biased in adults, making results not directly comparable. To summarize our 308 findings, sleep behavior change during the pandemic was not dependent on externally 309 reported measures of social contact. 310

Age, sex, and parental stress had a small impact on children's both eating behavior 312 and sleep in our dataset. Higher parental stress marginally increased the chance of 313 increased meal size in the preschool group. Thus, parental stress, depending on the age 314 group, remains an important factor to consider in the framework of children's eating 315 behavior. In alignment with this, stress exposure in adults can increase food intake, with 316 specifically increasing the preference for high-fat, high-sugar foods (Tomiyama 2019). 317 Future investigations to elucidate the impact of stress on young children's eating 318 behaviors could inform strategies for mitigation. 319

In conclusion, this study sheds light on the association of social isolation with 321 sleeping and eating behavior in children up to 6 years old. We report that, in contrast to 322 findings in adolescents and adults, social contact beyond the family household is only 323 negligibly associated with young children's sleep and eating behavior. Thus, more 324 research is needed to gain a deeper understanding of the maturational transition and the 325 relationships between social contact, sleep patterns and eating behavior. This is a 326

significant concern, particularly in light of the rising rates of obesity (Pan, Wang, and Pan 2021) and sleep problems in children observed in recent decades (Chen et al. 2021). While these issues have complex causes, social isolation might potentially contribute to them, making it a worthwhile focus for addressing mental, metabolic and chronobiological health. 31
