16 Abstract

17 Antimicrobial resistance (AMR) research is increasing globally, but its extent in Singapore is unclear. 18 The aim of this study was to review the current research trends on AMR in Singapore and identify the 19 types of research conducted. Scientific literature on AMR from Singapore published between 2009 20 and 2019 were retrieved from databases using a search string that included search terms that would 21 encompass the range of terminologies related to "antimicrobial resistance" and "Singapore". A total 22 of 741 AMR research and review articles published between 2009 and 2019 were identified, which 23 described research led by researchers from Singapore, that involved researchers from Singapore in 24 overseas collaborations, or involved samples or data from Singapore. Articles were assigned to the 25 most appropriate research domain and relevant sector(s) (animal, environment, food or human). 26 Although an upward trend in the number of AMR research articles published was observed, articles 27 that described research on AMR knowledge, awareness, socioeconomic impacts and transmission 28 remained scarce. Furthermore, the higher proportion of research articles from the human sector 29 highlighted that more research from the non-human sectors was needed, which coincidentally began 30 to gradually increase in the last five years. By reviewing the types of studies that were conducted in 31 each domain, broad areas where research gaps exist could be identified, as well as currently 32 unexplored topics. With increasing complexity of the AMR problem and its impacts on multiple 33 sectors, having a comprehensive overview of the evidence gaps is paramount to the development of 34 a relevant One Health research agenda in AMR.

38 Introduction

Antimicrobial resistance is a natural phenomenon, occurring as microorganisms evolve and compete for survival in their ecological niche [1]. However, the discovery of antimicrobials used in the treatment of infections, particularly antibiotics, has increased selection and accelerated the rate at which microorganisms acquire resistance [2]. Despite revolutionising human healthcare management worldwide, its misuse has led to the current global antimicrobial resistance (AMR) situation [3]. Reviews in the last decade provided alarming projections on the estimated healthcare costs and impact on global health [4, 5].

47 Microorganisms acquire resistance to antimicrobials through different mechanisms, including 48 mutations, to gain survival advantage in the presence of antimicrobials. These mechanisms are quick 49 to appear when antimicrobials are used [6], and cause a continuous feedback loop that leads to higher 50 usage of antimicrobials to treat infections caused by increasingly resistant microorganisms. Research 51 and development for new antimicrobials are needed when the existing ones are no longer effective.

Research has also gradually shifted towards identifying other non-biological factors that contribute towards the development of resistance. For example, the use of antimicrobials in livestock and agriculture for disease prevention and growth promotion purposes contributes to the increasing burden of AMR. Furthermore, antimicrobials are also used in companion animals, and the interaction between humans and companion animals can facilitate the spread of AMR microorganisms [7]. Therefore, multidisciplinary research that adopts a One Health approach [8] is needed to uncover the increasingly complex nature of AMR.

Scientific literature on AMR had been reviewed by others for specific microorganisms [9] or in specific sectors [10, 11] to study the global AMR research trends to guide future research directions for the global research community. For Singapore, such a review could help with understanding and

- 64 proposing research needed at the local level to address AMR in the country, as well as to guide funding
- allocation in addition to charting future research direction at the national level. Therefore, we studied
- the scientific literature on AMR that had been published from Singapore between 2009 and 2019, with
- 67 the aim of understanding the types of research performed to address AMR in Singapore, areas where
- 68 research gaps still exist, and the local AMR research community. Articles that reported antimicrobial
- 69 use (AMU) were also included as AMR and AMU are closely related.

71 Methods

72 Identification of Research Articles

To review the scientific literature on AMR in Singapore, we used the search string in Supplementary Information SI1 to retrieve peer-reviewed articles published on AMR between 2009 and 2019 from the following major bibliographic databases, without restrictions on language or study design to maximise search results: Global Health (Ovid), Scopus, Embase (Ovid), MEDLINE (Ovid), CINAHL (EBSCO), PubMed and Web of Science. We also manually checked the reference lists of included studies for potentially relevant articles.

80 Study Selection

The search results from different databases were combined in a single EndNote library to remove duplicated records. A preliminary screen of all titles and abstracts was performed. Full texts of articles were then retrieved and read in full by SP and DMG, and included based on the eligibility criteria described below.

86 Eligibility Criteria

87 Articles were included only when the main scope of research or review was on addressing AMR. 88 Additional criteria included, but were not limited to, identifying methods to reduce or prevent the 89 occurrence, prevalence or incidence of AMR; treating infections due to AMR microorganisms or 90 developing methods to remove or improve removal of antimicrobials; and understanding the levels of 91 antimicrobial use/AMR and its impact. We defined articles as being from Singapore (SGR) when it was 92 published by authors from Singapore, identified by their institutions. Articles were defined as research 93 collaborations when authors from Singapore were part of a study led by a research team from an 94 overseas institution (SGO). Articles that used AMR samples or data collected from Singapore were also 95 included (SGS).

We excluded studies that were pre-prints or e-published outside of the stipulated time frame;
editorials, conference abstracts or proceedings, opinion pieces and guidelines; research that was not
conducted in Singapore or by researchers from Singapore; as well as studies that did not have AMR as

- 99 its main focus.
- 100
- 101 Data Extraction, Analyses and Article Classification

102 Each article was reviewed manually to extract the study aim and outcomes, publication year, journal 103 title, lead institution(s), microorganisms studied (to the genus level), and recorded in a standard form. 104 Institutional information was determined by first and corresponding authors' affiliations, as we 105 hypothesised that they played a larger role in the conceptualisation of the article's research focus [9], 106 and used to determine whether the articles published should be categorised as SGR, SGO or SGS. 107 Articles were read in full and assigned to the appropriate sector(s) (animal, environment, food or 108 human) and one of nine research domains. The research domains were identified via a consultation 109 with stakeholders in the field of AMR in Singapore (Table 1). When an article spanned multiple 110 research domains, it was assigned by consensus to the most relevant single domain.

112 **Results**

113 Search results

Of 8700 articles from our initial search, we identified 717 eligible articles (Figure 1). Another 24 articles
were identified through a manual search of references. In total, 741 articles were found to be relevant.

116 Of these, 551 were SGR articles, 62 were SGS articles, and the remaining 128 were SGO articles

- **119** Trend of AMR research published from Singapore, 2009-2019

120 The number of SGR articles increased from 17 in 2009 to 73 in 2019, representing a threefold increase 121 (Figure 2A). Most of the articles were from the human sector (N=490, 89%), followed by the 122 environment (N=27, 5%) and food (N=10, 2%) sectors. Most of the research that covered more than 123 one sector were from the human-environment sectors (N=14, 3%) (Figure 2B(i)). The annual trend of 124 articles published from each sector also showed an increase between 2009 and 2019, with research 125 articles from the environment and food sectors showing a prominent increase from 2017 (Figure 2Bii). 126 Research on AMR from Singapore could be distributed to nine domains (Figure 2C(i)). The annual trend 127 of research published from most domains was relatively consistent, except for the three domains with 128 the lowest number of articles published: Knowledge, Attitudes, Practices, Social and Economic Impacts 129 and Transmission (Figure 2Cii). Majority of the AMR research in Singapore was conducted by the 130 institutes of higher learning (universities and polytechnics, N=245) and public healthcare institutions 131 (N=260) (Supplementary Table ST3).

Most of the articles identified studied AMR in bacteria, both in terms of phenotypic and genotypic characterisation; AMR in gram-negative bacteria was studied more than in gram-positive bacteria (total 608 versus 307). In comparison, AMR in fungi, parasites or viruses was not studied as much but the frequency remained relatively consistent between 2009 and 2019 (Figure 2D). There was also active research conducted to identify or develop novel agents against AMR bacteria listed on the

138 World Health Organization's (WHO) priority pathogens list for therapeutics development [15] (Table

139 2).

141 The types of studies in each domain were diverse, highlighting that understanding AMR required a 142 multidisciplinary approach. Through reviewing the outcomes of AMR research from each domain that 143 were already conducted, existing gaps were identified that could be potential areas for future research 144 (Table 3 and Supplementary Information SI2).

146 Overseas research collaborations on AMR to further our understanding, 2009-2019

In parallel with the increasing number of AMR research and review articles from Singapore, there was
an increasing trend in the number of overseas research collaborations in AMR. No specific trend was
observed until 2014, when it began to show an increase (Figure 3, *"International collaborations"*).
Most of the articles published were from the human sector (N=109, 85%), followed by environment
(N=10, 7.8%) and food (N=2, 1.6%). There were six research articles that spanned multiple sectors
(4.7%).

153 The countries where the researchers had most collaborations with were Australia (N=24), followed by 154 the United States (N=21) and the United Kingdom (N=14) (Figure 4A), with most research conducted 155 on Therapeutics and Diagnostics (Supplementary Table 2). Within Asia, researchers from Singapore 156 collaborated most with those from China (N=12), with the majority of the research conducted on 157 Surveillance. Overall, the distribution of collaborative AMR research domains was similar to that of 158 AMR research from Singapore, i.e. Therapeutics had the highest number of research articles, while 159 Knowledge, Attitudes, Practices and Social and Economic Impact had the lowest number of research 160 articles published (Figure 4B).

162 AMR research that included samples from Singapore, 2009-2019

163	As part of ongoing multinational efforts to address AMR, researchers in Singapore participated in
164	regional and global studies by contributing samples or data, or was a study site (Figure 3, "Sample
165	contribution"). Of the 62 studies, 57 (92%) were from the human sector and four (7%) from the
166	environment sector. One study was conducted across the human and animal sectors. These studies
167	were assigned to the following research domains: Surveillance (N=39, 63%), Public
168	Health/Epidemiology (N=16, 26%), Therapeutics (N=2, 3%), Diagnostics (N=2, 3%), Transmission (N=2,
169	3%) and Microbiology (N=1, 2%) (Supplementary Table 2). A description of the types of studies are
170	listed in the Supplementary Table ST4.

171 **Discussion**

172 The main objective of this article was to understand the AMR research conducted in Singapore in order 173 to identify research gaps to guide future research. In addition, we also identified AMR research 174 conducted internationally where Singapore collaborated in or contributed samples. Our data echoed 175 other reviews of AMR research conducted in the wildlife [10], the food-producing animals [11], or the 176 global AMR research [9], where an increasing trend was observed over time despite selecting different 177 time periods for the review. For Singapore in particular, the launch of the National Strategic Action 178 Plan (NSAP) on AMR in 2017 [16] coincided with a larger annual increase in the number of AMR 179 research articles published. Furthermore, the quick succession of articles published on AMR research 180 trends also indicated an interest to identify where research gaps exist to fill the gaps in our 181 understanding.

182

183 However, unlike both reviews by Torres et al. [10, 11], our review did not limit the studies to a specific 184 sector, or retrieve articles from a single database, as Luz et al. did [9]. The lack of such restrictions was 185 to reduce as much bias as possible during the article retrieval stage, so that articles from all sectors or 186 research fields could be retrieved as long as AMR was the main focus. By removing this bias, we could 187 identify articles from all sectors, which highlighted the higher volume of articles from the human 188 sector, in comparison to the non-human sectors. A quick comparison of research from single sectors 189 alone showed that the combined number of articles from the animal, environment and food sectors 190 was only 7.8% of the number of articles from the human sector. However, despite the small number, 191 a gradual increase was observed after the launch of Singapore's NSAP in 2017. Taking reference from 192 the global observation and trend in AMR research from the wildlife and food-producing animals [10, 193 11], AMR research from the animal and food sectors in Singapore would likely continue in a similar 194 trend. Furthermore, the increasing emphasis on understanding cross-sector influences and impacts of 195 AMR [17], and the increasing evidence that antimicrobial misuse in food-producing animals harbours 196 potential impact on human health [18] would also spur continued research from these sectors.

198 The three domains with the lowest number of research articles were *Knowledge*, *Attitudes*, *Practices*, 199 Social and Economic Impact, and Transmission. Improving awareness and knowledge about AMR was 200 a recurring theme regardless of geography or sector. In Japan, AMR awareness had not significantly 201 changed despite WHO World Antimicrobial Awareness Week campaigns since 2015 [19]. Surveys 202 conducted in Japan also showed continued misconceptions about antibiotics use [20], which was again 203 echoed by a Chinese survey showing insufficient knowledge and neutral attitudes on AMR among 204 consumers in the food sector [21]. Although culturally dissimilar, the similarities with a recent study 205 on AMR knowledge and awareness among Singaporeans [22] demonstrated the need to improve AMR 206 education. In addition to studies in Japan, China and Singapore, results regarding AMR knowledge in 207 Ethiopia, Italy and Greece also showed that education with more appropriate content remained a 208 requirement, and that this was not restricted to a single population or country [12, 23, 24]. Reviews 209 on the contribution of AMR and the consequences for the population, such as that published by 210 Verraes et al., provide updated information to the scientific community working on AMR in the food 211 sector [25]. However, the information may not be easily understood by the public. Findings from a 212 WHO survey on antibiotic awareness campaigns held globally recommended dedicating sufficient 213 resources to campaign development and implementation, especially with updating obsolete 214 information and using more effective communication strategies [26]. Campaign evaluations were also 215 needed to measure their effectiveness and impact, since less than half of known campaigns were 216 evaluated and the results of such evaluations were usually not publicly available [26].

217

Our review also highlighted that research that delved deeper into the contribution of each sector towards the development of AMR was needed. The environment, for example, is a known reservoir of *de novo* resistance development, but awareness and understanding of its potential impact are lacking [27-29]. The presence of AMR genes and bacteria in the environment continued to be an area of concern, with several meetings held in the last five years to formulate and update the research

agenda on water, sanitation and AMR [30, 31]. Treatment systems in Singapore are effective in
removing most AMR genes and bacteria, but research in this area is still ongoing to further improve
the current treatment efficiencies [32-35]. Recommendations on priority research topics from global
expert consultations such as these could also be adapted for Singapore's context.

228 Singapore is exposed to AMR from multiple sources, such as from imported food or international 229 travellers, and research on potential transmission pathways of AMR is important. Therefore, 230 continued national, regional and global surveillance and epidemiological studies not only provide 231 information on the prevalence and incidence of AMR in and around Singapore, but also update risk 232 assessments and mitigation actions to minimise impacts where necessary [36-38]. Combining AMR 233 risk assessments with potential social and economic impact assessment may provide a holistic 234 approach towards overall impact assessment [39] and encourage the adoption of actions to minimise 235 the impacts due to AMR. Research on the economic impact and burden due to AMR could be 236 strengthened to facilitate such assessments for Singapore.

237

238 Lastly, the role of the animal, environment and food sectors in the transmission of AMR and their 239 intersecting impact on all the One Health sectors should also be investigated [17]. Most of the current 240 research conducted in Singapore addressed AMR from a human perspective, or from a single sector. 241 AMR genes from the environment had been shown to impact human health, including extended-242 spectrum beta-lactamase and New Delhi metallo-beta-lactamase-1 genes [40, 41]. These two genes 243 revealed a feedback loop between infection, antibiotic use and the development of antibiotic 244 resistance [42]. Identifying and understanding the transmission of such genes from the environment, 245 food and animal sectors would be necessary to plan risk assessments and mitigation measures. Being 246 an island state where all sectors are in close proximity or sharing the same space, this information is 247 important to minimise cross-sector transmission that would be detrimental to Singapore's health 248 security and economy.

Besides the three domains identified where research needs to be strengthened, other areas such as diagnostics for cross-sector application and an integrated surveillance system to facilitate correlation of data should also not be overlooked. With WHO working towards a global research agenda on AMR [43], Singapore could also identify relevant research questions needed to drive a national AMR research agenda that supports local needs using a similar approach.

256 Strengths and Limitations

257 Like the three reviews of global research trends [9-11], this was the first review of Singapore's research 258 landscape on AMR. We did not limit the types of research in our search of articles from the databases, 259 which allowed us to identify studies that could be assigned to the research domains identified from 260 stakeholder consultation. The studies were also not limited in terms of research technique employed, 261 and covered basic biological studies, sociology, public health, computational modelling and clinical 262 trials. We also did not impose restrictions on language, although our initial search identified only 263 articles published in English. However, this landscape review could have been limited by the lack of a 264 key word analysis to further corroborate the domains identified. There was also a risk of excluding 265 relevant research not indexed in scientific databases we searched, but this was mitigated by a manual 266 check of the references of included articles. While posters presented at scientific meetings were 267 excluded, this was unlikely to significantly impact the landscape review reported here as they 268 represented ongoing research work that were subsequently published, and would likely still be 269 included in our review. Due to the lack of agreed definitions for the sectors globally, articles were also 270 categorised using self-defined sectors. Nevertheless, the review of Singapore's AMR research 271 landscape will be a continuous effort to identify the evolution in response to the global call and needs 272 in AMR.

275 Conclusion

276	This review provides the first overview of the AMR research in Singapore. Besides an increasing
277	research output and diversifying topics in AMR research, it uncovered research gaps where resources
278	could be dedicated to increase the amount of research and corresponding output needed to drive the
279	AMR agenda highlighted by the Global Action Plan on AMR. In line with the One Health approach to
280	AMR, more research on AMR in and between all sectors is encouraged to identify transmission
281	between the One Health sectors. Collaborations with industry partners would also be needed to
282	translate findings into practice. The population's knowledge and response towards AMR should be
283	improved, and research on effective education methods is needed. Furthermore, developing a better
284	understanding of the direct and indirect costs of AMR would support the channelling of resources and
285	optimisation of interventions. Innovative cross-disciplinary research should be encouraged and
286	fostered, using a design theory approach that would break the current mould that researchers often
287	limit themselves to [44].




429 Figure 1. Flow diagram of article identification process.


432 Figure 2. AMR research articles from Singapore published 2009-2019. (A) Number of articles published per year, from 2009 to 2019. (B) Number of research




- 436 Figure 3. Comparison of AMR research trends from 2009 to 2019, for Singapore publications,
