

# Stones in Our Pockets: Mental Health Dimensions of Grief in Contemporary Video Games

## Abstract

This article combines the expertise of games studies scholars, medical ethicists, and clinical psychologists to analyse representations of grief in contemporary video games. Grief is a universal human experience, but navigating its psychological, social, and embodied effects can be a challenging task. Constructionist approaches to grief therapy emphasise the importance of metaphors for understanding the experience of loss (Nadeau 2006; Young 2008; Neimeyer 2010; Southall 2013). Paying attention to the metaphorical language used by a client can provide a therapist with key information about the client's personal and cultural perspectives and world view. Equally, a therapist can work with clients to devise metaphors that shift their perspectives and aid the process of meaning-making. Video games provide players with new metaphors to express and explore grief. Since video games communicate across audio, visual, verbal, haptic, mechanical, and performative modes, they can offer a complete gestalt that touches on the physical, emotional, practical, and systemic impact of loss. In this article, we survey the multimodal metaphors for grief that appear in 14 commercial-off-the-shelf (COTS) video games and identify recurring tropes and themes. We consider 1) what is illuminated by these metaphors? 2) what is obscured by these metaphors? and 3) what are the therapeutic implications of these metaphors? We conclude with a set of recommendations for game developers who want to design 'serious games' that explore emotionally fraught topics, and a set of recommendations for grief and bereavement therapists seeking to integrate video games into their practice.

## Introduction

Grief is an unavoidable part of human experience, but navigating its psychological, social, and embodied effects can be a difficult task. While most people find ways of living with grief, approximately 10-15% struggle with "intense, prolonged and complicated grief, characterized by extreme separation distress, preoccupation with the loss, and the inability to function in major life roles across a period of many months or years" (Neimeyer & Thompson, 2014). Over the last two decades, there has been a rise in the recognition of the

importance of metaphors in psychotherapy (Lawley & Tompkins 2011; Southall 2013), including a growing awareness of how metaphors exchanged between therapists and bereaved clients might affect attitudes towards grief (Nadeau 2006; Young 2008; Neimeyer et al. 2010; Goldberg & Stephenson 2016; Guité-Verret et al. 2021). Psychotherapists have drawn on the work of linguists and literary theorists such as George Lakoff and Mark Johnson (1980), Paul Ricoeur (1975), and Susan Sontag (1978), to argue that metaphors buttress our entire conceptual systems, affecting how we think, talk, and act (Southall 2013). Metaphors are not mere descriptions of reality: they are the means by which reality is negotiated, both on an intra-psychic and a societal level.

Metaphors can be useful in therapy because they ground abstract, intangible, ephemeral experiences, making them easier to examine and easier convey to others. In other words, metaphors are an aid both to reflection and to communication. At the same time, metaphors are inherently polyvalent. They are laden with intended and unintended connotations, which means they are somewhat resistant to the reduction in complexity that occurs when lived experience is translated into language. Furthermore, metaphors can provide a “safe way” (Nadeau, 2006 p.220) to explore difficult emotions or uncertain futures because they allow patients and therapists to approach sensitive topics indirectly. This can reduce defensiveness and instead encourage curiosity, flexibility, and even playfulness. Finally, metaphors can reveal what is being obscured or ignored. Since metaphors explicitly offer a subjective perspective on an experience, they can throw into sharp relief possible alternative perspectives that can subsequently be examined.

To support the generation and integration of metaphors, therapists and patients often engage with literature, art, and performance. This can take the form of creating new literary, artistic, or performed pieces, or of making personal connections to existing pieces. The process of exploration, articulation, validation, and transformation that structures arts-based therapy can be particularly useful for those experiencing bereavement. This is because grieving can be understood as a process of reconstructing a world of meaning that has been undermined by loss. To put it another way, grieving is an act of sense-making that allows one to repair or redefine one’s model of reality. Traumatic experience can disrupt previously held perspectives through impacts on memory but also by fracturing moral frameworks by which people live their lives.

Making art or engaging with art can provide the scaffolding within which one can build new frames of reference for interpreting one’s experiences. Arts-based therapy can engage with a wide range of media, such as photography, dance, pottery, and poetry. Video games are a relatively new medium, but nonetheless hold an important position in contemporary media landscapes. They appeal to overlapping, adjacent, and different demographics compared to traditional media, thereby expanding the reach of arts-based therapies. It is possible that patients who are unwilling to engage with traditional media such as poetry or painting could be more open to gaming (Pavarini, Reay, & Smith).

A poignant example of using metaphor in therapy is found in narrative exposure therapy, where stones can represent traumatic events or profound sadness, such as grief, in a person's life timeline. Each stone, varying in size and weight, symbolises the magnitude and impact of different traumatic experiences. This physical representation allows individuals to organise their life stories visually and tangibly, acknowledging and addressing each traumatic event. Through this process, patients can explore and understand their emotional landscapes in a structured, tangible way, facilitating healing and comprehension of their journeys. This method exemplifies how metaphors in therapy can bridge the gap

between the ineffable complexities of personal experiences and the necessity of addressing them directly for therapeutic progress.

While there have been important studies that address the use of video games in therapeutic settings (e.g., Ceranoglu 2010), gaming as a form of self-care (e.g., Spokes 2024), table-top role playing games in group therapy (e.g., Connell 2023) and game-making in relation to bereavement (e.g., Harrer 2018), there is a need for further empirical and theoretical research into how this new medium fits within existing therapeutic paradigms (Pavarini, Reay, & Smith). This article contributes to current scholarship in three ways:

- 1) It integrates insights from games studies about how metaphors work in video games and considers the connection to how metaphors work in psychotherapy.
- 2) It examines metaphors related to grief across a wide range of video games, from small, browser-based or mobile games developed by solo designers to AAA console games by major development teams.
- 3) It models a form of interdisciplinary research wherein psychologists and psychiatrists can comment on the therapeutic value of commercial video games, without requiring extensive gaming expertise.

## Literature Review

### Metaphors in games

Metaphors drawn from video games and gaming culture are already shaping personal behaviours, societal attitudes, and cultural beliefs. Describing someone as an ‘NPC’ (non-player character), for example, proliferated as a meme in far-right political circles to ridicule those who did not hold conservative views. Similarly, video game specific concepts such as ‘side quests’, ‘the final boss’, ‘noobs’, ‘XP’, and ‘rage quitting’ are now used as figures of speech in non-gaming contexts. This paper, however, is interested in the use of metaphors in video games and how these metaphors might influence conceptions of grief.

Video games provide us with new languages to express and explore complex aspects of the human experience. While we should be wary of contributing to the rhetoric of ‘video game exceptionalism’ by overstating the novelty of this medium’s affordances (Nicklin 2020), video games do combine communicative modes in ways that differ significantly from other forms of entertainment. Firstly, as Harrer writes, “unlike other artistic methods...game design engages metaphors through multiple modalities at once: rules, haptics, graphics and sounds” (2018, p.62). This means that video games can simultaneously draw on:

- the haptic, somatic languages of dance and performance,
- the visual imagery of film, animation, and photography,
- the auditory devices of music, soundscapes, and sound design,
- the verbal modes of dialogue, narration, and written text,
- the systematic modelling of simulations,
- the ludic signifiers of play, puzzles, challenge, and competition.

Reay (2024) argues that video games can be understood as dynamic ecosystems of meaning, within which different elements like visual, auditory, verbal, haptic, and ludic can enhance, extend, counterpoint, and even contradict each other. Dissonance between these elements can create interpretive gaps that invite subjective interpretation. The multimodality of video games does not necessarily close interpretive gaps, thus rendering a simulation of reality. Instead, introducing various elements creates spaces for interpretation, enriching the game with complexity and multiple perspectives. While aiming for ultra-realism in depicting loss

could potentially re-traumatise players, using these elements to deepen and add subtlety to metaphors empowers players to construct their own meanings. This approach leans into the imaginative rather than just the factual and literal representation, trusting players to close interpretive gaps. Additionally, since video games typically encourage playful engagement and exploration, players might see these open-ended interpretations as challenges to be unraveled.

Secondly, the highly interactive nature of video games means that they offer players a unique set of possible subject positions (Thi Nguyen 2020). In relation to video games that use extended metaphors, Magnusson notes that players are invited to respond (cooperatively or antagonistically) to the game whilst also being ‘ventriloquised’ by the game (2022). He claims that this form of “triangulated address and poetic ‘ventriloquism’ can only really be achieved by interactive media” (p.72, 2022). This is affirmed by Harrer, who notes, “compared to other modalities of reception, [video game] play invites the receiver to become part of a symbolic world, allowing an embodied connection to personal contents and themes” (p.63). Players can be interpellated into metaphorical representations, discovering how they work and what they feel like from the inside out. Rusch frames this as the “crucial difference between *doing* and *witnessing*” (p.72), coining the term ‘experiential metaphors’ to capture this distinction. Experiential metaphors are “a powerful form of metaphorical mapping and meaning generation” wherein inner states are made “concrete by letting us physically enact them through our virtual bodies or other means of projection into a game environment” (p.74). This is important because it engages ‘the emotions of agency’ (Isbister 2008), which include feelings such as pride, guilt, triumph, betrayal, humiliation, complicity, gratitude, loyalty, and duty. Unlike emotional reactions that we might experience vicariously via empathy with on-screen characters, the emotions of agency are felt ‘first hand’ and belong solely to the player. This contributes to the sense that a particular playthrough is personal and reflects a player’s individual choices, desires, and competencies, which may prove particularly useful in the context of deepening self-awareness and re-writing one’s identity in the aftermath of loss.

Finally, video game metaphors stand out from those in other media by offering visual metaphors and non-verbal communication that can intuitively reach and resonate with the player, often more directly than the more cognitively demanding verbal metaphors. Metaphors are, on some level, fundamentally about the connections between different elements since they invite us to understand one thing in terms of another. Video games take this a step further by specifically emphasising the connections between contexts, inputs, and outcomes. This could be particularly useful for encouraging bereaved patients to locate their personal experiences within a network of meaning, or – to use a metaphor commonly associated with grief – to see the hole created by loss within the context of the remaining material that edges it. As Rusch summarises, taking a systemic view of “personal problems can be highly beneficial” because it can “open one’s perspective to the bigger picture rather than focusing on an issue in isolation” (p.171). This becomes even more important when we consider Frazer-Carroll’s critique of the individualisation of mental illness. She writes that the failure to locate individual suffering within a broader social and political matrix “frames ongoing distress as a personal failure to self-discipline or seek out appropriate services, rather than acknowledging the structural conditions that also dictate our lives” (2023, p.44). Representations of loss via systems-based media may challenge the ‘privatisation’ of loss (Jalland 2013), instead emphasising the communal, structural, and ritual aspects of grief.

## Video Games and Arts-based Therapy

We are not the first to suggest that video games can be used as part of arts-based therapeutic interventions. Beyond the ‘games on prescription’ model – which has seen purpose-built video games such as EndeavorRX and LumiNova approved to augment the treatment of ADHD and anxiety respectively (Waltz 2020; Lockwood et al. 2022) – there has been increasing scholarly interest in the therapeutic potential of playing Commercial-Off-the-Shelf (COTS) games (Phillips 2021), as well as in the therapeutic potential of amateur game-making (Danilovic 2018; Harrer 2018; Rusch 2014).

We have chosen to focus on the representation for grief in COTS games rather than to analyse custom-made serious games (defined here as games made primarily for a purpose that is beyond entertainment) because we are interested in how the artistic or literary quality of video games might shape grief management. While some serious games for grief have a fantasy layer - the mobile game, *Apart of Me*, for example invites players to explore a tropical island whilst completing therapeutic tasks such as breathing exercises and logging one’s mood - they are often better categorised as ‘tools’ rather than as ‘art’. That is to say, the success metrics of a video game like *Apart of Me* are connected to its instrumental value, rather than to its artistic value. The fantasy layer exists to make the core therapeutic tasks more palatable: the audiovisual and narrative components are the ‘chocolate’ in the ‘chocolate-coated-broccoli’ model of serious games. Our view, however, is that the figurative aspects of video games could be considered ‘nutritious’. If we accept that it is the affective, imaginative, and aesthetic aspects of poetry, novels, art, sculpture, and so on that have the power to clarify grief and comfort the grieving (Shapiro 2006; Brennen 2020), then it follows that we should explore these same aspects in video games used in therapeutic settings for grieving patients. Finally, unlike custom-made serious games for therapeutic interventions, COTS games often have large player bases and appeal to broad audiences, which may include grieving individuals. Arguably, the reach and penetration of COTS games may make their impact on collective attitudes towards grief more significant than serious games.

## Surveying Metaphors used in Grief Therapy

Researchers have documented the metaphors used by clients to describe their grief in the form of case studies (Young 2008; Goldberg & Stephenson 2016; Guité-Verret et al. 2021). Young looks for categories that emerge within her case studies and identifies two groups of metaphors – “one connotes breakage, the other erasure” (2008, p.361) – and three themes – “metaphors of natural forces, of technology, and of fiber and fiber arts” (p.363). Guité-Verret et al. identify three distinct categories of metaphor in their case studies of individuals experiencing bereavement during the Covid-19 pandemic: “1) being cut off from others, 2) living and facing obstructions and 3) feeling shockwaves” (2021). Other researchers have conducted narrative literature reviews to identify the most common metaphors for grief reported in sessions with therapists. Southall (2013), for example, concludes that the dominant metaphors for grief can be sorted into the following categories: military metaphors, metaphors of journeying, metaphors of personhood, metaphors of the natural world, and existential / ideological metaphors.

Rather than reporting metaphors used by patients and therapists to describe grief, this paper reports the metaphors used in contemporary video games to describe grief.

However, we, too, are interested in cataloguing and critiquing the emerging motifs and patterns.

Based on this literature review, we have generated the following set of assumptions:

1. Metaphors are important meaning-making tools for those experiencing grief. Metaphors can provide patients and therapists with insights into subjective, personal experiences by both illuminating and obscuring aspects of reality.
2. Video games employ metaphors in ways that are comparable to other art forms and entertainment media. However, the form and function of metaphors in video games are shaped by a combination of communicative affordances that is unique to this medium.
3. Video game players may encounter metaphors for grief in COTS games that have an impact on their own mourning processes.

## Method

We employed purposive sampling to select video games for this study. Our inclusion criteria were:

1. Commercial off-the-shelf games (rather than bespoke games specifically designed as a therapeutic intervention)
2. Published between 2013 and 2023
3. Accessible on mobile, PC, Nintendo Switch, or PlayStation
4. Available to play in English
5. Represents a form of grief (e.g., death-related loss, relationship dissolution, losing home/possessions, loneliness, or major life transitions)

Table 1 details our final corpus.

Our corpus includes AAA games (e.g., *God of War*), award-winning games (e.g., *What Remains of Edith Finch*), indie games (e.g., *Spiritfarer*, *Lost Words: Beyond the Page*), autobiographical games (e.g., *That Dragon, Cancer*), and single-developer games (e.g., *Under a Star Called Sun*). It encompasses action games, walking simulators, platformers, adventure games, visual novels, cooperative games, and resource management games. It reflects a range of art styles, from high fidelity, motion-captured, realism through to highly abstract, stylised, pixel art. Finally, our corpus contains games that might appeal to a diverse range of player demographics, including different ages, genders, and levels of gaming literacy.

### Autoethnographic Reading

Autoethnographic close reading is an interpretive approach that involves analysing the formal properties of videogames while considering the role of the player in the signification process. According to Kłosiński (2022), autoethnography requires the transformation of lived experiences into discursive ones through narration, which can be compared with other narrations about it. In the context of the formal analysis of video games, autoethnographic reading requires the player-analyst to document their gameplay experience. The resulting text aims to capture the expressive eloquence of a video game's non-verbal signifiers, as well as the embodied, affective experience of play (Reay 2024). The point of autoethnographic reading is not to create an objectively accurate account of a specific gameplay sequence, but to preserve the unique aesthetic and emotional journey of an individual playthrough. These written accounts can be used as stable reference points throughout the analytic process.

For this study, the lead author played all of the video games listed in Table 1, creating anecdotes that detail key aspects of each playthrough. These narratives encompass the visual, auditory, mechanics, and haptic dimensions of the grief metaphors found in each game. This initial summary was then refined in collaboration with co-authors, who each experienced at least one game from the selection. Through hybrid meetings and workshops, the team identified points of resonance and dissonance based on their individual play experiences. These discussions helped organise their observations and reflections, leading to the selection of theoretical frameworks for analysing the games. This approach provides a subjective perspective for game analysis. The collective insights were integrated with the team's expertise in serious games, arts-based therapy, and medical ethics, fostering a comprehensive and interdisciplinary exploration of the games and their potential implications.

It is often assumed that interdisciplinary collaboration enhances research outputs. However, we have found that studies located at the intersection of psychology and games studies often encounter barriers that inhibit productive knowledge-exchange and knowledge-creation. Some of these barriers are general and relate to a mismatch between humanities methods of enquiry and methods used in the social sciences, but others are specific to the study of video games and relate to levels of ludic literacy. Ludic literacy refers to 1) a proprioceptive fluency when interacting with conventional control schema for video

games; 2) the ability to ‘read’ a video game’s audiovisual layer – including icons and symbols - to interpret its underlying rules; 3) a familiarity with the formal properties of different game genres. Asking a researcher with low ludic literacy to appraise a video game is akin to asking someone who cannot read to critique a novel. This is the elephant in the interdisciplinary room: ludic literacy is not considered a skill in the same way that traditional literacy is considered a skill, and so ludic illiteracy often goes unremarked.

We feel it is not necessary for those with expertise in psychology and psychiatry to also be experienced gamers to contribute productively to discussions about video games in therapeutic settings. It is the role of games studies scholars to make the primary texts legible to collaborators. This is usually an iterative process that requires designated space and time. For this project, we opted to establish this collaborative space through virtual or hybrid meetings.



## Results

## Discussion

The video games in our corpus could be positioned along sliding scales from ‘literal’ to ‘figurative’ and from ‘realistic’ to ‘fantastical’. *God of War*, for example, is quite literal in how it presents the mourning of its central characters: skilled actors give expert performances of the intrapsychic and interpersonal effects of grief through naturalistic dialogue and believable body language. However, this game is ‘fantastical’ in the sense that the plot centres of battles between Norse gods, mythical creatures, dwarves, witches, and legions of undead. *Gris*, on the other hand, is highly figurative. The nature of the loss itself is left ambiguous – some players interpret it as the death of a mother while others see it as the loss of a previously held identity. Some games had ‘literal’ and ‘realistic’ elements, but deeply metaphorical subplots. *If Found...* recounts a believable experience of a three-dimensional character in a specific time period and setting – rural Ireland in the early 90s. This narrative is entwined with a sci-fi subplot about an intergalactic explorer fighting to destabilise a blackhole. Similarly, *Lost Words: Beyond the Page* shifts between the realistic story of a young girl losing her grandmother and the highly metaphorical world of Estoria – a fictional place invented by the girl as the backdrop for her first novel. However, even games in our corpus that took a literal, realistic approach to exploring grief, relied on multimodal metaphors to convey and elicit feelings associated with loss.

We identified a recurrent set of metaphors that appeared across multiple video games. Several games used images of outer space to describe loss. In *If Found...* and *Under a Star Called Sun*, outer space expresses the vastness of loneliness and the emptiness of loss. Hurling away from Earth, alone and untouchable in the vacuum of space, the voyager in *Under a Star Called Sun* connects the inexorable passage of time to the growing emotional distance from a lost loved one. Rather than putting grief into perspective, the increasing distance seems to exacerbate the sense of loss because the destination of the spaceship is unclear and, perhaps, unimportant to the voyager. In *If Found...*, the sci-fi subplot follows the efforts of an intergalactic explorer to prevent a blackhole from engulfing the world by creating an ‘anomaly’. The anomaly occurs when Kasio’s mother is given a drawing an astronaut that Kasio made as a child, connecting the subplot with the main plot and making explicit the fact that the ‘blackhole’ is a metaphor for Kasio’s potential death through community- and self-neglect. *Spiritfarer* and *Gris* use visual metaphors of constellations to illustrate restorative forms of grieving. Metaphors of seeing light during moments of darkness undergird star-gazing practices of finding narrative meaning by joining previously unconnected dots. Completing these patterns allows the avatar in *Gris* to walk new pathways through the sky, while the constellations that appear in *Spiritfarer* act as reminders that although the deceased are beyond our reach, they persist in new cosmic forms. The collection mechanic associated with fireflies in multiple games also draws on metaphors of focussing on glimmers of light during dark times, even if those lights are faint, transient, and fugitive.

The images of ruins, abandoned houses, and bedrooms as proxies for deceased characters appeared in over a third of the games in our corpus. The gothic ‘haunted house’ trope is a very common metaphor for unprocessed grief, but is perhaps especially prevalent in video games because this medium often relies on environmental storytelling to impart narrative (Jenkins 2004). In *What Remains of Edith Finch*, the house itself is a metaphor for family. It expresses both the welcoming hospitality of family and the dangerous, jealous claustrophobia of overbearing relatives. *What Remains of Edith Finch* models the concept of

'getting to know' lost loved ones by engaging with artefacts associated with them and with stories told about them. In *If Found...* and *Gris* the crumbling structures represent the decline of the protagonists' wellbeing and sense of one's identity becoming fragmented and fractured as grief erodes one's firm foundation. In *Spiritfarer*, the abandoned room takes on a slightly more positive meaning. The empty bedrooms of former passengers are a constant reminder of those who have passed on and their material persistence is juxtaposed to the immateriality of their former occupants. However, there is something comforting about being able to revisit the spaces that capture some of the essence and personality of the dead that is not unlike the comfort of visiting a gravestone.

The 'depression as drowning' analogy is also familiar from other media. However, in its deployment in the games in our corpus, the overwhelm conveyed by waves of sadness were counterbalanced by an opening up of exploration opportunities. The undersea caverns in *Gris*, for example, offer players new directions for discovery, while the ocean in *That Dragon, Cancer* represents a change from the safe but strictly delimited island environment. In this sense, the idea of 'wallowing in one's sadness' seems less pejorative since the embodied metaphor acknowledges the allure and perhaps even the importance of 'plumbing the depths' of one's depressive feelings. Similarly, the cathartic release associated with rage – for instance, the 'juicy' combat of *God of War* or the sense of destructive release associated with smashing vases in *Gris* – means that this emotion is not cast as something 'negative' that must be avoided or moved past. The free movement associated with the fluidity of water is contrasted to the numbing paralysis of ice. In *Röki*, the final challenges take place in a palace of ice, and in *God of War* Kratos must learn to master the cold of emotional repression and the burning heat of rage before he can achieve self-acceptance.

Representing illness and death as monsters is not unique to video games, but when coupled with mechanics that force fail states these metaphors serve to undermine the 'battle / soldier' rhetoric attached to terminal diagnoses. Due to the strong conventional association between failure and death in video games, games in our corpus, such as *That Dragon, Cancer*, *Lost Words: Beyond the Page*, *Florence*, *Brothers: A Tale of Two Sons*, *What Remains of Edith Finch*, *Stillness of the Wind*, were able to subvert this association by suggesting that overcoming death is not possible through skill, will, or effort.

Four games in our corpus, i.e., *If Found...*, *Lost Words: Beyond the Page*, *Knights and Bikes*, *What Remains of Edith Finch*, were framed by or set within the focalising the characters' journals. The power of autobiographical storytelling as a grieving practice.

Many games achieved feelings of intimacy using art styles and fonts that were suggestive of being hand drawn and handwritten. Since grieving can be a vulnerable and personal experience, these design decisions add a 'human thumbprints' to the digital text, affirming the presence and investment of human creators.

Beyond visual and auditory representation of grief, the use of game mechanics and haptic offers a novel approach to influencing player emotions. For instance, *Florence* utilises jigsaw puzzle difficulty to mirror the challenges of communication within a relationship's various phases. Initially, puzzles are more complex, representing the couple's cautious and deliberate communication. As their relationship deepens, the puzzles simplify, reflecting improved understanding and ease of communication. Moreover, the game introduces a mechanic where players must restrain their interaction to symbolise the need to "let go" when the relationship ends. In *Stillness in the Wind*, the game's pace intentionally slows down, symbolising the protagonist's aging process. This mechanic not only adds depth to

gameplay but also profoundly conveys time's passage, inevitable change, and the exploration of life, death, loneliness, and despair.

## Conclusion and Limitations

This article traverses the intersection of games studies, medical ethics, and clinical psychology to dissect how contemporary video games metaphorically represent grief. It illuminates the multifaceted nature of grief—a universally yet complexly navigated experience—and highlights how video games, through their unique blend of audio, visual, verbal, haptic elements, and game mechanics, offer new metaphors for articulating and exploring the experience of loss. This exploration covers 14 COTS games, identifying recurring motifs, their illumination and obscuration of grief, and their therapeutic potentials. Ultimately, the paper proposes recommendations for game developers aiming to tackle emotionally charged topics in serious games and for therapists interested in incorporating games into grief counselling. This multidisciplinary approach not only broadens the understanding of video games' potential in therapeutic contexts but also challenges traditional narratives surrounding grief, suggesting that the medium's inherent interactivity and multimodality could redefine the paradigms of grief therapy.

The paper suggests that video games' capacity to evoke a spectrum of emotions through gameplay mechanics, including discomfort and ambiguity, positions them uniquely for addressing themes of grief. It demonstrates the role of games in facilitating a nuanced exploration of loss, beyond merely softening the edges of difficult emotions. We have shown that metaphoric representation creates interpretive gaps that encourage the player to co-construct meaning. Recommendations for game developers focus on leveraging the interactive and participatory nature of games to enable players to explore grief in a manner that is personal and meaningful. These insights advocate for a nuanced approach to designing serious games, where the complexity of human experiences like grief can be approached with empathy, creativity, and a readiness to embrace interpretive gaps for players to express their own meaning through choice and interaction. This perspective champions video games as a significant avenue for therapeutic exploration, heralding a new chapter in how we perceive and utilise games in the mental health and healing.

However, it is crucial to acknowledge the limitations related to cultural perspectives on grief. Variations in how different cultures process grief—from specific mourning periods to annual remembrance days like the Qingming festival (a.k.a. tomb sweeping day) in Chinese culture—highlight the contextual and cultural embeddedness of grief metaphors. Our inclusion criterion of games available in English limits the cultural perspective to primarily Western interpretations of grief. Metaphors, deeply ingrained in cultural constructs, vary across cultures, social groups, countries, and identity groups. As Littlewood (1990) argues, context dependent meanings are more important than specific universal processes of healing. Thus, video games may introduce metaphors that do not universally translate across cultural or social divides, suggesting a need for broader inclusivity and consideration in future research.
