# 1 Cognitive impairment at older ages among 8000 men and women living in

- 2 Mexico City: cross-sectional analyses of a prospective study

# 24 KEY POINTS

- 25 Question: What is the distribution of cognitive impairment among adults in Mexico City?
- 26 Findings: In this cross-sectional study of 8,197 adults aged 50-89 years, the sex- and district-
- standardised prevalence of cognitive impairment ranged from 10% in those 50-59 years to 55% in those
- aged 80-89 and at any given age was higher in women than in men. There was little difference in the
- 29 prevalence of cognitive impairment between participants with or without hypertension, diabetes or
- 30 excess of adiposity.
- 31 Meaning: Cognitive impairment is common in adults in Mexico City. Its relevance to major morbidity
- 32 and mortality deserves future research.

#### 33 ABSTRACT

Importance: There is limited population-based evidence on the prevalence of cognitive impairment in
 Mexico, a country with a rapidly aging population and where key risk factors, such as diabetes and
 obesity, are common.

37 **Objective:** To describe the distribution of cognitive impairment in a sample of adults from Mexico City.

38 **Design, Setting, and Participants:** This cross-sectional population-based study included participants

from the Mexico City Prospective Study which 50,000 men and 100,000 women aged ≥35 years from

40 two districts in 1998-2004. In 2015-2019 about 10,000 survivors were resurveyed with identical

41 information from the original survey and additional assessments including a cognitive assessment.

42 The main analyses included those aged 50-89 years with complete cognitive assessment and

43 covariate data at resurvey.

Main outcomes and measures: Cognition was assessed using the Mini Mental State Examination
(MMSE) and those with cognitive impairment (MMSE ≤24) were identified. The distribution of MMSE
scores and cognitive impairment by age, sex, and major disease risk factors (diabetes, hypertension,
and adiposity) was analyzed among those with complete MMSE data and some degree of selfreported formal education.

49 **Results:** Of the 9,288 participants aged 50-89 years at the 2015-2019 resurvey with complete data, 50 8,197 reported having at least some years of formal education. Among these (mean age 66 years; 51 31% men), their mean MMSE score was 26.2 (SD 3.6) points, 1,941 (24%) had cognitive impairment, 52 mean body-mass index (BMI) was 28.6 (SD 5.5) kg/m<sup>2</sup>, 3.008 (37%) had previously-diagnosed hypertension and 2,467 (30%) had previously-diagnosed diabetes. The sex- and district-standardised 53 54 prevalence of cognitive impairment increased strongly with age, from 10% in those 50-59 years to 55 55% in those aged 80-89. At any given age, the prevalence of cognitive impairment was higher in 56 women than in men. After accounting for the effects of age, sex, and district there was little difference 57 in the prevalence of cognitive impairment between participants with or without diabetes, hypertension, 58 overweight or obesity (BMI  $\geq$ 25 km/m<sup>2</sup>), or high levels of fat mass.

Conclusion and relevance: In this population of adults aged 50-89 years from two districts of Mexico
City, the prevalence of cognitive impairment was high, particularly among women. The extent to which
cognitive impairment relates to health outcomes in this population needs to be investigated.

#### 62 INTRODUCTION

63 Epidemiological and demographic changes in global populations have highlighted the relevance of the 64 ageing process for the preservation of cognitive function, which has a significant effect on the independence and quality of life of older people 1-3. Metabolic diseases, such as excess adiposity or 65 66 type 2 diabetes, and cardiovascular diseases have been identified as risk factors for the development of cognitive impairment 4-6, a condition which has been associated with an increased risk of dementia 67 68 <sup>7,8</sup>. Given how rapidly populations across the world are aging, including those in understudied regions 69 such as Latin America, there is a need for a greater understanding of the distribution of cognitive 70 impairment and its associated risk factors in such regions. 71 Mexico is the second most populous country in Latin America at around 126 million people.<sup>9</sup> Obesity 72 and diabetes are common in Mexico and confer an unduly high excess risk of mortality (mostly due to vascular and renal causes)<sup>10–12</sup>. Obesity<sup>13,14</sup> and diabetes<sup>15</sup> are also established risk factors for 73 74 cognitive impairment and dementia. The reported prevalence of cognitive impairment in Mexico is 75 estimated to be around 7% to 10% in those aged 65 years increasing to 27% in those aged ≥85 years 76 <sup>16,17</sup>. However, these estimates are based on studies with very small sample sizes<sup>17</sup> or where 77 information on cognition was not exclusively collected directly from participants but also through proxy 78 interviews<sup>16</sup>.

The Mexico City Prospective Study (MCPS) recruited 150,000 participants in 1998-2004. We aimed to
report the age- and sex-specific distribution of cognitive impairment and its sociodemographic,
lifestyle, biological and medical health characteristics in a subset of around 9,000 MCPS participants

82 who had cognitive function assessed during a resurvey of survivors carried out in 2015-2019.

#### 83 METHODS

#### 84 Study design and participants

Study design, sampling methods, and follow-up have been described before<sup>18</sup>. Briefly, between 1998
and 2004, households in two contiguous districts in Mexico City (Coyocán and Iztapalapa) were
visited and all inhabitants aged 35 and over were invited to participate in the study. Of the 112,333
households visited, 106,059 (94%) yielded at least one inhabitant who consented to participate.
Ethics approval was granted by the Mexican Ministry of Health, the Mexican National Council for
Science and Technology, and the University of Oxford. All participants provided written informed
consent.

#### 92 Data collection

93 In the baseline measurement, during household visits, trained nurses conducted face-to-face 94 interviews and recorded information on sociodemographic and lifestyle factors, current medications, 95 and medical history (including previous medically diagnosed diseases such as diabetes). Blood 96 pressure, weight, height, waist and hip circumference were measured using standard protocols, and a 97 non-fasting venous 10 mL blood sample was collected. In 2015-2019, a repeat survey was performed 98 in a subset of around 10,000 surviving participants. For this resurvey, streets within the two study 99 districts in which participants were previously recruited in 1998-2004 were selected at random and 100 then systematically revisited to identify participants who were still alive, living at the same address, 101 and willing to take part in a further survey. Data from the resurvey were entered directly into study 102 tablets which captured the exact time points at which each question or procedure was completed. The 103 resurvey involved similar questions and assessments as at the original survey in 1998-2004, but with 104 some additions. Whole-body bio-impedance measures at resurvey were recorded using a Tanita SC240-MA body composition analyzer. Cognition at resurvey was assessed using the Mini Mental 105 State Examination (MMSE) in Latin-American Spanish<sup>19</sup>, a tool that is commonly used to identify 106 107 individuals at a higher risk of cognitive impairment in clinical and population studies. The original 108 MMSE<sup>20</sup> and the version used in this study have the same domains and scores: orientation to time (5 109 points); orientation to place (5 points); registration (3 points); attention and calculation (5 points); 110 recall (3 points); and, language (9 points). Cognitive impairment was defined as a score of 24 or less 111 on the MMSE, to be consistent with previous studies in Mexican population<sup>19,21</sup>.

#### 112 Statistical analysis

- 113 Analyses were limited to resurveyed individuals whose cognitive status was assessed with the
- 114 MMSE. The few participants who were aged below 50 years or were aged 90 years or above were
- 115 excluded. We also excluded anyone with an MMSE score of zero, anyone with an MMSE
- 116 questionnaire duration less than 1 minute or longer than 30 minutes, and anyone with a missing self-
- 117 reported education (**Supplementary Table 1**).
- 118 Initial analyses plotted the distributions of MMSE score and of cognitive impairment at different ages
- across groups of educational attainment reported at resurvey (i.e., without formal education,
- 120 incomplete primary education, complete primary education, secondary education, and tertiary
- education). As having no formal education strongly limited the ability of participants to complete the
- 122 MMSE questionnaire reliably (Supplementary Figure 1), the main analyses were limited to the large
- 123 proportion of participants with some degree of formal education. (Analyses including those reporting
- 124 no formal education are provided as sensitivity analyses.)

125 The prevalence of cognitive impairment and the mean MMSE scores (with 95% confidence intervals) 126 were plotted separately in men and women across equally sized age groups (~1000 women and ~500 127 men in each group). To obtain standardised estimates, the prevalence of cognitive impairment was first calculated separately in men and women at ages 50-59, 60-69, 70-79, and 80-89 years. These 128 129 eight age- and sex-specific estimates were obtained by averaging the group-specific prevalences in 130 participants residing in Coyoacán and in Iztapalapa, yielding district-standardised estimates. These 131 were then averaged to calculate the overall age-, sex- and district-uniformly-standardised prevalence 132 at ages 50-89 years.

133 Finally, to assess how the prevalence of cognitive impairment varied in those with and without key risk 134 factors, while accounting for variation due to age, sex, and district of residence, sex- and district-135 standardised prevalences across equally-sized age groups were calculated in those with and without 136 such factors. The factors included previously-diagnosed diabetes (i.e., a self-reported medical 137 diagnosis or treatment of diabetes), previously-diagnosed hypertension (i.e., a self-reported medical 138 diagnosis or treatment of hypertension), overweight or obesity (i.e., a body-mass index of 25 kg/m<sup>2</sup> or 139 above) and high impedance-measured fat mass (i.e., those at the top half of the distribution of fat 140 mass). Analyses were conducted using R (version 4.3.2).

#### 141 **RESULTS**

Of the 159,755 participants recruited at baseline from 1998 to 2005, 10,144 were resurveyed in 2015-2019. Of these, 388 participants were aged 49 years or below or 90 years or above at resurvey, 218 had missing MMSE score, 370 had a very short or very long MMSE questionnaire duration, and 126 had missing data on education, and were excluded. Of the remaining 9,288 men and women aged 50 to 89 years, 1,091 reported not having had any formal education and were removed (**Supplementary Figure 1**), leaving 8,197 participants for the main analyses.

148 Table 1 shows the characteristics at resurvey of the 2,565 men and 5,632 women aged 50 to 89 149 years who reported having some level of formal education. In these participants, the mean (SD) MMSE score was 26.2 (3.6) in both men and women (Supplementary Figure 2), the mean (SD) age 150 151 was 66 (9.7) years, about half were residents of Coyoacán, and 11% had completed tertiary-level education. About one in six (14%) were current smokers, nearly half (44%) were current drinkers, and 152 153 17% engaged in leisure-time physical activity at least 3 times per week. In the study population, 154 obesity, hypertension, and diabetes were common. The mean (SD) body-mass index (BMI) was 28.6 155 (5.5) kg/m<sup>2</sup>, about half of the population (42%) had BMI between 25 and 29.9 kg/m<sup>2</sup>, and one-third 156 (35%) had a BMI ≥30 kg/m<sup>2</sup>; the mean (SD) systolic blood pressure (SBP) was 132 (22) mmHg and about a third (30%) had previously diagnosed diabetes. Compared with women, men were more likely 157 158 to have tertiary-level education (13% vs 9%) to smoke (24% vs 10%), and to drink alcohol (56% vs 159 38%). However, women, on average, had higher BMI (29.2 vs 27.5 kg/m<sup>2</sup>) and were more likely to 160 have previously diagnosed hypertension (39% vs 32%) than men.

161 Of all 8,197 participants included in the main analyses, 1,941 (23%) had an MMSE score ≤24 162 consistent with cognitive impairment. Those with cognitive impairment were, on average, about 8 years older than those without (72 [9.8] vs 64 [8.9]), were more likely to be residents of Coyoacán 163 164 (58% vs 50%) and had lower educational attainment (2% vs 13% with tertiary-level education). They 165 were also more likely to be widowed (32% vs 18%), and less likely to smoke (11% vs 16%), drink (33% vs 47%), or exercise  $(12\% \text{ vs } 18\% \text{ had leisure-time physical activity } \geq 3 \text{ times per week})$ . 166 Participants with cognitive impairment also had a lower BMI (28.0 vs 28.8 kg/m<sup>2</sup>), were less likely to 167 168 have obesity (31% vs 36%) and were more likely to have previously diagnosed hypertension (43% vs 169 35%) and previously diagnosed diabetes (33% vs 29%).

#### 170 Age and sex specific prevalence of cognitive impairment

171 The overall age-, sex-, and district-standardised prevalence of cognitive impairment at ages 50-89 172 years was 29% and was moderately higher in women (31%) than in men (26%) (Table 2). In both 173 men and women, the prevalence increased steeply with age, from 8% at ages 50-59 years to 52% at 174 ages 80-89 years in men and, just as steeply, from 12% at ages 50-59 years to 59% at ages 80-89 175 years in women (Table 2 and Figure 1). When averaged across men and women, the mean MMSE score reduced from 27.6 (2.3) at ages 50-59 years to 23.0 (4.8) at ages 80-89 years. 176 177 Cognitive impairment by key metabolic risk factors 178 After standardising for age, sex, and district of residence, there was little to no difference in the

prevalence of cognitive impairment in individuals with key metabolic risk factors compared with those without (**Figure 2**). At every given age, the sex- and district-standardised prevalence of cognitive status was broadly similar in individuals with and without previously diagnosed hypertension, with and without a BMI  $\geq$ 25 kg/m<sup>2</sup>, and with and without a fat mass above the sex-specific median (>19.2 kg in men or >24.4 kg in women). There was some suggestion that the prevalence of cognitive impairment between ages 60 and 75 was slightly higher in those with versus without previously-diagnosed diabetes, but such differences were not seen at either younger or older ages.

#### 186 Sensitivity Analyses

187 The prevalence of cognitive impairment showed similar distributions by age and sex in residents from 188 the two districts, but the overall age- and sex-standardised prevalence was higher in Coyoacán (32%) 189 than in Iztapalapa (25%) (Supplementary Table 2). When considering all the population with and 190 without formal education, the overall sex- and district-standardised prevalence increased to 35% 191 (31% in men and 39% in women; Supplementary Table 3).

### 192 DISCUSSION

193 This study describes the distribution of cognitive impairment among 9000 participants of the Mexico 194 City Prospective Study whose cognition was assessed with the Mini-Mental State Examination in 195 2015-2019. The uniformly-standardised prevalence of cognitive impairment at age 50-89 years was 196 29% overall, increasing from 10% at ages 50-59 years to 55% at ages 80-89 years, and was higher in 197 women than in men overall (31% vs 26%, respectively) and at every given age. After accounting for 198 age, sex and district of residence, the prevalence of cognitive impairment was broadly similar in those 199 with vs without previously diagnosed diabetes, hypertension, BMI ≥25 kg/m<sup>2</sup>, or an above-average fat 200 mass. Overall, the findings from this study highlight that, in this urban Mexican population, cognitive 201 impairment is common.

202 This study builds on previous studies of cognitive impairment in Mexico. While it is difficult to compare 203 directly, other studies in the Mexican population have reported a wide range of prevalences of 204 cognitive impairment in adults (7%-34%). Differences across studies may be explained by different 205 study characteristics (particularly differences in age which may not have been accounted for through 206 standardization), different tools used for identifying cognitive impairment, and, in some cases, limited 207 study sample size (which can yield unreliable estimates) <sup>5,22,23</sup>. Our results are similar to those 208 reported by a study that used data from the Mexican Health and Aging Study (MHAS), which included 209 10,000 adults aged 60 years or above from different regions in Mexico. In this study <sup>24</sup>, cognition was 210 evaluated in 2015 with the Cross-Cultural Cognitive Evaluation questionnaire (CCCE) through either 211 direct or proxy interviews. The prevalence of any cognitive alteration (i.e., cognitive impairment or 212 dementia) was 20% and increased with age (17% at ages 60-75 years and 30% at ages >75 years). 213 Another study that used data from a subsample of 1,800 MHAS participants assessed in 2015, 214 reported a 34% prevalence of cognitive impairment in adults aged 60 years or above, perhaps 215 because more comprehensive assessments were used to identify those with cognitive impairment <sup>6</sup>. 216 Pooled together, our study further suggest that cognitive impairment is common among adults in 217 Mexico City and highlights the steep increase in its prevalence as individuals age. 218 Consistent with previous studies, we found a higher prevalence of cognitive impairment in women

than men.<sup>6,24</sup> There are many reasons why women may be more likely to develop cognitive

impairment than men, particularly in low and middle-income countries. In the current study, individuals

221 were born between ~1925 and ~1965. During this period, women in Mexico may have had lower

222 opportunities to access higher levels of education than men, a strong risk factor for developing 223 cognitive impairment. Women in the current study were slightly less likely than men to have tertiarylevel education for instance. Women in Mexico may also be more likely to be unpaid for their labour, 224 225 have poorer career progression opportunities and less likely to be economically independent than 226 men<sup>25</sup>. Such factors have been associated with higher risk of cognitive impairment <sup>26</sup>. While it is not 227 fully understood how low education and socio-economic status lead to cognitive impairment, it is 228 hypothesized that these factors limit the development of cognitive reserve in early and middle-life 229 which could be protective of dementia <sup>27</sup>. It is also likely that socio-economic status can increase the 230 risk of cognitive impairment (and dementia) due to social disparities in smoking, alcohol intake, 231 physical activity, adiposity, elevated blood pressure, and diabetes all of which are established risk 232 factors for dementia <sup>28</sup>. Overall, our findings highlight the potential benefits of addressing gender and 233 socio-economic disparities to close health gaps.

234 After accounting for age, there was little difference in the prevalence of cognitive impairment in those with vs without hypertension or excess of adiposity. This may be expected if presence of these risk 235 factors in early and middle-life is more relevant to cognitive impairment than presence in older age. 236 237 This may be particularly relevant for adiposity, for which long-term prospective evidence has shown 238 that those who develop dementia can lose weight many years before the diagnosis of the disease <sup>29</sup>. 239 Those with diabetes had a marginally higher prevalence of cognitive impairment than those without 240 diabetes (at least between ages 60 to 75 years), but further research is needed to establish the extent 241 to which diabetes may result in cognitive impairment in this population.

242 This study has several strengths, not least that it provides population-based prevalence estimates of 243 cognitive impairment in an understudied population. Information was collected by trained health 244 professionals using standardised procedures. While the tool used to assess cognition (MMSE) was 245 developed in an English-speaking population from a high-income country, it has previously been validated for use in Spanish-speaking individuals <sup>19</sup>. Although the full-length version of the MMSE was 246 247 used, this tool substantially underestimates cognition level in individuals with little to no literacy skills 248 (as certain tasks involve reading or writing). For this reason, we excluded from our main analyses 249 participants who reported not having had any formal education. However, as a consequence of 250 restricting our analyses to those who reported having at least some formal education, we may have 251 even underestimated the true prevalence of cognitive impairment in the whole population. By design,

- the Mexico City Prospective Study is not representative of the whole population of Mexico. However,
- the standardised prevalence estimates, including age-, and sex-specific estimates, within this report
- 254 facilitate comparison with other existing and future estimates and represent a valuable contribution to
- the epidemiological characterization of cognitive impairment in Mexico.
- In conclusion, in this cross-sectional population-based study of Mexican adults aged 50-89 years, the
- 257 prevalence of cognitive impairment assessed in 2015-2019 was high, particularly among women, and
- 258 increased steeply with age. The extent to which cognitive impairment relates to health outcomes in
- this population needs to be investigated.






