

1 **Characteristics and needs of Vietnamese technical intern trainees (care workers) in**

2 **Japan: A qualitative study**

16 **Abstract**

17 **Background**

18 Foreign caregivers are assuming increasing importance in Japan due to a significant shortage
19 of caregivers. To secure and train stable human resources, it is important to understand the
20 needs and challenges of foreign caregivers.

21 **Objective**

22 To identify the needs and challenges of Vietnamese technical interns, the largest group of
23 foreign caregivers in Japan, to facilitate system reforms for foreign caregivers and a more
24 efficient recruitment process.

25 **Methods**

26 A semi-structured interview survey was conducted with 27 Vietnamese technical interns
27 (caregivers). Interview items included reasons for choosing technical internship in Japan,
28 desired length of stay, and expectations in Japan, as well as career advancement after returning
29 home. Descriptive statistics and k-means clustering were used to analyze the data.

30 **Results**

31 Survey results showed that all respondents had made their own decision to come to Japan and
32 wanted to pursue caregiver certification; 44% had also considered other countries apart from
33 Japan; most wanted to stay in Japan for as long as possible; 37% wanted to live in Japan
34 permanently. The k-means method revealed three clusters: Japanophile cluster or those who

35 preferred Japan for its landscape, culture, and national character; Word-of-mouth cluster or
36 those influenced by personal referrals; and Intellectual cluster or those influenced by Japan's
37 economic development and care levels.

38 **Conclusions**

39 Vietnamese technical interns hoped to study advanced Japanese, become certified care workers,
40 and work in the nursing field after returning to their home country. They also tended to want
41 to stay in Japan for a longer period than that assumed for technical internship programs. Our
42 findings indicate that support for obtaining qualifications, Japanese language skills, and
43 caregiving skills are important to secure stable foreign caregivers. Since each cluster had
44 different backgrounds and reasons, motives, and assumptions for coming to Japan, it is
45 necessary to tailor recruitment, training, and support for each cluster.

46 **Introduction**

47 Japan's declining birthrate and aging population are increasing the demand for long-
48 term care; however, there is an acute shortage of care workers to support this demand.
49 According to the Ministry of Health, Labor and Welfare, there were 1.9 million care workers
50 in Japan in 2016, and it is estimated that approximately 2.45 million will be needed by 2045
51 [1]. The number of care workers has increased by only 15,000 annually, and there are concerns
52 that the workforce will decrease because of the declining birthrate [2]. To address the shortage
53 of care workers, not only do the domestic human resources need to be secured by improving
54 the working conditions and wages of care workers, but the acceptance of foreign care workers
55 also needs to be addressed. In addition new technologies such as information and
56 communication technology and robots need to be utilized [3]. Employment of foreign care
57 workers has been expanding in Japan; according to a survey, 30% of the long-term care
58 facilities in Japan are staffed by foreign care workers [4].

59 Acceptance of foreign caregivers in Japan may be categorized into the following four
60 types: (1) the Economic Partnership Agreement (the purpose of which is to strengthen bilateral
61 economic partnerships), (2) the status of residence for nursing care (the purpose of which is the
62 acceptance of foreigners in professional and technical fields), (3) the Technical Intern Training
63 Program (the purpose of which is the transfer of skills to their home country), and (4) the
64 Specified Skilled Worker (the purpose of which is the acceptance of foreigners with certain

65 expertise and skills to address labor shortage) [5, 6]. Of the four programs, the Technical Intern
66 Training Program comprises the largest number of foreign caregivers at 7,900, with Vietnam
67 accounting for approximately 40% of the total. However, several challenges have been
68 identified in recruiting foreign caregivers. For example, Yu [7] pointed out that recruitment,
69 training, and traveling costs are incurred as acceptance costs and that a certain level of Japanese
70 language proficiency is required. In addition, they are affected by exchange rates and
71 competition with other countries for human resources [7]. According to the Japan External
72 Trade Organization, the total number of general workers sent abroad from Vietnam is 140,000,
73 with Japan and Taiwan receiving a similar proportion of these workers (approximately 40%),
74 and South Korea (approximately 7%) also growing in popularity as a destination for these
75 workers [8].

76 Several studies have been conducted on Vietnamese technical trainees coming to
77 Japan [9-12]. However, few studies have focused on their needs, thoughts, and concerns. This
78 information may be useful from the perspective of system reform and human resource
79 recruitment. Therefore, this study conducted an interview survey of Vietnamese technical
80 interns (nurses) prior to their arrival in Japan, regarding their reasons for coming to Japan, their
81 thoughts and concerns about Japan, and their careers after returning home.

83 **Materials and Methods**

84 **Participant selection and data collection**

85 Technical intern trainees are expected to come to Japan after receiving Japanese
86 language and technical training for several months at the sending agency in Vietnam. Since the
87 regions and characteristics of the participants from each sending agency may be different, this
88 survey was conducted with recruits from three different sending agencies in Hanoi, Vietnam.

89 The survey was conducted between November 2023 and February 2024 after ethical
90 approval was obtained from the Yokohama City University Ethics Committee (reference
91 number: 2023-18). Participants were sent an explanation of the survey and the survey items in
92 advance. Participants then submitted consent forms to participate.

93 Semi-structured interviews were conducted with 27 Vietnamese nationals affiliated
94 with Vietnamese sending agencies (nine each from three sending agencies) and scheduled to
95 come to Japan as technical intern trainees (nursing care). Participants were divided into groups
96 of three, for a total of nine groups, and each group was interviewed for approximately 90
97 minutes by the authors. The interviews were conducted in the conference room of each sending
98 agency, with the assistance of a Vietnamese interpreter. Questions were asked in Japanese and
99 answered in Vietnamese. The survey items are listed in S1 Appendix.

101 **Data analysis**

102 Descriptive statistics were calculated based on the data obtained from the semi-

103 structured interviews. Clustering using the k-means method with cosine similarity was
104 performed on the 27 participants, who were classified into several clusters. The elbow method
105 was used to determine the number of clusters. The variables used for clustering were selected
106 based on the importance and variance of items. All statistical analyses were performed in R
107 (ver. 4.2.3).

109 **Results**

110 Participant characteristics are summarized in Table 1. Most participants were female
111 (92.6%). Participants' average age was 21.7 years, and about half of them (55.6%) were high
112 school graduates, while 22.2% had children. There was no variation in sex or age among the
113 sending agencies, but there was a variation in education and presence of children.

116 Table 2 shows the interview survey results. More than half the participants (56%) did
117 not consider any other country apart from Japan. Potential destinations other than Japan
118 included Germany (7 respondents), Taiwan (3), Korea (3), and China (1). The reasons for
119 choosing Japan over Germany were the better impression participants had of Japan, the friendly
120 relations between Japan and Vietnam, and the greater availability of information on Japan than
121 on Germany. Taiwan was chosen because of its cultural and lifestyle similarities with Japan.
122 Japan remained the first choice, based on information available on the Internet, and that from
123 acquaintances and relatives in Japan. Korea was less popular because it does not offer nursing
124 care as a career.

 127 being the most difficult, and measures the level at which one can understand the Japanese being
 128 used in a wide range of situations.

129 Certified care workers are certified nationally in Japan.

131 Regarding their career goals, 22% of the respondents wanted to pass the most difficult
 132 level (N1) of the Japanese-Language Proficiency Test, while all of them wanted to become
 133 certified care workers. However, communication difficulties, living environment such as

134 travelling by train, cold weather, and natural disasters, were cited as areas of concern regarding
135 Japan. Only one in three respondents wished to stay in Japan permanently; others wanted to
136 stay for an average of 6.8 years. Many hoped to work in the nursing care industry after returning
137 to their home country.

138 The reasons for choosing Japan are illustrated in Fig 1. Approximately half of the
139 respondents (51.9%) chose Japan because of their interest in Japanese culture (e.g., anime and
140 kimonos) and scenic beauty (e.g., Mt. Fuji). Approximately 40% of the respondents cited
141 personal recommendation by family and friends and the diligence and rule-abiding nature of
142 Japanese people, respectively, as the reasons for their choice.

143 **Fig 1. Reasons for Choosing Japan.**

144 The number of clusters was determined to be three using the elbow method. The
145 results of clustering using the k-means method are shown in Fig 2 and Table 3. The three
146 clusters were (1) the Japanophile cluster, (2) the word-of-mouth cluster, and (3) the intellectual
147 cluster.

148 **Fig 2. Results of Clustering Using the K-Means Method.** Components 1 and 2 explain
149 38.15% of the point variability.

153 Discussion

154 According to the General Statistics Office of Vietnam, the Vietnamese population
155 aged 65 and above will have grown rapidly, from 7.4 million people in 2019 (7.7% of the
156 population) to 16.8 million people by 2039, and 25.2 million people by 2069 (21.5%) [13].
157 However, Vietnam has no long-term care insurance and only a few long-term care services.
158 Therefore, family members play an important role in caring for older adults. In recent years,
159 family care has been challenged by declining family sizes due to declining birth rates, a shift
160 from multi-generational cohabitation to nuclear families with an increasing proportion of
161 elderly couples living alone, and rapid urbanization with a large number of rural youths
162 migrating to urban areas, resulting in rapid family dispersal [14]. Consequently, the
163 respondents wanted to gain skills in Japan in anticipation of future care needs or to provide
164 care to their families.

165 All respondents indicated that they wanted to become certified care workers, which is
166 a Japanese national qualification that effectively allows for permanent residence. However,
167 obtaining this certificate is difficult, with a pass rate of 82.8% for all candidates compared to
168 43.8% for foreign candidates, under the Economic Partnership Agreement [15]. Although
169 exam-related accommodations have been made for foreign examinees (e.g., paraphrasing of
170 difficult expressions, English notation of diseases, and extended exam times), the learning
171 environment and exam preparation support must be improved. One report also found that

172 gaining a caregiver qualification led to greater understanding of and confidence in their work
173 and contributed to the professionalization of care [16].

174 In this study, the participants were classified into three clusters. They were divided
175 based on their educational background, reasons for choosing Japan over other candidate
176 countries, and desire for permanent residence. The characteristics of each cluster were then
177 identified. These clusters can be useful for securing and developing human resources in the
178 future. For example, if one wants to target people who wish to live permanently in Japan,
179 targeting the intellectual cluster may be effective for disseminating information via the Internet
180 and emphasizing learning and growth opportunities in Japan. However, when targeting the
181 relatively young age group of high school graduates, it may be prudent to target the Japanophile
182 cluster by visiting high schools to disseminate information emphasizing culture, such as anime
183 and manga, or the diligent and rule-abiding nature of the Japanese people. In addition, when
184 targeting people with high aspirations for caregiving skills, targeting the word-of-mouth cluster
185 may be important by creating a mechanism that fosters referrals for Japanese caregiving.
186 Cluster-based targeting, public relations strategies, and cultivation methods must be given
187 greater consideration while targeting specific care workers.

188 Japan's technical internship system is at a major turning point. It has been
189 recommended that the system be revised to protect the human rights of trainees, clarify career
190 advancements, and create a safe, secure, and harmonious society for foreigners [17]. In fact,

191 much research has pointed out problems with the content of work, the treatment of trainees,
192 and the living conditions of technical interns in Japan [11, 18-20]. Many participants in this
193 study were influenced by personal recommendations, particularly regarding the working
194 environment and life in the community. Therefore, promptly establishing a system and
195 providing better working and living environments are among the most important efforts for
196 attracting foreign caregivers.

197 This study has some limitations that must be considered. First, the participants were
198 limited to 27 individuals from sending agencies in Hanoi; hence, these findings cannot be
199 generalized to all Vietnamese or technical interns. However, by targeting three sending
200 agencies, we avoided significant biases. Second, the participants were interviewed prior to their
201 entry into Japan, and their opinions may change after spending some time in Japan, whereby
202 they may experience a culture shock, conflicting reality or information regarding their
203 assumptions, or a change in their goals and plans; these aspects would need further
204 investigation.

206 **Conclusions**

207 Our study revealed that Vietnamese technical (nursing) trainees going to Japan wanted
208 to gain advanced Japanese language proficiency and become certified care workers. Most
209 wanted to continue working in the nursing industry after returning to Vietnam. Additionally,

210 more than half the participants chose Japan for care work compared to other countries such as
211 Germany, Taiwan, and Korea, particularly because of Japan’s landscape, culture, and national
212 character, as well as positive referrals by family and friends. More than a quarter of the
213 participants were looking to live in Japan permanently. Given the findings of the clustering of
214 our data, it is important to consider information dissemination, communication, and human
215 resource development tailored to the characteristics of each cluster in order to recruit
216 effectively.

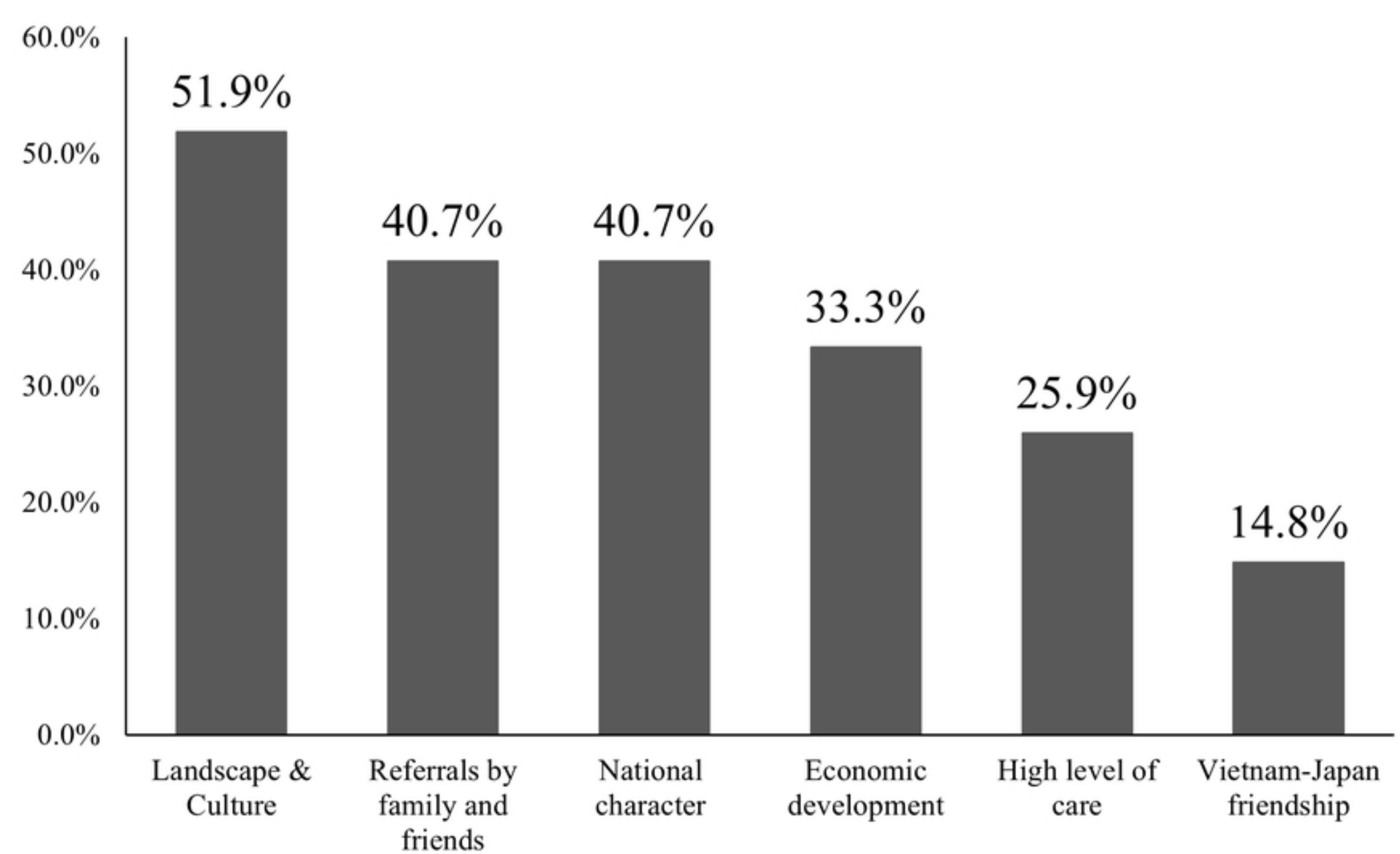

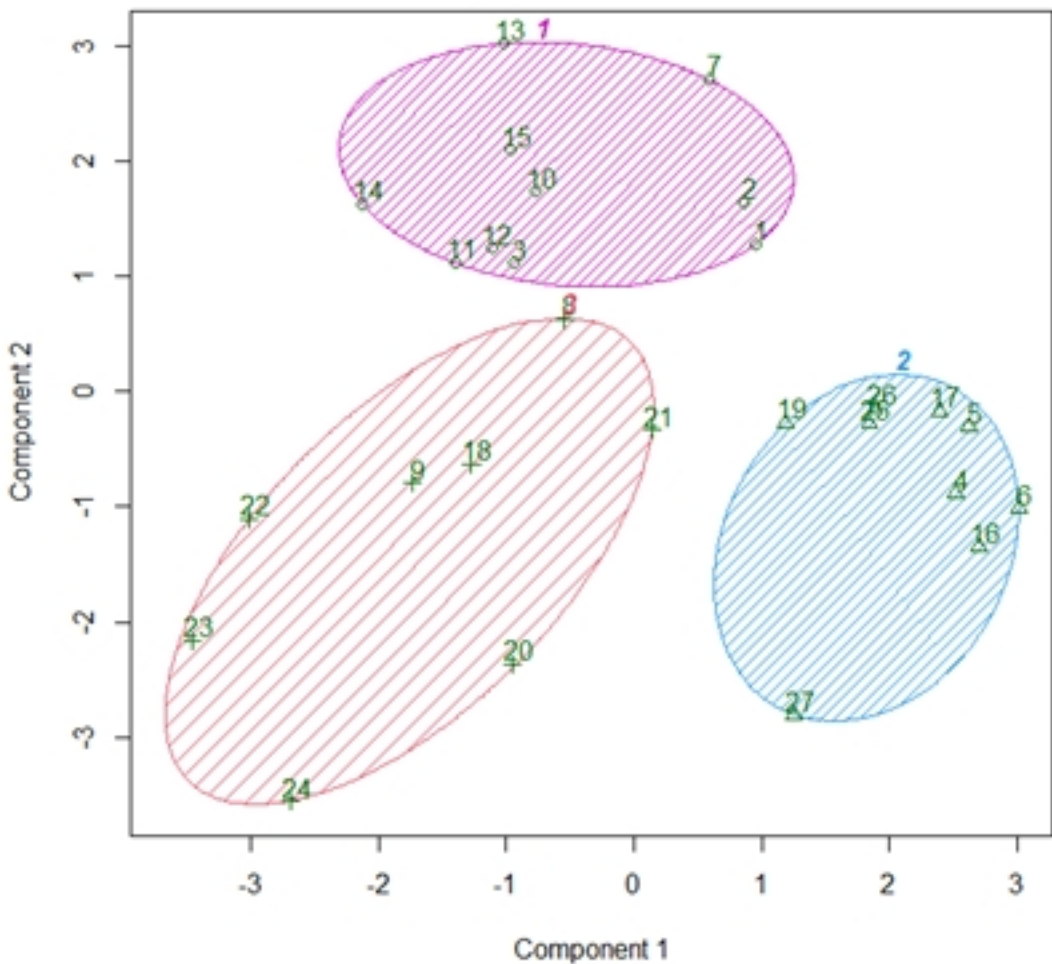
