underdiagnosed.¹ Estimation of the asymptomatic ratio—the percentage of carriers with 2526no symptoms—will improve understanding of 2019-nCoV transmission and the spectrum 27of disease it causes, providing insight into epidemic spread. Although the asymptomatic ratio is conventionally estimated using seroepidemiological data,^{2,3} collection of these 28data requires significant logistical effort, time, and cost. Instead, we propose to estimate 2930 the asymptomatic ratio by using information on Japanese nationals that evacuated from Wuhan, China on chartered flights. 3132Figure 1 illustrates the flow of the evacuation process. 40 Employing a Bayes theorem, the asymptomatic ratio is defined as

 $Pr(asymptomatic \mid infection) = \frac{Pr(infection \mid asymptomatic) Pr(asymptomatic)}{Pr(infection)},$

which can be calculated as m/(n+m), as seen in Figure 1. The asymptomatic ratio is thus estimated at 50.0% (95% confidence interval (CI): 12.5%, 87.5%) among evacuees. Should one of the four becomes symptomatic in the future, the overall asymptomatic
ratio would decrease to 37.5% (95% CI: 12.5%, 75.0%).

48In general, asymptomatic infections cannot be recognized if they are not confirmed by RT-PCR or other laboratory testing, and symptomatic cases may not be 4950detected if they do not seek medical attention. Estimates such as this therefore provide 51important insight by using a targeted population to assess prevalence of asymptomatic 52viral shedding. Despite a small sample size, our estimation indicates that perhaps more 53than a half of 2019-nCoV-infected individuals are asymptomatic. This ratio is comparable to that of influenza, which was estimated at 56-80%³ using similar 5455definitions for symptomatic individuals.
