40 Abstract

Inflammatory markers like C-reactive protein (CRP) have been associated with 41 42 posttraumatic stress disorder (PTSD) and traumatic experience, but the underlying 43 mechanisms are unclear. We investigated the association among CRP, PTSD, and traits 44 related to traumatic events and social support using genome-wide data from the Psychiatric Genomics Consortium (30,000 cases and 170,000 controls), the UK 45 Biobank (UKB; up to 117,900 individuals), and the CHARGE study (Cohorts for Heart 46 47 and Aging Research in Genomic Epidemiology, 148,164 individual). Linkage 48 disequilibrium score regression, polygenic risk scoring, and two-sample Mendelian 49 randomization analyses were used to investigate genetic overlap and causal relationships. Genetic correlations of CRP were observed with PTSD (rg=0.16, 50 p=0.026) and behavioral and emotional response to trauma, exposure to traumatic 51 52 events, and the presence of social support (-0.28<rg<0.20; p<0.008). We observed a 53 bidirectional association between CRP and PTSD (CRP \rightarrow PTSD: β =0.065, p=0.015; 54 PTSD \rightarrow CRP: β =0.008, p=0.009). CRP also showed a negative association on the "felt 55 loved as a child" trait (UKB, β =-0.017, p=0.008). Due to the known association of socioeconomic status (SES) on PTSD and social support, a multivariable MR was 56 57 performed to investigate SES as potential mediator. We found that household income (univariate MR: β =-0.22, p=1.57x10⁻⁷; multivariate MR: β =-0.17, p=0.005) and 58 deprivation index (univariate MR: $\beta=0.38$, $p=1.63\times10^{-9}$; multivariate MR: $\beta=0.27$, 59 60 p=0.016) were driving the causal estimates of "felt loved as a child" and CRP on PTSD. The present findings highlight a bidirectional association between PTSD and CRP 61 62 levels, also suggesting a potential role of SES in the interplay between childhood 63 support and inflammatory processes with respect to PTSD risk.

65 Introduction

66 Posttraumatic stress disorder (PTSD) is a common psychiatric condition that can occur after experiencing or witnessing traumatic events.¹ Inflammatory processes, 67 68 reflected by blood-based markers like C-reactive protein (CRP), could be involved in the biology of the trauma response and PTSD.² CRP is a protein that responds to 69 inflammatory stimuli by triggering cellular reactions such as those related to 70 macrophage recruitment during inflammation initiation.³ Elevated levels of pro-71 inflammatory cytokines (e.g. interleukins; a downstream product of CRP signaling) and 72 acute-phase proteins (e.g. CRP) have been observed in the blood of individuals with 73 74 PTSD.^{4, 5} Meta-analyses of cross-sectional studies have confirmed the association of inflammation with traumatic events and PTSD.^{6,7} Longitudinal studies reported 75 evidence supporting a bidirectional association: elevated inflammation may contribute 76 to PTSD and that PTSD contributes to elevated inflammation.⁸⁻¹³ Additionally, PTSD is 77 78 well-known to be associated with many chronic diseases (e.g., cardiovascular diseases, 79 type-2 diabetes, and rheumatoid arthritis) with an established inflammatory component.¹⁴⁻¹⁶ Understanding the mechanisms underlying the PTSD-inflammation 80 81 association can potentially lead to important translational implications. If inflammation 82 is causal for PTSD, inflammatory markers may be useful in identifying persons at risk, 83 and anti-inflammatory treatments may be therapeutic. If PTSD causes inflammation, 84 this would provide evidence for one pathway via which PTSD increases risk of chronic 85 disease and may support screening for inflammation in persons with PTSD. A third hypothesis is that the relation between inflammation and PTSD is not causal in either 86 87 direction but accounted for by a third factor.

88 Analytic approaches based on large-scale genome-wide datasets may help us to 89 understand how inflammatory processes and CRP levels are related to etiology or 90 consequences of PTSD. Mendelian randomization (MR) can be used to investigate 91 causal relationships using genetic variants (e.g., single nucleotide polymorphisms -92 SNPs) as instrumental variables in genetic epidemiologic experiments analogous to randomized control trials.¹⁷⁻¹⁹ In this context, we investigated the genetic overlap and 93 94 the putative causal relationships linking CRP and PTSD, leveraging large-scale genome-wide datasets from the Psychiatric Genomic Consortium PTSD Workgroup 95 96 (PGC-PTSD), the UK Biobank (UKB), and the Cohorts for Heart and Aging Research 97 in Genomic Epidemiology (CHARGE) study. To investigate more broadly the 98 relationship between trauma and inflammation, we also tested traits related to

99 behavioral and emotional response to trauma, exposure to traumatic events, and the 100 presence of social support. Additionally, since socioeconomic status has a well-101 established relationship with the traits investigated (i.e., PTSD, CRP, traumatic events, 102 and social support),²⁰⁻²² we tested whether the associations observed are independent 103 from the effects that are mediated by socioeconomic status (SES).

105 Materials and methods

106 Cohorts Investigated

107 Genome-wide association data for PTSD were obtained from PGC-PTSD using Freezes 108 1.5 and 2. PGC-PTSD Freeze 2 includes 23,185 cases and 151,309 controls of European 109 descent, including both PGC and UKB samples. PGC-PTSD Freeze 1.5 includes only 110 12,823 cases and 35,648 controls available from PGC samples (i.e., UKB samples were 111 not included in the Freeze 1.5 meta-analysis). We used the PGC-PTSD Freeze 1.5 112 dataset to exclude the potential bias induced by the overlap between PGC-PTSD Freeze 113 2 and UKB samples in the PRS and MR analyses. PTSD diagnosis across PGC-PTSD 114 cohorts was obtained considering different version of DSM criteria (DSM-III-R, DSM 115 IV, DSM-5). A detailed description of the QC criteria and GWAS methods was reported previously.²³ 116

117 To investigate inflammatory processes, we used the genome-wide data generated 118 by the CHARGE Inflammation Working Group, which investigated the genetics of 119 circulatory CRP levels measured via standard laboratory techniques in up to 148,164 120 subjects of European ancestry.²⁴

Additionally, we obtained GWAS summary association data related to trauma 121 122 traits, behavioral and emotional response to trauma, exposure to traumatic events, and the presence of social support from the UK Biobank (UKB)²⁵ included in the category 123 124 "traumatic events" (UKB Field ID: 145). These were assessed via the UKB online mental health questionnaire (up to 118,000 individuals of European descent).²⁶ In 125 126 addition, we investigated indicators of SES, considering "Average total household 127 income before tax" (UKB Field ID: 738, household income) and "Townsend 128 deprivation index at recruitment" (UKB Field ID: 189, deprivation index).²⁷ Details 129 regarding QC criteria and GWAS methods of this previous analysis are available at 130 https://github.com/Nealelab/UK_Biobank_GWAS/tree/master/imputed-v2-gwas.

Briefly, the association analyses for all phenotypes were conducted using regression
models available in Hail (available at https://github.com/hail-is/hail) including the first

20 ancestry principal components, sex, age, age², sex×age, and sex×age² as covariates.
Details regarding the UKB traits investigated in this study are reported in Supplemental
Table 1.

137 Heritability and Genetic Correlation

138 To estimate observed-scale SNP-heritability and genetic correlation among the 139 phenotypes interrogated in this project (PGC-PTSD Freeze 2, CRP, trauma traits, and 140 socioeconomic status traits), we performed Linkage Disequilibrium Score Regression 141 (LDSC) according to the pipeline described previously (available at https://github.com/bulik/ldsc).28 142

We also calculated the heritability z-score, which is defined as the heritability estimate produced by LDSC divided by its standard error. The heritability z-score is able to capture information about the genetic architecture of a trait and the reliability of each heritability estimate. As recommended by LDSC best practice, we conducted genetic correlation analysis only using traits with heritability z-score>4.²⁸ Genetic correlations were adjusted for multiple testing using false discovery rate (FDR), considering Q < 0.05 as the significance threshold.

151 Polygenic Risk Score (PRS) and Definition of the Genetic Instruments

152 PRS were calculated using PRSice v1.25 software (available at 153 <u>http://prsice.info/)²⁹</u> and considering the following parameters: clumping with a linkage 154 disequilibrium (LD) cutoff of $R^2 = 0.001$, 10,000-kb as clumping window, and 155 exclusion of major histocompatibility complex (MHC) region of the genome because of 156 its complex LD structure. European samples from the 1000 Genomes Project were used 157 as the LD reference panel.

To conduct this PRS analysis, we used GWAS summary data from the cohorts described above (PGC-PTSD freeze 1.5 - to avoid sample overlap between PGC-PTSD Freeze 2.0 and UKB). We applied FDR multiple testing correction to correct the p-value for the number of PRS p-value thresholds tested at Q < 0.05.

163 Mendelian Randomization (MR)

We used the R package TwoSampleMR³⁰ to infer the causal relationship between the phenotypes of interest, testing genetic variants (i.e., SNPs) which survived the PRS FDR correction as instrumental variables. This R package permits conducting five MR

analysis: inverse variance weighted (IVW), MR-Egger, weighted median, simple mode,
and weighted mode.³⁰ These methods were considered to verify the stability of the
causal effects of MR results and the IVW approach was reported as the main results due
to its higher statistical power.³¹ The MR analysis was conducted in accordance with the
STROBE (STrenghtening the Reporting of Observational studies in Epidemiology) MR reporting guidelines.³²

Multiple MR sensitivity tests were performed to investigate the presence of 173 horizontal pleiotropy and heterogeneity among the variants included within the genetic 174 instruments tested: MR-Egger regression intercept.³³ MR-PRESSO (Pleiotropy 175 RESidual Sum and Outlier) global test).³⁴ and MR heterogeneity test.³⁵ Outliers 176 contributing to the heterogeneity and horizontal pleiotropy within the genetic 177 instruments were identified via a leave-one-out analysis and considering MR-RAPS 178 (MR-Robust Adjusted Profile Score)³⁶ standardized residuals that fall outside the 95% 179 180 confidence level.

181 Multivariable MR (MVMR) was applied to estimate the effect of two or more 182 traits (risk factors) on a specific outcome (disease) using the multivariable IVW 183 approach available in the MendelianRandomization R package.³⁷

185 Results

186 Genetic Correlation and Polygenic Risk Scores analyses

187 SNP-heritability was estimated for all traits investigated in this study and we 188 found that 4 trauma response traits, 12 trauma exposure traits, and 2 socioeconomic 189 status traits had heritability z-score>4 (Supplemental Table 2). We found a positive 190 genetic correlation between CRP and PTSD diagnosis (PGC-PTSD Freeze 2: rg=0.155, p=0.026). After multiple testing correction (FDR at 5%), we observed significant 191 192 genetic correlation of CRP with seven traits related to behavioral and emotional 193 response to trauma, exposure to traumatic events, and the presence of social support 194 (Figure 1). Positive genetic correlation was also observed between CRP and socioeconomic status: deprivation index, rg=0.20, $p=3.38\times10^{-5}$; household income, rg=-195 0.25, $p=4.08\times10^{-10}$. The direction of the genetic correlations of CRP was in line with 196 expectations: positive genetic correlation with the presence of PTSD, traumatic events, 197 198 and deprivation index; negative genetic correlation with social support and household 199 income.

200 Considering our genetic correlation findings, we conducted bidirectional PRS 201 between CRP and trauma traits, PGC-PTSD Freeze 1.5 case-control status, and 202 socioeconomic traits. After FDR 5% correction for the number of PRS thresholds, we 203 found 12 significant associations (Table 1). The most significant PRS association was 204 observed between household income and CRP ($R^2=0.08\%$; FDR Q-value=7.45×10⁻²⁵).

206 Mendelian randomization (MR)

Based on the PRS findings, we performed two-sample MR to assess the causality among the traits. If heterogeneity or pleiotropy was identified within the genetic instruments, we removed the outlier variants to verify that the causal estimates were not generated by potential biases within the genetic instruments.

211 In our MR analysis, we found evidence supporting several causal relationships 212 among the traits investigated (Figure 2; Supplemental Table 3). Our results suggest a 213 bidirectional association between PTSD and CRP, where genetically determined CRP 214 levels have a causal effect on PTSD (β =0.065, 95% CI: 0.012 to 0.119, p=0.015), and 215 genetic liability to PTSD has a causal effect on CRP (β =0.008, 95% CI: 0.001 to 0.015, 216 p=0.024). We observed the presence of possible heterogeneity in SNPs evaluated in the 217 $PTSD \rightarrow CRP$ association (heterogeneity test p=0.001). However, after removal of the 218 outlier variants from the genetic instrument, the PTSD \rightarrow CRP association remained 219 significant (β =0.008, 95% CI: 0.002 to 0.015, p=0.009).

220 Among the traits related to traumatic events and social support, we observed that 221 CRP also has a negative causal effect on the "Felt loved as a child" trait from UKB (β =-222 0.02, 95% CI: -0.034 to -0.007, p=0.003). However, strong evidence of heterogeneity 223 was present among the variants included in the genetic instrument (heterogeneity test 224 $p=4.26\times10^{-5}$). Removing the variants contributing to heterogeneity within the genetic 225 instrument, we confirmed the CRP-"Felt loved as a child" association (β =-0.017, 95% 226 CI: -0.031 to -0.004, p=0.008). "Felt loved as a child" trait showed a protective effect on PTSD risk (β =-0.139, 95% CI: -0.206 to -0.071, p=5.64×10⁻⁶). However, the genetic 227 228 instrument was affected by heterogeneity (heterogeneity test p 0.002). Removing the 229 variants generating the heterogeneity within the genetic instrument, we confirmed the 230 protective effect of "Felt loved as a child" trait on PTSD (β =-0.19, 95%CI=-0.124 to -0.257, p= 2.1×10^{-8}). 231

We also observed that indicators of SES affect both CRP levels and PTSD risk. Household income showed a negative bidirectional association with CRP (household income \rightarrow CRP β =-0.131, 95% CI=-0.161 to -0.102, p=1.06×10⁻¹⁸; CRP \rightarrow household income β =-0.016, 95% CI=-0.027 to -0.005, p=0.004). Both household income and deprivation index have a causal effect on PTSD (Household income: β =-0.277, 95% CI: -0.312 to -0.142, p=1.57×10⁻⁷; Deprivation index: β =0.389, 95% CI: 0.262 to 0.515, p=1.63×10⁻⁹). The effects were confirmed also after removing outlier variants when heterogeneity or horizontal pleiotropy was observed within the genetic instruments (Supplemental Table 3)

241 Finally, we performed a MVMR analysis to verify whether the causal effects 242 observed among PTSD, CRP, social support, and SES are independent from each other 243 (Figure 3). We confirmed that genetically determined CRP has causal effect on PTSD, independently of the "Felt loved as a child" association (β =0.066, 95% CI: 0.007 to 244 0.126, p=0.029; Figure 3A). However, the CRP \rightarrow PTSD association (univariate MR 245 246 β =0.066, 95% CI=0.013 – 0.119, p=0.015; multivariate MR β =0.043, 95% CI=-0.027 – 247 0.113, p=0.232) was not independent from the effect of deprivation index (Deprivation 248 index \rightarrow PTSD: univariate MR: β =0.38, p=1.63×10⁻⁹, 95% CI=0.263 – 0.516; multivariate MR β =0.27, p=0.016; 95% CI= 0.050 – 0.498; Figure 3B) and household 249 250 income (Household income \rightarrow PTSD: univariate MR β =-0.22, 95% CI=-0.312 - -0.142, $p=1.57 \times 10^{-7}$; multivariate MR $\beta=-0.17$, 95% CI=-0.294 – 0.051, p=0.005; Figure 3C). 251

253 Discussion

We used genome-wide data to investigate the genetic overlap and the causal mechanisms between CRP levels and PTSD, also considering the effects of SES, traumatic experiences, and social support. Our findings indicate that there is bidirectional association between PTSD and CRP levels, which appears to be strongly affected by SES.

259 CRP is a protein that responds to inflammatory stimuli by triggering cellular 260 reactions and it is normally induced through pro-inflammatory cytokines, mainly by interleukin-6 secretion.^{38, 39} CRP may be produced in the microvessel endothelial cells 261 262 that form the blood-brain-barrier, and peripheral CRP can affect the central nervous 263 system via mechanisms of blood-brain barrier disruption associated with elevated levels of peripheral inflammatory cytokines.^{40, 41} Higher levels of pro-inflammatory cytokines 264 265 may influence neurotransmission, leading to altered production of serotonin, 266 norepinephrine, dopamine and brain-derived neurotrophic factor. This effect on levels 267 of neurotransmitters may be associated with specific psychiatric symptoms, such as

anhedonia.⁴² Furthermore, these cytokines may influence the neurocircuitry, causing 268 alterations in motivation status, and anxiety, arousal, and alarm response.⁴³ Twin and 269 family studies estimated that heritability of CRP is around 35%-40%.²⁴ Several 270 271 environmental factors, such as sociodemographic variables, dietary habits, behavioral and lifestyle factors, are also strongly associated with CRP level.⁴⁴ Previous cross-272 sectional and longitudinal studies highlighted the presence of a bidirectional association 273 between PTSD and CRP levels.⁶⁻¹³ Our findings confirm this scenario. However, we 274 also observed that the CRP-PTSD association is not independent from SES (i.e. high 275 276 deprivation index and low household income). The effect of SES on CRP levels was previously observed in studies highlighting the association of increased CRP levels with 277 low SES and traumatic childhood experiences.⁴⁵ In addition, low SES has been 278 associated with DNA methylation of genes involved in inflammation, suggesting that 279 280 alterations in epigenetics of specific genes might influence the inflammation response leading to increased inflammatory markers.^{46, 47} 281

282 A recent GWAS of social stratification in Great Britain showed that genetic 283 factors related to socio-economic status (educational, income, employment) are associated with a wide range of physical and mental health outcomes.⁴⁸ Lower 284 economic status might be a mediator of the negative association between educational 285 attainment and PTSD.⁴⁹ In line with these previous findings, we found that SES might 286 287 affect the interplay among inflammatory processes (i.e., CRP level), PTSD, and 288 childhood social support. This confirms that SES may affects several of the comorbid 289 traits associated with PTSD.

Furthermore, we found that "Felt loved as a child" was a protective factor with 290 291 respect to genetic liability to PTSD and CRP levels. Social support systems have been 292 considered as an important protective factor for mental health and well-being of 293 individuals, and refer to social interaction which involves love, care, respect, affection, acceptance, and financial assistance.^{50, 51} Social support might influence trauma 294 295 perception and cognitive processes and consequently reduce the risk to develop 296 psychiatric disorders. Individuals with low social support had worse prognosis of PTSD.^{52, 53} Additionally, high levels of social support were associated with reduced 297 CRP levels.54,55 298

Although we present novel results contributing to understand the association among PTSD, CRP levels, traumatic events, and social support, our study has several limitations. Our analyses focused on CRP levels only, because no large-scale GWAS

302 has investigated other inflammatory biomarkers. Further studies will be needed to verify 303 whether the same effects are present across inflammation-related molecules such as IL-304 6. The analyses were conducted using GWAS in subjects of European ancestry, thus we 305 cannot generalize these results to other populations. The magnitude of estimates for the 306 effect of CRP on PTSD is relatively small, which may indicate a minor contribution of 307 the associations reported in the biology of PTSD. The genetic information about PTSD 308 and trauma traits were obtained across different cohorts, which may cause heterogeneity 309 in the outcomes related to stress exposition. The datasets investigated were generated 310 from participants assessed using different instruments, also including online 311 questionnaires. Although this approach was needed to collect information from a large cohort and the online instruments were validated,²⁶ this may have affected the quality of 312 313 the data collected.

In conclusion, this study is the first analysis leveraging large-scale genome-wide datasets to investigate the underlying mechanisms linking CRP, PTSD, and traumatic experiences. Our findings support a bidirectional association between PTSD and CRP, which appears to be strongly affected by SES. Additionally, SES traits seem to also mediate the interplay among CRP levels, PTSD, and childhood emotional support.









Figure 2: Significant two-sample MR results.
