Association of previous medications with the risk of COVID-19: a nationwide claims-

based study from South Korea

#### Abstract

**Background.** Re-purposing of existing drugs for the treatment of COVID-19 might be an effective alternative during the pandemic.

**Objective.** To determine the association of the risk of COVID-19 and the drugs which have been suggested to have therapeutic effects against or increase the susceptibility to SARS-CoV-2.

**Design.** A case control study using a nationwide claims database. Exposure was defined as a prescription of study drugs which would have been continued until 7 days prior to test for COVID-19 or later.

**Setting.** South Korea, where a large testing capacity was available throughout the course of the epidemic.

**Participants.** Adults aged 18 years or older who were tested for COVID-19.

**Measurements.** The diagnosis of COVID-19.

**Results.** Among 65,149 subjects included (mean age, 48.3 years; 49.4% male), 5,172 (7.9%) were diagnosed of COVID-19. Hydroxychloroquine showed no significant association with the risk for COVID-19 (adjusted odds ratio [aOR], 1.48; 95% CI, 0.95–2.31). Camostat (aOR, 0.45; 95% CI, 0.20–1.02) and amiodarone (aOR, 0.54; 95% CI, 0.33–0.89) were associated with a lower risk for COVID-19 in overall population, but the difference did not reach statistical significance in subgroup analysis. Angiotensin receptor blocker was associated with a small increase in the risk (aOR, 1.13; 95% CI, 1.01–1.26), which was not observed in subgroup analysis.

**Limitations.** A possibility of bias in the characteristics of controls; information on drug compliance and the severity of underlying conditions could not be obtained.

**Conclusions.** No medications included in our study was consistently associated with a risk for COVID-19. These findings suggest that more cautious approach is warranted for the clinical use of re-purposed drugs until the results from clinical trials are available.

## Introduction

Coronavirus disease (COVID-19) is a novel infectious disease caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) that has spread worldwide since the first reported case in late 2019. The relatively large proportion of mildly symptomatic cases and early high viral shedding has undermined the effectiveness of the classic "identify and isolate" strategy. Many countries have resorted to massive social distancing to slow the spread of this disease, although a surge of patients has overwhelmed healthcare systems in several countries. Most patients with COVID-19 have a mild course of the disease, although respiratory failure and death are more common among older people or people with underlying conditions.<sup>2-4</sup> Novel antiviral agents or an effective vaccine will not be available in the near future, and there is significant interest in repurposing medications that are used for other indications.<sup>5</sup> Hydroxychloroquine (HCQ) and lopinavir/ritonavir are drugs with promising results from preclinical studies, and some clinical data have been recently reported. Other agents are reportedly effective in vitro against the coronaviruses that cause severe acute respiratory syndrome or Middle East respiratory syndrome, although there is no high-quality clinical evidence to support the use of those agents for treating COVID-19. Host cell entry of SARS-CoV-2 requires angiotensin-converting enzyme 2 (ACE2).<sup>6</sup> The action of ACE2 is not directly affected by ACE inhibitors (ACEIs) and angiotensin receptor blockers (ARBs), which are commonly used anti-hypertensive agents, although these drugs reportedly lead to increased expression of ACE2 in various tissues. <sup>7,8</sup> Thus, there is controversy regarding whether treatment using ACEIs or ARBs might increase the host's susceptibility to SARS-CoV-2 infection and COVID-19. Furthermore, some argue that ACEI/ARB might reduce the risk of respiratory failure, as the downregulation of ACE2 is reported to correlate with severity of lung injury.<sup>9</sup>

Although well-designed randomized trials are needed to address these issues, it takes time to perform those trials and report the results. Therefore, controversy persists regarding the potential harm that may be associated with use of unproven drugs for treating COVID-19. Carefully curated and reliable data from a large cohort may be a useful alternative for the time being. Thus, we conducted a case-control study to evaluate the relationships between various medications and the risk of COVID-19 using a nationwide medical insurance claim database from the Republic of Korea.

#### **Methods**

Data source

We extracted information from the Korean Health Insurance Review & Assessment Service (HIRA) database. The HIRA is a quasi-governmental agency that reviews all claims made to the National Health Insurance Service, which is the universal single payer for healthcare in Korea. All reimbursement claims for COVID-19 tests in suspected cases are sent for review by the HIRA (Figure 1). Claims for COVID-19-related testing are made using a special "public crisis" code (MT043), and reimbursement for confirmed cases are claimed based on the International Classification of Diseases and Related Health Problems, 10th edition (ICD-10) codes for COVID-19 (B34.2, B97.2, U18, U18.1, and U07.1). We identified all tested individuals within national health insurance services coverage who were ≥18 years old using the code MT043. Among these individuals, the cases were defined as individuals with ICD-10 codes for COVID-19 and the remaining individuals were categorized as the controls ("test-negative" controls). The last date of data entry was April 8, 2020.

This study's retrospective protocol was approved by the institutional review board of the Gil Medical Center, Gachon University College of Medicine and Science (GFIRB2020-118).

Study design and definitions

This retrospective case-control study evaluated the risk of COVID-19 according to the use of various pharmaceutical agents. Exposure was defined as the prescription of medications that would have been continued until ≤7 days before the testing for COVID-19. Drugs of interest were selected from a list of pharmaceutical agents with reported inhibitory effects against SARS-CoV-2 infection in preclinical studies, as well as agents with theoretical concerns regarding an increased risk of COVID-19 (Appendix Table 1). Two authors (KH and WJ) reviewed the literature and selected the drugs of interest, and any disagreement was arbitrated by a third author (JJ). The maximum interval of 7 days between the prescription ending and COVID-19 testing was selected to account for the incubation period and delays in diagnosis. A preplanned subgroup analysis on the patients tested and treated in Daegu/Gyeongsangbukdo province (DG) was conducted, as a large regional outbreak occurred in this area which led to a higher risk of community transmission. 10 Comorbidities were categorized into disease groups (Appendix Table 2) and identified using ICD-10 codes that were entered at least twice within the 5 years before the COVID-19 tests. The Charlson comorbidity index (CCI) was calculated as previously described. 11 Healthcare utilization was evaluated based on the number of hospitalizations, the number of outpatient visits, and the number of emergency room visits within 1 year before the tests for COVID-19.

## Statistical analysis

The baseline characteristics of the cases and controls were compared using the  $\chi^2$  test or Student's t test, as appropriate. Exposures to the drugs of interest were compared using logistic regression models with sex, age, region of residence, comorbidities, healthcare utilization, and other drugs of interest as covariates. All tests were two-tailed and results were considered statistically significant at p-values of <0.05. All analyses were performed using

SAS software (version 9.4; SAS Institute Inc., Cary, NC, USA).

## **Results**

We identified 65,149 subjects who were tested for COVID-19, including 5,172 patients (7.9%) who were diagnosed with COVID-19 (Table 1). The mean age was 48.3 years (range, 18–110 years), and 49.4% of the patients were male. The most common comorbidities were chronic lung diseases (50.9%), chronic liver diseases (44.0%), hypertension (32.8%), and diabetes (27.6%). Relative to the controls, the cases had a significantly lower mean age (44.6 years vs. 48.6 years, p<0.001) and a significantly lower proportion of male patients (44.3% vs. 48.7%, p<0.001). The controls had more comorbidities and a higher mean CCI (1.4 vs. 1.8, p<0.001), as well as more frequent hospitalizations, outpatient visits, and emergency department visits. A total of 8,888 subjects were tested in DG province, where a regional outbreak occurred, and the test positivity rate in this subgroup was 15.0% (n=1,335). Relative to the overall population, the cases' and controls' baseline characteristics were more similar in the DG province subgroup. There were no significant differences between the DG cases and controls in terms of mean CCI (1.9 vs. 1.9, p=0.760) and the prevalences of diabetes, hypertension, chronic heart diseases, and malignancy. However, the controls still had higher proportions of chronic lung diseases (44.8% vs. 49.9%, p<0.001), chronic liver diseases (45.7% vs. 50.3%, p=0.002), and chronic neurological diseases (24.5% vs 27.8%, p=0.013). The cases had a higher rate of chronic kidney diseases (19.2% vs. 12.0%, p<0.001).

Drugs with potential effect against SARS-CoV-2

The following drugs were included after a literature review: HCQ, camostat, statins, sirolimus, mycophenolate, amiodarone, and direct antiviral agents for hepatitis C (HCV DAA). We did not include lopinavir/ritonavir and other protease inhibitors, as the expected

number of HIV cases would be too small to accurately analyze, given the prevalence of HIV infection in Korea. In the overall population, the rates of HCQ prescription were 0.44% among the cases and 0.42% among the controls (Table 2 and Appendix Table 3). No significant association between HCQ use and COVID-19 was observed in the crude analysis (odds ratio [OR], 1.07; 95% confidence interval [CI], 0.69–1.63; p=0.774), although HCQ was marginally associated with a higher risk of COVID-19 in the multivariable analysis (OR, 1.48; 95% CI, 0.95–2.31; p=0.086). The association was more significant and the effect size was larger among subjects from DG province (Table 3). Confirmed cases of COVID-19 were more likely to have been prescribed HCQ in both the crude analysis (OR, 1.99; 95% CI, 1.08-3.67; p=0.029) and the multivariable analysis (OR, 2.53; 95% CI, 1.30–4.96; p=0.007). In contrast, camostat was marginally associated with a lower risk of COVID-19 in the overall population (adjusted odds ratio [aOR], 0.45; 95% CI, 0.20–1.02; p=0.054). The confidence intervals were too broad to confirm the association in the multivariable analysis of the DG province subgroup, although the effect size remained stable. Controls were more likely to be on prescription for statins, but there was no significant difference in adjusted analyses in both populations. Sirolimus was not associated with the risk of COVID-19 in the overall population, and the sample of sirolimus users in the DG province was too small for comparison. Mycophenolate was also not associated with the risk of COVID-19 in the overall population, but was non-significantly related to an increased risk of COVID-19 in the DG province subgroup. Interestingly, amiodarone was associated with a significantly decreased risk of COVID-19 in the overall population (aOR, 0.54; 95% CI, 0.33–0.89; p=0.015), although this association was not observed in DG province (aOR, 0.89; 95% CI, 0.42–1.88; p=0.762). The use of HCV DAA was observed for 0.01% of the controls and none of the patients in the overall and DG populations, which was too small a sample for a meaningful comparison. Drugs with no expected benefit, including non-steroid anti-inflammatory drugs,

proton pump inhibitors, and N-acetylcysteine, were associated with decreased risk for COVID-19. However, no significant difference was observed when a more strict definition for drug use requiring prescription for ≥30 days during the last 6 months was used (Appendix Tables 4 and 5).

Drugs with hypothetical concerns regarding an increased risk of COVID-19

After statins, ARBs were the second most commonly prescribed medications (15.4% of the subjects). Although the cases were less likely to receive ARBs (OR, 0.80; 95% CI, 0.74–0.87; p<0.001), ARB use was associated with a higher risk of COVID-19 after adjusting for comorbidities and other concomitant medications (aOR, 1.13; 95% CI, 1.01–1.26; p=0.034). However, the difference did not reach statistical significance in subjects in DG area (aOR, 1.17; 95% CI, 0.95–1.44; p=0.148). The use of ACEIs was much less common (1.0%, n=653), and ACEI use was not significantly associated with COVID-19. The controls were more likely to receive oral hypoglycemic agents (metformin and thiazolidinediones) and statins, although these drugs were not significantly associated with the risk of COVID-19 in the multivariable analyses.

# Discussion

This large case-control study evaluated Korean health insurance claims and revealed that no drugs were consistently associated with the risk for COVID-19. However, camostat was associated with a marginally reduced risk of COVID-19. In this context, SARS-CoV and SARS-CoV-2 engage ACE2 as the receptor for host cell entry, with the spike (S) protein of coronavirus binding to ACE2. 6,12 In this process, S protein must be primed by host cell proteinases, which include a serine protease known as TMPRSS2. 13,14 Camostat mesylate is a serine protease inhibitor that is approved for treating chronic pancreatitis in Korea and Japan.

A recent *in vitro* study demonstrated that camostat, which is a known inhibitor of TMPRSS2, blocks the entry of SARS-CoV-2 into lung cells, and our results suggest that camostat might be a useful therapeutic agent for COVID-19.<sup>6</sup> Results from ongoing clinical trials will provide more evidence regarding its potential effect against SARS-CoV-2 infections. Nafamostat mesylate is a similar serine protease inhibitor that has also been used in an injectable formulation for pancreatitis and as a short-acting anticoagulant in Korea and Japan. Clinical trials have been proposed for critically ill patients with COVID-19 who cannot take oral medications.

Chloroquine (CQ) has been used for treating malaria since the 1940s and has also been used for the treatment of connective tissue diseases including rheumatoid arthritis and systemic lupus erythematosus (SLE). CQ reportedly inhibits the SARS-CoV-2 in vitro by inhibiting glycosylation of host receptors and endosomal acidification. <sup>15,16</sup> In China, CQ and HCQ have been recommended for treating COVID-19 and a small trial indicated that HCQ treatment led to a faster negative conversion of viral shedding. <sup>17,18</sup> However, more recent studies have suggested a lack of clinical benefit and even the possibility of poorer outcomes. 19-21 Furthermore, the interest in CQ/HCQ has raised concerns regarding cardiac toxicity and drug shortages for patients who require these drugs for other conditions.<sup>22</sup> CO is not available in Korea and HCQ is used for same indications. The present study revealed that HCQ use was not associated with a lower risk of COVID-19 in the overall population, and HCQ use was actually associated with a higher risk of COVID-19 in DG province, where the cases and controls had similar proportions of comorbidities. Therefore, our results and those of the recent clinical studies suggest that HCQ does not have a significant clinical effect against SARS-CoV-2 infection, although the results from ongoing randomized controlled trials are needed clarify its effect.

Statins, which are also known as HMC-CoA reductase inhibitors, may play a therapeutic role by reducing endothelial dysfunction by affecting ACE2 expression.<sup>23</sup> The present study revealed that statin use was significantly less common among the cases than among the controls. However, there was no difference in the risk of COVID-19 after adjusting for demographic factors and comorbidities.

Sirolimus, mycophenolate, and amiodarone reportedly had inhibitory effects against SARS-CoV and/or MERS-CoV in preclinical studies.<sup>24-26</sup> However, the present study failed to detect significant protective effects for those drugs, albeit amiodarone showed a reduced risk for COVID-19 in overall population.

The ACEI and ARB inhibit the activity of ACE1, which is a homolog to ACE2 but is not used by SARS-CoV for host cell entry.<sup>27</sup> However, several studies have shown that ACEIs/ARBs upregulate the expression of ACE2, which is reportedly correlated with susceptibility to SARS-CoV infection in vitro. 7,8,28,29 Thus, concerns were raised regarding the theoretical risk for COVID-19 in patients taking ACEI/ARB. In contrast, other reports have indicated that high serum levels of angiotensin II and downregulation of ACE2 expression may be related to lung injury by respiratory viral infections. 30,31 Therefore, ACEI/ARB has a theoretical possibility to decrease the risk for severe infection by SARS-CoV-2. However, there is no evidence that ACEI/ARB are associated with clinical outcome in either way. Major societies recommended that patients continue taking those anti-hypertensives as prescribed. <sup>27,32</sup> The present study is unable to support a clear conclusion regarding ACEI/ARB use, as the risk of COVID-19 was higher in the multivariable analyses for the overall population and the DG province subpopulation, although the difference was only significant in the overall population. A recent retrospective study of 1,128 patients with COVID-19 and hypertension revealed that inpatient use of ACEIs/ARBs was associated with a lower risk of mortality.<sup>33</sup> Considering the proposed theoretical mechanism of ACEI/ARB interacting with the pathogenesis of COVID-

19, it is possible that ACEIs/ARBs have different effects during the initial SARS-CoV-2 infection and the subsequent inflammatory stage. Further studies are needed to understand the risks of SARS-CoV-2 infection among patients with hypertension.

Our study has several strengths. First, South Korea rapidly established a large testing capacity and has successfully contained the outbreak, which suggests that it is unlikely that a large number of COVID-19 cases were missed. Also, we were able to use "test-negative" controls owing to the vast testing capacity. Thus, our findings might not be replicated in other countries with more limited testing capacities, where testing cannot be offered to all patients with acute respiratory infections. Second, the single-payer universal healthcare system in Korea ensures that we had reliable data regarding medication use and comorbidities. Given that there is near-complete coverage for common illnesses, only an extremely small proportion of cases would not have data regarding the drugs of interest. Last, we used the diagnosis of COVID-19 as an outcome. In contrast, most recent studies regarding medications and COVID-19 have compared the risk of a severe clinical course among COVID-19 patients.

The present study also has several limitations. First, our design was vulnerable to bias in the characteristics of "test-negative" controls. Controls were older and had more comorbidities in our study, and we suspect that older people with underlying conditions had higher chance of developing acute respiratory symptoms which led to vigorous testing. However, we conducted robust multivariable analyses and a subgroup analysis on DG area where the risk of community transmission was substantially higher. Second, the use of claims data precludes an analysis of prescription compliance or the accuracy of comorbidity diagnoses. Third, we could not obtain data regarding the severity of the underlying conditions, performance status, and socioeconomic characteristics. Last, some drugs were prescribed infrequently and the small sample sizes limited the statistical power of the related analyses.

In conclusion, we observed that no medications were consistently associated with the risk for COVID-19. Camostat and amiodarone might be associated with lower risk, which warrants further studies. However, the use of HCQ, ACEIs/ARBs, or statins was not associated with a significant change in the risk of COVID-19. Our findings suggest that repurposing these pharmaceutical agents may not provide significant clinical benefits for the patients with COVID-19. Clinical trials are needed to generate high-quality evidence regarding the efficacy of these agents in this setting.


