

Multiethnic genome-wide association study of differentiated thyroid cancer in the EPITHYR consortium

Abstract

Incidence of differentiated thyroid carcinoma (DTC) varies considerably between ethnic groups, with particularly high incidence rates in Pacific Islanders. Here, we conducted a genome-wide association study (GWAS) involving 1,554 cases/1,973 controls of European ancestry and 301 cases/348 controls of Oceanian ancestry from the EPITHYR consortium. Our results confirmed the association with the known DTC susceptibility loci at 2q35, 8p12, 9q22.33 and 14q13.3 in the European ancestry population and suggested two novel signals at 1p31.3 (rs334729) and 16q23.2 (rs16950982), which were associated with TSH levels in previous GWAS. We additionally replicated an association with 5p15.33 reported previously in Chinese and European populations. Except at 1p31.3, all associations were in the same direction in the population of Oceanian ancestry. The frequencies of risk alleles at 2q35, 5p15.33 and 16q23.2 were significantly higher in Oceanians than in Europeans and may explain part of the highest DTC incidence observed in Oceanians.

INTRODUCTION

The incidence of thyroid cancer was estimated to be 567,233 new cases worldwide in 2018, representing 3.1% of all cancers (1). Papillary thyroid carcinoma (PTC) and follicular thyroid carcinoma (FTC) are the most frequent types of differentiated thyroid carcinomas (DTC) accounting for about 90% of all thyroid cancers. The incidence of DTC is characterized by 3-4 times higher rates in women than in men and wide geographic and ethnic variations (1,2). The highest incidence rates in 2018 were estimated in North America, Pacific Islands and Eastern Asia (1). In some multi-ethnic populations such as in New Caledonia or New Zealand, higher rates were reported in Pacific Islanders than in other ethnic groups (3–5). The causes underlying these geographic and ethnic variations are still unknown and a role for environmental and genetic factors is suspected. During the last decades, the incidence of DTC has increased in most high-resource countries (6).

Part of the increase in incidence has been attributed to changes in medical screening practices that enhance the detection of micro-PTC (≤ 1 cm in diameter) that are of minimal clinical relevance. It has also been suggested that changes in environmental and lifestyle risk factors may contribute to this increase (7). Apart from exposure to ionizing radiation during childhood, a well-established risk factor for DTC (8), increased DTC risk has also been consistently associated with obesity (9–12). Other risk factors such as deficient or excess iodine intake (13,14) or some reproductive and menstrual factors (15) are suspected to play a role in the etiology of DTC. By contrast, several studies have reported an inverse association between DTC risk and cigarette smoking (16), alcohol intake (17) or oral contraceptive pills (18–20).

DTC is also one of the cancers with the highest familial risk (21), suggesting a major role of genetic risk factors. However, only a few susceptibility loci have been identified thus far by genome-wide association studies (GWAS) (22–29), with limited sample size. All previous GWAS, except one, were conducted in European descent populations and highlighted four susceptibility loci at 2q35, 9q22.33, 8p12 and

14q13.3 that were subsequently widely replicated in diverse populations (30–34). One of these GWAS was conducted in Belarus and focused on radiation-related PTC by including individuals aged under 18 years old at the time of the Chernobyl accident. This study highlighted no other signal than the one at locus 9q22.33. One GWAS was conducted in a population of Asian ancestry in Korea and in addition to the same four previously reported loci identified in populations of European ancestry, reported six other genomic regions at 1p13.3, 1q42.2, 3p14.2, 4q21.1, 12q14.3 and 19q13.2 (29). More recently, a meta-analysis of five GWAS that included 3,001 cases and 287,550 controls of European ancestry (28) reported five new susceptibility loci at 1q42.2, 3q26.2, 5q22.1, 10q24.33 and 15q22.33. However, to our knowledge findings from this meta-analysis have not been replicated in an independent sample.

In order to assess the contribution of known DTC susceptibility loci and to identify new ones in individuals of European ancestry and in individuals of Oceanian ancestry from Pacific Islands, we conducted a multiethnic GWAS in unexplored case-control studies from the EPITHYR consortium.

RESULTS

Genome-wide analysis

A total of 1,554 cases and 1,973 controls of European ancestry and 301 case and 348 control individuals of Oceanian ancestry from seven case-control studies were included in the analyses (**Supplementary Table 1**). The study sample included more than 80% women and most of the participants were younger than 50 years old in both ethnic groups. European cases mostly developed PTC, with a higher proportion of tumors larger than 10 mm, while papillary microcarcinomas were more frequent in Oceanian cases (**Table 1**). We performed a GWAS separately in each ethnic group and identified significant variants (i.e. reaching the genome-wide significance P-value threshold of 5×10^{-8}) at loci 1p31.3, 2q35, 8p12, 9q22.33

and 14q13.3 in Europeans, and none in Oceanians (**Figure 1**). There was no indication of genomic inflation in both GWAS ($\lambda = 1.02$ in Europeans and $\lambda = 1.04$ in Oceanians, **Supplementary Figure 1**) suggesting no confounding by cryptic population structure. In the pooled analysis combining both populations (inflation factor $\lambda = 1.08$), no additional loci were highlighted and the association at locus 1p31.3 became non-significant (**Supplementary Figure 2**). We also conducted an analysis restricted to PTC cases in Europeans and observed a strengthened association at locus 8p12, but no additional signal was evidenced (**Supplementary Figure 3**).

For each significant locus, we report the association with the SNP with the smallest P-value in the genomic region (lead SNP) according to the European GWAS in **Table 2**. Except at 1p31.3, the associations with these SNPs were in the same direction in Oceanians.

Known loci

DTC susceptibility loci at 2q35, 8p12, 9q22.33 and 14q13.3 have been highlighted in previous GWAS conducted in Europeans. Lead SNPs at 2q35, 9q22.33 and 14q13.3 in the present study were the same or highly correlated with those reported in the published meta-analysis of GWAS on DTC (28) (**Supplementary Table 2**). At 8p12, the SNP rs142450470 in the present study (OR=1.33, 5×10^{-7} for DTC, OR =1.36, $P=1.8 \times 10^{-8}$ for PTC in Europeans) was moderately correlated with rs2439302 highlighted by previous GWAS (22,24) ($r^2=0.45$, OR=1.19, $P=4.8 \times 10^{-4}$ in our study) (**Supplementary Table 2**). The conditional analysis of rs142450470 on rs2439302 gave an OR=1.32 with $P = 1.3 \times 10^{-4}$, whereas the conditional analysis of rs2439302 on rs142450470 provided an OR=1.01, $P=0.97$, suggesting a single signal at this locus.

Stratified analyses by histology showed that the association with rs1588635 at 9q22.33 was stronger for PTC, in particular of size >10 mm, while the association with rs142450470 at 8p12 was specific to PTC (**Supplementary Figure 4**).

Replication of the novel locus at 1p31.3

The lead SNP at 1p31.3, rs334729 lies in intron 3 of the *NF1A* gene (**Supplementary Figure 5.a**). This gene encodes a member of the NF1 (nuclear factor 1) family of transcription factors, and NF1 isoforms were shown to interact with thyroid transcription factor 1 (TTF-1) to regulate cell function in experimental studies (35). This locus was previously reported in a GWAS on thyroid stimulating hormone (TSH) levels (24,36) but not in GWAS on DTC. We conducted a replication analysis of rs334729 using data from two independent case-control studies conducted in Ohio (USA) (28) and Italy (25) totaling 2,270 cases and 2,125 controls and the association was nominally replicated ($P=0.03$) with the association in the same direction, but with significant heterogeneity between the three studies ($P\text{-heterogeneity}=8.6\times 10^{-3}$) (**Supplementary Table 3**). Rs334729[C] is highly correlated with rs334725[C] ($r^2=0.93$) which has been found associated with decreased TSH levels in a GWAS conducted in an Islandic population (effect of rs334725 [C] = -0.13, $P=1.0\times 10^{-20}$) (24). In that study, rs334725[C] was additionally analyzed in association with DTC in four studies which reported an increased risk ($OR=1.30$, $P=6.6\times 10^{-3}$ for rs334725 [C]). We combined the results from these four studies with our findings in Europeans ($OR=1.89$, $P=1.4\times 10^{-7}$ for rs334725[C]) in a meta-analysis and found an $OR=1.52$, $P=6.1\times 10^{-8}$ (**Supplementary Table 4**) which was at the limit of the significance level.

Replication of suggestive loci

All chromosomal regions with at least two SNPs associated with DTC at suggestive level $P\text{-value}<10^{-5}$ in the GWAS conducted in Europeans (**Supplementary Table 3**) or in the pooled GWAS (**Supplementary Table 5**) were considered for replication. Due to the lack of replication sample, we did not attempt to replicate our findings in the Oceanian population. In addition to the known loci at 2q35, 8p12, 9q22.33, 14q13.3 and the novel locus 1p31.3, we identified 9 loci in Europeans and 11 loci in the pooled analysis

corresponding to these criteria. The lead SNPs at each locus of interest were analyzed in the replication sample, and only variants at 5p15.33, 16q23.2 and 19p12 were associated with DTC at a nominal P-value <0.05 (**Supplementary Table 3** and **Supplementary Table 5**). For these SNPs, we report the results of the combined analysis of the three studies in European and the association in Oceanians in **Table 3**.

Only the variants at 16q23.2 (rs16950982 and rs17767383) reached the genome-wide P-value threshold of 5×10^{-8} in the meta-analysis. Association with rs16950982[G] was in the same direction in both ethnic groups, while we observed opposite effects for the effect allele [A] of rs17767383 (**Table 3**). These two variants were in strong linkage disequilibrium (LD) in Europeans ($r^2=0.88$), but only in weak LD in Oceanians ($r^2=0.37$), and were located in an intergenic region close to the proto-oncogene *MAF* encoding a transcription factor (**Supplementary Figure 5.c**). Interestingly, rs16950982[G] was correlated with rs3813582[C] ($r^2=0.88$) which was previously associated with decreased TSH levels ($\beta=-0.082$, $P=8.45 \times 10^{-18}$) with a male-specific effect (36) also observed in our study on DTC (**Supplementary Figure 4**). Rs16950982[G] is also in LD with rs17767419[T] ($r^2=0.88$) which was associated with increased thyroid volume ($\beta=0.068$, $P=9.4 \times 10^{-15}$) (37). According to GTEx Portal (<https://www.gtexportal.org/home/>), rs16950982[G] and rs17767383[A] are significantly associated with lower expression of *MAFTRR* in many tissues including thyroid tissue (respectively $\beta=-0.55$, $P=2.8 \times 10^{-36}$ and $\beta=-0.60$, $P=2.7 \times 10^{-43}$) and this gene is suspected to have a tumor-suppressor function (38).

At 5p15.33, we nominally replicated results for rs7726159 located in intron 3 of *TERT* (**Supplementary Figure 5.b**), but the combined association did not reach the GWAS significance threshold ($P=4.9 \times 10^{-6}$) (**Table 3, Supplementary Table 4**). We found that the associations in both ethnic groups were in the same direction but the allele frequency differed greatly, with a higher frequency of the risk allele [A] in the Oceanian ancestry population. In the meta-analysis of DTC GWAS in an European population (28), the best hit reported at 5p15.33 was for rs10069690[T] ($OR=1.20$, $P=3.2 \times 10^{-7}$), which was moderately correlated with our lead SNP rs7726159 ($r^2=0.46$). Interestingly, another study conducted in a Chinese

population (39) and analyzing 15 haplotype-tagging SNPs in the *TERT-CLPTM1* region reported an increased risk of PTC with rs2736100[G], which is highly correlated with rs7726159[A] in Asians ($r^2=0.92$ in 1000 genomes CHB population), but only moderately correlated in European populations ($r^2=0.43$ in 1000 genomes CEU population). Rs7726159[A] was also previously associated with increased telomere length in European (40) and Asian (41) populations, as well as with risk of multiple cancers including breast and ovarian cancers (40,42). This variant was also shown to enhance *TERT* transcription (41). At 19p12, we reported an association with rs10415826 ($P=8.7 \times 10^{-7}$) (**Table 3**), in intron 1 of *ZNF257* (**Supplementary Figure 5.d**). Little is known about the function of this gene encoding a transcription factor from the zinc finger family and to our knowledge, no association with other traits has been reported so far with this variant.

Replication study of hits identified in a previously published meta-analysis of GWAS on DTC

The meta-analysis of DTC GWAS conducted by Gudmundsson et al. (28) identified five susceptibility loci at 1q42.2, 3q26.2, 5q22.1, 10q24.33 and 15q22.33, but the authors could not replicate these results in an independent sample. Here, we conducted a replication analysis of the lead SNPs at these loci and observed association with DTC in the same direction in Europeans for all SNPs; for SNPs at 1q42.2, 5q22.1 and 10q24 the P-values were <0.001 . In Oceanians, associations with these SNPs were all in the opposite direction and none were significant (**Supplementary Table 6**).

DISCUSSION

EPITHYR constitutes a new consortium to study DTC risk factors; it gathers over 2,000 DTC cases and matched population controls of various geographical origin, with detailed epidemiological and genetic data. While lifestyle risk factors have been extensively analyzed in individual studies, this is the first analysis of genome-wide data in this consortium (10,20,50,31,43–49).

In summary, we confirmed the association with the known DTC susceptibility loci at 2q35, 8p12, 9q22.33 and 14q13.3 in the European ancestry population. We additionally replicated the association between DTC and a SNP at 5p15.33 (rs7726159) that correlated with rs2736100 which was reported in a previous Chinese study on PTC (39). Interestingly, the risk allele [A] of rs7726159 has also been associated with longer telomere length (40,41). This is in line with a Danish study in 95,568 individuals reporting that genetic determinants of long telomeres were associated with increased risk of cancer. In this study, it was hypothesized that long telomeres could lead to the development of cancers by promoting the survival of precancerous cells (42). Our results also suggest two novel DTC susceptibility loci at 1p31.3 (rs334729) and 16q23.2 (rs16950982), and the alleles of the SNPs conferring a higher risk of DTC have also been associated with decreased TSH levels in a previous GWAS (24,36). These results are concordant with previous epidemiological studies that measured thyroid hormones level in blood samples of DTC cases and their matched controls (51). Interestingly, the association with rs16950982 at 16q23.2 was stronger in men, which is also consistent with the results of the GWAS on TSH for this locus (36). Our study is the first GWAS conducted in an Oceanian population from French Polynesia and New Caledonia, two territories where the incidence of DTC is among the highest. Except at 1p31.3, all associations we highlighted in Europeans were in the same direction in the Oceanian ancestry population. However, our study was limited by the sample size and by the lack of replication sample in this population. Interestingly, we observed that the frequency of the risk alleles at 2q35, 5p15.33 and 16q23.2 were significantly higher in Oceanians than in Europeans (supplementary Table 7). This may explain part of the difference in DTC incidence observed between these two populations but additional GWAS and epidemiological studies in Oceanian populations are needed to fully understand the highest incidence observed in these populations.

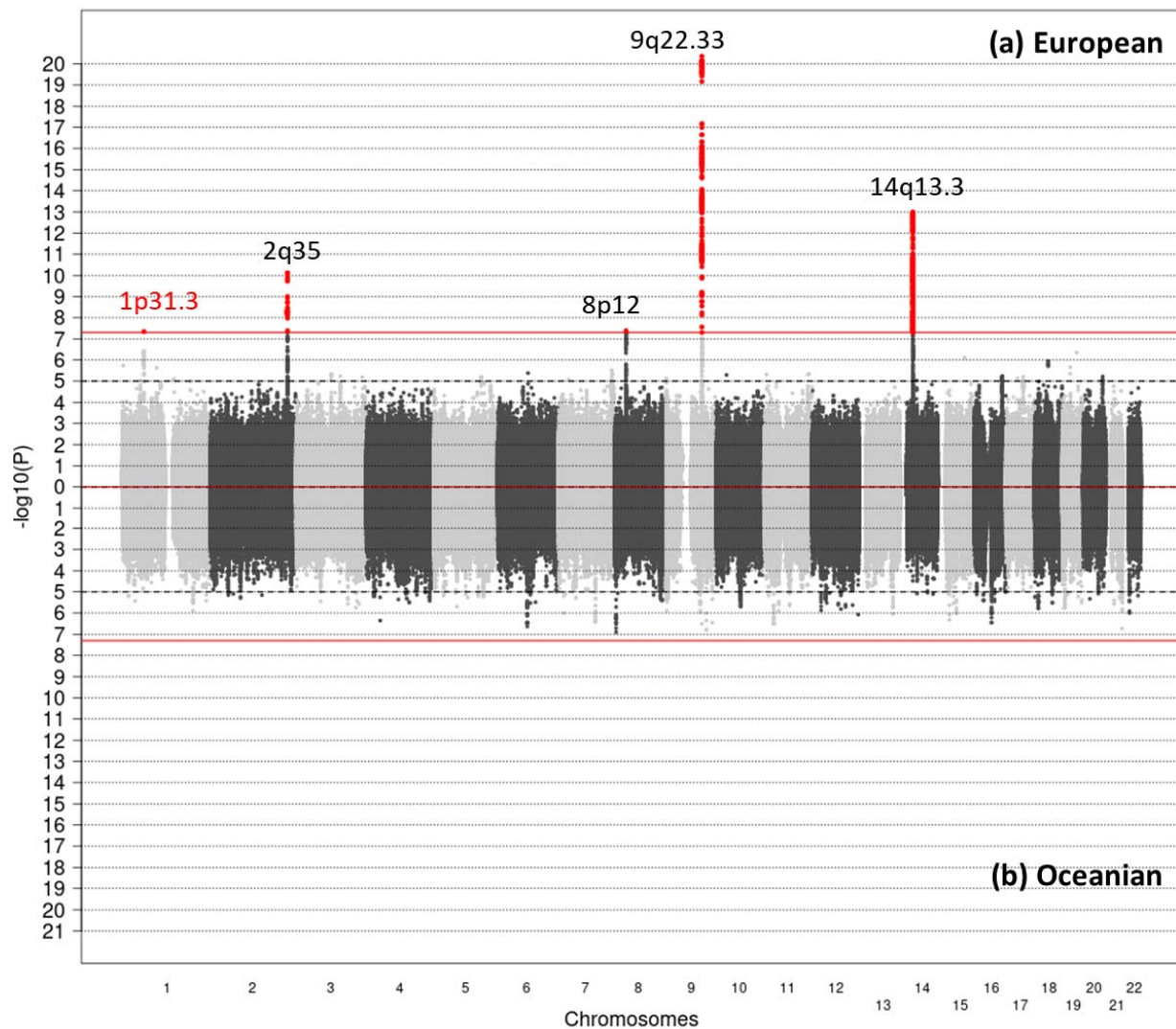

METHODS

Discovery sample

The EPITHYR consortium included data from seven population-based case-control studies. Of these studies, three were conducted in Metropolitan France (CATHY, YOUNG-Thyr and E3N studies), two in South Pacific Islands (French Polynesia and New Caledonia), one in Cuba and one in Gomel region of Belarus contaminated after the Chernobyl fallout. The study designs are briefly outlined below and were described in detail previously (10,12,19,31,46,52). The number of participants in each study, as well as the number of participants for which a saliva or blood sample was available are shown in **Supplementary**

Table 1.

All studies provided information on ethnicity, personal and familial history of thyroid disease, weight, height, dietary habits, alcohol intake, tobacco smoking, residential and occupational histories, and for women, menstrual and reproductive factors and exogenous hormone use. The EPITHYR sample constitutes the largest study on DTC including detailed epidemiological data and genetic data of the participants. All participants provided informed consent and each study was approved by their governing ethics committee.

CATHY study

The CATHY study is a population-based case-control study performed in Marne, Ardennes, and Calvados, three French administrative areas (“départements”) covered by a cancer registry (19). Cases were patients aged 25 years and older who were diagnosed with DTC between 2002 and 2007 and residing in these areas. Controls matched to the cases by sex, age (5-year age groups), and study area were recruited by selecting telephone numbers at random. To prevent possible selection bias arising from differential participation rates across categories of socioeconomic status (SES) among controls, quotas by SES were also applied to reflect the distribution by SES categories in the general population. From 621

cases and 706 controls recruited for the study, saliva DNA samples (Oragene®) were obtained for 516 cases and 569 controls.

New Caledonia (NC) study

The NC study is a country-wide, population-based, case-control study (10). The cases included patients with DTC diagnosed between 1993 and 1999 who had been living in NC for at least 5 years at the time of diagnosis. The cases were identified from the two pathology laboratories in NC and from active searches in the medical records of the main hospitals. Age- and sex-matched controls were randomly selected from recently updated electoral rolls. A total of 332 cases and 412 controls were included. Saliva DNA samples (Oragene®) were available for 224 cases and 261 controls.

Young-Thyr Study

The Young-Thyr study population consists of 805 DTC cases and 876 cancer-free controls (46). The case-control study was conducted with patients younger than 35 years of age and born after January 1st, 1971, thereby excluding those who were older than 15 years of age at the time of the Chernobyl nuclear power plant accident. These cases were newly diagnosed with DTC between January 1st, 2002, and December 31st, 2006, and have their main residence at the time of diagnosis in a region of eastern France (Alsace, Champagne-Ardennes, Corse, Franche-Comté, Lorraine, Rhône-Alpes, and Provence-Alpes-Côte d'Azur). Controls were selected from the general population and individually-matched to a single case of the same sex and year of birth (within one year) and region of residence during the year when the case was diagnosed with cancer. They were randomly selected in each region from the landline telephone subscriber directory. DNA samples from saliva (Oragene®) were available for 715 cases and 692 controls.

Cuban Study

The Cuban study population consists of 199 cases and 193 controls (31). All patients aged between 17 and 60 years, who were living in Havana and its surrounding municipality of Jaruco (30km from Havana), and were treated for DTC between 2000 and 2011 at INOR (National Institute of Oncology and Radiobiology) and at the Institute of Endocrinology were eligible for the study. Potential cases were selected from the National Cancer Registry databases and were cross-referenced with the INOR Pathology Register. Controls were selected from the general population living in Havana city and its surrounding municipality of Jaruco using consultation files from primary care units (family doctors). They were frequency-matched with cases by age at cancer diagnosis of the cases (± 5 years) and gender. The study was approved by the Clinical Research Ethics Committee of the National Institute of Oncology and Radiobiology (INOR), Havana, Cuba.

French Polynesia Study

The French Polynesia study population consists of 144 cases and 231 controls (53). All patients diagnosed with DTC, between 1983 and 2003, before the age of 56 years of age and born and living in French Polynesia were eligible for the study. Prevalent cases were identified from the cancer registry of French Polynesia, medical insurance files, and the four endocrinologists in Tahiti. Controls were individually matched on date of birth (± 6 months) and sex and were selected randomly from the French Polynesia registry of births, which records all inhabitants born in French Polynesia. The study was approved by the French Polynesian Ethics Committee.

Chernobyl study

The study was conducted on a subgroup of subjects from the population-based case-control study carried out in the most contaminated areas of Belarus to evaluate the risk of thyroid cancer after

exposure to radioactive iodine in childhood (52). Subjects included in the genetic study consisted of 83 PTC cases and 324 matched controls who consented to give a blood sample. Cases and controls included in the study were not related. All subjects were from the Gomel region in Belarus, and were younger than 15 years at the time of the Chernobyl accident. The control subjects were matched to the PTC cases by age (within 1 year for those who were 18 months or older at the time of the accident; within 6 months for those who aged 12–18 months and within 1 month for those who were younger than 12 months), sex and type of settlement. The cases were diagnosed within 6–12 years after the accident with histologically verified PTC confirmed by the International panel of pathologists. Two-thirds of the cases developed PTC before the age of 15 and the remaining cases before the age of 25. For more than 60% of cases, the latency (time between exposure and diagnosis) was less than 10 years.

The study was carried out with the approval of the IARC ethics committee and of the Belarus Coordinating Council for Studies of the Medical Consequences of the Chernobyl Accident.

Peripheral blood samples (10 ml) were collected in the presence of anticoagulant (sodium citrate) and processed for genomic DNA extraction using a standard inorganic method.

E3N study

The E3N is a prospective cohort that included 98,995 women in 1990 who were living in France, born between 1925 and 1950 and covered by the MGEN, a National Health Insurance Plan for teachers and coworkers (12). Participants, who gave written informed consent for external health follow-up through the health insurer, completed biennial self-administered questionnaires, requesting information on lifestyle characteristics and health conditions. Blood samples were collected between 1994 and 1999 from 25,000 E3N participants and collection of saliva samples was conducted between 2010 and 2011 and were obtained from 47,000 participants. Participants were asked to report any diagnosis of cancer on each Q1 to Q8 questionnaire, and cases were then further explored by requesting information from

the subjects' physicians. Pathology reports were obtained for all incident thyroid cancer cases. For the present study, we considered only first primary DTC cases (i.e., PTC or FTC). For this study, sufficient DNA material was available for 568 participants: 372 DNA samples were extracted from saliva and 196 from buffy-coat.

Replication sample

The Italian study included 701 cases consecutively recruited at the Department of Endocrinology of the University Hospital of Pisa, Italy. Controls (n=499) were healthy subjects recruited among blood donors and workers of the University Hospital of Pisa during their routine visits in the context of a program of surveillance performed by the Occupational Medicine unit. The eligibility criteria were the same for cases and controls, and it included a minimal age of 18 years. Individuals affected by any malignancy, chronic inflammatory disease, or related diseases in the past were excluded from the control group. A further exclusion criterion for controls was the presence of thyroid nodules or other benign thyroid diseases, when known. Both cases and controls should not have familial relationship with each other. All participants were of Caucasian origins. Other details of the study were published with the results of the GWAS (19). According to the Helsinki declaration, both healthy and affected volunteers gave their written informed consent to participate in the study and the study protocol was cleared by the local Ethical Committee.

The Ohio (USA) study is a case-control study that included 1,580 of self-reported European descent participants, including histologically confirmed PTC or FTC patients and 1,628 controls from the central Ohio area. Cases had a mean age of diagnosis of 43 years (74% are females) and controls had a mean age of 45 years at recruitment (74% are females). Genomic DNA was extracted from blood using standard

procedures. The study was approved by the Institutional Review Board of the Ohio State and all participants provided written informed consent.

Genotype data

OncoArray SNPs selection

All EPITHYR subjects were genotyped at the Centre National de Recherche en Génomique Humaine (CNRGH/CEA, Evry, France) using the Infinium OncoArray-500K BeadChip (Illumina), on an Illumina automated high-throughput platform. This array, which was previously described in details (54) contains 499,170 SNPs with a genome-wide backbone of about 250,000 tag SNPs designed such that the large majority of common variants could be accurately imputed. Additional SNPs include dense coverage across known genetic variants associated with breast, colorectal, lung, ovarian, and prostate cancers, SNPs covering ancestry, putative rare susceptibility variants from sequencing studies and other variants of potential biological relevance. As the OncoArray was not originally designed to include thyroid cancer susceptibility variants, we incorporated 13,759 additional custom markers based on prior evidence of association, candidate submissions, fine-mapping of known susceptibility regions and in genes involved in relevant biological pathways.

Quality control of genotyping data

Details of the genotyping calling for OncoArray are described in more details elsewhere (54). Cluster files generated using 56,284 samples from the GAME-ON consortium (available at http://consortia.ccge.medschl.cam.ac.uk/oncoarray/onco_v2c.zip) were applied to our dataset.

A total of 4,553 individuals were genotyped. We excluded samples with a call rate <95% (n=17), with a sex discordant call (n=12), and duplicates within and across studies (n=20). Additionally, we excluded

pairs of individuals which were identified as duplicates using the genetic data but with different epidemiological data (n=10).

Ancestry was computed using the Fastpop program (55) which derived principal component analysis (PCA) scores from 2,318 informative markers and a subset of ~47,000 individuals from the GAME-ON consortium. These scores were applied to our dataset. Individuals of European ancestry and Asian ancestry were defined as individuals an estimated proportion of European ancestry >0.8 and an estimated proportion of Asian ancestry >0.4, respectively with reference to the HapMap populations, based on the first two principal components (**Supplementary Figure 6**). Of the remaining 4,494 individuals, 3,538 were of European ancestry and 649 of Asian Ancestry. Additional individuals with extreme heterozygosity (4.89 standard deviation from the mean of the ethnicity) (n=11) were excluded and the final dataset comprised 3,527 individuals of European ancestry (1,554 cases and 1,973 controls) and 649 individuals of Asian ancestry (301 cases and 348 controls).

Of the 512,929 SNPs that were successfully manufactured, we received 493,266 SNPs with a call rate >90%. We excluded SNPs with a call rate <95% by study (n=8,327), duplicate SNPs (n=814), monomorphic SNPs (n=13,832), SNPs for which the cluster plots were judged to be not ideal (n=4,083). Of the remaining 466,210 SNPs, we additionally excluded SNPs not in HWE in each ethnic group ($p < 10^{-7}$ in controls, $P < 10^{-12}$ in cases) (n=563 in the study of European ancestry individuals and n=417 in the study of Asian ancestry individuals), monomorphic SNPs (n=5,210 in European ancestry individuals and n=37,513 in Asian ancestry individuals) as well as non-monomorphic SNPs with MAF<1% (n=58,912 in European ancestry individuals and n=75,177 Asian ancestry individuals). We retained for the analysis 401,525 SNPs among Europeans and 353,103 SNPs among Asians (**Supplementary Figure 7**).

Imputation

We performed the imputation of missing SNPs in each population (European and Asian) independently using the October 2014 (version 3) release of the 1000 Genomes Project dataset as the reference panel.

We excluded from imputation (but not from association analysis) SNPs with a call < 98% in each ethnic group, SNPs that could not be linked to the 1000 Genomes project reference as well as ambiguous SNPs (AT/GC).

For the European population, we additionally excluded SNPs for which the difference statistic $(|p_1 - p_2| - 0.01)^2 / ((p_1 + p_2)(2 - p_1 - p_2))$ was > 0.008 , where p_1 and p_2 are respectively the frequencies in our data set and in the 1000 Genomes Project. Therefore, imputation in Europeans was based on 362,025 genotyped SNPs and a two-stage procedure was performed, using SHAPEIT2 (using the default parameters (“—burn 10 —prune 10 —main 50”) to derive phased genotypes and IMPUTEv2 to perform imputation using 5 Mb non-overlapping intervals. The number of reference haplotypes to use as templates when imputing missing genotypes was increased to 800 (“-k_hap 800”), and the buffer region was increased to 500kb (“-buffer 500”). We excluded imputed SNPs with an imputation $r^2 < 0.3$ and SNPs with a MAF $< 1\%$ in our population leaving a total of 9,673,063 SNPs.

For the Asian population, we imputed the non-genotyped data with IMPUTEv2 but without pre-phasing in SHAPEIT, which is computationally more demanding but improves imputation accuracy (56). Because our “Asian” population was closer to Oceanian populations (**Supplementary Figure 8**), we added to the 1000 Genomes project reference panel, genomes from 26 Oceanian individuals from the Simons Diversity Project that were available publicly

(https://sharehost.hms.harvard.edu/genetics/reich_lab/sgdp/phased_data/). Imputation was based on 314,954 SNPs. We excluded SNPs with an imputation $r^2 < 0.3$ and SNPs with a MAF $< 1\%$ in our population leaving a total of 7,179,638 SNPs.

Statistical analysis

Odds ratios (OR) were calculated using logistic mixed models with the genetic relationship matrix as random effect to account for population structure and relatedness (57). All analyses were adjusted for age, sex, and study. We conducted separate analysis in Europeans and Oceanians, as well as a pooled analysis combining both populations. We also performed stratified analyses by sex, age group (<50, ≥50 years-old), histology (papillary/follicular cancer), and size of carcinoma for papillary cancers (<10mm/≥10 mm). We used the GASTON R package (<https://cran.r-project.org/web/packages/gaston/index.html>) to perform the logistic mixed models. For genome-wide analyses, P-values for each genetic variant were derived from a score test using a logistic mixed model as this test is less computationally demanding than a Wald test but asymptotically equivalent. A Wald test was then performed for a subset of variants of interest in order to get the effect size estimate. The traditional Bonferroni threshold for GWAS at $P < 5 \times 10^{-8}$ was used to assess significance.

In the replication phase, we performed a fixed effect meta-analysis with inverse-variance weighting as implemented in METAL software (58). Heterogeneity of ORs across the studies and across the stratification groups was assessed using the Cochran's Q-test.
