

Appendix: Mathematical description

We study the hypothetical effect of multiple infections with COVID-19 during one infective period on disease severity and mortality by an extended SEIR model (see Figure 1 for an illustration). Particularly, we adapt the deterministic compartmental model underlying the pandemic preparedness tool CovidSIM [1].

Model compartments

A population of N individuals is assumed. The model follows the time change in the number of individuals being susceptible (S), latently infected (E_{Sum}) consisting of n_E sub-states ($E_k, k = 1, \dots, n_E$), prodromal (P_{Sum}) consisting of n_P sub-states ($P_k, k = 1, \dots, n_P$), fully contagious (I_{Sum}) consisting of n_I sub-states ($I_k, k = 1, \dots, n_I$), late infectious (L_{Sum}) consisting of n_L sub-states ($L_k, k = 1, \dots, n_L$), in the final “removed” stage (R), and dead individuals (D).

A fraction f_{Sick} of fully contagious individuals becomes symptomatic, i.e., they get sick, while the remaining infections are asymptomatic. Asymptomatic infections are never lethal, whereas a fraction f_{Dead} of symptomatic infections results in death. If individuals acquire multi-infections they are more likely to become symptomatic (denoted \tilde{f}_{Sick}) and die (denoted \tilde{f}_{Dead}). Therefore, we have to distinguish between single- and multi-infected individuals. A multi-infection can be acquired at one infective contact with a multi-infected individual or by successive infections. In the latter case, the multi-infection is acquired on top of a single infection and the increased risks of developing symptoms and of mortality do not immediately manifest. Namely, it takes an average duration $1/\alpha$ until the multi-infection becomes effective. This reflects a transient phase during which neither the likelihoods of developing symptoms nor the mortality are yet elevated. As a consequence, in all stages of the infection, we need to distinguish between (i) single infections, (ii) multi infections in the transient phase, and (iii) the remaining multi infections. This is done by modeling the three classes by different compartments. The notation of the last paragraph is used for single infections. The respective compartments in multi-infected individuals in the transient phase are denoted by E_k^* ($k = 1, \dots, n_E$), P_k^* ($k = 1, \dots, n_P$), I_k^* ($k = 1, \dots, n_I$), and L_k^* ($k = 1, \dots, n_L$). The compartment of the remaining multi-infected individuals are denoted by \tilde{E}_k ($k = 1, \dots, n_E$), \tilde{P}_k ($k = 1, \dots, n_P$), \tilde{I}_k ($k = 1, \dots, n_I$), and \tilde{L}_k ($k = 1, \dots, n_L$).

Total numbers of infected and symptomatic individuals

The total number of single infections in the latent stage is given by

Case Isolation

A fraction f_{Iso} of symptomatic single and multi-infections in the transient phase get hospitalized and will be put into quarantine wards. Moreover, a (higher) fraction \tilde{f}_{Iso} of the remaining symptomatic multi infections are isolated, reflecting that these infections lead to more severe symptoms and hence a higher demand for medical help. Infected individuals that cannot be isolated in quarantine wards because their maximum capacity (Q_{max}) is reached are sent into home isolation. While isolation in wards is perfect, in home isolation only a fraction p_{Home} of infectious contacts is prevented. Isolation lasts until recovery or death. Importantly, case isolation mechanisms are sustained only during the time interval from t_{Iso1} to t_{Iso2} . In particular, case isolation policies might not be in place at the introduction of the disease. At time t ($t_{\text{Iso1}} \leq t \leq t_{\text{Iso2}}$), the number of individuals isolated in quarantine wards or at home is

The capacity of quarantine wards is divided proportionally by individuals in the respective sub-states of the infection. Thus, the number of fully contagious single infections in the k th sub-state is

Likewise, the numbers of fully contagious and late infectious single and multiple infections in home isolation are, respectively,

Because infectious contacts are avoided by isolation measures, not all infected individuals participate in transmission. The effective number of fully contagious single infections in the k th sub-state that effectively participate in disease transmission at time t is

Durations

The average duration of the latent, prodromal, fully contagious and late infectious periods are denoted by D_E , D_P , D_I , and D_L , respectively. Infected individuals have to

progress through n_E equivalent latent sub-states. Hence, the average duration in each latent sub-state is D_E/n_E , and individuals leave the latent sub-states at a rate

$$\varepsilon := \frac{n_E}{D_E}. \quad (16a)$$

As a consequence the duration in the latent phase is Erlang distributed with mean D_E and variance D_E/n_E . Similarly, the rates at which individuals leave the prodromal, fully contagious, and late infectious states are, respectively,

$$\varphi := \frac{n_P}{D_P}, \quad \gamma := \frac{n_I}{D_I}, \quad \text{and} \quad \delta := \frac{n_L}{D_L}. \quad (16b)$$

As outlined above, if a single infected individual is infected again during the latent, prodromal, fully contagious, or late infectious phases, it becomes multi infected, but the multi infection does not manifest immediately. Namely, if the multi-infection is transient for an average duration $D_T = 1/\alpha$.

Contact rates

The basic reproduction number R_0 is the average number of infections caused by an infected individual during the whole duration of the infections consisting of the latent, prodromal, fully contagious and late infectious periods. The quantity R_0 fluctuates seasonally with an amplitude a and a peak at time $t_{R_{0\max}}$, modeled by

Susceptibles encounter infected individuals (not in isolation) randomly. The relative contagiousness of prodromal and late infectious individuals compared with fully contagious ones are c_P and c_L , respectively. Single and multi-infected individuals are equally contagious in the respective stages. Thus, the effective contact rates are

General contact reduction and force of infection

During the time interval from t_{Dist_1} , t_{Dist_2} , general contact reducing measures, e.g., social distancing, curfews, etc., are in place, which reduce contacts by an amount p_{Dist} . We define

An infectious contact with a multi-infected individual leads to a multi infection with probability \tilde{m} . Thus, the force of infection by which susceptible acquire single infections

is given by

where $\lambda_{\text{Ext}}^{(s)}$ is the external force of infection leading to single infections form outside the population. Likewise the force of infections by which susceptibles acquire multi infections is given by

where $\lambda_{\text{Ext}}^{(m)}$ is the external force of infection leading to multi infections form outside the population. The combined force of infections by which susceptibles become infected is

Single infected individuals at any state of the infection can acquire a multi infection. However, the initial infection also leads to some protection as the immune system is already activated. Thus the force of infection experienced by latent, prodromal, fully infected, and late infectious individuals is reduced by factors q_E , q_P , q_I , q_L , respectively.

Differential Equation

Putting together what is described above leads to the following system of differential equations (cf. Fig 1). The change in the number of susceptible individuals is given by

$$\frac{d\tilde{P}_1(t)}{dt} = \alpha P_1^*(t) + \varepsilon \tilde{E}_{n_E}(t) - \varphi \tilde{P}_1(t), \quad (27e)$$

$$\frac{d\tilde{P}_k(t)}{dt} = \alpha P_k^*(t) + \varphi \tilde{P}_{k-1}(t) - \varphi \tilde{P}_k(t) \quad \text{for } 2 \leq k \leq n_P. \quad (27f)$$

For the number of fully contagious individuals the differential equations become

$$\frac{dL_1(t)}{dt} = \gamma I_{n_I}(t) - \delta L_1(t) - q_L \lambda(t) \frac{L_1^{(\text{Eff})}(t)}{N}, \quad (29a)$$

$$\frac{dL_k(t)}{dt} = \delta L_{k-1}(t) - \delta L_k(t) - q_L \lambda(t) \frac{L_k^{(\text{Eff})}(t)}{N} \quad \text{for } 2 \leq k \leq n_L, \quad (29b)$$

$$\frac{dL_1^*(t)}{dt} = q_L \lambda(t) \frac{L_1^{(\text{Eff})}(t)}{N} + \gamma I_{n_I}^*(t) - \delta L_1^*(t) - \alpha L_1^*(t), \quad (29c)$$

$$\frac{dL_k^*(t)}{dt} = q_L \lambda(t) \frac{L_k^{(\text{Eff})}(t)}{N} + \delta L_{k-1}^*(t) - \delta L_k^*(t) - \alpha L_k^*(t) \quad \text{for } 2 \leq k \leq n_L, \quad (29d)$$

$$\frac{d\tilde{L}_1(t)}{dt} = \alpha L_1^*(t) + \gamma \tilde{I}_{n_I}(t) - \delta \tilde{L}_1(t), \quad (29e)$$

Finally, the number of recovered and dead individuals change according to

$$\frac{dR(t)}{dt} = \delta(1 - f_{\text{Sick}} f_{\text{Dead}})(L_{n_L}(t) + L_{n_L}^*(t)) + \delta(1 - \tilde{f}_{\text{Sick}} \tilde{f}_{\text{Dead}}) \tilde{L}_{n_L}(t), \quad (30)$$

and

$$\frac{dD(t)}{dt} = \delta f_{\text{Sick}} f_{\text{Dead}} (L_{n_L}(t) + L_{n_L}^*(t)) + \delta \tilde{f}_{\text{Sick}} \tilde{f}_{\text{Dead}} \tilde{L}_{n_L}(t). \quad (31)$$

Number of multi infections

The cumulative number of multi infections at time T , excluding those, that were still in the transient phase upon recovery or death, can be calculated as follows. The number of single and multi infections at time T is $N - S(T)$, while the number of deaths that occurred until then is $D(T)$. Denoting the proportion of deaths attributed to multi infections (excluding those that were transient upon recovery) by x , we have the equation

$$D(T) = (N - S(T)) (x \tilde{f}_{\text{Sick}} \tilde{f}_{\text{Dead}} + (1 - x) f_{\text{Sick}} f_{\text{Dead}}), \quad (32)$$

yielding the total number of multi infections (excluding those that were transient upon recovery and death) as

$$(N - S(T)) x = (N - S(T)) \frac{D(T) - f_{\text{Sick}} f_{\text{Dead}} (N - S(T))}{\tilde{f}_{\text{Sick}} \tilde{f}_{\text{Dead}} - f_{\text{Sick}} f_{\text{Dead}}}. \quad (33)$$
