The app checks via Bluetooth whether the smartphone has been in close proximity (less than 1 meter) for more than 15 minutes with another smartphone of a person tested positive who owns the app. The app suggests what to do if contact is established through a notification. It works transparently and anonymously: no personal data is collected. There is just the exchange of a pseudo-identifier renewed every 15 minutes which does not allow the person to be identified. It is supported by the French government and was developed by a group of public and private actors coordinated by the French research institution Inria#
