


Figure A1. Timeline of data collected by Fitbit over a 24-hour period.

B2. Linear regression models for trends in activity

The slope of the linear trendline was defined as:

$$\frac{\Delta A}{\Delta time} = \frac{A_0 - A_i}{t_0 - t_i},$$

where
$$A = activity metric$$
, $0 = original date$, $i = subsequent date$

For example, more subjects had a significant change in average REM duration per night starting on March 23 than other dates. We compared the mean REM duration per night for all individuals from Jan 1 to March 23 and March 23 to May 31. To assess trends in REM, we also calculated the slopes of the linear regression model for daily REM duration from Jan 1 to March 23, and March 23 to May 1. Analogous calculations were performed for each of the six activity metrics.




Figure E1. Overall demographics and health data on all subjects included in the before/during dataset. Subjects were given a questionnaire upon entering the study.




Figure E2. REM trend before/during SAHO by demographic and health data.




Figure E3. Step trend before/during SAHO by demographic and health data.




Figure E4. Resting heart rate trend before/during SAHO by demographic and health data.




Figure E5. Wake trend before/during SAHO by demographic and health data.




Figure E6. Sedentary active trend before/during SAHO by demographic and health data.




Figure E7. Total sleep time trend before/during SAHO by demographic and health data.




Figure E8. REM trend by demographics and health data before/during SAHO divided by those that increased or decreased activity.




Figure E9. Step trend by demographics and health data before/during SAHO divided by those that increased or decreased activity.




Figure E10. Resting heart rate trend by demographics and health data before/during SAHO divided by those that increased or decreased activity.




Figure E11. Wake trend by demographics and health data before/during SAHO divided by those that increased or decreased activity.




Figure E12. Sedentary active trend by demographics and health data before/during SAHO divided by those that increased or decreased activity.




Figure E13. Total sleep time trend by demographics and health data before/during SAHO divided by those that increased or decreased activity.




Figure E14. Overall demographics and health data on all subjects included in during/after dataset. Subjects were given a questionnaire upon entering the study.




Figure E15. REM trend during/after SAHO by demographic and health data.




Figure E16. Step trend during/after SAHO by demographic and health data.




Figure E17. Resting heart rate trend during/after SAHO by demographic and health data.




Figure E18. Wake trend during/after SAHO by demographic and health data.




Figure E19. Sedentary active trend during/after SAHO by demographic and health data.





Figure E20. Total sleep time trend during/after SAHO by demographic and health data.

Figure E21. REM trend by demographics and health data during/after SAHO divided by those that increased or decreased activity.




Figure E22. Step trend by demographics and health data during/after SAHO divided by those that increased or decreased activity.




Figure E24. Wake trend by demographics and health data during/after SAHO divided by those that increased or decreased activity.




Figure E25. Sedentary active trend by demographics and health data during/after SAHO divided by those that increased or decreased activity.




Figure E26. Total sleep time trend by demographics and health data during/after SAHO divided by those that increased or decreased activity.






Figure E28. Mean % change (left) and % change of slope of the linear trendline (right) for before/during the SAHO by activity.




Figure E29. Mean % change (left) and % change of slope of the linear trendline (right) for before/during the SAHO by cluster.






Figure E31. Mean % change (left) and % change of slope of the linear trendline (right) for during/after the SAHO by activity.




Figure E32. Mean % change (left) and % change of slope of the linear trendline (right) for during/after the SAHO by cluster.






Figure F2. 7-day moving average of steps with linear trendline. The bolded trace is the average for the cluster; the light grey tracings are for each individual in the cluster.












Figure F8. 7-day moving average of steps with linear trendline. The bolded trace is the average for the cluster; the light grey tracings are for each individual in the cluster.









Appendix G: Self-Evaluation of Activity

Data recorded by the wearable devices for the 40 subjects in Group B differed from self-reported activity on a number of metrics including steps and sleep quality (see Figure 4, main text). For example, 55% (18/40) of subjects indicated 'no change' in activity while increasing their daily steps ($\pm 20.4 \pm 18.6\%$) or while increasing sedentary time ($\pm 2.6 \pm 1.7\%$) and decreasing steps ($\pm 15.2 \pm 11.1\%$). 75% (30/40) of subjects indicated 'no change' in the number of times they woke during the night, when the devices recorded them waking up 6-9% more or less frequently (see Tables E3 and E4 in Appendix E).








What is your gender?








How would you describe the area in which you live?












What are the main reasons for your activity changes?






How have your remote / virtual social interactions changed since stay-at-home orders have been in place? 264 out of 267 answered




What is your level of remote/virtual interactions **after** stay-at-home orders were lifted? This includes phone calls, video conferencing, online/text chatting, etc.




What was your level of in-person interactions in the months **before** stay-at-home orders? In-person interactions can include a partner, children or colleagues.




