These items are the basic minimum to include in a manuscript. Without this information, readers and reviewers cannot assess the reliability of the findings.

<b>Study design</b>	1 For each experiment, provide brief details of study design including: <ol style="list-style-type: none"> <li>The groups being compared, including control groups. These items complement the Essential 10 and add important context to the study. Reporting the items in both sets represents best practice.
