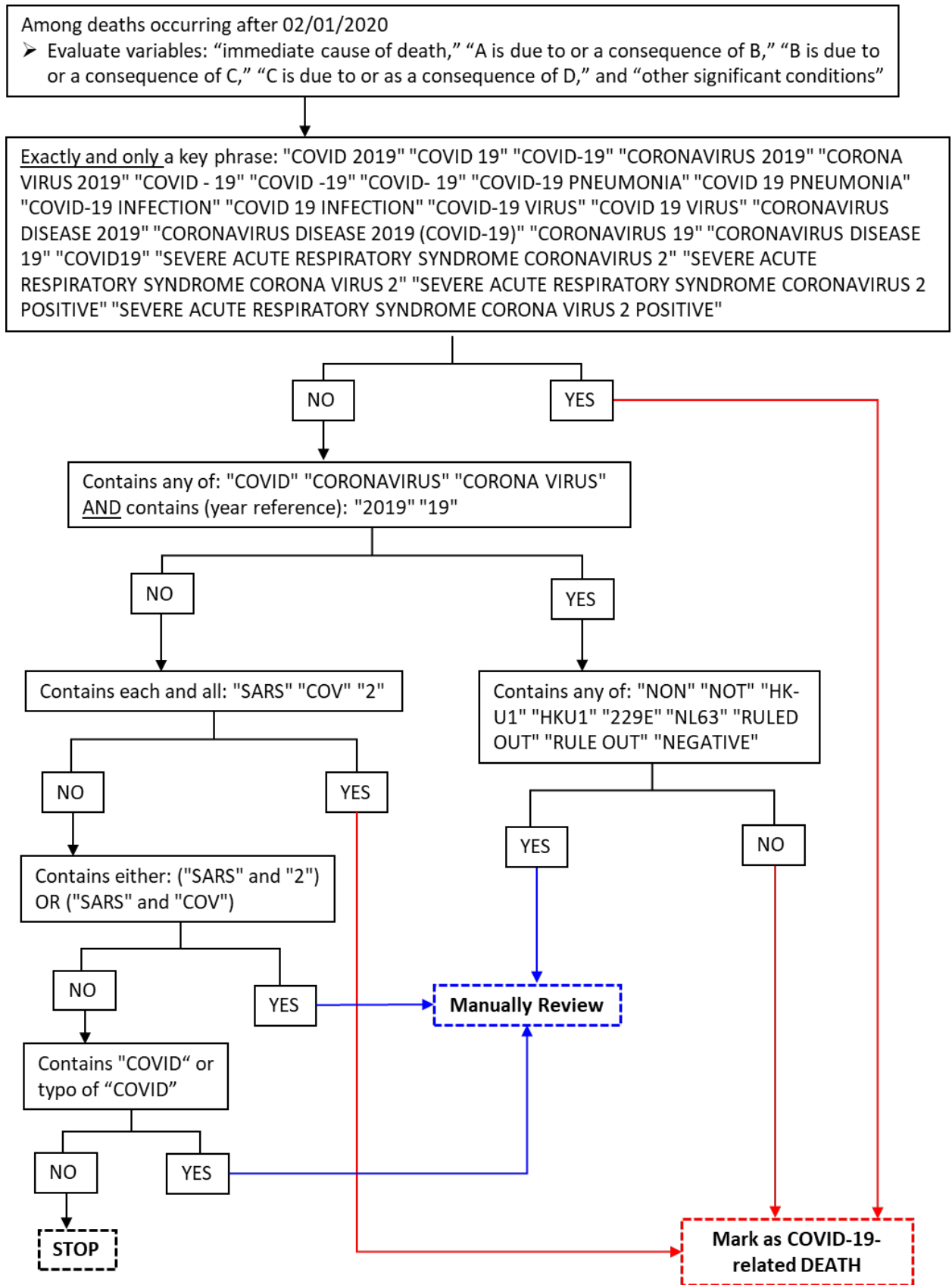

## **eMethods. Statistical Analysis**

The SE for each individual MR and PM was calculated as follows:  $SE[\ln(MR)] = 1/A^{1/2}$ , where  $A$  is the number of COVID-19 deaths. The standard error for each individual MRR and PMR was calculated as follows:  $SE[\ln(MRR)] = (1/A_1 + 1/A_0 - 1/N_1 - 1/N_0)^{1/2}$ , where  $A_j$  is the number of COVID-19 deaths,  $A_0$  is the number of COVID-19 deaths in the referent group,  $N_1$  is the population (or comparison deaths for PMR) and  $N_0$  is the population for the referent group (or comparison deaths for the referent group for PMR). The 95% CI for each measure of disease or association was calculated as  $95\% CI = measure \pm 1.96 \times SE$ .

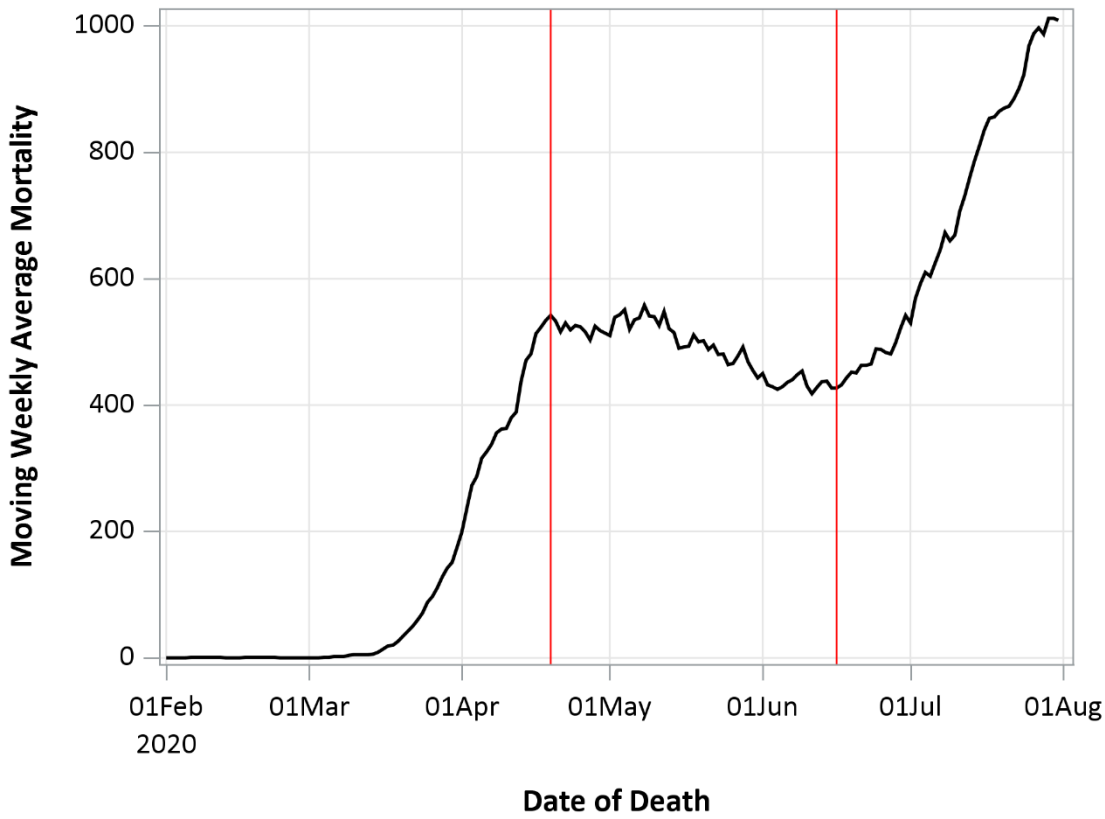
**eFigure 1. Flow chart depicting algorithm used to identify COVID-19-related deaths.**



In addition to relying on the code U07.1 as the underlying cause of death or a relevant condition, we searched the following text fields for keywords or combinations of keywords: "immediate cause of death," "A is due to or a consequence of B," "B is due to or a consequence of C," "C is due to or as a

consequence of D,” and “other significant conditions”. For select keywords or combinations of keywords, deaths were manually reviewed by the study team to evaluate if the death was COVID-19 related.

**eFigure 2. Weekly COVID-19 mortality in California during the study period calculated as a moving average using a 7-day window.**

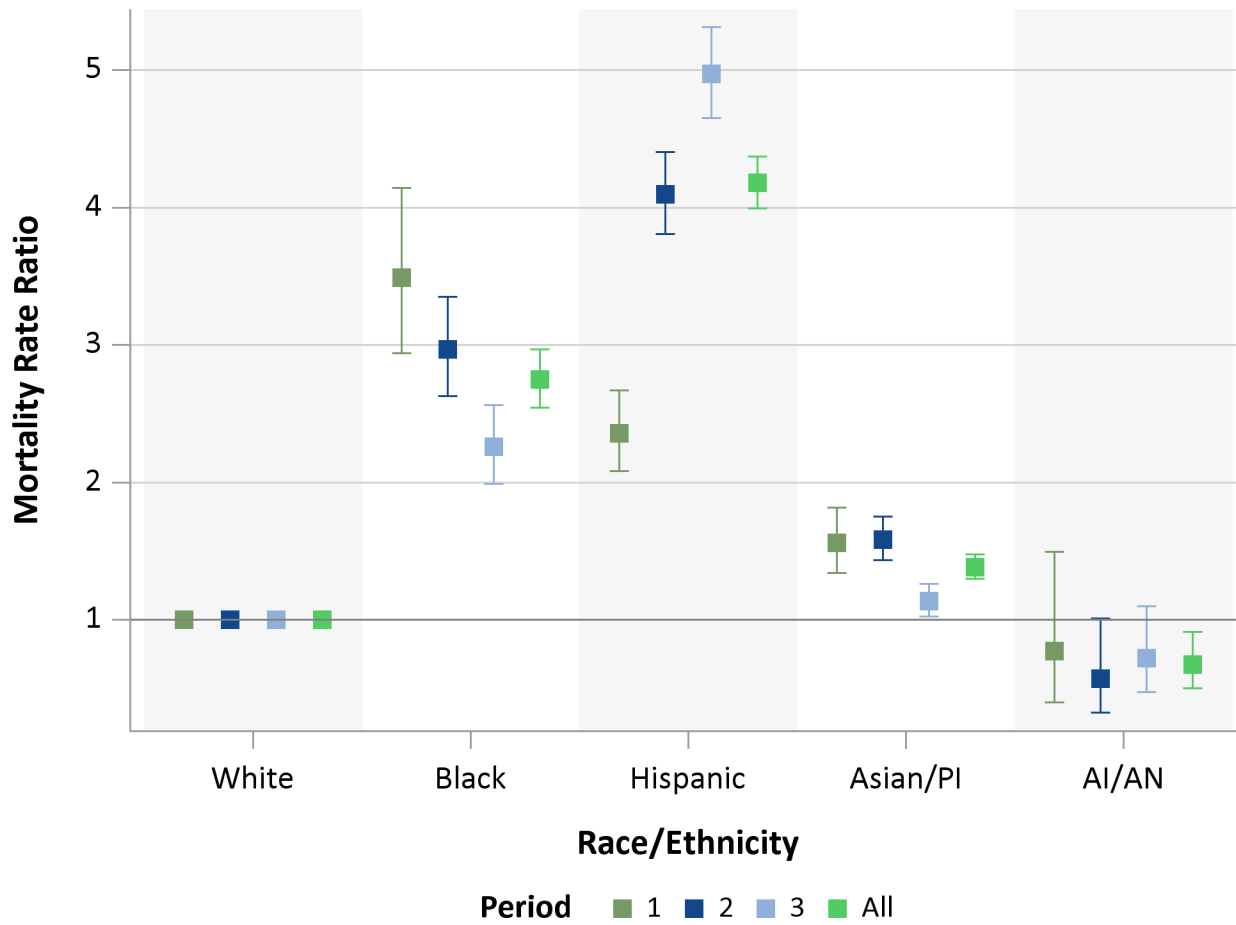


Red vertical lines separate the three periods of the epidemic in California with distinct patterns. Dates of separation are April 19 and June 16, 2020.

eFigure 3. Age-standardized mortality rate ratios (MRR) and 95% CI by race/ethnicity and study period.



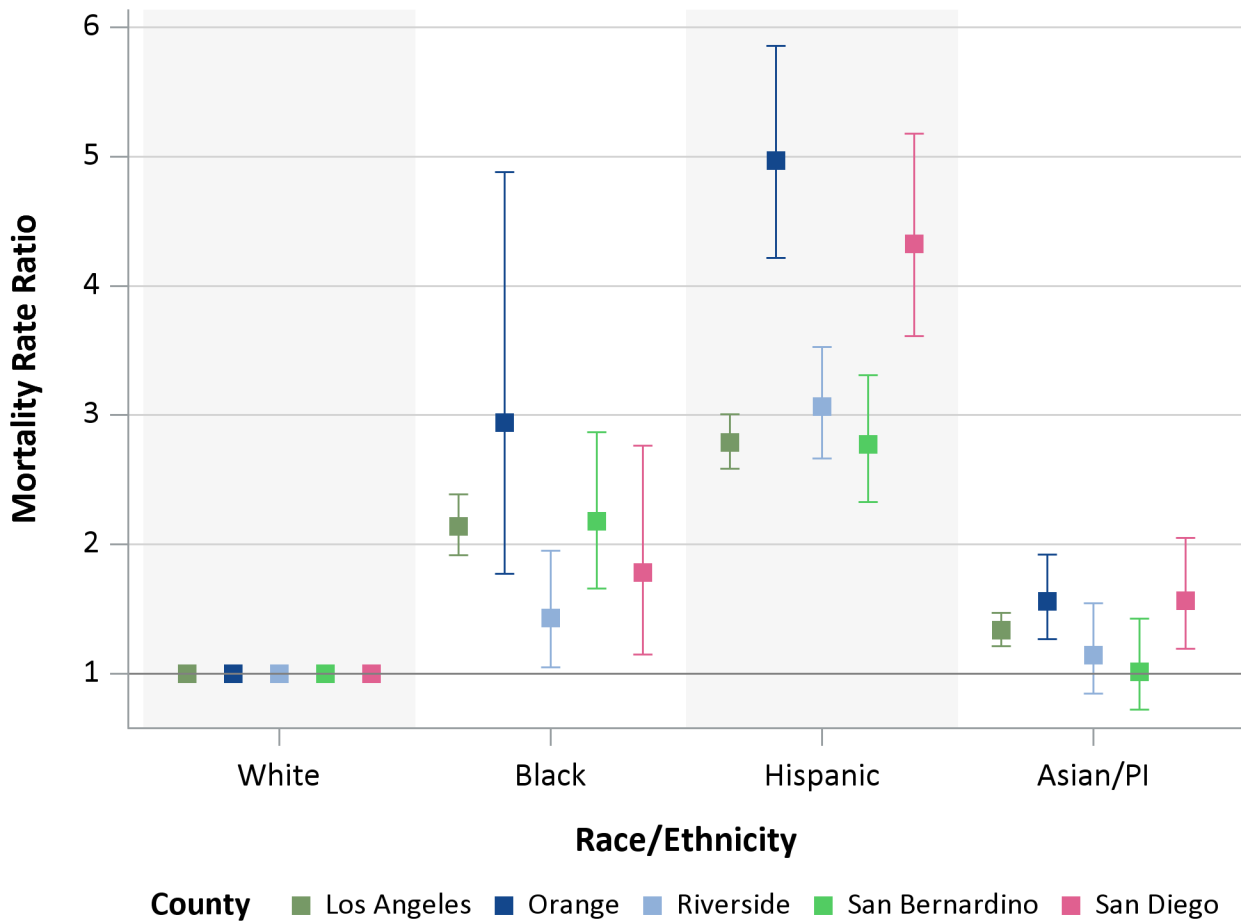

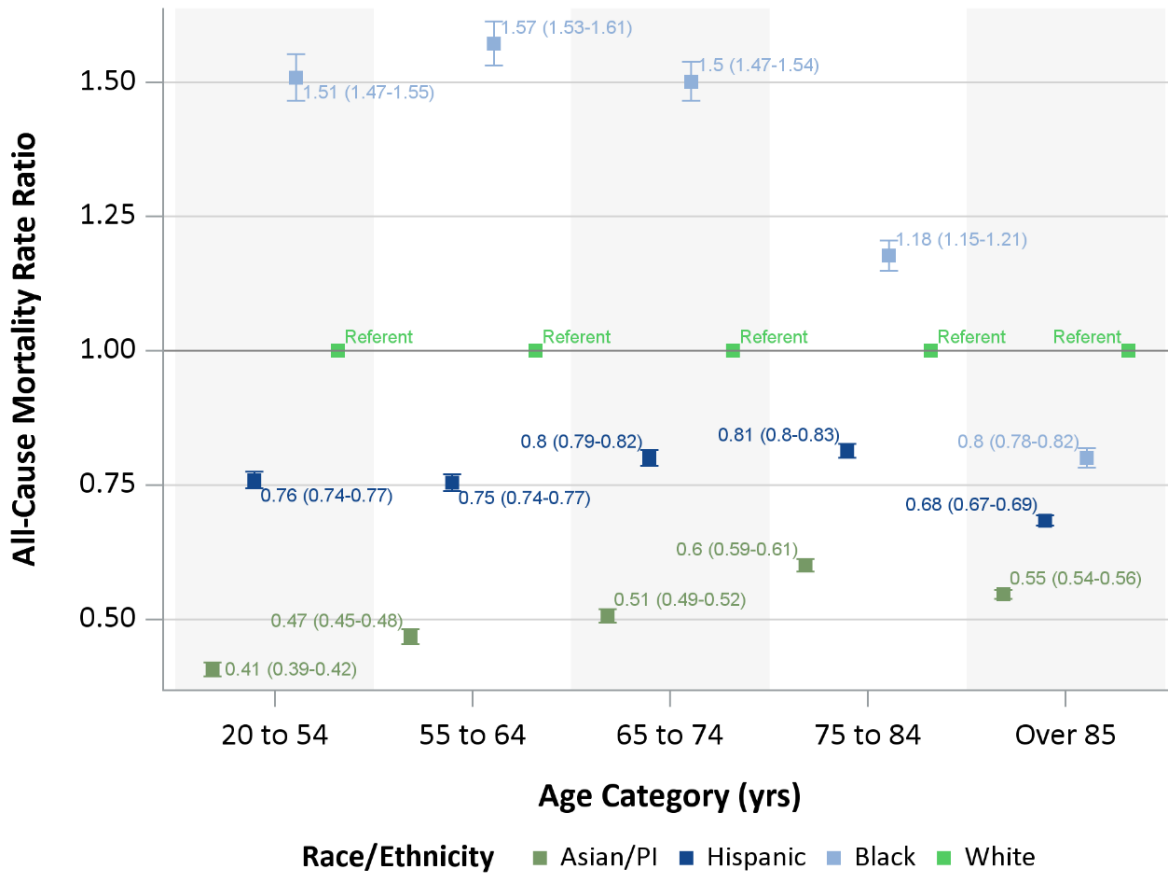
