eMethods

Demographic Information

Participants self-reported demographic information about age, gender, ethnicity, race, educational attainment, political partisanship and ideology, and place of residence. Information about race and ethnicity was collected because of differing rates of COVID-19 vaccination across racial and ethnic minority groups.^{1,2}

Assessment of COVID-19 Vaccine Hesitancy

The survey included two questions about COVID-19 vaccine hesitancy adapted from Persad *et al.* 2021,³ which were presented before the passage. The first question asked “How likely are you to get vaccinated for COVID-19 when a vaccine is available for you?” and included 6 answer choices (“I definitely will NOT get vaccinated.”; “I probably will NOT get vaccinated.”; “I probably will get vaccinated.”; “I definitely will get vaccinated.”; “I am completely undecided about whether I will get vaccinated.”; “I have already been vaccinated.”) The second question asked “Thinking about this in a different way, which of the following statements comes closest to what you are most likely to do when a COVID-19 vaccine is available for you?” and included 4 answer choices (“I will get vaccinated as soon as possible.”; “I will wait to see what happens with other people before deciding whether to get vaccinated myself.”; “I will not get vaccinated, regardless of what happens to other people who get the vaccine.”; “I have already been vaccinated.”)

Prescreening and Sampling Strategy

We administered the surveys through Prolific (<https://www.prolific.co/>), an online survey vendor with a large number of active users in the United States. Both cohorts were assembled using a convenience sampling strategy in which participants enrolled on a first-come, first-serve basis. Prescreening questions written by Prolific and previously administered to their users were employed to restrict enrollment to the target populations.

The following prescreening criteria were applied to both cohorts:

Question: “In which country do you currently reside?”

Accepted answer: “United States”

Question: “Have you received a coronavirus (COVID-19) vaccination?”

Accepted answer: “No”

One additional criterion regarding vaccine hesitancy was applied only to cohort A:

Question: “Please describe your attitudes towards the COVID-19 (Coronavirus) vaccines:”

Accepted answers: “Against (I feel negatively about the vaccines)”; “Neutral (I don’t have strong opinions either way)”

In addition, participants in related pilot studies run by the investigators between February 1, 2021 and April 15, 2021 were excluded during prescreening, and all participants in cohort A were ineligible to join cohort B.

To increase the racial and ethnic diversity of the convenience samples, we limited the number of participants who could enroll in each cohort based on their answers to the following prescreening question:⁴

“Please indicate your ethnicity (i.e. peoples’ ethnicity describes their feeling of belonging and attachment to a distinct group of a larger population that shares their ancestry, colour, language or religion)?”

For each cohort, we capped enrollment at a maximum of 100 people for each of the following 5 groups:

Group 1: Responded “White/Caucasian”

Group 2: Responded “Black/African American”

Group 3: Responded “East Asian”, “South Asian”, or “South East Asian”

Group 4: Responded “African”, “Caribbean”, “Middle Eastern”, “Mixed”, “Native American or Alaskan Native”, “Other (please feel free to us know your ethnicity via email)”, “White/Sephardic Jew”, “Black/British”, “White Mexican”, or “Romani/Traveller”

Group 5: Responded “Latino/Hispanic”

Participant Compensation

Participants were paid \$2.00 for taking the survey.

Exclusion Criteria

303 participants enrolled in cohort A, and 286 participants enrolled in cohort B. After data collection, we excluded participants who met any of the following criteria:

- 1) Did not complete the whole survey.
- 2) Answered “Not at all carefully” to the question “How carefully did you complete this survey? Please answer honestly. Your payment does NOT depend on your response to this question.”
- 3) Gave incorrect responses to both attention check questions, “Please answer ‘Slightly unlikely’ to this question.” and “What color is the sky? Please answer this question incorrectly, on purpose, by choosing ‘Red’ instead of ‘Blue.’ ”
- 4) Answered “Yes, one dose” or “Yes, two doses” to the question “Have you gotten a COVID-19 vaccine?”

In addition, participants were excluded from cohort A if they reported a strong intention to receive a COVID-19 vaccine, in contrast to their answers to the Prolific prescreening questions. For these purposes, strong intention was defined as answering “I definitely will get vaccinated” to the question “How likely are you to get vaccinated for COVID-19 when a vaccine is available for you?” and answering “I will get vaccinated as soon as possible” to the question “Thinking about this in a different way, which of the following statements comes closest to what you are most likely to do when a COVID-19 vaccine is available for you?”

Participants who reported using Google searches or other outside help to answer the survey questions (9 [3.3%] in cohort A and 10 [3.5%] in cohort B) were not excluded.

CDC Passages and Readability Analysis

The survey passages were taken from <https://www.cdc.gov/coronavirus/2019-ncov/vaccines/safety/JJUupdate.html>, which is the CDC’s primary web page for communicating information about the pause to the general public. To create the text included in the survey, we removed links and references to other web pages, non-textual elements such as figures and infographics, and formatting other than section headers, bulleted lists, and paragraph breaks. No other changes were made to the passages.

Participants in cohort A were presented with the version of the passage released on April 16, 2021. It is 948 words long and scores above an eighth grade reading level by both the Simple Measure of Gobbledygook (SMOG) and Flesch-Kincaid Grade Level (FKGL) metrics (12.9 and 11.4, respectively).

On April 20, 2021 the CDC made several changes to the passage, including reducing the length to 795 words and altering the language and section headings. The core content was unaltered.

Participants in cohort B were given the revised passage, which scores 12.7 by SMOG and 10.7 by FKGL.

The full text of each passage is available in eAppendix 1 and eAppendix 2, respectively. Readability grade levels were calculated using Readability Studio Professional, version 2020 (Oleander Software).

Comprehension Questions

We developed 7 multiple-choice questions to assess how participants understood the major recommendations of the passage. The full set of questions and answer choices, along with participant responses, are provided in eTable 1. The first 3 questions involve recall of information stated directly in the passage; the remaining 4 questions involve application of concepts to hypothetical scenarios.

Impression Questions

Participants were asked to rate their impressions of 7 attributes of the passage using a 6-point Likert scale (options “Strongly disagree”, “Disagree”, “Slightly disagree”, “Slightly agree”, “Agree”, and “Strongly agree”). The questions were adapted from a previous study of COVID-19 health literacy by Kerr *et al.* 2021.⁵

Counterfactual Questions

We used the nonrandomized counterfactual format described Graham and Coppock 2021 to assess participants’ beliefs about the effect of the J&J/Janssen pause on their confidence in the safety of COVID-19 vaccines and the likelihood that they would receive the Pfizer/BioNTech or Moderna vaccine.⁶ Participants first answered three questions about their current beliefs after reading the passage. They were then instructed to answer the same three questions as if they had been asked before the pause was announced.^{6,7} For the figure, we tabulated the number of participants who expressed more, less, or the same confidence in response to the counterfactual questions than the baseline questions.

Statistical analysis

Associations between participant characteristics and performance on the comprehension questions were assessed using ordinal logistic regression. The dependent variable was the total number of correct responses to the 7 comprehension questions. Statistical analyses were performed using the Python package statsmodels (version 0.13.0.dev0). Statistical significance was defined as $P < .05$.

Recommendation to Pause Use of Johnson & Johnson’s Janssen COVID-19 Vaccine

On April 13, 2021, CDC and FDA recommended a pause in the use of Johnson & Johnson’s Janssen COVID-19 Vaccine. Of the nearly 7 million doses administered so far in the United States, a small number of reports of a rare and severe type of blood clot have been reported in people after receiving the J&J/Janssen COVID-19 Vaccine. All reports occurred among women between the ages of 18 and 48, and symptoms occurred six to 13 days after vaccination. As of April 13, 2021, of the more than 180 million doses administered so far of the Pfizer-BioNTech or Moderna vaccines, no reports matching those associated with the J&J/Janssen vaccine have been received.

J&J/Janssen COVID-19 Vaccine Update, April 13, 2021

The use of this vaccine is ‘paused’ for now. This is because the safety systems that make sure vaccines are safe received a small number of reports of a rare and severe type of blood clot happening in people who got this vaccine.

We do not know enough yet to say if the vaccine is related to or caused this health issue. To be extra careful, CDC and FDA recommend that the vaccine not be given until we learn more.

If you got this vaccine, seek medical care urgently if you develop any of the following symptoms:

- severe headache,
- backache,
- new neurologic symptoms,
- severe abdominal pain,
- shortness of breath,
- leg swelling,
- tiny red spots on the skin (petechiae),
- or new or easy bruising

Learn More About the J&J/Janssen Vaccine Pause

What does a “pause” mean?

On April 13, 2021, CDC and the US Food and Drug Administration (FDA) recommended a pause in the use of Johnson & Johnson’s Janssen (J&J/Janssen) COVID-19 Vaccine. Although the J&J/Janssen vaccine is still authorized for use, CDC and FDA recommend this vaccine not be given to anyone until we know more. This gives scientists a chance to review the data and decide if recommendations on who should get the vaccine need to change. CDC and FDA will share more information as soon as possible with healthcare providers, people who got the vaccine, and the public.

What do I need to know about the possible safety issue?

Here is what we know now: scientists and doctors always look carefully at all reported side effects.

From their review, they saw a small number of cases of a rare and severe type of blood clot in people who got the J&J/Janssen COVID-19 Vaccine. All reported cases were in women between the ages of 18 and 48, and the problems were found up to two weeks after vaccination.

What if I got this vaccine?

If you got this vaccine more than three weeks ago, your risk of developing a blood clot is very

low.

If you got this vaccine within the last three weeks, your risk of developing a blood clot is also very low. However, you should be on the lookout for possible symptoms of a blood clot:

- Severe headache
- Blurred vision
- Fainting
- Seizures
- Pain in your abdomen (chest or stomach)
- Leg pain or swelling
- Shortness of breath

Get medical care right away if you have any of these symptoms and got the J&J/Janssen COVID-19 Vaccine within the last few weeks. If you have any questions at all, call your doctor, nurse, or clinic.

Has this issue been seen with the other COVID-19 vaccines?

No. As of April 13, 2021, no cases of this blood clot issue have been reported among the more than 180 million people who received the Pfizer-BioNTech or Moderna vaccines.

Are COVID-19 vaccines safe?

Yes. COVID-19 vaccine safety is a top priority for the federal government, and all reports of health problems following COVID-19 vaccination are taken very seriously and investigated as needed. We know the safety systems in place are working. COVID-19 vaccines have undergone and will continue to undergo the most intensive safety monitoring in U.S. history.

Should I cancel my vaccination appointment?

If you are scheduled to get the J&J/Janssen COVID-19 Vaccine, work with your vaccine provider to reschedule your appointment to get another type of COVID-19 vaccine.

Safety Is a Top Priority

COVID-19 vaccine safety is a top priority for the federal government, and all reports of health problems following COVID-19 vaccination are taken very seriously. This potential safety issue was caught early, and this pause reflects the federal government's commitment to transparency as CDC and FDA review these data. COVID-19 vaccines have undergone and will continue to

undergo the most intensive safety monitoring in U.S. history.

What to Do If You Received the J&J/Janssen COVID-19 Vaccine

If you received the vaccine more than three weeks ago, the risk of developing a blood clot is likely very low at this time.

If you received the vaccine within the last three weeks, your risk of developing a blood clot is also very low and that risk will decrease over time.

Contact your healthcare provider and seek medical treatment urgently if you develop any of the following symptoms:

- severe headache,
- backache,
- new neurologic symptoms,
- severe abdominal pain,
- shortness of breath,
- leg swelling,
- tiny red spots on the skin (petechiae), or
- new or easy bruising

If you are scheduled to get the J&J/Janssen COVID-19 Vaccine, please work with your vaccine provider to reschedule your appointment to receive another authorized and recommended COVID-19 vaccine. There are two other COVID-19 vaccines authorized and recommended for use in the United States: Pfizer-BioNTech and Moderna.

What does a pause mean?

Although the J&J/Janssen vaccine is still authorized for use, CDC and FDA recommend this vaccine not be given to anyone at this time while this safety signal and its possible implications are investigated. The pause will give scientists a chance to review the data and decide if recommendations on this specific vaccine need to change. What do we know?

Scientists and doctors look constantly and carefully at all reported vaccine side effects.

This pause also will allow CDC's independent advisory committee, the Advisory Committee on Immunization Practices, to meet, review these reports, and assess their potential significance.

Report any adverse events after vaccination to v-safe and the Vaccine Adverse Event Reporting System.

What do I need to know about the possible safety issue?

COVID-19 vaccine safety is a top priority for the federal government, and all reports of health problems following COVID-19 vaccination are taken very seriously.

We know the safety systems in place are working. This potential safety issue was caught early, and this pause reflects the federal government's commitment to transparency as CDC and FDA review these data. COVID-19 vaccines have undergone and will continue to undergo the most intensive safety monitoring in U.S. history.
